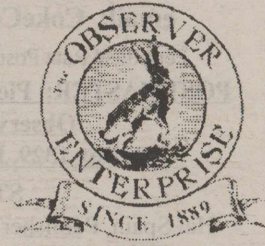

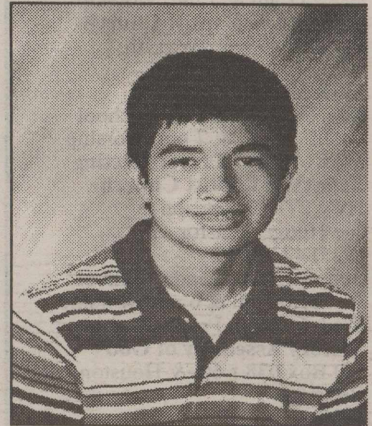

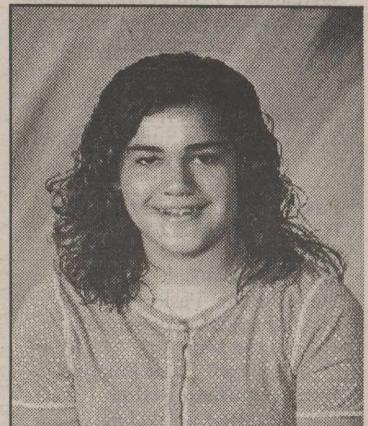

Proceeds will benefit the Joe Torres Memorial Scholarship.

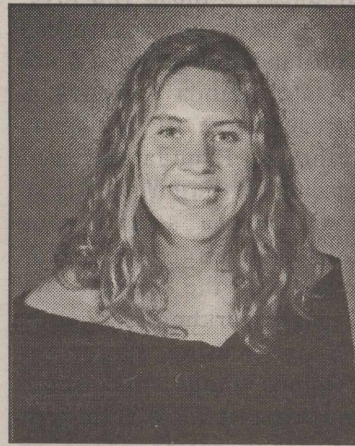

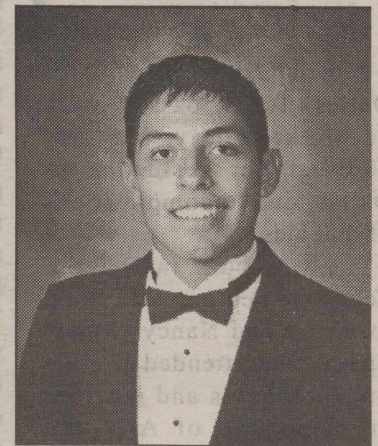
### 2nd Annual Clay Antilley Invitational Golf Tourney set

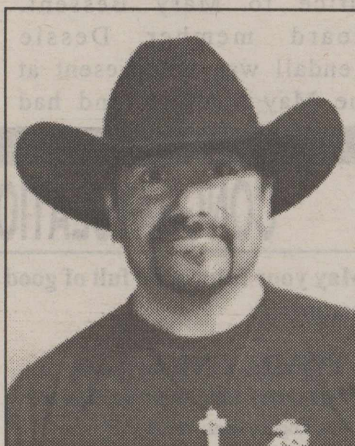

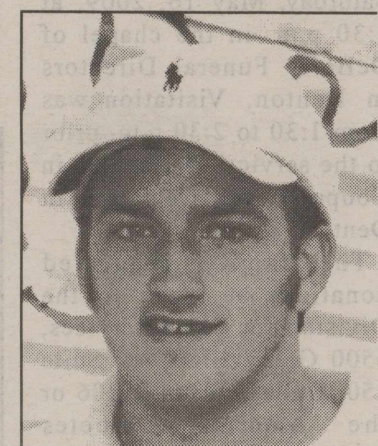

The Board of Directors of the West Coke County Hospital District met May 18, 2009, in regular session in the conference room of the Robert Lee Care Center. Members present were Mary Bessent, Mike Lomas, Marilyn White, and Pat Stephens. Others present were Janie Munoz, Business Office Manager, and Roger Alexander, Administrator. President Bessent called the meeting to order at 9:32 am, declared there was a quorum, and gave the invocation. Judge Roy Blair was present to administer the oath of office to Mary Bessent. Board member Dessie Kendall was not present at the May meeting, and had

already been sworn in. The Board elected to leave the currently presiding officers to serve in the same capacity for the coming year. The minutes from the April meeting were approved. The Board voted to officially name the Robert Lee State Bank as depository of funds, and the Board meeting day will continue to be the last Monday in the month, unless circumstances dictate otherwise.

In the staffing update, Roger Alexander reported the facility currently is in need of an LVN 2 days a week, and 2 CNAs. The Board discussed the hiring of some RLHS students to begin training. He feels the staff is doing an outstanding job in caring for the residents. He also gave an update on the Alzheimer's Unit. There are six residents currently in the unit.

In his report on accounts receivable, Roger stated that he and Janie continue to persevere, as they are still experiencing some challenges.

In public relations, the brochures are complete, and everyone is thrilled and gratified with the wonderful results. Last week, Janie Munoz and Mary Rodriguez attended the Spring Fling, a program sponsored by the AAA (Area on Aging Agency) to inform senior citizens about services and products available in the area. They passed out approximately 1000 brochures, as well as pens, bags, and popcorn in a cup with the Care Center logo. Janie said it was well attended, and the day was hailed as a great success. Many thanks to Janie and Mary for representing the Care Center in this capacity.

Under capital projects, Roger reported the painting and repair of the old Clinic building adjacent to the Care Center should begin next week. They are still awaiting the arrival of the new beds, which should be in the last week in May. The financial report was discussed and accepted.

In his Administrator's update, Roger informed the Board there would be a fish fry appreciation luncheon held for the staff sometime in June. This will be in celebration of the good results of the state survey conducted at the facility. **Simpson-English exchange vows**

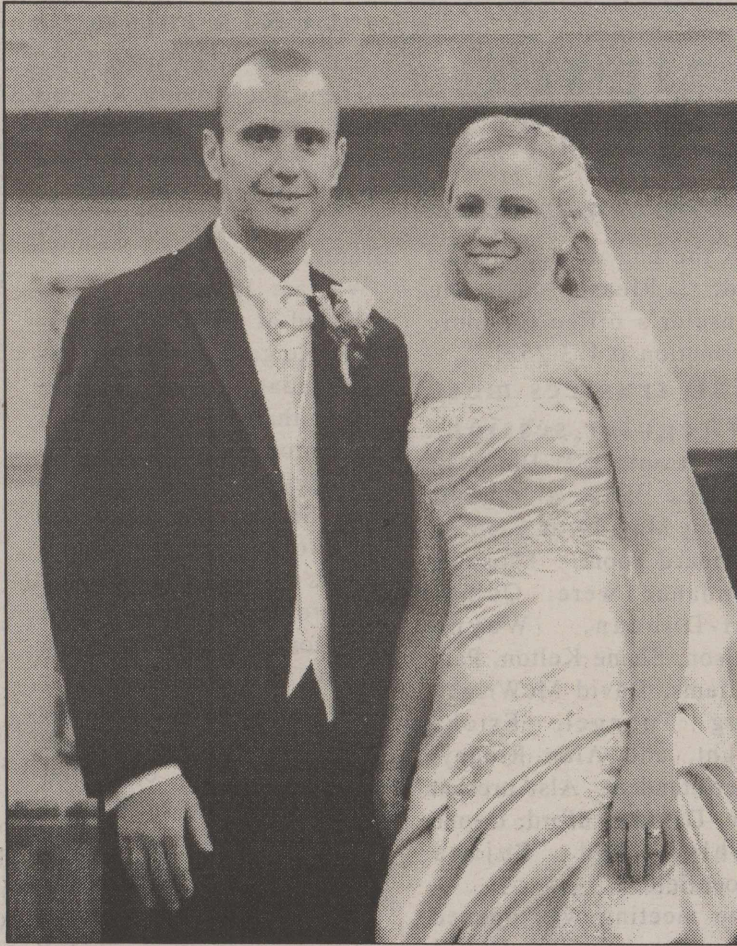

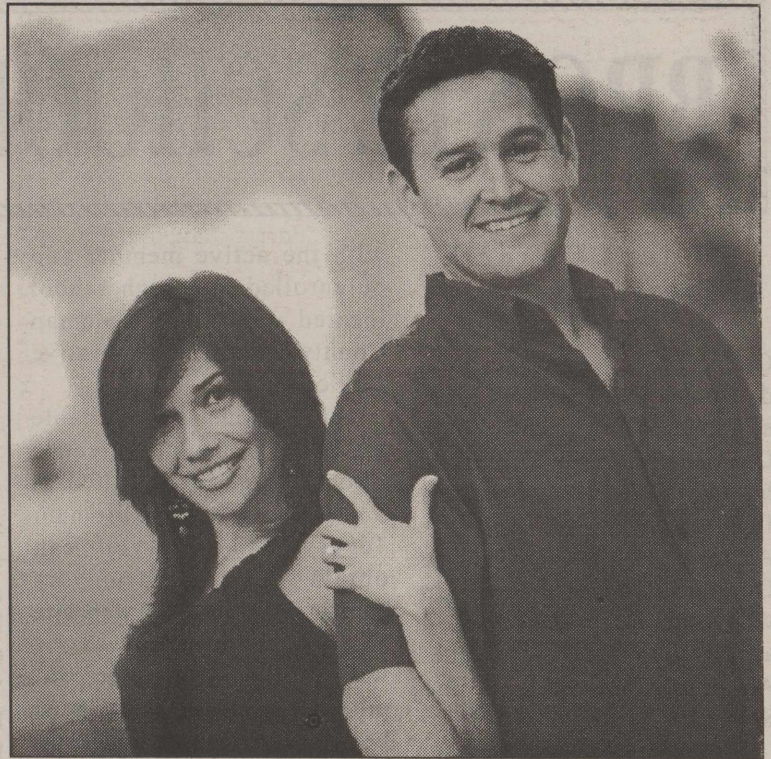

## Click It or Ticket kicks off

Against the backdrop of their mangled pickup, two Salado teens joined transportation officials and law enforcement officers at the Capitol recently to launch Texas' biggest-ever Click It or Ticket campaign. Ethan Mitchell, 17, and Trey Mohler, 14, walked away from a potentially deadly

rollover crash with only minor injuries and talked about how safety belts saved their lives.

The high school students are part of the Texas Department of Transportation's latest public education campaign designed to reach 18- to 34-year-old motorists, a group more likely to be involved in traffic crashes and less likely to buckle up than other age groups.

TxDOT also is going to other great lengths to call attention to the importance of buckling up. Beginning May 8, five inflatable characters-including Godzilla, a rock star icon and a rubber duck-will travel to major cities across Texas. Looming more than two stories tall, these unconventional messengers will warn Texans that thousands of state troopers, police officers and sheriff's deputies will be on Texas streets and highways between May 18 and 31, including the Memorial Day holiday weekend, to enforce the state's safety belt laws.

"We are happy that more than 90 percent of Texans obey the law and buckle up, but we're pulling out the stops to reach pickup drivers and passengers, teen drivers and other hold-outs who haven't gotten into the habit of using their safety belts," said John Barton, TxDOT's Assistant Executive Director for Engineering Operations. "Buckling up is the single, easiest thing motorists can do to protect themselves from death or serious injury if they're involved in a crash."

Drivers and front seat passengers can be ticketed for not wearing their safety belt as can drivers who do not buckle up their children. Safety belt violations can result in fines ranging from \$25 to \$200.

The eighth annual Click It or Ticket enforcement effort is supported through partnerships with the Department of Public Safety (DPS) and the National Highway Traffic Safety Administration (NHTSA), as well as local law enforcement agencies. 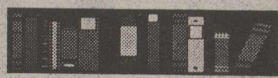

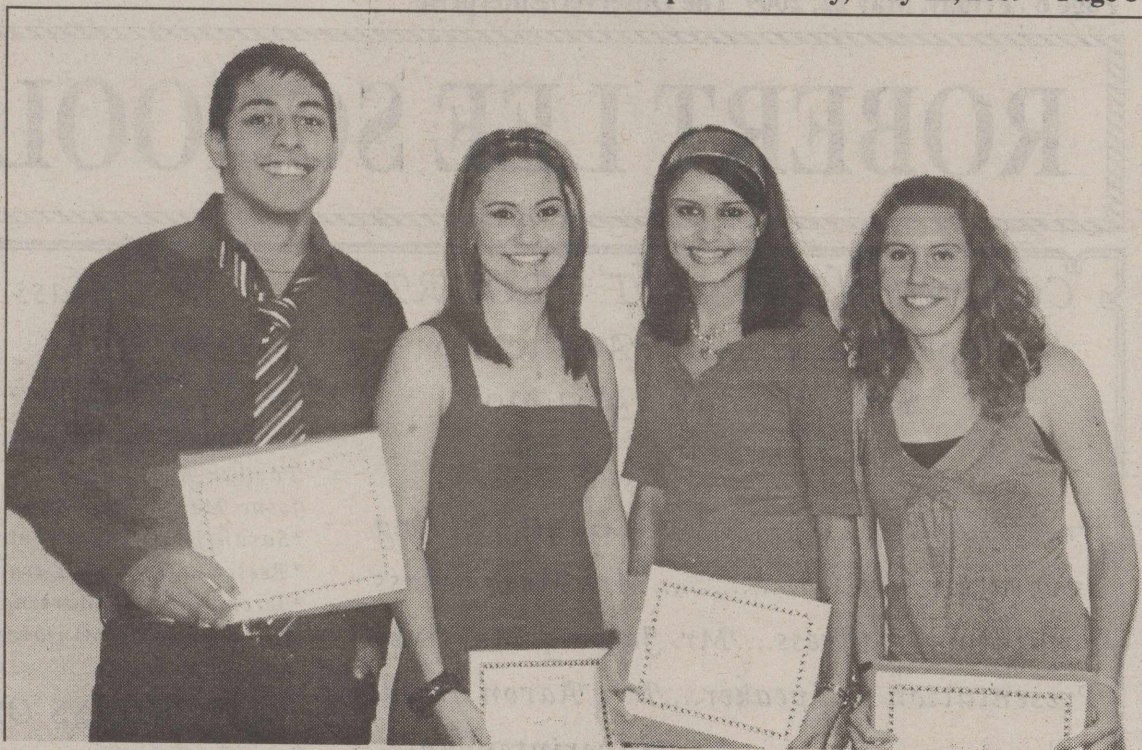

**Steers capture second State Title**

The Robert Lee Steer golf team came back from Austin with its second state Class A golf title in 2 years. The Steers dominated the competition at the state tournament (May 11-12) by firing a 313-314-627 total, out distancing second place Gruver's 333-328-661 total by 34 shots. Sophomore Logan Philley and senior Mason Ross led the Steers scoring as both brought home medals in the medalist competition. Philley, who finished as second medalist in last year's State Tournament, fired rounds of 69-71 for a 4 under total 140 on the par 72 Morris Williams Course. Philley's round not only won this year's tournament, but was the second best 36 hole total of any Class A/B medalist in the history of the State Tournament, dating back to 1949. Charley Coody, in 1954, playing in the Class A division (divisions consisted of AA, A&B), bested Philley's score by one stroke with a 139.

Ross made his final tournament of his high school career his best, as he shot rounds of 75-77-152 total, good for 3rd place and the Bronze medal. Sophomore Haden Dillard finished just outside the top ten medalists with rounds of 84-80-164 total. Philley, Ross, and Dillard were all members

of last year's state championship and all markedly improved their performances at this year's tournament. Rounding out the Steers team scoring were sophomore Foster Allen's rounds of 85-86-171, good for a top 20 finish in a field of 56 players, and junior Cody Brosh's rounds of 91-91-182.

Final result: 1) Robert Lee 627, 2) Gruver 661, 3) Malakoff Cross Roads 685, 4) Flatonia 687, 5) Irann 706, 6) La Rue Lapoyner 707, 7) Riesel 723, 8) Stamford 731.

The State title completed a great year for the Steers as they went through their season winning the District, Regional, and State titles and losing only to Sonora by a single shot at Christoval's Tournament. Sonora went on to finish as the runner-up at the Class 2A State Tournament.

Philley had an outstanding

year by winning medalist honors at invitational tournaments in Robert Lee and Christoval and then capturing medalist honors at the District tournament, finishing as the runner-up medalist at Regional, and capping it off with a great State Tournament win. Philley's season average was 71.5.

Other team members also had outstanding seasons with Ross finishing 4th at the District tournament to go along with his 3rd place finish at State and posting a 78.8 average. Dillard took 2nd place honors at the District Tournament and 3rd at the Regional Tournament and had a very respectable 80.0 average. Foster Allen had his best round of 78 at Regional and finished with a respectable 84.1 average and Cody Brosh had his best round at Regional with an 83 and finishing with an 86.6 average. With 4 returning players, the Steers are already looking forward to next year.

From the battle of the Alamo, when Colonel William Barret Travis and his men stood their ground, declaring "no retreat, no surrender" and sacrificed all for the freedom of their nation - to the young men and women who are laying down their lives on foreign battlefields today - generation after generation, our state's men and women have exhibited the indomitable Texas spirit of service and patriotism.

Stretching back to the American Indian Wars, 70 Texans have been awarded the Congressional Medal of Honor for their heroic service. And many of them died earning that distinction.

During World War II, a young B-24 pilot from Fort Worth named Horace Carswell was flying a single-craft mission to take out a convoy of Japanese ships in the South China Sea. After scoring direct hits on the target, Major Carswell's

aircraft was badly damaged. Through skillful flying, he kept the staggering bomber in the air long enough to make it to land so his crew could safely parachute onto the Chinese shore. Major Carswell and his copilot were killed in the crash landing, but through his courageous actions, the rest of his crew survived.

He was posthumously awarded the Medal of Honor, and Carswell Air Force Base outside of Fort Worth was named in his honor.

### 2009 Elder Abuse Campaign: Get Involved

May is Elder Abuse Prevention month and Older Americans Month, and Adult Protective Services (APS) is reminding Texans that stopping elder abuse is truly everyone's responsibility.

No one knows exactly how many older Texans are being abused, neglected, or financially exploited. Many victims are too embarrassed to ask for help, and their suffering can be shrouded by secrecy.

As our population ages, statistics show the problem is a growing concern: nationwide studies estimate that three to five million seniors age 65 and older have experienced abuse, with only one in five cases reported.

In 2008, Texas APS, a division of the Texas Department of Family and Protective Services (DFPS), completed almost 70,000 investigations of abuse, neglect or exploitation involving adults living at home. Of those, more than 48,000 cases were confirmed, with most cases including physical or medical neglect.

In these cases, it was often family members - adult children, spouses or grandchildren - who were the perpetrators.

"Everyone needs to be diligent to ensure vulnerable adults are free from abuse, neglect, and exploitation," said Karl Urban, APS Assistant Commissioner. "Isolation places vulnerable adults at risk. That's why elder abuse prevention is everyone's business."

This marks the fourth year of APS' It's Everyone's Business campaign. It's a statewide effort to educate Texans about the pervasive problem of abuse, neglect and exploitation of the elderly and adults with disabilities, and to encourage citizens to get involved in making a

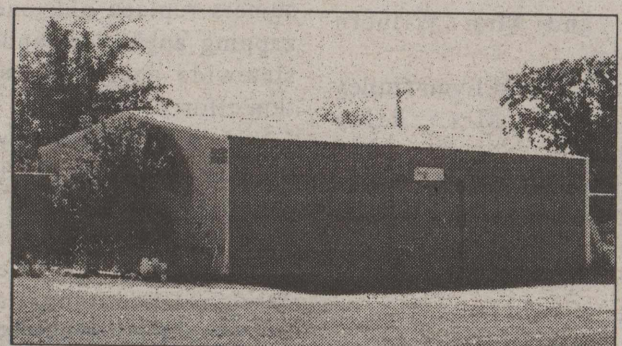

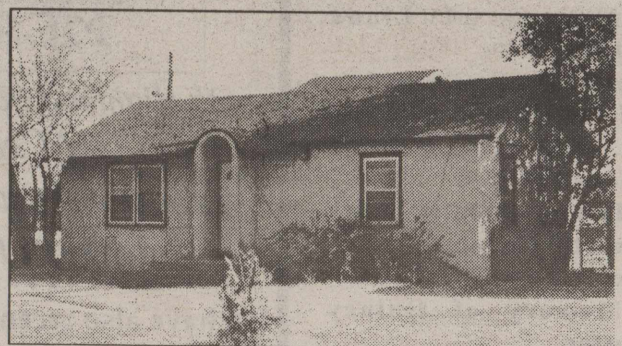

Another Texan who made an indelible mark on our nation's history is Master Sergeant Roy Benavidez, a daring and fearless soldier in Vietnam from Cuero. Sergeant Benavidez and his soldiers were ambushed on a secret mission in Cambodia, and despite suffering a broken jaw, sustaining 37 bullet wounds, and being stabbed with a bayonet, he exposed himself repeatedly to enemy fire and carried gravely wounded soldiers in his arms to safety. He was so badly maimed that his commander nominated him for a Distinguished Service Cross award because the Army was afraid he wouldn't survive long enough for the extensive Medal of Honor process to be completed. But he did survive, and was subsequently awarded the Medal of Honor. MSG Benavidez made service to his country his life's work. A bust of MSG Benavidez is on display at the United States Military Academy at West Point, where it serves as a tribute to his life and an inspiration to future leaders.

Preserving these legacies is critical, because, as President Ronald Reagan once said, "Freedom is never more than one generation away from extinction. We didn't pass it to our children in the bloodstream. It must be fought for, protected, and handed on for them to do the same, or one day we will spend our sunset years telling our children and our children's children what it was once like in the United States where men were free."

Today, a new generation of patriots is serving in Afghanistan and Iraq. Like many before them, some are paying for our freedom with their lives. In the early days of the war in Iraq, a 23-year-old Texan named James Kiehl was killed when his convoy was ambushed near al Nasiriya. His remains were brought home to Comfort, Texas, and on the day of his funeral something remarkable happened. Hundreds of men, women, and children from across the community lined the streets to honor their hometown hero and show support for his family as the funeral procession wound its way through the small town. He was one of the first Texans to lay down his life in combat. To date, more than 400 Texans have died in Iraq and Afghanistan.

Many of today's military heroes have not yet made it into the pages of history. But they are already solidifying a legacy of valorous service. Unlike many of the wars that were fought in previous generations, none of the men and women serving in Iraq and Afghanistan were drafted into service. Every single one of today's soldiers stood and volunteered to go. If you ask one of our troops or the family of one of our fallen heroes why they volunteered,

their responses are almost always rooted in patriotism and the desire to be a part of something greater than themselves.

Every day, I think of those Texans who have made the ultimate sacrifice. I think about the loved ones who miss them. It is fitting for our nation to pause and remember them on Memorial Day. But to truly honor their service, we must always cherish liberty, work to keep America free and strong, espouse the values for which our troops have fought and died, and pass down their memory to future generations.

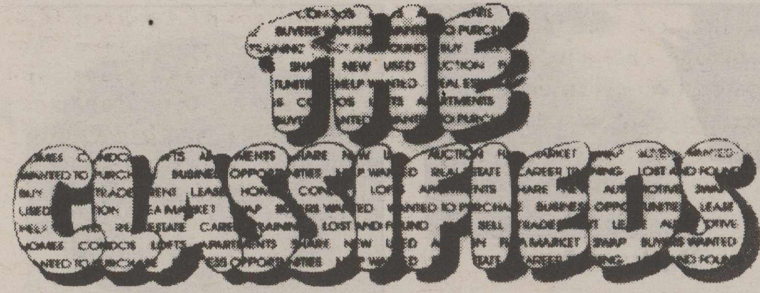

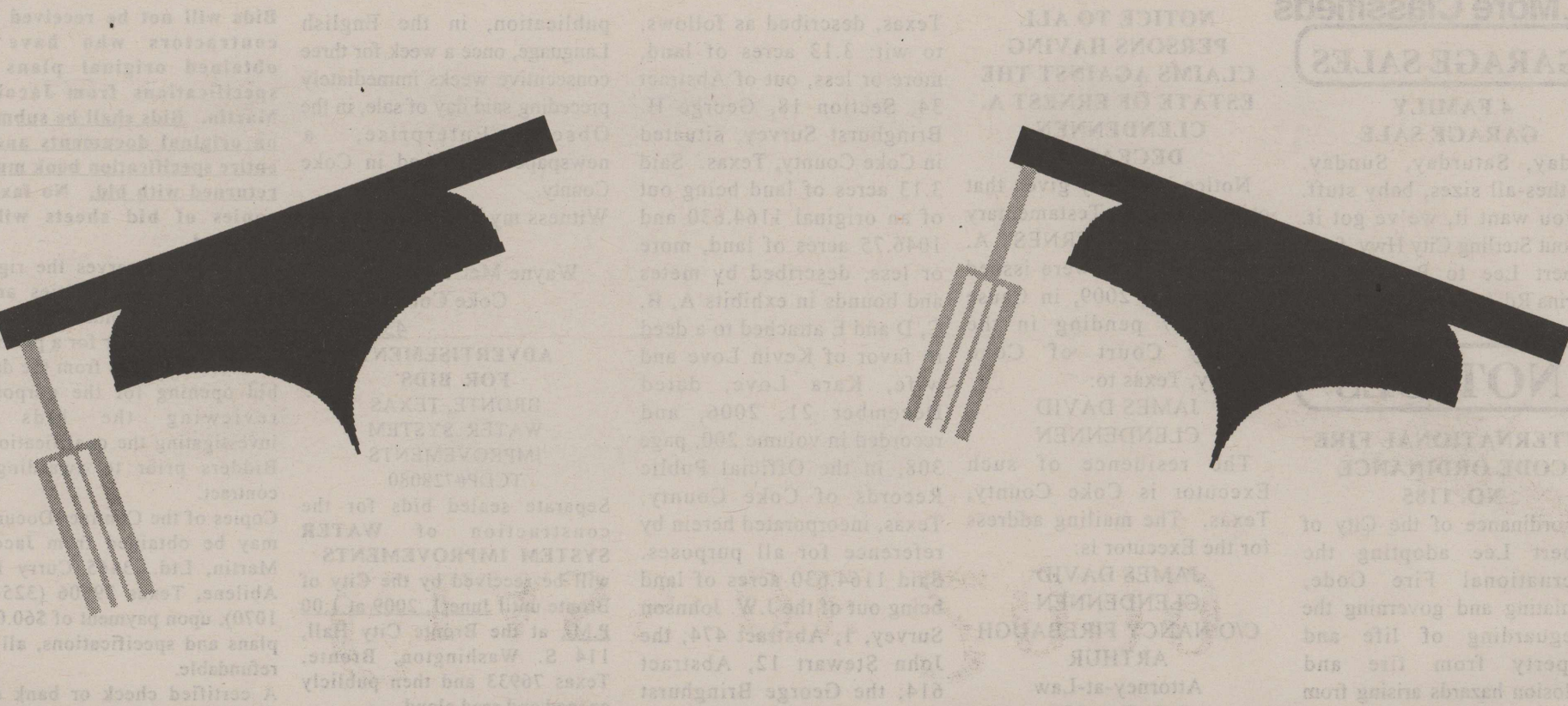
