Pecan Baptist Church rebuilds

In 1897, a small number of Baptist met under an arbor on Pecan Creek and organized Pecan Missionary Baptist Church. John Reed, a minister since 1895, gave land for the church. Members worshipped there until 1903, then built a site at the foot of Green Mountain. Nearby Pecan Creek and Dripping Springs served as a baptistery.

In 1934, they built again, adding a fellowship hall and classrooms. On October 9, 2006, in the early morning, the sanctuary was destroyed by fire. By the grace of God, they have built a new and beautiful sanctuary and are going forward doing God's work.

On Saturday, September 12, at 2 pm, the church members, led by Brother Jim Dominey, will host an open house so the public may have an opportunity to view the church. With its 16 stained glass windows, everything is new and welcoming.

Beginning Sunday morning, September 13, through Wednesday night, September 16, a revival will be held. Brother Bill Rogers will be the visiting preacher and Daryl Copeland will be the song leader.



Big Country Beef Conference set for August 27 in Abilene

Texas AgriLife Extension Service's Big Country Beef Conference has been set for Thursday, August 27. The biennial conference starts with registration at 8 a.m. in the Big Country Hall adjacent to the Extension offices Center grounds. This year's event will cover everything from the current status of the national animal identification system to maintaining herd performance during droughts.

The conference is the largest and most comprehensive educational beef program in the Big Country. We typically draw speakers and participants from across Texas.

Session 1 of the program will begin with a beef industry outlook given by Mr. Tim Niedecken, Executive Director of Assn. Services of the Texas and Southwestern Cattle Raisers Association. David Extension Economist from in the cattle markets.

Session 2 will begin with (Continued on next page)

Bruce Voyles with Global Animal Management, Inc. Coke County Courthouse, discussing age and source 13 E. 7th Street, Robert Lee, verification program and the technology available to producers. Mike McCravey, industry relations manager for the Texas Beef Council will then highlight activities of the beef checkoff, a producer-funded marketing and research program designed to increase domestic and/or international demand for beef.

Session 3 will begin after lunch with Dr. Ron Gill, Livestock Specialist with the at the Taylor County Expo Texas AgriLife Extension Service from College Station will be covering how to maintain herd performance during drought. Regmund with the ADM Alliance Nutrition, Inc will then discuss mineral programs and how they help pay for themselves. In our fourth and final session, Mac Devin DVM with Fort Dodge Animal Health will discuss understanding and managing bovine trichomoniasis. The primary production and economic impact of trich is that it causes infertility and abortions and often extends the breeding and calving season. Anderson, Mike Edington D.V.M., with the Coleman Vet Clinic will College Station, will then conclude our conference with discuss current market trends a special look at stocker health management.




Alvin Torres passed away on Monday, August 10, 2009, in Robert Lee.



Lenses that absorb and block UV are one of the strongest defenses against eye and eyelid damage, so it's best to wear sunglasses year-round whenever you are out in the sun. 

The Treasury issues an IOU to Social Security. The U.S. Government spends the money in the Treasury plus more. Since the Treasury operates at a deficit and borrows money from China, the Social Security System, and other sources every month to remain solvent, the odds on the Treasury being able to pay back Social Security in the year 2017 without additional borrowing will be remote. But don't worry, 2017 is eight years from now and the cash to repay the IOUs will show up. I have no doubt that it will. It will appear in the form of higher and higher taxes and inflation. But again, there is nothing to worry about. In eight years, Government health care program will be full blown and this will take the financial burden off the taxpayer for their health concerns.

I can understand why Conaway and the other 534 members of the House and Senate are not putting total effort into stopping our trip down the Socialist Road. They have their own retirement plan, not Social Security. They will have

their own medical plan, not the one due for a vote in Washington. Let's stop dead in our tracks right now and choose the Road marked "Liberty". Call your congressman now and demand that bills be introduced and passed that will force Congressmen, Senators, and all Federal employees to share in the







Cell Phones in Prisons Mean Business as Usual for Convicted Criminals

Our nation faces a growing threat from crime syndicates and other dangerous felons that operate inside the very facilities meant to keep them and their illicit activities off our streets and out of our communities. Imprisoned convicts coordinate murders, plot extortion schemes, and run drug trafficking, credit card fraud, and identity theft enterprises. These dangerous operations are increasingly facilitated by contraband cell phones smuggled to inmates. This problem is growing at such an alarming rate that it threatens not only the lives of the security professionals who work in these American prisons, but the general public as well.

In 2008, correctional facilities across the nation reported startling numbers of confiscated phones. For example, the federal prison system located more than 1,600 contraband communications devices, and in Texas alone, there were 1,162 cases. This year, there are already nearly 700 illicit cell phone cases in

Texas. These numbers are even more disturbing because they represent only the phones that were actually found.

Prisoners are using increasingly sophisticated methods to smuggle phones into correctional facilities and then conceal them from authorities. A single phone is often shared among many inmates, and just a few phones inside a prison can lead to coordinated attacks both inside and outside prison walls. And we have seen how effective these tools are for spreading violence. Escape attempts coordinated by contraband cell phones have resulted in the deaths of corrections officers. Prisoners have also used them to intimidate witnesses and local officials and to carry assassination attempts. In Maryland, a witness for an upcoming trial was gunned down in his front yard after a prisoner gave the murderer his address from a cell phone. At a recent Senate hearing, Texas state senator John Whitmire shared an account of how he was and his family were subsequently subjected to harassment and death threats.



Most importantly, to ensure the

integrity of wireless networks for public safety and commercial wireless providers, and minimize before permitting the use of any chance of interference, the legislation outlines the coordinated efforts from all stakeholders, including prisons and the telecommunication providers.

Some have suggested that there are alternatives to Safe Prisons Communications many of these technologies present problems for corrections departments because of their high cost, or because they may be useful at detecting phones, but not preventing their use.



Beware the Skunks! - Keep your Pet Safe and Odor-Free in the Great Outdoors

With the fall season in sight, many of us will venture to the great outdoors and go camping. All kinds of fascinating creatures can be found in the great outdoors, but when your puppy is roaming around, beware the skunks! Puppies especially can become curious when they come across these foreign creatures, but skunks are startled easily and have no mercy. The skunk odor, which is actually a poison, can sometimes take years to remove from a dog's fur.

Skunks have an incredible talent for spraying with accuracy. They also have the ability to spray multiple times in a row, reaching up to ten feet away. The spray that a skunk emits is a type of oil, accompanied by a horrific odor that will seep deeply into a dog's fur. Thankfully, there are multiple options for getting rid of the odor.

Most people believe that tomato juice is the best remedy for getting rid of a skunk's odor, but this is in fact, false. Tomato juice is not very effective on animals and will sometimes stain a light-haired animal's fur. Tomato juice is also very acidic and is thought to be harmful to cats, but it is not known for certain just how harmful. Better options include hydrogen peroxide, lemon juice, dishwasher detergent, or a variety of commercial products that are available at local pet stores or from your veterinarian. While commercial products are more costly than home remedies, they are often more successful at removing the odor on the first try.

The smelly skunk spray should not be the only concern to pet owners. Skunks carry rabies without showing signs of the symptoms. One bite from a skunk and your pet could become infected with the rabies disease; his life in danger. If there is a chance your pet has been bitten by a skunk, Dr. Blue-McLendon stressed that you should take your pet to see a veterinarian immediately, if there is even a chance it has been bitten by a skunk.

Skunks like to hide in dark places, so it is a good idea to train your pet not to go under houses or decks, and always have them updated on their rabies vaccinations.

"If you own fruit bearing plants, remove the fallen fruit quickly to reduce food sources that may keep skunks coming back to your property" said Blue-McLendon. "There is no way to train your pet to stay away from skunks," noted Blue-McLendon. Most pets will keep their distance after being sprayed once, but some pets never learn their lesson, and continue to be sprayed by the paranoid skunks.

If so, you may want to fill out a new W-4 form with your employer and recalculate your withholding allowances.

* Do you expect significantly higher (or lower) deductions this year? (For example, deductible mortgage costs or medical expenses.)

* If you make quarterly tax filings, have you allocated enough to ensure you won't pay a penalty next year?

* Has your home property value dropped significantly in recent years? If so, you may be able to request that your property taxes be reevaluated.

* If you plan to buy a home or new car this year, have you investigated tax credits for which you may be eligible? Go to www.irs.gov and search for "Recovery Act."

Charitable contributions. If you don't have charitable contributions automatically deducted, tally up what you've contributed so far and decide if it's in line with your goal for the year. Don't wait until the expensive month of December to make last-minute contributions.

Reimbursement accounts. If you participate in employer-sponsored health care or dependent care reimbursement accounts, determine whether you're on track to exhaust your account balances. Again, don't wait until year's end to scramble for qualified expenses that will allow you to fully benefit from their tax advantages.

Regardless of whether the worst is behind us or not, it makes sense to get your own financial house in order to weather this economic storm and any future ones.

TDA Market Recap Aug. 10, 2009

For the week ending Aug. 8, 2009, feeder cattle price trends at Texas auctions were mixed, from \$4 lower per hundredweight to \$4 higher compared to a week

...Financial Tuneup earlier. Fed cattle prices were \$1 lower on a decline in beef prices and a growing backlog of available cattle in feedlots. Cotton prices were higher amid prospects for improved global demand. Grain prices ended the week lower due to a stronger dollar, lower crude oil prices and favorable growing weather in the Midwest. As for futures markets, cotton and lumber were higher, while feeder cattle, finished cattle, wheat and corn were lower. Central and South Texas received little or no rainfall again last week, while other areas of the state recorded up to three inches of rain. Cotton progressed well in areas that have received rain, but some hail damage was noted on the High Plains. Bolls are opening on 13 percent of the acreage with the crop reported in mostly fair to good condition. Corn is 48 percent harvested, well ahead of the normal 30 percent by this date. Grain sorghum harvest is also ahead of normal at 53 percent complete. Wheat field preparations are underway in many areas. Rice is in mostly fair to good condition with 28 percent of the acreage harvested. Pasture conditions are highly variable depending on rainfall received with ratings from very poor to good. Topsoil moisture was rated short to adequate in many areas, but was mostly very short in the Upper Coast, South-Central and South Texas regions.
