# **Blaylock, Lee win commissioners' races** in primary election

Coke Countians went to the US Representative Mike polls on Tuesday, March 2, to elect a couple of commissioners on the east side of the county, and cast their ballots in some other important local and statewide political races.

Starting with the commissioners' races on, the east side, incumbent Bobby Blaylock defeated Joe Sefcik by a total of 59 to 41 in the precinct 4 race, and Wendell Lee totaled 74 votes to defeat incumbent Robert Feil, who had 45 votes in the precinct 2 race. Neither race has a Republican contender for the general election.

Staying with the Democratic Party, Kathi Cox defeated Ronny Brown in the race for the democratic nominee for county treasurer by a vote of 225 to 131. Cox will face Hal Spain in the general election, as he 2010. totaled 240 votes in the Republican primary election.

In the only other locally contested race, Jackie Walker defeated Judy Gartrell by a count of 126 to 73 to become the Democratic nominee for Justice of the Peace, Pct. 1. Leroy Casey will be the Republican nominee, with a total of 123 votes.

Coke County was the governor's race, which Rick

Conaway totaled 212 votes over his opponents Chris Younts 69 votes, and Al Cowan 17 votes; Lieutenant Governor - David Dewhurst 246; Attorney General - Greg Abbott 243; State Representative - Drew Darby 253; and County Republican Chair - David Kitten 231 votes.



The financial statements were discussed and approved.



### **Coke County Food** Pantry

The Coke County Food Pantry is located in Robert Lee at 714 Austin Street and is open each Wednesday from 2:00 pm to 4:00 pm. Each first time shopper must provide a proof of address in Coke County. One member from a family is allowed to shop and will be given a shopping bag. This bag is to be brought back each week to be used again. Only one back will be furnished. Each shopper is allowed to fill their own bag, but there are rules that must be followed. All types of products are available-canned vegetables, fruits, soups, meats, dry products, such as macaroni and cheese, rice, beans, pasta, soup mixes, etc. Also, there is canned milk, dry milk, crackers, corn meal, cornbread mix, flour, sugar, etc. There are frozen products available at times. The Food Pantry is a very small version of a grocery store. Three shoppers are allowed in the Food Pantry at one time to make choices and fill their bag. The vounteers help them to find products so that their shopping can be done in an expedient manner. If fresh produce, bread, and

cakes/pies are available those celebration of the exquisite items are put into a plastic bag furnished by the Food Pantry (this is what we call a free food because it doesn't take up room in their shopping bag). These foods are perishable and can't be held over until the next week. We are fortunate to have some fresh and dried produce donated by individuals and local businesses.

Food is purchased weekly at the Concho Valley Food Bank in San Angelo. Two of our volunteers go every Tuesday to shop and are met back at the Food Pantry by other volunteers to help unload and stock shelves.

In the last quarter of 2009 the numer of families receiving food was 658, the total number in these families was 2044. The number of children was 345 and the number of adults 65 and over was 341.

As time goes by there seems to be more of a need in the County and it is more difficult to get what is needed with the resources we have. We would appreciate donations either of canned food, frozen food and/or money to purchase food. So,----if anyone is cleaning out a freezer or a pantry, please think of the Food Pantry. Also, when shopping, please consider picking up a few extra items to be donated to the Food Pantry. It's hard to think that children or adults in our County could be going to bed hungry, but this is a reality. Please donate if you are able--we need your help.

"R U Safe? Protecting Yourself in Cyberspace" is designed to educate children and their parents about online dangers and give them the tools needed to be safe while online. The DVD was created by the Texas Young Lawyers Association (TYLA) and is available for viewing and downloading at http://www.tyla.org or may be requested by calling 512.427.1529.

"These statistics are shocking," said Cori Harbour, TYLA President. "Research indicates that teens who've talked to parents or guardians ignore messages from unfamiliar people, refuse to reply or chat, block unknown senders, and report these occurrences to trusted adults. Education regarding online safety is proving instrumental in the fight against online predators."

"We wanted to begin a conversation with children that they need to have some accountability when it comes to social networking and technology," said Alyssa Long of San Antonio, a chair of TYLA's Cyber Awareness Committee. "There are not only personal protections kids have to take when they're online, but there are legal consequences to some of these activities. Young people may not be aware that they can get arrested for things like sexting and cyber bullying."





Hand Delivery of **Census Ouestionnaire** launches in rural Texas Here we come. Many rural Texans will begin receiving their 2010 Census forms this week as trained Census workers begin the handdelivery of a million questionnaires to households without numbered street addresses and to those in other areas, such as the coastal areas ravaged by hurricanes and the colonias the Texas-Mexico along border.

Census workers hit the country roads starting March 1 to begin the first major operation of the 2010 Census: the enumeration of an estimated 25 million rural residents across the country and almost 4 million in Texas. The operation runs through the month of March and marks the beginning of the 2010 Census questionnaire delivery. Although it will cover almost two-thirds of the geography

of Texas, almost 90 percent of Texas' 8.2 million households will likely receive the Census questionnaire by mail, the least expensive mode of delivery, around the third week in March.

The questionnaires are handdelivered to rural areas to update hard-to-register addresses and to ensure that each household receives a questionnaire. These on-site visits are necessary because the Census Bureau relies on counting individuals at specific physical addresses to prevent counting people twice.

Household occupants will be asked to fill out the answers to the 10 questions and return the completed form by mail. It's important to note that Census workers will not ask for any information during this operation other than to ask you to complete the questionnaire and to mail it back. If no one is home, the enumerator will leave the questionnaire in a plastic bag

on the doorknob or nearby.

"We're going to bring it right to your door," said Gabriel Sanchez, Dallas Regional Census Director. "It will either come in the mail or we are going to take the extra step of delivering it in person."

In Texas, the so-called update enumeration will involve mobilizing perhaps 6,000 enumerators and support staff to cover the four-week operation. They will deliver questionnaires to more than 1 million Texas households.

You can identify official Census workers by their government identification badge, the confidentiality notice in their possession and the questionnaire. Some workers may also be carrying a Census tote bag. Census workers in this operation will not ask for any information and will not ask to come inside your house.

Census Day is April 1, the day that the law requires you to be counted at the address where to live and sleep most of the time. In mid-March, the Census Bureau will mail questionnaires to 145 million households in the United States, the largest mass mailing in the history of the county and the least expensive way to reach 90 percent of those who live in the United States.

The Census is especially important to farm communities and rural communities. While Texas' overall population grew by 12.7 percent from 2000 to 2005" nearly twice the national rate -- its rural population grew much slower and its proportion of the overall population declined. Of Texas' estimated 24.8 area lost population between Texas Comptroller of Public Accounts study of U.S. Census data.


Because congressional representation is entirely dependent on the Census count -- and the disbursement of federal dollars is based, in part, on population figures -- getting an accurate Census count is

vital for rural Texas and its many communities. In 2008 alone, the federal government spent billions of dollars on rural and farm programs, including \$909 million in crop insurance, \$42 million in livestock compensation programs, \$279 million in crop disaster assistance and \$21 million in rural rent assistance

Rural areas also present special difficulties in getting a full and accurate count. Farflung homesteads are often difficult to locate and migrant farm workers can be difficult to include because of the mobile nature of their livelihoods.

Promoting the Census in rural Texas is one way to ensure the continued economic vitality of one of the nation's most important agricultural and cultural areas. It's also safe. All information remains strictly confidential: Census data is not shared with any individual or other government agency. So encourage your neighbors to fill out the Census questionnaire when it arrives in mid-March. Mail it back by the first week of April and a Census worker will not knock on your door in May.

The Census is mandated in Article 1, Section 2 of the U.S. Constitution. The 2010 Census is the nation's 23rd.
