- October 26 is the last day to apply for a ballot by mail. (The application must be received and not just postmarked by this date).

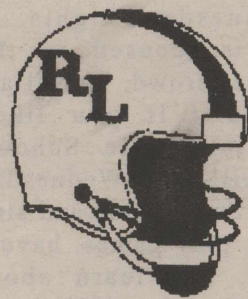
- October 29 is the last day of early voting.

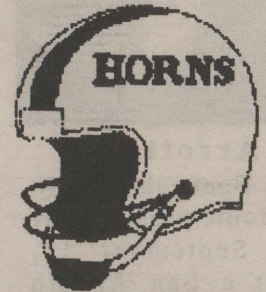

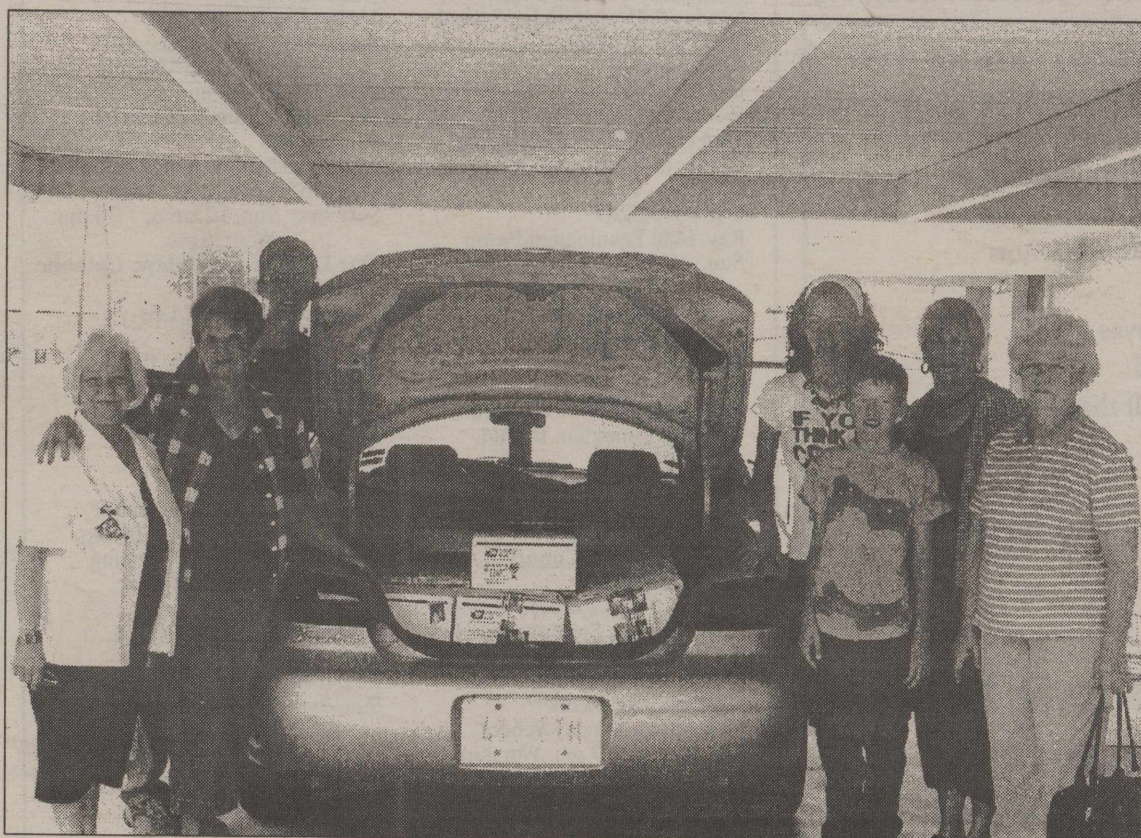
Flu Shot Clinic set for October 8

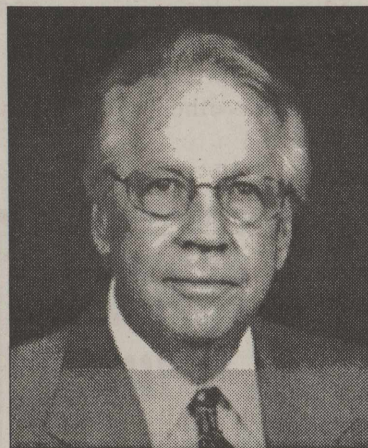

Longhorns drop one to Eagles

The Bronte Longhorns fell to 1-2 on the season as the Eldorado Eagles won a close contest 14-6 last Friday night in Eldorado. This game highlighted both defenses as yards were hard to come by for both teams. The stats show that as well as each team was held to under 200 yards of offense, but Eldorado held the edge in turnovers as the Horns turned the ball over 3 times and the Eagles just once.

The Horns scored first in the game on a one yard run by Nathan McGinnis that capped a nice 60 yard drive. The try for the extra point was missed. Good yardage was picked up on the drive by Jordan Baumann and Creed Coalson. The Horns were able to take advantage of a blitzing defense with some counters that created holes in the Eagle front.

The Horns played very well defensively as they held Eldorado's offense to 30 yards in the first half. They had been scoring lots of points and putting up lots of yards on their previous three opponents; so we were pleased with where we were at half. In the second half the Eagles made a few adjustments offensively, but the Horns defense was still really good. The Eagles had

a long scoring drive to start the second half. They tied the score on a two yard run at 6-6. The extra point snap was no good, but the holder was able to connect with a receiver for a two point conversion and the lead was 8-6. The Longhorns offense could not get on track for the remainder of the contest, and Eldorado was able to take advantage of a short field midway through the fourth quarter and score one more time to have the 14-6 advantage. This is two tough losses for the Horns in back to back games; so we will continue to work to improve in all aspects of the game.

The Longhorns will be without the services of Kerwin Rawls as he was injured in the second quarter of last week's game. Kerwin suffered a severe high ankle sprain that the Dr.'s casted on Saturday. He is believed to be in the cast for two weeks and in a boot the following week. His return is not known at this time. This week the Horns home opener will be against the Winters Blizzards. Winters is 4-0 on the season and have a lot of guys back from last year. Game time will be at 7:30.

Letters to the Editor

Dear Editor,

The Commissioners Court is required each year to have a budget that must be adopted before the fiscal year starts. For the 2011 budget the Commissioners Court decided that Pct. #1 constable needed a salary increase from \$7,992 to \$14,400 per year and the Pct. #2 constable's salary would increase from \$7,992 to \$11,196 per year. This unfair difference in salaries was taken before a salary grievance committee and a nine to zero vote allowed Pct #2 constable to receive \$14,400 per year also.

On September 1 and September 7, the Commissioners Court had a public hearing for the 2011 proposed budget. I attended the September 1 hearing and voiced my concern that a salary increase of 80% from \$7,992 to \$14,400 per year can't be justified. The county has also had an increase in health insurance for county employees from \$6,692 to \$7,869 per year, which is a 17.6% increase. If you do the math, a salary increase of 80% and hospital insurance increase of 17.6% equals a 97.6% increase in salary and benefits for one constable. The total cost for Pct #1 constable which includes retirement, social security, travel expense, and equipment expense, and salary is \$33,000 per year.

Are you aware that Pct #1 constable several years ago started receiving approximately \$750 per month from the city of Robert Lee to do law enforcement within the city? Two deputies on the west side of the county had been sharing the \$750.

Other county employees received a 3% raise and

thanks to Obama Care, we the taxpayers will be paying 17.6% more for county employees' hospital insurance.

Only two people were present from the public for the September 1 public hearing. We the people need to be more involved in all forms of government so things like this don't happen. On September 13 the budget was adopted for fiscal year 2011 which begins October 1.

Being an American Essay Contest focuses on American Citizenship

U.S. high school students and their teachers are invited to compete for nearly \$115,000 in prize money by participating in the Bill of Rights Institute's fifth annual Being an American Essay Contest. Top prize winners and their teachers will also receive all-expenses paid trips to the nation's capital.

The largest high school essay contest in the country, awarding 180 students and teachers with cash prizes and attracting more than 50,000 essays last year, explores the rights and responsibilities of American citizenship. The contest is administered by the Bill of

Rights Institute, a non-profit educational organization in the Washington, D.C. area devoted to educating children about the Constitution and Founding principles. The sponsors include the History Channel and the Stuart Family Foundation.

"This contest is unique in that it gives students the opportunity to think about the important civic values communicated in our Founding documents, and embodied by American civic heroes," said Dr. Jason Ross, Bill of Rights Institute Vice President of Education Programs. "This context is vital to helping students see their own acts of good citizenship as a meaningful part of the American experiment of self-government."

Specifically, students are asked to share their thoughts on American citizenship by answering the following question: "What civic value do you believe is most essential to being an American?"

The top three student winners and their teachers from each of the nine geographical regions will be announced at a special Washington, D.C. Awards Gala in the spring of 2011, where they will be awarded cash prizes of \$5,000 (First Place), \$1,000 (Second Place), and \$500 (Third Place). The winning students will also explore the nation's capital, meet contemporary American heroes and national leaders, and visit national landmarks.

Additionally, the contest will award 126 honorable mention prizes of \$100 to seven students and their teachers from each region.

"The contest not only honors and awards sponsoring teachers, but also equips them with free lesson plans and other supplemental materials that meet state and

national academic standards so they can easily incorporate the essay contest into their classrooms," said Being an American Essay Contest Director John Croft.

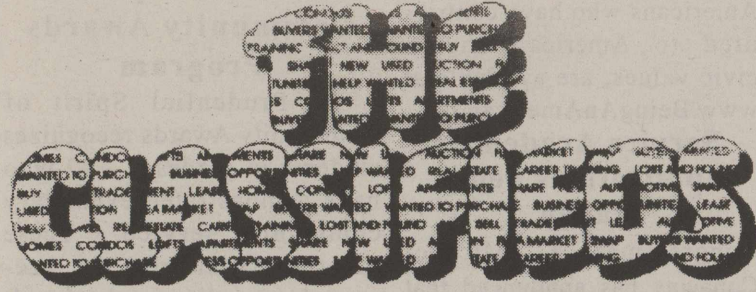

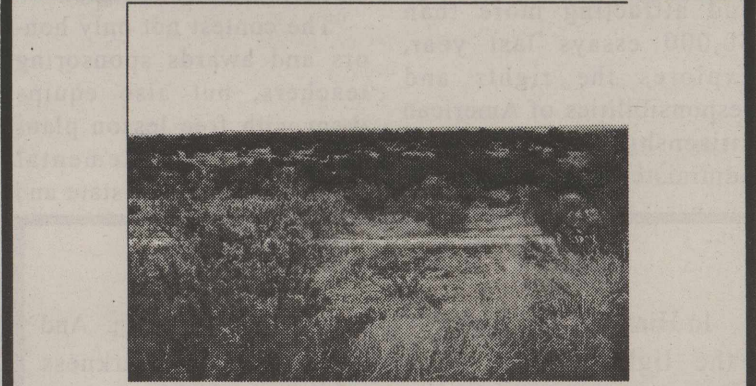

AN ORDINANCE ESTABLISHING NEW SCHEDULE OF RATES AND CHARGES FOR SERVICES RENDERED BY THE CITY OF ROBERT LEE WATERWORK'S SYSTEM

WHEREAS, the cost of chemicals, materials, utilities, and maintenance have increased to the point where the current schedule of rates is no longer sufficient to cover the increased cost, and

Customers outside the city limits receiving water shall be charged a minimum charge of \$25.00 with an allowance of 4,000 gallons. Consumption of 5,000 gallons and thereafter shall be charged \$3.52 per

thousand gallons.

Rates and fees charged to the Coke County Water Supply Corporation and the Snead-Corbin Water Supply Contract shall be subject to the same increase imposed in the City.

Service Fee of \$30.00 - disconnect/reconnect due to non-payment. After office hour reconnect fee - \$45.00.

Service Fee of \$20.00 - new customer accounts and transfers.

Section 2: Bulk water - \$.20 per barrel.

Section 3a: Water Tap Fees - 5/8"meter - \$225.00, 1" meter - \$300.00, 1 1/2" meter - \$400.00

Section 3b: Meter deposit - Owner - \$100.00, Renter - \$125.00, Commercial - \$175.00

Section 4a: Due date of bill - 20th of each month.

Late fee - \$4.50
Services may be terminated after the 28th day.

Section 4b: The City reserves the right to immediately and without notice remove the meter or disconnect water service to any customer whose meter had been tampered with and to assess actual repair charges to the customer plus a damage fee of \$50.00.

Section 5: Procedure when a customer challenges the amount billed for water used.

Section 7: It is hereby declared duly constituted by the City Council. Said Ordinance was duly passed by affirmative vote.

SECTION G:

COLLECTION CHARGES
The following rate schedule is hereby implemented as stated in Exhibit A of the Solid Waste Contract between the City of Robert Lee and Duncan Disposal:

(a) Premises inside city limits used for private residences, single mobile home sites and/or locations, shall be charged a base rate of \$14.54 per month per family unit as to occupied residences, apartments, and units, with one collection per week.

(b) Premises outside city limits used for private residences, single mobile home sites and/or residences, shall be charged \$15.64 per month with one collection per week.

(c) Premises used for commercial, business, and/or public purposes not receiving sanitation container service as described herein shall be charged \$14.54 per month with one collection per week.

(d) Charge for additional carts shall be \$9.22 per month, with one collection per week.

(e) Base rate may be adjusted monthly based on the previous month's cost of diesel fuel as published by the Department of Energy - Gulf Coast Region.

SECTION I:

CONTAINERIZED SYSTEM

The following rate schedule is hereby implemented as stated in Exhibit A of the Solid Waste Contract between the City of Robert Lee and Duncan Disposal:

(a) Public, private, business and/or commercial locations and sites, including certain private residences receiving a 3 yard sanitation container system shall be charged the following rate with one collection per week:

3 yard container 1x per week - \$40.98

3 yard container 2x per week - \$65.33

**TRASH RATE ORDINANCE
ORDINANCE #274** of the City of Bronte, Texas is hereby amended as to Section G and Section I to read as follows:

SECTION G

COLLECTION CHARGES

(a) Premises used for private residences, single or double unit apartment houses, single mobile home sites and/or locations, shall be charged \$14.20 per family unit as to occupied residences, apartments, and units. One polycart container will be provided for each trash service location. Additional containers will be provided for an additional cost of \$9.00.

(b) Premises used for commercial business, and/or public purposes not receiving sanitation container service as described herein shall be charged \$15.77 per month. One polycart container will be provided. Additional containers will be provided for an additional cost of \$9.00.

(c) Premises located outside the City Limits shall be charged at a rate of 1.5 times above the rate charged the City by its trash collection provider. Said premises must be served by another city utility for which a bill is sent.

(d) If polycart is lost or damaged by the resident, a \$60.00 replacement fee will be

assessed.

**SECTION I
CONTAINERIZED
SANITATION SYSTEM:**

(1) After the effective date of this ordinance, certain public, private, business and/or commercial locations and sites, including the City of Bronte are to receive sanitation container system service for the removal of garbage and trash under the rates and rules hereinafter set forth. Pursuant to the sanitation container system services, the City of Bronte will furnish a container or containers to be used in the collection and/or removal of garbage and trash. The following formula shall be used as to the fees charged for garbage and/or trash hauling to-wit:

Charges per month:

Container size:	Rate
2 yd. (1 x week)	\$63.34
4 yd. (1 x week)	\$100.71
6 yd. (1 x week)	\$134.95
8 yd. (1 x week)	\$169.19

This Ordinance Amendment supersedes any previous Amendments to the Section G and Section I.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRONTE:

That there is hereby levied and there shall be collected for the use and support of the municipal government of the City of Bronte, upon all property, real, personal and mixed, within the corporate limits of said City subject to taxation, a tax of \$0.390157 on each \$100.00 valuation of property, said tax being so levied and apportioned to the specific purposes here set forth:

For the maintenance and support of the general government (General Fund), \$0.390157 on each \$100.00 valuation of property.

SECTION 2. That taxes levied under this ordinance shall be due October 1, 2010, and if not paid on or before January 31, 2011, shall immediately become delinquent.
