# Huge show of support shown at public hearing

Over 150 Coke County citizens attended a public hearing Monday evening, September 27, at 6 pm in the Coke County Courthouse. The hearing's purpose was to inform the public and answer questions about the plans for the detention facility in Bronte.

Coke County Judge Roy Blair opened the meeting with an outline of the overall project. He explained ownership, financing, liability, operation of the facility, and its benefits to Coke County.

Judge Blair was joined in the presentation by Michael Croft, owner of Michael Croft Enterprises, Inc. and representing Stellar Solutions of Georgia, LLC, and Coke County Sheriff Wayne McCutchen. Joanne Powell, representing Congressman Mike Conaway, was in the audience, along with Robert Lee Mayor John Jacobs, Bronte Mayor Gerald Sandusky, Bronte and Robert Lee City Council members, Coke and County Commissioners.

According to Judge Blair, the facility will be owned by Coke County. Approximately \$28,000,000 will be needed for new construction and renovation of the existing facility. This money is coming through USDA grants and guaranteed loans. A corporation was formed, with directors from Coke County, to remove any liability from Coke County and its taxpayers.

The USDA loan and grant process is handled in two parts. Mr. Croft, along with Coke County officials, have satisfied all of the requirements and have been granted approval in part one of the

Over 150 Coke County citiens attended a public hearing was one of the many requirements monday evening, ments now satisfied for part two.

Operation of the facility will be under the direction of Michael Croft. A retired law enforcement officer formerly of Georgia, Mr. Croft has successfully operated correction facilities for over five years following a 28 year career in the Sheriff's Department. His experience includes rebuilding a closed facility and returning it to a productive and lucrative operation. He began working with the Coke County Commissioners Court and Sheriff McCutchen on this facility approximately two years ago. He is joined on this project by Robin McGowan Justice, owner of Stellar Solutions. Justice retired from the Georgia Department of Corrections after 20 years.

The facility, slated to open in early 2012, will house approximately 530 inmates and will be considered medium security. It will employ over 100 people once completed. Texas State Jail standards are the most stringent of all licensing agencies which may be used by those contracting to provide inmates and therefore, this facility will meet their criteria. Letters of intent for nearly 800 inmates have been received from other Texas counties.

Based upon the lowest possible per diem rate and at 80% occupancy, Coke County stands to add \$335,000 to county coffers annually. Economic impact of the facility to Coke County and the surrounding

## When it rains, it pours

by Hal Spain, Publisher Coke County and surrounding counties (mainly to the north and west) were inundated with some pretty hefty rainfall over the weekend. The rainfall was aided by an abundant supply of moisture from the gulf in advance of a cold front that arrived on Sunday.

As the old ranchers used to say, "that was a million dollar rain." This one would surely fit the profile, as conditions were dry all over the county with a burn ban in effect and a high possibility of wildfires.

As a result of last weekend's rainfall, the commissioners' court has lifted the burn ban for the county, at least for a few months.

As to totals, I've heard so many rainfall figures over the past two days, I can't keep them all straight. Let's start out with both Robert Lee and Bronte, as their totals were pretty much the same, somewhere around 4 inches, plus or minus. We did get a report of over 5 inches at the Robert Lee golf course.

Some of the worst flooding occurred at Hayrick and Cox Road just east of Robert Lee, with over 6 inches. The creek which crosses Cox Road was running over 8 feet deep, according to Deputy Randall Jacks. We have also heard some big rainfall totals in the Sanco area, which ran Yellow Wolf Creek, but have not been able to confirm that as of yet.

As a result of the flooding, water was 6 inches over the roadway just west of Bronte on Hwy 158 on Saturday, causing a one vehicle rollover. Water was also over the roadway just south of Robert Lee on 208. The Blackwell Ranch Rodeo was submerged and will be postponed until a later date.

Other rainfall totals from around the county include 2.6 inches at Edith, and from 2.2 to 2.4 inches around Lake Spence. Millard Smith recorded over 5 inches on the divide toward Water

Valley, and 5.7 inches was recorded four miles north of Bronte.

As to lake levels, this is what I have been able to ascertain from the USGS websites for Oak Creek and Spence. Oak Creek shows to be up a little over a foot, from 1991.70 feet (elevation) to 1992.80. Reservoir storage data from Lake Spence shows an increase of 840 acre feet from the storm, and an increase in elevation of about a half a foot. The Colorado River crossing at Silver was running at about 2 feet high on September 25. When the runoff got there, the river was running at about 6.5 feet deep on September 26, and has since dropped back down to less than 3 feet in depth on September 28.

Robert Lee Mayor John Jacobs stated that Mountain Creek was now up to from 1/2 to 2/3 full (about four feet from the top). He indicated that the City would wait about a week for the water to clear up, and start pumping from Mountain Creek. This inflow should be about a two to three month supply for the City.

In a related matter, the mayor also restated what he had discussed at the public hearing for the prison, which was held on Monday, September 27. The cities of Bronte, Robert Lee, and the Coke County Water Supply Corporation have entered into a contract with the engineering firm of Jacob and Martin. Engineers for this firm are to begin a feasibility study for additional water sources and the possibility of joint treatment facilities for the three entities. The mayor also stated that any and all possibilities for additional water sources and funding will be pursued.

Volunteers are needed to organize and recruit teams, seek community support, coordinate logistics, find



Absent Board members were excused from the previous meeting, and minutes from that meeting were approved. The Board went into Executive Session at 9:42 AM to discuss personnel


returning to regular session, the motion was made and approved to give Roger Alexander a one-time bonus. Roger is doing an excellent job, and the Board commends him highly.



## PUBLIC NOTICE

On September 17, 2010, Atmos Pipeline – Texas, a division of Atmos Energy Corporation ("APT" or the "Company"), filed a Statement of Intent to change its natural gas transportation rates for firm and interruptible customers and implement a new schedule of rates and riders applicable to all transportation customers receiving service under existing Rate Schedules CGS and Rate Schedule PT. The proposed effective date of the requested rate changes is October 22, 2010. If approved, the proposed changes will affect approximately 4 firm transportation customers and 63 interruptible transportation customers. APT's Other Revenue customer class is not affected by this filing.

If approved, the proposed rates will increase the Company's annual revenues by \$38.9 million. The proposed change in rates constitutes a "major change" as that term is defined by Section 104.101 of the Texas Utilities Code. In addition, the Company seeks to recover all rate case expenses as allowed by law. The exact amount of rate case expenses will not be known until the case is completed.



area will be at least \$18,000,000 per year.

The facility will provide 24 hour dispatch for all county EMS, fire, and law enforcement personnel. This will save the county approximately \$16,000 on an annual basis. An ambulance service with an EMT and paramedic will be on call 24 hours per day. Coke County will no longer have to pay to house inmates in neighboring counties, a savings of approximately \$75,000 annually.

Following the presentation, a question and answer session was held. During this time, Mr. Croft assured those present that he would personally oversee the facility. He promised not only to give priority to county residents during the hiring process, but also to make all purchases possible from locally owned businesses. Sheriff McCutchen answered questions regarding State Jail requirements for new employees and Judge Blair noted that Concho Valley Council of Governments had agreed to provide training for these new employees. Starting salaries for correction officers were currently being considered at \$12 per hour.

Bronte Superintendent Ricky Royall was available to assure attendees that the current Bronte water and sewer systems were fully capable of handling the new facility.

The final question of the evening was asked by Richard Baker of Bronte. He asked the members of the audience to raise their hands if they supported the facility. It appeared that almost everyone raised their hands, followed by resounding applause.

The hearing was dismissed at approximately 7:20 pm.
