On May 13, 1969 a nearly \$3 million deal was completed when the Daedalian Corp., with a Midland address and a Hobbs address, completed purchase of nine blocks of land from Fred Barrett, Jr. The land sold consisted of three sections called the Homeplace in Block G, 387, 411 and 424. The Wolf Unit, consisting of section 14 and section 15 and the the S. 1/2 of section 13 of block A. The Black Unit, made up of sections 18 and 23 in block A8. Also the Hill Unit, made up of section 10, block A9.

From records in the County Clerk's office, seven pages of farm equipment and irrigation equipment was sold with the land.

It was reported that the Daedalian Corporation also would operate facilities at the airport of the previously Hobbs based business.

Miles and miles of irrigation pipe was sold with the land. It is believed that the corporation plans on a 5,000 acre planting of potatoes in the future.

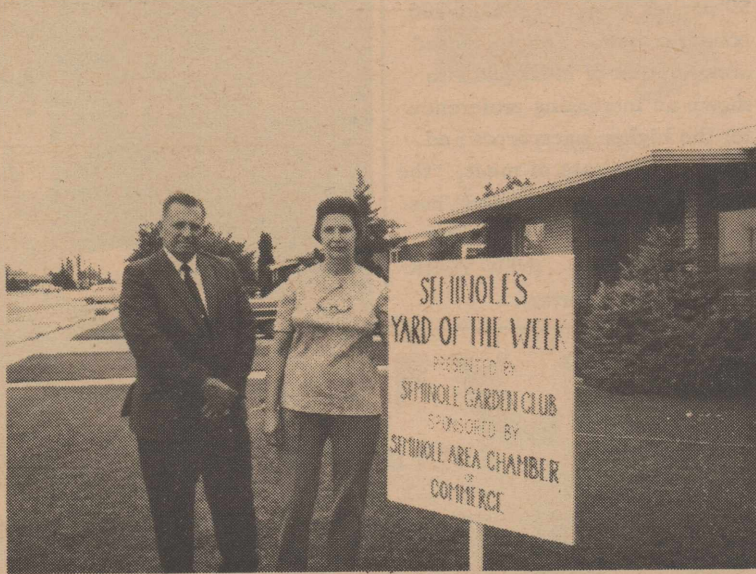

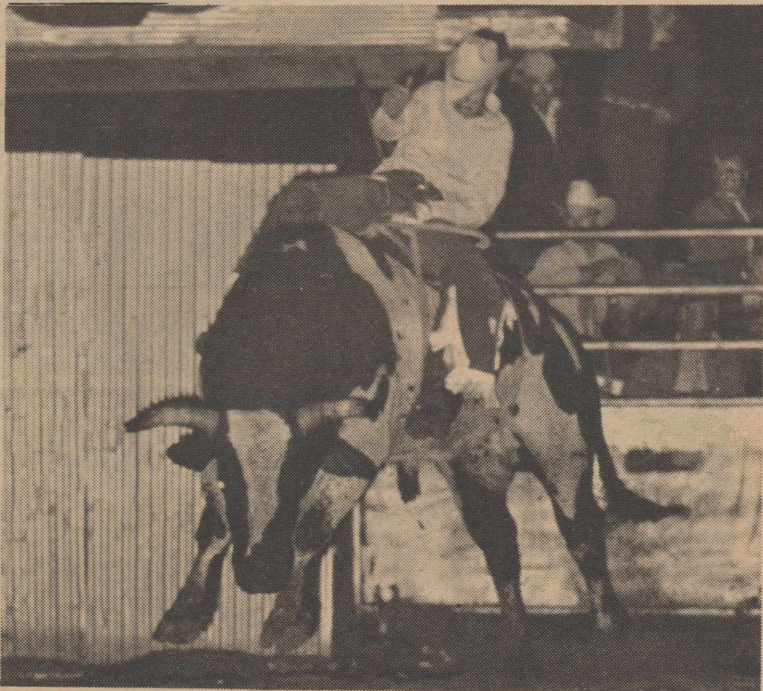

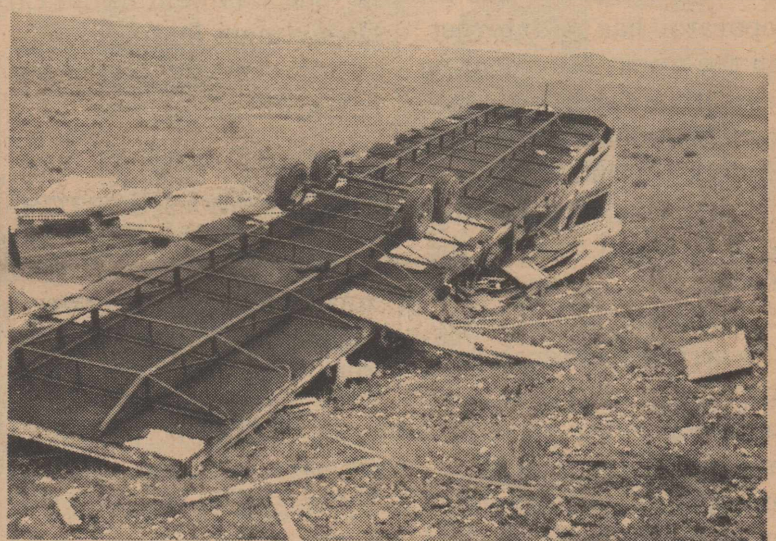

He had been told by his father to leave the trailer in a high wind, which he did. No one was hurt. Ricky said, "I tried to open the door and it was hard for me to get out." His father said, "I'm just glad the boy was out. He got in a pickup truck and moved out of the area."

A News Editorial

This article is being written so people of Seminole, the school district and Gaines County will understand the re-appraisal to be made by the Southwestern Appraisal Co., Inc., Maburn Harris, president. The Commissioners Court is in the process of employing this company at a contract price, to cover a little over one year, of \$45,862.50 and the school \$29,137.50 or a total of \$75,000. The price was shaved from \$90,000 when a longer period on the contract was given.

2. Southwestern Appraisal Company has done appraisals for the following counties, Aransas, Castro, Limestone, Ward, Yoakum, Victoria, Tom Green and Jim Hogg. For schools - Decatur, Groesbeck, Lamar Consolidated, Mart, Tom Ball, Hill-Daisetta, Lyndale, Kingsville, and Clyde. For cities - Decatur, Addison, Lewisville and Kingsville. The above are the most recent.

3. The purpose of the re-appraisal by Southwestern Appraisal Company is to appraise only land, houses and other personal property.

4. Oil properties have had a re-appraisal and evaluation each year for the past 20 years. Thomas Y. Pickett Company receives 4¢ on each \$100 of oil evaluation to do this work each year. They have been working 8 months this time.

The question has been asked concerning Southwestern Appraisal Company, whether they belong to a professional appraisers organization. They do not.

Originally when land appraisal was set up in Gaines County acreage close to town was valued at \$3.50 per acre; the next circle around Seminole \$2.50 per acre; the third circle out from Seminole \$1.50 per acre. This has never been changed.

NEW FARM WHEAT

ALLOTMENT

Farmers who would like to be considered for a "new farm" allotment for the 1970 crop of wheat on a farm which does not have a 1969 wheat allotment should get in touch with the ASCS county office during the month, Troy Martin, Chairman, ASCS County Committee, said today. Applications for such allotments may be filed until July 1.

As last year, a producer eligible to file such an application is one with a farm for which no wheat allotment has been established and for which neither the owner nor the operator has an interest in the wheat allotment on any other farm, who has available land and adequate equipment and facilities for the successful production of wheat crop on the farm, who during the last 5 years has had at least 2 years' experience in producing wheat, and who as an operator expects to receive more than 50 percent of his current year's income from the total production on the farm (not including the anticipated income from wheat produced on a "new farm" allotment).

Other factors are also involved, and it is suggested that interested producers discuss the details with officials at the ASCS county office. The Chairman said that formal application for a "new farm" wheat allotment may be made by filing a written application at the ASCS county office prior to the July 1 deadline.

SEALED PROPOSALS addressed to the Mayor and City Council of the City of Seminole, Texas, will be received at the office of the City Secretary, City Hall, Seminole, Texas, until 7:30 o'clock p. m. on the 30th day of June, 1969, for permanent public improvements, to wit: a building to be used for City hall purposes, said building to be located in the downtown business area, in the general proximity of the existing City Hall. The building must be generally sound construction throughout, with a minimum square footage of 8,000 square ft, including all walls; roof of leakproof material; floor and foundation of concrete construction; outside walls, fireproof construction; and at such time and place all such proposals will be publicly opened and read.

ALL BIDDERS must submit cashier's or certified check issued by a bank satisfactory to the City Council, or a proposal bond given by a reliable surety company authorized to do business in the State of Texas, payable without recourse to the City of Seminole, in an amount not less than 5% of the amount of the proposal or bid as a guarantee that the bidder will enter into contract within ten days after notice of awarding of contract to him, or submit a proposal in the form of a binding contract to convey the premises after acceptance of the proposal by the City.

IT IS THE INTENTION of the City Council of the City of Seminole, Texas, to issue time warrants to the contractor or contractors in payment of all or a portion of the cost of purchasing and acquiring the above mentioned improvements, not to exceed the principal sum of FIFTY THOUSAND DOLLARS (\$50,000), said warrants to bear interest at a rate of not to exceed 6% per annum, and to mature serially, the maximum maturity date to be not later than December 31, 1980.

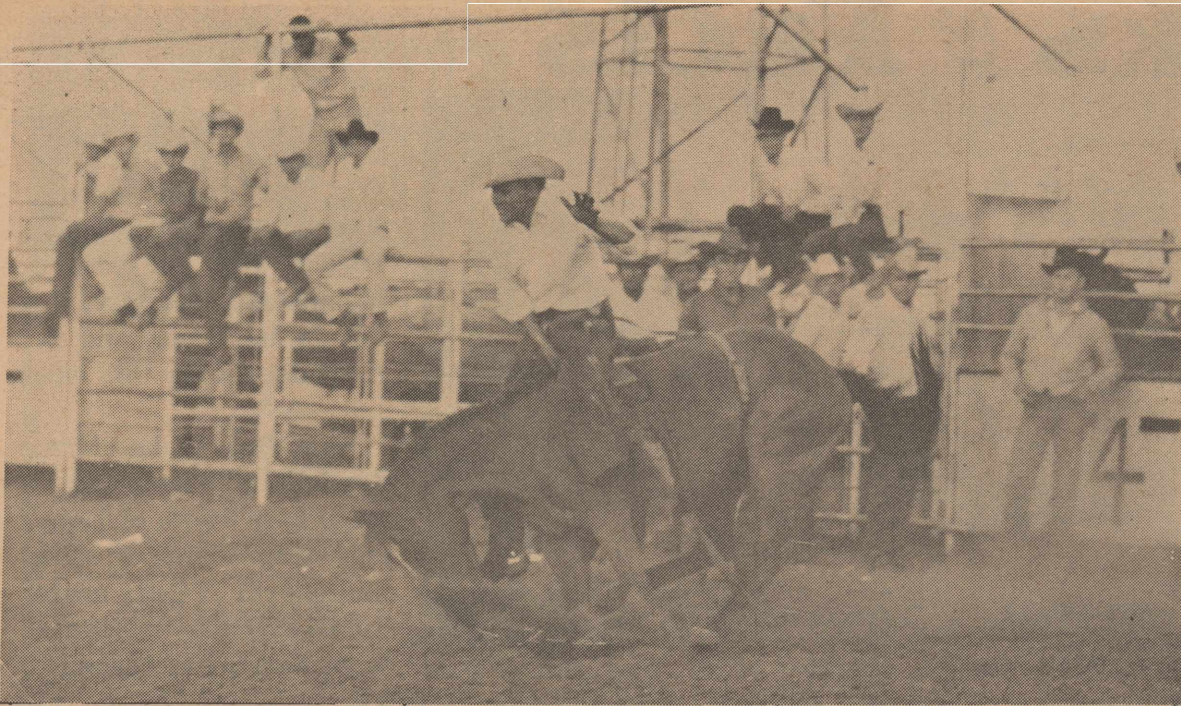

What more interesting thing could be done than watch the honey bee come and go, a buzzard in his motionless flight, or a tiny humming bird collecting nectar? What a wonderful thing - youth - and with time to do - to explore - to learn - and to live.

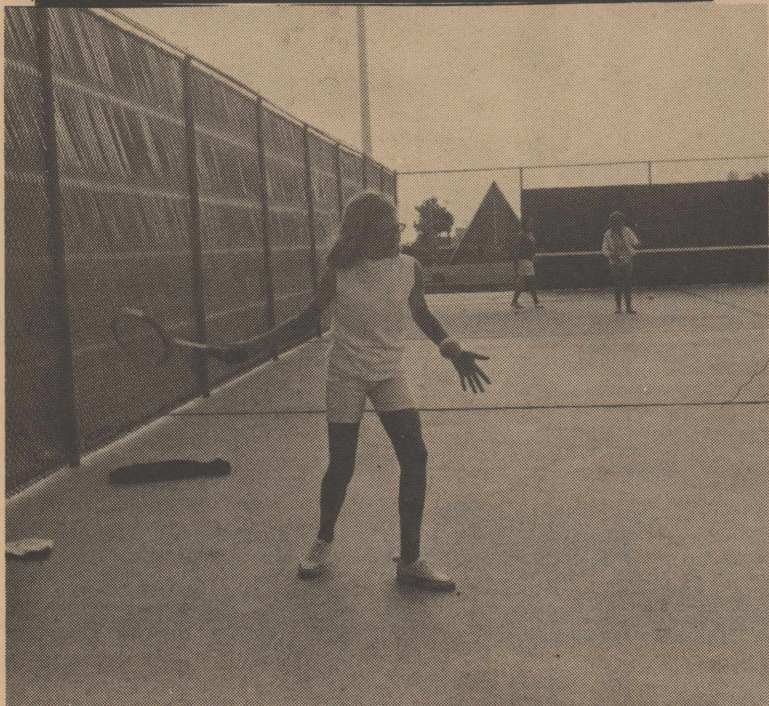

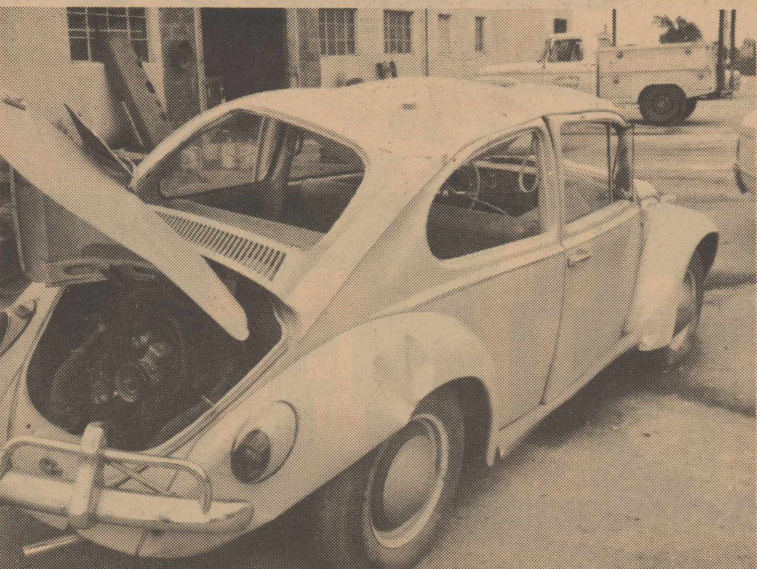
SEVERAL ACCIDENTS INVESTIGATED BY HIGHWAY PATROLMAN

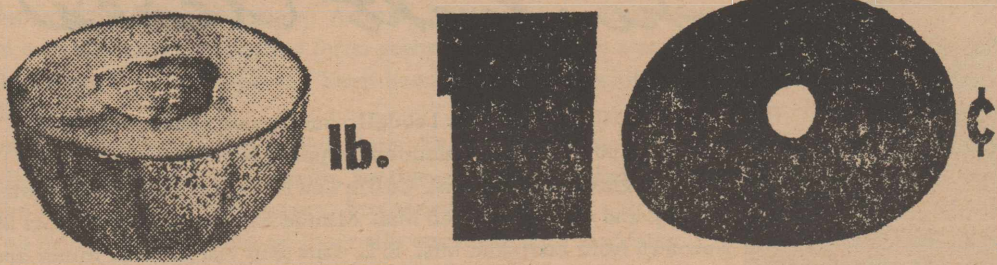

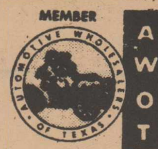

Information From Social Security Office

BY DOROTHY FEAZELL

Claims for social security disability benefits should be filed early-- these take longer to process than most retirement and death claims, since each case must be evaluated in detail to determine whether or not the disability is severe enough to meet the requirements of the law.

Persons having disabilities which prohibit their working for twelve months or more ought to apply for benefits as soon as possible. Since disability payments can begin no earlier than the seventh month after the disability began, a disabled worker has six months to apply before checks are due. The earlier you file, the more time you and the disability specialists have to get all the necessary facts to pay the claim.

Any worker who might qualify for such benefits should check with me when I am at the Gaines County Courthouse, as soon as possible.

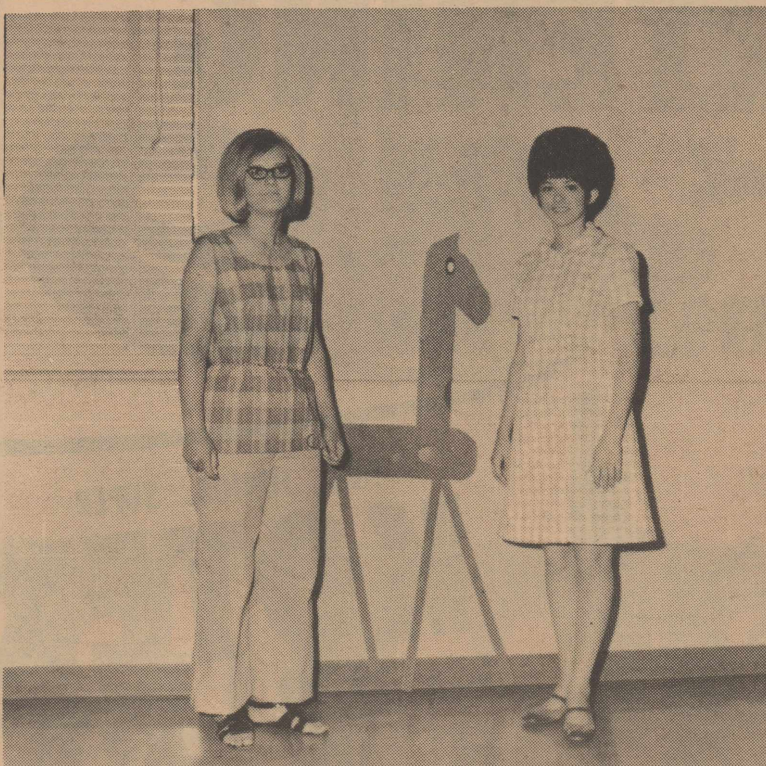

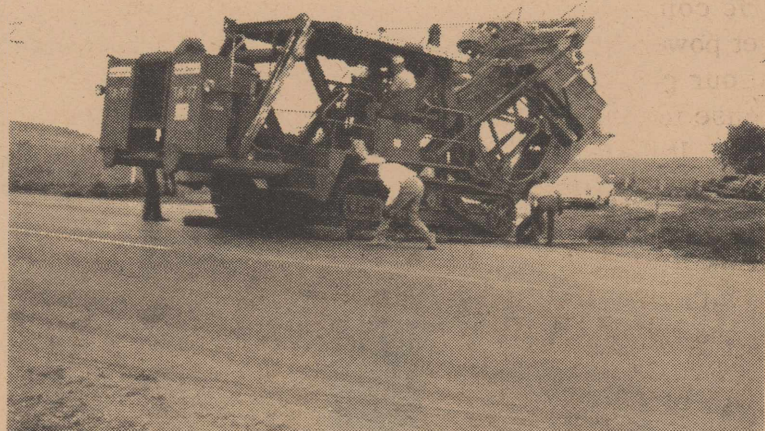
