

## SERVICES HELD MONDAY FOR L.P. SMALLIN

Leslie Polk Smallin, 86, 4427-B 31st. St., Lubbock, died at 11:30 a. m. Sunday in the Golden Age Nursing Home after a lengthy illness. Funeral services were held Monday at 2:00 p. m. in the South Seminole Baptist Church with the Rev. Bobby Phillips, pastor, officiating, assisted by the Rev. E. M. Jennings of Lubbock. Graveside rites were at 5:30 p. m. and burial followed in the Ralls Cemetery under the direction of Singleton Funeral Home.

Mr. Smallin and his wife, the former Ruby Ragle, had resided in Seminole since 1934 until they moved to Lubbock some eighteen months ago.

A native of Fayetteville, Ark. Mr. Smallin lived in Crosbyton, Ralls, Lamesa and Menard before moving to Seminole. He was employed as manager of Forrest Lumber Co. until he purchased an insurance agency where he worked until his retirement.

Mr. Smallin was a charter member of the South Seminole Baptist Church where he served as a deacon, a charter member of the Seminole Rotary Club, a member of the Seminole Masonic Lodge and the Seminole Golf Club. 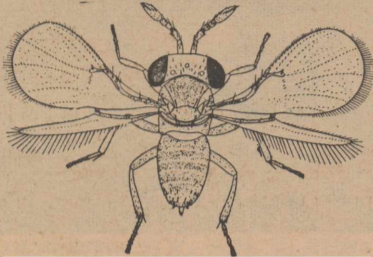

## COTTON INSECTS



A. Trichogramma --- This helpful insect is a parasite that attaches itself to the egg of harmful insects. It kills the individual before it damages the plant.

The famed bug-killer DDT is losing its deadly wallop and falling into disfavor as a threat to wildlife and mankind. But even if DDT fades from use, the insects will hardly take over the world, for potential replacements are on the way.

In fact, U. S. entomologists appear close to an important advance in man's age-old war against the insects that devour his crops. This attack won't be spearheaded by the well-known chemical insecticides but by an expanding arsenal of biological controls based on weapons pro-



Adult cotton bollworm A HARMFUL INSECT vided by nature. If the approach succeeds as hoped, it may sooner or later reduce the use of chemical insecticides—and any resulting pollution of the environment. The effort will include:

-Massive deployment of bugs that are harmless to man but prey on crop-destroying pests.

-Large-scale sterilization of adult insects to disrupt their reproductive cycle.

-Use of synthetic copies of the natural scents secreted by pest species to lure bugs to their destruction.

## City Council Meets

The City Council met Monday night and (1) okayed a street light to be installed at 11th Street and N. W. Ave. F.

(2) Northwest 6th Street was opened up for 1½ blocks, beginning at the Denver City Highway and running north to the paved football parking lot of the school. This street is adjacent to and west of the M. S. Doss Youth Center.

(3) The following members from the Chamber of Commerce and Industrial committee were present, Charles Ray, Dwayne Herman, Earl Bartley and Olan Locker, to recommend to the city council the sale of a portion of up to 100 acres of the old airport east of Seminole for a cotton compress and warehouse if the railroad comes through. Guy Nichols from Sudan is the interested party and said he would employ between 75 and 80 people approximately six months out of the year, with that number falling off sharply after the busy season. An 8 inch main would be necessary for such a facility.

The Council was most interested but wanted to check on right of way and cost before granting full permission. He did not want the land as a gift; he wanted to buy it.

(4) An application to park a trailer in the 100 block of Southwest 14th Street was passed over when it was pointed out that the deed restriction on record prohibited trailer homes in Austin Acres. In an order of dedication dated May 9, 1949 and filed May 13, 1949, Vol. 99, page 48 in the Deed of Records, Gaines County, Texas, Emma

## School Board Has Breakfast Meet

The Seminole School Board had a breakfast meeting Monday morning at 6:30 A. M. at Jo's Restaurant. (1) The board voted unanimously to pick up all transfer students from the State line west and north approximately 3½ miles, who now attend school in Hobbs. Last year from that area there was a daily attendance of 9.7 students to the Hobbs system at a cost of \$6,000.24 to Seminole. There were no 11th or 12th grade students found in that area. The arrangement with Denver City would remain the same at present.

(2) The board voted unanimously to have the newly installed aluminum seats on the home side of the football field replaced because the gold coloring was not the same.

(3) Accepted at the breakfast meeting was the green stain and paint (approximately \$300) donated by the Seminole Tennis Association to paint the old tennis courts.

(4) The firm of Wilton, Woods and Coffee from Lamesa was employed to audit the school records.

(5) A request for \$500 for supplies and \$115 for travel during the 1969-70 school year was granted for the new library in the elementary building.

(6) Two new bus drivers were employed - R. G. 'Shorty' Moretz and Merlin Sooter.

Jerry Franklin will be asked at the next board meeting to discuss the tennis program. Also discussed at that time will be a raise for the auxiliary help.

A buffet supper for teachers will be held September 2 (the first day of school) at 6:30 P. M. at the cafeteria so that they might meet board members and other teachers.

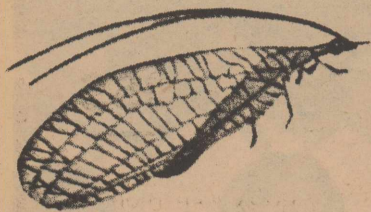

Another helpful insect is the praying mantis.

Generally in Gaines County the harmful insects to cotton are tobacco budworms, cotton bollworms and adult bollworms. Other destructive insects are the corn bore and the cabbage looper. The boll weevil parasite deposits eggs in boll weevil larvae. The tachina fly deposits eggs in caterpillars and worms. The ichneumon wasp deposits eggs in caterpillars and worms.

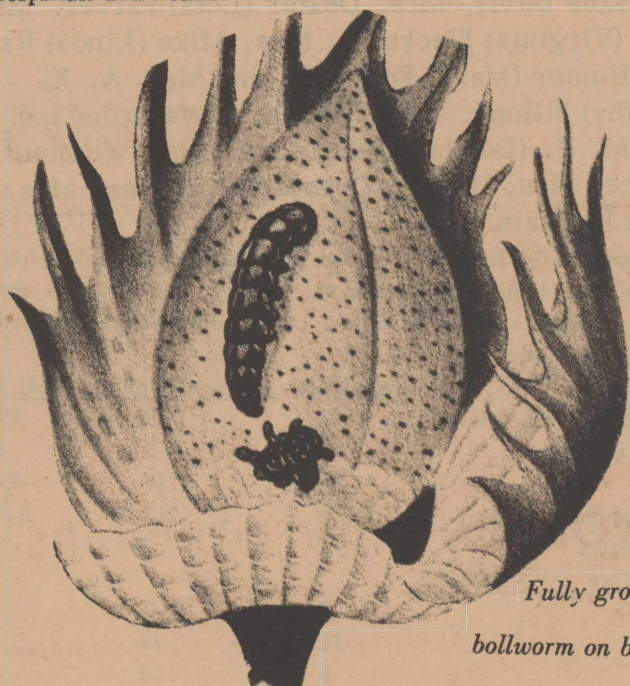


LADY BEETLE

Tobacco budworm larva

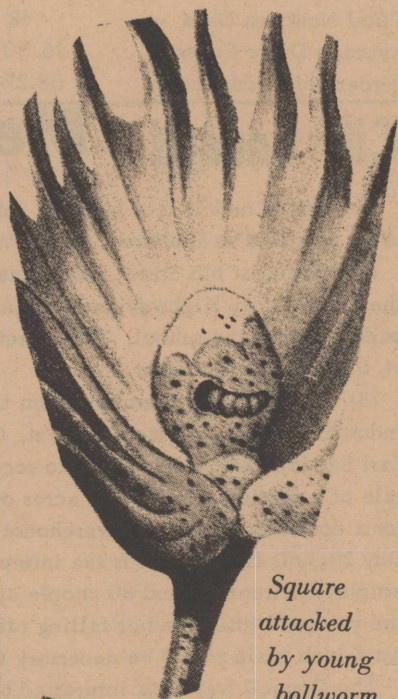


Fully grown bollworm on boll

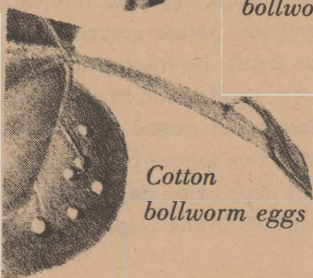


ICHNEUMON WASP

Square attacked by young bollworm

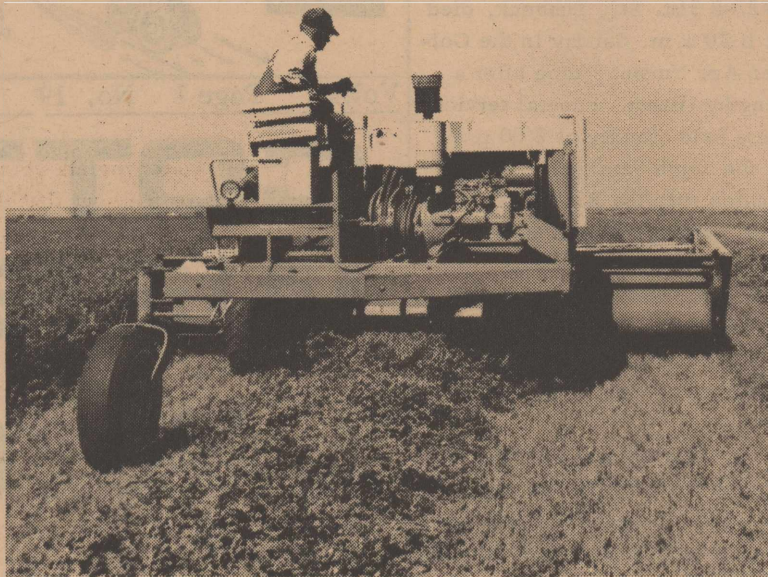


Cotton bollworm eggs

## MANY HAY BALERS OPERATING IN GAINES COUNTY VICINITY

Many hay balers are operating in the Gaines County vicinity this year. Operating on the Seminole Farms is a No. 82 New Holland baler. Its capabilities are approximately ten bales per minute or between 500 and 600 per hour.

D. G. 'Shorty' Presley told the News on Monday that the Seminole Farms, located 13 miles Southwest of Seminole, would be baling German millet from 950 acres and were expecting to make over 40,000 bales. The feed will be used to help warm up between 1,000 and 1,500 feeder cattle that are on the farm now.

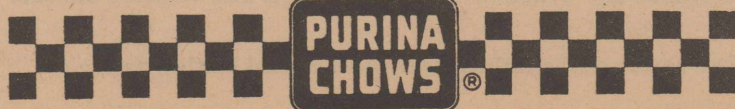

 their dinner when they got a drink out of the sprinkler, removed the end plug and the family cat came out. Dead, of course, drowned and bedraggled.

The true story I want to tell about is about the time that I put a 6" main line together 1/2 mile long. (It's purpose was to furnish water for the smaller auxiliary sprinkler lines.) It had been idle for weeks and the joints were all free of one another. I put them all together, leaving the far end open, walked back to the well, started the motor and pump running slowly.

Then I drove the pickup to the end of the line, got me a good club and waited for the water and the rabbits to get there. Maybe I would get 6 to 10 this time. The trick was to hit them as they came out in front of the water, the dirt, sticks and the dust.

I hit one, I got another and wound up for number 3. I heard him scratching as he came down the line and I got ready for the big kill. I raised my stick, started my swing. But what? --- It's black with a white stripe! A skunk!!! I stopped; I dropped my club. Three feet away was a frustrated, mixed-up, mean looking skunk.

I ran. Then I looked all around to be sure one of the hands or an oil field pumper or a neighbor did not observe how big a coward I actually was. I've never been sprayed by a skunk but I've seen dcgs and others who have. Me, a coward? Where skunks are concerned I am.

There are also many stories about the mice, the rats, the ground squirrels, snakes, pack rats, little dogs, eyeballs, tails, feet hanging out and on and on.

If you will believe this one I'll tell you about a real rabbit hunt. No guns, no pipes, only sticks for ammunition. The next time you drive by a field in Gaines County and see someone moving irrigation pipe by hand, just remember that in all probability when they had to remove the end plug (4" or 5") to wash the sand out of the line, they've had to dodge 3 to 5 feet of the insides of some small animal as it went round and round on the sprinkler.

**CITY COUNCIL MEETS CONT. FROM P.1**

J. Austin, To the Public set out Point 8, which says: No trailer, basement, tent, shack, garage, barn, or other outbuilding erected on any of the above land shall at any time be used as residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence. No existing structures shall be placed or be permitted to be placed on any lot in said subdivision.

(5) Humble Oil, 11th Street, was granted permission to tie into the city sewage, with them being responsible for lines coming to city lines.

(6) Thirty new water meters were purchased at a cost of \$32.50 each when it was pointed out that there would be a 13% increase.

(7) The council will write letters and send telegrams showing their disapproval to state authorities who are trying to raise the collection on the sales tax from 2% to 7 1/2%. (The state has been charging 2% of the 1% sales tax to collect and disburse back to the cities the 1%. They want to raise this to 7 1/2% of the 1%.)

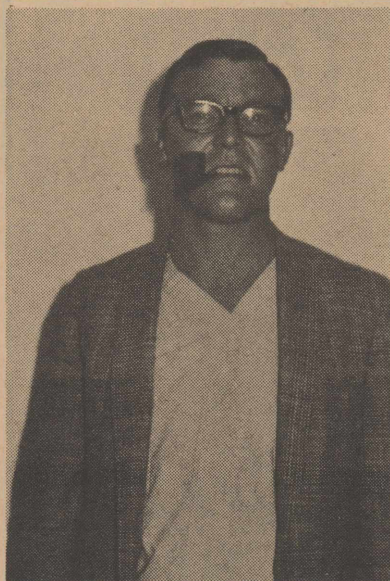
(8) Mel Pope, resident engineer for the highway department including Gaines, Yoakum and Terry Counties, was present to discuss the classification of streets and highways. His interest and the state's interest is to have certain streets designated as main arteries with the thinking that at some future date the state and/or federal government might participate in upkeep. The following streets were considered: N.W. Ave. F. between 62 and 214, 11th Street, both S.W. and S.E., and possibly S.W. 4th and S.W. 6th for a three block area north and south of the school.

Mr. Pope pointed out that on the west highway out of Seminole in 1966 upwards of 3400 cars per day travelled the highway and it is probably up at least 10% from that figure now; north out of Seminole 2600 to 2700 cars per day, south 2500 to 2600 cars per day, and east 1900 to 2,000 cars per day. He further stated that he hoped the west highway would soon be under construction and the plans were 80% complete and they hoped to let a contract in February.

If it is 24 miles to the state line and a four lane highway takes in nearly 30 acres to the mile it would take 720 acres of land. This does not include access roads which could include another 120 feet. If the highway west had access roads on either side it would take in nearly two sections of land.

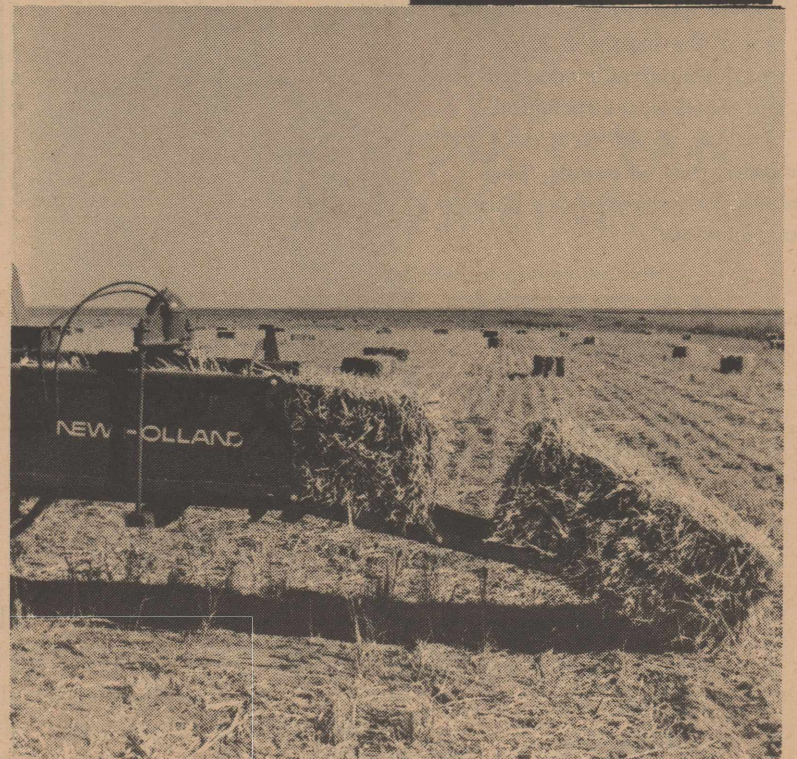

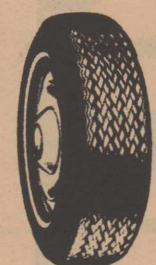

**SCHOOL PRE REGISTRATION** by John Thompson

Activities for the new school year begin on the local scene Thursday, August 21, with pre-registration for students in the first six grades. High school students also begin registering on that date. Only students new to the system in grades seven and eight pre-register and this is scheduled for Wednesday, August 27. Other junior high students register the first day of school, Tuesday, September 2.

Students who will attend the F. J. Young Elementary School will register between the hours of 9:00 a. m. and 3:00 p. m. on the 21st. All students in grades 1-5 who live west of 11th street, south of the Hobbs Highway, and west of Cemetery Road will attend the Young school. In addition students in these grades who will ride buses driven last year by McDougal, Hughes, Christian, Bennett, McGehee, Grayson, and Patterson will enroll at this school.

Students in grades 1-3 who live east of 11th street or who ride other buses will enroll at the Primary school on the central campus. Registration here will also be between the hours of 9:00 a. m. and 3:00 p. m. on August 21 and will be conducted in the north cafeteria dining room. The Seminole Element-

tary School will also conduct enrollment on the 21st during the same hours. Enrolling in this school will be all sixth graders and pupils in grades 4-5 who live east of 11th or who ride buses which do not go by the Young school. All three buildings will be open during the noon hour for the convenience of working parents who wish to register their children at that time.

High school seniors will pre-register on Thursday, August 21, between the hours of 9:00 a. m. and 12:00 noon. Juniors will enroll that afternoon from 1:00 p. m. to 4:00 p. m. On Friday, August 22, sophomores will enroll in the morning and freshmen in the afternoon with the same hours as on the preceding day.

All seventh and eighth graders new to the system should report at 9:00 a. m. sharp in the junior high library on Wednesday, August 27. Promptness is stressed as tests will be given these pupils and will begin at that time. These students should bring a pencil with them. All other junior high pupils will register on September 2, the first day of school.

Pupils who are on vacation at the time of pre-enrollment will register the first day of school. Parents who have any questions about enrollment should contact their child's principal or the central office in the Administration Building.

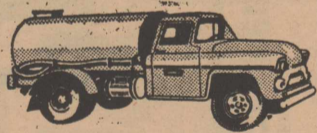

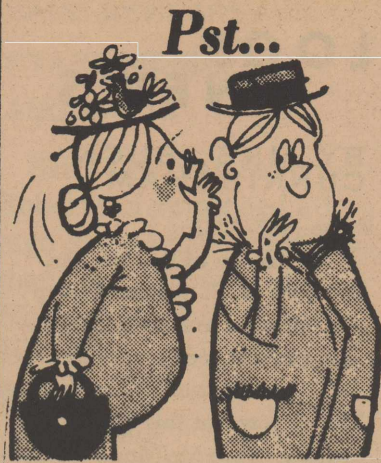

## "CHARRO!"

The year is 1870. Jess Wade (ELVIS PRESLEY) rides into a Mexican border town in response to an urgent message from a former girl friend, Tracy (INA BALIN). The message, however, is a ruse, and he finds himself surrounded by the guns of his former friends, a band of outlaws with whom he once rode. Jess had left them a year before to go straight. Led by Vince, (VICTOR FRENCH) and his deranged brother, Billy Roy (SOLOMON STURGES), they take him prisoner.

Jess is brought to their mountain hideout where they have Mexico's famed gold and silver Victory Gun, the weapon that fired the last shot against Maximilian and freed the country. The outlaws have stolen it and intend to sell it to the highest bidder.

Jess tells them soldiers on both sides of the border will hunt them down. Vince produces a counterfeit "Wanted" poster, proclaiming that Jess had stolen the cannon and offering a reward for his capture—dead or alive.

## FUNERAL SERVICES HELD FOR MISS VERNON BIRDWELL

Miss Vernon Birdwell, 93, died Wednesday at 4:00 p. m. in Seminole Memorial Hospital after a long illness.

Funeral services were held at 4:00 p. m. Friday in the First Presbyterian Church with Rev. Jim Corey officiating. Burial was in Seminole Cemetery, directed by Seminole Memorial Funeral Home.

A member of a prominent ranching family, Miss Birdwell had been a resident of Gaines County 60 years. She had operated the first telephone system in this area.

Surviving are a sister, Mrs. Hattie Patterson and many nieces and nephews, including Miss Doll Birdwell of Odessa and Ben Birdwell, Seminole.



The Jim Hughes family moved to Gaines County from New Boston, Texas in 1916. The above picture was made in 1918, 7 miles east of Seminole and 7 or 8 miles south of the present Fairview Church. The family was made up of left to right, Robert Hughes (R. M. E.), Mr. and Mrs. Jim Hughes, Jr. and their son, Jack; Sam Isler, a grandson of the elder Hughes, riding aboard 'Shamrock'; Karl Hughes, Bill Isler, in short pants standing in front of his grandfather, Jim Hughes (Dad) and beside his grandmother in the wheelchair; the oldest boy standing next to his mother - Walter Hughes; Miss Leon Hughes and Harry Hughes. Also in the background on horseback was Rennie Hughes, riding 'Little Bill'.

Other interesting things about the picture are the some 300 to 400 head of sheep in the background. They were kept penned in behind a net wire fence except when herded. One of the three Model T's belonged to the photographer, one to the Sr. Hughes and it is supposed that one of the boys owned the other car. There's a nursing bottle in the foreground on the left. (There's always multiple births among sheep and orphan lambs to feed.) The eclipse mill in the background pumped from a waterwell between 120 and 140 feet deep. Near the house was a water tank for drinking water. The fence was used for the clothes line and looks like one cultivator and one planter by the fence. The family farmed approximately 100 acres for livestock feed. Those must be salt blocks behind the sheep and near the cars. The lambs are getting nearly grown in size and are hard to tell from the ewes.

Note the high top button shoes on the women and the barefeet on part of the boys. All the men either had caps or hats on. The larger boy on horseback has a real weapon in his hand - loaded (what's commonly referred to today as a slingshot). Rennie Hughes evidently was some kind of a cowboy and 'Little Bill' some kind of herding animal and cow horse --- no bride.

"Yea," responded a boy on the front row. "Alaska is pandemonium."

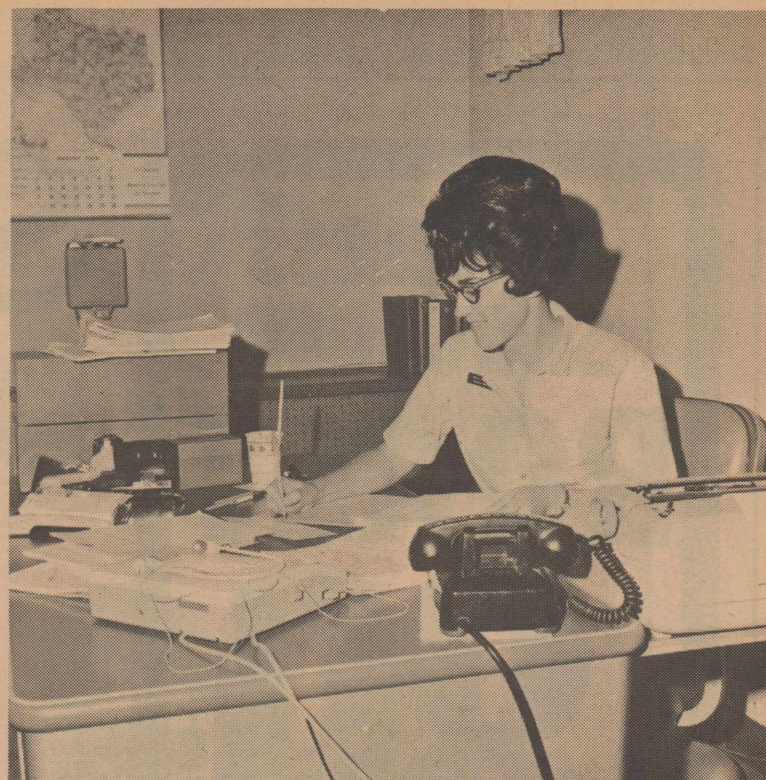
"Nay," averred the teacher, "thy use of the word must not be so literal."

## SEMINOLE SCHOOL DISTRICT BOARD OF TRUSTEES MEETS

The Seminole School District Board of Trustees voted at their meeting Monday to discontinue paying tuition and transportation costs for pupils who live along the Texas side of the State line but who have been attending school at Hobbs, New Mexico. Seminole has been paying the actual per pupil cost and transportation costs to the Hobbs Municipal School District for several years but Seminole buses are now running so near this area that trustees felt that this arrangement was no longer economically feasible. This will take effect at the beginning of the 1969-1970 school year and will affect approximately twelve pupils.

The arrangement was first made in the 1940's when local buses were not coming within several miles of the State line and it was beneficial to both the district and the pupils involved to pay their tuition and let them attend school in Hobbs. Also in past years Seminole had been receiving the State per capita money on these pupils but the last session of the legislature changed the basis of per capita allocation from the census to average daily attendance which would mean that with these pupils attending school in New Mexico, Seminole would receive no State per capita money on them.

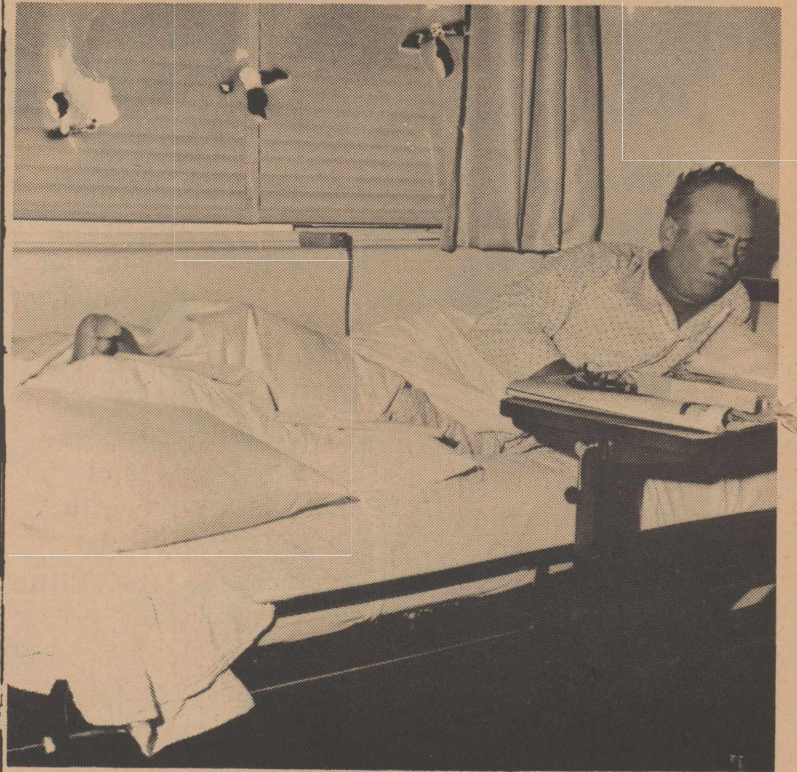
The Candy Stripers voted to have a bake sale for their project of the month. It will be held on Wednesday, the 13.

## SEMINOLE PREPARES FOR MENTAL HEALTH CENTER

County Judge Chester D. Browne announces that Seminole is scheduled to become the fourth city in this area with a community mental health center.

Dr. Preston Harrison, superintendent of the Big Spring State Hospital, said that Gaines County officials had set August 19, as the date for a public meeting to explain the functions and operations of the new facility.

He and several members of the professional staff of the state hospital appear at a public meeting in the Seminole Community building at 7:30 p. m. August 19 as will Dr. John Miller and Dr. Jerome Smith, Lubbock, Consultants to Gaines County.

Dr. Smith will serve as clinician and will visit the clinic every Tuesday. Other staff members will include a nurse who will serve as drug-check clinician; a case worker to conduct interviews and set up appointments between Dr. Smith and the new visitors or prior patients. Also a full time clerk will provide community services.

Dr. Harrison, Mr. Walter Widger of Social Welfare Service, Mrs. Mary Cochran of Volunteer Services, and Mrs. Betty Duncan of the Circuit Rider Program will discuss the problems of mental health, and the services which may be furnished through the community center. The Circuit Rider program will serve the center as it does the three established ones at Colorado City, Snyder, and Lamesa.

## EDITORIAL

Several people have called the News and asked questions concerning letters they have received from suppliers and merchants concerning the Truth in Lending Act. The Truth in Lending Act, which is part of the Federal Consumer Credit Protection Act, and Regulation Z, interpreting the act became effective July 1, 1969.

The purpose of the act was to let customers know the cost of credit. The act requires that finance charges be disclosed and the annual percentage rate shown. If you offer consumer credit you are compelled to notify the people you make charges to. If you buy anything on time the Truth in Lending Act requires the seller to give you the cash price, total down payment, the unpaid balance and then itemize all credit charges, finance charges, the day the finance charges begin and the total of all payments. Also the deferred payment price, the annual percentage rate, the amount charged for any default, a description of the security and how rebate is calculated on pre-payment.

It is required that this information be received by the buyer and given by the seller before the contract or credit is extended. If taxes, license fees and registration fees are included in the contract they must be shown separately. Concerning the annual percentage rate - if 6% is charged and the pay back is by the month the interest rate per annum would be approximately 12% and would have to be shown. Also the advertiser of credit comes under the act and if advertised as such to further sales, advertisers must advertise credit rates.
