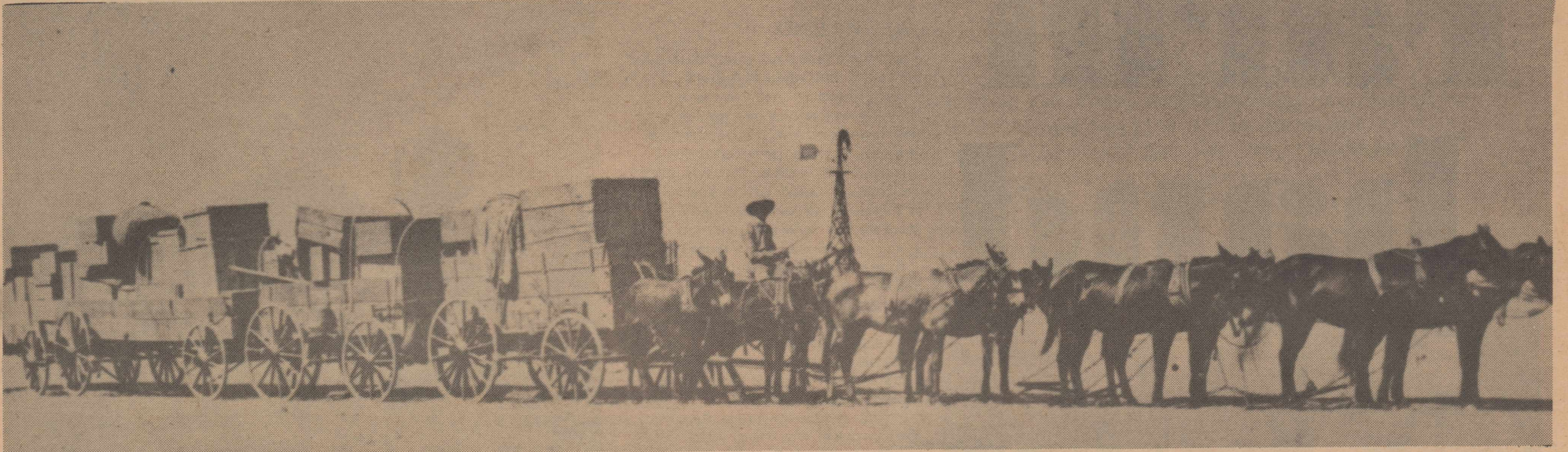


# FREIGHT BUSINESS 1898



Fred W. Denham, who freighted in and around Seminole and owned a ranch south of Seminole, is shown with his hookup and his freight wagons in 1898. The dry goods being hauled were for the McManie & Posey new store opening in Floydada, Texas. The fourth wagon back was usually used for a camping rig and feed for the horses and mules. Mr. Denham can be seen here riding the inside horse on the left. He drove the other teams from this position, with lead lines to the front team. The wagon wheels had narrow tires on them and in a good hard country would travel twenty to thirty miles per day. "A good mule in those days would bring \$35.00 to \$40.00." At night the teams were either hobbled or turned loose. The freighter usually kept a saddle horse to wrangle the work stock on. The mules were Spanish type, weighing 900-1000 pounds, some of them no doubt with a stripe down their back. They were the tough kind. A freighter with good spans of mules and good teams of horses would talk out or holler out at one of the animals and they would pick up the slack. It was a good wheel horse or a good mule that worked at the tongue, carried the rider, turned the front wagon, and lasted out the day. Four head were worked abreast at the tongue with three pairs out in front, or a total of ten head pulling these four freight wagons. If wagons were heavy loaded, wheels were greased every two days and, as truckers do today when a freighter stopped he put his hand on each hub to see which one needed greased. If one was hotter than another it needed greased. In the background can be seen a windmill, probably the camping place for the night. These loads came out of Amarillo, Texas. The McWhorters just over in Andrews County bought the place that was owned by Fred W. Denham.

When I got ready to quit he was ready. He nearly beat me to death a few times and when he got the best of me he just grinned and when I got the best of him he still grinned.

You've heard of a tough boot. He was tougher than both of them. He wasn't the best student in the world but he knew how to twist a rabbit out of a hollow tree. He knew how to find a bee tree and the smoking of dried grapevines never seemed to burn his tongue. He was always ready to ride all the calves, to play hooky, to hully-gully, to hunt, to fish, or was happy to just lie around the fire.

The outstanding thing about Andrew was his ability to flop either or both ears. He always sat in the seat just in front of me and he could look at you intently, cock his head a little sideways and throw up the ear on that side, just like a mule. Now a 5th or 6th grader just could not stand to see Andrew do this without getting tickled.

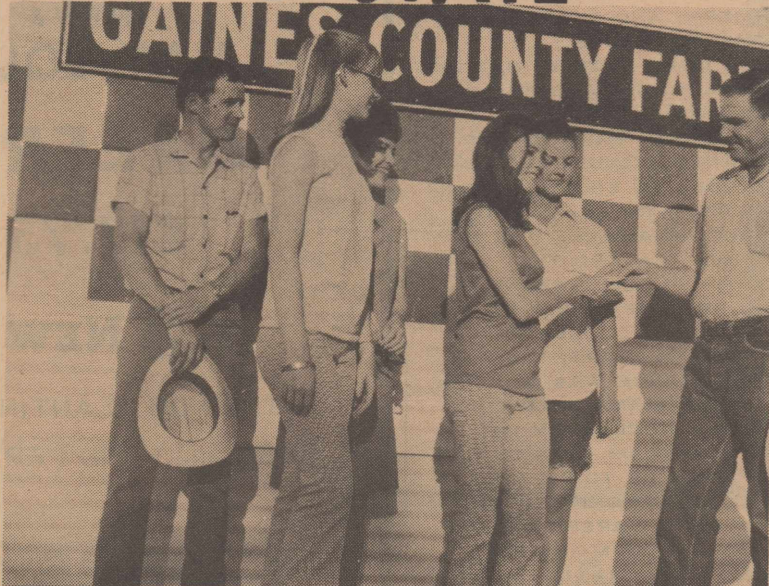

## FARMERS URGED TO CERTIFY COMPLIANCE WITH FARM PROGRAMS

All participants in the 1970 feed grain, wheat, or cotton programs are being sent a reminder flyer on certification and compliance with these farm programs, according to Troy Martin, Chairman of the Gaines County Agricultural Stabilization and Conservation (ASC) Committee.

"It would be a good idea for a farmer to stick that little black and - yellow leaflet in a spot where it will catch his eye every day reminding him to come in early to the County ASCS Office to certify compliance," Martin said.

The leaflet reminds farmers that early and accurate certification means earlier farm payments this year. Farm program payments are expected to begin soon after July 1 and be completed by the end of August.

Processing and computing of the total payment earned by a participant is begun as soon as he certifies he has complied with program provisions.

The flyer also lists four important items for producers taking part in the 1970 farm programs:

"Do plant within your allotment, base, or permitted acreage on all farms in which you or your family have an interest.

"Do be sure you certify to correct acreage. Once you certify your acreage it can't be adjusted.

"Don't guess your acreage. If in doubt, ask for measurement service. Errors found on spot checks can be costly.

"Don't certify if you're not positive that planted, diverted, and conserving base acreages are correct."

The ASC Committee Chairman said it would take producers less than a minute to read the flyer -- but that it could be the most important minute of their farm operations this year.

Mistakes in certifying compliance can cost farm program participants some or all of the payments they would otherwise earn, he said.

SHINGLES WERE BLOWN OFF HOUSES, AND CROPS SUBSTAINED HEAVY DAMAGES. FARMERS HAVING REPORTED HAIL DAMAGE TO YOUNG CROPS ARE CHARLIE ROWLAND, GLEN FLEMMING, JAMES STEPHENS, AND OTHER FARMERS WEST AND NORTH OF SEMINOLE.

THE NATHAN WOMACKS LOST A STORAGE ROOM BEHIND THEIR HOUSE.

THE RAIN VARIED FROM ONE-HALF TO TWO AND ONE-HALF INCHES.

BLOWING WINDS CAUSED SAND TO DRIFT OVER HIGHWAYS--ESPECIALLY BAD 4 TO 5 MILES EAST OF LOOP.

FARMERS LOOSING EARLY PLANTINGS OF COTTON ARE REMINDED BY CALVIN HOLCOMB, COUNTY AGRICULTURAL AGENT, TO CHOOSE FROM THE FOLLOWING VARIETIES: PAYMASTER 54B, RILCOT 90, GREGG 35. THESE VARIETIES HAVE DONE WELL FOR REPLANTING. OTHER VARIETIES THAT MIGHT BE PLANTED ARE: PAYMASTER 101, PAYMASTER 202, STRIPPER 31, TAMCOT 788, LOCKETT 4789A, AND DUNN 65C. STRIPPER 31 HAS DONE WELL FOR LATE PLANTING DUE TO ITS HIGH MIKING ABILITIES. IF YOUR FIELD HAS A HISTORY OF BAD VERTICILLIUM WILT, PLANT VARIETIES SUCH AS STRIPPER 31 RAHTER THAN GREGG 35.

## WHEAT PRICE - SUPPORT SCHEDULE MODERNIZED

A NEW LOAN RATE STRUCTURE FOR 1970-CROP WHEAT IS DESIGNED TO HELP KEEP LOCALLY-PRODUCED WHEAT WHICH IS UNDER LOAN WITHIN THE AREA UNTIL MARKETED, ACCORDING TO TROY MARTIN, CHAIRMAN OF THE GAINES COUNTY AGRICULTURAL STABILIZATION AND CONSERVATION (ASC) COMMITTEE. HE EXPLAINED THAT FOR THE 1970 WHEAT CROP, THE U.S. DEPARTMENT OF AGRICULTURE HAS ESTABLISHED AN INDIVIDUAL LOAN RATE FOR EACH COUNTY, AND WILL DO THE SAME SOON FOR THE 1970 CROPS OF GRAIN SORGHUMS, BARLEY, RYE AND FLAXSEED.

WHILE COUNTY LOAN RATES WILL STILL BE BASED ON THE NATIONAL AVERAGE PRICE-SUPPORT LOAN LEVEL --\$1.25 A BUSHEL IN THE CASE OF 1970-CROP WHEAT-- THE SCHEDULE ESTABLISHED FOR EACH COUNTY WILL TAKE INTO CONSIDERATION SUCH FACTORS AS TERMINAL MARKET PRICE RELATIONSHIPS, CASH PRICES RECEIVED BY FARMERS, AND EXPORT MARKETING PATTERNS.

THE LOAN RATE STRUCTURE USED FOR 1969- AND PRIOR-YEAR CROPS--USUALLY CALLED THE 'BACKOFF' OR 'TERMINAL MINUS' SYSTEM--TENDED TO ENCOURAGE MOVEMENT OF GRAIN FROM PRODUCING AREAS. THE NEW METHOD--CALLED THE 'COUNTY PLUS' SYSTEM-- WILL HELP KEEP GRAIN UNDER-LOAN CLOSER TO HOME UNTIL MARKETED.

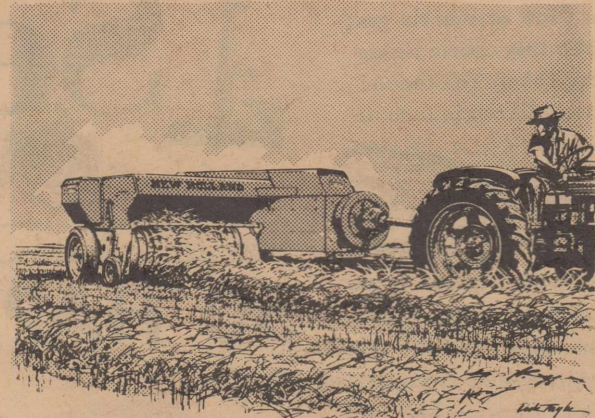
"THE CHANGE WAS MADE IN ORDER TO ALLOW GRAIN TO MOVE, IF NECESSARY, IN SUCH A WAY OR IN SUCH A DIRECTION AS TO BE ACCEPTABLE AND BENEFICIAL TO PRODUCERS, WAREHOUSEMEN AND TO THE COMMODITY CREDIT CORPORATION WHICH MAKES THE PRICE-SUPPORT LOANS TO ELIGIBLE PRODUCERS," MARTIN SAID.

THE NEW SYSTEM WILL INVOLVE SOME CHANGES IN MAKING LOANS AND SETTLING WITH PRODUCERS. DETAILS WILL BE SUPPLIED TO WHEAT PRODUCERS SOON, THE ASC COMMITTEE CHAIRMAN SAID.

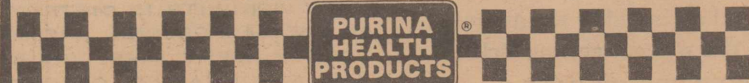

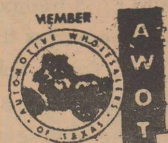

Sometimes she could live through this one, but then he turned his head to the right and cocked the left ear. Walter fell apart, and usually Mrs. Kirksey did too.



# Editorial

In 1936 at the Texas Centennial was a neat little sign which read 'Spit on the ceiling. Any fool can spit on the floor.' Being a country boy, I immediately looked to the ceiling - 75 feet high. I backed up and observed others as they read the sign, and from that day till this one it's never been outstanding to me to spit on the floor. Any fool can mess up what someone else has prettied up. Are we raising a generation of fools that think it's smart to spit in the floor, to throw bottles out on the highway right of way, to disfigure the community buildings, the county park, the schools or any other public facility? Some national parks have been threatened with closure because of the attitude of some American citizens for disrupting, for tearing up and for their filth while staying there. Some major cities have had to close city parks for the same reason. Some beaches cannot be enjoyed because of the neglect and the do-not-care attitude of others.

Let's get a little bit closer to home. A teacher living in Gaines County called the park attendant and complained of the broken glass in the area only to have some of her charges pull shingles off the building and throw them on the lawn. This didn't happen in a national park. This didn't happen in a major city. This happened in Gaines County Park. (2) Light fixtures are near impossible to keep replaced. Plug-ins are not available; they've been broken off and jerked off. (3) Someone from week to week throws soft drink bottles in the outside pavilion (amphitheater) seating area. (4) Mothers and fathers let their children climb on top of the buildings, either because of poor supervision or they do not care. (5) Outside rest rooms are unusable a part of the time - no lights, the filth of some and commodes made unusable. (6) Movable water hydrants are just plain broken off where other guests cannot have water. (7) Windows are broken. (8) Grease and food stuffs are left on the floor, on the walls and on the ceiling. Messes are made that makes extra work for custodians and people who are responsible for paying the bills and cleaning up.

Is it possible that the American people and Gaines County will have to stop keeping public facilities open because we are afraid to make those that refuse to take care of them pay the penalty, or that we do not care enough to make each other and our children behave? This editorial is being written to make us all think. We're becoming more crowded and we must be more careful with refuse, junk, trash, our habits and our ways.

The following is taken from an article entitled 'We Must Obey the Law', by Gayle Oler. All damage to property, all disregard of American rights, the rights of individuals and corporations, must be instantly checked by whatever means necessary, because the law of the land is the progress we have made during the life of this nation up to this date. With that law and that progress taken away, we fall back into the abyss of barbarism. Our nation may or may not have climbed very high from its starting point, but it must hold what it has gained. Our laws of property and privilege have been passed by the millions acting in their best hours, and they must not be set at naught by militant minorities acting in their worst hours.

### Industrial Board Meets

An economic research study which reveals those industries best adapted to the communities in its service area has been prepared for Southwestern Public Service Company by Arthur D. Little, Inc., nationally-known management consulting and research organization.

The confidential information in the study is being made available to those communities in the electric company's service area which have a going program for industrial and area development. Members of the local development group, Robert Jones, C.O. Wright, Reeves Cothes, Charles Ray, Glen Cavitt, and Dwayne Herman, heard a presentation of the study by Bob Whippo, local manager for Southwestern Public Service Company and members of the area development department, at a meeting last Wednesday.

Larry Milner told the local group that the study allows the electric company to sight in on target industries for this area, those which best utilize the natural, human and geographic resources of the region.

"We have developed a national advertising program, including direct mail and trade paper insertions, which will be aimed at those industries which the surveys show are most compatible to this region. We'll start with those with the most plus factors and work through the list," Milner said.

Emphasizing the highly competitive nature of industrial and area development, Milner urged the local industrial development team to make use of the information but to not broadcast it because much of the information in the study will apply to adjacent areas as well as the territory served by Southwestern Public Service Company.

"There's no sense in all of us working together to get this information, paying to have it put in usable form and then give it away. Most of the communities we serve helped compile the data that we have and we want them to be able to use it," Mr. Milner said.

The economic research study points out what industries should be sought by communities in the area and why. Several types of industry are available to nearly all towns in the region while there are a number for which only one or two communities have the desired elements.

The survey revealed that among the strengths of the region are a high quality labor supply, an excellent business climate and exceptional transportation facilities for shipment in any direction.

The study indicates that continued vertical integration of the area's agricultural production is vital to continued industrial growth. Vertical integration means adding value to the raw product and shipping out of the area a finished consumer product rather than a raw material.

"We are telling the communities we serve which are interested in industrial development what we are going to do as a result of the study and offering them the opportunity to integrate their efforts with ours. We are going to offer industries on the survey list anything and everything they want to know, including plant location studies. We want to get the communities and industries which match together, because that's what industrial development is all about," Mr. Milner concluded.

A copy of the study is available in the local office of the Southwestern Public Service Company for use by the local industrial development team.

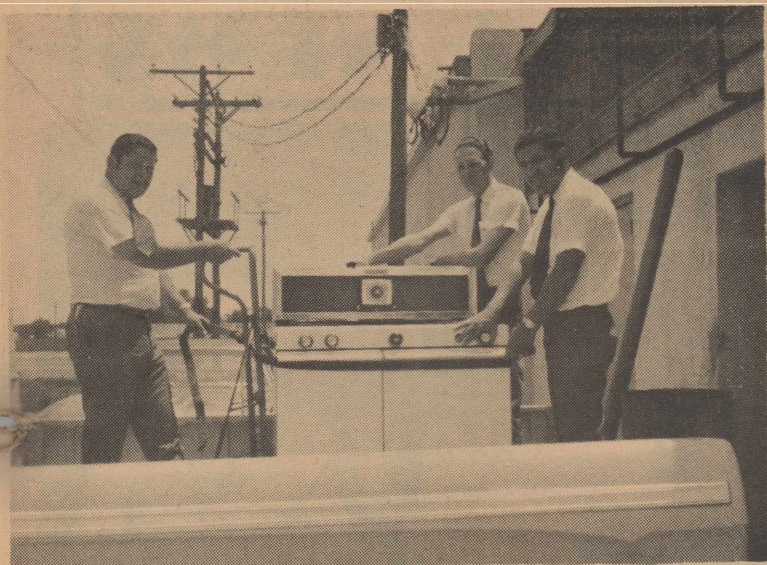

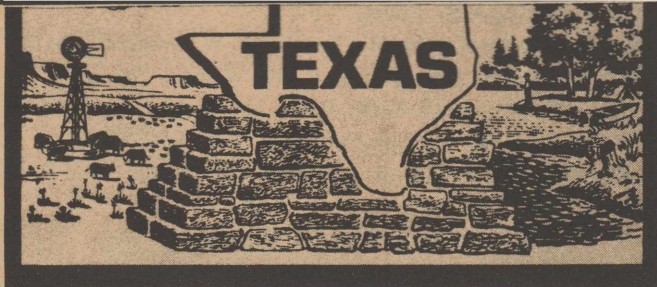

**TEXAS HIGHWAY DEPARTMENT**



MASSACRES, PICTOGRAPHS, legends and tall tales all go with the newest Texas state park - Hueco Tanks, a 738-acre tract 22 miles northeast of El Paso. The Parks and Wildlife Commission recently accepted title to the site culminating several years of effort by El Paso citizens to preserve the unique area. Hueco Tanks had an attraction that could not help but destine it to a colorful history - water. Depressions in the limestone make natural "cisterns" which store a great amount of water during the wet season. And in this parched country any quantity of water at all draws man and beast like a magnet. Apaches, Kiowas and Comanches camped here and left behind cave drawings telling of their adventures and sorrows, triumphs and superstitions. In addition to water, there are giant igneous monoliths, with labyrinths of caves and tunnels, that form an excellent fortress.

LAST GREAT INDIAN BATTLE in El Paso County was fought at Hueco Tanks when some early settlers tracked marauding Apaches across the desert to the tanks, besieged them in their caves and slaughtered them. Earlier, around 300-500 A. D., a Pueblo tribe called the "basket makers" inhabited the area. The pictographs are perhaps the most important features of the site as far as preservation is concerned. Painted on the solid rock walls, they are both perishable and immovable.

Would you believe they did not win one hole? The time 7:10, it was a dark day--the sun continued to shine.

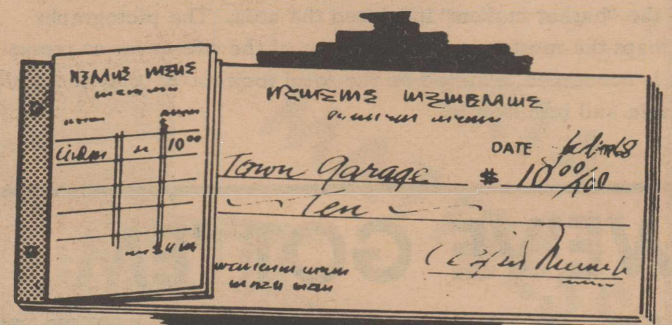

DID YOU KNOW THAT IF YOU OPERATE ANY TYPE OF AGRICULTURAL BUSINESS, THE HIRED WORKERS YOU HAVE IN THAT BUSINESS MAY BE COVERED BY SOCIAL SECURITY? IT'S A FACT.

ANY EMPLOYEE WHO WORKS AND EARNS \$150 OR MORE FOR ONE EMPLOYER DURING ANY YEAR, OR WORKS AT LEAST 20 DAYS ON A TIME BASIS FOR AN AGRICULTURAL BUSINESS, IS COVERED BY SOCIAL SECURITY. EVEN PART TIME EMPLOYEES COULD MEET THE EARNINGS OR WORK TEST. YOU, AS THEIR EMPLOYER, WOULD BE LIABLE TO WITHHOLD SOCIAL SECURITY TAX FROM THE EMPLOYEE'S CHECK, MATCH THAT TAX YOURSELF, AND REPORT THE EARNINGS AT THE END OF THE YEAR.

THE REPORT OF AGRICULTURAL EMPLOYEES MUST BE FILED WITH THE INTERNAL REVENUE SERVICE BY JANUARY 31 OF THE FOLLOWING YEAR. REPORTS SHOULD BE ON INTERNAL REVENUE SERVICE FORM 943--SHOWING EACH EMPLOYEE'S NAME, SOCIAL SECURITY NUMBER, AND AMOUNT PAID. THE REPORT SHOULD BE ACCOMPANIED BY TAX WITHHELD FROM EMPLOYEE'S PAY AND MATCHED BY EMPLOYER.

TO BE SURE WHICH EMPLOYEES TO REPORT, KEEP RECORDS ON ANYONE WORKING FOR YOU IN YOUR AGRICULTURAL BUSINESS.

IF YOU HAVE ANY QUESTIONS ABOUT FARM WAGES, PLEASE INQUIRE AT THE SOCIAL SECURITY OFFICE NEAREST YOU OR SEE ME ON ONE OF MY REGULAR VISITS TO THE COURTHOUSE.

**B. Get control of all means of publicity, thereby:**

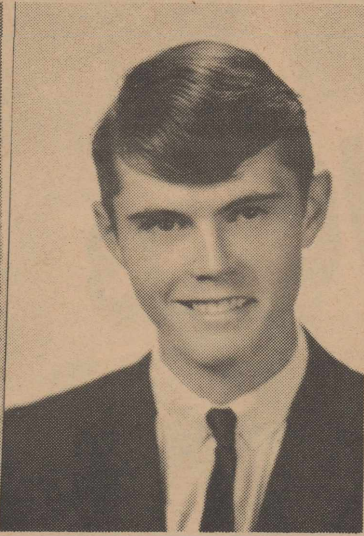
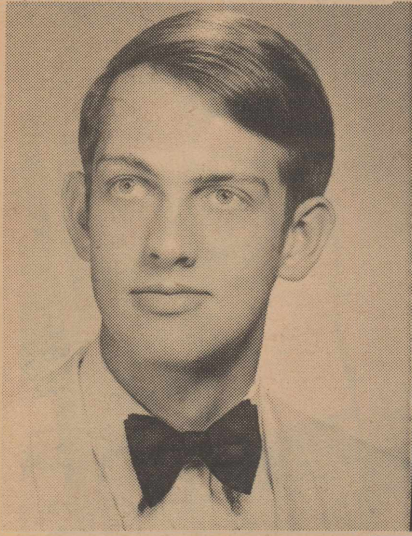
- 1. Get people's minds off their government by focusing their attention on athletics, sexy books and plays and other trivialities.**

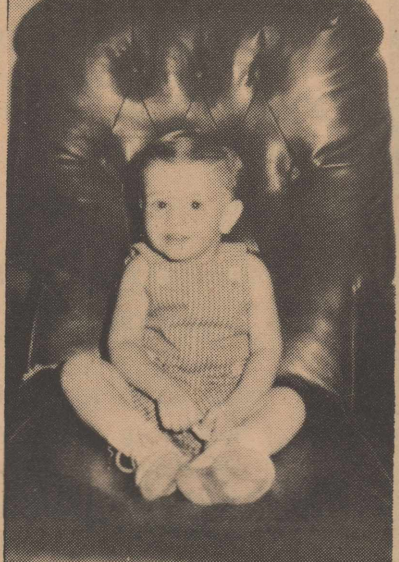

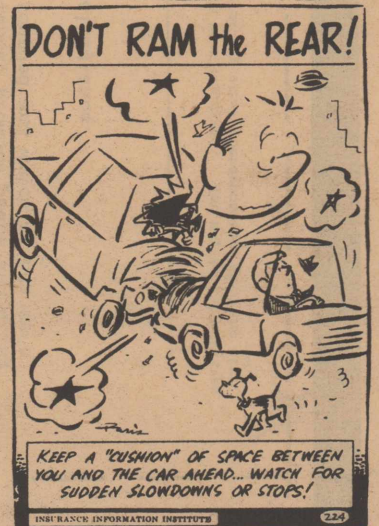
**MIKE SMITH, GOLF PRO, SPEAKS AT LIONS CLUB**

**THE ACADEMIC HOOD**

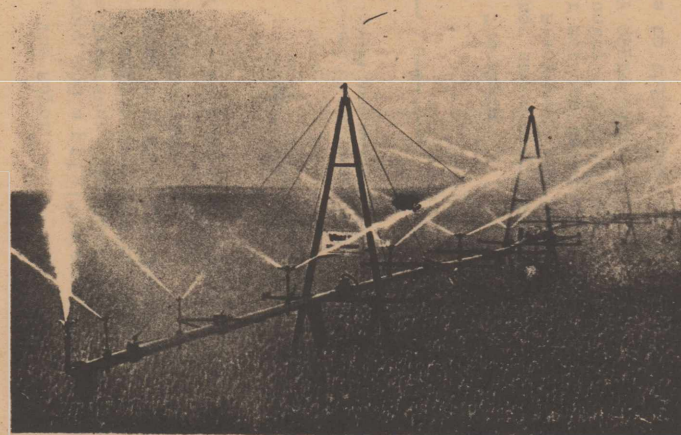
THE ACADEMIC REGALIA WORN AT COLLEGE COMMENCEMENTS, CONSISTING OF A GOWN, MORTARBOARD CAP, AND HOOD, ORIGINATED IN MEDIEVAL EUROPE. WHEN THE UNIVERSITIES BEGAN ABOUT THE TWELFTH CENTURY, A STYLE OF DRESS WAS QUITE DIFFERENT FROM WHAT IS WORN TODAY. THE BASIC ITEM OF APPAREL WORN BY EVERYONE, MEN AND WOMEN ALIKE, WAS A LONG GOWN OR ROBE. THE COLORS AND MATERIALS OFTEN INDICATED THE SOCIAL STATUS AND WEALTH OF THE WEARER. AN OUTER CLOAK WAS WORN OVER THE GOWN IN COLD WEATHER. THE CLOAK HAD A HOOD HANGING DOWN THE BACK, WHICH COULD BE PULLED UP TO COVER THE HEAD. THE MODERN ACADEMIC HOOD HAS EVOLVED FROM THIS MEDIEVAL GARMENT.

OVER THE CENTURIES THE DRESS OF THE COMMON MAN CHANGED TO MORE MODERN STYLES, BUT THE EUROPEAN UNIVERSITIES RETAINED THE MEDIEVAL DRESS. THE SCHOLARS' APPAREL WAS PRESCRIBED BY UNIVERSITY RULES AND DISTINGUISHED THE SCHOLAR FROM THE COMMONER. IN THE EIGHTEENTH CENTURY KING'S COLLEGE (NOW COLUMBIA UNIVERSITY) AND OTHER COLONIAL COLLEGES BEGAN TO USE THE ACADEMIC APPAREL OF ENGLISH UNIVERSITIES AT THEIR GRADUATION CEREMONIES. THE PRACTICE SPREAD WIDELY IN THE UNITED STATES AFTER 1880, AND 1895 AN INTERCOLLEGIATE COMMISSION ADOPTED A CODE OF ACADEMIC DRESS WHICH MOST COLLEGES FOLLOW TODAY.

THE HOOD IS A SYMBOL OF THE DEGREE WHICH THE WEARER HOLDS, AND IS, THEREFORE, THE MOST DISTINCTIVE PART OF THE ACADEMIC DRESS. THE COLORS OF THE HOOD IDENTIFY THE DEGREE AND THE UNIVERSITY OR COLLEGE WHICH CONFERRED IT.
