Association donates to local Volunteer Fire, EMS departments

The Oak Creek Lake Association (OCLA) announced contributions of \$1,000 to the Volunteer fire departments (VFD) of Blackwell and Bronte as well as \$1,000 to each Emergency Medical Services (EMS) of Bronte and Blackwell for a total of \$4,000 contributed.

The City of Sweetwater owns Oak Creek Lake and surrounding property (with a few exceptions) and leases Lake Lots to individuals. The lake is the major source of drinking water to the City of Sweetwater. The lessees pay taxes in Coke County and some lake lots pay Blackwell ISD taxes.

OCLA came into being in 2008 as a coming together of lake lot lessees at Oak Creek lake. The group at their May 2011 annual membership meeting unanimously approved the appropriations. Everyone recognized the life saving work of the EMS and the VFD's that protect their investments and lives in

Eastern Coke County and supported rewarding the receiving organizations.

The annual dues (set at \$10 for 2011) of association members was the source of the funds. Membership in the association is limited to those who lease (or own) property around Oak Creek lake. The association (A 501 (C)) entity focuses on and addresses issues affecting lake lot folks.

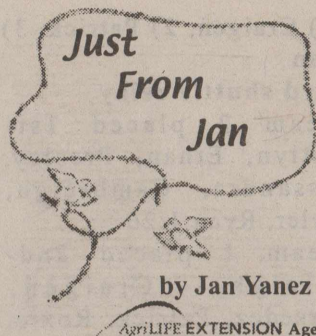

15 Ways To Keep Cool When It's Hot

1. Alter your pattern of outdoor exercise to take advantage of cooler times (early morning or late evening). If you can't change the time of your workout, scale it down by doing fewer minutes, walking instead of running, or decreasing your level of exertion.
2. Wear loose-fitting clothing, preferably of a light color.
3. Cotton clothing will keep you cooler than many synthetics.
4. Fill a spray bottle with water and keep it in the refrigerator for a quick refreshing spray to your face after being outdoors.
5. Fans can help circulate air and make you feel cooler even in an air-conditioned house.
6. Try storing lotions or cosmetic toners in the refrigerator to use on hot, overtired feet.
7. Keep plastic bottles of water in the freezer; grab one when you're ready to go outside. As the ice melts, you'll have a supply of cold water with you.
8. Take frequent baths or showers with cool or tepid water.
9. Combat dehydration by drinking plenty of water along with sports drinks or other sources of electrolytes.
10. Some people swear by small, portable, battery-powered fans.
11. If you're wearing a cap or hat, remove it and pour a bit of ice cold water into the hat, then quickly invert it and place on your head.
12. Avoid caffeine and alcohol as these will promote dehydration.
13. Instead of hot foods, try lighter summer fare including frequent small meals or snacks containing cold fruit or low fat dairy products. As an added benefit, you won't have to cook next to a hot stove.
14. If you don't have air-conditioning, arrange to spend at least parts of the day in a shopping mall, public library, movie theater, or other public space that is cool. Many cities have cooling centers that are open to the public on sweltering days.
15. Finally, use common sense. If the heat is intolerable, stay indoors when you can and avoid activities in direct sunlight or on hot asphalt surfaces. Pay special attention to the elderly, infants, and anyone with a

chronic illness, as they may dehydrate easily and be more susceptible to heat-related illnesses. Don't forget that pets also need protection from dehydration and heat-related illnesses too.

Care for livestock after a fire

Livestock caught in the path of the wind-swept fires across the state of Texas could suffer death, severe damage from burns and smoke inhalation. Often times, it takes days, maybe even weeks after fires to assess the livestock injuries.

Locate and secure the cattle, provide adequate water and forage, and then consult your vet. That's the first steps, but experts from Texas AgriLife Service and the Texas Veterinary Medical Diagnostic Laboratory have put together a list of other considerations and steps to take when determining livestock damage.

Feed & Water

If they can be moved to unburned ground, it is best. Provide fresh water

and then rotate their feeding area to prevent the build-up of pathogens.

Make sure they have adequate forage, appropriate supplements and good water.

Assessing damage

Check surviving cows and calves for signs of exposure to flames, heat and smoke. There could be cows with potentially scorched udders. Cows that suffered scorched udders from burns or excess heat may develop mastitis and will probably not allow calves to nurse. Calves should be monitored closely to detect any that are not able to nurse their dam.

Analyze cattle for secondary problems that lead to infections and further problems, for example, burned eyes, feet, udders, sheathes and testicles, as well as smoke inhalation with lung inflammation and edema.

It may take 10 days to two weeks for the damage to start showing on feet.

The cattle will start sloughing the hoof wall and become crippled.

To assure the welfare of the affected animals, veterinarians need to be consulted. If, in the event the animal is not going to be able to be treated, decisions concerning sending them to market need to be made immediately, before secondary complications develop.

Damage can also be done by livestock inhaling smoke. Smoke can move for miles and cattle that are not near the flames or heat could suffer some damage, such as irritation to the lining of the respiratory system, including nasal passages, trachea and lungs. This can lead to inflammation, edema and emphysema, with the severity determined by the duration of inhaled smoke.

In addition, the lining of the eyelids and eyeballs can be irritated and lead to secondary infections which can be fatal.

Continued Monitoring and Action

Monitoring should continue for weeks after the event. Secondary complications could be indicated by a cough or cloudy eyes in the animal.

Before secondary complications of infection occur, immediate slaughter for human consumption may be the most appropriate, humane procedure. Prior to slaughter, an antemortem inspection by veterinary meat inspectors will determine safety and wholesomeness for human food.

West Coke County EMS Memorials Clifford Wilson Mr & Mrs James Herford USDA Designates area counties as Primary Natural Disaster Areas

The U.S. Department of Agriculture has named Coke, Sterling, Nolan, Taylor and Tom Green counties as part of the 213 counties in Texas designated as primary natural disaster areas after one of the worst droughts in more than a century. The state sustained excessive heat, high winds and wildfires that burned hundreds of thousands of acres.

"Many producers have lost their crops due to the devastation caused by the drought and wildfires," said Agriculture Secretary Tom Vilsack. "President Obama and I want these farmers and

ranchers to know that we will support them through the recovery process and help them once again become productive suppliers of food, fiber and fuel that keep America prospering. This designation will help provide that support."

The drought, wildfires and other natural disasters - which began January 1, 2011, and continues - caused 30 percent or more loss of forage crops, pasture, corn, oats and wheat in the designated counties.

Farmers and ranchers in Nolan county also qualify for natural disaster assistance because it is contiguous.

All counties listed above were designated natural disaster areas June 24, 2011, making all qualified farm operators in the designated areas eligible for low interest emergency (EM) loans from

USDA's Farm Service Agency (FSA), provided eligibility requirements are met. Farmers in eligible counties have eight months from the date of the declaration to apply for loans to help cover part of their actual losses. FSA will consider each loan application on its own merits, taking into account the extent of losses, security available and repayment ability. FSA has a variety of programs, in addition to the EM loan program, to help eligible farmers recover from adversity.

USDA also has made other programs available to assist farmers and ranchers, including the Supplemental Revenue Assistance Program (SURE), which was approved as part of the Food, Conservation, and Energy Act of 2008; the Emergency Conservation Program; Federal Crop

Insurance; and the Noninsured Crop Disaster Assistance Program. Interested farmers may contact their local USDA Service Centers for further information on eligibility requirements and application procedures for these and other programs.
