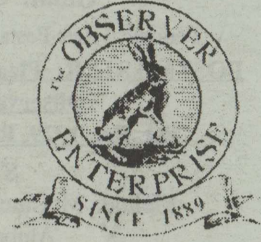

### Sign-up begins for USDA disaster assistance programs

Much of the Lone Star State continues to experience drought-like conditions, but Texas farmers and ranchers can find relief through U.S. Department of Agriculture (USDA) disaster assistance programs restored by the 2014 Farm Bill.

Sign-up is available at the

local Farm Service Agency (FSA) for the Livestock Forage Disaster Program (LFP), Livestock Indemnity Program (LIP), Emergency Assistance for Livestock, Honeybees and Farm-Raised Fish Program (ELAP) and the Tree Assistance Program (TAP).

"Depending on the size and type of the operations, eligible farmers and ranchers can enroll in one of the four programs administered by the FSA," said Coke County Farm Bureau President John Ross Copeland. "They have three to nine months to apply, depending on the program and the year of the loss."

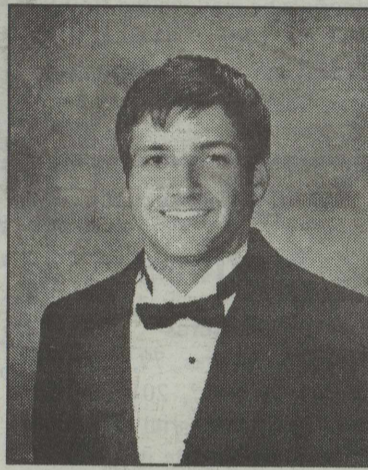
John Ross noted the programs are retroactive, allowing farmers and ranchers to receive payments for livestock deaths and grazing losses that have occurred since the expiration of the livestock disaster assistance program 2011.

"Farmers and ranchers in Coke County have already been hit hard by this drought. Many have adjusted the way they operate just to stay afloat," John Ross Copeland said. "The disaster assistance programs will provide some much-needed relief as they evaluate their farming and ranching operations."

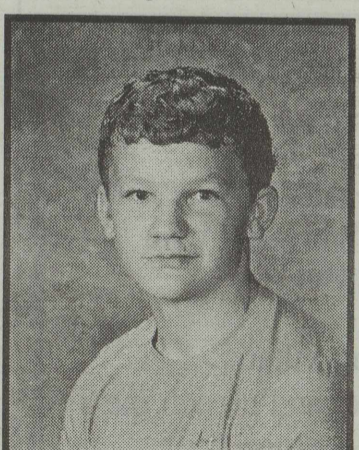
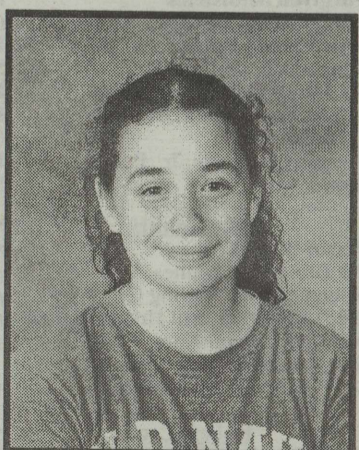

**AgriLife Extension Honors County Governments during Cooperative Extension Centennial**

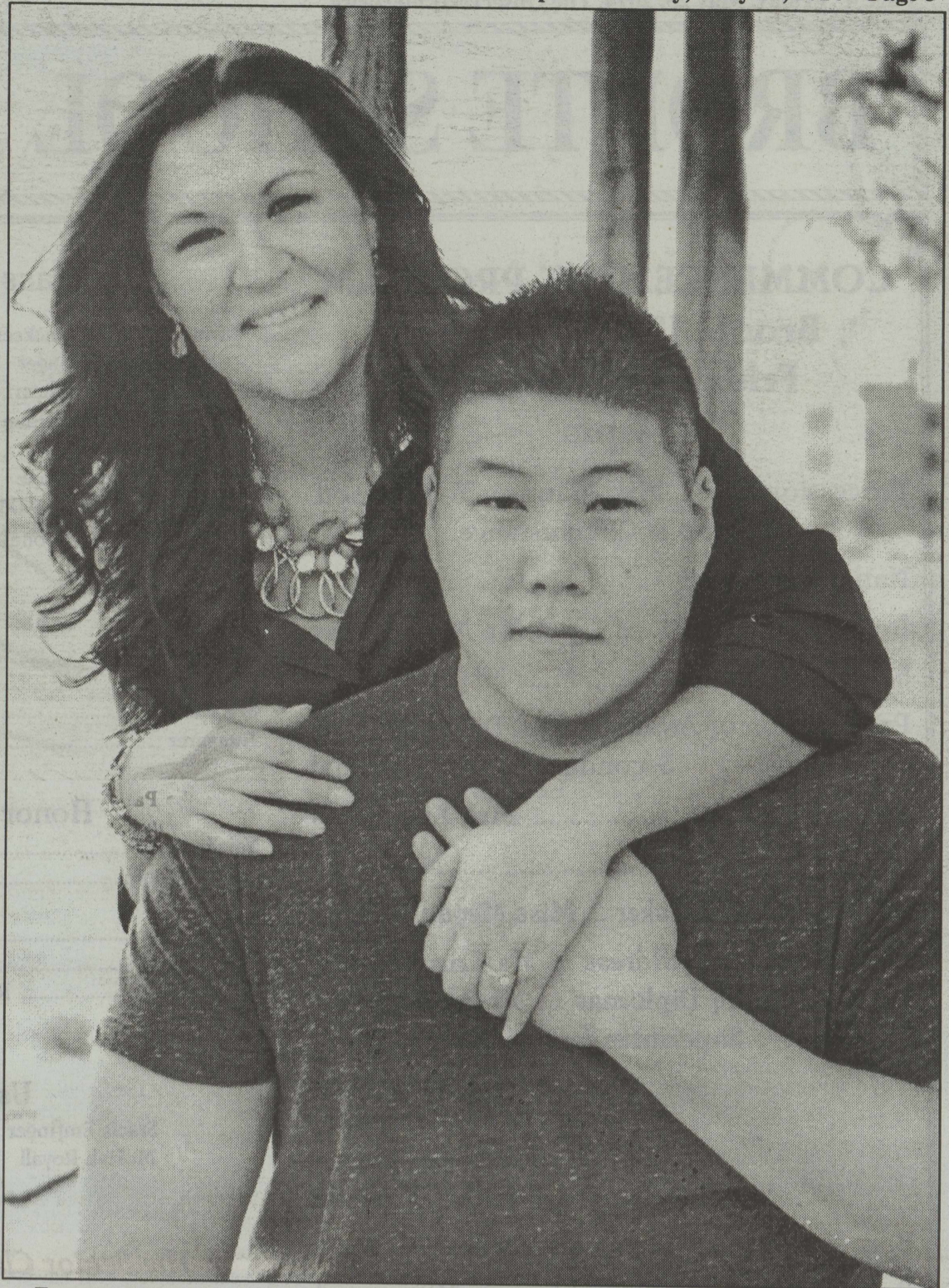
This month, the Texas A&M AgriLife Extension Service joins other Cooperative Extension services around the United States in celebrating the 100th anniversary of the signing of the federal Smith-Lever Act on May 8, 1914. This act provides for cooperative agricultural extension work at the nation's land-grant colleges – and county governments are vital partners in that work. As part of the celebration, AgriLife Extension representatives will present Extension's Building a Better Texas Award to every County Commissioners Court in Texas for decades of cooperation and support. County Extension offices are located in 250 of Texas's 254 counties, and Extension serves every county.

Jan Yanez and Morgan Runyan said "We want our county government to know how much we appreciate the partnership we have developed over the years. Without their support, we would not have been able to serve the people of Coke County as well as we have, and many Texans would

have missed opportunities to benefit from the practical, university-based information that Extension offers."

AgriLife Extension provides dozens of popular programs, including Texas 4-H and Youth Development, Texas Master Gardeners and Junior Master Gardeners, Texas Superstar plants, Walk Across Texas, Do Well Be Well with Diabetes, Better Living for Texans, Texas Master Naturalists, the Passenger Safety Project and many more. It also works one on one with local farmers, ranchers and landowners; provides wildlife services; diagnoses plant diseases; tests soil, water and forage; trains food handlers and pesticide applicators; and even trains county officials in the basics of serving their communities.

Headquartered at Texas A&M University in College Station, AgriLife Extension is a member of The Texas A&M University System. It is linked in a unique partnership with the nationwide Cooperative Extension System through the U.S. Department of Agriculture's National Institute of Food and Agriculture and through Texas county governments. County governments help provide locations and funding for county

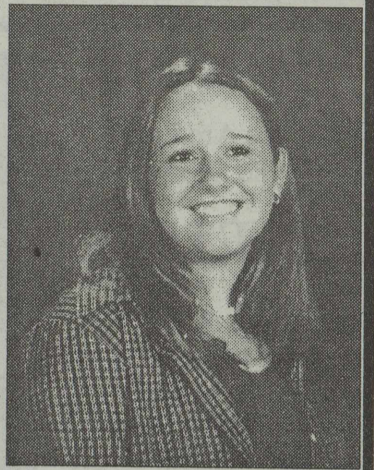
### Directors set high goals for Scholarship Fund

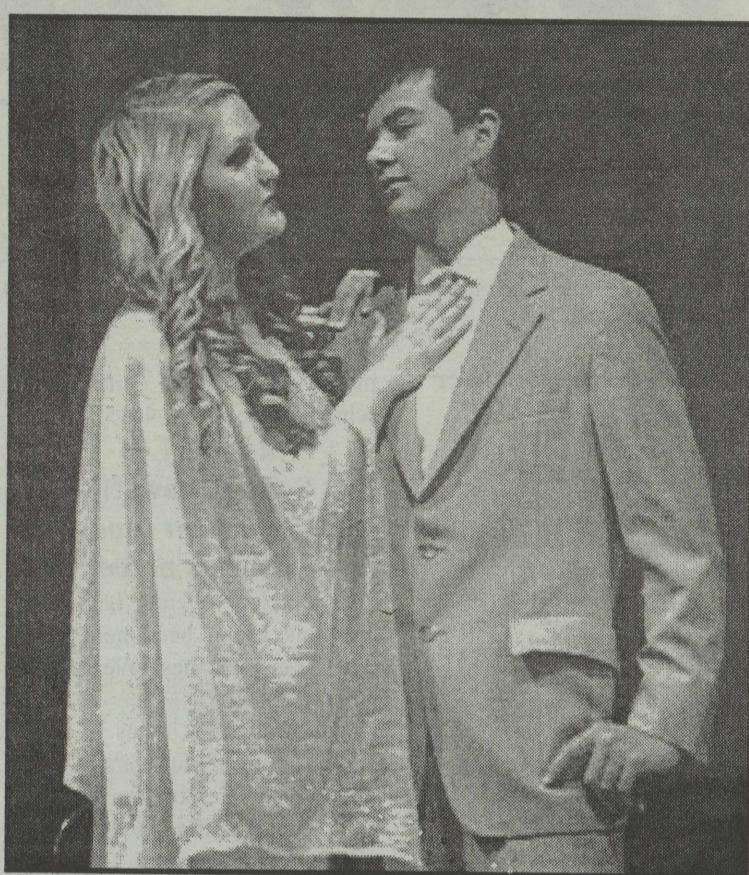
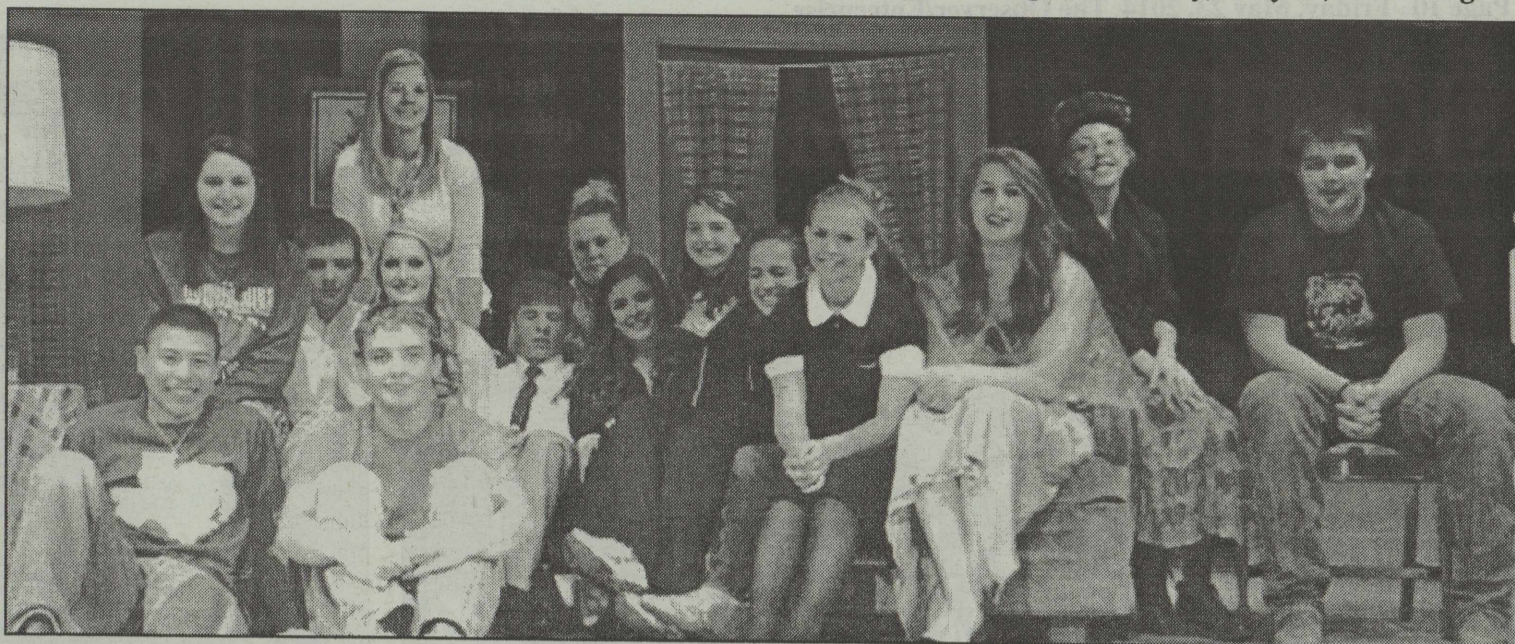

To date, \$414,000 has been

Currently, two to four seniors at Bronte receive the scholarship each year. Each student must

maintain a 2.0 GPA and carry a minimum of 12 hours or the equivalent to remain eligible for the scholarship.

These scholarships are not just for those students attending 4 year universities, but also for

students planning to attend junior colleges, vocational schools and trade schools.

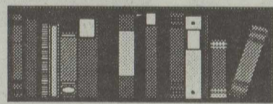
## RLISD bad weather make-up days

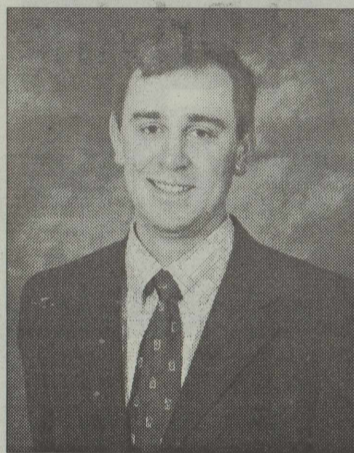

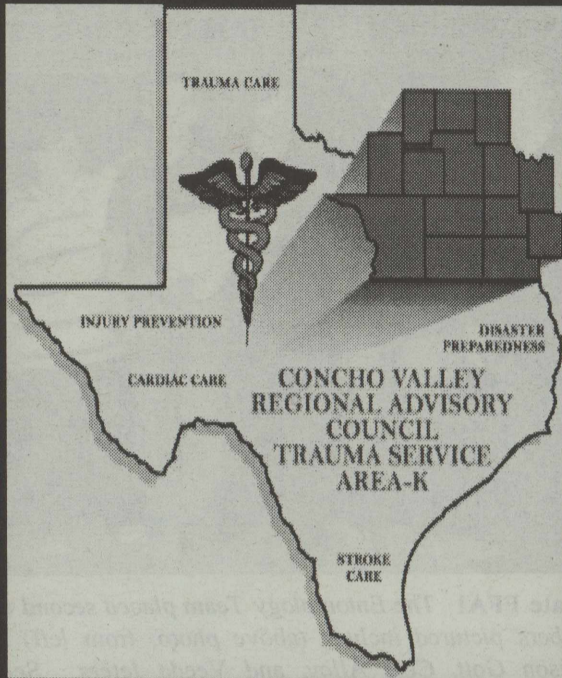

Here are some facts about distracted driving:

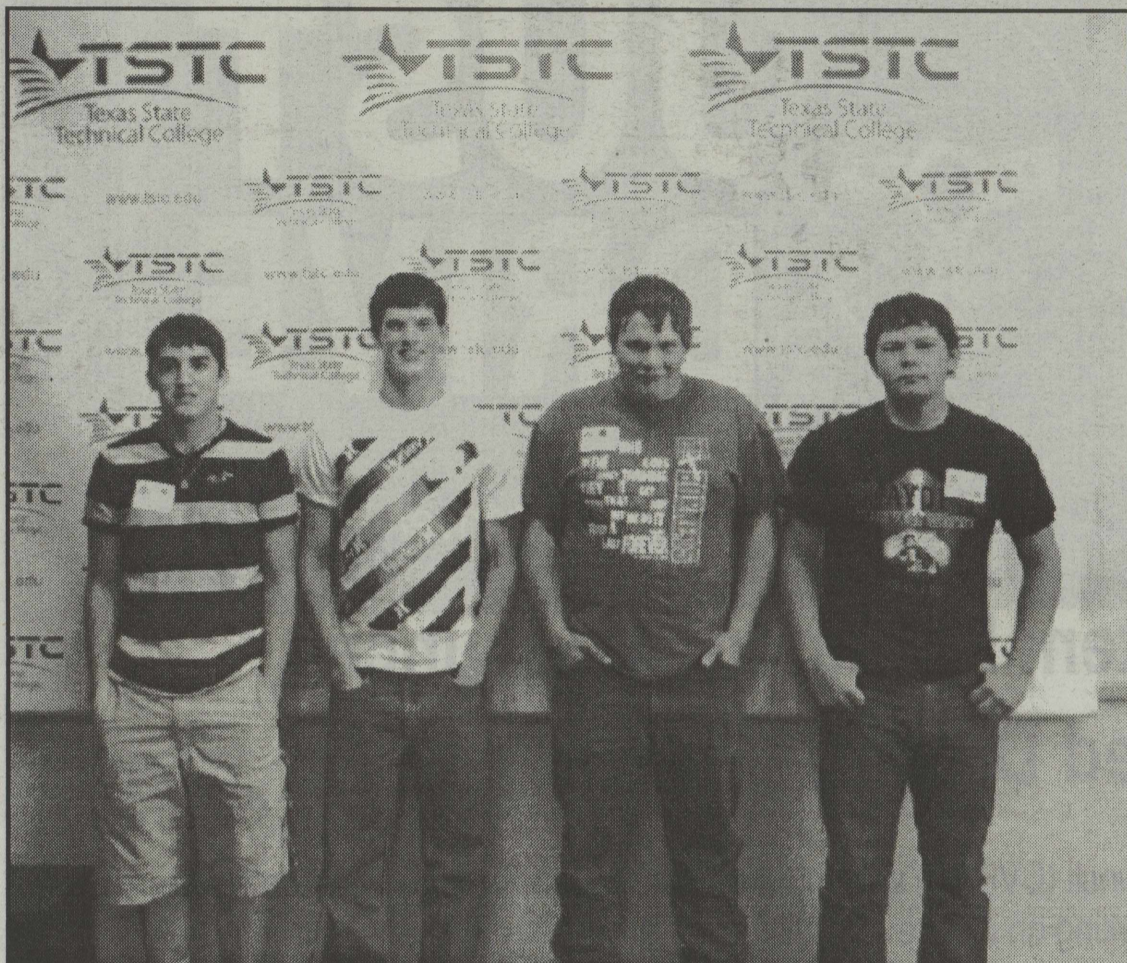
When your mind or attention is not focused solely on driving, you're a distracted driver. While cell phones are a major culprit, anything that takes your mind and attention away from your driving is a distraction.

There are three main types of distractions:

- Visual — taking your eyes off the road
- Manual — taking your hands off the wheel
- Cognitive — taking your mind off what you're doing

- Those who text and drive are 23 times more likely to be in a motor vehicle crash, according to the Virginia Tech Transportation Institute.
- When drivers read or send a text message, their reaction time is doubled. When asked to respond to a flashing light while texting behind the wheel, drivers were more than 11 times more likely to miss the light altogether.
- A whopping 97 percent of teens say texting while driving is dangerous, but 43 percent admit to doing so.
- Almost all teens (nine in 10) expect a reply to a text or email within five minutes or less, which puts pressure on them to respond while driving.
- According to 77 percent of teens, adults tell kids not to text or email while driving – yet adults do it themselves "all the time."
- Crashes kill more young people than any other cause, accounting for nearly half of all teen deaths in America each year. Most teens and parents are unaware of the top five dangers of teen driving: driving at night; speeding and street racing; distractions, such as cell phones/texting and too many teen passengers; low seat belt use; and alcohol use.
- More than 3,000 U.S. teens die each year in car crashes; that's the equivalent of a commercial jet loaded with teenagers crashing once every other week for an entire year.
