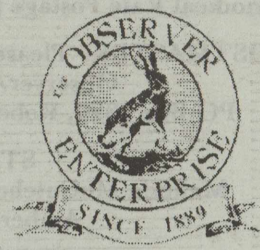

Old Jail open to public following Saturday's dedication

The new Old Jail will be on display following the dedication ceremonies on Saturday, September 20, 2014, at 9:30 am. The early hours for the dedication and touring times were set because the Old Jail is not air conditioned. Preservation processes state that outside temperature that is higher than an inside temperature would be detrimental to the concrete walls of the building.

Two plaques will be added to the Old Jail naming the preservation project's benefactor, Roberta Cole Johnson, and her contributions to West Texas historical projects. Another plaque will be added to the annex naming Charles and Joy Millican Blake, trustees of the Johnson estate, who worked to determine sites for preservation in our area.

The Old Jail's preservation work has been an amazing collaboration of the Coke County Historical Commission, history lovers and recorders, Coke County Commissioners and crews, Robert Lee city crews, neighbors of the Old Jail, engineers of Southern Folger Detention Equipment of San Antonio, history oriented agencies from San Angelo and Winters, Olive's Nursery, and especially the encouragement of pioneer family members.

Plans for the annex include securing preservation and storage equipment, cataloging capability, self-publishing facilitators, and workspace for

students of all ages to stay connected to the past. A visit to Fort Chadbourne, Fort Concho, the Winters Rock Hotel and museums, or the West Texas Collection at ASU will provide insight into the exciting place for history and preservation... all outside of iPads, iPhones, and PC's.

The Court voted on that day to increase the Sheriff's salary and that of his deputies by 7%. Following the unanimous vote, the 2015 budget was approved, adopted and subsequently certified.

The Texas Local Government Code requires the County to approve and post Elected

 Officials' salaries in advance of approving the annual budget. The code requires that Elected Officials receive written notice of the approved salary as well as the opportunity to meet with a grievance committee should they disagree with the salary set by the Commissioner's Court. The salary grievance committee process has to be completed before the annual budget is adopted.

Since the increase voted in by the Commissioners Court on September 2 was after the required notifications, a public hearing had to be set to once again hear public comment on this subject and to take action.

Swine Validation Time

It is that time a year again to order swine validation tags for FFA and 4-H members planning on exhibiting swine projects at the Coke County Show and the major stock shows. Any barrow must have a state validation tag to be eligible to enter Fort Worth, San Angelo, San Antonio, Houston, or Austin stock shows. Also, any gilt must have a state validation tag to be able to participate in the CTBR Stars of Texas gilt show at the San Angelo Stock show. You can contact your Agriscience teacher or the Coke County Extension office to place your tag order. The tag order is due by Tuesday, September 23, 2014 to the swine validation chairman. Swine validation will be held in November and will be set by the county stock show board of directors.

Range and Wildlife Field Day scheduled

 The Texas A&M AgriLife Extension Service and Texas Parks and Wildlife Department will conduct a multi-county Range and Wildlife Management Field Day on September 19 in Brown County for landowners interested in managing wildlife and livestock.

The program will run from 8 a.m.-4 p.m. at the McGillivray and Leona McKie Muse Wildlife Management Area, 15 miles northeast of Brownwood off County Road 478.

The morning talks will be followed by lunch, then a tour of the wildlife management area.

Individual registration includes lunch. RSVP by September 14 by contacting the AgriLife Extension office in Brown County at 325-646-0386.

Three Texas Department of Agriculture continuing education units, two integrated pest management and one general,

will be available.

"Many Texas landowners are beginning to see the value of managing wildlife on their properties," said Brian Hays, associate director of the Texas A&M Institute of Renewable Natural Resources, Gatesville. "Landowners interested in managing for wildlife can take advantage of various incentive programs to diversify their income through good land stewardship for livestock and wildlife."

Scott Anderson, AgriLife Extension agent in Brown County, said AgriLife Extension staff will discuss quail and

turkey biology and management. Texas Parks and Wildlife Department personnel will talk on Texas horned lizards, wildlife management planning and the Proposition 11 wildlife property tax exemption.

Other scheduled talks to be presented by U.S. Department of Agriculture Natural Resources Conservation Service experts will focus on rangeland evaluation and proper brush control techniques to include dozing, prescribed fire and herbicide application.

"A particular focus will be on quail because of their popularity

as a game species and their extreme decline in numbers in recent years," said Mike Marshall, AgriLife Extension associate with the Texas A&M University Institute of Renewable Natural Resources at Gatesville. "The Muse property offers an ideal place to see proper quail management in action."

Other field tour stops will include demonstrations on calculating stocking rates, plant identification, habitat assessment and a preview of a prairie restoration effort now underway on the wildlife management area.

The Robert Lee ISD Board of Trustees met in special session at 5 pm Wednesday, August 27, 2014, in the Robert Lee ISD Conference Room 119.

Members present included Wes Washam, Jeffie Roberts, Beverly Sinclair, Tom Sawyer, Irma Torres, George Grim, and Erin Oleksiuk. The meeting was called to order by President Wes Washam.

The Invocation and pledge were led by Tom Sawyer.

Irma Torres made a motion to approve the minutes of August 21, 2014, seconded by Erin Oleksiuk. All voted for.

Jeffie Roberts made a motion to accept the financial report, budget amendments as presented by Robin Allen and to pay the bills, seconded by Beverly Sinclair. All voted for.

A Public Hearing on 2014-2015 Proposed Budget was held.

Supt. Hood recommended to approve the 2014-2015 Official Estimated Budget by Fund and Function as presented. Erin Oleksiuk made a motion to approve this recommendation, seconded by George Grim. All voted for.

A Public Hearing on 2014-2015 Proposed Tax Rate was held.

Supt. Hood recommended to set the tax rate by ordinance for 2014-2015 as follows: \$1.04 for the purpose of maintenance and operation (M&O) and \$0.42 for the purpose of payment of principal and interest (I&S) for a Total Tax Rate of \$1.46. Tom Sawyer made a motion to adopt the 2014-2015 tax rate as presented, seconded by Irma Torres. All voted for.

Supt. Hood recommended signing a resolution setting minimum fund balance for year ending August 31, 2015 as \$100,000 for sick leave, \$200,000 for capital expenditures, \$100,000 for technology and \$100,000 for land. A motion was made by Tom Sawyer and seconded by Jeffie Roberts to approve the resolution as presented. All voted for.

Supt. Hood recommended signing a resolution on Committed Fund Balance for year ending August 31, 2014. Tom Sawyer made a motion to approve this resolution as presented, seconded by Irma Torres. All voted for.

Jeffie Roberts made a motion to approve 2014-2015 Teacher Salary Schedule and Auxiliary Salary Schedule as presented by Supt. Hood. The motion was seconded by George Grim. All voted for.

Beverly Sinclair made a motion, seconded by Irma Torres, to approve 2014-2015 Stipends as presented. All voted for.

Supt. Hood gave his report on elementary numbers and calendar items.

There were no personnel matters to discuss.

ACT and SAT Test Deadlines announced

Students interested in taking the October 25, 2014 ACT test must register on or before September 19th, 2014 in order to avoid late fees. Students may register online at www.actstudent.org or pick up an application in the high school counselor's office. The cost of the ACT test is \$38.00 or \$54.50, if a student registers for the ACT Plus Writing test. If someone is unsure which test to sign up for, please consult the high school counselor.

Students interested in taking the October 11, 2014 SAT Test

must register on or before September 12th in order to avoid late fees. Another SATTest will be administered November 8th and the deadline to apply for that test is October 9th. The cost of the SAT Reasoning test is \$52.50 and includes a required writing portion. Registration may be done online at sat.org/register or you may pick up a registration packet in the counselor's office.

Fee waivers are available to junior and senior students who qualify for free or reduced lunches. Call or see Mrs. Timmerman, counselor for more information. Please keep in mind that the ACT and SAT tests will be offered several times throughout the year. The ACT test is offered at Bronte High School in October, April and June. 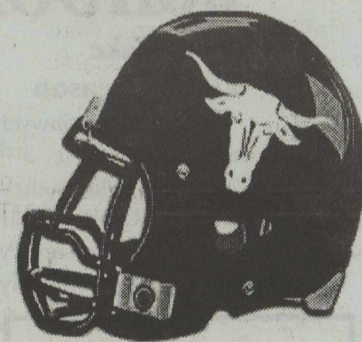

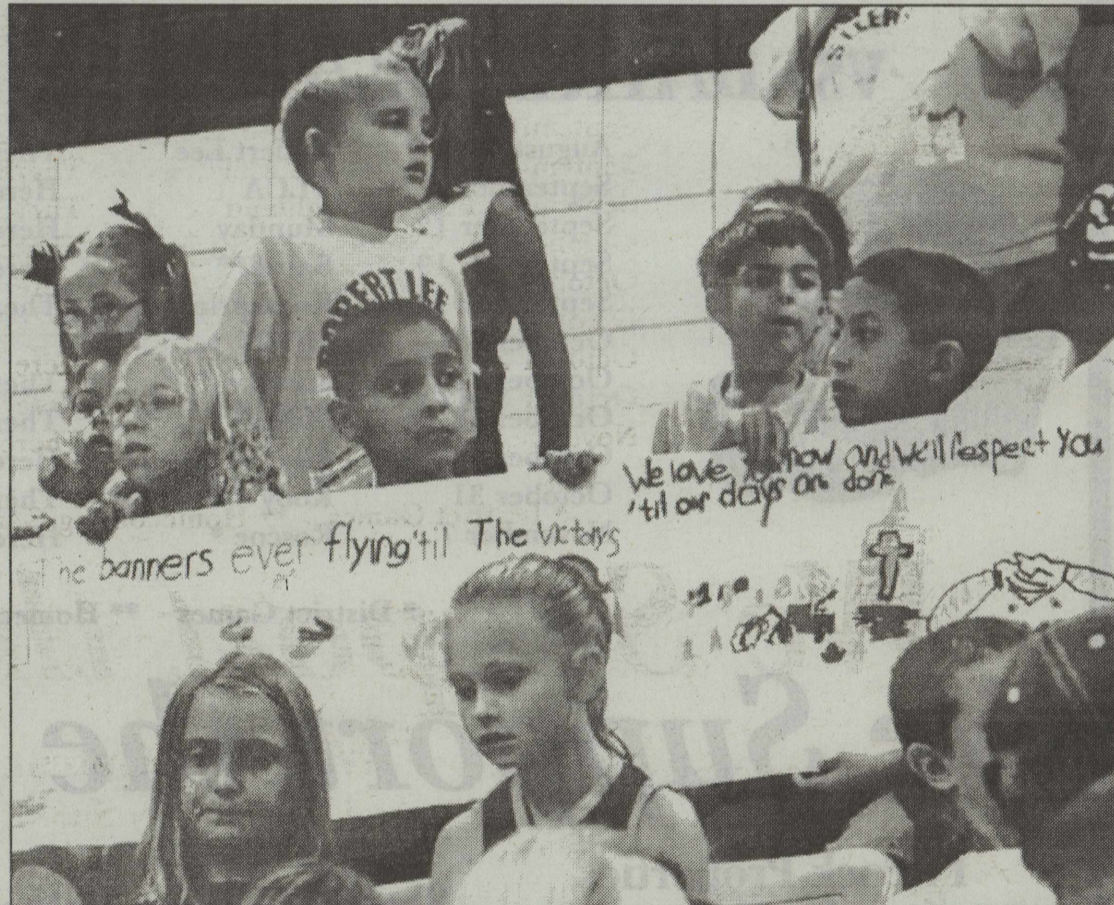

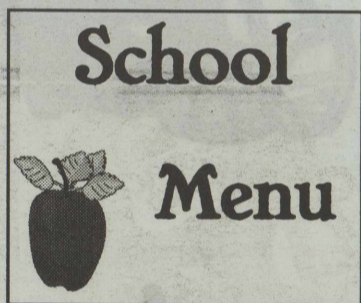

Farm Bill programs set

The Texas A&M AgriLife Extension Service has set five farm bill programs across West Texas meant to help producers in their decision-making process, said an AgriLife Extension economist.

"This farm bill sign-up has lots of 'moving parts' that require producers to process quite a bit of data in order to make rational decisions," said Bill Thompson. "Our commodity groups and industry associations have done an excellent job of explaining the programs and the options in front of us, but now it's time to learn to work through the intricacies."

All the programs are set from 9 am until 12 noon at the following dates and locations:

- Sept. 23, Garden City, Glasscock County AgriLife Extension meeting room, 117 S. Myrl St.
- Sept. 24, San Angelo, Tom Green County 4-H Center, 3168, North U.S. Highway 67.
- Oct. 6, Stamford, Stamford High School Auditorium, 507 S. Orient, St.
- Oct. 7, Fort Stockton, Texas A&M AgriLife Extension Center, 1618 Airport Dr.
- Oct. 8, Fort Hancock, Community Building, 562 Knox Ave., 562 Knox Ave.

Thompson said the meetings will recap both the programs available to producers, including Price Loss Coverage, or PLC, and Agricultural Risk Coverage, or ARC. They also will cover any base and yield update options available that can illustrate the data needed to complete the decision-making process.

"Though the new farm bill addressing cotton won't be in place until 2015, almost all farms will still need to enroll acreage into one of these two coverage areas," Thompson said. "We will also have a short discussion of the disaster and conservation programs available."

Thompson said he'll introduce an online decision aid available to producers developed by the Agricultural and Food Policy Center of the agricultural economics department at Texas A&M University, College Station. The decision aid simplifies the analysis needed to choose between the PLC and ARC coverages.

"A significant emphasis was placed on crop insurance by Congress, so this decision aid will help producers identify optimal and viable insurance coverage levels to provide as much of a crop loss safety net as possible."

Thompson said he expects many questions to arise during the meetings,

so he's allotted ample time for discussion.

Quail Appreciation Days

The Texas A&M AgriLife Extension Service will conduct a second set of Quail Appreciation Days across Texas this fall for landowners, naturalists and others interested in proper quail management aimed at stopping the decline of wild native quail.

"This is the first time in half a dozen years that I feel I've really seen a glimmer of hope in our wild quail population decline situation," said Dr. Dale Rollins, statewide coordinator for the Reversing the Quail Decline Initiative in San Angelo.

"This fall's quail crop is shaping up to be the best since about 2008 in most areas. May and June brought real quail-making weather. Surviving quail were quick to take full advantage of the cool, wet weather, to 'seize the day' from a reproductive standpoint.

"It's our hope that this series of Quail Appreciation Days will help landowners make the most of their improved quail population by implementing and then demonstrating good habitat management practices."

All the programs share similar agendas, though each will be tailored to fit the area in which that particular appreciation day is set. All start with registration at 8:30 am and conclude by 4:30 pm.

Dates, counties and the AgriLife Extension agents conducting the workshops are as follows:

- Sept. 23, Tom Green County, Josh Blaneck.
- Sept. 30, Zavalla County, Marcelino Valdez.
- Oct. 1, McMullen County, Isaac Cavazos.
- Oct. 2, Duval County, Rogelio Mercado.
- Oct. 15, Wilson County, Bryan Davis.

Each workshop will include presentations on quail physiology and management, plus an afternoon tour demonstrating management and habitat assessment techniques.

Individual pre-registration is due one week prior to the field day and a late fee will be charged at the door for those not pre-registering.

Three Texas Department of Agriculture continuing education units, two general and one integrated pest management, will be offered at each workshop.

"Our goal is to have attendees literally think like a quail for the entire day," Rollins said. "Once they experience the quails' world, they can better appreciate how their management decisions, particularly grazing and brush management, impact quail; either good or bad."

Rollins said the Quail Appreciation

Day series is one component of AgriLife Extension's Reversing the Decline of Quail Initiative. Other components currently being implemented include a series of research projects and "QuailMasters," a series of continuing education workshops for serious "students of quail."

Livestock Producers urged to enroll in Disaster Assistance Program by October 1

The U.S. Department of Agriculture (USDA) is encouraging producers who have suffered eligible disaster-related losses to act to secure assistance by September 30, 2014, as congressionally mandated payment reductions will take place for producers who have not acted before that date. Livestock producers that have experienced grazing losses since October 2011 and may be eligible for benefits but have not yet contacted their local Farm Service Agency (FSA) office should do so as soon as possible.

The Budget Control Act passed by Congress in 2011 requires USDA to implement reductions of 7.3 percent to the Livestock Forage Disaster Program (LFP) in the new fiscal year, which begins October 1, 2014. However, producers seeking LFP support who have scheduled appointments with their local FSA office before October 1, even if the appointment occurs after October 1, will not see reductions in the amount of disaster relief they receive.

USDA is encouraging producers to register, request an appointment or begin a Livestock Forage Disaster Program application with their county FSA office before October 1, 2014, to lock in the current zero percent sequestration rate. As an additional aid to qualified producers applying for LFP, the Farm Service's Agency has developed an online registration that enables farmers and ranchers to put their names on an electronic list before the deadline to avoid reductions in their disaster assistance. This is an alternative to visiting or contacting the county office. To place a name on the Livestock Forage Disaster Program list online, visit www.fsa.usda.gov/disaster-register.

Producers who already contacted the county office and have an appointment scheduled need do nothing more.

"In just four months since disaster assistance enrollments began, we've processed 240,000 applications to help farmers and ranchers who suffered losses," said Agriculture Secretary Tom Vilsack. "Eligible producers who have not yet contacted their local FSA office should stop by or call their local

FSA office, or sign up online before October 1 when congressionally mandated payment reductions take effect. This will ensure they receive as much financial assistance as possible."

The Livestock Indemnity Program, the Tree Assistance Program and the Noninsured Disaster Assistance Program Frost Freeze payments will also be cut by 7.3 percent on October 1, 2014. Unlike the Livestock Forage Disaster Program, applications for these programs must be fully completed by September 30. FSA offices will prioritize these applications, but as the full application process can take several days or more to complete, producers are encouraged to begin the application process as soon as possible.

The Livestock Forage Disaster Program compensates eligible livestock producers who suffered grazing losses due to drought or fire between October 1, 2011, and December 31, 2014. Eligible livestock includes alpacas, beef cattle, buffalo, beefalo, dairy cattle, deer, elk, emus, equine, goats, llamas, poultry, reindeer, sheep or swine that have been or would have been grazing the eligible grazing land or pastureland. Producers forced to liquidate their livestock may also be eligible for program benefits.

Additionally, the 2014 Farm Bill eliminated the risk management purchase requirement. Livestock producers are no longer required to purchase coverage under the federal crop insurance program or Noninsured Crop Disaster Assistance Program to be eligible for Livestock Forage Disaster assistance.

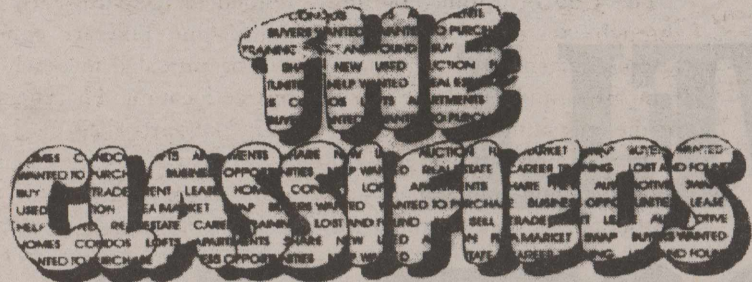

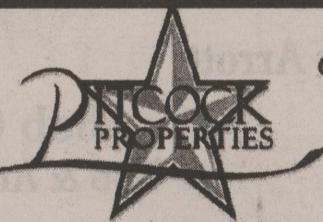

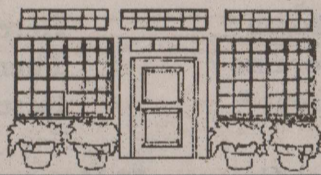

ORDINANCE 14-08

REPLACING

ORDINANCE 14-01

THE STATE OF TEXAS
COUNTY OF COKE
CITY OF BRONTE

WHEREAS, the City of Bronte is subject to certain federal and state environmental laws, rules, and regulations, governing the collection and disposal of garbage and trash, as herein defined; and

WHEREAS, it is the intent of the City to comply with all such environmental laws, rules and regulations for the benefit, welfare, and best interest of the citizens of Bronte;

THEREFORE, BE IT ORDAINED AS FOLLOWS:

The City of Bronte shall furnish garbage collection service pursuant to the understated rules, regulations, and stipulations as specified in this ordinance and as may be amended, to-wit:

A. DEFINITIONS: The following terms shall be defined for the purpose of this ordinance as follows, to-wit:

1. Garbage - All glass, tin cans, paper boxes, waste materials from kitchens, refuse from kitchens, residential waste materials, grocery store waste material, restaurants, cafes, hotels and such other waste and/discarded material as may be discarded from residential and/or commercial locations in and about the City of Bronte.

2. Trash - Rubbish, including but not limited to yard cleanings, grass clippings, leaves, and other such discarded residential and/or commercial material as may be discarded by residential and/or commercial occupants and commercial businesses in the City of Bronte.

B. CONTAINERS REQUIRED:

1. Each and every owner, occupant, tenant and/or lessee using or occupying any building, house or structure within the City for residential usage, church utilization, schools, lodges, commercial establishments, businesses, and/or other purposes not receiving sanitation container system service as described herein, shall be provided a 96 gallon polycart.

C. DESIGNATED PICKUP POINT FOR CONTAINERS FOR REMOVAL:

As to all house, buildings and premises from which garbage is to be collected and removed which are adjacent and adjoin to a street, the owner, occupant,

tenant, and/or lessee of the premises, shall be required to place the polycart(s) at the curb adjacent to the City street fronting the premises in or that it may be easily accessible to the City's collection service in its collection and removal of garbage. In the event it is not practical to collect the garbage from a street as to those locations and/or sites where said street is not fully "developed," "opened," or other obstruction may exist, the owner, occupant, tenant, or lessee of the premises shall place polycarts at points designated by an authorized agent of the City, said point being accessible to the City Agent.

The designation of the location of polycarts as designated herein shall be at the sole and complete discretion of the City in regard to the most accessible point for collection and removal of the same. The decision of the City in regard to the location of the designated point shall be final.

D. WET GARBAGE:

All garbage and trash that is mixed with water and/or other liquids shall be drained before being deposited in the polycart or receptacle.

E. AUTHORIZED PERSONS TO COLLECT AND HAUL GARBAGE AND TRASH:

(b) Premises used for commercial business, and/or public purposes not received sanitation container service as described herein shall be charged \$25.00 per month. One polycart container will be provided for each trash location. The charge for extra polycarts shall be \$10.50 per polycart.

(c) Premises located outside the City Limits shall be charged at a rate of 1.5 times above the rate charged the City by its trash collection provider. Said premises must be served by another City utility for which a bill is sent.

(d) If a polycart is lost or damaged by the resident, a \$60.00 replacement fee will be assessed.

G. WHOM TO BE BILLED:

All persons, businesses, commercial institutions, and/or public agencies within the city limits who are served by city water meters are required to pay the garbage collection fee with the following exception:

1. Water service customer is in a nursing home, hospital or rehab center for a continuous period of more than 60 days;
2. Water service customer resides outside the City for a continuous period of more than 60 days;
3. Property has been vacant and unoccupied for a continuous period of more than 60 days;
4. The land is vacant of any dwellings.

H. CONTAINERIZED SANITATION SYSTEM:

1. After the effective date of this ordinance, certain public, business and/or commercial locations and sites shall receive sanitation container system service for the removal of garbage and trash under the rates and rules hereinafter set forth. A residential service may be allowed sanitation container system service on a short time basis. Pursuant to sanitation container system services, the City will furnish a container or containers to be used in the collection and/or removal of garbage and trash. The following formula shall be used as to the fees charged for garbage and/or trash hauling, to-wit:

Charges for one pickup per week:

Container Size	Rate
2 yd.	66.50
4 yd.	105.75
6 yd.	141.70
8 yd.	177.65

Charges for two pickups per week:

Container Size	Rate
(Once Per Week Plus One Extra Pickup)	
2 yd.-\$40 per pickup-\$103.34	
4 yd.-\$50 per pickup-\$150.71	
6 yd.-\$74 per pickup-\$208.95	
8 yd.-\$90 per pickup-\$259.19	

2. In the event a container will adequately and completely serve several business institutions which are required to receive container service, the business institutions will be allowed to use the same container and pay a prorate part of the charge, based upon the number of businesses utilizing the same container and the agreement of the businesses utilizing the same. In the event no agreement can be reached as to the prorate share payment, the City shall determine the business's prorate share and assign the same and collect accordingly.

3. Lids and doors of all containers shall be kept closed at all times except when the container is being filled.

4. It shall be unlawful for any person to disturb a sanitation container furnished by the City or contents thereof,

save and except the owner and/or occupant of the premises shall have the right to designate parties, persons, employees, or agents who are authorized to dump trash into said container.

5. It shall be unlawful to make a fire or burn any material in the sanitation container furnished by the City or to paint or mark on the same or to place any poster, placard or sign upon the same.

6. Whenever it has been determined as set forth above that any owner or occupier or premises will receive sanitation container system service for the removal of garbage or trash, it shall be unlawful for such owner or occupier to allow any accumulation of garbage or trash around said container or in the vicinity of said container and it shall be required to place all garbage or trash in said container. The use of any other system of garbage container for collection by the Sanitation Department when said container service is provided shall be unlawful.

I. METHOD OF BILLING:

City shall, through its garbage and water departments, include the fees for the services herein provided on monthly bills to such persons and receiving water from the City. In the event any person is not receiving water services, the charges for the garbage services shall be directed to the person receiving garbage service.

J. PROHIBITION AGAINST BURNING OF TRASH, LEAVES, AND/OR GARBAGE.

All open air burning of trash, leaves, grass, shrub clippings and/or other garbage is specifically banned and prohibited from the effective date of this ordinance.

K. SEVERANCE OF PROVISIONS:

In the event any provision of this ordinance shall be deemed invalid, all remaining provisions of the ordinance shall remain in full force and effect.

L. PENALTIES:

1. **Penalty for Violation of Ordinance:** Any person, firm corporation, or association who violates any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine of not more than Two Hundred Dollars (\$200) and each and every day of continuance thereof shall constitute a distinct and separate offense.

2. **Violation:** Violation of any of the terms or provisions of this Ordinance by any corporation or association shall subject the officers and agents actively in charge of business of such corporation or association to the penalty herein provided.

3. **Injunction:** In addition to the penal remedy herein, the City Attorney shall, upon the direction of the City Council, institute any appropriate action or proceeding, including actions for injunction to prevent, restrain, correct, or abate any act, conduct, work, business,

practice or use which is a violation of and illegal under this Ordinance.

M. REPEAL OF CONFLICTING ORDINANCES:

All ordinances in conflict herewith shall be and the same are hereby repealed to the extent of any conflict with this Ordinance.

N. EFFECTIVE DATE:

This ordinance shall be effective as of the February 20, 2014.
