Notorious stretch of highway sees second tragic accident in weeks

The last fatality accident of 2014 in the 5 mile stretch of US Highway 277 north of Bronte occurred Saturday evening, December 27, 2014, taking the life of a local woman. Only 15 days later on Sunday evening, January 11, 2015, a three vehicle accident occurred in the same stretch. Fortunately, although one man was airlifted to the hospital and two more transported by ambulance, this head-on collision resulted in no fatalities as of press time.

These most recent accidents are just two of several which have occurred in this dangerous stretch of highway in the last couple of years. With 2014 statistics not yet available, information contained within this article is based on interviews with emergency personnel and witnesses to the accidents.

The majority of the tragic accidents had three common factors.

* The accidents were head-on

collisions near one of two curves in this stretch of highway. When heading north on US Highway 277, one curve begins before you reach the city limits and continues for approximately half mile (top right photo). The second curve is located at Old Highway Road, about three miles north of Bronte (bottom right photo).

* The accidents occurred when the southbound driver crossed the center line into oncoming traffic. None of these southbound drivers were locals.

* The accidents occurred after sunset.

Two of the above factors are unchanged from years past when accident statistics were low. The curves have been there since the highway's construction and drivers have always traveled at night. What is contributing to this uptick in accidents?

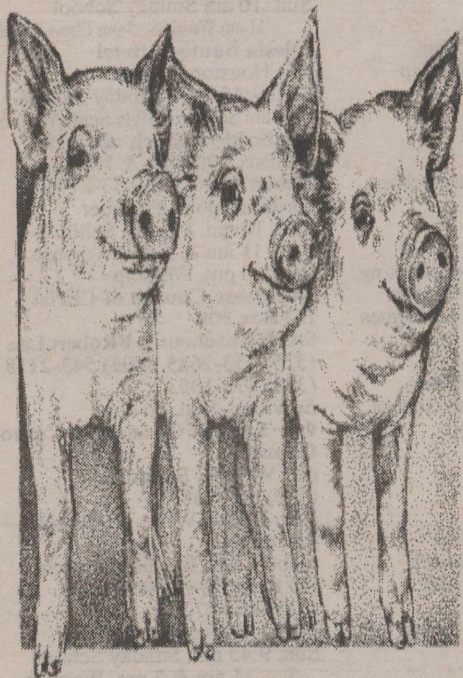
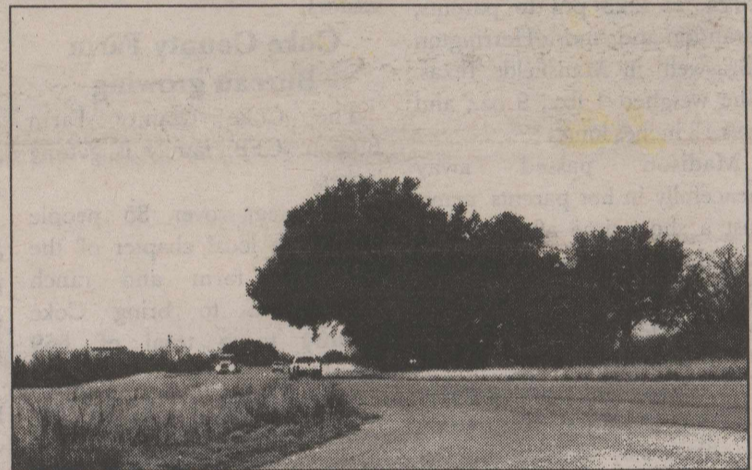
The first thing usually mentioned is the new speed limit of 75 mph. However, before the speed limit was decreased to 55 mph in the 1970s, the speed



limit was 70 mph. Therefore, the increased speed limit may not be the sole cause.

Residents living on US Highway 277 North or on one of the roads intersecting with this highway have been very aware of the changes in traffic in the last five years. According to Texas Department of Transportation's 2013 statistics, the average daily number of vehicles on this stretch of

County Stock Show set for this weekend

The 76th edition of the Coke County Junior Livestock Show will be held Friday and Saturday, January 16 and 17, 2015, at the Sterling Lindsey Memorial Exhibition Building in Robert

Lee.

This year's show will feature animals in the Market Lamb, Market Goat, Market Swine and Market Steer shows, but more importantly, many young exhibitors from around the county.

New this year is the Pee-Wee Show. It will be held immediately following the Sheep and Goat Shows on Friday evening, January 16 and is open to all children 8 and under who are not 4-H members. Clover bud members are eligible to

participate. Participants will need to find a lamb or goat to borrow for the show and sign up at the concession stand during the Sheep and Goat Shows.

The county stock show offers the youth of Coke County an opportunity to exhibit their livestock projects which they have worked with for more than 11 months, in many cases.

Besides being a worthwhile educational activity for our youth in teaching them responsibility, working with others and numerous life skills, it is an important economic endeavor when you consider the animals purchased from county producers, feed purchased locally and the premium sale monies that come in from county and other areas. The total amounts of monies generated by these exhibitors amounts to over \$150,000 per year that is circulated in the county.

The show will begin Friday, January 16, at 6:30 pm with the Market Lamb show, followed by the Market Goat show. These will be judged by Bronc Fleming, livestock producer of San Angelo. Saturday, January 17, the Market Swine show gets

underway at 8:30 am, followed by the Market Steer show at 11 am, judged by Duffy Galloway, Loraine ISD agriculture teacher.

The Buyer's appreciation barbecue will be served at 12 noon. Following the barbecue, the premium sale will be held at 2 pm to honor the prize winning animals and exhibitors.

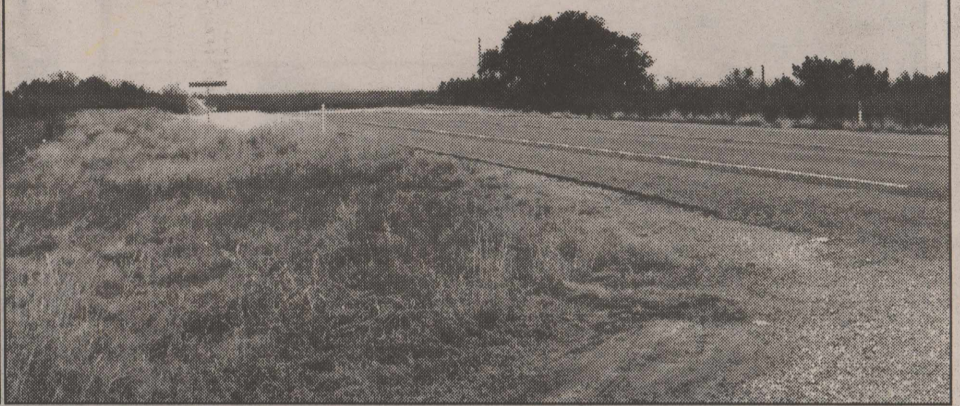

highway ranged between just under 3,000 to over 3,600, with 5,166 vehicles going through the US Highway 277/State Highway 158 intersection in downtown Bronte on a daily basis. City officials and law enforcement agree that 2014's numbers will be considerably higher.

Accidents at the curve near Old Highway Road are most likely a combination of a higher speed limit and more traffic. In tests, a vehicle traveling south can make that curve with their cruise set on 75. Unfortunately with a speed limit of 75, many drivers have their cruise set a little (or a lot) higher than that. These drivers may cross the center line coming out of the curve and, because of the increased traffic, have a better chance of running into an oncoming vehicle.

The curve at the north edge of Bronte has more issues. Locals know they're coming into town. Drivers unfamiliar with this area may not. I have lived in Bronte most of my life and have lived north of Bronte for twenty years. Because I drive that stretch of road every day, I don't really see it. In preparation for this article, I drove it with "new eyes" - both during the day and then at night.

During the day, you can see the Bronte water tower from a couple of miles out of town. Unfortunately, you lose sight of it about a mile and half before you get to the city limits. The same thing happens with the lights from town at night. Because of the curve you are not looking at a town as you get closer.

Drivers have another clue .9 of a mile out with a sign giving the distance to Bronte and San Angelo. Most drivers who are traveling through, probably only notice the distance to San Angelo.

The next sign says "No Engine Brake" and is located one half mile from the city limits. If you're not a trucker, you probably don't pay attention to that one.

Finally, four tenths of a mile from the city limits, is a sign saying "Reduced Speed Ahead". It is followed by a "65 MPH"

sign two tenths of mile later - only two tenths of a mile from the city limit sign located next to a "50 MPH" sign. If you are traveling at 75 MPH, it takes less than 10 seconds to go 2/10 of a mile.

The Welcome to Bronte sign is located near the "Reduced Speed Ahead" sign and is a good indicator to daytime travelers that they are entering a community. However, the sign is set off the highway across the fence and is not readily visible at night.

The December accident was located between the Reduced Speed Ahead sign and the 65 MPH sign. Last weekend's accident was located within 50 yards of the city limit sign where the speed limit drops to 50 MPH. In this accident, the southbound driver's cruise locked in at 82 MPH when he struck the northbound vehicle.

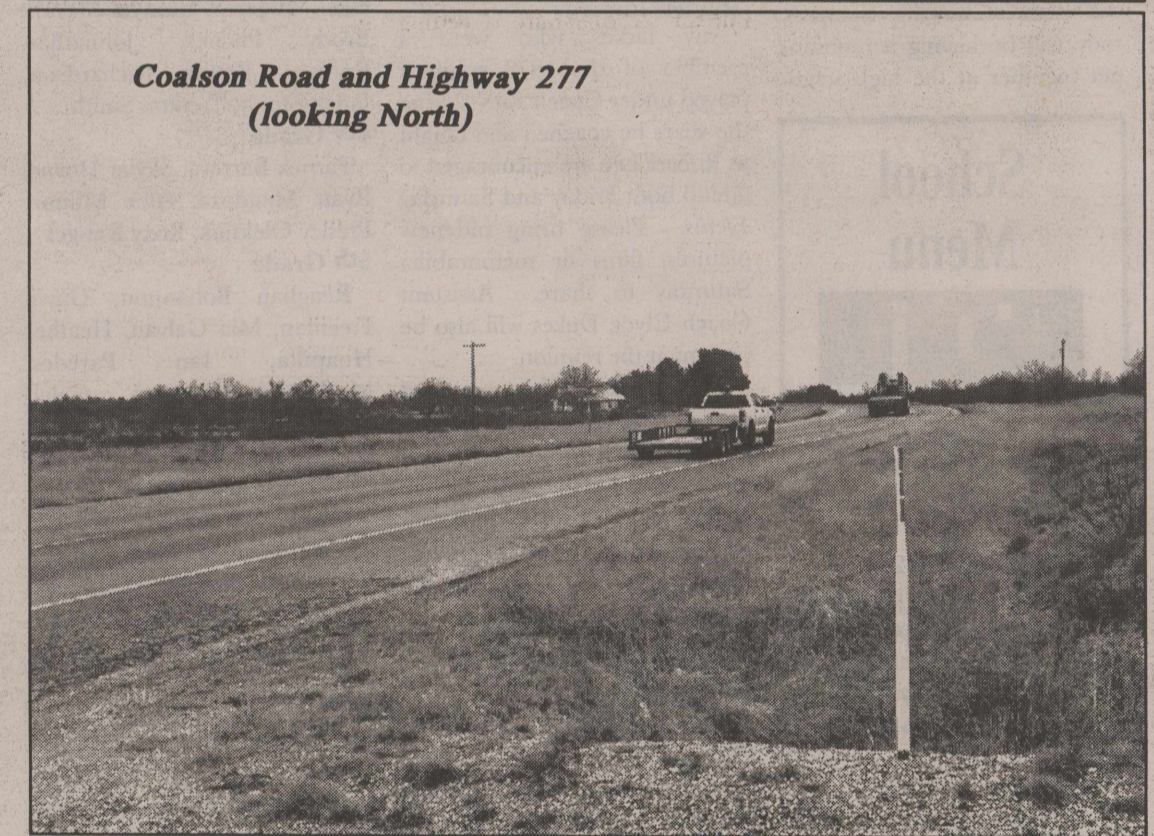
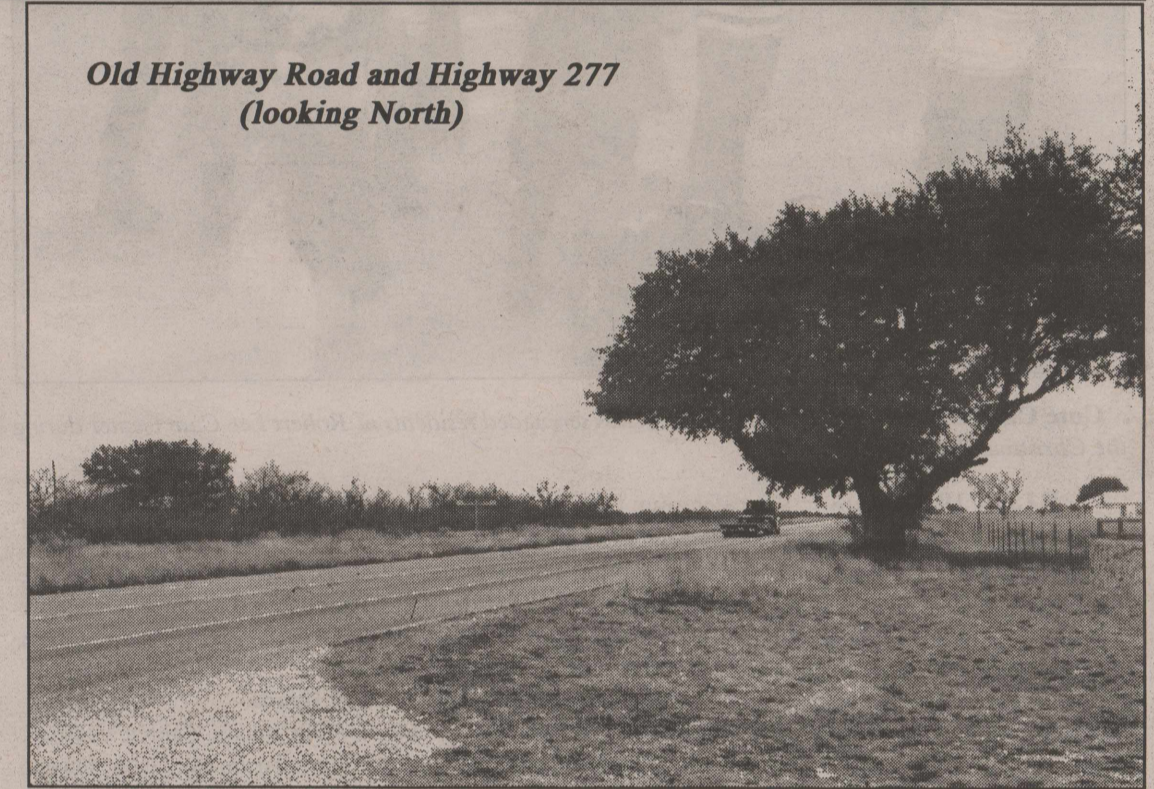
Coke County Sheriff Wayne McCutchen would like to see the speed limit drop to at least 70 mph on US Highway 277 within the Coke County border and has increased traffic patrols on this highway.

Possible solutions to avoid accidents near the city limits could be as simple as more visible signage and lighting. Until changes are made, citizens are urged to be extremely cautious.

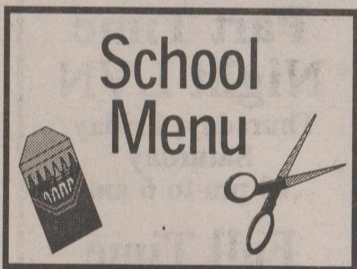

ORDINANCE

AN ORDINANCE OF THE CITY OF BRONTE, TEXAS, PROHIBITING BURNING OF TRASH, GARBAGE, BRUSH OR OTHER REFUSE WITHIN THE CITY LIMITS OF BRONTE AND FURTHER AUTHORIZING THE MAYOR TO ISSUE A

BAN ON OUTDOOR BURNING DURING PERIODS WHEN COKE COUNTY HAS ISSUED A BAN ON OUTDOOR BURNING; PROVIDING A PENALTY IN AN AMOUNT NOT TO EXCEED \$500.00 FOR ANY VIOLATION OF ANY PROVISION OF THIS ORDINANCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HERewith; AND PROVIDING FOR SEVERABILITY.

WHEREAS, in order to protect the public health, safety and welfare of its citizens, there exists a need to regulate and prohibit outdoor burning of trash, garbage, brush or other refuse that items may pose a risk of fire to citizens, dwellings, property, livestock and other structures within the City.

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRONTE, TEXAS, THE FOLLOWING:

Section 1. The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

Section 2. Procedures related to the declaration of a ban on outdoor burning are hereby adopted as follows:

I. Issuance - Whenever Coke County issues a ban on outdoor burning, the Mayor may, upon his/her discretion, order the implementation and enforcement of a ban on outdoor burning within the corporate limits of the City of Bronte. The Mayor shall have full discretion to determine the time period for the declared ban on outdoor burning; provided however the ban on outdoor burning will remain in effect for the duration of the ban imposed by Coke County, unless otherwise lifted or extended by an order of the Mayor or by vote of the City Council.

II. Exemptions:
Noncommercial Cooking -

Noncommercial cooking in a device designated for such purpose by the manufacturer is allowed, provided such device is designed to contain all flames and/or sparks and shall take place only when the wind speed is 15 miles per hour or less. A spotter with water and an available pressurized delivery system must be on hand before any outdoor cooking begins and remain on hand until the outdoor cooking is completed.

Ceremonial Fire/Bonfires - Ceremonial Fire/Bonfires must be approved by City Council. A ceremonial fire shall not be conducted within with 25 feet of a structure or combustible material. Conditions which could cause a fire to spread within 25 feet of a structure shall be eliminated prior to ignition. A spotter with water and an available pressurized delivery system must be on hand before any outdoor ceremonial fire/bonfires begins and remain on hand until the fire is out.

Portable Outdoor Fireplaces - Portable outdoor fireplaces shall be used in accordance with the manufacturer's instructions and shall not be operated with 15 feet of a structure or combustible material and shall take place only when the wind speed is 15 miles per hour or less. A spotter with water and an available pressurized delivery system must be on hand before any portable outdoor fireplaces are ignited and remain on hand until the fire is out.

Fire Training - Outdoor burning shall be authorized for training of firefighting personnel when approved by City Council.

Municipal Burning - The City of Bronte may burn vegetation and/or brush for the purpose of maintaining and/or clearing of right-of-way for streets and/or drainage.

Diseased Animal Carcasses - Diseased animal carcasses may be burned when this is the best way to control spreading of

diseases and must have approval in writing from City of Bronte Mayor or City Council.

III. Enforcement Authority - The Mayor or his/her appointed designee, and City of Bronte Ordinance Office has the authority to enforce this ordinance and to order the extinguishing of any fire in violation of this ordinance.

IV. Penalties -Any person, corporation or entity who or which intentionally, knowingly, recklessly or with criminal negligence violates any provision of this Ordinance shall be deemed guilty of a misdemeanor shall be fined in an amount not to exceed \$500.00. Each day in which any violation shall occur, or each occurrence of any violation, shall constitute a separate offense.

Section 3. All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

Section 4. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Bronte, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

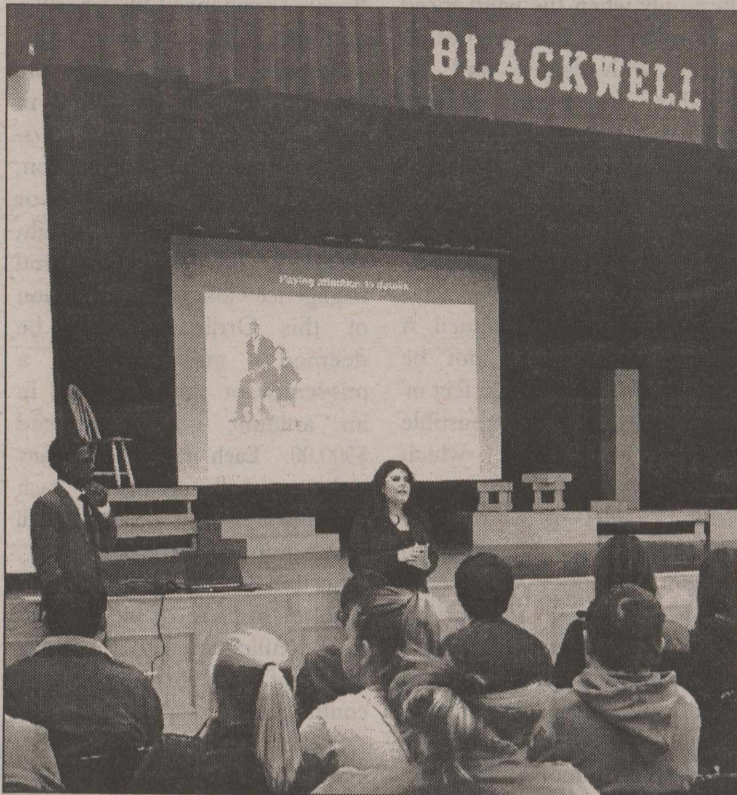

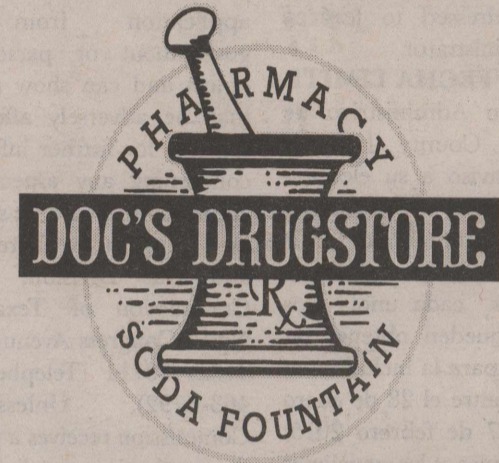
