#### **Special Election** ordered

A Special Election will be held Saturday, May 9, 2015, to allow voters in Coke County's Justice of the Peace Precinct 2 (Precincts 2 and 4) to determine whether on-premise beer and wine sales will be allowed in those precincts.

The issue began months ago with Jennifer Addona circulating a petition in Bronte to call for this election. She plans to open a restaurant in the building on the southwest corner of the US Highway 277 and State Highway 158 intersection.

At Tuesday's Commissioner's Court, it was announced that her petition had met all of the legal requirements and had been certified. Statute dictates that Commissioners Court must order an election if all requirements have been met.

#### Commissioners call for reduced speed on US Highway 277

At Tuesday's Commissioners Court, Precinct 2 Commissioner Paul Williams asked the Court to authorize a resolution requesting Texas Department of Transportation lower the speed on US Highway 277 within Coke County's borders.

Court voted to authorize this resolution which will be sent with a letter to the TxDOT District Engineer in San Angelo. However, this engineer does not have the ability to make this change. Before any changes may be made, the Texas Transportation Commission in Austin, TxDOT's governing board, will have to approve this reduction.

#### **Major Stock Show** Update



c0mplic@t3d 1. Create passwords. Avoid birthdays, pet names and simple passwords like 12345. It is also important to change password at least 3 times a year. Because friendly theft theft by someone the victim knows - is the most common type of identity theft or fraud, don't share your passwords with family members and be mindful of who has access to your personal information

2. Keep tabs on your Check account activity and online statements often, instead of waiting for the monthly statement. You are the first line of defense because you know right away if a transaction is fraudulent. If you notice unusual or unauthorized activity, notify your bank right away. When a customer reports an unauthorized transaction in a timely manner, the bank will cover the loss and take measures to protect the account.

3. Stay alert online. Be sure computers and mobile devices are equipped with up-to-date malware and anti-virus protection. Never give our personal financial information in response to an unsolicited email, no matter how official it may seem. Your bank will NEVER contact you by email asking for your password, PIN, or account information. Only open links and attachments from trusted When submitting sources. financial information on a website, look for the padlock or key icon at the top or bottom of your browser, and make sure the Internet address begins with "https," This signals that your information is secure during transmission.

4. Mobilize your defenses. Use the passcode lock on your smartphone and other devices. This will make it more difficult for thieves to access your information if your device is lost or stolen. Before you donate, sell or trade your mobile device, be sure to wipe it using specialized software or using the manufacturer's recommended technique. Some software allows you to wipe your device remotely if it is lost or stolen. Use caution when downloading apps, as they may contain malware and avoid opening links and attachments - especially from senders you don't know.

Tips for Victims:

If you are a victim of fraud and suspect your personal

information compromised, you should take the following steps:

\* Call your bank and credit card issuers immediately so they can take necessary steps to protect your account.

\* File a police report and call the fraud unit of the three credit-reporting companies.






