A meeting of the Coke County Roping Club was held at the arena in Bronte Sunday evening, June 21, 2015, at 6 pm with over thirty people in attendance.

The meeting was called to order by Bartley Murray, immediate past president, at 6:11 pm. He began by asking everyone to introduce themselves. He next pointed out to the group that the club was moving forward and looking to the future. He stated the meeting was not a time for looking back at old arguments, but a time of coming and working together.


Wayne Coalson recognized for plowing the arena on Saturday. The group was very appreciative of Saturday's clean-up effort.

Murray then explained the facts surrounding the proposed donation of the arena to Bronte ISD. He touched on how the current six members had wanted the property cared for and used for the community youth since and membership numbers had dropped so dramatically and remained low for years. He then explained that, after the renewed interest, club members moved to halt the donation that was creating discord in the community.

Terry Austin asked the group to recognize the current members of the club who were present (Bartley and Jennifer Murray and Wayne and Melinda McCutchen) and thank them for the years of hard work and dedication.

The bylaws and portions of the deed were read to the group and questions regarding these two documents were answered.

Murray then explained the vital need for a liability insurance policy on the property. Kerwin Denton asked what size policy was needed. Mary McMullan detailed the policies purchased by AJRA. James Brunson explained the policies used in various events hosted by cowboy churches.

(Continued from page 3) and had produced several shocks to workers in recent years. Jennifer Murray reported that the light bulbs used to light the arena were no longer manufactured.

It was noted that Corby Kelso had purchased the land at the end of the arena and taken down the old fence between the two properties. He is currently constructing a new fence.

Potential events to be held at the arena were next discussed. These included ranch rodeos, playdays, ropings and youth ranch rodeos. Mary McMullan reported the going price to lease roping cattle was \$17.50 per steer, per run and \$25 per calf, per run. The cost of cattle that might be accidently injured or killed in an event was noted. A goat roping was also proposed.

The need to become a corporation to protect members and officers was discussed. McMullan pointed out the importance of remaining nonprofit. Jennifer Murray discussed the facts discovered during recent research into the club's EIN number (tax ID number) and the IRS status of that number. Currently, the club's EIN is listed as in good standing.

Once all of the issues had been addressed, membership applications with attached bylaws were passed out. The Murrays explained the 24 hour rescission rule (grace period) for members and also said that if the liability policy is not purchased, members may request to rescind their membership and receive a refund of their membership fee. Eighteen individual and family

memberships were received.

Elections were held for officers. Following a vote by written ballot, Bartley Murray was elected as the club's president; Jenny Baker is the new vice president; Katie Austin is the new secretary; and Jennifer Murray and James Brunson will serve as rodeo co-

The club next focused on the future with the following items discussed:

- * Revitalization of the arena;
- * Potential events;
- * Banners and sponsorships;
- * RV hook-ups and dump

Questions were regarding a previous grant proposal presented to the Bronte Economic Development Board in 2010. Jennifer Murray explained the information and requests made in the proposal. She further explained that all but one member of the board voted to award the grant, but that the requirement by this dissenting member documentation of every penny spent by every competitor and spectator while in Bronte was impossible to satisfy.

Cory Lloyd made a motion, seconded by Bartley Murray, to demolish the current bathrooms. The motion carried.


