#### Forage Losses must be reported by Monday

Coke/Sterling County USDA Farm Service Agency (FSA) Executive Director Michael Sturm reminds livestock producers who suffered grazing losses that occurred throughout 2015 due to drought or wildfire that they have until Feb. 1, 2016, to report their losses and to enroll in the Livestock Forage Disaster Program (LFP).

LFP provides compensation to eligible livestock producers who suffered grazing losses for covered livestock due to drought on privately-owned or cashleased land or fire on federallymanaged land. Producers in Coke and Sterling Counties are eligible to apply for 2015 LFP Friday, January 29, 2016

The offices are currently held by Mayor Leroy Casey and council members Sid Burns and Styles. Applications may be picked up at the Bronte ISD Administration Office beginning Wednesday, January 20, 2016, during the hours of 8 am to 4 pm, Monday through Friday.

Robert Lee JSD will hold an election to elect two members of the Board of Trustees. These are three year terms currently held by Erin Oleksiuk and Beverly Sinclair. Applications for candidates to apply for a position on the Robert Lee ISD Board of Trustees may be picked up at the Robert Lee ISD

The City of Bronte will hold an election for mayor and three council positions. These are two year terms. The offices are currently held by Mayor Gerald Sandusky and council members Wade Stautzenberger, Paul Gohman, and Jodie Arrott. Applications can be picked up at City Hall.

To be eligible for a seat on a city councils, a person must be a registered voter and must reside within that city on the date of the election.

Bronte ISD will hold an election for two members of the Board of Trustees. These are three year terms currently held by Shane Kelton and Kay Administration Office beginning Wednesday, January 20, 2016, between 8 am and 3:30 pm Monday through Friday.

Requirements for filing for school board are that you must have lived in the state for one year and six months in the school district prior to filing, be at least 18 years of age, and be a registered voter at the time of election.

West Coke County Hospital District will have three two year terms on their ballot for their Board of Trustees. The terms of Pat Stephens, Pat Carwile and Sarah Green are expiring.

East Coke County Hospital District Board of Trustees will also have three two year terms on the ballot. These offices are currently held by Howard Baker, Lanette Fletcher, and Everett Bedford.

"Prolonged drought conditions have created a need for livestock disaster assistance programs in Coke and Sterling Counties," said CED Sturm. "I encourage all affected livestock producers to contact the Coke/ Sterling County FSA Office to schedule an appointment to enroll in the program before the Feb. 1 deadline."

Livestock producers must complete the LFP application and required supporting documentation no later than Feb. 1, 2016, for losses that occurred throughout 2015. Producers who already have appointments scheduled require no additional action to meet the deadline.

Eligible livestock includes alpacas, beef cattle, buffalo, beefalo, dairy cattle, deer, elk, emus, equine, goats, llamas, poultry, reindeer, sheep or swine that have been or would have been grazing the eligible grazing land or pastureland.


Return to Item 2: A motion was made by Councilman Alexander and seconded by Councilman Johnson. The regular session of the city council meeting was adjourned



# Millican Sees Tax Revenue Needs

Marshall remembers the mid to late 1960's during the completion stages of the dam that created E.V. Spence Reservoir. Marshall recalls the Colorado River Municipal Water District. Some of these properties were acquired by condemnation that caused many Coke County tax payers to relocate and move their families from their homes.

The Colorado River Municipal Water District (CRMWD) pays no county property taxes on land or improvements owned by the water district. CRMWD owns several hundred acres around Lake Spence that is above the 1,912 foot elevation which is the flood stage level of the lake. These properties should be sold at any price and be put back on the county tax roll. There are many changes that could be made by CRMWD that would benefit Coke County and Robert Lee. Some of these changes may need to be done by our Texas Legislation.

Marshall says, "If going to Austin is what it takes to get this done, I'm ready. I'm sure that Coke County is not the only county that has these problems where CRMWD has holdings"

"I am aware of many properties in Coke County that are delinquent on our tax rolls. If I am elected Commissioner of Precinct 3, I will be aggressive in working with the delinquent tax attorney firm for collections or sales of these properties to return them to active status on the tax roll."






