## Voters turn out for Primary Elections

Coke County had quite a turn-out at the polls for the 2016 Primary Elections. Precincts 1 and 3 boosted the 39.55% turnout due to contested commissioner races in both precincts. Of this percentage, 37.21% voted in the Republican Primary with only 2.34% voting in the Democrat Primary. These percentages reveal the trend toward Republican voting in Coke County is continuing.

Only two county offices were contested, Coke County Commissioner Precinct 1 and Commissioner Precinct 3.

The results in Precinct 1 in the Republican Primary were Donald Robertson 72, Shauna Grantham 66, Sid Burns 62 and Mike Salls 59. With no one candidate reaching the 50% plus 1 vote, there will be a run-off election held Tuesday, May 24, 2016, between the top two candidates - Donald Robertson and Shauna Grantham. There were no candidates for this office in the Democrat Primary and no Independent filed a Letter of Intent.

The results in Precinct 3 in the Republican Primary were Marshall Millican 135 and Andy Swinney 98. Charles Yorke received 14 votes in the Democrat Primary. These two gentlemen will face each other in November's General Election. They will be joined by Bill Burns who has filed his Letter of Intent as an Independent for this office.

Other Coke County offices on the ballot in the Republican Primary included Constable Precinct 2 Marty Boyd, who received 270 votes with 90 under votes; Nicholas E. Arrott, II, for County Attorney, with 673 votes and 182 under votes; County Tax Assessor/Collector Josie Dean with 667 votes and 186 under votes; County Sheriff Wayne McCutchen with 737 votes and 122 under votes; County Chairman, Susan Williams with 592 votes and 259 under votes.

The only other Coke County position in the Democrat Primary was for County Chairman where Robert Houck was unopposed. He received 44 votes with 10 under votes.

In the race for the Republican Presidential nomination, Coke County agreed with the rest of Texas on the top three picks. However, we split with the state

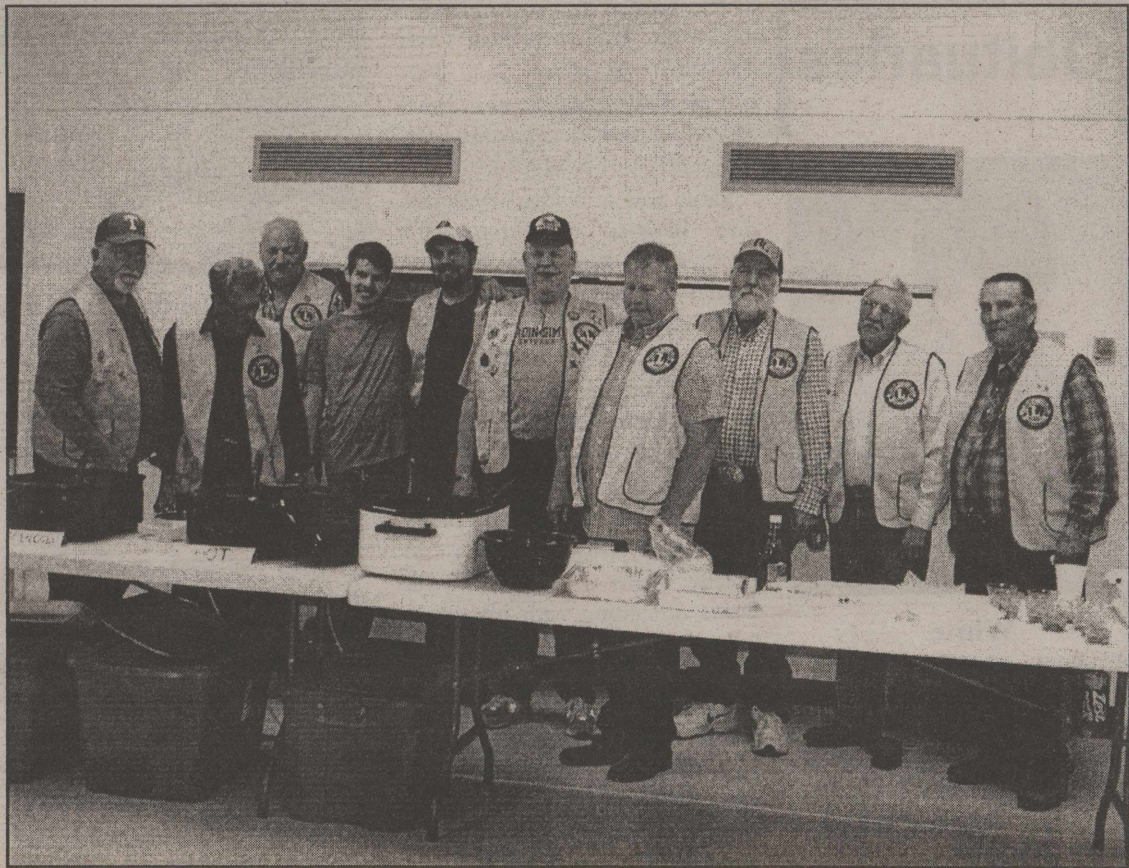
when it came to places 4 and 5. Ted Cruz received 405 votes in Coke County and 43.76% statewide; Donald Trump received 251 votes in Coke County and 26.75% statewide; and Marco Rubio received 85 votes in Coke County and 17.73% statewide. In Coke County, Ben Carson received 50 votes, but finished in 5th place statewide with 4.15%. John Kasich received 23 votes in Coke County, but placed 4th in Texas with 4.24%.

Coke County Democrat Primary voters were evenly split between Bernie Sanders and Hillary Clinton with 25 votes each in the race to receive the Presidential nomination. Statewide Clinton came in with 65.18% to Sanders 33.18%.

Precinct 1 Commissioner won't be the only office on ballot in the Republican May 24, 2016, run-off election. Gary Gates with 28.35% and Wayne Christian with 19.75% with face off for Texas Railroad Commissioner. Mary Lou Keel with 39.42% will go against Ray Wheless with 35.42% for Judge, Court of Criminal Appeals, Place 2. For Judge, Court of Criminal Appeals, Place 5, Scott Walker with 41.48% will face Brent Webster with 20.45%.

Although there are no local offices on the ballot in the Democrat run-off election on May 24, Grady Yarbrough with 39.95% will face Cody Garrett with 35.15% for Texas Railroad Commissioner.

Coke County voters seemed to disagree with statewide voters when it came to judicial races in the Republican Primary. In the race for Justice, Supreme Court, Place 3, Incumbent Debra Lehrmann only received 227 votes in Coke County to Michael Massengale's 370 votes. However, statewide Lehrmann won with 52.20% of the vote. In the race for Justice, Supreme Court, Place 5, Incumbent Paul Green only received 156 votes in Coke County to Rick Green's 416 votes. However, statewide Paul Green won with 52.07%. In the race for Justice, Supreme Court, Place 9, Incumbent Eva Guzman only received 246 votes in Coke County to Joe Pool's 345 votes. However, statewide Guzman won with 59.21% of the vote. The only judicial race Coke County voters agreed with

statewide voters was the election for Judge, Court of Criminal Appeals, Place 6, between incumbent Michael Keasler and Richard Davis. Keasler received 302 votes to Davis' 232 votes and won with a statewide percentage of 56.87%.

Justice, 3rd Court of Appeals District, Place 4, Melissa Goodwin with 539 votes and 308 under votes.

District Judge, 51st Judicial District, Barbara Walther with 617 votes and 237 under votes.

District Attorney, 51st Judicial District, Allison Palmer with 555 votes and 295 under votes.

The Board went into Executive Session at 9:43 am and returned to regular session at 10:10 am. No action was taken.

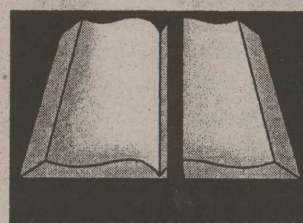
The census count shows there are currently 28 residents in the facility, as of the meeting date.

In addition to voting for the candidates in the various elections, voters were able to give their input through questions asked (either Republican propositions or Democrat referenda) at the end of the primary ballots. The following, with their results in Coke County and statewide, appear below.

**Farm bill safety net program enrollment now open for COKE County farmers**

It's time once again for Coke County farmers to enroll in farm bill safety net programs at the local Farm Service Agency (FSA) office.

The enrollment period for the 2015 Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs opened Dec. 7 and will remain open through Aug. 1, 2016.

"Many Coke County farmers already made their safety net program selection, but it's important for all of them to go back to the FSA office to enroll their acreage into the program for the new year," John Ross Copeland, Coke County Farm Bureau president, said.

FSA officials encourage farmers to call their local FSA office to make an appointment to enroll before the deadline.

"If Coke County farmers don't enroll, their farms and crops won't be eligible for financial assistance should crop prices or farm revenues fall," John Ross said. "These safety nets are important to ensure American farmers have something, if only the percentage of a crop's original value, to make ends meet in bad years. Without it, many farmers and ranchers would go out of business in times of drought or excessive rain."

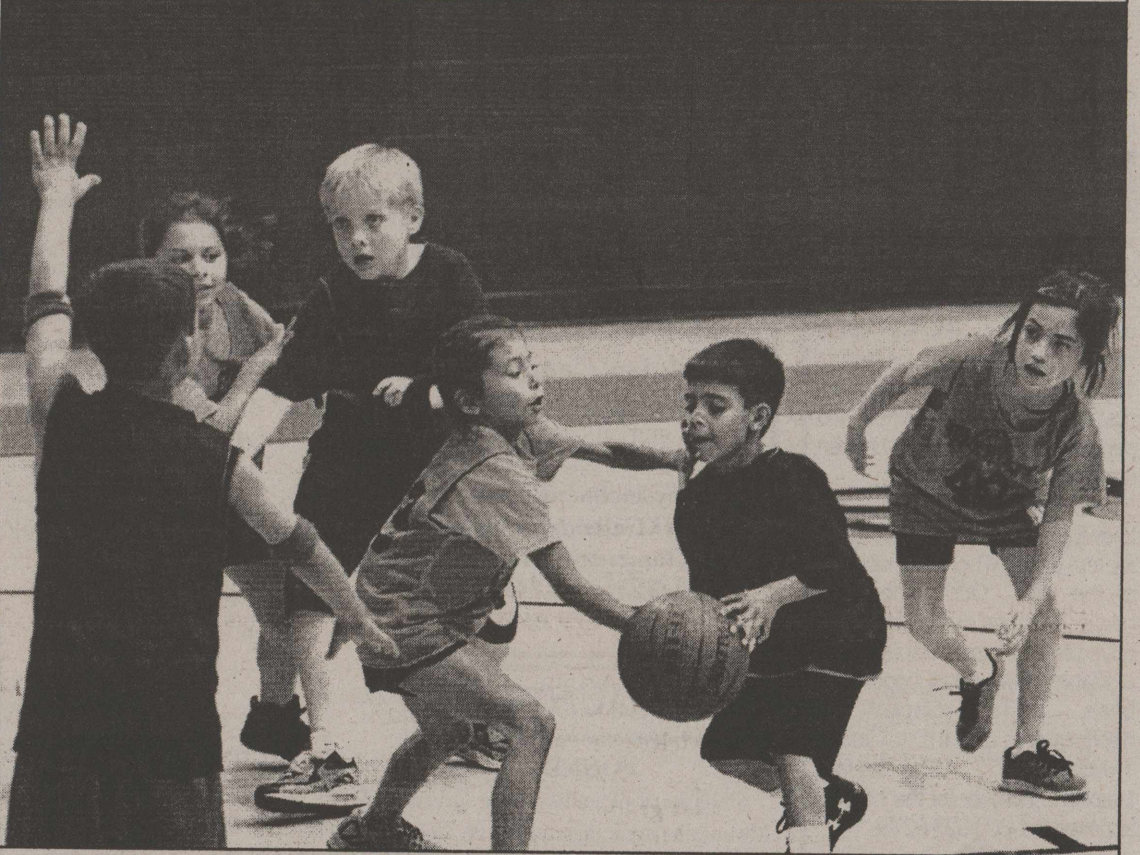
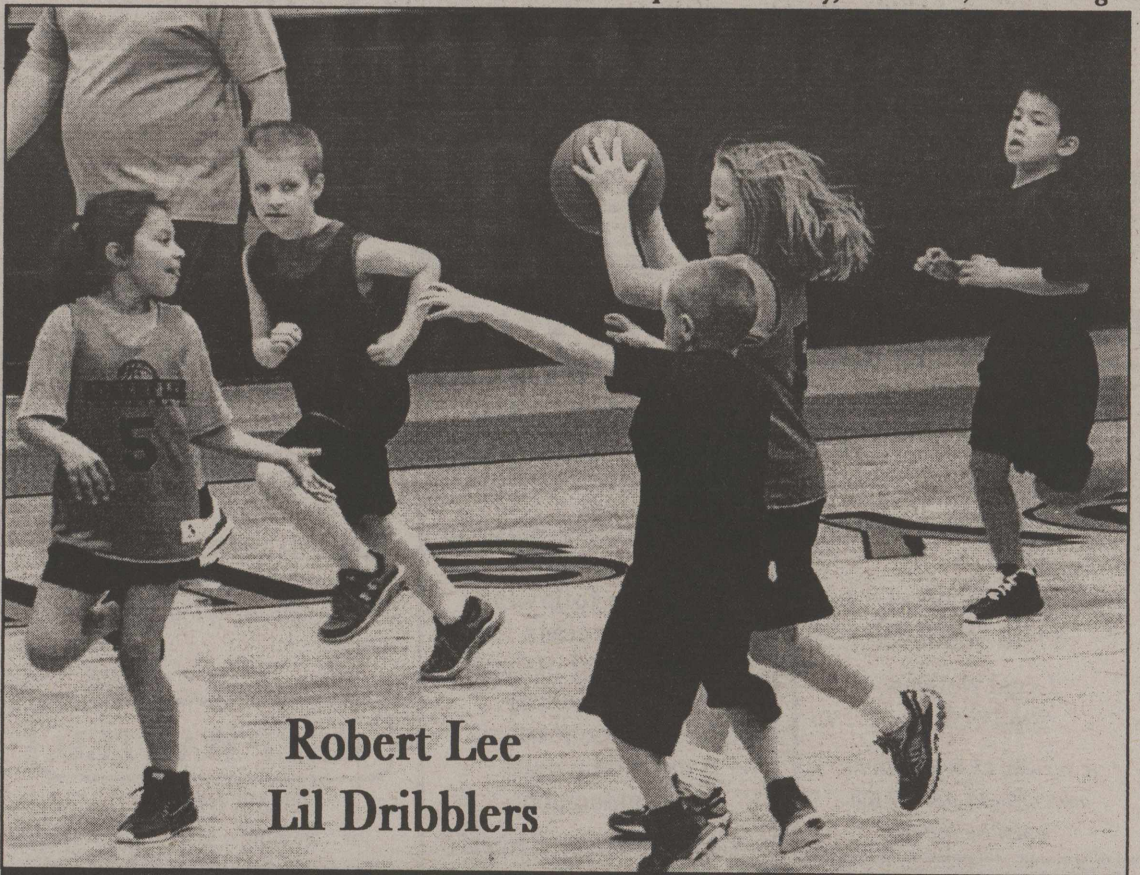

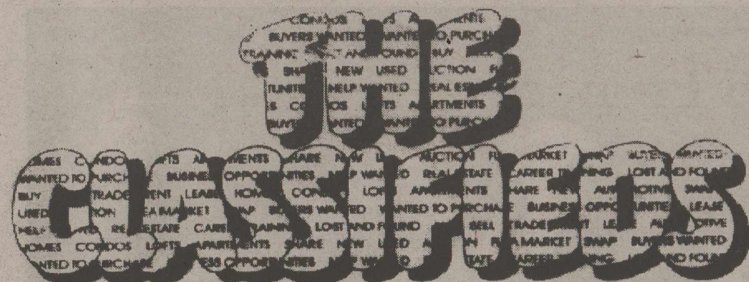

**CVEC offers scholarships**
