Sanderson, Brenden Scott, and Madison Solis.

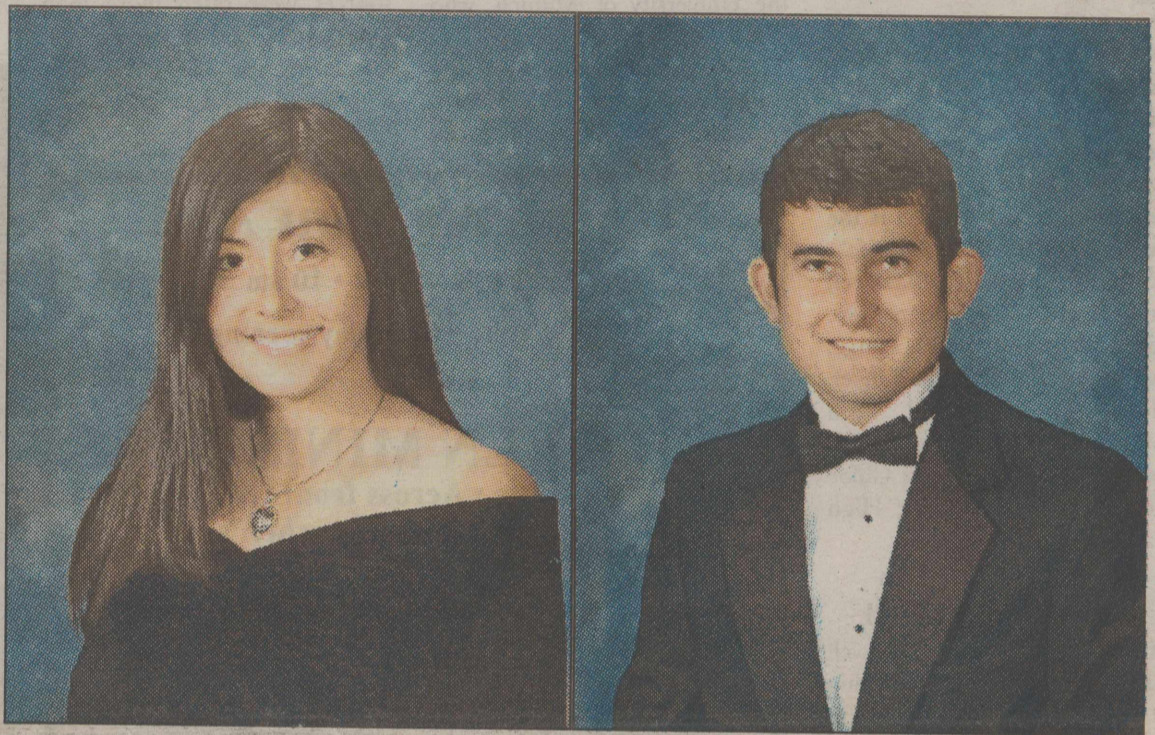
Primary Run-off Election results announced

Finding Water With A Forked Stick May Not Be A Hoax

Now comes a massive set of data that suggests there may be some validity to dowser's claims. The encouraging words are contained in a study financed by the German government and published in the Journal of Scientific Exploration. http://www.jse.com/betz_toc.html, which is a peer reviewed scientific journal published at Stanford University.

The project was conducted by the Deutsche Gesellschaft für Technische Zusammenarbeit in the hope of finding cheaper and more reliable ways of locating drinking water supplies in Third World Countries.

Researchers analyzed the successes and failures of dowser's in attempting to locate water at more than 2000 sites in arid regions of Sri Lanka, Zaire, Kenya, Namibia and Yemen over a 10-year period. To do this, researchers teamed geological experts with experienced dowser's and then set up a scientific study group to evaluate the results. Drill crews guided by dowser's didn't hit water every time, but their success rate was impressive. In Sri Lanka, for example, they drilled 691 holes and had an overall success rate of 96%.

"In hundreds of cases the

dowser's were able to predict the depth of the water source and the yield of the well to within 10 percent or 20 percent", says Hans-Dieter Betz, a physicist at the University of Munich, who headed the research group.

"We carefully considered the statistics of these correlations, and they far exceeded lucky

guesses," he says. What's more, virtually all of the sites in Sri Lanka were in regions where the odds of finding water by random drilling were extremely low. As for a USGS notion that dowser's get subtle clues from the landscape and geology, Betz points out that the underground sources were often more than 100 ft. deep and so narrow that misplacing the drill only a few feet would mean digging a dry hole.

Fort Chadbourne celebrates "Evening with a Hero"

On May 12, 2016, the Fort Chadbourne Foundation was proud to present Air Force Medal of Honor recipient Colonel James P. Fleming as guest speaker at a dinner held at Fort Chadbourne.

Colonel Fleming who earned the medal for going above and beyond the call of duty in Vietnam, shared his heroic story of courage to a crowd of 300. Ann Pate, historian at Fort Chadbourne served as Master of Ceremonies for the event. Although veterans were present from WWII, Korea, and the War on Terror, Pate had prearranged with Colonel Fleming a special surprise for other Vietnam Veterans in the crowd.

Pate had learned through her conversations with Colonel Fleming that he was not aware of the pinning ceremony associated with the Vietnam 50th Anniversary Commemoration Program. Fort Chadbourne, in partnership with the Department of Defense program serves to recognize and honor our Vietnam Veterans through this Commemoration which was begun through a proclamation signed in 2012.

Pate asked if they might pin Medal of Honor recipient Fleming at the event, and he agreed. One of his close friends who had taught with him at the Air Force Academy and served in Vietnam, retired Lt. Colonel Larry Gill was on hand to pin Colonel Fleming and in return Colonel Fleming pinned Gill. After the two men shared the kinship of pinning each other, it



was announced that all Vietnam Veterans in the audience should make their way to the stage. Colonel Fleming had requested the honor of pinning each of them himself. In all, 27 Vietnam Veterans were honored on stage, pinned with the eagle pin and thanked for their service to our

country. Fort Chadbourne was proud to host such a honorable event, and much thanks and gratitude to Medal of Honor Recipient Colonel James P. Fleming for being a part of this very special evening at Fort Chadbourne.
