### Texas Sales Tax Holiday set for August 5-7

Texas Comptroller Glenn Hegar reminds shoppers they can save money on certain items priced for less than \$100 during the state's annual sales tax holiday. This year, the sales tax holiday is scheduled for Friday, Saturday and Sunday, Aug. 5-7.

The law exempts most clothing, footwear, school supplies and backpacks priced below \$100 from sales tax, saving shoppers about \$8 on every \$100 they spend

during the weekend.

"As families all over our state prepare to send their children back to school, we hope folks take advantage of this opportunity to get the supplies they need and save some money in the process," Hegar said. "As the father of three young children, I know how these expenses can add up. This event provides Texas families with some relief from state and local sales taxes."

Lists of apparel and school supplies that may be purchased tax-free can be found on the Comptroller's website at TexasTaxHoliday.org.

This year, shoppers will save an estimated \$92 million in state and local sales taxes during the sales tax holiday.

The tax holiday weekend has been an annual event since 1999.

The activities consist of a

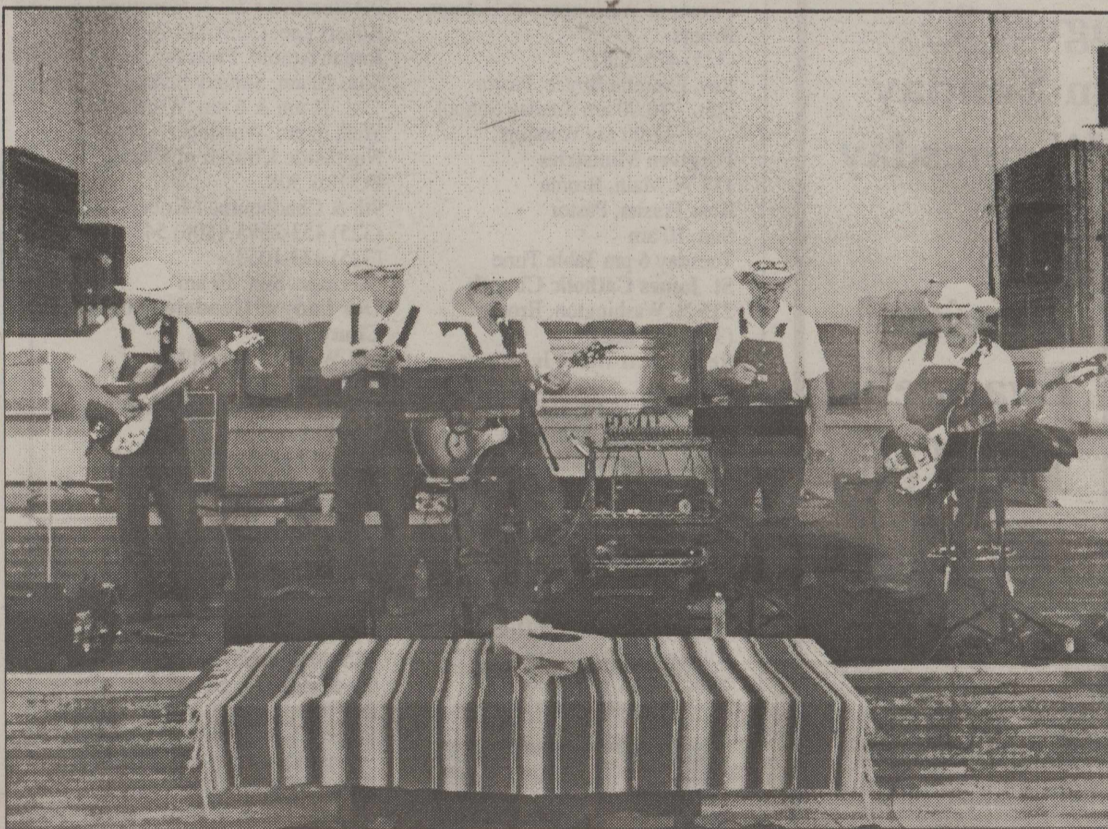

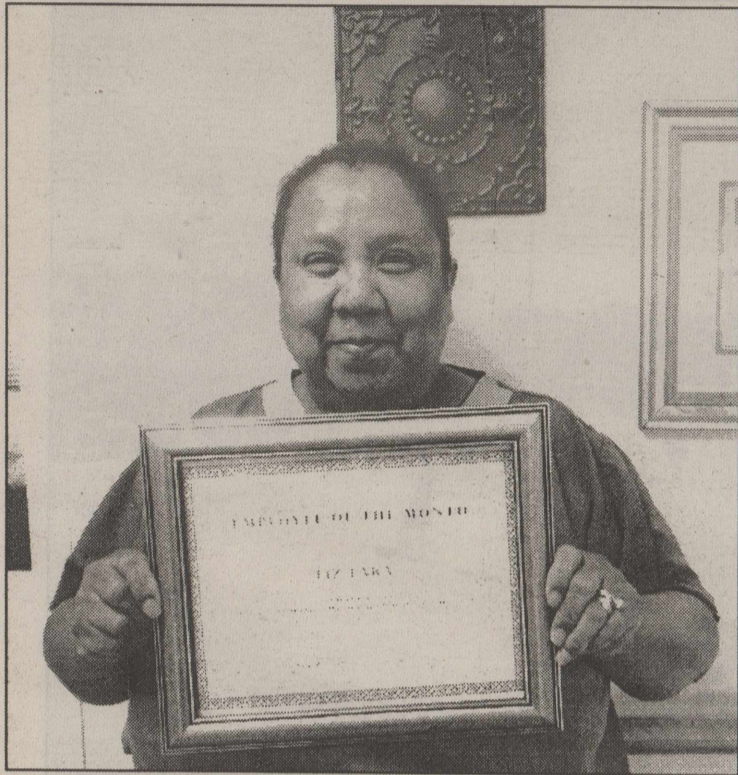

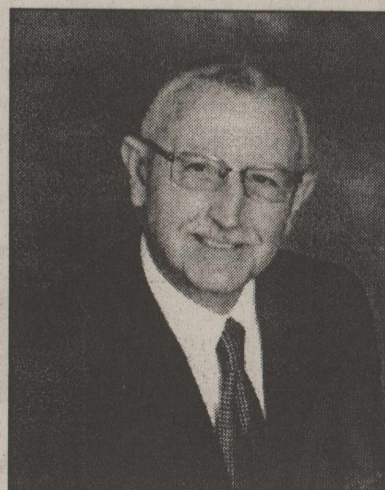

**Private property organizations look for eminent domain reform**

The Lone Star State is rapidly expanding, sometimes using eminent domain to do so, leaving landowners looking for fair offers.

"Eminent domain cases may not pertain to you right now, but it could be your house, land or private property affected in the future," said John Ross Copeland, Coke County Farm Bureau president.

It's an issue the Texas State Senate Affairs Committee studied during the legislative interim. The charge focused on gathering and reviewing data "on the compensation provided to private property owners for property purchased or taken by entities with eminent domain authority. Examine the variance, if any, between the offers and the fair market values of properties taken through eminent domain. Make recommendations to ensure property owners are fairly compensated."

Texas Farm Bureau and other private property rights organizations are gathering that information and working toward eminent domain reform in next year's session.

John Ross Copeland noted the groups have compiled a survey to collect information on eminent domain takings.

"It's a short survey that addresses the issue of fair compensation," John Ross said. "We'd like landowners in Coke County and the surrounding area to share their stories regarding eminent domain. We can use that information to build a case for reform."

"Fair compensation is needed and should be the only option," John Ross said. "Eminent domain reform is needed to ensure fair compensation, prevent lowball offers and limit expensive litigation."
