Bronteoberfest events outlined for weekend

Brontoberfest set for October 22

Restoring Bronte Foundation is gearing up to host the 2nd Annual Bronteoberfest in Bronte on Saturday, October 22, 2016. Last year's event was a huge success with over 1,000 people in attendance. Over \$5,000 was raised at last year's event that went toward the park restoration efforts.

This year, RBF has changed things up a bit and expect Bronteoberfest to be much bigger and better than last year. Added events to this year's Bronteoberfest include additional beer/wine vendors, added music around town, and a food truck court. The main events have not changed, but will be improved. An event, Nine at Night lighted golf tournament, has been added for Friday night at 8 pm.

The Bronteoberfest events will include a cook-off with over twentyfive teams, craft beer and local wine vendors throughout the downtown area, multiple vendors and artists, German inspired foods, food truck court, German vehicle show, and activities for children and young people, including a ice cream freeze off, a bounce house, 3 point tournament, and horseless goat roping. All the events lead up to a concert Saturday night featuring Zane Williams and Kramer LaBarge.

Early voting in this year's General Election slated for November 8, 2016, will be held from Monday, October 24, 2016, through Friday, November 4, 2016. Friday, October 28, 2016, is the last day for the clerk to receive an application for a mail-in ballot.

Early voting will be held at the Coke County Courthouse. On election day, voters in Precincts 1 and 3 will vote at the Coke County Courthouse with voters in Precincts 2 and 4 voting at First Baptist Church in Bronte.

There is only one local contested election. Voters must choose between Marshall Millican, Republican candidate, Yorke, Democrat Charles candidate, and Bill Burns, write-in candidate, for Coke County Precinct 3 Commissioner. Others on the local ballot include Donnie Robertson, Coke County Precinct 1 Commissioner; Constable Precinct 2 Marty Boyd; Nicholas E. Judge Blair announced the presence of a quorum. Comm. Williams was absent.


Comm. Montgomery made a motion to approve the minutes for September 13th and 19th. The motion was seconded by Comm. Sefcik.


Marshall Millican is Active in **Our Community**
