Nearly half a million acres of the Texas Panhandle burned. Homes, barns and fences burned. Some lost livestock. Others lost their lives.

Now that the fires are out, farmers, ranchers landowners are working to rebuild. But they need help.

Janis sits on her bed and hums along with Elvis Presley, munching her favorite potato chips. In the hallway, Vivian giggles, singing the tune played by a handsome fiddler, "...I'm too young to marry." Virginia listens with her eyes closed, remembering the song her daddy sings to her. Is this a sleepover from the 1950s? No, it's the residents of Robert Lee Care Center reconnecting with who they are and remembering a life well-lived.

nationally recognized program that reconnects elders with their identity and their past through music. The Robert Lee Care Center is a certified Music & Memory facility. Residents are provided with their own personal iPod loaded with their favorite music and available to them at all times. It is essential that the music be individualized and personal to each resident. While it takes a significant amount of time to identify the resident's favorite songs, teen volunteers have been assisting staff with finding the right music for each of the residents. This intergenerational activity is a means of joy and delight to the residents who enjoy the time they spend with the teenagers listening to their favorite songs.

Such individualized music can be especially powerful for those with dementia. Music acts as a kind of backdoor to the brain and reconnects parts of the brain that may have seemed lost to the person. There is extensive research showinghow music can activate areas in the brain that medications and treatments cannot. In many aspects, it seems to bring the elder "back to life" by reconnecting them with memories, relationships, and their own identity. Music assists with those who are in therapies, reduces or even eliminates the need for medication for depression, calms residents who

By Diane Rainbolt are upset, reduces boredom and feelings of loneliness, facilitates speech even for those who may be mostly nonverbal, enhances swallowing ability, triggers memories and thereby increases cognition. It offers to residents and families the hope of connection renewed relationships increased cognitive and physical capabilities for their loved ones. The staff at the Robert Lee Care Center has personally witnessed this in their residents while listening to their iPods. 

This notice is being published pursuant to Commission Procedural Rule 22.51(a)(1).

Oncor's rate filing, based on the system-wide financial results for a 12-month test year ending on December 31, 2016, adjusted for known and measureable changes, supports a net increase in transmission and distribution rates of approximately \$317 million over adjusted test-year revenues, or approximately a 7.5% increase over adjusted test-year revenues of \$4,214.2 million. Test-year revenues have been adjusted to normalize billing units, to remove the revenues associated with Oncor's Energy Efficiency Cost Recovery Factor, and to increase test-year revenues to reflect Transmission Cost of Service ("TCOS") and Transmission Cost Recovery Factor ("TCRF") adjustments. TCOS revenue was adjusted to include the September 15, 2016 interim update rates at 2016 Option 2 ERCOT 4CP. TCRF revenue was adjusted to equal the March 1, 2017 TCRF revenue requirement reflected on Line 2, Attachment A of Oncor's petition filed and approved in Docket No. 46616. If approved, the increased rates will be charged to Oncor's direct customers, all retail electric providers ("REPs"), in those portions of Oncor's service area under the original jurisdiction of the Commission. Each such REP is notentially affected by the proposed charge. Depending on the REPs'. potentially affected by the proposed change. Depending on the REPs' actions, the end-use customer classes of such REPs are potentially affected by the proposed change. In addition, the result could be a change in Oncor's transmission cost of service rates, which would impact all load serving entities in the Electric Reliability Council of Texas. Oncor has requested an April 21, 2017 effective date for its proposed rate change



Fire Season Tips

By Mark Sides, RLVFD

Above average temperatures, large amounts of dry fuels, low relative humidity, and strong winds could again set the stage where a careless spark, a lightning strike, or an arcing power line become the opening number in a

Texas Firestorm.

Robert Lee, Bronte and outlying communities are no different from other rural Texas towns where rangeland, pastures, and CRP may be near or immediately adjacent to homes and businesses.

These are a few simple items that will reduce the chances of your home going up in smoke:

- 1) Routinely clean gutters, especially in the fall. Keep your yard clean of leaves, limbs, and dead grass.
- 2) Remove tree limbs that extend over the eaves of the roof or within 10-15 feet of the chimney
- 3) Keep your grass mowed to a 4" height or less, and if possible, well watered during periods of extreme drought. Prune tree branches at least 10 feet from the ground.
- 4) Landscape using deciduous trees and shrubs such as oaks, agarito, eastern redbud, desert willow, and sages. Avoid junipers, pines, and other evergreens unless they are planted 100 feet or further from the house.
- 5) Make sure your house number and street number are clearly posted to provide firefighters easy identification.
- 6) Maintain at least 30 feet of open space between your home and the surrounding brush line or CRP field.
- 7) Avoid concentrations of shrubbery or ornamental grasses up against the house.
- garden 8) Have connected at all times and long enough to reach around the
- 9) Store firewood at least 15 to 30 feet away from the house.
- 10) Maintain roads and entrances to provide easy access and adequate turnaround space for emergency equipment.
- 11) Exercise extreme caution and keep a reliable, pressurized water source handy when doing any outdoor burning or welding.
