The filing period for the March 6, 2018, primary election began November 11, 2017, and will continue through December 11, 2017. Offices up for election include County Judge, currently held by Roy Blair; County Treasurer, currently held by Hal Spain; Justice of the Peace, currently held by Jackie Walker; County/District Clerk, currently by Mary held Grim; Commissioner Precincts 2, currently held by Paul Williams; in Robert Lee. and Commissioner Precinct 4, currently held by Joe Sefcik.

As of Monday morning, only a few candidates had filed for a place on the ballot. Russell Johnson filed for Justice of the Peace, as well as Jackie Walker. 



#### Robert Lee City Council minutes posted

The Robert Lee City Council met in regular session Monday evening, November 13, 2017. Mayor Leroy Casey presided and Council Members present included Roger Alexande Janie Munoz, Shaunna and Grantham. There are two vacant council positions currently. These are due to the death of Toni Rainwater and the resignation of Joe Longoria. The meeting began at 6:02 pm with a quorum present. Deputy City Secretary Brandie Millican was also in attendance. The sign-in sheet is on file.

The meeting began with the Pledge of Allegiance and Invocation.

## **Open Forum**

Joe Longoria spoke to the council regarding an open letter addressed to him. The letter was received after his resignation as a council member.

Fire Marshall Tom Fletcher was asked if there was anything motion was made by Council Member Munoz and seconded by Alexander to approve the minutes of the October 9, 2017, meeting with corrections. The motion passed.

#### **B. Regular Business**

A motion was made by Munoz, seconded by Alexander, to pass a resolution allowing the City Council to meet twice a month in regular session on the second and fourth Mondays. Following a brief discussion, the motion passed.

A motion was made by Munoz to elect Aaron Hood and Roger Alexander to the Coke County Appraisal District Board of Directors. Following a second by Council Member Grantham, the motion passed.

A motion was made by Alexander and seconded by Munoz to add Roger Alexander and Shaunna Grantham to the signature cards at the bank. The signature card will have Leroy Casey, Mayor, and Council Members Alexander, Munoz and Grantham. The motion passed.

A motion was made by Alexander to adjourn the regular session to go into executive session for the purpose of discussing the internal investigation, utility billing and collections in relations to city hall staff. This motion was seconded by Grantham and was passed.

The regular session adjourned at 6:19 pm and reconvened at 7:15 pm. Audio tape of the executive session is on file.

Alexander moved a vote of No Confidence in the City Secretary. The motion was seconded by Grantham and passed.

A motion was made by Alexander and seconded by Grantham to continue research into finding a credit card machine for City Hall and relaying results of the search back to the council. The motion passed.

Munoz moved to remove Kay Torres from all signature cards and as person of contact for the City of Robert Lee. The motion passed following a second by Grantham. **C. Reports**
