





County Commissioners Court Meeting minutes told

The Coke County Commissioners Court met in regular session Tuesday, June 12, 2018, at the county courthouse in Robert Lee.

Those in attendance included County Judge Roy Blair, Commissioner Precinct Donald Robertson, Commissioner Precinct 2 Paul Commissioner Williams, Precinct 3 Marshall Millican, Commissioner Precinct 4 Joe Sefcick, and Deputy Clerk Monica Reyes.

The meeting was opened with the pledge to the flag and the prayer was offered by Judge Blair.

Judge Blair announced the presence of a quorum.

Commissioner Sefcik made a motion to approve the minutes and was seconded by Commissioner Robertson. The motion carried.

The Treasurer's Report was presented by Treasurer Hal Spain. Commissioner Robertson moved to approve the Treasurer's Report as The motion, presented. seconded by Commissioner Millican, carried.

Commissioner Sefcik moved to approve the payroll. The motion was seconded by Commissioner Williams and carried.

Commissioner Williams moved to approve the accounts payable for payroll. The seconded Commissioner Sefcik, carried.

Judge Blair presented the Extension Reports.

Sheriff Wayne McCutchen presented his report.

The Tax Collector's Report was presented by Judge Blair.

County/District Clerk Mary Grim presented her report.

Constable Precinct 1 Marty Boyd presented his report.

Justice of the Peace Precinct 1 Jackie Walker's report was presented by Judge Blair.

Commissioner Williams made a motion to approve the donation of caliche from Ronnie McGinn to Coke County. The motion, seconded Commissioner Sefcik, carried.

Commissioner Williams reported that the walking trail at the Bronte Park was completed.

Commissioner Millican moved to pay the bills. The motion, seconded by Commissioner Sefcik, carried.

Judge Blair adjourned the meeting at 9:53 am.

Senate passes farm bill

by Jessica Domel The nation is one step closer to new farm and nutrition on Thursday, June 28, the U.S. Senate passed its farm bill, the Agriculture Improvement Act of 2018.

"With 171 amendments and a vote of 86-11, obviously getting this farm bill done has been a tremendous team effort," Sen. Pat Roberts, chair of the Senate Committee on Agriculture, Nutrition and Forestry, said after the bill's passage.

Senator Debbie Stabenow, the committee's Ranking Member, said the Senate's farm bill passage proves that bipartisanship is the way to get things done.

"It's not always the easiest path to take. However, when we put our differences aside and focus on the needs of the communities, the people that we serve, that's how we deliver a good bill," Stabenow said. "In this case, it's a bill that serves our farmers, our families and rural America."

More than 500 food, agriculture and conservation leaders agree the bill will provide certainty communities and farmers, according to Stabenow.

"The Senate pushed the farm bill one big step closer to the finish line, and it could not have come at a better time," Zippy Duvall, American Farm Bureau president Federation Georgia farmer, said. America's tarmers ranchers continue to face a challenging agricultural economy, a shaky outlook for our export markets and a dire

for some good news and the Senate delivered it in bipartisan fashion."

Both Texas Senators, John Cornyn and Ted Cruz, voted in favor of the five-year legislation.

"Approval by the U.S. Senate of its farm bill adds more momentum to this process. We're encouraged," Texas Farm Bureau President Russell Boening said. "We very much appreciate both Senator John Cornyn and across the country. Senator Ted Cruz for their support of the Senate bill."

Explore our history with a visit to a Texas Frontier Fort!

Visiting our Texas Frontier Forts is a perfect short, fun and educational trip for the whole family. These Texas Frontier Forts include Fort Griffin, Fort Concho, Fort Richardson, Fort Chadbourne, Fort Belknap, Fort Stockton, Fort Davis, Fort Bliss, Fort McKavett, Fort Clark, Fort McIntosh, Fort Inge, and Fort Phantom Hill. This article will focus on the frontier forts close to Coke County.

Fort Chadbourne

We in Coke County are blessed to have one of these restored forts within our own borders. Our own Fort Chadbourne was first established in 1852 as a United States Army post. The "Camp on Oak Creek" was originally intended to provide protection for those traveling to Santa Fe. It was built on the Butterfield Overland Mail route and housed 8th Infantry Companies A and K. In 1861, US forces surrendered the fort to the confederacy. Although US Infantry were stationed there after the War Between the States, a lack of water forced its closure and abandonment in 1868. The resident troops were moved to

Fort Concho at this time.


The public might never have been able to experience this piece of history without the efforts of Garland and Lana Richards who have worked tirelessly to restore the buildings and artifacts housed within them. Richards' ancestor Thomas Lawson purchased land from Samuel Maverick's widow, Mary, in 1877. Fort Chadbourne was on part of the land purchased. Odom and his wife, Lucinda, were the first of eight generations to live on the ranch containing the fort. They made their home in what is now called the Double Officers' Quarters. This building was destroyed in a fire in 1919 and restored to what it is today in 2007. Known as the first Chadbourne Ranch Headquarters, visitors to the fort can appreciate the Odom family heirlooms with which the rooms are furnished.


Fort Chadbourne is open Tuesdays through Saturdays from 8 am to 5 pm and is located twelve miles north of Bronte on US Highway 277. Just look for its entrance graced by a huge cavalry spur.
























Fort Concho

Less than fifty miles south of Fort Chadbourne is Fort Concho, located in San Angelo, Texas. The over 1600 acre site for Fort Concho was first selected in November 1867 and was necessary due to the lack of water at the older Fort Chadbourne. The 4th US

Cavalry's Company H arrived to take up residence in December of 1867. First named Camp Hatch and then Camp Kelly, the post became permanently known as Fort Concho in honor of its location on the banks of the Concho River.

The storehouses, commissary



and quartermaster, were constructed at the post in 1868. Construction continued until in 1879, approximately forty permanent limestone rock buildings were available to house and service the eight companies of soldiers who called Fort Concho home. This fort served as the regimental

headquarters for both the 4th and 10th Cavalries and at its peak was home to 400-500 men - soldiers, both infantry and cavalry, officers and support personnel. Some of all four regiments of the Buffalo Soldiers were stationed here before the fort was closed in 1889.

Today, Fort Concho is owned

by the City of San Angelo and includes over twenty original and restored buildings. It is open Monday through Saturday from 9 am to 5 pm and Sunday from 1 pm to 5 pm. Self-guided tours are available until 4:30 pm on each of these days. Guided tours are available Wednesday through Sunday.



Fort McKavett

Fort explorers only have about 65 miles to travel from Fort Concho to Fort McKavett. Leaving San Angelo heading south to Christoval and heading out onto Toenail Trail (FM 2084) and then turning east on 190, will bring you to old Fort McKavett. This US Army post began with five companies of the 8th US Infantry in 1852. Its purpose was to protect settlers and all who traveled on the Upper El Paso Road. Camp San Saba, as it was originally

known, was changed to Fort McKavett in honor of Captain Henry McKavett. The fort was abandoned in 1859, reoccupied in 1868 and closed for good in 1883. Soldiers returning in 1868 found most of the original buildings destroyed and were forced to live in tents until new structures could be completed. It is said that General William T. Sherman called this fort "the prettiest post in Texas".

Fort McKavett is now a Texas State Historic Site and is open daily from 8 am to 5 pm.

Fort Mason


The last frontier fort we will visit on this southern route is Fort Mason, located on Spruce Street in Mason, Texas, just a little over 60 miles southeast of Fort McKavett.


Lt. Colonel William J. Hardee chose the site for this post established by Companies A and B of the 2nd US Dragoons on July 6, 1851, to protect settlers from the Indians. Once the fort was established, fewer Indian raids occurred and the fort was closed several times in its first decade. At one time in early 1856, 2nd US Cavalry Companies B, C, D, G, H and I all had their headquarters on this post. Of those stationed at Fort Mason prior to the Civil War, twenty went on to become generals. Eight of these became generals in the Union Army with twelve serving as generals for the Confederacy. Fort Mason was the last command

for Robert E. Lee as a US officer.

Abandoned from 1861 to 1866, the fort was used briefly by the Confederate Army to house prisoners in 1862. In late 1866, the US Army returned to the fort and it was reoccupied, repaired and improved. By 1869, the fort had twenty-five buildings - most empty and needing repair and only 69 men stationed there at that time. It was ordered closed in March of that year. However in 1870, it was reopened to serve as the headquarters for the Frontier Forces Companies A and B. These forces were disbanded or moved in 1871 and the doors of Fort Mason were closed permanently.

Present day visitors to Fort Mason can view and explore a reproduction of the officers quarters at the Fort Mason Museum.

"This year's bill also retains and strengthens the Price Loss Coverage program to help provide Texas agricultural producers with stability through unpredictable weather and natural disasters," Cornyn said. "Finally, the bill promotes animal health and reauthorizes disease research programs, including a crucial one that will help the U.S. Department of Agriculture provide research to contain the spread of the cattle fever tick."

The Senate farm bill calls for a new program to replace the Dairy Margin Protection Program, which was not as effective for dairy farmers as intended.

It would also create stronger trade promotion programs, rural development and research programs.

Additional funding to increase Conservation Reserve Program acres to 25 million is also included.

"Agriculture and farming are vital to the fabric of our nation and are an enduring legacy of the great state of Texas. Resources like crop insurance provide farmers with an economic safety net for their efforts to feed and supply their fellow Americans, in good times and bad, and ensure food security for our nation," Cruz said.

Cruz noted the Senate achieved some long-needed reforms in this year's farm bill and took a stride toward more.

"For example, I'm pleased the final Senate bill takes steps towards restoring programs for cotton producers, by reducing the impact of amendments designed to benefit other regions and commodities at the expense of others," Cruz said.



"Of course, no bill is ever perfect, but this bipartisan effort gives us a solid framework for progress," Duvall said of the Senate farm bill. "We do have concerns about some of the



provisions that were added to the bill that make it harder for farmers to manage risk, but we are confident that those issues can be satisfactorily addressed by the House/Senate conference committee. We look forward to working with conferees from both houses to get the best possible farm bill done for rural America."

The current farm bill expires September 30.

Explore our history with a visit to a Texas Frontier Fort!

Fort Phantom Hill

Fort Phantom Hill, located on FM 600 in Jones County, was never officially named as a fort. It was established in 1851 as a US Army post to provide protection for the Santa Fe trail. The post suffered from a scarcity of fresh water from the beginning. The guardhouse, commissary and ammunitions magazine were the only stone buildings. The post was abandoned in 1854 and a fire destroyed most of the buildings

soon after. The ones not destroyed were used as Butterfield Overland stage station between 1858 and 1861. The Confederate Texas Mounted Rifles and Texas Rangers used the post during the Civil War and later it became a sub post after the war of Fort Griffin. It was closed in 1872.

The fort is open daily from dawn to dusk and is free to the public.



Fort Griffin

Fort Griffin, located on Hwy 283 north of Albany, Texas, was first established in 1867 to provide protection for settlers and as a supply point for buffalo hunters. The railroad bypassed the post in the 1870s and it was closed in 1881.

Fort Griffin is a Texas State Historic Site and is open daily from 8 am to 4:30 pm.





Fort Belknap

Fort Belknap is located between Newcastle and Graham on FM 61 in Young County, Texas. The post was established in 1851 was the center of a network of roads including the Butterfield Overland Mail route from St. Louis to San Francisco. From 1854 to 1859, its soldiers provided protection to two nearby Indian reservations. In 1859, these reservations and Fort Belknap were closed. During the Civil War, Confederate troops of the Texas

Frontier Regiment occupied the fort. Texas Rangers used it from 1864 to 1867 when the 6th US Cavalry came in. Due to the fort's dilapidation, reconstruction was considered. However with the founding of Fort Griffin, the fort was permanently closed.

The Fort is open Monday through Saturday from 9 am to 5 pm and Sunday from 1:30 pm to 5 pm. It is closed on Wednesday and daily from 12 noon to 1:30. Admission is free to the public.

Fort Richardson

The 6th US Cavalry first established this post as Fort Jacksboro, but later renamed it Fort Richardson. It is in the Fort Richardson State Park off Hwy 380 in Jacksboro, Texas. The Fort's first purpose was to counter hostile Indian raids. Seven original buildings have been restored and two replica buildings have been added.

Fort Richardson is open Sunday through Thursday from 8 am to 5 pm, Friday from 8 am to 9 pm and 8 am to 8 pm on Saturday.
