

Robert Lee City Council meeting minutes told

June 11, 2018

The Robert Lee City Council met in regular session on Monday, June 11, 2018, at 6 pm at City Hall.

present included Those Mayor Allyson Crenshaw, Mayor Pro Tem Roger Alexander, Council Member Brandi Brosh, Council Member Rickey Green, Council Member Janie Munoz, and Council Member Billy Williams, and a quorum was determined.

The invocation was provided by Mayor Pro Tem Roger Alexander with the Pledge of Allegiance recited by those in attendance.

Leta Caston addressed the Council regarding the Vision with a Purpose building improvement and coloring book.

Council Member Roger Alexander made a motion to approve the minutes from May 28, 2018, with corrections listing correct names to the bank accounts, and was seconded by Council Member Rickey Green. The motion carried with a vote of 5 - 0.

Council Member Rickey Green made a motion to discuss the Robert Lee Volunteer Fire Department donation agreement and was seconded by Council Member Brandi Brosh. The donation to EMS has been included and a recommended amount of \$2.00 to be listed on the form. The donation form will be provided to citizens with the July 1 utility billing. A motion was made by Council Member Brandi Brosh to approve of the donation agreement with changes and was seconded by Council Member Janie Munoz. The motion carried with a vote of 5

A motion was made by Mayor Pro Tem Roger Alexander to discuss the Municipal Judge agreement and was seconded by Council Member Billy Williams. City Attorney Jeff Betty advised that elected personnel cannot have more than one poisition, with the exception of the City Attorney and Justice of the The contract is approved by the City Attorney. A motion was made by Mayor Pro Tem Roger Alexander to approve of the Municipal Judge agreement and was seconded by Council Member Brandi Brosh. The motion carried witha vote of 5 - 0.

A motion was made by Council Member Janie Munoz to discuss holding City Council meetings once a month on the second Monday of the month and was seconded by Council Member Brandi Brosh. In 2017, the Council approved to meet twice a month due to internal issues. Staff has requested that the meetings be

changed to meet once a month. A motion was made by Mayor Pro Tem Roger Alexander to approve of changing the council meetings to the second Monday of each month instead of the second and fourth Mondays of each month. The motion was seconded by Council Member Janie Munoz and carried with a vote of 5 - 0.

A motion was made by Council Member Brandi Brosh to discuss the Sheriff's Office agreement and was seconded by Council Member Janie Munoz. At 6:09 pm, Mayor Allyson Crenshaw recused herself from the meeting due to a conflict of interest. Mayor Pro Tem Roger Alexander presided over discussion. City Attorney Jeff Betty advised that he did not forsee any issues. These agreements were created by statute to allow for emergency services. Agreements such as this are used by other cities. A request to correct Allyson Crenshaw's name on the signature page was made. Sheriff Wayne McCutchen reported that the agreement would be presented to the Coke County Commissioner's Court on June 12. A motion was made by Council Member Billy Williams to approve the Sheriff's Office agreement and was seconded by Council Member Rickey Green. The motion carried with a vote of 4 - 0.

At 6:10 pm, Mayor Allyson Crenshaw returned to the meeting.

A motion was made by Council Member Brandi Brosh to discuss Animal Control Enforcement and was seconded by Council Member Rickey Green. Currently the City is paying an Animal Control Officer (ACO) ten hours a week as an employee. A request was made to the Council to increase the number of hours the ACO works. The ACO also needs a rabies vaccination in the amount of \$600. A recommendation was made to employ ACO as a full-time employee. Council requests that the ACO remain at ten hours a week as funds are not available in the budget. No further action was taken.

Discussion was held on newly elected officials to attend TMCN training in Abilene on July 12. It is \$25 per individual to attend. No further action was taken.

Public Funds Investment training will be held in Amarillo June 14-15 for the City Secretary to attend. No action was taken, there was only discussion.

The Council discussed the TML Conference for the Mayor in San Antonio August 16-17. The training is not required, however the Council recommends Mayor Allyson Crenshaw to attend. A motion

was made by Mayor Pro Tem Roger Alexander to send Mayor Allyson Crenshaw to the Newly Elected Officials Training in San Antonio. He was seconded by Council Member Brandi Brosh and the motion carried with a vote of 5 - 0.

Mayor and Public Works Report

The staff met with San Angelo Pump, 3Ds Plumbing, Billy Williams, Ricky Royall, Rickey Green, and Allyson Crenshaw regarding the Lift Station. Before installation can begin, clean up and repairs need to be done at the bottom of the lift station. The City may not have to build a new lift station but may repair the existing lift station at a lesser expense.

The most recent International Property Code the City of Robert Lee approved was in 2006. The 2018 Code will be available later this year. City Attorney Jeff Betty advised if the City is going to adopt the Code, the City needs to go through each additional code and determine what applies to the community. Most cities do not have standardized codes. A standard ordinance officer will not be prepared to enforce the code requirements. The City needs to focus on animal control, dangerous buildings, and public nuisance. recommendation is to no longer use the standardized codes and repeal the previously approved ordinances adopting the International Property Code.

Fire codes still need to be applied.

There was no City Secretary's Report.

The City is in good standing with Texas Commission on Environmental Quality's water regulations. The City is waiting for confirmation from TCEQ on being compliant with wastewater.

The Texas Comptroller has released the \$15,000 to the City for sales and use tax. Fundswere held due to previous staff not filing reports within the required timeframe. The City received the request from the Texas Workforce Commissioner for reports which were also submitted.

(Continued from previous page) The lift station quote to repair includes a brand new pump. This solution will be a permanent fix to repair the lift station. The repairs to the lift station is an emergency to comply with the Texas Commission on Environmental Equality. A motion was made by Council Member Brandi Brosh to accept the bid from All-American Pump and Machine from San Angelo for repairs to the lift station. She was seconded by Council Member Janie Munoz. The motion

carried with a vote of 4 - 0.

The Council approved to have the Coke County Sheriff's Department maintain ordinance enforcement duties. Employee Renee Smith had been approved for 10 hours for animal control and 10 hours for ordinance enforcement. Her hours would have bee reduced the 10 hours she had been working as the ordinance enforcement officer. Renee has turned in her two week's notice and will reconsider her resignation if the City increases her hours with animal control from ten hours to twenty hours to compensate the cut in

The City of Bronte has agreed to discuss working with Robert Lee for a contracted animal control officer when their animal control officer retires. There is no timeframe for when this might happen.

A motion was made by Council Member Brandi Brosh to find twenty hours for the animal control officer to maintain employment with Renee Smith. The motion was dropped due to no second to the motion.

Council Member Billy Williams recommended transferring funds from another budget item to cover the increase in hours for an animal control officer. Mayor Pro Tem Roger Alexander stated that he was opposed to the idea due to the condition of the budget and needed updates have not been completed.

No further action was taken.

Payments to the Upper Colorado River Authority (UCRA) had not been made since October 2017. The past due balance for loans is in the amount of \$13,938.40. The

staff will pay the balance and future monthly payments.

The contract with the Coke County Water Supply Corporation (CCWSC) for the purchase of water from Robert Lee expired September 20, 2016.

The City received confirmation that they are in compliance for water services and a letter from TCEQ stating compliance was provided.

The utility billing late notices have been mailed out and disconnects will be done at the end of the month.

The lift station at the water plant is functioning.

The phone lines are down several times throughout the week. Services with Vonage will begin providing better quality at a more affordable rate.

Copies of the International Property Maintenance, Building, and Fire Codes may be provided to the Council. The documents average 700+ pages per book.

A motion was made by Council Member Janie Munoz to adjourn the meeting at 6:39 pm and was seconded by Council Member Brandi Brosh. The motion carried with a vote of 4 - 0.

Stephen and Sterling Myers Reunions, Rodeos, and Legacies

The arena lights have been
turned off. The stock has been
loaded. The crowds have drifted
away. Except for finalizing the
accounting and cleaning up the
aftermath, the 88th Texas
Cowboy Reunion is in the books,
so I wanted to say a few words
about this year's event and what
the event means in general.

In 1930, amidst the Great Depression, thirteen community leaders met in Stamford to propose a celebration to boost morale and stimulate the local economy. These leaders organized an event, centered around Independence Day, that would promote the legacy of the West Texas cowboy, a way of life that was quickly disappearing in the face of 20th century mechanization. That first year, 12,000 people watched three days of rodeo events and participated in cowboy fellowship and historical commemoration.

The event quickly took off. Permanent facilities were built. In 1935, legendary cowboy humorist Will Rogers performed at the TCR in one of his last public appearances before his death. In 1937, at the peak of rural populations, a record 70,000 visitors attended. Wild cow milking, double mugging, the grand entry, and the signature cloverleaf pattern of modern barrel racing were invented in the rodeo arena at Stamford. In 1940, the newlyformed American Quarter Horse Association held its first show in

Will Rogers described the TCR as a "real cowboy reunion...in a real cowtown." Today, current TCR leadership and the many dozens of volunteers strive to uphold the mission of the thirteen founders and the vision so eloquently described by Rogers. That mission is why, in my humble opinion, the TCR continues to persevere. As rural populations have declined, many rodeos and other small town cultural events have struggled to succeed and some have disappeared entirely. The TCR has had its struggles, but this year, in five days, it is estimated that over 20,000 people visited the grounds and the event is

growing each year in attendance, rodeo competitors, and sponsorship dollars.

The TCR was never intended to be a local rodeo, or even just a rodeo for the sake of having a rodeo. That's why it was named the "Texas Cowboy Reunion." The rodeo performances are an integral part, but above all, the TCR is designed to celebrate one of the most enduring images of America, the Texas cowboy. For 88 years, the event has brought together multiple generations of cowboys and non-cowboys, locals and non-locals, rural people and city people, from far and wide, all for that purpose.

The world has changed since 1930 and so has the TCR. Open-air rodeos in July are hot in an air-conditioned world and rodeos now compete against movies, sports, lake activities, and recreation entertainment dollars. To stay relevant in 2018, the presentation of the TCR has changed in some fashions, but the event stays true to its roots. As such, crowds still flock to Stamford to celebrate the Texas cowboy through rodeo, music, art, cooking, shopping, and more.

So here's to those original thirteen founders: Andrew John Swenson, William G. Swenson, Ray Rector, Rudolph Swenson, John Selmon, A. C. Cooper, F. Harley Goble, R. B. Bryant, W. G. Owsley, Charles E. Coombes, R. V. Colbert, Louie M. Hardy, and Roy Arledge. 88 years later, their legacy endures. May it continue to endure for another 88 years.




