

In May of 2017 Floydada voters decided 406-283 to invest in their secondary schools. They chose to replace a 62-year old aging high school with a state of the art facility that would provide students with a safe campus and innovative learning environment.

The new school bonds also allowed the district to construct a Ag/Building Trades facility; new football stadium and track located next to the secondary campus; additional parking, new transportation facility with covered parking for district buses, new softball field, renovations to Watson Field and new tennis courts.

According to school officials at the time, wind farms within the district will end up paying 73 percent of the cost of the bonds with homeowners and other FISD property owners responsible for the remaining 27 percent.

Now, almost four years later, dreams have become a reality.


On Sunday, April 10 school administrators hosted an open house and invited parents, students and the community to come tour the new facility with its soaring ceilings, college banners and trophy cases bringing Floydada's legacies of its history with its aspirations for the future.

Wayne Morrin, principal, was on hand to greet visitors and talked about the collegiate banners hanging from the ceiling. "When we hoisted those from the rafters, it seemed to make a real difference with the students," he said, "it was aspirational, they looked up and seemed to show a little bit of awe."

Students on hand welcomed guests into the facility as though they were docents

or curators at a museum, carefully explaining what each department did or which subject was taught in which class-

room. Lyle Miller, president of the Floydada Collegiate Indepen-



dent School District, was a part of one of the tour groups and he reminisced about the process of getting the ideas of the bond election to fruition.

"Dr. Trevino (Gilbert Trevino, school superintendent) did a major community outreach effort to help explain the importance of the bond election and how this facility was needed," he said.

Miller noted that the entire process took almost five years to get to this point.

The school board president marveled at every design feature and accoutrement along the tour. From the sleek, new stainless steel-appointed cafeteria to the auditorium with a ceiling designed to yield exceptional acoustics no detail has been overlooked in creating a place for Floydada students conducive to learning.

Me and the IRS

It's that time of year when Americans celebrate (well, maybe not) the ratification of the 16th Amendment to the Constitution, which allowed Congress to collect personal income tax.

It wasn't the first time we paid federal in-Revenue Act of 1861 to help fund the Civil War, it was repealed in 1872. Congress tried for a flat rate income tax in 1894, but it was ruled unconstitutional by the Supreme Court.

The Revenue Act of 1913 followed, requiring payment of taxes by March 1 each year. The date was changed to March 15 in 1918, though it is not apparent why, and then later to April 15 in order to give the government more time to hold onto the money (or, some say) to spread out the Internal Revenue Service workload.

April 15 has been the filing deadline since 1955, but sometimes that changes slightly if the 15th falls on a holiday like Patriots' Day or Emancipation Day. Additional time has been granted in the case of a natural disaster, such as in 2007 when certain states got an extension through June after experiencing a powerful spring Nor'easter.

This year individuals will get an automatic extension until May 17 due to the pandemic, and for

the next two years, taxes will be delayed to April 18 (given no new emergency circumstances) just because of the day of the week on which the 15th will fall.

Just how much each person pays in taxes has come tax, but after Abraham Lincoln signed the varied enormously since Lincoln's time, when it might have been between 1 and 6 percent, all the way up to 91 percent for the highest tax bracket, in the 1960s. Most Americans now pay 15 percent or less.

If you and Johnny Paycheck aren't inclined to regard Tax Day as a date to be celebrated, perhaps it can be observed with the consolation that a tiny fraction of those tax dollars funds NASA, the Smithsonian Institution museums, the National Endowment for the Arts, K-12 education and veterans' benefits. A little over 20 percent goes for healthcare programs like Medicare and Medicaid, as well as research and disease control. About 25 percent funds defense through the U.S. military.

and other long-term care facilities can still require that their residents are vaccinated under his order.

"Every day, Texans are returning to normal life as more people get the safe and effective Covid-19 vaccine. But, as I've said all along, these vaccines are always voluntary and never forced," Abbott said.

Vaccines continue steady rise across state. As of Sunday, just more than 9 million Texans have received at least one dose of a Covid-19 vaccine, and 5.46 million are fully vaccinated, according to the Texas Department of State Health Services. DSHS urges those who have not been vaccinated to go to the state's Texas Public Health Vaccine Scheduler, which can be found at getthevaccine.dshs. texas.gov.

Meanwhile, the state's weekly shipment of Covid-19 vaccines dropped this week after a manufacturing error in a Baltimore plant ruined a 15-million batch of the single-dose Johnson & Johnson vaccine.

Last week, the state received 2.5 million doses from the three manufacturers, an amount that dropped to 1.9 million this

Contempt order against salon owner tossed out. The Texas State Supreme Court on Friday threw out a contempt order against a Dallas salon owner who refused to close last year when all non-essential businesses were ordered.

Shelley Luther tore up a cease-and-desist order from Dallas County and was fined \$7,000 and sentenced to a week in jail. The high court ruled unanimously that the restraining order was too vague, and that the contempt of court decree issued by a district judge should be voided as well.

Luther's defiance sparked national coverage, prompting Abbott to reverse part of his order that called for jail time for business owners who did not shut down last year after the pandemic outbreak.

Abbott demands shutdown of San Antonio minor facility. The governor's latest salvo against the federally run unaccompanied minor facilities included a letter to Vice President Kamala Harris, who has been tapped to head the effort dealing with a large influx of unaccompanied minors seeking entrance into the United States.

Abbott's letter demanded the Biden administration shut down a facility in San Antonio under investigation by the state for allegations of child abuse and neglect.

"The Biden administration opened the borders and failed to plan for the influx of unaccompanied children crossing the border, and now we are faced with our worst fears-allegations of child abuse and neglect," Abbott said.

To date, there has been no direct response from Harris.

PLAINVIEW — The City of Plainview announced the retirement of AmeriCorps Seniors RSVP Program Director, Irma Shackelford, effective in July. Shackelford has served the AmeriCorps Seniors program in Floyd, Hale and Lamb counties for eight years.

As the AmeriCorps Seniors Project Director, Shackelford managed the RSVP Program which includes volunteer projects such as "My Dad Reads to Me" at two local prison units and partnering with Hale County 4-H for maintaining 1.67 miles of the Running Water Draw Hike and Bike Trail to keep it clear of trash and debris. She also oversees AmeriCorps Seniors volunteers who partner with the Hale County Meals on Wheels to deliver more than 300 meals to the homebound individuals including veterans and coordinating volunteers for FISH, the local food pantry, who serve an average of 415 families each month through 2020. Some of her other responsibilities include completing federal and state financial reports, semi-annual and yearly grant reporting and overseeing the 15-member Advisory Council to ensure the successful continuation of the program.

The AmeriCorps Seniors RSVP Program recently celebrated 47 years and encompasses volunteers from Hale, Floyd and Lamb Counties. Despite the pandemic, 226 RSVP volunteers served 19,116 hours via twenty-five stations (areas of volunteering) in the second half of 2020. The City of Plainview serves as the program sponsor.

"It has been an honor and while I am stepping away from the administrative duties, I will still be actively involved as a volunteer," says Shackelford. "We have a great group of volunteers and I look forward to AmeriCorps Seniors future in Plainview. I would also like to thank the City for their support of the program."

Shackelford and her late husband, Larry, have two children - Philip and his wife Kyndra and Aaron. She is a member of the St. Alice Catholic Church.

Food bytes

Customize a raspberry-lemon pastry to suit your taste

Raspberry and lemon are a marriage made in heaven in this beautiful large pastry that gets cut into individual servings.

The concept is to put a tart or pie filling inside a brioche shell. Brioche, being a light, eggy bread, makes a wonderful vessel for the filling.

My inspiration comes from Julia Child, and Brian Hart Hoffman at Bake from Scratch. When I ran across a beautiful version of what they call a brioche tart, I decided to come up with my own variety. Hoffman adds fruit preserves to the one he makes, so I found a good, sweet, yet tart raspberry jam and thought I'd pair it with a touch of lemon in my cheesecake-like filling. It's reminiscent of a cream cheese pastry.

I basically use the same brioche recipe as the one at Bake from Scratch. You may use any you prefer. You can also omit the lemon, or even the jam, if you desire. If you use jam, you can certainly choose your favorite. I found one at Costco I like, a seedless raspberry that has the consistency of a curd. Which leads me to believe lemon curd would be a perfectly acceptable option as well—maybe even a full layer of it beneath the cheesecake filling.

However you customize it, it's great with tea or coffee for breakfast, or to serve as a dessert. Enjoy food made fresh!

- **Raspberry-Lemon Pastry**
- 21/4 cups all-purpose flour
- 3 tablespoons granulated sugar, or honey
- 21/4 teaspoons instant yeast
- 1¹/₂ teaspoons salt
- $\frac{1}{2}$ cup plus 1 tablespoon warm milk (120 to 130 degrees F)
- 3 eggs, divided (plus 1 tablespoon water)
- 1 teaspoon vanilla
- 6 tablespoons unsalted butter, softened
- Cheesecake filling, (recipe follows)
- 1¹/₂ tablespoons turbinado sugar

In a medium mixing bowl, mix flour, sugar or honey, yeast, and salt with an electric mixer on low speed until combined. Slowly add warm milk on medium speed. Add 2 eggs and vanilla and continue mixing on medium until well combined and dough begins to come away from the sides of the bowl.

Knead with a dough hook attachment on low speed, or by hand on a lightly floured surface, for about 8 minutes, incorporating butter, 1 tablespoon at a time. Place dough in a greased bowl, turning to grease the top. Cover and let rest in a warm spot for 30 to 45 minutes until doubled in size.

Spray a 9-by-9 baking pan with non-stick cooking spray. Line with parchment paper with edges hanging over 2 sides.

Roll dough out on a floured surface into an 11-inch square. Place into the prepared pan and fold excess edges in to create a crust to hold the filling. Cover and let rise for 20 to 30 minutes.

- FILLING
- 8 ounces cream cheese, softened
- 2 tablespoon butter, softened
- 1/3 cup granulated sugar
- 1 egg
- 1 teaspoon vanilla
- 2 tablespoons freshly squeezed lemon juice
- 1 teaspoon fresh lemon zest
- 2 tablespoons raspberry jam
- 1 tablespoon water
- Turbinado sugar for sprinkling
- Preheat oven to 325 degrees F.

In a medium mixing bowl, with an electric mixer, cream together cream cheese, butter, and sugar on medium speed. Add egg, vanilla, lemon juice, and lemon zest and continue mixing on medium speed until smooth.

Spoon filling into the dough. Mix jam with 1 tablespoon water until smooth. Make several indentations in the cheesecake filling to drop dollops of jam. Use a knife to swirl the jam into the cheesecake mixture.

Beat remaining egg with water and brush the top edges of the dough. Sprinkle turbinado sugar on top of the egg wash.

Bake in preheated oven for approximately 35 minutes or until center of filling is set and brioche is golden brown. Let cool, then remove from pan by loosening edges with a butter knife and lifting out by the overhanging parchment. Cut into individual servings. Makes 8 servings.

The new website highlights both the values and stories of the state agency's Forest Stewardship Program. The program helps landowners achieve their property goals, increase their profits, sustain environmental functions and improve the overall health of their land by providing professional assistance tailored to individual needs.

"The new dashboard demonstrates the value that managed forests have versus non-managed forests," said Shane Harrington, Texas A&M Forest Service Program Leader. "This can vary, but includes increased growth 🛛 meaning more timber and direct profit, and higher quality water and air, creating healthier lives for Texans."

One way the dashboard showcases this added value is through data. For example, when landowners steward their land, forests can produce up to 53 more tons of wood per acre during their lifetime.

"The values section of the dashboard estimates economic values related to increased timber production, carbon sequestration, water management and wildlife habitat," said Harrington.


Along with values, the dashboard also features video and testimonial stories of Texas landowners who have seen financial and environmental benefits from land stewardship.







Quitaque's Comanchero Canyons museum reopens April 10; new Floyd County discoveries featured



STAFF REPORTS

After a year of closure due to the Covid-19 pandemic, Quitaque's Comanchero Canyons Museum last week resumed Saturday openings from 10 a.m. to 4 p.m.

"We also have set June 5, 2021, for our annual Rendezvous celebration that will have some unique additions," said museum board president Jerry Leatherman. The Rendezvous was just beginning to seal its reputation among the year's must-attend events related to local heritage of the region, when the Covid-19 lockdowns hit.

New exhibits this year include a display of over 100 rings and brooches discovered last year in northeast Floyd County by board members Leatherman and Ronnie Carpenter. Evidence points toward these "drops" originating from the ill-fated 1841 Texan-Santa Fe Expedition. The approximately 300 "pioneers" on that trek consisted of militia, merchants and servants. They spent 22 days unhappy in various camps in the area of what would become Floyd, Motley, Hall and Briscoe counties while search-
