Gaither's duty to the U.S. Army came to a close in 2014, but since that time her passion has still burned to help veterans navigate through the red tape of all things VA and Veteran related.

"I worked in the medical field," explained Gaither, "so hospitals, medical documents, even benefits do not intimidate me. I've been there and done all of that, and I can use my skills to help others."

I showed up to meet with Letesha and got to see, firsthand, her unique ability for reaching out to veterans and coaxing them through the interminable maze of benefit claims as she counseled a Veteran exaspered. Veterans get pushed back and pushed back and told different things so much, that they end up frustrated and feel like the claim process is just not worth the time and effort." Gaither passionately believes that it is--that each and every individual that served and sacrificed for the freedoms of our nation deserve any and all benefits that our government has promised.

Gaither's passion is addicting. Her efforts don't stop with benefits assistance, it is clearly evident that she truly cares for and is interested in the veterans that have been placed under her wing--which, by the way, is not a small group. According to records obtained from the Veterans Administration, Floyd County, alone, has 329 registered registered with VA.

"The Veterans are my motivation," declares Gaither. "These heroes fought bravely for our country, it's time they had someone to fight for them." She added, "With the help of American Legion Post #141, we are working to make sure that no Veteran gets left behind alone."

Letesha is available to any and all veterans, whether registered with the VA or not. She can assist with claims paperwork, benefit awards, and, most importantly, lend an ear and come up with a solution.

"Frustration is part of the system, but I want to make that frustration minimal."

### Lockney. lists 2019 Projects

In his famous 2007 speech at Harvard University, Mikhail Gorbachev stated, "If you don't move forward, you begin to move backward."

This quote expresses the past frustration by the City of Lockney's City Manager, Buster Poling. But that's all changing now. After a complete re-vamping of the city's governing structure in May 2016, Poling took over the reins and has kept things rolling forward.

Poling was recently asked what projects he is especially proud of, and what he has up his sleeve for the near future.

He stated that his biggest accomplishment this year is bringing the past due audits current. The law requires cities to perform annual audits--Lockney's last audit was dated 2012. Poling has worked tirelessly this year, together with City staff and CPAs, combing through six years of transactions, making needed adjustments, and getting the financial records in order. Finally, the 2018 audit is "in the books'

and auditors express confidence in those records.

Part of the difficulties in researching and verifying the financial records of the City came from an outdated software system lacking in report capabilities and accuracy of the inputs. The City Council has approved the purchase of an entirely new, updated software operating system that will serve the City for years into the future.

The City is currently working on submitting a CDBG applica-

## **Lockney School Board Calls for Election**

LOCKNEY - Members of the Lockney School Board of Trustees met in regular session on Monday, Jan. 21. The Board called for an election for May 4 for Precincts 3 and 4 and an At-Large position. Current incumbents are Heath Rexrode, District 3; Billy Lefevre, District 4; and Kirk Wilson, At-Large. Anyone wishing to run has until the close of business on Friday, Feb. 15 to file.

In other action, the Board approved the payment of bills and the financial report showing a balance of \$4,395,565.70. The Board approved budget amendment #012101 to transfer funds from the sale of old and obsolete music instruments to the Band equipment line.

The Board approved an amendment to the EPEC Shared Services Agreement to reflect the changes with the reconfiguration of the EPEC SSA member districts. The Board also approved the extension of Superintendent Jim Baum's contract by one year. The Board accepted the resignation/ retirement of Julie Dorman.

Baum reported a total enrollment of 442 students including 207 in elementary, 115 in junior high and 120 in high school.

The Board set Feb. 25 for their next meeting at 7:00 P.M.

Inflation for 2018 settled The venue? A Salvation Army thrift store. Today, that same crew member job is being offered for \$12 an hour as the small-town McDonald's remains in heavy competition for labor in light of the ongoing shale oil boom in the area. Back in Washington, D.C., the know-it-alls on the left have a different idea. They believe that the national minimum wage should be \$15 an hour regardless of what market you live in and how much the public will pay for a hamburger, fried chicken or pizza.



Why does this matter?

Because economic growth doesn't typically occur in massive spurts, but instead shows up in people's paychecks three And while people appreciate it when they pay less at the pump for gasoline, the prices vary from week to week and are hard to calculate into our personal budgets.

But when the average wage earner sees his or her overall take home pay increase gradually, they find themselves with enough money to not feel so stressed at the end of each month. They can then begin thinking about growing their family, putting aside something for the future or even going on

Wage Hikes Already Here

This same impact is felt when Americans believe that they can afford to quit a job That Salvation Army Store they hate before finding a new creates increased or decreased demand for labor and it is that demand which naturally increases or decreases wages. This freedom effect is being felt in the economy and the free flow of labor is what causes competition between employers for workers and increases in wages and benefits to attract and keep good people.

An example can be found in Williston, North Dakota, which is the heart of the Bakken Oil field. In a February 13, 2013 article titled, "Minimum Wage Increase: The bad idea

Half A Million Jobs Destroyed

The non-partisan Congressional Budget Office has estimated that this mandate will eliminate half a million jobs for entry level job seekers. To put that in perspective, the city of Atlanta, Georgia has fewer than 500,000 residents, so imagine all of them suddenly going from employed to unemployed.

And it is reasonable to argue that the CBO is being very conservative in this estimate. Anyone who has ordered from the counter at a McDonald's recently has encountered a new electronic board which allows you to place your order using its touch screen. The company has also implemented remote ordering by mobile phone for both contracted-out delivery and pick-up.

So, even without a \$15 an hour mandate, jobs which used to be available for kids trying to get skills, Moms re-entering the workforce as their kids go to school and seniors looking to pad their retirement savings

Minimum Wage, Opportunity Killer-

Interestingly, the study found that employers in Seattle chose to hire higher skilled workers deeming them more likely to help make a profit by increasing productivity over the entry level workers they replaced. The clear result is that those who rely upon entry level jobs to begin their pathway into the labor market are adversely impacted by higher minimum wages.

One of the study authors, Jacob Vigdor of the University of Washington concluded, "Basically, what we're doing is we're removing the bottom rung of the ladder."

Not exactly what the advocates of a \$15 minimum wage are promising from Washington, D.C. Perhaps it is time they look at Williston, North Dakota where McDonald's employees are paid well above the current minimum wage due to labor supply and demand, or even further west where in Seattle, the very people the newly fashionable socialist party in Congress claims to want to help are being kicked out of the labor pool altogether.

At a time when real wages are rising due to actual market forces, there is no need for Congress to artificially distort labor costs and destroy hope among those who are just trying to get started in life by getting that first gateway job.

### THE FLOYD COUNTY HISTORICAL MUSEUM **MEMORIES 1979**

#### **GEORGE S. MICKEY FAMILY**

George Samuel Mickey was born in Princeton, Mercer County, Missouri, March 8, 1857. His father was Samuel Everitt Mickey and his mother was Elizabeth Maranda Ray. Sarah Willetta Smith was born in Carrroll Parish, Louisiana, October 10, 1863. Her father was William Burley Smith and her mother was Sarah Ann Sheppard. They were married May 21, 1883, in Eulogy, Bosque County, Texas.

George and Sallie had eight children. The oldest, Gracie died the third day of January before she would have been three years old on the 29th of April, 1887. The next was George Francis, then Everitt, Ross, and a little girl, Annie Viola, who lived only two weeks. She was buried in the Della Plain Cemetery. Then Lew, Eula, and Smith, who was born nine days after his daddy died. That was December 30, 1895, at Eulogy, Bosque County, Texas.

In 1890, the family moved to Floyd County. Their first house was a dugout west of Floydada in what is now the Sandhill Community. George, Frank, and Lew Mickey homesteaded land.

In June 1895, George and Sallie Mickey went back to Bosque County to visit Sallie's father and sisters. While they were there, George found work. He became ill in November and died December 23,1895.

Sallie Mickey and her children, lived with her sister for awhile. Her brother, Charlie Smith, lived with his family in Floyd County. He encouraged Sallie to come back and promised to help her. She

#### moved back to Floyd County to live.

George Francis Mickey was a Church of Christ minister for fifty-eight years. He married Oline Stalcup in Petersburg in 1910. Ross married Clara Pennington in Claude, Texas, and later moved to Seymour where was a pharmacist for many years. Rhea Lewis Mickey and Vida May were married in 1917 at Mickey, Texas. Lew was a carpenter in Plainview many years. Everitt married Mary Baumgartner in Canyon in 1921, and he was also a carpenter. Smith served in the navy in World War I and later married Irene May in 1926 in Floydada, Texas. He was an automobile mechanic in Plainview until his death in 1971. Eula was a school teacher and she married Robert M. Peel in 1929 in Floydada. He had two children, Jimmy and Viola. Eula died in1937. Sallie had expected to have her home with Eula and did as that was the farm she and George had homesteaded in 1890. However, after Eula's death other arrangements were necessary. She made a home for Eula's husband, Robert Peel, and his two children for three years. She felt as close to Eula's step-children as any other of her grandchildren and it was real grief to her when she finally had to give up because of a heart condition. She died in Plainview in 1943.

Sallie Mickey was postmistress at Mickey, Texas from June 1, 1910 until February 18, 1914. Many people knew her as Aunt Sallie. - Memories of a Granddaughter, Barbara McDonough.





It appears that are going to try to grow tomatoes my worms are growing in length and in number--this allows for a larger amount of kitchen scraps to be added and composted and in return, greater amounts of fertilizer tea. Win-Win!!

In our house, this time of year is just as exciting and anticipated

as the holiday season. Terry and I comb through the seed catalogues as if they were the beloved Sears Wish Books. We fold over page corners, circle items with markers, and fill out order forms. Once that is done, we split up the orders based on live plants or seeds, then we go even further by dividing up the seeds based on planting times. We sketch out every corner and open space of our garden and place and re-place symbols of our plants-just to see if the 'design' will benefit everyone and everything involved. Believe me! When those boxes of live plants and packages of seeds arrive, it truly is like Santa has come again!!

With our keyhole garden boxes still producing veggies, we have added some more 'vertical' growing apparatuses: some nifty arched trellises for our vining plants to climb, two strawberry towers, and numerous palletsagain (because one can never give up) and have some nice aboveground boxes that will also hold a host of peppers. We just didn't get enough salsa made last year!

All in all, we are right on schedule to have a beautiful and plentiful backyard garden!







The Super Bowl is a festive night in homes and bars across America, but if your night involves alcohol, plan for a sober ride home. We want to remind everyone:


Drunk.

The Super Bowl should be a night of fun, so we want our community folks to plan safe rides home if they plan to be out at a party. Even one drink can impair judgement. You should never put yourself, or others, at risk because you made the choice to drink and drive. For most, even one drink can be one too many. Safety should be your number one priority: When it's time to leave the party, make sure your designated driver is actually sober. If he or she decided to drink, you should call a cab, use the SaferRide app, or call someone else who you know hasn't been drinking. Remember that Fans Don't Let Fans Drive walking impaired can also they can add your name

be dangerous, so designate a sober friend to walk home with you if needed. If you are driving, remember that sober driving isn't the only law that should be followed: Make sure you, and your driver, wear your seat belts. It's the best defense in a crash.

If you're planning on being the designated driver, refrain from drinking alcohol --it's that simple. People are relying on you. While at the party, enjoy the food, the company, and non-alcoholic drinks. Encourage other designated drivers on social media by using the hashtag #DesignatedDriver. Let @ NHTSAgov know you are the #DesignatedDriver so to the Wall of Fame. Your positive influence could help keep other sober drivers to stay on the right track. If someone you know has been drinking and tries to drive, take their keys and help them get home safely. Even if they make a fuss in the moment, they'll thank you later. If you're hosting this year's Super Bowl party, prepare plenty of snacks and nonalcoholic beverages for your guests and the designated drivers. 

## Floydada school construction continues to progress

With clear weather the construction at the new Floydada ISD high school campus continues to progress. Backfilling around the exterior walls of the basement is almost complete. The steel roof of the basement is in place. As soon as there is a window of above freezing temperatures concrete will be poured over the steel.

The CTE building (ag and building trades) steel framework is complete and exterior sheet metal is being placed. The north side of the building will be full height for use of construction projects such as welding and wood-working. A paint booth for trailers and vehicles will also be located there. The south side will house classrooms on the lower level. The stairs lead to the second level, which will be used for storage.

Both vertical and horizontal steel is being placed on the north end of the main building for what will eventually be the band hall and auditorium.

With the back fill of the basement, erection of the west side of the high school building, which will house the field house and coach's offices can soon begin.

Sometime in February the light standards for the football field will be put up. Plans at this time are for the football field to be complete in time for the opening of the 2019 football season.




