## Dr. Kevin Shively steps into Dean's Dental Practice

Dr. Kevin Shively has become the lucky doctor chosen by Dr. Dean to take over the reins of his Floydada dental practice. In the upcoming months, Dr. Dean will be transitioning into a Lubbock practice treating dental sleep medicine using appliances other than C-PAP machines to treat Sleep Apnea. That practice will be located in the Lubbock metroplex.

Dr. Shively arrived in Lubbock through a job opportunity; however, upon meeting Dr. Dean, Shively stated, "The stars aligned, and everything fell into perfect place."

Shively is originally from Louisville, Kentucky. He graduated from the University of Louisville School of Dentistry in 2013, at which time, he enlisted in the Army and has spent the past five years serving the military in Germany.

And Dr. Dean's thoughts regarding Dr. Shively? "He is everything I had been looking for--hoping for--to take over this practice," stated Dr. Dean. "We are very excited. We couldn't have found a better replacement!"

"The last few years, we have had to out-source multiple procedures to other dentists," stated Dr. Dean, "but Dr. Shively will be doing a lot of what I've been sending out; things like root canals and such." That, in itself, will be a benefit to patients and will save time and effort for all involved.

Technology within the dental industry has changed drastically since Dr. Dean set up his practice in Floydada in 1992. "We used to have to send crowns, caps, even prosthetics to labs in larger cities," explains Dr. Dean. "Patients would have to wait two to six weeks with a temporary bed for

## Lady Winds Capture Schools' First Ever District Crown

**RALLS - The Lady Winds rewrote history on Tuesday, defeating Ralls and claiming the 2-4A District crown for the first time in school history. Floydada capitalized on five Lady Rabbit errors - mainly four in the top of the fifth - to secure at least a share of the championship and the 4-3 victory on Senior Night in Ralls.**

Kenley Yocum took the loss but challenged the Lady Winds giving up four runs on four hits walking three, hitting two and striking out 16. Only one of Yocum's runs were earned.

Hannah Morales notched another victory giving up three runs on five hits walking two and striking out five - including a two-run homer in the bottom of the sixth by Yocum. The Floydada offense struggled with all four hits coming from Clarissa de la Fuente and Kylie Ricketts.

Ricketts went three of four with one run and a double, while de la Fuente recorded the only RBI for the Lady Winds. Floydada had multiple scoring opportunities but just couldn't close the door, stranding nine base runners - including seven in scoring position.

## The 501: Particular about Perpindicular

I married a right angle man.  
Who knew?

That's marriage. You get some surprises.  
If I hadn't met Hugh, I might never have discovered the right angle approach to life. If he exhibited right angle behavior when we were dating, I didn't notice. Things get overlooked.



Indeed, it took time for his version of feng shui to dawn on me. Maybe two or three years. I think maybe he ended up just having to explain it to me. I've since become a disciple.  
Here's the deal:  
Life's full of stuff, large and small. Unless the objects get put away out of sight (car in the garage and silverware in the drawer), stuff remains in view. If you line things up at right angles, you impose order. I'm using the phrase "at right angles" loosely. Parallel works too. Or perpendicular, if you wish. But the idea is the same. You create order rather than chaos. Think grid.

Messy people, listen up. You can use the technique to great advantage. (Don't ask how I know.) Instead of learning all those principles in the self-help books about getting rid of clutter, just think the right angle way. Line stuff up perpendicularly (or parallel) to other stuff, and you thereby create the illusion that it's all there on purpose.

Happily it's easier to be a right angle person in West

Texas than most other places. We have elbow room. The four directions are very much with us. And it's not just because roads and streets give us lots of grids.

I've been to a Comanche ceremony or two where the acknowledgement of east, west, north and south was an integral part of things. Comanches were originally people of the Wide Open Spaces even though their reservation ended up in the Wichita Mountains.

As long as we've slipped into the Plains Indian realm, may I mention that circles are also sacred in the Comanche view of things. (I wanted to say "in Comanche circles," but let's avoid cheap puns.) In one way, circles are like right angles. If you arrange things in a purposeful circle, you achieve much the same effect as if you go with the right angle approach. Either way, you've created order, albeit done differently. A circle by any other name is a right angle. (You probably won't ever hear that again.)

Maybe it's because my husband is an architect that he's orderly and all about right angles. On the other hand, I have a cousin who's an architect who likes throwing circles into the scheme of things. (Conrad, if that's not right, forgive me.)

Either way, it's about making order out of chaos.

Sometimes you hit a snag. We're constructing a lid for our pickup bed, and we've discovered it's a trapezoid! Seriously.

Hugh took it surprisingly well -- maybe because he's learned to live with me.

Life's not perfect. Right is nice. But if you're off a degree or two, the world will keep spinning -- on a tilted axis, at that.

## County Commissioner Meeting

Floyd County Commissioners met April 8th in the Floyd County Courthouse for the April meeting.

The first order of business was to announce training certifications by county staff. Sheriff Raissez completed the NIMS Training Emergency Response and Linda Nichols completed her Certified Asst. County Treasurer training requirements.

Cristen Brooks, Floyd County's Family and Community Health Extension Agent presented her activity report from February and March. Currently, she is doing double-duty until an Ag Agent is hired. Brooks reported on the March photography contest, Floyd County Friends Unity Center Gala (The bldg. is used frequently by the 4-H), Rotary Club presentation, the Educational Presentation contest April 29, Shooting Sports contest April 19 and the Regional contest hosted by Floyd County, May 18th, and District Roundup on April 29th. During the Parent Leader Association meeting on March 19th, the parents voted to combine the Lockney and Floydada 4-H clubs into one county club. Brooks also commented that the club continues its work with SOS, that is desperately in need of canned or frozen foods.

County Judge Marty Lucke presented the County Investment Report: The county has three CDs (\$200K) of which \$2,064.32 of interest was reinvested. The three CDs include \$101K-General Fund, \$75K in Road, and \$25K in Library. The county is looking to investing another \$300K of CDs, which would provide for a base investment of \$500K. Lucke stated that, "...because we have been frugal, all of the debt we were in three years ago is gone, and we are building up or portfolio. We made cuts, we

got what was needed--we just haven't splurged on more." Lucke is hoping to have \$1 Million invested in CDs by 2020.

The Lubbock Jail Interlocal Agreement was presented to the commissioners. There were no changes to the agreement other than the renewal dates. Currently, prisoners that must be held in Lubbock are billed at \$65/day. Sheriff Raissez stated that the county utilizes Garza County's facilities before taking prisoners to Lubbock. Commissioners approved the new agreement unanimously.

Lucke stated that, in regard to the Copy Machine proposals, he recommended the Xerox plan. Their servicemen are located in Lubbock though Benchmark. The Commissioners approved the contract unanimously.

While on the road recently, one of Precinct 4 vehicles broke down. Bids for repair were in the \$14-\$16K range. Commissioner Martinez located a 2013 ¾ cab with 116,000 miles in Lubbock for \$15,000. Lucke stated that there was money for the vehicle in his equipment budget to pay for the truck. The commissioners approved the purchase unanimously.

Judge Lucke gave a brief Legislature report. He also stated that the county has had no communication from APEX regarding work on the windfarm.

The Commissioner's Court convened into Executive Session. Upon reconvening, Judge Lucke stated that the Session was related to a personnel matter.

The next meeting is scheduled for May 13, 2019.

Those attending the meeting were County Judge Marty Lucke, County Clerk Ginger Morgan, County Commissioner Tanner Smith, Commissioner Clint Bigham, Commissioner Nathan Johnson and Commissioner David Martinez.

## Purchasing bunnies, chicks and ducklings for Easter Gifts

Bunnies, chicks, and ducklings are often associated with spring and newness of life. Over the years they have also become much requested Easter gifts.

Despite their popularity many end up in animal shelters once children tire of their cute, little new pets. That's why many animal welfare advocates and humane societies advise sticking to chocolate, in the strongest possible terms, and others encourage educated, responsible rabbit and chicken adoption during the Easter holidays.

Parents need to think carefully before purchasing any live animal as a gift for a child and about the commitment of ownership.

The same applies to ducks and chicks. People will get one or two and sometimes they only last a week of so if not properly cared for.

Often parents buy chicks and, if they survive, try to raise them in the city. For parents who want to take on the responsibility of a live animal at Easter and although feed stores may carry a number of ducklings and chickens most businesses advise against gifting birds to children as pets, especially Easter gifts.

Chicks are living creatures are creatures that can live up to 10 years with proper care. Before purchasing chicks it is important to research ownership and the responsibility of raising chick carefully.

Information on raising chickens can also be found at www.backyardchickens.com and www.mypetchicken.com and at the local extension's website.

Advice for caring for rabbits includes:

Use the proper equipment. Only use all-wire cages. These are much less likely to cause urine stains on your rabbit than solid bottomed cages. They also keep your rabbit's environment cleaner and reduce ammonia. If you plan to breed your rabbits, make sure you have a nest box ready at least a week before your doe is due to deliver.

Feed a healthy and consistent diet. People will spend a long time looking at feed bag labels trying to determine the See **EASTER**, Page 10

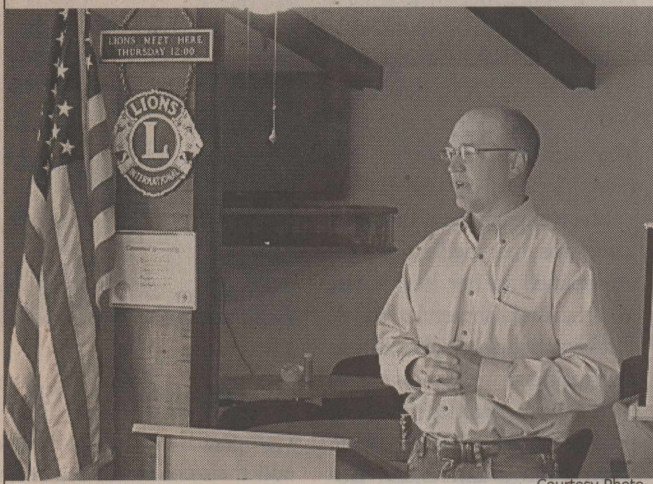

## The South Plains Hobby Club March 28, 2019

The South Plains Hobby Club met at the Museum of Texas Tech University in Lubbock, Texas. The program was held at the Helen DeVitt

Jones Auditorium. It began at 10:30 a.m. We parked on the west side of the building.

Our speaker was Dr. Marian Ann Montgomery, Curator of Clothing and Textiles. The "Come and See" programs let us see into the massive closet of "Museum's Clothing and Textile" collection. She will show and talk about 20 or more items of clothing, quilts, embroidered pieces and more. The programs are free but they require an RSVP. For information contact marian.ann.montgomery@ttu.edu. Just to let you know her next program is in September 2019.

Dr. Montgomery is very good in her knowledge of the backgrounds of the items. She had different styles of dresses from 1920's to 1950's. From everyday wear to going to the prom. Two beautiful coats that were hand painted. Sewing work was detailed. Oh, I want to mention a magnifying light that I had never seen used before. Her assistant used it when there was some detailed done on clothing, quilts, etc. Anything there at her program. It helped us to see some wonderful sewing talent. Shoes, also, different styles. Beth Levine or Irene Lane said of her shoes, "We made very pretty shoes that nobody needed but everybody wanted." I thought she was a very fun and honest person/designer. There was wedge sandals, high heels, and others. Very different in the way and style they were made.

All I can say is different to look at. A lady, Helen Claire Crofts, bought old clothing at car shows back in the day. She enjoyed the look and style of them and she wore them. Dr. Montgomery had several pictures through her program. She had quilts that were very pretty. Including two baby quilts that were known as the "Puff or Biscuit" design.

One of them was called "Bambi and Thumper" quilt. Made by Barbara Ann Malone. I believe she said in 1944. Dr. Montgomery had a very delicate parasol on display. She told us about "Feed Sack" dresses. Quite a few of our ladies had these made for them by their mothers when they were growing up. They would go to the store with their mothers to help pick out which print they would like for their dress. They have received from the Nichols collection 4,000 swatches of printed feed sack fabric. There will be a program on feed sacks on August 17, 2019 at the Texas Tech Helen DeVitt Jones Auditorium, Lubbock, Texas. The cost is \$40.00 including lunch. I heard there some quilters that want to go.

By the way, the "Old Settlers Day" is on May 11, 2019. Ethelyn Vernon would like the quilts to be displayed and brought on Thursday, May 9, 2019 from 9:00 a.m. to 5:00 p.m. to the Floyd County Historical Museum in Floydada, Texas.

## THE FLOYD COUNTY HISTORICAL MUSEUM MEMORIES 1979

### MONTGOMERY FAMILY

Six generations of our family have lived in Floyd county. My father, Joseph A Montgomery, was born in Bells County, Texas, September 24, 1884. My mother, Mary A. Erwin, was born October 28, 1888 in Allsboro, Alabama. They grew up neighbors in Hall County near Memphis, Texas. After a long courtship they ran away in 1911 to get married (at ages 24 and 27), with the help of an aunt she had a beautiful white dress for the big day. After the marriage they took the train to Colorado Springs for a thirty-day honeymoon. On their return they made their home at the Montgomery Ranch. I was born at the ranch February 7, 1913. When my father heard of the good water and all the pasture land on the Plains we moved in 1916. He bought land in S.W. Floyd County and we lived in town until a barn was built. My mother decided to fix up two rooms in the new barn and we moved in so she could cook for my father and the hired help. This was our home until the house was finished in the spring of 1917.

On January 28, 1918 my brother Joe Dolph was born during an awful snow storm. A neighbor was paid \$20 to go for Dr. Lon Smith. The Doctor and his nurse had to stay the night as it was too bad to make it back to Floydada. Joe is now retired as the superintendent of the Anchorage Alaska School System. Robert

Andrew was born August 26, 1920. Bob is now a retired counselor and teacher from the Alaska Public Schools.

Bob is married to the former Mary Frances Barnes of Hale Center. They have two children, Pam and Mike, college students in Anchorage.

Joe is married to Ebba Erickson and they have two daughters. Julia is married to Peter Ginder, a lawyer in Anchorage and they have Jonathan and Brian. Marilyn is married to Michael Oden, a rancher in Washington State and they have two boys, Micheal and Andrew.

In 1922 we moved our house to Floydada to where Buddys' Grocery Store now stands. My father and Ed Johnson put in the "White Rose Cafe". Later Mr. Johnson sold his interest to my father, but due to bad health he had to close in the spring of 1925.

He was taken to the hospital in Lubbock and lived less than a month. He had sugar diabetes and all the doctors back then had not been able to find his trouble until too late. A widow with three children, mother took in boarders and served meals to the public - Mrs. Joe Montgomery's Sunday dinners for 50 cents were quite popular. Later she babysat for 15cents an hour.

In August, 1926, I married Willie B. Eakin of Chilton, Texas at Colorado Springs. To this day I am still teased that

I married so young that my mother and brothers had to go on our honeymoon with us!! The next year we bought and moved to our farm home 18 miles S.W. of Floydada near the Allmon School where we have been involved in farming and the cattle business for over fifty years. On June 24, 1927 our only child, Bettye Allene was born.

Several years later my mother, Mary Montgomery, married W. M. Dorsey. Also making his home in Floydada for his last several years was my maternal grandfather, W. C. Erwin (born 3/18/1861, Cherokee, Alabama).

Our daughter, Bettye, married a Floydada native, Alvis LeRoy Chowning in 1945 and they had two children, Delores and Douglas. Delores and her husband, Ken Fincher live in Amarillo and have three children; Terry, Tammy, and Todd. Douglas lives in Floydada and has two boys, Wayne and Dusty.

It doesn't seem that long ago that we moved to the Plains of West Texas but our family has seen six generations live and farm in Floyd County. Even the family that has moved away seem to still spend as many holiday and summers here as possible. We are all very proud to have our heritage here and be a part of Floyd County's history and of the future of our area!!

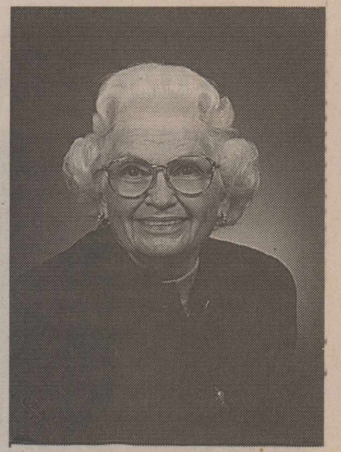
1944 and shortly afterward began teaching in Floydada until she retired in 1990 after 43 years of teaching Homemaking.

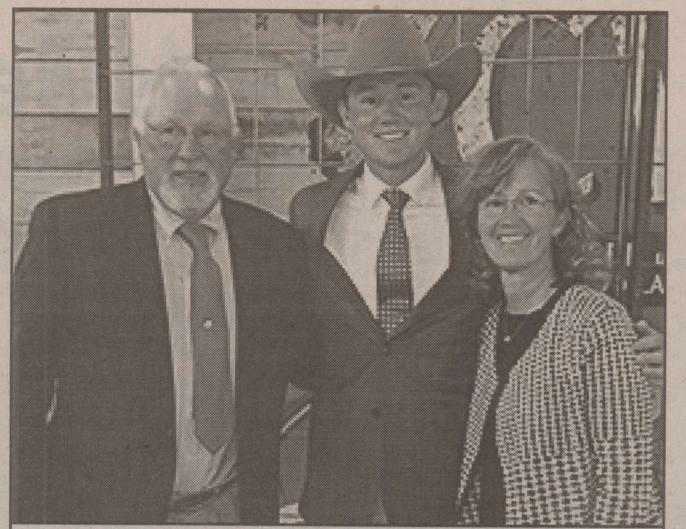

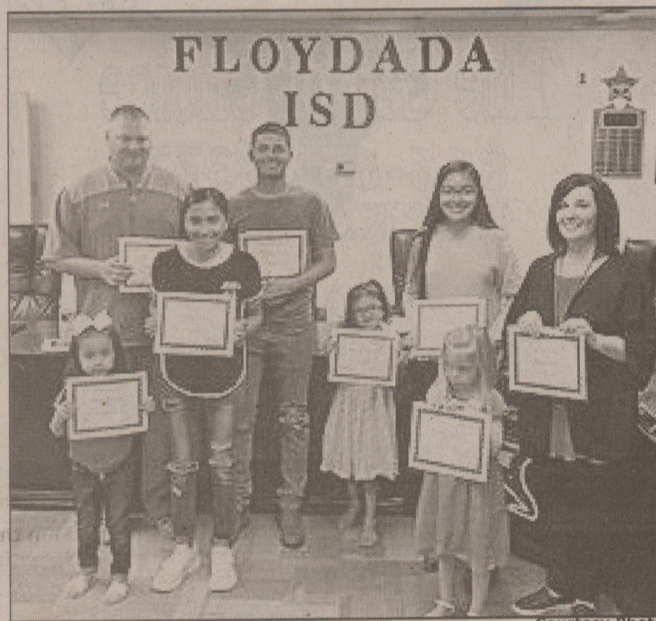
## Students sew pillow cases to Donate

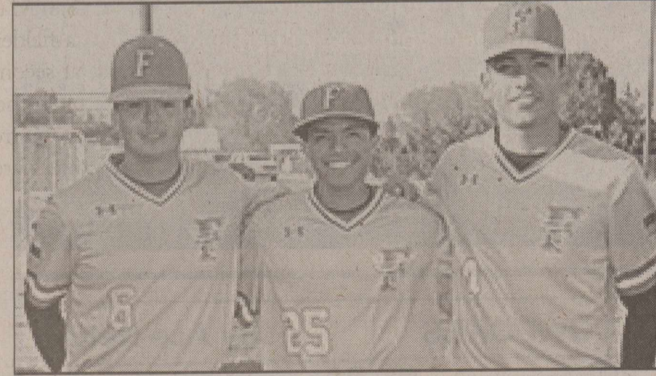

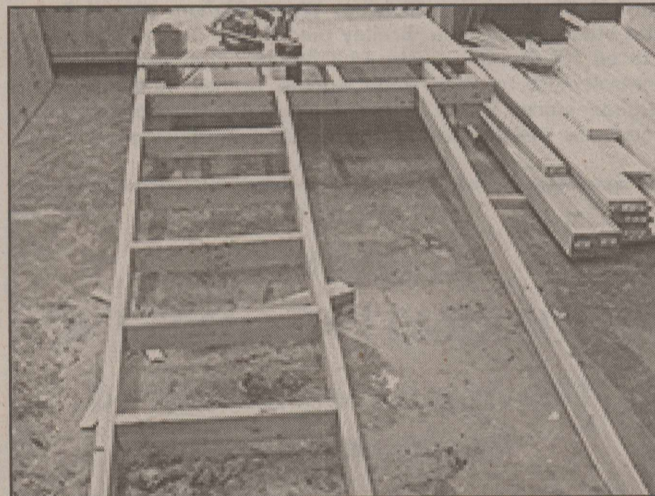

center field but the Lady Rabbits still trailed, 4-3.

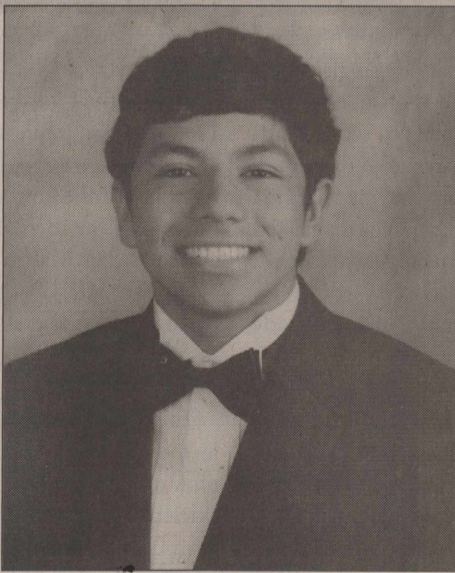

healthiest diet for their rabbits. While that is admirable, sometimes the freshness of the feed and the consistency of the nutrition are more important than the brand of pellets. Ideally, show rabbits should have a diet low in protein and fat and high in fiber. Free-choice timothy hay is an excellent addition to any rabbit's meal. Always make sure the feed is fresh; rabbits will not condition well on stale pellets. A healthy base diet is more effective at getting your rabbit in top condition than any supplements you could throw in.

Provide the proper environment. Proper housing doesn't stop at a well-made cage. The cage must be located in an area with excellent ventilation. The surrounding temperature should not get above 85 degrees at any time of the year, at least unless you take measures to keep your rabbit cool and hydrated in hot weather. The cage can be kept outside, but must be protected from predators and precipitation. It must be kept in a quiet area so your rabbit will not be stressed.

All these factors, if the rabbit is not protected from them, can compromise your bunny's immune system. It's also very important to keep the cage clean. Not only will this help prevent disease such as coccidiosis, but it will keep you're your rabbit's coat from getting stained.

Even though live animals may be cute and desirable at Easter, parents and children need to remember the responsibility of caring for the pets. The only worry with chocolate bunnies and PEEP chicks are the unwanted calories.

• 44 ounce boneless chicken breasts	1. Slice chicken breasts into strips.
• 1 tablespoon lime zest	2. Prepare marinade by zesting 1 lime zest, juicing limes and lemon, mincing garlic, chopping cilantro and measuring cumin, kosher salt, black pepper, and olive oil.
• ½ cup lime juice	3. Place a resealable plastic bag inside of a sturdy bowl. Fold over the top to avoid a messy seal and open the inside of the bag to create a bowl like shape.
• 2 tablespoons lemon juice	4. Add chicken and marinade ingredients to the resealable bag.
• 5 cloves garlic minced	5. Seal the plastic bag and marinate the chicken in the refrigerator for 3 to 12 hours.
• 1/4 cup cilantro chopped	6. *Tip: The more time you allow for the chicken to marinate, the more flavorful it will be.
• 2 teaspoons cumin	7. Preheat grill to medium-high heat. Place chicken on grill and discard the marinade to avoid cross-contamination. Grill for 3-5 minutes on each side or until the chicken reaches a minimum internal temperature of 165°F.
• 1 teaspoon kosher salt	Alternative cooking methods:
• ½ teaspoon black pepper	1. Oven – Preheat oven to 350°F. Place chicken in an oven safe dish with half of the marinade. Bake for 45-60 minutes or until the chicken reaches an internal temperature of 165°F. Be sure to discard remaining marinade to avoid cross-contamination.
• ¼ cup olive oil	2. Slow Cooker – Place chicken and marinade in a crockpot. Add 1 cup of water. Cook on low for 6-7 hours. Or cook on high for 4 hours. Make sure the chicken reaches an internal temperature of 165°F.

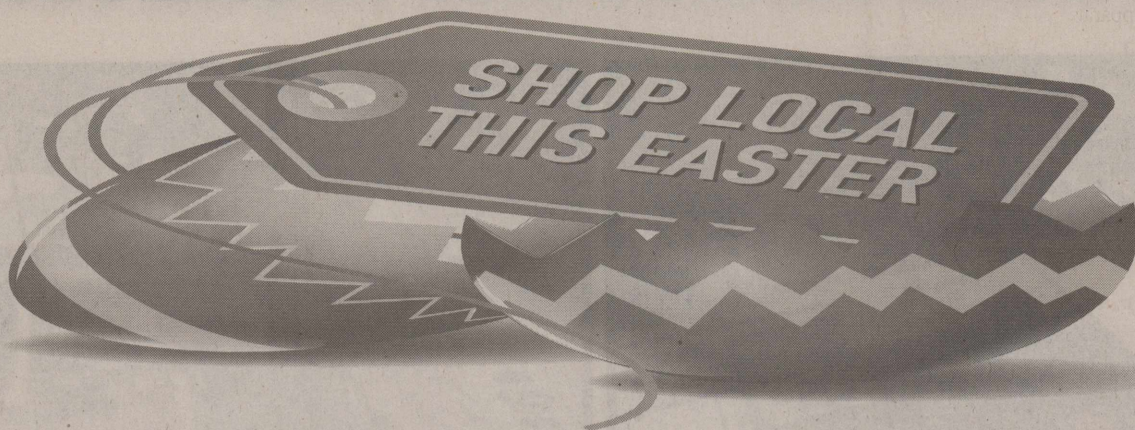

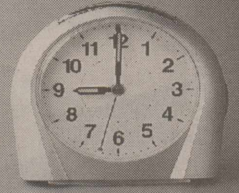

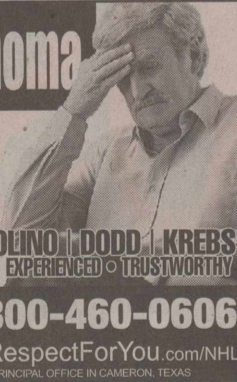
