## Floyd County... Where are your **Hospital District Tax dollars going?**

Floyd County is very fortunate to have two hospital districts. Lockney Hospital District geographically represents 25% of the county and Caprock Hospital District in Floydada represents 75%. The biggest difference between the two districts is that only Lockney has an operating hospital providing medical and emergency care in Floyd county. Both districts run clinics in their respective towns. The Lockney Clinic is staffed by four physicians and a physician's assistant. The Silverton clinic, under the umbrella of the Lockney Hospital District, has a physician and a family nurse practitioner that staff the local clinic. The clinic in Floydada is staffed by the West Texas Physician Group, which is not affiliated with any hospital.

The only hospital in the Caprock Hospital District closed its doors in 1992. Since then, the Lockney Hospital District has provided 95% of the healthcare in Floyd County while the Caprock Hospital District has provided only a clinic. The Caprock Hospital District operates an excellent EMS service, but its cost is only a small portion of their budget, according to financial reports for the year ending September 30, 2018. The Floydada EMS team works closely with the Lockney volunteer EMS service and the W.J. Mangold Memorial Hospital Emergency Department and staff.

According to the 2018 year ending financial reports, the Caprock Hospital District amassed \$244,000 in net profit after all expenses. The operating funds upon which the profit was made were contributed mostly by tax dollars of citizens in their district. At their January meeting, the board elected to buy an additional certificate of deposit (CD) with the \$244,000, making a total of \$900,638.93 held in CDs. Tax payers have the right to know how revenues are utilized. Are those revenues being used to benefit the local hospital and/or DRAW **INTEREST ON CDs?** 

Since Caprock has closed its hospital, the complexities of running a hospital have changed drastically. The changes required by federal and state governments added to the tremendous reduction in revenue by patients, insurance companies, and Medicaid and Medicare. Expanded reporting has also put a severe strain on the

operational needs of all rural hospitals. W.J. Mangold Memorial Hospital has remained current in its obligations, but there are additional changes scheduled for the next five years that present great financial challenges to all rural hospital districts across the state of Texas.

Lockney Hospital District is responsible for the total operations of W.J. Mangold Memorial Hospital. This includes in-patient and out-patient hospital stays, surgeries, a physical therapy department, a home health agency, and the only emergency care department in Floyd County. These operations are staffed 24 hours a day, 7 days a week and 52 weeks a year. Caprock Hospital District does not contribute any financial assistance to support W.J. Mangold Memorial Hospital.

In order to maintain stability in Floyd County economics, and for economic development to take place, there must be support for local businesses, successful school systems and an atmosphere of collaboration in both Floydada and Lockney. There must also be a strong healthcare system in Floyd County, which Lockney Hospital District has in W.J. Mangold Memorial Hospital.

W.J. Mangold Memorial Hospital sought a grant from Caprock Hospital District, a district with no hospital expenses of its own. At a board meeting in March 2019, an amount of \$200,200 was requested for critical capital improvements. Had they agreed, Caprock Hospital District could have granted the requested funds without having to raise their tax rate, and they would still have been able to retain a portion of their operating profit. The Caprock Hospital District denied any financial assistance with a two-sentence letter indicating there would be no further discussion of the matter.

It is important to remember why W.J. Mangold Memorial Hospital is such a vital organization in Floyd County: First, it is the only hospital in Floyd, Briscoe and Motley Counties; it also serves patients from Hale and Crosby Counties. Second, it is one of the major employers in Floyd County. Both Hospital Districts must work together not only for the healthcare of the county but also the economic well-being of Floyd County.





me at the corrals. Hooves were protruding. Our mama and baby were definitely suffering some distress.





## THE FLOYD COUNTY **HISTORICAL MUSEUM MEMORIES 1979** WILLIAM P. AND ANNIE NEFF

William P. Neff was born in Coffee County, Tennessee, November 30, 1882. His arents were John Eli Neff and Ellen McAbee Neff. The family moved West and to Callahan County, Texas. As they moved west, other children were born. They moved in wagons pulled by teams and walked most of the time.

Annie L. Towell was born in Viola, Arkansas, April 22,1887. Her parents were Thomas Towell and Sue Johnson Towell. The family moved westward in wagons pulled by teams and they walked most of the time.

William and Annie's families came to Callahan County about the same time, and they net and married at Cross Plains, Texas, July 28,1907. Several of their children were born near Baird, others in Oklahoma and in Floyd County, Texas.

They owned a farm in Callahan County and farmed and did other work. Later they noved to Oklahoma and farmed and owned a grocery store.

They moved to the plains of Texas in 1923 from Duncan, Oklahoma, and lived near McAdoo, Texas and then to the Fairview Community of Floyd County. They farmed and raised cattle in the northeast part of Floyd County.

## **Abundance of mature birds await Texas turkey hunters**

With many mature toms strutting across the Rio Grande turkey range, Texas hunters should have a good shot at a long beard this spring.

Jason Hardin, Texas Parks and Wildlife Department (TPWD) turkey program leader, said good habitat conditions could make for challenging hunting, but the middle to latter part of the season should be phenomenal.

The general spring season for Rio Grande turkeys in the South Zone runs through April 28 and then culminates with a youth-only weekend

many jakes this year due to low recruitment associated with dry conditions the past probably a hunter's best bet to two years.

"We really bumped the turkey population up in 2015 and 2016. You're going to see a lot of three- and four-yearold toms out there," Hardin told the Texas Farm Bureau Radio Network. "A lot of our toms live to be a ripe old age. So, expect to see a bunch of big, mature toms out there this year."

Hardin recommended hunters rely on their decoys to do most of the work and minimize calling, as late- season gobblers will be wary of calls. He stressed that those hunters willing to put in the time and patience this spring should have an opportunity to harvest a boss tom.

so low," Hardin said.

He noted spur length is age a turkey, especially if the bird is 3-years-old or older.

New this season, hunters have the option to use precharged pneumatics (air guns) as legal means for harvesting Rio Grande turkeys in Texas.

Eastern spring turkey hunting in the counties having an open season starts a week later this year on April 22 and runs through May 14. Hunters are required to report harvest of eastern turkeys electronically to TPWD within 24 hours of harvest.

Reports can be made through the TPWD My Tex-

ers still have to tag harvested birds.

The harvest reporting app can also be used as a tool for voluntarily reporting and tracking harvests of other resident game species, including Rio Grande turkeys. With My Texas Hunt Harvest, hunters can log harvested game animals and view harvest history, including dates and locations of every hunt.





As I sit, writing at my computer, I am hearing thunder and raindrops outside my window--I love spring!

My garden has been through extreme cold and rising hot temperatures since the last time I reported. That cold front just about got all of my pepper plants and some of my tomatoes that I had just gotten into the ground. At the last minute, I gathered a bunch of straw and tucked it around those plants and replaced their tubs and buckets in order for them to "weather the storm" so to say.

We lost some leaves on each of the plants, but we've still got fruit (grape-sized tomatoes) and our peppers are sprouting out new leaves to take the place of those that froze off. Only time will tell, but, all-in-all, these new plants are showing their dedication!

With this hot, sunny weather, Terry and I have been busy planting our corn. First, we got the Indian corn in the ground--we had less of it to plant. After shoveling most of our load of dirt into our garden beds, we got some of our Sweet Corn planted and watered. With the sprinkler doing its best, I moved inside our fenced garden and planted peas and, on what will become our grape-arbor-oasis, I planted clover. The bees will be so happy with us this year and will delightfully spend hours upon hours pollinating every flower bloom they find!

As of Easter afternoon, our Indian corn had pushed up a few baby stalks; the peas were sprouting and pushing through the dirt, and where I planted and soaked my clover, volunteer spaghetti squashes were emerging and spreading their leaves.

As I've stated before, when volunteer plants start coming up, it's time to begin planting in earnest! I've got my box of seeds ready. Terry and I made great progress on all of our beds this past week. Lastly, this rain will be the final step toward a lush, productive garden that will provide so much bounty for our family and friends.

On a side note, I did get some more Kale harvested and in the freezer. I came into about a 1/2 bushel of cherry tomatoes this past week, so I sliced them into halves, sprinkled olive oil on the batch, salted and peppered them after putting them on cookie sheets and any available pans I could find, and stuck them in a 200-degree oven for eight hours. YUM!! Roasted tomatoes ready for use in omelets, pasta salads, or just for healthy snacking! With some added oil poured into the jars, these fruits will be usable for several months straight out of the refrigerator. Happy gardening, y'all!!
