Commissioners approve RD reorganization plan

FLOYDADA — Floyd County Commissioners approved a bankruptcy exit plan last week for the defunct Reagor-Dykes Auto Group. The Floydada City Council had previously approved the plan in October.

The approval of the reorganization plan by local entities was a necessary step which could lead to the reopening of a local

Judge Robert Jones, a federal bankruptcy judge, approved the auto group's amended disclosure statement and reorganization plan, allowing attorneys to send those and voting ballots to the creditors named in its bankruptcy and the federal government.

Those ballots are due by Nov. 22. Ballots not received by that date will not be counted.

Creditors who objected to the sponsor, reorganization plan had until Nov. 6 to file

written objections.

Judge Jones has set a hearing date on confirmation of the plan for Dec. 11.

If the reorganization plan fails or is not confirmed, the case will be changed into a Chapter 7 liquidation plan.

The reorganization plan includes:

· Consulting agreement with the Fin-Ewing auto group to achieve "long-term business and financial goals.'

· A new slate directors and officers.

• Up to \$13 million in new investment from an investment group headed by oiland-gas company Henry Resources, LLC.

· New franchise agreements with Ford Motors, General Motors, Toyota, and

· A "Creditor's Trust" which will retain 10 percent of the new business's equity; the other 90% will remain owned by the plan

Cotton production down in county



Cotton ginning season in full swing for area gins with growers reporting varying grades in their crops.

The current market price is .5465, which is trending better than last year.

has reported their current bale count is 20,219. They estimate ginning 50,000 bales this season.

Darty Gin has a current bale count of 6,100. Last year they had a total of 22,332 bales. The Dougherty area had several farmers reporting severe storm damage this year to their crops. They report that the grading has been worse than last year. They project to finish ginning in December.

Barwise Gin reported that their current bale count is 4,540. Their estimated total is 8,000, slightly below

last year's 8,158 bales. Their average grade is the same as last year. Barwise expects to finish ginning in December.

The McCoy Gin has ginned a total of 8,249 bales. Last year's total was 26,000. Their grading The Floydada Coop Gin has been better than last year and expect to be finished before the end of the year.

D & J Gin of Lockney has ginned 12,500 bales. Their estimated total is 20,000 which is down from last year's total of 46,438. They reported that the grading is better this year than last year.

Lockney Coop Gin's current bale count is 4,644. Their estimated total is 12,000 and is down considerably from last year's total of 31,813. They project to be finished ginning in December and reported their cotton grading is about the same as last year.

Floyd, Hale Counties enter into agreement over prisoners

FLOYDADA — Floyd County has entered into an Interlocal Agreement with Hale County concerning the housing of prisoners. Under the agreement, \$52 per day is required per prisoner if jail space is available,

Floyd County would comply with a number of requirements set forth in the agreement.

Commissioner Nathan Johnson made the motion, Commissioner Davis Martinez made the second as the motion passed unanimously.

The following members were present: County Judge Marty, Lucke, Tanner Smith commissioner, PCT 1, Clint Bigham Commissioner, PCT 2, Nathan Johnson Commissioner, PCT 3 and David Martinez Commissioner, PCT 4.

Judge Lucke reported that the U.S. Forest Service monitors the drought scores very carefully, and at this time Floyd County is not under a burn ban. 

ALVA AND ELLA RAPER

Alva Raper was born in Indiana, June 25, 1872. His family moved to Jack County, Texas in 1884. He was the youngest of several children when he met the youngest daughter of the Faires family. Ella Ora was born November 3, 1874 in Johnson County. After her parents died, she went to live with her older sister, Mrs. J. W. Baggett, who had married and moved to Jacksboro. On September 24, 1893, Ella and "Al" were Steve Williams of the Prairie View Community near Plainview.

and settled on a farm in the Liberty Community near Plainview. The next year another daughter Mary Hazel, who is married to Lavon Johnson, was born March 17, 1912.

LEVELLAND - South Plains College will offer the NRA Basic Personal Protection Outside The Home course in the Law Enforcement Technology building on Nov. 23-24 (Saturday and Sunday).

This course is intended for individuals who have a License To Carry or plan to get one. The classes focus on firearm safety skills needed to win during a violent encounter. It is not a course for beginners. National Rifle Association instructors must take the student course before taking the instructor course.

The course is divided into two levels - basic and advanced. The nine-hour basic level covers safety, mindset, avoiding confrontations, legal aspects and concealed carry. The range portion teaches students to present the

pistol from concealment as well as all shooting with the gun holstered and

The Basic Class will begin at 9 a.m. on Nov. 23 (Saturday) and end at 6 p.m. with the Nov. 24 (Sunday) class beginning at 1 p.m. to 6 p.m. There will be frequent breaks and an hour-long break for lunch on Nov. 23.

Students will learn to move to concealment or cover, fire with one hand, move forward and backward, and aim by point shooting. Students who complete this level successfully also may take the advanced portion, which is another five hours at the range covering more advanced shooting skills. The range portion requires approximately 200 rounds of ammunition, and it is included at no



Hunters pursuing mule deer this fall in Briscoe, Childress, Cottle, Floyd, Hall, Lynn and Motley counties will be required to comply with a new antler restriction regulation that prohibits the harvest of any mule deer buck with a main beam outside spread of less than 20 inches.

Hunters are encouraged to bring their mule deer buck to a deer harvest check station so that TPWD Wildlife Biologists on buck age structure. Support small businesses Nov. 30

I'm thankful for small business. It's what keeps our economy humming. Small businesses account for over 99 percent of all employers in the state, and they employ about 45 percent of the Texas workforce over 4.7 million workers in Texas alone.

That's why I always look forward to Small Business Saturday. It's a chance to thank the entrepreneurs who help our communities throughout the year.

Small Business Saturday -- always the Saturday after Thanksgiving and Black Friday -- began 10 years ago to focus attention on the independent shops and restaurants hit hardest by the Great Recession.

Since then, it has become one of the busiest shopping days of the year.

Holiday shoppers spent a record \$17.8 billion last year on Small Business Saturday, according to American Express and NFIB, the nation's leading small business advocacy organization. To put that in perspective, people spent only \$7.9 billion online two days later on Cyber Monday.

American Express and NFIB estimate that 104 million Americans shopped small last year on Small Business Saturday. In many cases, it was their chance to interact directly with the small business owner, the person who sponsors their local Boy Scout troop or cheer squad.

And it isn't just brick-and-mortar

businesses that are benefitting from all this. Among shoppers who reported participating in last year's Small Business Saturday, about 41 percent said they shopped small online, too.

Most encouraging, 96 percent of shoppers surveyed last year said Small Business Saturday makes them want to shop small the rest of the year, too. What began 10 years ago as a marketing campaign to help small businesses get through tough economic times has become a movement.

Something else to consider: When we shop at chain stores, the profits go someplace else. When we #ShopSmall, 67 cents of every dollar remains in the local community, according to a study by American Express. What's more, every dollar spent at a small business creates another 50 cents in local business activity because of employee spending and purchases to keep the business up and

Small businesses make a difference. They're owned by and employ our families, friends, and neighbors. They do a lot throughout the year to keep our communities healthy, from creating jobs to supporting local charities and civic groups.

I know it's hard to resist the post-Thanksgiving doorbusters and discounts at the chain stores, but I hope you'll shop small on Saturday, Nov. 30. Small business is the heart of Texas's economy. When we help small business, we help everyone.
