New judge oversees commissioners court agenda of grants, financials, and upgrades

In new county judge Marty Lucke's first session presiding over the Floyd County Commissioners, the court dealt with annual reports from county offices, a year-end review of finances, updates on grants, the recurring agenda items of improving courthouse internet, computers and hot water and a proposal for a new grant which caused one county commissioner to recuse himself from the vote.

Floydada Economic Development Corporation Executive Director Sean Overeynder and Elena Quintanilla, South Plains Association of Governments Regional Services Director, presented a Texas Capital Fund application proposal to the court for \$100,000 for Floyd County Supply.

The project, which has no liability for the county, comes from funds from Texas Department of Agriculture. TDA, however, does not allow individual applications. All applications must come from city or county entities. Floyd County Supply is owned by Precinct 2 commissioner, Lindan Morris, and he recused himself from the court for the vote, but made himself available for questions from commissioners.

Morris said he has plans to convert Floyd County Supply to a modern, state-of-art convenience store in Floydada that would be comparable to one that you would find in any city. He said his company had market research that showed that a demand existed for such a facility in Floydada. He said he planned to use the funds from TDA to rehabilitate his business and hire employees.

Quintanilla said that SPAG would be the administrator of the grant.

The court unanimously approved submitting the Texas Capital Fund application.

Rick Knapp, from Knapp and Company, PC, Dallas, a firm which has been handling the county's audit since 2009 reported on the year-end financial review for the

Knapp noted that this year's financial report is improved year-over-year. He said property taxes are up due to expansion in the wind and energy transmission sectors. He noted that the county is up \$211,000 in

Petersburg farmer Ronnie Hopper and his son, R.N. Hopper, are among recipients of the 2015 Farm Press-Cotton Foundation High Cotton Awards.

The Hoppers were honored at a breakfast last week at the Beltwide Cotton Conference in San Antonio, coordinated by the National Cotton Council.

Father Ronnie and son R.N. Hopper of Petersburg, Texas accepted the award from Southwest Farm Press. The Hoppers the farm operation.

Floyd County Historical Museum "Memories, 1979"

THE E.M. (DOCK) WALLINGS

E. M. Walling lived at Walnut Springs, Bosque County, Texas. The land was rocky and poor for farming. He and his son, Jay, heard of the good grass and plenty of water and came to Floyd County and bought land from E. P. Morey, August 5,1891, southeast of Floydada. When school was out in 1892, E. M. moved his family to Floyd County, to a three-room dugout and one room house.

In 1893 he hauled lumber from Amarillo, Texas to build his home. This was welcome after living for three months on a trip west in wagons, one being pulled by oxen owned by a brother in law. Bud Grantham, who helped them move. The small children rode in the wagons and the older ones rode horses and helped drive me stock.

After a few years E. M. moved his family to Floydada where they ran a hotel. Many business people ate lunch with them and they had several boarders. This was the Harkey Hotel, bought by E. M. in 1898. Some of the boarders were Billy Montgomery who worked at the courthouse, Raleigh Scott, a druggist and Will Massie, a real estate dealer. One day E. M. and son Kay went hunting and brought in a prairie dog and an owl, asking Annice to cook them. She said she would cook the dog but not the owl. All the boarders said the prairie

dog was delicious. A little while after lunch the youngest boy became ill. Mr. Massie asked Floyd T, "What is wrong?" and Floyd T. said, "I must have ate too much of that damn dog." Mr. Massie has told this story many times.

As the brakes were full of wild animals and this is where they got their fire wood, they saw many panthers, and another son was trapped on the wagon by a panther while older brothers gathered wood. One time Kay killed a bear and Annice also cooked it, which was also good.

E. M. bought lots where the Lockney High School now stands and built his home there. He was asked to help when people were sick, and many said they owed their life to him. He lost his wife

E. M. and Annice's children were Kay, Jay, Donnie, Letha, Daisy, Sally, Earl, Charley, Jeff and Floyd T. In later years E. M. married Mollie Winn Holden, who had a daughter Lois, and in 1909 E. M.'s last child was born, Willie Wanda.

E. M. sold real estate, did trading, and became a good veterinary. While he was treating a horse one time the horse fell on him which cost him his life. This was 1919. All of his family are buried in the Floydada Cemetery except one daughter. Sally McDonald, who lives in Plainview, Hale County, Texas at this

The thing that makes were initiated by Farm Press it work, they say, is crop rotation. "The success of notill cotton relies on rotation," Ronnie says.

> R.N. notes, "We started converting to no-till production in the summer of 2006, and we became fully no-till about 2008. There have been only a few exceptions when we had to work new farms to level fields or take out beds."

> Technology, including herbicide-resistant crops, improvements in planting and spray equipment, and

to plant no-till cotton," he savs.

The result has been significant conservation and improved soil, both contributing to better yields. Their success in improving efficiency and their commitment to creating a more sustainable production system were among the factors leading to the Hoppers being selected for the 2015 Cotton Foundations/Farm Press High Cotton Award for the Southwest region.

Hopper knows the issues of water well. He also serves as an elected member of the board of directors of the High Plains Water District board and his jurisdiction includes Floyd County.

The Hoppers represented the Southwest in the High Cotton selection. Other High Cotton recipients were Rick Morgan, Corapeake, North Carolina, representing the Southeast; George LaCour, Morganza, Louisiana, representing the Mid-South and Mark Watte, Tulare, California, better varieties "allowed us representing the Far-West.

including revenues, depreciation, over the prior year. In last year's report the county showed a deficit.

He noted that the county still had issues. The employee retirement programs are still underfunded, even though the county made a one-time payment of \$50,000 toward the program.

He noted that the county had made improvements in reconciliation procedures, but work was still needed to be done. The audit found unrecorded transactions that had to be corrected.

In other court action commissioners heard from county clerk Ginger Morgan and Tax Assessor Collector Delia Suarez about the need for new computers. Both offices are on Windows XP, which cannot be upgraded. The court recommended

that they bring bids to the next meeting.

SPC to offer Concealed Handgun class on Jan. 17

LEVELLAND - South Plains College will offer a Texas Concealed Handgun License class on Jan. 17 (Saturday) in the Law Enforcement Technology building on the Levelland campus. The class will begin at 8 a.m. with breaks every hour as well as a lunch break.

The classroom portion will cover firearm safety, the use of force, non-violent conflict resolution, lawful weapon carry, storage with children in the home and contacts with law enforcement personnel. It runs about five hours.

The range portion covers range safety rules and commands, and the shooting portion of the class at distances ranging from three to 15 yards. The number of students will determine how long the range portion requires. Inexperienced shooters might want to take the N.R.A. Basic Pistol

course before taking the C.H.L. course.

Students will need to bring either a revolver or semiautomatic pistol of at least .32 caliber and 50 rounds of ammunition to match. Eye and hearing protection are provided for students who do not have

The cost of the course is \$70 for students getting their first license, and \$25 for students wanting a refresher course before renewing their license. Although renewals now are handled strictly online, the 15 or more changes in Texas firearms law in 2013 make a refresher course a good investment. Students need to register and pay in advance. Space is limited.



World News Update: Terror in Paris

On Wednesday, January 7, 2015 at approximately 11 o'clock, three men armed with AK-47s raided the building of a weekly publication called Charlie Hebdo in the city of Paris, France leaving 12 people dead and 11 people injured.

Charlie Hebdo is a section of the newspaper that consists of rousing cartoon images of politics, pop culture, and religion. There was not a verification of a motive, but they believe that the purpose of this horrifying manslaughter was a publication of cartoons in the Charlie Hebdo section of the Muslim Prophet Muhammad.

After the numerous murders, officials released the names of the three killers: brothers, Saïd and Cherif Kouchi, both in their 30s, and Hamyd Mourad, at 18 years old. Hamyd Mourad later that day turned himself into the police saying he was forced to carry out the shooting.

On the next day, Thursday January 8, 2015, police discovered that there were two other accomplices along with the Kouchi brothers named Amedy Coulibaly and Hayat Boumeddiene. Infiltrating a local Jewish supermarket, Coulibaly armed with two Kalashnikov assault rifles, held at least 15 people hostage. Four shoppers by the names of Yoav Hattab, Philippe Braham, Yohan Cohen and François-Michel Saada were shot dead on site.


Police shot and killed Coulibaly at the supermarket just after he shot the four hostages. Almost simultaneously, police then shot Chérif and Saïd Kouachi for the liability of the 12 deaths that included two police officers on Wednesday, January 7, 2015. After all the tragedy, and three gunman dead, Boumeddiene, Amedy Coulibaly's girlfriend is still on the run. It was reported that she recently crossed into Syria on January 8, 2015. Stationed around the outskirts of Paris, about 1,500 troops are hunting down Boumeddiene while keeping Paris safe for precautionary measures.

Forty years after it opened in 1975, the American Cotton Growers Denim Mill in Littlefield has ceased operation.

The plant, which was Littlefield's and Lamb County's single largest private employer, went silent Tuesday.

In early November 2014, the company announced that it would shutter the plant in 60 days due to industry pressure and foreign competition.

When it closed Tuesday its workforce was 340 employees, which is down from a normal staff of more than 600.

In reaction to the carried the nickname of

closure, the South Plains Workforce Commission organized a job fair in Littlefield on Wednesday, drawing more than 30 businesses from throughout the region in an effort to recruit employees from among the mill's displaced

"There is a lot of unanswered questions that we have," Littlefield City Manager Mike Arismendez told area news media earlier this week, "but this community has rallied together, continued to be steadfast, and continued to work forward. And we will get there, and we will have the opportunities that we need to open up the plant again. So we are resilient, and we will bounce back."






