# Civilians Are Urged To Support United **Welfare Fund Drive**

Emphasis in the United Welfare Fund campaign on the base shifted this week to civilian employees, as it was found contributions from these workers were well below

As of Wednesday noon, 41.31 ercent of all base n ersonnel had contributed a day's pay, with military showing 49.14 percent and civilians 29.82 percent.

Records showed that one organization, the 3501st Periodic Maintenance squadron, had contributions and/or pledges of 91.13 percent of a day's pay from military personnel. This led the base for military personnel, but the 27.8 percent of contributions and pledgganizing and es from civilians put the squadron in third place, instead of first.

Showing contributions and pledges from military personnel over 70 percent were the 3500th Motor Vehicle squadron with 79.08 percent, 3505th Field Maintenance squadron, 76.44 percent, and 3502nd Flight Line Maintenance squadron, 71.12 percent.

When a serviceman commits a crime in the United States he brings dishonor on his Service. When he commits a crime outside United States territory he brings dishonor on the United States of

He deals a damaging blow to himself, his family, his Service, the U. S. Armed Forces as a whole, and his country.

It is not unnatural that people in other lands are unusually angered when allied servicemen commit crimes against them. If foreign troops were stationed in our home towns and committed crimes against Americans we would be just as incensed.

Under these conditions, punishment for such crimes is not likely to be light. In many cases, under current rulings, the accused may be tried by the foreign country — not by United States courts.

A recent U. S. Court of Appeals ruling indicates that a foreign country has a right to try U. S. military personnel for crimes committed in the foreign land. The Court held that the United States has jurisdiction over military personnel stationed in a foreign country only when that country has agreed to give that jurisdiction to the United

But no matter by whom the accused is tried—and no matter what is the finding of the court—an incident has brought some degree of dishonor to the United States. It has weakened, somewhat, the overall strength of the Nation we are sworn to defend.

# Education — More Than In Classrooms

Not many years ago, "education" was thought of primarily as teaching and learning in the classroom. Now the term has broadened to include learning in many kinds of situations-both for adults and children—on the job, and in the home.

Libraries along with schools have always been a basic means of education in this country. On the other hand our civilian neighbors, the citizens of Lubbock, are taking care of the needs of the military. For example, the Community Chest provides \$7,000 per year to maintain the Lubbock Service Organization. The Lubbock Chapter of the American Red Cross not PROTESTANT: only makes loans and grants to the military but provides home service to dependents and assists in obtaining emergency leaves. Where government hospitalization is not available for polio victims, the National Foundation comes to the rescue.

There can be no question of the interdependence of our personnel-military and civilian. Just under the uniform we have the same physical bodies, all subject to the same fates of hard luck. When contacted for your 1/365th of your pay, contribute cheerfully for a gift otherwise is not acceptable.

## MISSOURI

Any qualified person who may be absent on election day may vote by absentee ballot.

Members of the Armed Forces may send a Federal Post Card application to the Clerk of the County Court or Board of Election Commissiners, county of residence, any time before the election. However, it is recommended that such application be made before Sept. 7. Marked ballots must reach officials by 6 p.m., Nov. 7.

Other voters must send for an "Application for Absentee Ballot" from one of the above offices. This form, when completed, can be sent in as early as Oct. 7, the day on which officials start mailing bal-

All marked ballots must be in by 6 p.m., Nov. 7.

## RHODE ISLAND

Members of the Armed Forces, civilians officially attached to units of the Armed Forces, their spouses and dependents may send Federal Post Card applications to the Secretary of State, Providence, any time before Nov. 6. Ballots will be sent starting about Oct. 17, and must be returned—complete with the prescribed oath—not later than Dec. 4.

Any qualified voter who will not be present for voting may use an absentee ballot.

Members of the Armed Forces and overseas employes of the government and their wives may send Federal Post Card applications to their County Court Clerk any time before Ovt. 27.

Other voters should obtain an 'Applicatoin for Absentee Voters' Ballot" and return it to their Couney Court Clerk before Oct. 27.




