# **Mini Bull Riding featured at PBR Built Ford Tough Series**

Since their first event in Amarillo at the Cowboy Church in 2011, Jr. and Lillie Leal started their travels all over the United States building the hard-core sport of mini bull riding.

The Leals have been very fortunate since the beginning of their adventure with mini bulls. But partnering with professional bull riding (PBR) all-star Chris Shivers, 2-time PBR World Champion Bull Rider and PBR 90-Point Club Champion, was a history altering move in their careers. With gaining momentum and tours on the rise, it was only a matter of time that mini bull riding took that next step up.

On March 2, Cowboys Stadium in Arlington, Texas will showcase MBR in the PBR Fan Zone in the Dickies Iron Cowboy IV in the Built Ford Tough Series.



# **High School Student of the Month**



**One Sale Closer to Florida**

Did you know that Charles Richard Drew is the African-American doctor responsible for life saving blood banks in the world today? His involvement in Red Cross and in Great Britain during World War II saved millions of lives and it continues to save lives today.

**Did You Know?** 

Charles Drew began his life in Washington D.C. with his father and mother. He soon went on to display incredible athletic talent, which sent him to Amherst College on a sports scholarship. Two years after graduating Amherst he was accepted into McGill University in Canada where he began studying for a medical degree away from prejudice treatment. His studies quickly proved him to be an excellent doctor regarding blood transfusions and he returned to the United States as a professor at Howard University and a doctor at Freedmen's Hospital. During World War II, Drew accomplished a discovery that would lead to his ultimate success. Plasma could be dried and stored in "banks," then later reconstituted for use. This not only maximized blood available to injured patients, but it also allowed it to be stored longer. Drew was placed at the top of the medical world because of this finding. He was invited to Britain to establish a blood bank there and came back to America to help the Red Cross set up more banks. In 1941, he resigned from the Red Cross because of racist policies regarding the mix of white and African American blood. Although he faced prejudice views during his life, he was able to collect roughly 14,500 pints of plasma for use in his blood banks and made a huge difference to the world during his lifetime. His accomplishments forever changed the medical field, and his work continues to save lives today.

Flying Saucers — — — -? **PATH THROUGH CANYON TREES UNEXPLAINED 1958** 

**Floyd County Hesperian 100th year edition** 

May 23,1996 What was IT? That question filled the minds of county and area residents in late 1958 and early 1959.

"The reports of the strange lights that played around the rim of Blanco Canyon

at the TM Bar Ranch on the morning of November 21,1958 and the weird object and silently over the yon in the same early morning hours, still have local people by the ears," slated an article in the February 12,1959 Hesperian is-

sue. "Speculation on what "it" was, how "it" got there and by what power "it" may have been propelled is still going the rounds."

The Hesperian got into the spirit of the thing, and reporter -photographer Kenneth Rimmer spent a couple of hours prowling around in

the canyon between the TM Bar Headquarters where the Q. D. Williams family live and the J.S. Hale place across the canyon on the hill southwest from them. Rimmer produced photos as "added evidence that something strange occurred. At least they are evidence that some mighty force was at work sometime recently in Blanco Canyon."

In his article, Rimmer stated

he told the Air Force officers that the "light" or whatever it was traveled at an estimated rate of 2,000 miles per hour from the "hill" where it was first sighted past a check point to the southwest.

The Williamses awakened the Roy Fawvers and the J. S. Hale families the morning of the strange occurrence.

Fawver got into his pickup and "made a run" for the point where the strange



object was seen. When he arrived, "it took off west at rapid speed, just as though the object knew someone was coming too close."

Hale, who "prodded around" in the canyon with Rimmer on his January visit, gave an angle the newsman had not heard previously.

"Not only did the 'lights." Or 'space ship' or whatever Note the big trees' trunks where the cotton wood giants lie bowled over, and the 'swath' cut clearly visible, through the tree in the upper picture.

"Hale was the first to see the pattern of the swath cut through the trees.. The autumn was one of remarkable little wind, and it is doubtful that the trees were bowled over by an act of nature.

"When J.S. first saw the fallen trees and

the path cut through the big limbs he noted that the breaks were fresh. He confidently expected to find a plane a few hundred yards up the creek from the scene.

"It ap peared that a low flying bomber 01 some such had cut too close to the ground and had sheared off the big tree growth. However, there was no plane wreckage anywhere near the scene

and no report of a missing plane from any nearby (air) fields.

"Could the strange visitor have cut the path through the valley of the canyon? How could it have happened?"

"It seems quite apparent that a thing like that could not have happened but there if the evidence that something did happen. Like the



#### 8, 2013- Agriculture Secretary Tom Vilsack today reminded Hispanic and women farmers and ranchers who allege discrimination by the USDA in past decades that there are 45 days remaining in the filing period closing March 25, 2013.

"Hispanic and women farmers who believe they have faced discriminatory practices in the past from the USDA have 45 days left to file a claim in order to have a chance to receive a cash payment or loan forgiveness," said Secretary Vilsack. "USDA urges potential claimants to contact the Claims Administrator for information and mail their claim packages on or before March 25, 2013."

The process offers a voluntary alternative to litigation for each Hispanic or female farmer and rancher who can prove that USDA denied his or her application for loan or loan servicing assistance for discriminatory reasons for certain time periods between 1981 and 2000. As announced in February 2011, the voluntary claims process will make available at least

and tax relief payments, plus up to \$160 million in farm debt relief, to eligible Hispanic and women farmers and ranchers. There are no filing fees to participate in the program.

The Department will continue reaching out to potential Hispanic and female claimants around the country to get the word out to individuals who may be eligible for this program so they have the opportunity to participate.

Independent legal services companies will administer the claims process and adjudicate the claims. Although there are no filing fees to participate and a lawyer is not required to participate in the claims process, persons seeking legal advice may contact a lawyer or other legal services provider.

Under Secretary Vilsack's leadership, USDA has instituted a comprehensive plan to strengthen the Department as a model service provider and to ensure that every farmer and rancher is treated equally and fairly as part of "a new era of civil rights" at USDA. In February 2010, the Secretary announced the Pigford II settlement with African American farmers, and in October 2010, he announced the Keepseagle settlement with Native American farmers. Both of those settlements have since received court approval. Unlike the cases brought by African American and Native American farmers,

women farmers over a decade ago were not certified as class actions. The claims process provides a voluntary alternative to continuing litigation for Hispanic and female farmers and ranchers who want to use it.

In 2012 our last confirmed rabies case was a skunk that was collected in Potter Co. on 7/15/12. Our Region did not have another reported case until today, when a skunk collected in Lubbock on 2/4/13 was reported by the lab as positive. The rabies-less period lasted 204 days from the date of incident in our last case in 2012 until the incident date for the first case in 2013. All good thingsmust come to an end.

I do not expect an active year in 2013, but I am always subject to being surprised. The apparently decreased skunk population and drought in 2012 should have reduced the number of animals in the reservoir, but time will tell the true story.

Please remind clients to be sure their pet vaccinations are up to date and that horses and show stock should be vaccinated against rabies.

The Lockney City Council met on Thursday, February 14, to consider and take action on advertising for the hiring of a water/street full-time employee. It was decided that the Council can't advertise at this point because they don't know what the job description is at this point. A motion was make to advertise for a full time employee for the City of Lockney after Councilman Shad Schlueter develops a job description, which passed unanimously.

Businessman Greg Hallett, from Platinum Supplemental Insurance, asked for a permanent soliciting permit for door-to-door sales for supplemental insurance. He was in Lockney previously two years ago. According to Hallett, they are almost done with Floyd County, but will be here a couple weeks longer. He stated that he is willing to go by what the City Council recommends. Attorney Lanny Voss stated that state law doesn't allow the City to enter into an agreement permanently. A permit was issued for Monday through Thursday from 9am-7pm for one year. A copy of Platinum Supplemental Insurance's insurance will be on file at the City Hall

Abel Luna reported that the City needs to make a trip to Lubbock to get Hot Mix to patch the hole on Locust Street where a leak was fixed. Meanwhile, something will be placed on the street to barricade it so the hole isn't driven over. State notice is being given that it needs to be fixed. The Council also talked about another site that needs to be fixed by the football field. There is reportedly water standing by the concession stand.

Voss requested that the farm lease on hand be sent to him for review and for updating.

A generator needs to be hooked up in case there is a power outage. Bids from A1 Electric in Lubbock and Dart Carthel are on file.

Voss reiterated that bid practices need to be adhered to.

"We have to either get bids according to the specs or not accept it. If we are going to solicit estimates we need everything to be on the same playing field and under the same criteria," said Voss.

City Secretary Charlotte Hooten informed the Council that they are announcing bids for financial advisor, bond council, and engineer for Water Well Grant. Specs are available at City Hall, 218 W. Locust

In EDC news, Councilman Bil Anderson presented research done on a new marquis for the City. He found some in the \$7,000-12,000 range as op-

#### posed to \$72,000 like Ralls has.

Two bids have been received and they plan on putting the marquis on the lot where the Wall of Pride is.

In a review of the financial statements, it was reported that the City is sitting on \$600,000.

The Council agreed to buy the Pipehunter Sewer machine out of the equipment fund for \$47,000 under the condition that they get the used machine from the contractor until the new one arrives. It was agreed to table the issue of accepting the Verizon or AT&T's bid for the purchase of 3 iphones for city employees until the next meeting. The iphones could be used by City employees to monitor the wells by the touch of a phone.

The Council agreed to allow AMEC, an agency that TCEQ contracts out, to set up a new monitoring well at SW 3rd and Poplar Street. Residents on each of the corners at the intersection of SW 3rd and Poplar Street will be informed that it will occur.

Juan Gutierrez wants to present concrete numbers to the counsel on how much it would cost to repair it. Schlueter proposed that he be allowed to come into the March meeting and present his Plan of Rehabilitation. If obligations are not met or they follow the timeline, then they are in a binding contract stating that the building will be torn down.
