## Mother walks for her son, for Autism cure

An estimated 3,000 people attended the 2013 Burkhart Walk for Autism Awareness at Jones AT&T Stadium on April 28. Among the many walkers were the five family members and friends that made up Kaleb's Krew, from Floydada, who walked for their friend Kaleb who is diagnosed with a severe form of Autism.

This is the seventh or eighth year that Kaleb's mother Darolyn Snell has walked for her son in Lubbock. According to Snell, the walk originally began at Willie McCool Field, but soon required a larger location with the rise in participation.

"This year it was hot—we did around a mile

(5 laps)," said Snell. "We enjoyed the comradery of it and the company of other people dealing with it, too."

There were many fun diversions at the walk for kids as well. According to Snell there were information booths there offering different services from hippotherapy (horse therapy), personal therapy, and child I.D. kits (which she has for bother her boys). Kids and adults had a chance to take their picture with Texas Tech's Masked Rider and bouncers were set up for endless entertainment.

Usually Kaleb's Krew has t-shirts made up for the walk, but didn't this year due to the small size of the group. They ended up wearing last year's shirts that are red and black with "Burkhart Walk for Awareness" on the front and "Kaleb's Krew" on the back.

"People don't realize how wide the spectrum is," said Snell. "Some people with mild forms can go their whole lives and most people won't even know they have it...others are so severe they cannot function in a normal capacity even as adults."

Lowe's, Ace Hardware, Nielson's and Floydada Senior Citizens all contributed by allowing Snell to set out donation cans at their businesses. Kaleb's Krew managed to raise almost \$400, which was a feat since they had less than a week to do it.

"I walk in hopes of them finding treatment, if not a cure, and to honor my little boy," said Snell. "The focus needs to be on Autism, otherwise there will never be a cure."

The Floydada Independent School District held its Board of Trustees election on Saturday, May 11 at the Floydada Independent School District Superintendents Office

Running for the At-large seat was incumbent Marty Lucke and Manuel Mendez. The election ended with Lucke receiving 230 votes to Mendez's 64.

The election between Kay Brotherton and Clay Lowrance for District 5 ended in a close vote, with Brotherton emerging with 32 votes to Lowrance's 29.

District 4 will be filled by John Woelfel who ran unopposed and received 26 votes.

# LaBaume achieves lifelong dream

Fifty-one years ago, Sam Houston State Teachers College senior Jon J. LaBaume was looking forward to his graduation. He would take his final class during the first summer session, then return in August to formally gradu-

However, his dream of walking across the stage to receive his diploma never took place. But his dream will finally come true Saturday morning when LaBaume will be among the Sam Houston State University students who will formally have their degrees conferred during commencement ceremonies for the College of Sciences and the College of Fine Arts and Mass Communication.

LaBaume was a first-generation college student from Dublin, a small town in Central Texas, and the first in his family to earn a degree. Everything was going as planned for the agriculture major in the summer of 1962—he completed his final class, bought his class ring and his yearbook, ordered invitations for his commencement ceremony, and took a temporary job in Austin with the Cotton Division of the United States Department of Agriculture

until something permanent came along.

When he asked his supervisor for the day off to attend his graduation ceremony, he was told, "I guess since you're a college graduate, you think you know everything. If you want to take the day off, that's fine. But you're a temporary employee, and you won't have a job when you get back."

LaBaume said he had no choice.

"Instead of missing work and losing

"Instead of missing work and losing my job, I missed my graduation," he said.

Not long afterwards, LaBaume took a full-time job with the USDA in the Soil Conservation Service, which has since become the Natural Resources Conservation Service. He was employed to work in the Texas Panhandle town of Silverton as a conservationist by the USDA in 1963 and retired as an NRCS district conservationist in Floydada in 1998.

He and his wife Elaine raised a daughter, Kelli (Childre), and a son, Coy. He returned to the SHSU campus once, in 1965, for the graduation of his sister, Jane LaBaume Truelove Bell.

As a student, LaBaume took classes in Old Main and at Country Campus and worked on campus in the meat lab. One of his memories includes being mistaken for a prison inmate



#### Lockney City Council awards bid to Quallis

Quallis Construction out of Lubbock was awarded the bid for HOME Program #1001645 and 1001648 under the provision that each dwelling does not exceed \$80,000 at the April 25th Lockney City Council meeting. A motion was made to adopt a proclamation for April as Fair Housing Month for HOME both contracts.

The council also passed a resolution adopting Section 3 policy, which will provide job training, employment and contracting opportunities for Section 3 residents and Section 3 businesses of the areas in which the project is being carried out. A resolution was also adopted establishing a Section 3 policy for HOME Program from the Texas Department of Housing and Community Affairs.

The Fair Housing/Equal Opportunity/Section 504 Standards as required by the Texas Department of Housing and Community Affairs Program naming Mayor Roger Stapp as the designee.

A time limit was set for the revamping of Aposento Alto Pentecostal Church on SE 2nd Street. A request was made March 21 wanting 6 months, and the council agreed that a letter be sent to them stating that it be habitable and safe by September 30, 2013, with everything up to code and approved by the City.

All discussions concerning the Golf Cart Ordinance were tabled until the next meeting.

In the report on the streets presented to council, it was learned that requests were made by the public, sent through council members, for the City of Lockney

to repair some of the streets with holes in their surfaces. Charlotte Hooten claimed that money had been set aside to purchase equipment to fix the streets or for hiring someone to do it.

Sheriff Paul Raissez gave his report, stating that he had been going around town looking at semi trucks that are parked within the city limits and calling the owners to have them moved. According to Hooten, anything south of Sherbert Street (by Attebury) is ok to park at. According to the council, these trucks within the city limits are causing street damage. The current ordinance states that trucks cannot park within one hundred feet of a residence.

The Sheriff's department has hired two more employees that began May 6 to help patrol the streets. Because of the condition of the current city police car, Raissez is looking into a new police car/SUV through SmartBuy.

The council appointed Ed Marks to the Mackenzie Municipal Water Authority Board for a two-year term effective May 1,

The City's generator will be hooked up soon due to tornado season's approach. According to City Secretary Hooten, letters will be mailed out to city customers to update phone numbers, emails, and cell phone numbers for the emergency contact system.

A motion was made to cancel the local election which passed unanimously.







The next Doctor I remember using over the next few years was Dr. Von Andrews. He was a good doctor and I remember him to be a good and honest man. As I remember all the doctors that I shall name were good, honest, very dedicated to their profession, and very unselfish. Our family did not use all that I shall name as people did not run to the doctor as much as we do now, and Floyd County had more doctors with what population we had.

The next two doctors that I remember were the Smith brothers, who had a hospital together. I think at one time they owned the building that Doctor Guthrie had when he retired. Dr. Lon Smith was primarily a surgeon. He liked to talk with patients and would say most anything in reason that came across his mind.

He performed as many appendicitis operations as I remember hearing about in Floydada. He also received many patients from out of town. As we might notice many ailments might seem to go in bunches of clusters. That period of time seemed to be the appendicitis time. We now seem to have more heart trouble, strokes and cancer then we seemed to have had since World War II. I am not a doctor and these past statements are simply my opinion.

Dr. George was a general practice physician and a very good one. He was well versed in medicine practice, for that day in time. I would consider Dr. George also a very good physiologist in dealing with his patients or anyone else that he had conversations with.

He told us one time that He said it was alright to work hard but we should take time to rest an relax and we wouldn't have so much heart trouble and strokes. As he got too old to practice medicine he was still very interesting and informative to talk to.

There were two more doctors we never went to see but other people said they were fine doctors and of very good character. One was Dr. Rhinehart, who didn't live in Floydada very long, and the other was Dr. Hopkins.

I heard nothing but good about Dr. Hopkins. He and Mrs. Hopkins' daughter Aline Henry still lives here. She was the prettiest girl I ever remember knowing and talking to.

In those times there were some doctors that had the name of comers and goers. I can thing of only two that I liked their service. They were in later years. One was Dr. Ballard and the other was Dr. Crum. You also remember others and have your preference, that is your privilege and right to see as you will. m the past fifty years my wife selected Dr. Guthrie to be in attendance at

our oldest son's birth. That suited me just fine. One reason that she selected him was that her family had Dr. Guthrie's papa years before, when both the Germany and the elder Guthrie lived in Petersburg.

Dr. Donald Pitts was working together with Guthrie when all our children were bom. We were well pleased with Dr. Guthrie and received our medical service from him for several years. We had three children, Jesse's birth was \$50.00; Carolyn's birth was \$60.00 and Bobby's birth was \$90.00. Anyone can see what inflation has had on the cost of living for several

My oldest sister and three of her children, my brother, baby sister, mama and myself were at home with the flu in the late fall of 1918. We had made a poor, cheap crop that year and papa and brotherin-law, George had taken a covered wagon and went over near the north field brakes to trap for coons, coyotes, badger and other fur bearing animals. They would skin what they caught, dry the hides and sell them at the fur market as they came home at Matador.

We had poor over worked Dr. Houghton to come and see what he could do for our flu family. He struggled to our place through the snow. My sister Mary had the pneumonia but he saved her life. Doctor Houghton was a great believer in carbolic acid to kill germs along with the other things used. I say he saved all our lives when we were sick. Mama and the baby seemed to be immune to flu. I heard of several other people who seemed to be immune.

Bro. Henry was sick and the world was going to fast. was not able to see after the livestock. So mama let the horses and cows both have run of the feed stacks so they could get plenty to eat. She turned the cows and calves together and all the milking she did each day was mild enough for the baby.

My sister was too sick to give milk for the baby and we didn't have money to send for commercial milk by what a few neighbors, had the nerve to come to the door to ask if they could get something for us from town. Most people were deathly afraid to go into any one's house where the flu was. Many died and it was hard to get anyone to help bury the dead. The courthouse and other places served as hospitals.

Dr. Houghton warned mama to wrap tow sacks around her feet an not catch cold when she had to go out in the snow. Doctor Houghton lived several more years and made us a very good doctor until he died.

We have three very good doctors at the present time. Doctor Lopez is our surgeon and a very good one. He performed two cases of minor surgery on me and I am very well pleased. Dr. Lopez is a very pleasant man. He is one who is unselfish and highly dedicated to his work.

Doctor Hale is one that I don't know very well personally. I am pretty well acquainted with several of his older kin folk. They are all nice people in my estimation. Doctor Hale is sure to be tops coming from both his papas's inheritance and also from his mother's people. I haven't heard anything but good form the people that know him professionally. I am sure that if I need the service of a general doctor and Doctor Jordan is out of pocket that Doctor Hale's office is where

HOME Contract #1001754 - RSP #2011-0113. Floydada has determined that this project will be tiered. All of the project addresses are not known. A tiered project allows the analysis to be completed on a geographic area to address environmental impacts that might occur, or not occur, on a typical site within the area. The broad review of the geographical area will make it so the compliance factors listed will not have to be repeated on a site specific basis, once eligible individuals or families are known. No construction work will begin until all levels of this tiered review are completed.

Total HOME Contract Award: if funding becomes available, the maximum amount per home for rehabilitation will be \$30,000 and the maximum amount for reconstruction will be \$80,000. Project Locations will be within Floydada Corporate limits.

Commentors should specify which part of this Notice they are addressing.

#### **RELEASE OF FUNDS**

The City of Floydada certifies to TDHCA that Gary Brown in his capacity as City Manager to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to Texas Department of Housing and Community Affairs at 221 East 11th Street, Austin, TX 78701. Potential objectors should contact TDHCA at (512) 936-0934 to verify the actual last day of the objection period.







Graduation is just around the corner, and there will be many well-deserved celebrations. But before your graduate celebrates, parents need to take the time to talk with their teens about alcohol. Doing so may save a life and prevent injuries.

To save lives, the minimum legal drinking age is set at 21. The teen brain is still developing and is very sensitive to alcohol. Alcohol can be tricky because it affects judgment and decision making, which are two things critical to making the right choices.

Alcohol not only affects a teen's decision making; it also affects their inhibitions and physical control. Teens think they are invincible, and they often take risks that mature adults would not. Dangers associated with teen drinking include car crashes, falls, drowning, fights, and sexual risks. While they may tempo-

rarily feel elated and happy, alcohol is a depressant. High school graduates should celebrate their accomplishments. ## **USDA** Announces Farm Payments Scheduled to Resume

WASHINGTON, May 8, 2013 — The U.S. Department of Agriculture's Farm Service Agency (FSA) Administrator Juan M. Garcia announced today that farm payments, which had been temporarily suspended due to sequestration, are scheduled to resume today, May 8. This includes payments for the 2011 Supplemental Revenue Assistance Payments Program (SURE), the Noninsured Crop Assistance Program (NAP) and the Milk Income Loss Contract Program (MILC).

"I'm pleased to announce that farmers and ranchers can expect to begin receiving their payments beginning today, May 8,' said Garcia. "We appreciate the producers' patience during the delay. We're working diligently to get these payments out as quickly as possible.'

On March 4, 2013, FSA began a temporary suspension of FSA program payments in order to assess the impact of sequestration and determine the leastdisruptive process possible for carrying out required cuts. The Department will use the Secretary's limited authority to transfer funds to avoid reducing these program payments.

Producers should be advised that program sign-up periods currently underway have the following enrollment deadlines: 2013 Average Crop Revenue Election (ACRE) Program - June 3rd; 2011 SURE - June 7; and the 2013 Direct and Counter-Cyclical Program - August 2nd. Producers should contact their local Farm Service Agency office as soon as possible for appointments to enroll in these programs before the deadlines.

USDA has made a concerted effort to deliver results for the American people, even as USDA implements sequestration - the across-the-board budget reductions mandated under terms of the Budget Control Act. USDA has already undertaken historic efforts since 2009 to save more than \$828 million in taxpayer funds through targeted, common-sense budget reductions. 

## Rep. Springer passes first 3 bills

Hard to believe we are already in the month of May, we are truly closing in on the end of Session. In the past week, I passed my first three bills out of the House and got a number of other bills moving towards the

HB 697, which will tax-exempt booster clubs and other school support groups passed nearly unanimously in the House and has headed to the Senate where it will be carried by Sen. Robert Duncan (R -Lubbock). These groups exist only to benefit local schools and students, it is not right for the government to hackle them to get a few extra cents out of the sale of a Dr. Pepper.

Saturday was "gun day" at the Capitol. I passed HB 698 which will help citizens of rural Texas exercise their Second Amendment rights by creating flexibility with the digital finger printing requirement. Currently many are driving close to 100 miles to get their prints done to get their concealed handgun license (CHL). My bill will require DPS to develop rules to allow alternative methods of printing for citizens an approved facility.

Fletcher (R - Cypress) which allows for licensed CHL holders to carry on an institution of higher eduction passed the House Saturday, along with Rep. Toth's 'Fire Arms Protection Act'. I was proud to co-author both pieces of legislation, hopefully we can get them through the Senate and onto the Governor's desk in the coming weeks. The third bill I passed, HB 3896, is a local bill for Jack County that will serve as the enabling legislation for their hospital district. I also passed two more bills out of committee that will help local communities of House District 68. HB 2521 would allow Type B Economic Development Corporations to invest in more diversified housing infrastructure instead of just affordable housing projects. HB 2516 would allow for fines collected for a burn ban violation to remain in their county of origin to be used by local volunteer fire departments.



#### REQUEST FOR RELEASE OF FUNDS

On or about June 3, 2013, the City of Lockney will submit a request to the Texas Department of Housing and Community Affairs (TDHCA), for the release of HOME Investment Partnerships Program funds under Title II of the National Affordable Housing Act of 1990, as amended, to undertake a project for the purpose of the reconstruction/rehabilitation for 1-20 owner occupied single family homes if funding comes available in Lockney, Texas. HOME Contract #1001648 - RSP #2011-0052. Lockney has determined that this project will be tiered. All of the project addresses are not known. A tiered project allows the analysis to be completed on a geographic area to address environmental impacts that might occur, or not occur, on a typical site within the area. The broad review of the geographical area will make it so the compliance factors listed will not have to be repeated on a site specific basis, once eligible individuals or families are known. No construction work will begin until all levels of this tiered review are completed.

Total HOME Contract Award: if funding becomes available, the maximum amount per home for rehabilitation will be \$30,000 and the maximum amount for reconstruction will be \$80,000. Project Locations will be within Lockney Corporate limits.

#### FINDING OF NO SIGNIFICANT IMPACT

City of Lockney has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. All comments received by May 31, 2013 will be considered by Olton prior to authorizing submission of a request for release of funds. Commentors should specify which part of this Notice they are addressing.

#### **RELEASE OF FUNDS**

The City of Lockney certifies to TDHCA that Roger Stapp in his capacity as Mayor to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. TDHCA's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows Lockney to use Program funds.

Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to Texas Department of Housing and Community Affairs at 221 East 11th Street, Austin, TX 78701. Potential objectors should contact TDHCA at (512) 936-0934 to verify the actual last day of the objection period.

He has other fond memories of campus life as well-attending Tripod's funeral, watching a very successful Bearkat baseball team compete against much bigger schools, and attending football games at Pritchett

"That old rock stadium looks so small now,"he said. "When I was going to school, we thought it was huge."

He was also living on campus when Hurricane Carla struck the Texas coast.

"It was rough around here," he said. "I had never experienced the effects of a hurricane before. The rain washed a hole in the middle of the street near my dorm that was about 12 feet deep, 20 feet wide, and 30 feet long. That hurricane certainly left an impression on me," he said.

Although he moved far away from Huntsville to work and raise a family, he often thought about his alma mater. And he always regretted not getting to go through graduation ceremo-

"All the work and effort, being the first in my family to graduate from college, the time that I had spent working to pay for my education—I just always wished I could have participated in my graduation ceremony," LaBaume said.

"He loved his time at Sam Houston," Childre said. "The first new car that he bought was an orange and white pickup truck, and for years there was a picture of Old Main hanging in our house.
