Individuals make life changing trip

On May 20, an EF5 tornado (the most damaging possible classification on the Enhanced Fujita Scale) carved a path for 17 miles from west of Newcastle, Okla. through Moore, Okla., claiming 23 lives and injuring 377 people. The landscape appeared like a war zone, most recognizable landmarks missing and leaving houses stripped to their foundations.

In Floyd County, Facebook was lit up with conversation about the tragedy and the more it was discussed, the more Lockney citizens (and surrounding areas) felt that they wanted and could do something to help.

Quickly the Lockney Senior Citizens Center, Elementary School and Lowe's were set up with receptacles and became official drop-off locations for all the necessities that Moore residents would need to get back on their feet.

Resident Doty Jo Harrison posted on her Facebook, "I need an enclosed trailer, donations and a pickup!"

The interest was there with willing volunteers, they just needed a plan.

"It was an organized fiasco, no one was in charge of anything, but it got done," said Renee Armstrong, Director of Food Services at the Lockney Senior Citizens Center.

Armstrong heard that Dulaney was taking a load to Oklahoma and asked if Lockney's boxes could be included.

Other businesses across Plainview became one of many generous donors: Covenant Hospital, Lakeside, WalMart, United and Amigos, CVS, Family Dollar and Dollar General as well. The Coupon Cuties, of Plainview, a group of ladies organized by Sandra Dulakis, spent \$450 for priceless donations, only spending \$225 after their couponing magic. Many people, too many to name, in the area played a huge role in pulling this enormous task together and made a big difference.

On Friday, May 31, Andrea Bennett volunteered to help organize the goods that were delivered to Dulaney. Dulaney employee Cody Lindeman was waiting in the wings with Ron Flippin and Flippin's truck, ready to depart for Oklahoma at 5 a.m. the next morning.

When the truck left Plainview, it contained nine pallets of water (450 cases), six pallets worth of food and toiletries—a 52 foot trailer almost filled to the brim—with Lockney contributing 109 pounds of the goods.

"People in Moore were grateful for all the donations we delivered. While we were unloading, a truck from Indiana pulled up with their second

and I wanted us to do some kind of project that we could all do," said Moreno. "And it would involve getting out into the community and helping others."

Before Earth Day, Moreno showed his class a cartoon called Maya and Miguel which stressed the point of Earth Day not only on April 22, but every day.

"When we opened up this project to them they were willing and ready," said Moreno. "Any-

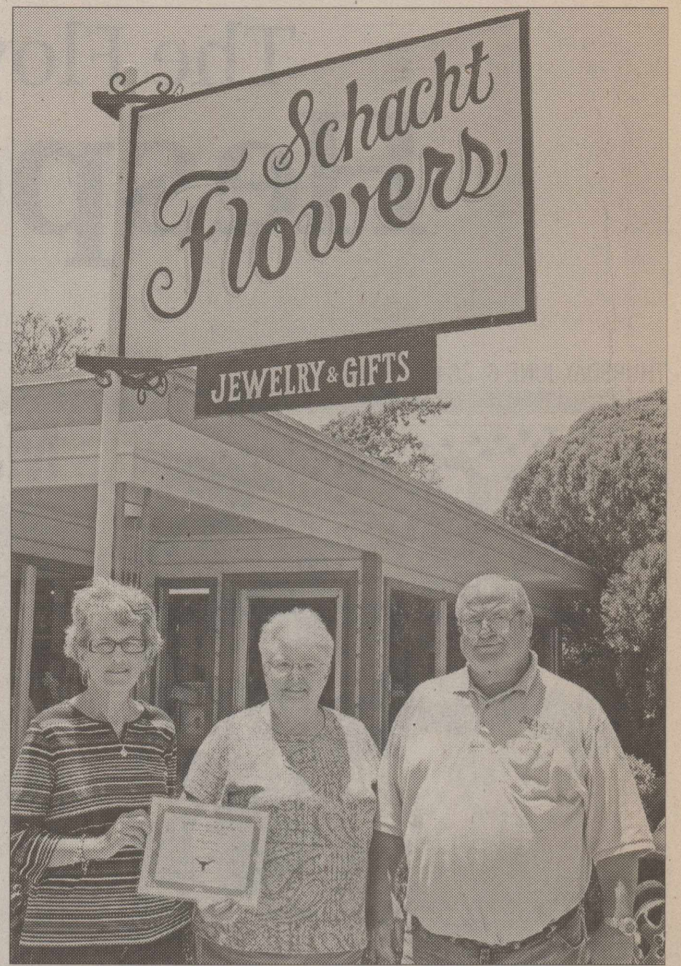

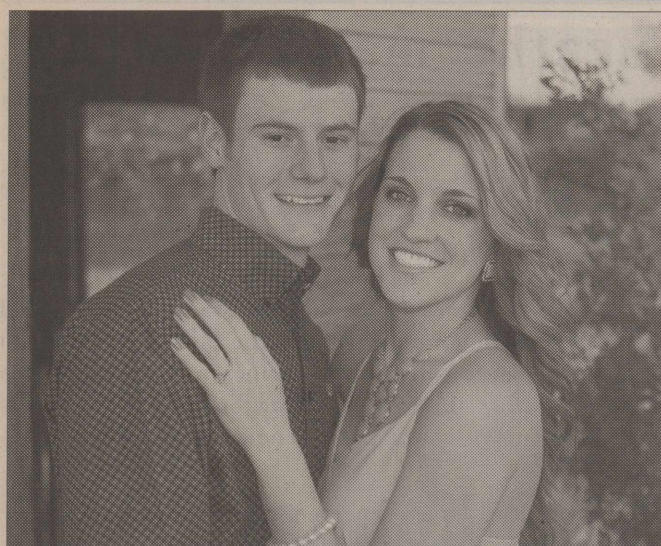

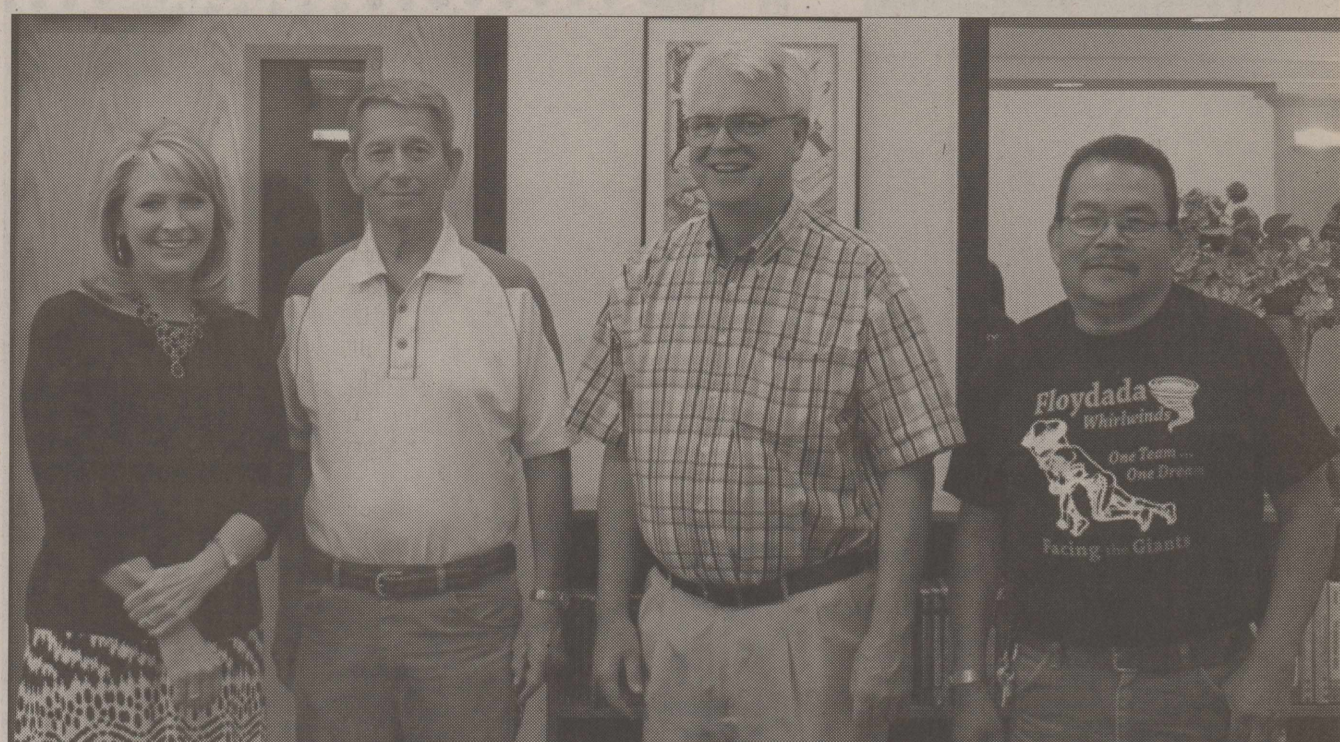
Miller and Pinkerton to marry

Mayshaw from "Memories" - 1979

Floyd County Historical Museum

A new town was started in 1892 by citizens of Floyd County and was christened Mayshaw in honor of Mrs. May Shaw, the wife of A. J. Shaw, one of the promoters of the new enterprise. The site chosen for Mayshaw was two miles west of Della Plain on a patented section owned by Shaw. After 1896 there were only a few dugouts to mark the sight of the defunct town.

After the supreme court had held that Floydada was the legally chosen county seat of Floyd County, many of the supporters of Della Plain regarded its cause as hopeless and turned their attention to a new town project, with the plea for harmony. The Citizen's Town company was organized and its stock capitalized at \$11,000, the value of each

share being \$5.00. At the head of this enterprise were A. J. Shaw of Galesburg, Illinois and A. F. Farmer, A. J. Sams and others of Floyd County.

The Mayshaw Zepher explained the cause of the town's existence as follows; Mayshaw was started by the citizens of Floyd County who, being tired of the ceaseless warfare being waged between the various towns of Floyd County, determined to build a town of their own and for this purpose held a mass meeting and elected a committee of seven persons who were to select a site.

The reasons given for selecting the Shaw site were "that this section was near the geographical center of the county, had a perfect land title, was almost the exact agricultural center of the county, had a splendid natural drainage, a magnificent view and last, it was known that plenty of water could be secured upon this section at a very small expense.

For a few months during the summer of 1892 Mayshaw seemed to prosper. A post office was established, a small public library was installed and some new business enterprises were projected, but came to naught. A few of the houses at Della Plain were removed to Mayshaw,

while others were moved to Briscoe County.

Town Declines

Colonel and Mrs. Shaw showed a paternal interest in the new town and encouraged the projected enterprises, but conditions were adverse to the town's growth, as a long continued drought and a grasshopper plague following in 1893. Vainly did the Mayshaw Zepher attempt to attract recruits to the town. Its editor, J. H. Dodson, was a candidate for county judge and during the first year of its existence this publication was sent free to the citizens of Floyd County. It inserted without cost classified reading notices and the marks and brands of stockmen. In 1893 Dodson moved to California, and the Zepher ceased to function until it was revised in 1894 by W. C. Hawkins. In the Spring of 1895 Hawkins discontinued the publication and succeeded J. F. Lockney as editor of the Floyd County Times at Floydada.

Among the leading spirits of Mayshaw, besides J. H. Dodson, the manager of the Citizen's Town Company, were I. R. Vorhees, a mechanic and windmill expert; S. H. Brown, the blacksmith; G. W. Farnsworth, a public-spirited fanner; C. F. Ramsey, one of the first members of the commissioner's court of Floyd County; A. J. Sams, a merchant; Mrs. T. Cromartie,

proprietor of the Winsor Hotel; E. P. Thompson, who was "Prepared to put up or repair all kinds of windmills on short notice"; and G. W. Grammar, who proclaimed himself an instructor in music, stenography, and phrenology.

A Sunday School was organized at Mayshaw and there was preaching the first Sunday in each month by Rev. Anson Cox, of the Friend's Church, and every third Sunday by C. W. Smith of the Church of Christ.

On May 19, 1892, the commissioner's court of Floyd County created the Mayshaw School District, and the first session was taught by Miss Rosa Ewing, a daughter of J. A. Ewing.

A Baptist minister and Populist leader organized on April 28, 1892, the Mayshaw Farmer's Alliance with S. M. Brown as president, H. Terry as vice-president, and S. F. Lindsay as secretary; and on Saturday, May 14, it held its first regular meeting.

The following news item from the Mayshaw Zepher tells about a part given by the youth people of Mayshaw. "Thursday night May 2, 1892, a number of the youth and beauty of Floyd County went to celebrate the completion of the new business house of J. B. Anthony of Mayshaw. Messrs. Cox and Fanner furnished me music and dancing continued until the wee small hours."

But Mayshaw's prosperity was of less than two years duration. Her promoters lost heart, as those of Dell Plain did, and by degrees, the town was depopulated and in 1896 only a post office and a blacksmith shop, both of which were under the management of S. H. Brown, were left.

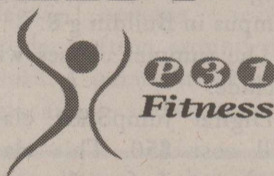
same day. Boys, you will never know how much we appreciated your help.

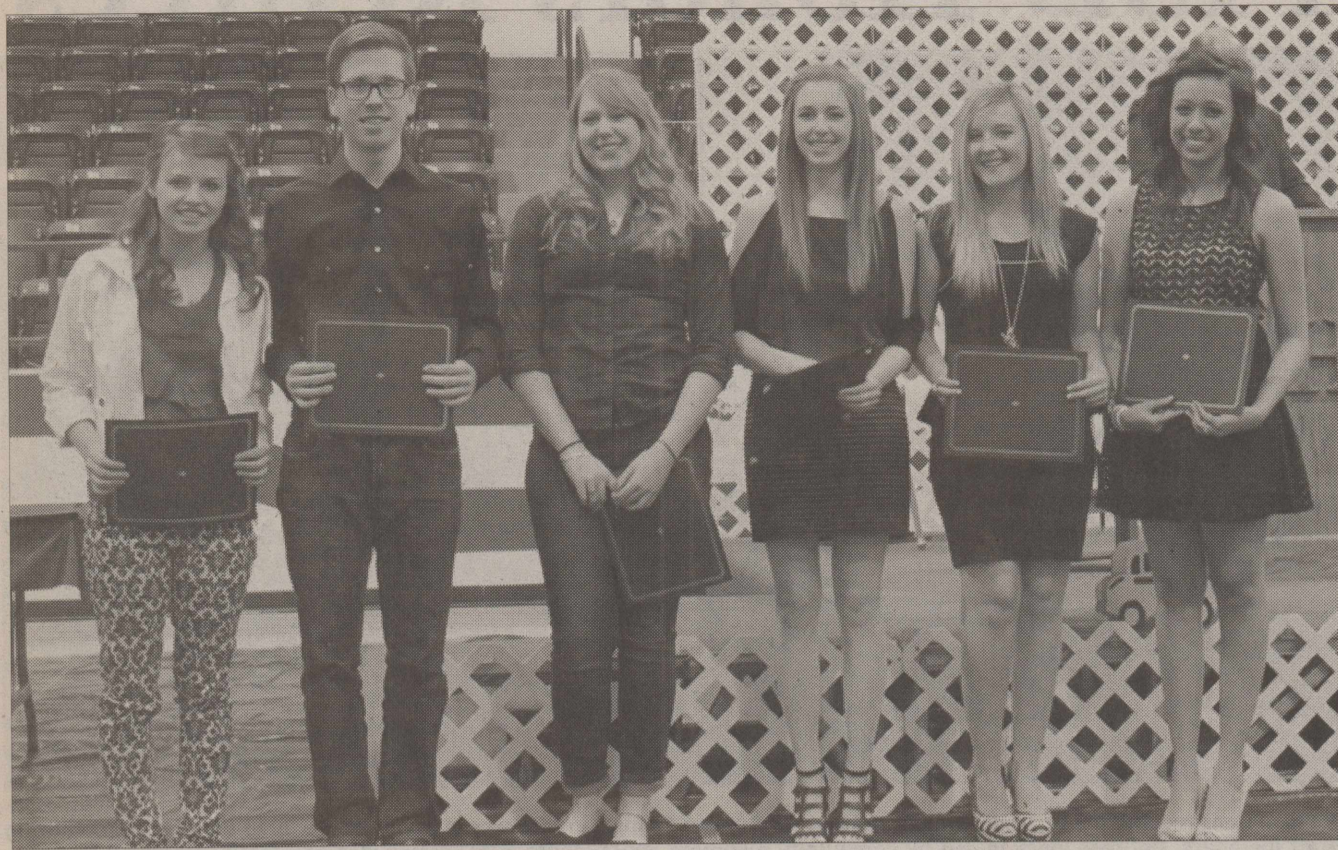

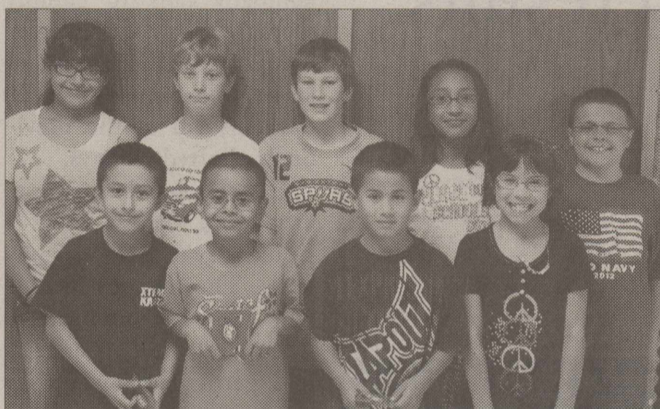

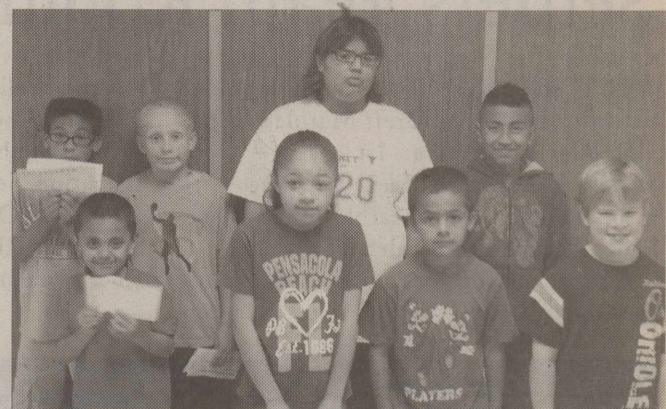
Lexi Morgan making a victory lap down the main hall on her new bike.

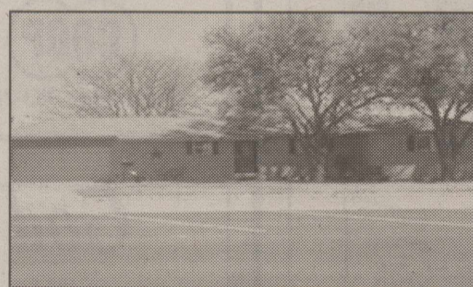

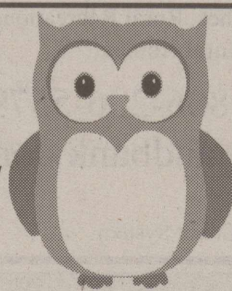

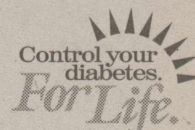

Panhandle-Plains Land Bank Announces Board Reorganization

AMARILLO, Texas—Following director elections at the annual stockholder meetings, Panhandle-Plains Land Bank announced board positions for the coming year. Serving as Board Chairman for a two-year term is Randy Darnell of Amarillo. Don James of Plainview will serve as Vice-Chairman. Darnell has served on the board since 2002; James since 2004.

The board also elected Perry Kirkland of Vega to serve as Chairman of the Compensation Committee. Steve Brown of Floydada was re-elected by the board to serve as its outside director. This is a position elected by the board, filled by a non-borrower. Mr. Brown was elected to serve as Vice-Chairman of the Compensation Committee. Danny Krienke of Perryton will continue to serve as Chairman of the Audit Committee.

At each of the regional stockholder meetings; the board recognized Wayne Garrett of Gruver. His term expired in 2013 and he chose to retire from the board. Mr.

Garrett joined the board in 1999 representing Place II, Hansford and Hutchinson Counties in the north Texas panhandle. He played a vital role as director for the association during a time of significant change and growth. Wayne and his wife, Lou, will continue to farm and ranch, and spend time with family. The association greatly appreciates his service and is fortunate to have a board willing to give of their time and talents.

Stockholders elected Tim Stedje, a farmer/stockman from Gruver to fill Place II. Tim and his wife, Julie; farm corn, cotton, and wheat, and own and operate a cattle feeding operation in Hansford County. He is a graduate of Texas Tech University; and is involved in numerous community activities. Dennis Babcock, of Groom was re-elected to Place 6; and Don James from Plainview was re-elected to Place 7.

Panhandle-Plains Land Bank is part of the Farm Credit System, serving member/borrowers in a seventeen county region of the panhandle and south plains.

Commissioners' make minor changes to tax abatement

In Commissioners' Court, that met on May 13, the tax abatement that had previously been approved was presented to the court with revisions by Wes Jackson of South Plains Wind Energy, L.L.C. The substance of the agreement did not change, according to Jackson. The changes that were made were that the abatement would start in the year in which the project commenced commercial operation, and the agreement now reads it will commence January 1, 2015. There was also a clarification for defaults and remedies in the section of the agreement that states "the county may cancel or modify this agreement upon 60 days of written notice if the company fails to comply with the terms of the agreement." Now the agreement states the company has 90 days instead of the previously allotted 60 days.

"I feel good about Westerly Wind," said Jackson. "I think they're a good company. They've got people who know what they're doing and the challenge is still getting a power purchase agreement and getting someone to buy your power at a price that will enable you to build the project."

He explained that this is the case with several other projects in the area and that not all of them will end up being built because there just is not enough demand. "Westerly has a better chance than most to get their projects built," said Jackson.

The commissioners reapproved the tax abatement agreement with the revisions to the original agreement with South Plains Wind Energy L.L.C.

Bristi Cure, business development manager for Invenery, visited with the court, telling them that the Energy Production Company would be soon seeking a tax abatement or payment in lieu of taxes agreement with Floyd County to build a 150 megawatt Power Station in Floyd and Crosby counties, with most of the towers built in Floyd County. No action was taken.

AgriLife Agent Ethan Fortenberry gave his report for April to the court. He said that he went to College Station for a week and attended meetings and training. Pesticide application training was held in Floydada with the Texas Department of Agriculture and received good attendance. Also, he attended a Plains Cotton Growers

meeting in Lubbock and some judging contests. Some students are going to state competition in archery, rifle, and pistol. The Friends Gala took place in the month of April and was a success, clearing \$38,000. "It's nice to see the county come out and doing something like that," said Fortenberry. For May, Fortenberry said that he was starting a results demonstration in the county working with three of the producers to address the weed resistance issue that is common in Floyd County.

Kyle Smith of Goen and Goen Insurance presented a quote from Blue Cross Blue Shield of Texas for a hospital plan per the court's request. The first page the commissioners viewed was the census of employees wanting health insurance who filled out the required form. He presented to the court the data showing that a minimum of 26 people must take a policy to be eligible for Blue Cross. With Blue Cross, the employer must pay 50% or more of the employee-only premium. Blue Cross also quoted short-term disability, life insurance and dental, which is optional to the county. \$30,000 in life insurance would cost \$216/month and short-term disability would cost \$252/month. According to Smith, Blue Cross only quotes 60 days out, but the numbers quoted are a good indicator of future prices. By June, the court said they would make a decision regarding insurance coverage. No action was taken.

Commissioners decided to leave the Texas County District Retirement Plan for the same with unanimous approval.

Also up for discussion was the J.P. 1&4 agreement/Hill Country out of the R.M.&P. fund. Judge Golightly reported that Justice of the Peace, Precincts 1 & 4's technology account was over budget and the Software Maintenance Agreement with Hill Country was paid out of the R.M.&P. account. The judge agreed to renegotiate next year's agreement and the commissioners approved the payment from the R.M.&P. account.

The court took action on approving the Appraisal District Budget for 2013/2014. Judge Golightly presented the budget for 2013/2014 to the commissioners, reflecting the increase from \$77,393 to \$82,274 (2.7% to 5.7%). Commissioner Morris stated that that increase was excessive. Commissioner Johnson commented that the Appraisal District ex-

perienced big increases last year, and are doing it again this year. Personal expenses alone went up \$10,000. According to Johnson, the auto insurance and use were not going up, it was all due to raises. Morris posed the question to his fellow commissioners what would happen if the court did not approve the budget and Judge Golightly replied that some of the other entities would have to reject it for them to go back and revise it. Morris moved to not approve the Appraisal District's Budget for 2013/2014 which passed unanimously.

The Consent Agenda was approved which included minutes from the April 8 agenda, written monthly reports of the County Clerk, Treasurer, JP 1&4, JP 2&3, District Clerk, Fund Transfers, part-time payroll, the deputations of Sheriff's deputies, Matthew Arguello and Marco Martinez; bills were paid, including approving a Bond for Kimberly Bennett, deputy T.A./C.

Four farm contracts were brought before the court to be approved. Treasurer Jo Elliott informed the court that two of the individuals were over one year delinquent and suggested no work be done until payment was made on their accounts. All commissioners voted in favor, with Judge Golightly abstaining.

The court took action on increasing hourly rates for county equipment on farm contracts. Rates went up to \$110 per hour for a maintainer, \$100 per hour for a backhoe, \$110 per hour for a loader, \$170 per hour for a dozer and \$7 per yard for a truck (and only within 10 miles). The rates for the county equipment was approved unanimously.

S/2 Lots 6, 7, and 8, Block 17, Bartley Heights Addition/812 W. Main St., Floydada were approved for sale to Lupe Stewart for \$450 with the commissioner's approval.

Morris made the motion to approve the Bounty Agreement to pay Talin Cruse for 41 pairs of Coyote ears, and the vote was unanimous.

The Annual Road Report from the commissioners was approved.

G.L. Hight Road Crossing was approved by the court with a motion from Johnson and second from Morales, passing unanimously.

Commissioners approved the Flood Damage Prevention Order for Federal Flood Insurance.

Judge Golightly stated that Carolyn Hardy had visited with her about re-allocating \$1,000 from the Senior Citizen's Captrons line item, which had not been used in several years, to the Texas Plains Trail to promote economic development in Floyd County. Commissioners voted to amend the budget for 2012-2013 to reflect the change.

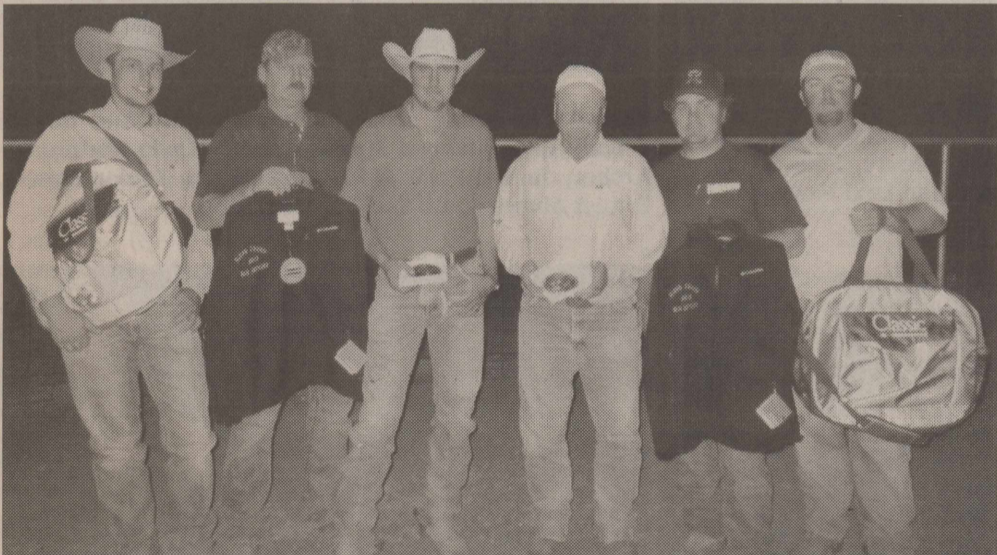

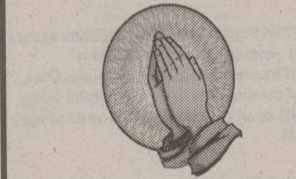

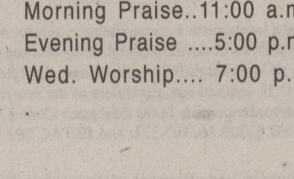

FISD Board Swears in New Officials Flying low

The Board of Trustees of Floydada Independent School District met Tuesday, May 14, 2013, to swear in the new board members. The results from the May 11, 2013 election were canvassed by board members William Dean and Roger Hughes. Results showed that board members Kay Brotherton, Marty Lucke and John Woelfel were elected. Notary Public Dee Leatherman swore in the newly elected officials, then the board recognized Charles Tyer for his many years of service as a board trustee for Floydada ISD.

Lyle Miller was nominated to continue serving as FISD board president. The board unanimously approved this nomination. John Woelfel was nominated to serve as the board vice president. This nomination also was unanimously approved. Nominee Rachael Castillo was unanimously approved to serve as board secretary.

The board honored several individuals who were nominated for the 2013 TASB sponsored Media Honor Roll. This program is sponsored by the Texas Association of School Boards and recognizes media representatives for fair and unbalanced

reporting of news about Texas Public Schools. Superintendent Gilbert Trevino recognized the 2013 TASB sponsored Media Honor Roll recipients: Barbara Anderson, Corey Johnston, Tony Ricketts, Sara Sisemore, and Cynthia Smith. Sisemore and Smith were both present to receive these certificates.

Business Manager Sharon Rainwater presented the tax report and cash flow statement. M&O current tax roll stands at \$2,427, 165.11, with net collections of \$2,368,968.54. I&S tax roll stands at \$286,011.40, with net collections of \$279,153.65. The percent of current roll collected is 97.6 compared to 97.45 percent this time last year.

The board approved Superintendent Trevino's request to purchase 370 MacBook Pro laptops for Grades 7-12 from Apple Inc. for \$424,612.

The board accepted the resignations of Matthew Nix and Estella Thomas, and approved the employment of Salina Marks as Special Programs diagnostician and Monica Smith as Curriculum Director.

The April 16, 2013 minutes were approved, the date for the June board meeting was set for June 25 at 7p.m., and the board agreed to sell Taxing Entity Lot S/2

6-7-8, Block 17, Bartley Heights, 812 W. Main Street.

The board took no action at that time to accept the application for an appraised value limitation on qualified property, to authorize the Superintendent to review the application for completeness, and to submit to the State Comptroller.

Roger Hughes made the motion to extend the district's depository contract with Prosperity Bank. The vote was unanimous in favor of the motion.

William Dean made the motion to approve the budget contribution to the Floyd County Central Appraisal District. This vote was also unanimous in favor of the motion.

In other business, the board discussed the Summer Professional Development Plan, approved the Superintendent Appraisal Instrument as presented, and approved the 2013-2014 FISD goals as presented. Additionally, the board approved the expedited waivers for the 2013-2014 school year, and amended the 2012-2013 budget as presented.

Future items for discussion will include increasing the FISD contribution by \$50.00/employee for health insurance at a cost to the district of \$66,000.

According to photographer Nikki Seymour, this picture, which was taken a mile or two west of Dougherty, can fool the eye. At first glance it appears that this is a fully formed tornado, however, "it is a strong updraft and inflow that appears to have had a very low pressure." Seymour said that it didn't quite have enough rotation to form a tornado, even though it appears like one. Two verbal reports were received of tornadoes, both north and south of Hwy 70 on FM 602. One was seen two miles north of Hwy 70 on FM 602 North, while the other sighting was half a mile on FM 602 South. Crop damage has been reported in the area, with some cotton fields beat to the ground, while neighboring crops were left untouched. Some replanting will be needed after golf ball sized hail followed the formations.

Special Education Child Find

With the assistance of the Texas Education Agency and the education service center 17, Floydada ISD must ensure that a free appropriate public education (FAPE) is provided to all individuals with disabilities, ages 3-21, who qualify for special education services. With the assistance of the Texas Education Agency, ESC 17, and the Early Childhood Intervention (ECI) program, Floydada ISD must ensure that early intervention services are made available for those children, ages 0-3, with an identified need.

To carry out these responsibilities, Floydada ISD must implement: a comprehensive system of "Child Find" in which the applicant agency personnel actively search for all individuals with disabilities or developmental delay who are 0-21 years of age. Floydada ISD is responsible for identifying, locating, and evaluating all individuals 0-21 years of age, regardless of nature or severity of disability. Once Floydada ISD determines eligibility, all individuals 0-21 years of age, regardless of the severity of the disability or developmental delay, are served by Floydada ISD [3-21 years of age] in accordance with Texas Education Code §25.001 or a program of ECI [0-3 years of age] (34 CFR §§300.128, 300.220, 300.300 Note 3, 34 CFR §§303.16, 303.321; and 19 TAC §89.1035).
