### **Council Awards Construction Project** for New Water Well

#### **By Charles Keaton** The Hesperian-Beacon

LOCKNEY - Lockney City Council members unanimously approved the awarding of a construction project to Amarillo Utility Contractors of Amarillo for \$456,793 to construct water well number seven for the city. The duration of the project should be no longer than 200 days. Funds for the well will be coming from the certificate of obligation approved earlier this year as well as a grant from the state of Texas.

The Council, meeting in regular session Dec. 11, also approved the revised Law Enforcement Service Contract with Floyd County for the fiscal year that began Oct. 1, provided the County also approves the contract as written. In other action, the Council approved a resolution for the submission of a grant through the Texas Community Development Block Grant Program. If approved, the grant will provide funds for the City to address need street improvements in some areas of town.

In additional action, the Council approved renewing their contract with Pitney Bowes Global for the postage

### **Lockney School Board Accepts Resignations, Appoint New Board Member**

LOCKNEY – Meeting in regular session on Dec. 8, the Lockney School Board accepted the resignations of district Librarian Kathy Young and elementary custodians Santos and Mary Mariscal. All three are retiring as of Dec. 31. The Board also appointed to fill the vacant Board seat that was opened when Heath Rexrode resigned in the summer so that his wife, Jeri, could be employed by the district. Following the 180 waiting period as required by law, the Board members nominated to fill the seat with Heath Rexrode again.

In other action, the Board approved the annual audit report as presented by Greg Gilbert of Bolinger, Sears, Gilbert and Moss, LLP. Gilbert said there were no surprises or exceptions in the audit and gave the district a clean audit. He said that there were a few minor adjustments but nothing worth noting. He did note that the district had incurred over \$245,000 in deficit spending in 2013-14 and only had about four and onehalf months of fund balance in the bank at the time of the audit. The current balance on hand, as of Nov. 30, including savings and investments was \$2,908,622.

The Board also approved Policy Update 101. The update had no major changes in any of the 33 policy updates listed. Board member, John Quebe, was reappointed to the Floyd County Appraisal District Board. The Board approved the 2014-2015 District Improvement Plan and Needs Assessment as required and as presented. The 2015-16 school calendar was also approved. The 2015 school year will begin Aug. 24 and end on May 26, 2016.

In other action, the Board approved budget amendments to pre-kindergarten funding, sick leave and maximum entitlement of federal funds.

Junior High seventh grade English and reading teacher, Cynthia Zavala gave a presentation about her first semester teaching. Zavala is a 2009 graduate of Lockney and a 2013 graduate of Eastern New Mexico University. She discussed her strategies in both classes she is teaching. In English, she

is putting emphasis on writing and grammar as well as critical thinking skills. In Reading, she is focusing on using the library with book reports or presentations about the books her students are reading.

Superintendent Phil Cotham reported that construction was continuing on the Longhorn Wind Farm. He also discussed several issues that are factors leading to the financial hardship facing Lockney ISD. He listed six causes including: state cuts from 2010 have not been fully restored; revenue from fund balance interest has plummeted since 2008; small school weight (based on a districts size in square miles) is only .00025 where most other schools are at .0004; a continuing decline in student population and attendance; less that the maximum tax rate (currently rate is \$1.14 and maximum allowed is \$1.17); and a lack of substantial tax base.

Cotham then explained nine possible solutions that exist. They were: the Texas Supreme Court rules that school funding is unconstitutional and funding is increase (the decision probably won't happen until late in the summer of 2015); wind farms provide additional revenues; small school weight is changed to .0004; pass a bond package to purchase buses and complete needed renovations through out the district; raise the tax rate to \$1.17; increase attendance rates district wide; increase student population; continue staff reductions as enrollment declines; and as a last resort, begin cutting programs.

Cotham said that he hope the first three possible solutions would occur and there would be no need to pursue the other six possible solutions at this time.

Cotham explained to the Board that he was in discussion with the City of Lockney regarding the water bill for the baseball field. He explained that for the past 24 years, the two entities have had a gentleman's agreement about splitting the water bill in half since the field is actually owned by the City and the school maintains and uses it.

The next school board meeting is tentatively scheduled for Jan. 15, 2015.

## **STAAR** and the Texas

### **Success Initiative**

Throughout people's schooling years, they are given examinations that determine if they are ready to proceed to the next grade, stage, or level. In the recent past, secondary students would be assessed by the TAKS test with endof-course exams. However, more recently, the State of Texas created a new test called STARR. In addition. they also created the TSI, or Texas Success Initiative, which is used by colleges to classify the placement and levels of advancement of students.

The STAAR, the State of Texas Assessments of Academic Readiness, assesses core subjects such as mathematics, science, reading, writing, and social studies. The standardized tests are for students between the grade levels 3-10, and the amount of test taking each year depends on which year of school they are currently enrolled.

The TSI, much like the STAAR, is an as-

sessment featuring varying levels of question at different ranges of complexity. This test allows the students to have an idea if they are actually 'college ready'. It also has an influence on the level of difficulty in the classes that they are enrolled in. The TSI is administered to juniors and seniors and is indicative of whether a student is eligible to enroll is dual credit courses, allowing them to obtain college hours while still in high school.

"A community college can not tell a student that they can not attend, but they can put a restriction on the courses that they are able to enroll in," said Mrs. Jahay, counselor at Floydada High School. A passing rate on the TSI is required to participate academically for college hours.

Out of both of the mandated tests, students prefer to take the TSI because there isn't a time limit, allowing them the needed duration for concentration. Each test serves a different population of student while remaining a diagnostic tool for local schools and the state.

## National News Update: The Status in Ferguson

For most towns, traffic is the glaring conflict facing public servants before the holidays. In the city of Ferguson, civilians are responding to the recent act towards police officer Darrell Wilson. The unresolved reactions began after the shooting of Michael Brown on August 9, 2014. Brown was an 18 year old black man fatally shot by police officer Darrell Wilson, 28, a white authority. The dispute of the shooting and respondent protests were brought into US attention after the death of Michael Brown.

Brown and a friend were

walking in the middle of a street when police officer Wilson demanded they move to a sidewalk. A disagreement broke out that led to Brown and Wilson struggling through the window of the police car until Wilson's gun was fired. Brown fled the scene and Wilson chased after him, eventually firing his weapon 12 times. Brown was hit by 7-8 rounds and was killed. Witness statements were uncertain in stating whether Brown had his hands up or whether he was moving toward the car when the irrevocable shots were fired.

On Nov. 25, 2014 the grand jury, which consisted seven men and women, de-

cided to not to indict Darrell Wilson for the murder of Michael Brown. Chaos broke out the following Monday night in response to the freedom of Wilson. Many of the protests were peaceful but it was announced that nearly fifteen shots were heard and some business were seen in flames by the end of the day. Protests resulted in the closing of Interstate 44. Sparks and people were consuming the town, defying Michael Brown's parents' wishes for peace. All of the destruction taking place in the St. Louis area of Missouri is affiliated with the national debate of racial intolerance between officials and civilians.

### **The Big Five: Science** A half semester coverage of Lockney's top UIL events

The science test consists of 60 multiple choice questions, 20 biology questions, 20 chemistry questions, and 20 physics questions. 



## **Assignment: Texas** Playa Lakes - Part 2



benefited from the lakes as well. Artifacts discovered in an ancient Roberts County playa (just a few miles southeast of here, near Miami) include spears and scrapers found in proximity to elephant bones. People of the Folsom period (10,900 -10,000 years ago) supplemented their bison diet with various aquatic animals and ducks they captured from playas. The term playa is Spanish in origin and literally means beach. Perhaps Francisco Coronado coined the term when he crossed the plains in search of the fabled Quivira — the lost city of gold. Pedro. de Castañeda traveled with Coronado on the expedition and made note of the playas in the mid-1500s. "Occasionally there were found some ponds, round like plates, a stone's throw wider or larger," he wrote. "Some contained fresh water, others salt." Throughout recorded history, the playas, which are the main water source on the plains, drew American Indians and 19th-century settlers. Comanche, and later hide hunters, knew that bison drank from the playas and often hunted them at the water holes. In fact, one of the theories that attempt to explain the origins of the playas suggests that bison wallowing in the mud over time caused the depressions. Still known as "buffalo wallows" by many contemporary plains residents, playas were actually formed by decaying organic matter that formed carbonic acid and dissolved the caliche soil layer. Once the caliche layer dissolved, various materials such as rock and organic matter permeated the soil and eventually formed a layer of clay in the bottom of the lakes that, when wet, is impermeable.

For centuries, the wet-dry cycles of the entirely eliminated as the area evolved high plains wetlands benefited wildlife into the agricultural breadbasket of and plant life alike. Since the Clovis Texas. Bill Johnson, a biologist for the period of 11,500 years ago, ancient people United States Fish & Wildlife Service based in the Panhandle, says that most playa degradation came from agricultural practices such as irrigation ditching and close-proximity plowing. Although the rate of destructive practices has slowed considerably, Johnson estimates that at least half of the playas that originally existed in Texas have been severely damaged or destroyed. "Although they represent only two percent of the landscape in the Southern High Plains, playas are key to both floral and faunal diversity," explains Johnson. "They are the primary wetland feature in a very arid landscape ---without functioning playas, both plant and animal diversity in the Texas High Plains would be very low." Johnson says that, during the peak of the winter, as many as half a million ducks are on the lakes in wet years. During the fall and spring migrations, that number increases substantially. "The numbers of ducks, geese, cranes and shorebirds that use playas during migration periods and winter can be quite impressive. Without functioning playas, it's not a stretch to say that waterfowl numbers would be affected on a continental level." However, waterfowl and shorebirds aren't the only avian species that utilize playas. The Panhandle's premier game bird, the ring-necked pheasant, is inexorably tied to the shallow water lakes. According to Texas Tech University researchers, pheasants spend as much as 90 percent of their time around playa lakes during the nonbreeding season. Without playas, pheasant numbers and, ultimately, the local hunting economies would suffer. Towns like Hart and Nazareth host huge groups of pheasant hunters annually, and their presence is essential to maintaining a vigorous local hunting economy even when the broader agricultural economy is marginal.

meter, reappointed Dennis Carter to the Floyd County Appraisal District Board and approved the first step in repairing and upgrading the City's animal control facility. After some discussion, the Council accepted the idea of discontinuing animal control activities for the winter months while the facilities are remodeled.

The Council tabled action on a few items including amending the budget, the disputed water bill with Lockney Schools, adopting new animal control procedures and standards and reimbursement for

damages and repair of the building located at 200 South Main.
