

# Thomas recognized as Hangar 25 Honored Veteran

Col. Sharon J. Thomas spent 30 years serving her country as a flight nurse in the United States Air Force Reserve. Now, she's serving veterans in Big Spring's West Texas VA Health Care Center. Tuesday night, she was recognized as Hangar 25's most recent Honored Veteran.

Speaking before a crowd of about 40 people in the Hangar 25 briefing room, Thomas regaled those present with tales of her career and words of wisdom she's gleaned throughout her career.

"This was outstanding! It was beautiful that Big Spring would honor me in such a way," Thomas said.

That's what the Disabled American Veterans' O'Neal-Kunkle Chapter in Big Spring is asking – that we remember veterans.

The group's biannual Forget-Me-Not fundraising campaign is this weekend.

"It will be Friday and Saturday, seven (a.m.) to seven ans at the VA domiciliary and the nursing home...we take them out to Thanksgiving buffet and Christmas buffet."

DAV members will be distributing their blue forgetme-nots at Wal-Mart.

"We'll be at both doors, both days," said Tarpley.

The Veterans of Foreign Wars organization has their familiar Memorial Poppy Campaign, giving away for donations little red flowers alluding to those in John McCrae's poem "In Flanders Fields." While the VFW's memorial poppies focus on remembering those who died in foreign wars, the DAV's forget-me-nots are similar, but tinted differently. 

## SMMC to help community members with health insurance enrollment

Beginning November 1, Scenic Mountain Medical Center will again help area residents learn about and enroll in health insurance options on the Health Insurance Marketplace.

"As a primary health provider in Howard County, our goal is to help educate residents in an easy-to-understand way, as well as assist those who haven't yet signed up for health insurance or Medicaid, if qualified," said Emma Krabill, CEO of Scenic Mountain Medical Center. "During the next few months, we'll be out in the community and meeting one-on-one to help these individuals find affordable coverage."

#### **Health Plans on Health Insurance** Marketplaces

The Health Insurance Marketplace

provides U.S. citizens access to affordable health insurance coverage. Depending on household income, some individuals may qualify for government financial assistance- or subsidies – towards the cost of the premium and other financial obligations like copays or deductibles.

All health plans on the Marketplace must offer a comprehensive set of benefits, and coverage cannot be denied for individuals with a pre-existing health condition. Some of the health benefits include free preventive care and wellness services, doctor visits, prescription drugs, hospital and emergency department care, lab services, pediatric services - and more.

"This is where Scenic Mountain Medical Center can assist," said Krabill. "With many people not having access to a computer or having difficulty maneuvering on the government website, our application counselors can help individuals and their families evaluate the health plan options and determine if they are eligible for Medicaid or other financial assistance. We'll also help with re-enrollment.

A few of our outreach efforts will include:

Beginning in November 1, consumers can make an appointment with our application coordinators who can help them find affordable health insurance on the Marketplace.

We will have informational panel cards throughout our facility, in our clinics, and around the community that includes a phone number to call to set up an appointment.

We will host speaking engagements

in the community to explain the insurance options, as well as how we can help with enrollment.

Information will be inserted into self-pay and uninsured billing statements.

Though a major function of www. healthcare.gov is assessing whether individuals and families qualify for financial assistance to lower the cost of health insurance, SMMC's application counselors can perform the same analysis and help with enrollment and reenrollment. To make an appointment to meet with an application counselor, call 432-268-4855 or 432-268-4971.

"Scenic Mountain Medical Center is committed to improving the health of the communities we serve by helping residents gain access to healthcare services," said Krabill.

"I feel very fortunate to be working in Big Spring, although it is very far from my home in Abilene."

Thomas started out setting the record straight about what being a veteran entails.

"There seems to be a lot of disagreement about what is a veteran? Are they a Reservist? Are they Active Duty? Are they a Guardsman? Are they all veterans? Yes. They are all veterans," she said. "Guard, Reserve, Active Duty. The Guard and the Reserve go side by side with Active Duty whenever there is anything that needs to happen. We deploy together, we train together, and we do work together on a daily basis."

A lot of people haven't gotten that message, she said.

"I still hear, 'Oh, you're just a Reservist.' What

"A lot of the people we airlifted out of Desert Shield were probably too sick to have been there to begin with. They were out of shape, they smoked too much, they couldn't carry the stretchers, they couldn't do the long days," she said. "They were not physically fit to be in that kind of setting. tice.' They said the military's got to change. They got rid of the cigarettes in all the Basic Training, and I was able to lead a whole bunch of that initiative with the Active Duty, which was quite exciting."

However, prevention took a side role when 9-1-1 hit and the United States went back to war in both Afghanistan and Iraq. During that time, Thomas was involved in planning and logistics, designating equipment and supplies for medical personnel involved in those conflicts.

Following her speech, Thomas was presented with a plaque and several other gifts, including a "Thank a Veteran" cap and a "Quilt of Valor," presented by DAV Vice Commander Mike Tarpley, who also presented her with a wooden yellow ribbon commemorating her Hangar 25 honor.

I've lost one job and almost lost a second job for being a weekend warrior and it was not just the weekends. That's one of those things. As a Reservist, you sign on the dotted line, 'I'm going to be here as a military personnel when you need me."

Thomas described her job as a flight nurse.

"What I did most of my career was as a flight nurse, which meant air medical evacuation," she said. That, in itself, when I first joined in 1982, was 98-percent Reserve driven. It was not Active Dutydriven. They had two bases where the Active Duty

flew out of back then. Maybe three altogether. They had a very small component that was Active Duty. The rest of the air medical evacuation was in the Reserve and Guard components. We actually deployed, deployed, deployed, like the Active Duty. Reserves actually go a lot of places."

Her first job was in Tactical Aircraft.

"It was a C-130. That is the workhorse of the Air Force and military. It is a big cargo and transport plane. Well, not so big anymore. It was big at the time, and then they got bigger," she said. "They're just big cargo planes, and for air medical evacuation, you have to bring all your equipment, everything, onto the plane. You have people who calculate how much oxygen you need, how much gas, how much electrical. And the 'pee factor.' The pee factor is, on those big C-130s and C-141s especially, how many people do you have on the plane for how long a trip it is, and how many toilets do you have? If you don't

## Read the transcript of AP's interview with President Trump

#### <u>By The Associated Press</u>

A transcript of an Oval Office interview Tuesday with President Donald Trump by AP White House reporters Catherine Lucey, Zeke Miller and Jonathan Lemire.

President Donald Trump: How is the business of the news? We're keeping you busy?

AP: Yes, sir, you are.

AP: Thank you for doing this.

Trump: What are you going to do in  $6\frac{1}{2}$ years with a normal boring person here? AP: It has certainly been a busy two

AP: Did they raise this idea of rogue killers in any of those conversations?

Trump: Well, the concept of it, I guess. Yesterday, when I spoke with the father, not so much today, but when I spoke to the father, it just sounded to me like he felt

like he did not do it. He did not know about it and it sounded like, you know, the concept of rogue killers. But I don't know. I think the investigation will lead to an answer. And they're going to do a very thorough investigation. I believe they're working with Turkey. AP: But he didn't bring up that? That was something you came up with after the conversation? Trump: Just the concept of it. No, that was just from my feeling of the conversation with the king, not with the crown prince but with the king.

ing forward. What do you think of that? Trump: Well, I think we have to find out

what happened first. You know, here we go again with, you know, you're guilty until proven innocent. I don't like that. We just went through that with Justice Ka-



Trump: It's a tough year ... The midterms are very tough for anybody the opposite of president, for whatever reason, nobody has been able to say.

AP: So my question is, if Republicans were to lose control of the House on November 6th - or a couple of days later depending on how long it takes to count the votes — do you believe you bear some responsibility for that?

Trump: No, I think I'm helping people. Look, I'm 48 and 1 in the primaries, and actually it's much higher than that because I endorsed a lot of people that were successful that people don't even talk about. But many of those 48, as you know, were people that had no chance, in some cases. We look at Florida, you look at Donovan in Staten Island. He was losing by 10 points, I endorsed him and he won. I could give you a long list of names. Look at Georgia governor of Georgia. And many, many races. And I will say that we have a very big impact. I don't believe anybody's ever had this kind of an impact. They would say that in the old days that if you got the support of a president or if you've got the support of somebody it would be nice to have, but it meant nothing, zero. Like literally zero. Some of the people I've endorsed have gone up 40 and 50 points just on the endorsement. AP: Eight years ago, Barack Obama said he got shellacked, so you know, taking the outcome of the election as a referendum on himself.

Look, it feels to me very much like '16. I was going out and making speeches and I was getting tens of thousands of people. And I was getting literally tens of thousands of people, also, more than Hillary in the same location. And I said, 'Why am I going to lose?' I mean, I go out, I make a speech like I have, you know, 25 times more people than she gets. And I didn't need Beyonce to get them. I didn't have to have, you know, entertainment and entertainers to get them. And then they'd all leave before she made the speech after the entertainer was finished. Honestly, it feels very much like it did in '16.

Now, I'm not sure that that's right. And I'm not running. I mean, there are many people that have said to me, 'Sir, I will never ever,' you on the trail when I'm talking to people backstage etcetera, 'I will never ever go and vote in the midterms because you're not running and I don't think you like Congress.' Well, I do like Congress because I think, and when I say Congress I like the Republicans that support me in Congress. We've had tremendous support. I mean, we've got the taxes with 100 percent Republican votes and we don't really have much of a majority. You know when you say majority, I always say, 'If somebody has a cold, we have to delay the vote.' So I get along, you know, very ... people have no idea how low how well I get along with Republicans in Congress. I get along well with a lot of the Democrats in Congress, but I'll never get their vote.

AP: You just mentioned Justice Kavanaugh. And I know, we've all been to your rallies, and you've suggested that fight was as hard as ...

Trump: I will say, that fight because he was treated so viciously and violently by the Democrats. That fight has had an impact on energy, and it's had an impact on the Republican Party, a very positive one in terms of getting out and voting. I think, but I'll let you know in three weeks.

AP: Along those lines, in the days before the actual vote was held, former President George W. Bush made a number of calls of senators also sort of lobbying on Kavanaugh's behalf. Does he deserve any of the credit here? Have you spoken to him, have you given him a thank you for that?

Trump: I did speak with him, I did. No, I didn't say thank you, per se. But I did speak to him before it and we had a great conversation about Kavanaugh, what an outstanding person he is, which is what he told me. And we had a very pleasant conversation, a very good conversation.

AP: There are a number of phone calls that you got from folks in that critical period. Did you hear from anyone who serves in the Supreme Court who serves alongside now, the justice?

Trump: No, I didn't. Nobody called from the Supreme Court. It's a very august body. It's a group of people that, once you're elevated to that level, you really tend to be in a different place, in a different world. No, I didn't, I never got a call. As an example, I did not get a call from Justice Gorsuch, who would be the most likely, or Justice Thomas. Or Alito. I've got no calls.

Trump: Oh, absolutely he's lying. And Michael Cohen was a PR person who did small legal work, very small legal work. And what he did was very sad, when you look. By the way, he was in trouble not for what he did for me; he was in trouble for what he did for himself. You do know that? Having to do with loans, mortgages, taxicabs and various other things, if you read the paper. He wasn't in trouble for what he did for me; he was in trouble for what he did for other people. He represented me very little. It's a very low level. And what he was is also a public relations person. And now if he wants to try and get a little bit lighter sentence for what he did ... Totally uninvolved. I wasn't involved and he had other clients, No. 1. And No. 2, he was a contractor to a large extent. But Michael Cohen, if you take a look at what he did, this had to do with loans, and I guess the taxi industry is something that I have nothing to do with, he did this on his own time.

Go ahead.

AP: You were tweeting today about Stormy Daniels ...

Trump: I won a case yesterday, a big case. They sued. Got thrown out. And not only did they get thrown out, but I get legal fees, which is quite unusual, because the case is so obnoxious and so wrong. And I give tremendous credit to the judge. And not only that, we go by Texas law. Texas law says you get every penny that you spent. Texas law is very tough for the legal fees.

AP: Sir, as the president of the United States, is it appropriate to call a woman, and even one who is making serious allegations and who you are in litigation against, to call her a horseface?

Trump: You know what? You can take it any way you want.

one was. Then, in 1890, they had one that was even worse. This was No. 3 or 4 or 5. We had worse hurricanes in 1890, we had worse, a worse hurricane 50 years ago. We've gone through a period, actually, fairly recently, where we have very few. I live in Florida to a large extent and spend a lot of time in Florida, and we had a period of time where we went years without having any major problem. And then you have a problem and it goes in cycles, and I want absolutely crystal clear water and I want the cleanest air on the planet and our air now is cleaner than it's ever been. Very important to me. But what I'm not willing to do is sacrifice the economic well-being of our country for something that nobody really knows. And you have scientists on both sides of the issue. And I agree the climate changes, but it goes back and forth, back and forth. So we'll see.

I mean, you know, I am a person that believes very, very strongly in the environment. I am truly an environmentalist. I know some people might not think of me as that, but I'm an environmentalist. Everything I want and everything I have is clean. Clean is very important — water, air. But I also want jobs for our country. And if we would have, as an example, entered certain agreements with other countries, I actually think that we're doing it so they could have an economic advantage. Because we would have had a tremendous— we would have been at a tremendous economic disadvantage if we entered into certain agreements.

AP: But scientists say this is nearing a point where this can't be reversed.

Trump: No, no. Some say that and some say differently. I mean, you have scientists on both sides of it. My uncle was a great professor at MIT for many years. Dr. John Trump. And I didn't talk to him about this particular subject, but I have a natural instinct for science, and I will say that you have scientists on both sides of the picture.

OK. what's next?

AP: Sir, you mentioned, you mentioned more than once that your inclination is not to interfere with the Department of Justice as the special counsel probe continues.

Trump: Well, the probe is ridiculous. OK. That that probe was even started. Jeff Sessions should have never recused himself. He did it for ... and he did it immediately. He should have told me that. And he recused himself. And even people that are not my friends say that was a horrible thing that he did to the president, a horrible thing. He should be ashamed of himself for doing it. He should have told me that beforehand. And if he would have told me that beforehand, I probably would have put somebody else in the Department of Justice. But Jeff Sessions should never have recused himself.

AP: I mean, you can fire him now. Would you want to do that? Will you do that?

Trump: I haven't said I was going to fire him or not.

AP: You could, I'm saying.

Trump: I can fire him whenever I want to fire him, but I haven't said that I was going to.

AP: Why don't you, sir?

Trump: I just haven't said I was going to fire him. We'll see what happens. But if you ask me: Am I thrilled? No, I am not thrilled.

AP: You've said in the past, also, on the probe, that you felt like there were certain lines that it shouldn't cross. How concerned would you be if it perhaps crept close on targeting your family, perhaps your eldest son?

Trump: Well, I can say this. I knew nothing about the meeting that you're talking about. My son's a good young guy. He did what every other person in Congress would do if somebody came up to them, said, 'Hey, I have information on your opponent.' I don't know of any politician. And I think I can speak for the people in this room that would have said, 'Oh, gee, information on my opponent and it's bad information?' Name me a politician that would have turned that down. There is no such thing as that kind of a politician. So that's what they heard. They heard it was about Hillary Clinton. They had a meeting or he had a meeting with some people. The meeting became about a different subject and they couldn't get out of the meeting fast enough.

Now here's the important thing. After the meeting, nothing happened. It was like, 'Hey, let's get together next week. Let's get together tomorrow. Let's get together.' Nothing happened out of that meeting. Absolutely nothing. He did absolutely nothing wrong. And there's nobody harder on my son than I am. And I would tell you, the press has made a fake news deal out of that meeting. If he did something wrong, I would have been livid. I could never really blame him because I've had people come up to me, senators. I've had a lot of political people say, 'Your son didn't do anything wrong. That was just a meeting. It was called oppo research.' A lot of the politicians would call it opposition research. There was nothing wrong with that. But here's more important. Nothing from the day of that meeting. It ended. And if you listen to people, it sounded like it ended like they couldn't get out fast enough. There was nothing wrong with having an opposition research meeting and nothing happened from the meeting. If that meeting went, 'Oh, let's have another meeting next week or let's have a meeting tomorrow or let's start doing this or that or a hundred different things,' that's different. That's totally different depending on what they were going to do. But nothing happened.

AP: The special counsel has submitted written questions to your lawyers. Have you read those questions? Have you been involved in drafting the response?

Trump: I won't respond, but you're right — we are looking at certain questions having to do with the word collusion. Of course there was no collusion. So we are looking at that, and we'll make a determination.



In 1941, the U.S. destroyer Kearny was damaged by a German torpedo off the coast of Iceland; 11 people died.

In 1967, Puyi (poo-yee), the last emperor of China, died in Beijing at age 61.

In 1973, Arab oil-producing nations announced they would begin cutting back oil exports to Western nations and Japan; the result was a total embargo that lasted until March 1974.

In 1979, Mother Teresa of India was awarded the Nobel Peace Prize.

In 1989, an earthquake measuring 7.1 on the Richter scale struck northern California, killing 63 people and causing \$6 billion worth of damage.

# **Bellinger lifts Dodgers over Brewers 2-1 in 13 to tie NLCS**

LOS ANGELES — By the time Manny Machado rounded third base, the Los Angeles Dodgers had already started streaming out of the dugout.

After more than five hours of tension-filled baseball, they were certainly eager to celebrate.

Cody Bellinger singled home the winning run with two outs in the 13th inning Tuesday night to give Los Angeles a 2-1 victory over the Milwaukee Brewers that tied the NL Championship Series at two games apiece.

The slumping Bellinger, who began the night 1 for 21 in these playoffs, was chased all the way into left field by teammates. Even manager Dave Roberts ran out to congratulate his outfielder, who got soaked with a Gatorade shower.

Bellinger laced a full-count pitch from Junior Guerra into right field to score Machado, who was nearly picked off second base moments earlier. Instead, he slid home and touched the plate with his left hand to beat Christian Yelich's throw and finally end an October nail-biter that took 5 hours, 15 minutes.

"One of the crazier games, where there's really no margin on either side," Roberts said. "The bullpen, what they did tonight against a very good offensive club, my hat's off to these guys."

It was the fourth extra-inning postseason game in Dodger Stadium history, and the home team's first such win since beating Philadelphia in Game 4 of the 1978 NLCS.

"It was a great baseball game, it really was," Yelich said. "Both sides had opportunities and they were just able to cash one in there at the end."

After a quick turnaround, Game 5 in the best-of-seven series is Wednesday afternoon, with Wade Miley pitching for the Brewers on three days' rest against fellow lefty Clayton Kershaw.

The teams return to Milwaukee for Game 6 on Friday.

"We lock it in, win one tomorrow, and we feel a lot better heading home," Yelich said.

> "Honestly, I didn't think he was going to throw me a strike," Bellinger said. "And then once I noticed he was attacking me, I just tried to put the ball in play and hopefully find a hole this time."

> Milwaukee manager Craig Counsell said: "I thought it was worth the risk of trying to expand to Bellinger, and if the at-bat goes to Grandal, we walk Grandal."

Bellinger, who entered as a pinch hitter in the sixth, also made a diving catch on his belly of a ball hit by Lorenzo Cain leading off the 10th, spreading his arms out and sliding like a snow angel in right field.

"I played right field in the minor leagues a lot before I started playing center field. I haven't been there much lately," Bellinger said. "But it's kind of like riding a bike. I saw it hanging up there, and ran as fast as I could and dove for it."

Both teams used all their position players and wasted numerous chances. Los Angeles went through its entire bullpen.

The Dodgers struck out 17 times — all against Milwaukee relievers — and have whiffed 49 times in the series. The Brewers fanned 15 times.

"Exhausting," Los Angeles outfielder Chris Taylor said. "Just a mental and physical grind all the way to the end."

Dodgers starter Rich Hill allowed one run and three hits in five innings.

The Brewers tied it 1-all in the fifth on pinch-hitter Domingo Santana's RBI double that took one hop against the right-field wall with Yasiel Puig scrambling in pursuit.

The Dodgers led 1-0 on Brian Dozier's RBI single in the first off Gio Gonzalez, who left after twisting his ankle while trying to field an infield single by Puig in the second.

Gonzalez has a high ankle sprain and will probably need to be replaced on the roster, Counsell said.

The sellout crowd of 53,764 was considerably noisier than on Monday, when Enrique Hernandez criticized Dodgers fans for being too quiet. Joc Pederson and Bellinger waved blue rally towels in the dugout.

But the Dodgers again struggled at the plate after going 0 for 10 with runners in scoring position during a 4-0 loss in Game 3.

Milwaukee put the potential goahead run on third in the seventh before Cain grounded out against Dylan Floro.

The Dodgers had runners at the corners in the eighth against hardthrowing Josh Hader, who pitched for the second consecutive day. Pinch-hitter Matt Kemp struck out to end the threat.

The Brewers had another chance in the ninth against closer Kenley Jansen. With fans on their feet, pinch-hitter Travis Shaw struck out with a runner on third to end the inning.

In the 10th, Ryan Braun singled with two outs and stole second against Jansen, who struck out Jesus Aguilar.

And when Bellinger finally ended it, the only NLCS game that had lasted longer was the New York Mets' 15-inning victory over Atlanta in Game 5 in 1999, which took 5 hours, 46 minutes.

"Let's get something to eat," Dozier said afterward. "I'm starving."

Machado allowed his left leg ting thrown out on a routine

play in the 10th. Aguilar appeared upset and the two exchanged words . Both benches and bullpens emptied, but no punches were thrown.

"It's a dirty play by a dirty player," Yelich said.

Aguilar, however, said the two talked it out after Machado singled in the 13th. Machado said they go back to their days in the minors.

"Everything that happens on the field stays on the field," Machado said. "He's a great guy."

The Dodgers said tickets were still available for Game 5, which begins at 2:05 p.m. PDT.

UP NEXT

Brewers: Miley makes his third postseason start in Game 5 on Wednesday. He threw 74 pitches over 5 2/3 scoreless innings Saturday in Game 2 of the NLCS, allowing two hits while striking out three and walking none. His other start came in Game 3 of the NLDS at Colorado. He didn't factor in the decision either time.

Dodgers: Kershaw took the loss in Game 1 against the Brewers. Kershaw had the best postseason outing of his career in Game 2 of the NLDS against the Braves, allowing two hits over eight shutout innings.
