

identified. "The encounter and the picture made an impression on me because this little girl had such a beautiful smile, and she



MMH to provide free heart screenings for teens

Midland Memorial Hospital (MMH), in collaboration with Championship Hearts Foundation (CHF), will be providing free heart screenings for students between the ages of 14 and 18. Athletes, cheerleaders, marching band students, drill team members and those who participate in vigorous exercises are encouraged to come and get their hearts screened.


The screenings will take place at MMH from 9 a.m. to 1:30 p.m. inside the Aqua En-

trance off Illinois. This heart screening tests for Hypertrophic Cardiomyopathy (HCM), which is the

leading cause of sudden car-

diac arrest in young people, including athletes, and affects roughly 1 in 500 people. HCM can cause thickening of heart muscles, which can lead to blockages and erratic heartbeat. Symptoms can include chest pain, dizziness, shortness of breath or fainting, but many times there are no symptoms present.

According to Danielle Johnson, public relations and interactive marketing with Midland Health, these health screenings have taken place in the past, but after the recent passing of a Lee High School student and basketball player, MMH reached out to CHF in an effort to bring awareness See **HEART**, Page 3



was so happy to see Santa. I remember her eyes – you could see the excitement in them - just kept looking at me," Franco (Santa) said. "I never knew her name, but the photographer liked the photo so much that he sent me a copy of the picture as well."

That photo – originally taken at JP Cowen during one of Santa's annual visits - became a special part of Santa's history. Over the years people asked Franco who the little girl in the photo, on his desk, was and he would tell them he didn't know her name. Through the years, he would begin asking people if they knew who the little girl was, but he never came across anyone who knew her name.

"When I joined Facebook, about 8 years ago, I decided to post the photo and ask if anyone knew her. As I had with people who saw the photo on my desk, I received lots of responses about her beautiful smile and how it was such a good picture, but still nobody knew who she was," Franco said.

For 8 Christmases, that picture made its way to Facebook and for a month or so, the search would continue, but as the holiday season came to an end, so did the search without any leads, until this year that is.

"This year, I posted the photo as I've done every year, but this year was different. I was contacted by Brooke Lynn Stone. She told me the little girl in the photo was her cousin, Dezy McCain," Franco said. "I couldn't believe it initially, after all this time, could the mystery have really been solved?"

After contacting Franco, Stone reached out to her cousin and informed her she was the focus of a search pertaining to a photo she took with Santa when she was a little girl. After speaking with her cousin, Mc-Cain decided to reach out on Facebook and inquire about this person searching for her.

"My first reaction was, who is this and why does he have my photo," McCain said. "Once I found out who he was, I was so excited... I had wondered over the years who Santa was, but it was so long ago I figured he wasn't Santa anymore." She continued, "I don't remember taking the photo,

but I had seen it several times over the years in the photo album. He was actually my first Santa, and my last; until today, when I met him again." The long awaited reunion, which Franco thought

would never come to fruition, finally materialized, thanks to one person stumbling across and recognizing that sweet smile that made an impact all those

The 17 year mystery was coming to a close, and the long awaited reunion was set. To make this sweet story even sweeter, McCain brought her daughter along to meet Santa.

"I was super excited, bouncing up and down, telling my mom 'I'm going to see Santa again,'" McCain said. "I almost cried after the pictures were taken and we were sitting there talking. It was one of the greatest experiences I have ever had. It brought me so much joy to see him so happy."

The magic of meeting Santa is a special one, no matter the age, when the heart of a child is present. The

"We felt this was an opportune time to remind par-

ents of the importance of heart screenings, as standard physical exams do not include cardiac screenings," said Johnson. These screenings will be provided free of charge

to those who attend the heart screening event in Januart, but the procedure would normally cost around \$700. Also according to Johnson, there was a previous heart screening event held on Wednesday, December 12 where roughly 176 students were screened. Of those, six teens were referred for further cardiology testing. Spots for this event are filling fast! You can register

until January 11, 2019, but the event is limited to 250 students. All students are required to have a consent form signed by parents, and as long as the students have these consent forms, parents do not have to be present during the exam.

same childlike astonishment that overtook McCain when she first met Santa, as a 3-year-old, flooded over her again and was reflected in her daughter, as she met this special Santa for the first time.

"My daughter was so happy to meet Santa. She kept talking about it. When she saw him, she ran up to him and gave him a hug. It was the cutest thing because normally she is very shy," she said. "For me, believing in Santa made Christmas that much more

She recalled, as a child, going to bed early Christmas Eve waiting for Santa to deliver gifts. Over the years, her belief in Santa never wavered. Through that one interaction with Santa, her belief was sparked and the Christmas spirit was instilled in her heart lasting well into her adult life. "There were some years that were a little harder

than others, for my mom and I, and in those years I would simply ask Santa for nothing more than to see my mom happy and every year Santa delivered," Mc-Cain said. "I still believe in Santa. It may not be in the same way, but Christmas wouldn't be the same with-With society changing and moving at such a fast

pace, the magic of Christmas seems to be getting lost, according to Franco. For those reasons, it is even more important for children – and adults - to believe in something, even if it is Santa. "I believe children need to believe in Santa Claus.

It's a parent's choice if they tell their child Santa isn't real, but I believe Santa does exist. He exists when you give someone a present with nothing expected in return; when you pay it forward, to a certain extent you are serving as the arms and feet of Santa," Franco said. "There is so much negative in life that the ability for a child to have a person to believe in, a person who cares and smiles at them, is important to the beliefs and dreams of a child.

While the special request McCain made to Santa 17 years ago has long been forgotten, the present she received is still impacting her life, and Santa's.

"I never lost my Christmas spirit because of Santa. He taught me that bringing good cheer and happiness is one of the best gifts anyone could ask for," she said. That desire to bring happiness to others is evident in McCain's life, according to Franco.

"My mom taught me and my siblings to give; my dad taught us to serve and passed down his love for children. Dezy said something that made my heart smile and reminded me why I continue to be Santa, she said she is very happy she has been able to make people happy over the years and that this is her best Christmas," Franco said. "I can't say that I have changed lives, but I can tell you I have seen smiles and little eyes fascinated by this man in a red suit and a white beard. If I had one piece of advice for people it would be, be a Santa; make a child smile and watch your life

This special reunion is just one of the signs Christmas magic still exists, just ask the mystery little girl and watch the sparkle in her eyes come alive. Merry Christmas Santa, Merry Christmas everyone.

who died at **US** border returns to Guatemala

GUATEMALA CITY — The body of a 7-year-old girl who died while in custody of the U.S. Border Patrol arrived in her native Guatemala on Sunday and was being driven hours into the countryside to be handed over to family members for a last goodbye.

A white coffin containing Jakelin Caal was received in the afternoon at Guatemala City's international airport by representatives of the country's Foreign Ministry and then loaded into the back of a black hearse by workers in or-

No family members were on hand. Domingo Caal, the girl's grandfather, told The Associated Press that the family didn't have money to travel from their poor hamlet to Guatemala's capital.

At Domingo Caal's home in the village of San Antonio Secortez, in the department of Alta Verapaz, relatives set up a small wooden altar flanked by vases overflowing with flowers, with photographs of Jakelin and the hand-lettered message, "We miss you." Behind the house, dozens of women prepared tamales and beans to feed mourners.

Relatives expected the body to arrive in the pre-dawn hours Monday in the hamlet of about 420 people who mostly live off growing of corn and beans. The village has no paved streets, running water or electricity, and residents say declining crop yields and a lack of work have pushed many in the community to emigrate in recent years.

Caal and her father, Nery Caal, were traveling with a group of 163 migrants who arrived at the New Mexico border earlier this month. After they were taken into custody Dec. 6, the father told a U.S. agent that the girl was

sick and vomiting. The father signed a paper stat-

ing that Jakelin was in good health, but it is not clear how much ne understood what it said. The form was in English, and agents read it to him in Spanish.

A bus carrying the two left the Antelope Wells port of entry for the Lordsburg station, roughly 90 minutes away. By then, according to a Customs and Border Protection statement, Jakelin's temperature had reached 105.7 degrees Fahrenheit (40.9 degrees Celsius). Emergency medical technicians had to revive her.

She was then flown to a hospital in El Paso, Texas, where she died the next day.

Guatemalan Foreign Ministry spokeswoman Marta Larra said the ministry had sent a diplomatic note to the U.S. State Department asking for it to monitor the case and determine the cause of death.

President Donald Trump's pick for attorney general, William Barr, sent an unsolicited memo to the Justice Depart-

ment this year criticizing parts of the Mueller probe as "fatally misconceived."

The 20-page memo, sent in June while Barr was in private practice and months before he was selected by Trump for the Justice Department job, may prompt questions about his ability to oversee the special counsel's investigation fairly. The document argues that there could be disastrous con-

sequences for the Justice Department and the presidency if Mueller were to conclude that acts a president is legally permitted to take — such as firing an FBI director — could



constitute obstruction of justice, just because someone concludes that there was corrupt

WITH RUSSIA? There is no smoking gun when it comes to the question of Russia collusion. But the evidence so far shows a broad range of Trump associates had Russia-related contacts during the 2016 presidential campaign and transition period, and that several lied about the commu-

American intelligence agencies and Mueller have said Russia was the source of hacked material released by WikiLeaks during the campaign that was damaging to Clinton's presidential ef-

-WHAT ABOUT OBSTRUC

TION OF JUSTICE? That is another unresolved question that Mueller is pursuing. Investigators have examined key episodes such as Trump's firing of former FBI Director James Comey and his fury over the recusal from the investigation of former Attorney General Jeff Sessions.

-WHAT DOES TRUMP HAVE TO SAY ABOUT ALL THIS? Trump has repeatedly slammed the Mueller investigation as a "witch hunt" and insisted there was "NO COL-LUSION" with Russia. He also says his now-former lawyer, Cohen, lied to get a lighter sentence in New York.

be contaminated with salmonella. The Jennie-O Turkey Store products have markings saying to use or freeze by Nov. 12 or 13. The recall includes plain ground turkey and turkey with taco or Italian seasonings. The products were shipped to Arizona, California, Florida, Georgia, Iowa, Illinois, Indiana, Louisiana, Michigan, Minnesota, Missouri, New Mexico, Nevada, Ohio, Oklahoma, Texas and Wisconsin.

Food safety officials are worried that some contaminated turkey may be in people's freezers. The recalled products have the tag P-579 marked on the lower left corner of the front of the package.

The USDA says the recall was part of an investigation into a November salmonella outbreak that involved 216 patients in 38 states.

Updated lawsuit teases new details against OxyContin maker

An updated complaint in Massachusetts' lawsuit against Purdue Pharma claims members of the family that owns the OxyContin maker are personally responsible for fueling abuse of the deadly The filing late Friday in Suffolk Superior Court

expands on the lawsuit the state filed in June against the drugmaker, 16 current and former executives and members of the Sackler family, which owns the company. The suit asserts that over the past decade the

Sacklers controlled a deceptive sales campaign by Purdue aimed at getting more people on higher doses of opioids to boost profits.

Much of the specifics on the allegations against Purdue Pharma executives and Sackler family members are blacked out while the state works to release a less-redacted complaint.

The state claims that the Sacklers directed the company to hire hundreds more sales representatives to visit doctors "thousands more times," in a bid to get more doctors to prescribe its painkiller. The Sacklers also directed sales representatives to encourage doctors to prescribe more of the opioids

Guzman scheme to transport cocaine all the way from Mexico to the New York City area by train using cooking oil tankers with secret compartments. He estimated he made as much as \$20 million from the cocaine train operation before he decided to quit because of "too much pressure" from Guzman over losses from seizures.

"They wanted to kill me because I had lost the train route," he said. "I just didn't want to keep going.'

RUNS IN THE FAMILY

Cifuentes' testimony outlined extreme family dysfunction, describing how his father drafted him at just 4 years old to help move illegal cigarettes and booze through the port in Medellin, Co-

He testified that many of his eight siblings were in the drug trade and that they had "conflicts like any other family." He admitted on cross-examination that his brother had ordered the killing of his nephew, but he explained it was because the nephew wanted to kidnap his own grandmother.

Cifuentes, 55, eventually began shipping Colombian cocaine to the Sinaloa cartel using airplanes made of carbon to deflect radar detection. He described meeting Guzman at his ranch in 2003 where there was a celebration for the second anniversary of the the drug lord's escape from prison.

Getting there wasn't easy: A small plane took him to a landing strip that was so short and sharply inclined that he started praying and telling himself that if he survived he would buy Guzman a helicopter so he "would fly in a more civilized way."

At another meeting in 2009, Cifuentes said he shared a joint with Guzman, who asked how strong it was before he took a smoke. He wasn't impressed.

"This does nothing to me," he

Pedro and Margarito Flores were known simply as "the twins" in Sinaloa cartel circle — identical twin brothers from the streets of Chicago who became so good at distributing cocaine to urban centers in the U.S. that Guzman sought them out.

Pedro Flores took the witness

stand last week to testify about their wildly lucrative business partnership with Gurzan, still exibiting a sense of awe about the defendant not shown by morehardened cooperators. While others simply referred to Guzman as Chapo, Spanish for "shorty," Flores kept calling him "The Man."

Flores, 37, described how, after becoming a fugitive in Mexico, he and his brother continued running their U.S. network with enough success that he was summoned to a meeting with Guzman in mountains in Sinaloa. He and Guzman's cohorts were driving up a road to the compound when he was startled to see a naked man, apparently being tortured.

"He was tied to a tree with a chain," he said, adding that he never learned what happened to him.

In another odd twist, he recounted discussing concerns about the "cover loads" used to disguise drug shipments stashed in trucks — in this instance, 150 live sheep he had to pay \$10,000 to put out to pasture.

The stresses of the job and the dangers of a bloody civil war within the cartel convinced Flores to commit munity by contacting U.S narcotics agents. He agreed to record telephone calls, played for the jury, in which an unsuspecting Guzman could be heard calling him his "amigo."

By associating with Guzman, he said, "I couldn't promise my family a tomorrow, you know?"

Fiance accused of killing Colorado woman missing for month

DENVER — The fiance of a Colorado woman who has been missing since Thanksgiving Day was arrested Friday on allegations of killing the mother of his child, and police said she likely died at her house in a mountain town. But authorities declined to say

whether they had found the body of Kelsey Berreth, 29, what led to the arrest of Patrick Michael Frazee and what motive there might be for Berreth's disappearance and slaying. Frazee, 32, was arrested at his home

in the alpine town of Florissant on suspicion of murder and solicitation of murder, said Miles de Young, chief of police in neighboring Woodland Park, where Berreth lived.

"As you can tell from the arrest, sadly, we do not believe that Kelsey is still alive," De Young said. Authorities also declined to elaborate

on the solicitation of murder charge, how they believe Berreth was killed or other aspects of the investigation, which spans several states and involves the FBI. Frazee was appointed a public de-

fender, Adam Steigerwald, at a court hearing Friday, but the attorney didn't immediately return a phone message seeking comment. Jeremy Loew, a private lawyer who had represented him, previously said Frazee cooperated with investigators and provided DNA sam-

Police have said Frazee was the last person to see Berreth alive. The couple shared a baby daughter but didn't live

The disappearance of the young pilot mystified family and friends and led to a social media push for information on her whereabouts.

Berreth was last seen at a grocery store near her home. Surveillance video showed her walking in on Thanksgiving Day with what appears to be the couple's daughter in a baby carrier. Frazee had told police that they met that afternoon so he could pick up the

De Young said the girl is in protective custody and will be turned over to Berreth's family.

Authorities searched Frazee's cattle ranch and Berreth's townhome but declined to say what they found.

retired farmers, a group that commonly took the job for extra income. Now, the district relies on 51 drivers mostly retirees and stayat-home parents — to transport roughly 3,400 students to and from school each day.

Even with administrators and bus mechanics filling in, the shortage has also resulted in fewer routes, more children waiting at each stop, and crowded buses. The district needs to hire six to eight more drivers, Schultz said.

"We have to do double duty," Schultz said. "Right now, I'm driving and doing my regular job. The mechanics are driving and doing their regular jobs so, instead of having eight hours a day, I only get them for four. It's like pulling a teacher out of the classroom

for half a day and still expecting the same job to get done."

Pay starts at \$19.10 an hour, followed by a \$2-anhour raise after six months, Schultz said, but the district struggles to fill open jobs. Schultz said he's now considering a "monthly rodeo" where potential drivers could test-drive a bus in a school parking lot.

"We're just trying anything we can right now," he said.

In St. Paul, Minnesota, some students are arriving late to school because fill-in drivers aren't familiar with the normal routes. A school district in Ypsilanti, Michigan, had to cancel a day of school in February because there weren't enough substitute drivers to cover for sick drivers.

And in Hawaii last year, a driver shortage in Maui forced state officials suspend bus rides for some students and limit rides for some others. The district offered free

monthly bus passes on local public transportation.

In Lincoln, Nebraska, some positions remain unfilled even after the local school district offered \$1,000 signing bonuses for new hires and a guaranteed six-hour day for all drivers. Officials also recruited an Omahabased contractor to provide extra drivers when needed to help transport roughly 4,000 students a day. The district faced a shortage of 32 drivers this year but has reduced it to eight, transportation director Ryan Robley said.

Kristi Meyers, a Lincoln Public Schools bus driver for six years, said she loves her ioh and knows every student by name, but wouldn't have been able to stay without the guaranteed hours and retirement benefits offered to senior drivers. Meyers drives routes throughout the day for elementary-age children and older youths who are in a job-skills training program. In the summer, she drives a bus carrying farm workers to make ends meet.

"It's a good job, and these are great kids," she said.

But Meyers said the job is considered part-time work, which prevents drivers from collecting unemployment benefits if they get laid off or getting paid holidays.

Martin, of the National Association of Pupil Transportation, said many districts require split morning and afternoon shifts for their drivers, which some consider a hassle. Keeping an eye on noisy children while facing away from them can be difficult as well, he said.

"It really takes a spec type of personality" to deal with the issues, Martin said. "Many people just don't have a burning desire to face those aspects of the job."





OxyContin has been the world's topselling opioid painkiller, generating billions of dollars for Purdue Pharma. In February, the company announced it was eliminating half of its sales force and would no longer market the drug to doctors.

The drugmaker has faced legal challenges over its painkillers before.

In 2007, it agreed to pay \$19.5 million to settle lawsuits with 26 states, including Massachusetts, and the District of Columbia that claimed Purdue aggressively marketed OxyContin to doctors while downplaying the risk of addiction. Purdue did not admit wrongdoing as part of that settlement.



ATLANTA — As Atlanta prepares to host the Super Bowl, artists there are painting murals that highlight the city's civil rights and social justice legacy.

The artwork adorning neighborhoods near the downtown stadium where the game will be played is part of an initiative called "Off The Wall: Atlanta's Civil Rights and Social Justice Journey." The proj-

ect is a collaboration between arts advocacy group WonderRoot and the Super Bowl host committee. While the murals' installation was timed to coincide with the Feb. 3 sports extravaganza, they are meant to be lasting public works of art for Atlantans to enjoy long after the football fans have left. The idea was to celebrate Atlanta's role in

the civil rights struggle of the 1950s and 1960s and connect that rich legacy with more contemporary struggles for justice and equality, WonderRoot executive director Chris Apple-"We definitely have works that, for good

reason, make Atlanta proud of its role in the civil rights movement and the human rights movement, and we have murals that invite and challenge us in Atlanta to continue striving for that beloved community," Appleton

The term "beloved community" was made popular by the Rev. Martin Luther King Jr., an Atlanta native, to describe a society centered on equal opportunity and justice and rooted in the philosophy of nonviolence.

Several dozen "community conversations" brought out unheard and untold stories about the struggle for justice that needed to be elevated, Appleton said. The artists sat in on those conversations and used them to inform their mural designs, which then went through two rounds of community feedback.

"I really believe the artists have done a great job of amplifying and complexifying narratives around justice issues in Atlanta and beyond," Appleton said. "The murals, as a collection, are celebratory in some cases, are aspirational in some cases and are rooted in truth-telling."

A nomination and selection committee inopen only to Atlanta area artists and was voted on by the public. In total, they plan to Muhammad Yungai, the muralist selected







WASHINGTON — The sooner-thanexpected departure of Defense Secretary Jim Mattis shifts the focus to President Donald Trump's appointment of an acting Pentagon chief and plans for a permanent replacement.

It also signals an acrimonious end to a tense relationship between Trump and Mattis that had eroded in recent months. A fracture developed last week over Trump's decision to withdraw U.S. troops from Syria and worsened after Mattis' public disagreement with Trump, aired in his resignation letter.

Deputy Defense Secretary Patrick Shanahan will take over as acting secretary on Jan. 1, Trump announced in a tweet Sunday. He had worked for more than three decades at Boeing Co. and was a senior vice president when he became Pentagon deputy in July 2017.

In the new year Trump wants to focus on streamlining purchases at the Pentagon, an issue on which Shanahan has already been working, a White House official said. The official asked not to be identified publicly discussing personnel matters.

U.S. officials said they didn't know if Shanahan would be Trump's nominee to replace Mattis. During a lunch with conservative lawmakers Satur-

day at the White House, Trump discussed his options. They were "not all military," said Sen. Lindsey Graham, R-S.C., who was among those attending.

Shanahan's biography on the Pentagon's website does not list military experience for the longtime Boeing executive. He earned a bachelor's degree in mechanical engineering from the University of Washington, then a master's degree in mechanical engineering as well as an MBA from the Sloan School of Management at the Massachusetts Institute of Technology.

In addition to work in Boeing's commercial airplanes programs, Shanahan was vice president and general manager of Boeing Missile Defense Systems and of Boeing Rotorcraft Systems. In a March 2016 report, the Puget Sound Business Journal called Shanahan a Boeing "fix-it" man who was central to getting the 787 Dreamliner on track after production problems in the program's early years.


An acting defense secretary is highly unusual. Historically when a secretary has resigned, he has stayed on until a successor is confirmed. For example, when Chuck Hagel was told to resign in November 2014, he stayed in office until Ash Carter was confirmed the following February.

Mattis, a retired Marine Corps general, had been expected to retain his position as Pentagon chief through February. Secretary of State Mike Pompeo, not the president, notified Mattis of Trump's decision to put in place Shanahan, said a senior administration official who insisted on anonymity to discuss personnel issues.





Breaking up (with Facebook) is hard to do: Here's how

NEW YORK — Every relationship has a breaking point. Even yours with Facebook. There's a way out, though the social network will try to win you back with promises to do better. Maybe even flowers.

For some users, though, the past two

years of privacy scandals, election manipulation by Russian trolls, executive apologies and even the political disagreements with friends and relatives have become too much. The latest: an alarming New York Times report detailing the massive trove of user data that the company has shared with such companies as Apple, Netflix and Ama-

A growing number of people say they are deleting Facebook, or at least considering it. While Facebook has tried to address some

of these problems, it's not enough for some users. Hard as it might seem to quit, especially for those entwined with it for years, it can be done.

Mostly.

GOODBYE FOREVER

Before deleting your account, rescue your posts and photos. Facebook lets you download the data you've shared with Facebook since you joined. This includes your posts and photos, as well as the "activity log" the history of everything you've done on Facebook, such as likes and comments on posts, use of apps and searches. The download also includes your profile, messages, list of friends and ads you've clicked on.

This process should give you a good — perhaps scary — idea of what Facebook has on

What you won't get are photos other people shared with you, even if you've been tagged. You need to save those individually. And some stuff will remain, including what others have posted about you, your chats with others and your posts in Facebook groups (though your name will be grayed out). To delete all this, you'll need to sift through your "activity log," accessible through your profile page, and delete each item individu-

Once you've saved everything and gone through your activity log, sign in one last time. Go to http://bit.ly/198wIoI and click on the blue button. Facebook says the process could take a few days. Your delete request will be cancelled if you log back in during this time. Facebook says it may take up to 90 days for all the data associated with your account to be wiped, but you can't change your mind after the first few days are up.

If you used your Facebook account for third-party apps and sites, you'll need new usernames and passwords for each.

TRIAL SEPARATION

If you're not quite ready for a divorce, deactivating your account is an option. To do this, go to your account settings.

Deactivating means other people won't be able to see your profile, but if you log back in, the whole thing is canceled and you are "active" again. Ditto if you log into an outside app or site using your Facebook account.

FOMO (FEAR OF MISSING OUT)

Depending on whether you were a fulltime Facebook addict or an occasional lurker, the psychological separation could

national security policy or smooth rattled relations with allies over the next two months. But U.S. officials said the reaction to Mattis' decision to leave — it sparked shock and dismay on Capitol Hill — annoyed Trump and likely led to pushing Mattis out.

"When President Obama ingloriously fired Jim Mattis, I gave him a second chance. Some thought I shouldn't, I thought I should," Trump tweeted Saturday, foreshadowing his displeasure and the Sunday announcement. He also fumed over the media coverage of his Syria withdrawal order, suggesting he should be popular for bringing troops home.

"With me, hit hard instead by the Fake News Media. Crazy!" Trump tweeted.

A White House official said Trump decided Mattis should leave the administration earlier than planned to avoid a drawn-out transition when someone on hand whom they consider a qualified deputy capable of running the Pentagon in an acting capacity. The official asked not to be identified publicly discussing personnel matters.

While Mattis' resignation followed Trump's announcement that he would soon pull all of the approximately 2,000 U.S.

troops out of Syria, officials said that the decision was the result of an accumulation disagreements.

In a stunning resignation letter, Mattis made clear he did not see eye to eye with a president who has pressed disdain for NATO and

doubts about keeping troops in Asia. Mattis was also unhappy with Trump's order to develop plans to pull out up to half of the 14,000 U.S. forces in Afghanistan.

Earlier Sunday, Trump's acting chief of staff said that Trump had known for "quite some time now" that he and Mattis "did not share some of the same philosophies ... have the same world view."

Mick Mulvaney told ABC's "This Week" that the president and his defense chief "just could never get on the same page" on Syria, adding that Trump had said since his presidential campaign that "he wanted to get out of Syria." Mulvaney said the president "is entitled to have a secretary of defense who is committed to that same

Asked whether Trump wanted a Pentagon leader willing to challenge him or someone in lock step with his views, Mulvaney said "a little bit of both."

"I've encouraged him to find people who have some overlap with him but don't see the world in lockstep with him," Mulvaney said.

Meanwhile, Senate Majority Leader Mitch McConnell, R-Ky., joined leading Republicans on foreign affairs in urging Trump to reconsider his decision to withdraw American forces from Syria and called it "a premature and costly mistake." They asked Trump to withhold a final decision for 90 days to allow time to study the impact of the decision, but Mulvaney told ABC that Trump wouldn't change his mind.

Just after tweeting the announcement about Shanahan, Trump said he had had "a long and productive call" with Turkey's president, Recep Tayyip Erdogan. Trump said they discussed IS, "our mutual involvement in Syria, & the slow & highly coordinated pullout of U.S. troops from the area. After many years they are coming home."

The routines of about 800,000 federal employees, meanwhile, were about to be disrupted.

More than half of those employees are deemed essential, such as U.S. Secret Service agents and Transportation Security Administration airport agents, must work without pay, though retroactive pay is expected. Another 380,000 were to be furloughed, meaning they will not report to work but would be paid later. Legislation ensuring that workers receive back pay was expected to clear Congress.

Trump had savored the prospect of a shutdown over the wall, saying he'd be "proud" to force one over an issue that was one of his biggest campaign promises. He had said he wouldn't blame Democrats for a shutdown but now blames them for not contributing to the 60 votes needed for such legislation to clear the closely divided Senate.

But Democrats aren't the only ones resisting Trump on the wall. Republican Sen. Bob Corker of Tennessee, who is leaving Congress in January and has criticized Trump on other issues in the past, called the border-wall fight a "made-up fight so the president can look like he's fighting."



Netflix named The Associated Press' Entertainer of the Year

AP Entertainment Writer NEW YORK — After a year like this, Netflix shows no signs of chill-

dominant online streamer started 2018 with almost 118 million subscribers, went on to win its first feature-film Oscar. briefly surpassed Disney as the most valuable U.S. media company, lured the likes of superstar show runners Shonda Rhimes, Kenya Barris and Ryan Murphy — not to mention Barack and Michelle Obama is expected to end the year with 146 million subscribers and a likely best picture Oscar nominee in "Roma."

In a sign of how influential the giant streamer has become, it also got what every celebrity gets — a gentle mocking on "Saturday Night Live.' The sketch comedy show's seasonending episode this month aired a fake ad highlighting Netflix's enormous effort to produce as much content as possible.

"Our goal is the endless scroll. By the time you reach the bottom of our menu, there's new shows at the top," explained the voice over.

For a dominating 12 months, Netflix has been named The Associated Press Entertainer of the Year, voted by members of the news cooperative.

"There's been so much amazing entertainment this year, and we're proud of the part we've played and humbled by this recognition from the AP," Ted Sarandos, Netflix's chief content officer, said Thursday after being told of the honor.

"We are thrilled to be working with the best creators who have helped us to entertain the world with shows, films and specials from Hollywood, Mumbai, Madrid, Seoul, Berlin and everywhere in between."

Netflix topped other candidates including Donald Glover, Ariana Grande, Bradley Cooper and Michelle Obama, among others. Previous AP Entertainer of the Year winners have included Lin-Manuel Miranda, Adele, Taylor Swift, Jennifer Lawrence, Lady Gaga, Tina Fey and Betty White.

Though Netflix doesn't release ratings, 2018 was a year when it seemed to really flex its digital muscles, showing off its deep reservoir of titles, from original unscripted shows to those produced in other countries. to even becoming a home for shows canceled elsewhere.

The company that once concentrated on sending DVDs through the mail in little red envelopes scored its first feature-film Oscar in March, with a best documentary trophy going to "Icarus," Bryan Fogel's investigation into doping in sports. (Netflix won its first ever Oscar last

year with the short doc "The White Helmets.")

Netflix movies, specials and shows were all over popular culture this year, including "The Kissing Booth," "Nanette," "To All the Boys I've Loved Before," "The Kominsky Method," "The Haunting of Hill House," "GLOW," "Lost in Space," "The Great British Baking Show," "Salt, Fat, Acid, Heat" and "Queer Eye." "House of Cards" — Netflix's first original series — debuted just six years ago.

It has backed such Oscar bait as "Roma" and "The Ballad of Buster Scruggs" and TV fans await more episodes from "Stranger Things," "The Crown" "Orange Is The New Black" and "Ozark." The company has even seen the phrase "Netflix and chill' part of the mainstream vocabulary. In May, Netflix's market capitaliza-

tion — or the total value of its stock shot higher than the capitalization for mighty Disney, previously the most valuable media company in the world. The Champagne-popping moment didn't last very long but it was a sign of how a maverick company could disrupt the order.

Netflix then knocked HBO off its longtime perch - 18 years - as the most nominated Emmy Award platform, eventually earning 112 nods. The streaming behemoth would go on to tie the premium cable network with 23 wins at the Emmy Awards. Netflix also dominated the television categories at the Screen Actors Guild Awards with 15 total nods, nearly double any other network.

Top filmmaking talent like Martin Scorsese, the Coen brothers and Michael Bay are working for Netflix, and the streaming giant convinced Charlie Brooker to bring his "Black Mirror" to its platform. It hired Channing Dungey from ABC Entertainment and Kira Goldberg from 21st Century Fox. It has promised to spend more than \$8 billion on content this year alone.

In 2019, Netflix will likely face stiffer challenges from the likes of Amazon, Hulu, Apple, WarnerMedia and Disney, as well as needing to handle its long-term debt. But Netflix is looking for more subscribers in India and South America and the company's market value is over \$100 billion.

"At Netflix, we're always working to give our members great choice

and a better rience, and we're excited about what's in store for 2019," Sarandos said.

'Aquaman' outswims 'Poppins,' 'Bumblebee' with \$67.4M debut

NEW YORK — In a flood of new releases, "Aquaman" easily swam past "Mary Poppins Returns" and "Bumblebee" to lead the busy pre-Christmas weekend with an estimated \$67.4 million over the weekend, according to studio estimates Sunday.

Without a "Star Wars" film on the December schedule for the first time in four years, a crowded slate of films sought to capitalize on the lucrative holiday period in theaters.

The DC Comics superhero film "Aquaman," which cost Warner Bros. \$200 million to make, arrived already a juggernaut overseas, where it has grossed more than \$400 million in three weeks of release. Including advance previews, the Jason Momoa-led "Aquaman" reeled in \$72.1 million in U.S. and Canada theaters, bringing its global total to \$482.8 million.

"Aquaman," directed by James Wan, has proven to be a stabilizing "Justice League" spinoff for Warner Bros. following bumpier DC releases outside of "Wonder Woman." The film garnered an A-minus Cinemas core from audiences.

For the studios, the weekend was as much about setting themselves up for Christmas to New Year's, when theaters are routinely packed through the week. With Christmas falling on a Tuesday, studio executives said the weekend was an unpredictable and distraction-filled one, competing with some of the busiest shopping days of the year. "We really kick off starting Tuesday,"

said Warner Bros. distribution chief Jeff Goldstein, who said the "Aquaman" performance came in just above the studio's \$65 million forecast. "With kids not really returning to school until January 7, this aligns the stars for us in a really positive Returns were more modest for Disney's

"Mary Poppins" sequel and Paramount's "Transformers" spinoff, though each had reason to expect strong business through "Mary Poppins Returns," starring Emily

Blunt and directed by Rob Marshall, debuted with \$22.2 million over the weekend and \$31 million since opening Wednesday. That was on the low side of expectations for the musical, which cost \$130 million to "May Poppins Returns," which co-stars

Lin-Manuel Miranda, will depend heavily on legs through the holiday season. On its side are good if not spectacular reviews (77 percent fresh on Rotten Tomatoes), an Aminus CinemaScore from moviegoers and four Golden Globe nominations.

"It's a great weekend to start yourself off on a launch pad into the holiday period," said Cathleen Taff, head of distribution for Disney. "We're looking forward to great word of mouth building over the next few weeks. And we're looking forward to a long

"Poppins" still narrowly edged "Bumblebee," which opened with \$21 million. That, too, is a soft beginning for a film that cost about \$135 million to make after tax credits. It's also far off the pace of the "Transformers" films, the last of which ("Transformers: The Last Knight") debuted with \$44.7 million in summer 2017.

But "Bumblebee," a "Transformers" prequel directed by Travis Knight and starring Hailee Steinfeld, has something the Michael Bay films never had: good reviews. "Bumblebee" was the weekend's most acclaimed new wide release with a 94 percent fresh rating on Rotten Tomatoes. Audiences also gave it an A-minus CinemaScore.

"The pre-Christmas preoccupation for moviegoers affected everyone. All movies were impacted slightly by that," said Kyle Davies, head of distribution for Paramount. "It doesn't concern me. We played really well with great reactions. The game plan has always been that we're now starting that play period where people go multiple times over the next few weeks, and that's the whole point."

"To me, this weekend was a dress rehearsal for the big push that starts Christmas Day," added Davies.

Also in the mix is Sony's well-reviewed 'Spider-Man: Into the Spider-Verse," which slid to fourth in its second week with \$16.7 million in ticket sales. The film also made one of the best debuts for an animated release in China where it was no. 1, grossing \$26.1 million over the weekend.

Clint Eastwood's "The Mule" added \$9.3 million in its sophomore frame, bringing its two-week total to \$35 million. Bradley Cooper, who co-stars in "The Mule," could also celebrate his "A Star Is Born" crossing \$200 million domestically.

Largely overlooked in the onslaught at theaters was STXfilms' "Second Act," starring Jennifer Lopez. The romantic comedy debuted with an estimated \$6.5 million in 2,607 locations, drawing an audience that was 70 percent female.

But the weekend's real flop was "Welcome to Marwen," the Robert Zemeckis-directed fantastical drama starring Steve Carell as an imaginative man whose scale model town helps him rehabilitate after a trauma. The film, which cost at least \$40 million to make, earned just \$2.3 million in 1,900 theaters. It's the second straight flop for Universal (which teamed with DreamWorks for "Marwen") following "Mortal Engines." That \$100 million film debuted last weekend with \$7.5 million film in ticket sales.

Yet the weekend managed to nearly equal the box office of the same weekend last year when "The Last Jedi" was in its second week of release and "Jumanji: Welcome to the Jungle" opened. Ticket sales for the "Star Wars"-less weekend were down a mere 2.1 percent, according to Comscore.



HONOLULU (AP) — Kouat Noi had 15 points, Jaylen Fisher added 14, and TCU never trailed in its 82-57 win over Charlotte on Saturday night in the Diamond Head Classic.

TCU (9-1), which has won six in a row, went on to play Bucknell in the semifinals Sunday.

Desmond Bane scored 10 for the Horned Frogs and Alex Robinson had 11 assists, tying the tournament's single-game record. The senior, who had 84 assists in one season at Texas A&M, has 506 at TCU — becoming just the third player in program history with at least 500 career assists.

Noi hit back-to-back 3s to cap an 11-0 run and, after Charlotte's Jailan Haslem made a layup, threw down a fastbreak dunk and then made another 3 to give TCU a 14-point lead with 2:36 left in the first half. The Horned Frogs took a 40-26 lead into the break and led by as many as 30 points in the second

Jon Davis led Charlotte (3-6) with 17

points and Jaylan McGill scored 13.

On Sunday, Desmond Bane scored 16 points to lead six TCU players in double figures and the Horned Frogs beat Bucknell 82-65 on Sunday night in the semifinals of the Diamond Head Classic.


TCU (10-1) will play Indiana State in the championship game on Tuesday





The bidding:

North East Pass Pass

Pass Opening lead — five of clubs.

Assume you're in four hearts and West leads a club. You can see at a glance that if either black-suit finesse were to succeed, you'd make the contract, so let's say you start out by taking the club finesse.

East wins dummy's queen with the king and shifts to the queen of diamonds. It doesn't particularly matter whether you win this diamond or the next one with the ace; sooner or later, you'll have to try a spade finesse to make the contract. When you do, East turns up with the king, and you go down one.


If by any chance you played the hand this way, you could try to assuage yourself by blaming the bad luck you had in losing both finesses. You could argue that the odds were 3-1 that at least one of the finesses would succeed. But this argument could be shot down by your partner, who might say with some asperity that you had blown an ice-cold con-

All you had to do, he might say, is go up with the ace of clubs at trick one, draw trumps, lead the queen of spades and finesse. True, you'd lose the queen to the king and East would cash the king of clubs before shifting to a diamond, but this would not stop you from making the contract.

You'd win the diamond with the ace, cash the jack of spades, cross to dummy with a trump and discard a diamond on the ace of spades. You could then concede your remaining diamond to the opponents, but you would have 10 tricks — six hearts, two spades, a club and a diamond to show for your efforts.



This Date In History

Today is Tuesday, Dec. 25, the 359th day of 2018. There are six days left in the year. This is Christmas Day.

Today's Highlight in History: On Dec. 25, 1991, Soviet President Mikhail S. Gorbachev went on television to announce his resignation as the eighth and final leader of a communist superpower that had already gone out of existence.

On this date:

In A.D. 336, the first known commemoration of Christmas on Dec. 25 took place in Rome.

In 1066, William the Conqueror was crowned King of England. Gen. George

In 1776, Washington and his troops crossed the Delaware River for surprise attack against Hessian forces at Trenton, New Jersey, during the American Revolutionary War.

In 1926, Hirohito became emperor of Japan, succeeding his father, Emperor Yoshihito.

New In 1931. York's Metropolitan Opera broadcast an entire live opera over radio for the first time: "Hansel and Engelbert by Humperdinck. In 1961, Pope John XXIII for-

mally announced the upcoming convocation of the Second Vatican Council, which opened in Oct. 1962.

In 1977, comedian Sir Charles Chaplin died in Switzerland at age 88.

In 1989, ousted Romanian President Nicolae Ceausescu (chow-SHES'-koo) and his wife, Elena, were executed following a popular uprising. Former baseball manager Billy Martin, 61, died in a traffic accident near Binghamton, New York.

In 1990, the World Wide Web, the system providing quick access to websites over the Internet, was born in Geneva, Switzerland, as computer scientists Tim Berners-Lee and Robert Cailliau (KAH'-yoh) created the world's first hyper-

linked webpage. In 1995, singer Dean Martin died at his Beverly Hills home

In 2006, James Brown, the "Godfather of Soul," died in Atlanta at age 73.

at age 78.

In 2009, passengers aboard Northwest Airlines Flight 253 foiled an attempt to blow up the plane as it was landing in Detroit by seizing Umar Farouk Abdulmutallab (OO'-mahr fah-ROOK' ahb-DOOL'-moo-TAH'lahb), who tried to set off explosives in his underwear. (Abdulmutallab later pleaded guilty and was sentenced to life in prison.)

Ten years ago: Pope Benedict XVI urged a world confronting a financial crisis, conflict, and increasing poverty not to lose hope at Christmas, but to join in "authentic solidarity" to prevent global ruin. Presidentelect Barack Obama spent a private Christmas with family and close friends in Hawaii. Singer, dancer and actress Eartha Kitt died in Weston, Conn. at age 81. Actress Ann Savage died in Los Angeles at

Five years ago: Pope Francis offered Christmas wishes for a better world, praying for protection for Christians under attack, battered women and trafficked children, peace in the Middle East and Africa, and dignity for refugees fleeing misery and conflict around the

One year ago: In his traditional Christmas message, Pope Francis called for a twostate solution in the Middle East, and prayed that confrontation could be overcome on the Korean Peninsula. Harsh winter weather gripped much of the country on Christmas, with bitter cold in the Midwest and a blizzard moving into New England. Russian election officials formally barred opposition leader Alexei Navalny from running for president, prompting him to call for a boycott of the March, 2018 vote.



CHRISTMAS LINEUP

Tuesday's slate starts with Milwaukee at New York, followed by Oklahoma City at Houston, Philadelphia at Boston, the Lakers at the Warriors and then Portland at Utah. It's Milwaukee's first Christmas game since 1977, which will end what was by far the league's longest Dec. 25 drought. Utah hasn't played on Christmas since 1997.

A look at each of the five games:

BUCKS AT KNICKS

Congratulations to the schedule-makers, because there's no way they could have known this Christmas game would be wrapped in animus. Giannis Antetokounmpo was peeved at New York forward Mario Hezonja — who dunked on him, stared at him and then stepped over him when the teams last met on Dec. 1.

THUNDER AT ROCKETS

A rematch of a game from Christmas 2017, which the Thunder won 112-107. Oklahoma City is 6-2 on Christmas since the team moved there; when the franchise was in Seattle, it was 0-11 on the holiday. Rockets star Chris Paul will miss Christmas for the third straight year — with the Clippers, he had a left hamstring strain and missed their game with the Lakers in 2016, sat out last year's Houston-OKC game with a groin strain and this year, it's another left hamstring issue that will keep him out.

76ERS AT CELTICS

These are heated, historic rivals, but they've met on Christmas only once before — in 1961, when the 76ers were the Syracuse Nationals. Boston, which famously avoided home Christmas games forever (the Celtics played their first 30 such games away from Boston), will be at home on the holiday for the second consecutive season.

LAKERS AT WARRIORS

It's the 20th consecutive Christmas appearance for the Lakers, and with LeBron James there now don't expect that streak to end anytime soon. Warriors star Kevin Durant apparently loves playing on the holiday; he's averaging 31.1 points in his eight previous Christmas games.

TRAIL BLAZERS AT JAZZ

Portland is 14-3 all-time on Christmas, and could tie Miami (10-2) for the best winning percentage on the holiday if it tops the Jazz. Meanwhile, for Utah, it's a chance for Jazz star guard Donovan Mitchell to get his first — but almost certainly not his last look at playing on Christmas.

CHRISTMAS HISTORY

The NBA's five-game Christmas lineup is back for an 11th consecutive year, and that may seem like a lot of matchups but has been exceeded plenty of times in the past. There were seven games on the holiday in 1949, 1971 and 1977, as well as six in 1970 and 1976.

And there were some years where everybody played on Christmas.

In 1952, the league had 10 teams so that meant five Christmas games. In 1956, the league's eight teams got together for two Christmas doubleheaders two games at Madison Square Garden, two others at the War Memorial in Rochester, New York. And in 1959, eight teams meant four games on the holiday again.

With Milwaukee playing, the league's longest Christmas drought will belong to the Atlanta Hawks, who haven't appeared on the holiday since 1989. After the Hawks, the longest droughts will be held by Charlotte (no appearances in 29 seasons), Memphis (no appearances in 24 seasons), Toronto (2001), Sacramento (2003), Indiana (2004) and Detroit (2005).

Houston set the NBA record for 3-pointers made in a game with 26, doing that against Washington

It cemented that, without question, 2018 in the NBA was the year of the 3-pointer.

So far this season, 11 franchises — Atlanta, Boston, Charlotte, Golden State, Houston, Milwaukee, Minnesota, New Orleans, New York, Sacramento and Utah — have set or tied team records for 3-pointers made in a regular-season game. That doesn't even take into account Brooklyn, Chicago, Denver, Detroit, Oklahoma City and Philadelphia also doing it in 2018, albeit last season.

Maybe the craze hasn't caught on in Canada.

The longest-standing team record for 3s in a game is held by the Toronto Raptors, who made 21 on March 13, 2005. Orlando's mark of 23 has stuck since Jan. 13, 2009 and Phoenix's record of 22 came on Nov. 14, 2010.

Meanwhile, Zaza Pachulia's quest for a 3 contin-

Pachulia has the NBA record for most 3s attempted in a career without a make — the Detroit backup center is now 0 for 29 in the regular season, 0 for 31 when including playoffs. He's 0 for 3 in 2018, though all those tries in this calendar year were desperation heaves from midcourt or deeper. And in fairness, only six of his career 3-point tries have been shots inside of 30 feet.
