Howard County Teen Court seeks director By ROGER CLINE

Do you have a passion for

helping young people succeed? Would you like a parttime job building a program to help teens stay out of trouble? You might be just who the Howard County Teen Court is looking for.

"We are advertising and putting out the call for our director position," said Big Spring ISD Truancy Officer and Teen Court Board President Dana Rodriguez. "We have a couple of resumes that have been turned in, they heard us on the radio talking about it."

Rodriguez said the Teen Court was recently re-established after several years out of operation.

"Howard County Teen Court had been around years ago," she said. "It was approved to be re-established earlier this year by the Big Spring City Council, and members of the Howard County Teen Court Board of Directors have been continually working hard to get the program started."

According to the job de-

scription sent out by Rodriguez for the executive director's position, the director "Will have overall strategic and operational responsibility for Teen Court programs, expansion, and execution of its mission.'


"Responsibilities include meeting with teens, parents, judges, attorneys, etc.; holding Teen Court sessions twice per month in the evenings, attend juvenile court hearings, speak at various schools to solicit teen volunteers, facilitate board meetings, organize fundraiser(s), approximately 12 office hours per week," says

the job description. "Right now, it is a part-time job, and we hope that it goes into a full-time job. Right now, it is part time because we're just starting," said Rodriguez. "It's going to be very much a growing job. As we get going and as things grow, it will grow into a full-time job. I would actually like to see the program grow into a two- or three-person job, but because of funding right now

we're starting small." Rodriguez said the position





HUNTSVILLE. Texas (AP) — A 61-year-old Texas inmate was set to be executed Wednesday for killing a Houston police officer more than three decades ago during a robbery.

Robert Jennings was condemned for the July 1988 slaying of Officer Elston Howard during a robbery at an adult bookstore.

Jennings would be the first inmate put to death this year both in the U.S. and in Texas, which is the nation's busiest capital punishment state.

His attorneys have asked the U.S. Supreme Court to delay the execution, arguing Jennings' trial attorneys failed to ask jurors to fully consider evidence — including details of his remorse for the officer's shooting, troubled childhood and possible brain damage — that might have spared him a death sentence.

Jennings got an execution stay in 2016. Lower appeals courts have rejected his request to delay Wednesday's execution and the Texas Board of Pardons and Paroles has turned down Jennings' request to commute his sentence.

A twice convicted robber, Jennings had been on parole for about two months when prosecutors say he entered Mr. Peeper's Bookstore with the intention of robbing the business. Since being paroled, Jennings had gone on a crime spree, committing about 10 robberies, including having already robbed the adult bookstore 12 days before Howard's

The 24-year-old Howard was in the middle of arresting the store clerk for operating a pornographic video arcade without a permit when Jennings shot the officer twice in the head.

Howard, who had been wearing a jacket with the words "Houston Police" on it, staggered for a few feet before falling to the ground, where he was shot

twice more by Jennings. The clerk later testified the shooting was so quick, Howard never had a chance to unholster his gun.

Jennings was arrested hours later when he went to a Houston hospital after being shot in the hand by his accomplice, who got angry at Jennings for shooting the officer.

Joe Gamaldi, the president of the Houston Police Officers' Union, said Jennings has spent more time on death row than Howard was alive.

Howard "was an honorable man full of integrity who did his job. He was absolutely one of the best and he was just taken entirely too soon by this animal who murdered him in cold blood," Gamaldi said.

After his arrest, Jennings confessed killing Howard, telling police in a tape-recorded statement he was remorseful about what happened and would "face what-

late attorneys, said the inmate's trial attorneys failed to present sufficient evidence of his remorse as well as his history of brain damage, being abused as a child and drug addiction. He said the trial attorneys also failed to provide an instruction to jurors that would have allowed them to give sufficient weight to these aspects of Jennings' life when they deliberated. Mallett said a prior appellate attorney also failed

to argue these issues in earlier appeals. "There has not been an adequate presentation of

his circumstances including mental illness and mental limitations," Mallett said. Jennings' trial in 1989 took place just as the Su-

preme Court issued a ruling that faulted Texas' capital sentencing statute for not allowing jurors to consider evidence

supporting a sentence less than death. The Texas Legislature changed the statute to

address the high court's concerns but that took place after Jennings was convicted. The Texas Attorney General's Office called Jennings' claim he had ineffective lawyers at

his trial and during earlier appeals "specious," and said appeals courts have previously rejected allegations his personal history was not adequately investigated and presented at his trial.

"My hope is that on Wednesday (Howard's family gets) the closure that they've been searching for for 30 years," Gamaldi said.

Chief: Injured Houston officer shot 3 times in line of duty

HOUSTON (AP) — Houston's police chief says one of four narcotics officers shot while serving a search warrant at a suspected drug house has been struck by gunfire two other times during his ca-

Police Chief Art Acevedo said Tuesday that the 54-year-old police supervisor, whose name hasn't been released, was also shot in 1992 and 1997. Acevedo didn't provide details of the other shootings.

Acevedo says that the officer told him in a note that he had to go into the house Monday after his colleagues were shot because he knew his "guys were down." Acevedo described the officer as "tough as nails."

He says: "The only thing bigger than his body, in terms of his stature, is his courage."

Two suspects were killed during the raid.

Top Harris County official questions \$105M Houston Astrodome plan

HOUSTON (AP) — The top official in the county home to the Houston Astrodome is raising questions about a \$105 million plan to redevelop the long-vacant sports stadium into a parking garage and events venue.

The Houston Chronicle reports that Harris County Judge Lina Hidalgo questioned the project's costs last week after learning the funding doesn't include air conditioning. Hidalgo says she's making sure the plan is fiscally responsible for the iconic stadium that hasn't housed a professional sports team for nearly two decades.

County Engineer John Blount says air conditioning was never part of the initial cost, but will be pursued later.

County commissioners last year approved the renovations that include 1,400 parking spaces and upgrades for music festivals and other events. Crews began preparing the stadium for redevelopment in October.

Trial opens for man charged with abducting 2 Texas sisters

AUSTIN, Texas (AP) — Prosecutors say a man who abducted two sisters and is suspected of killing their mother had moved into their Central Texas home to help look after the girls.

Terry Allen Miles is on trial for kidnapping charges for allegedly abducting the girls and feeling to Colorado in December 2017.

Prosecutors said during opening statements Tuesday that Miles admitting taking the girls. His attorneys say Miles was protecting the pair from their mother's chaotic and illicit lifestyle.

Defense attorneys say Miles had no part in the death of the girls' mother. Investigators have said the woman was found dead from apparent blunt force trauma at her home in Round Rock. The officer who found her was conducting a welfare check after she didn't show up at work.

Authorities say Miles was found days later in a remote area of southern Colorado.

Judge: Texas man accused in

hazing death must give phon passcode

BATON ROUGE, La. (AP) - A judge says a former Louisiana State University student charged in the alcohol-related hazing death of a fraternity pledge must give prosecutors the passcode to his seized cellphone.

The Advocate reports the judge ruled Monday that 20-year-old Matthew Alexander Naquin of Fair Oaks Ranch, Texas must give prosecutors the phone's password. The East Baton Rouge Parish District Attorney's Office confiscated the phone but had been unable to access its content because it's password-protected.

Naquin is charged in the death of 18-year-old Max Gruver of Roswell, Georgia. Gruver died last year after a Phi Delta Theta hazing ritual that required pledges to chug hard liquor.

Naquin is scheduled to stand trial July 8. Ryan Matthew Isto and Sean-Paul Gott have pleaded no contest to misdemeanor hazing in Gruver's death.

ACLU slams Texas' findings on potential non-citizen voters

AUSTIN, Texas (AP) — Civil rights groups demanded Monday that Texas officials walk back their recent suggestion that tens of thousands of non-citizens may have voted in the state since 1996, an announcement that spurred President Donald Trump to renew unsubstantiated claims of rampant voter fraud.

The ACLU, along with a dozen other voter and minority rights groups, sent state election officials a letter calling the state's method for identifying non-citizens "deeply flawed" and warning that local officials who took voters off their rolls based on those records risk violating federal law.

The backlash came after the Texas secretary of state's office announced Friday that 95,000 people identified as non-citizens in the state's driver's license and ID databases appeared to match individuals in voter registration records. About 58,000 of those people voted in at least one election, state officials said.

Trump seized on the announcement over the weekend, tweeting: "58,000 non-citizens voted in Texas, with 95,000 non-citizens registered to vote. These numbers are just the tip of the iceberg. All over the country, especially in California, voter fraud is rampant. Must be stopped. Strong voter

But on Monday, several Texas county election chiefs said they didn't know how many of these alleged matches would hold up once they investi-

Even Republican Texas Attorney General Ken Paxton, a Trump ally who said last week his office

was ready to prosecute cases, told supporters in a fundraising email that "many of these individuals may have been naturalized before registering and voting, which makes their conduct perfectly legal.'

Nearly 16 million people in Texas are registered to vote. The potential non-citizen matches found by the state go back as far as 1996, said Sam Taylor, a spokesman for the Texas secretary of state's office.

Taylor said Monday that his office used "our strongest possible matching criteria to make sure each of the matches was the same person." He said that although county election chiefs were instructed Friday in a written advisory to treat the names as "WEAK matches" while they investigate, Taylor said it did not "mean the criteria used to match the names was weak."

But voting rights groups remain skeptical about the list, which has not been made public.

"The methodology your office apparently employed to identify such voters looks deeply flawed, and its origins and intent are highly suspect," the letter reads.

Lisa Wise, the election administer in El Paso County along the U.S.-Mexico border, said she received a list of 4,100 potential non-citizens. She said her office would investigate, but that after a first scan she could tell all of the names wouldn't hold

Wise said that at naturalization ceremonies for new U.S. citizens, her office registers between 150 and 200 to people alone.

"Anything is possible," she said. "But I can tell just from our list, and I don't know what anyone else's looks like, but I can tell that universe is going to continue to shrink.'

Delay in producing evidence may delay school shooting trial

GALVESTON. Texas (AP) The trial of a Texas school shooting suspect may be delayed for a year as federal investigators have yet to deliver key evidence, prosecutors said Monday.

The disclosure came at a 10-minute status conference in a Galveston courtroom where, by closed circuit video from jail, Dimitrios Pagourtzis made his first public appearance since his arrest at Santa Fe High School. The 18-year-old student is accused of a May 18 rampage at the school that left 10 people dead

Galveston County District Attorney Jack Roady told state District Judge John Ellisor that his staff still awaits a "substantial amount of evidence" from the FBI and the Bureau of Alcohol, Tobacco, Firearms and Explosives. The defense team said they'd be ready for trial this year.

About three dozen of the victims' family members attended the hearing. Some wept as the proceedings unfolded with the shooting suspect onscreen, and one woman fled the courtroom in

Ellisor set another status hearing in about three months, at which point Roady said he expected to have the evidence developed by the federal agencies.

The defense team has asked Ellisor to move the trial from Galveston, citing publicity surrounding the case that could prejudice potential jurors and prevent a fair trial. Prosecutors said they would respond to the change-of-venue motion by Friday, at which point a hearing on the motion could be scheduled.

SANFORD, Fla. (AP) — A Florida man killed his parents and brother after he was kicked out of his home and accused of stealing \$210,000 from his family to send to a woman he had met on a porn website, according to a sheriff's office.

Grant Amato, 29, has been charged with three counts of first-degree murder in the deaths of his parents, Chad and Margaret Ann Amato, and brother Cody. Seminole County Sher-

iff's Office deputies found the victims' bodies Friday in their Chuluota home after a co-worker reported that Cody Amato had not

Grant Amato was arrestout bail Monday.

According to an affidavit, Cody Amato's girlfriend told deputies Grant Amato had stolen \$60,000 and guns from his brother. She said Grant Amato out of a training program to become a nurse anesthetist and stole the money to talk to a Bulgarian woman he met online. She also said Cody Amato told her he was afraid Grant "would kill everyone."

Another brother, Jason Amato, told investigators Grant had stolen \$150,000 from their father, including a loan taken out on his parents' house, and had sent the woman over \$200,000 in a three-month period. In an interview with in-

vestigators, Grant Amato said he had argued with his parents over his relationship with the woman he met through an adult website in June, and that his parents told him he could have no contact with her if he wanted to continue living at their

Amato said he began a 60-day internet- and sexaddiction treatment program in Fort Lauderdale in late December at his

left Jan. 4.

"Grant Amato initially agreed to the rules his father had set, but he didn't think they were fair because he felt that the Bulgarian female was his girlfriend and they had a relationship," the affidavit

According to the affidavit, in response to seeing crime-scene pictures of his parents and brother, Amato said "his family had been blaming him for months for ruining their lives ... so he might as well be blamed for this, too."

"There's some issues there, I think we have some mental health issues," Jeffery Dowdy, Amato's public defender, told WOFL-TV.

Amato is scheduled for arraignment March 26.

The Orlando Sentinel reported that last year, authorities responded twice to calls about Amato's behavior.

In June, Orlando po-

parents' request, but he lice responded to AdventHealth Orlando, where he worked as a nurse, about a report of a suicidal person. Officers said Amato did not meet the criteria to be held for observation as a danger to himself or others, but he was arrested on a grand theft charge for allegedly stealing vials of Propofol, a powerful sedative.

Amato said he took the drug for patients who were not "adequately relaxed by doctor-ordered medication," according to a police report. Prosecutors opted against filing charges against him.

On Dec. 20, his mother and brother reported that Amato was missing, depressed and possibly suicidal after losing his job and failing out of school. They also told deputies Amato had access to guns.

Jail records did not show whether Amato had an attorney.

FBI finds no specific motive in Vegas shooting

Associated Press LAS VEGAS (AP) — A high-stakes gambler

who rained a hail of gunfire down on a crowd of country music fans, killing 58, took any specific motive for the 2017 attack to his grave, the FBI said Tuesday as it concluded the investigation into the deadliest mass shooting in modern U.S. history. The agency found no "single or clear moti-

vating factor" to explain why Stephen Paddock carried out the attack from his suite in a high-rise casino hotel. The 64-year-old fatally shot himself as police closed in. "It wasn't about MGM, Mandalay Bay or a

specific casino or venue," Aaron Rouse, the agent in charge of the FBI's Las Vegas office, told The Associated Press. "It was all about doing the maximum amount of damage and him obtaining some form of infamy." The finding was contained in a long-awaited

report compiled by the FBI's Behavior Analysis Unit, a group of experts who spent months examining several factors that might have led to the rampage. "This report comes as close to understand-

ing the why as we're ever going to get," Rouse Almost 900 people were hurt during the Oct.

1, 2017, attack on an outdoor concert. Paddock wanted to die in infamy, inspired

in part by his father's reputation as a bank robber who was once on the FBI most wanted list, the report said. In many ways, he was similar to other active shooters the FBI has studied.

His "decision to murder people while they were being entertained was consistent with his personality," the report said.

The gunman was not directed or inspired by any group and was not seeking to further any agenda. He did not leave a manifesto or suicide note, and federal agents believe he had planned to fatally shoot himself after the attack, according to the re-

Paddock was a retired postal service worker, accountant and real estate investor who owned rental properties and homes in Reno and in a retirement community more than an hour's drive from Las Vegas. He also held a private pilot's license and liked to gamble tens of thousands of dollars at a time playing high-stakes video poker. His younger brother, Eric Paddock, called him

the "king of microaggression" — narcissistic, detail-oriented and maybe bored enough with life to plan an attack that would make him famous. His ex-wife told investigators that he grew up with a single mom in a financially unstable home and he felt a need to be self-reliant.

Police characterized him as a loner with no religious or political affiliations who began stockpiling weapons about a year before the attack. He spent more than \$1.5 million in the two years before the shooting and distanced himself from his girlfriend and family. He sent his girlfriend, Marilou Danley, to visit

her family in the Philippines two weeks before the attack and wired her \$150,000 while she was there. Danley, a former casino worker in Reno, returned to the U.S. after the shooting and told authorities

that Paddock had complained that he was sick and that doctors told him he had a "chemical imbalance" and could not cure him.

Danley, who is Catholic, told investigators that Paddock often told her, "Your God doesn't love me."

A Reno car salesman told police that in the months before the shooting Paddock told him he was depressed and had relationship troubles, and his doctor offered him antidepressants. Paddock would only accept a prescription for anxiety medication, the salesman said.

Paddock's gambling habits made him a soughtafter casino patron. Mandalay Bay employees readily let him use a service elevator to take multiple suitcases to the \$590-per-night suite he had been provided for free. Authorities said he asked for the room, which had a commanding view of the Strip and the Route 91 Harvest Festival concert grounds across the street.

The night of the massacre, Paddock used assaultstyle rifles to fire more than 1,000 rounds in 11 minutes into the crowd of 22,000 music fans. Most of the rifles were fitted with rapid-fire "bump stock" devices and high-capacity magazines. Some had bipod braces and scopes. Authorities said Paddock's guns had been legally purchased. Las Vegas police closed their investigation last

August, and Clark County Sheriff Joe Lombardo declared the police work complete after hundreds of interviews and thousands of hours of investigative work. Lombardo vowed never to speak Paddock's name again in public.

A separate report made public in August involving the Federal Emergency Management Agency found that communications were snarled during and after the shooting. It said police, fire and medical responders were overwhelmed by 911 calls, false reports of other shootings at Las Vegas casinos and the number of victims.

Hotel security video and police body camera recordings made public in a public-records lawsuit filed by media organizations including the AP showed police using explosives to blast through the door of the 32nd-floor hotel suite where Paddock was found dead.

He left behind nothing that offered an explanation.

"He acted alone. He committed a heinous act. He died by his own hand," Rouse said. "If he wanted to leave a message, he would have left a message. Bottom line is he didn't want people to know."

Arrests in Brazil dam disaster, dead fish wash up downstream

BRUMADINHO, Brazil (AP) — Brazilian authorities arrested five people Tuesday in connection with a dam collapse that killed at least 65 people and left nearly 300 missing, and dead fish were seen downstream floating at the banks of a river that an indigenous community depends on for food and water.

The dam that held back iron-ore waste, owned and operated by big mining company Vale SA, collapsed on Friday — burying a company cafeteria, other Vale buildings and inundating part of the small southeastern city of Brumadinho.

Grieving relatives of the dead buried some of the victims in Brumadinho and rescue teams continued a delicate search through swaths of muck for more victims or survivors. One official said the death toll was sure to rise.

The dead fish and trash were seen by a reporting team for The Associated Press about 18 kilometers (11 miles) downstream from the dam along the banks of the Paraopeba River.

The Pataxo Indians living alongside the river who use it to fish, bathe and gather water for the plants they cultivate as food were told by Brazilian environmental officials that they should no longer do so, said Hayo, the village chief who goes by one

"We used the river to take baths, to fish, to water our plants and now we can't do any of that," said Hayo, wearing a large feathered headdress and a red and black-beaded neckless. "We can't even water our plants because they say it damages the soil."

Two agents with the Brazilian Institute of Environment and Renewable Natural Resources, the country's environmental enforcement agency, took water samples and talked with tribe members but said they were not authorized to speak about their findings. The agency did not immediately respond to an email seeking comment.

The signs of possible ecological consequences came as the arrests of company workers with links to the dam were made in Sao Paulo and in the state

Three of the arrested worked for Vale, the company said, adding that it was cooperating with investigating authorities.

A German company that has inspected the dam said two of its employees were arrested. The Munich-based TUEV Sued company declined to specify whether the arrested staff were from its German headquarters or its Brazilian branch.

In ordering the arrests, Minas Gerais state judge Perla Saliba Brito wrote that the disaster could have been avoided

It's not believable that "dams of such magnitude, run by one of the largest mining companies in the world, would break suddenly without any indication of vulnerability," the judge wrote in the decision, according to news portal UOL.

Authorities said the five will be detained for 30 days while officials investigate possible criminal responsibility.

At a cemetery in Brumadinho, 15 freshly dug graves awaited the remains of some of those killed.

Wailing in grief at the cemetery was the wife of Edgar Carvalho Santos, one of the mining company's workers whose body has been found.

"He did not deserve this, he did not deserve it!" she sobbed.

Friends and family members prevented reporters from approaching the woman. One woman told Santos' wife that "this was not a

tragedy, it's a crime." It was a sign of the growing anger directed at Vale over the disaster. The company is one of Brazil's largest and a key

employer in Brumadinho, but many residents have complained that a siren that should have gone off to warn people to evacuate never sounded.

Military police Col. Evandro Borges told reporters that the official death toll was 65, though more bodies had been recovered Tuesday and that an updated death toll would be provided later in the day. He said 288 people were still missing, most of them Vale employees.

Vale is the world's largest producer of the ore, which is the raw ingredient for steel.

Many employees were eating lunch last Friday when the dam collapsed, burying a cafeteria and other company buildings.

The company's American depository shares on the New York Stock Exchange were up 3 percent Tuesday afternoon on the New York Stock Exchange, to \$11.54 each, after falling nearly 18 percent on Monday.

French jihadis will return home, and to prison, from Syria

PARIS (AP) — France's government is preparing for an influx of homegrown jihadis with the departure of U.S. troops from Syria, saying Tuesday that anyone who left to fight for Islamic extremists will go straight to

In an interview with BFM television, Interior Minister Christophe Castaner said that a handful of French jihadis had already returned and more would follow soon. Neither he nor France's foreign ministry confirmed BFM's report that as many as 130 could come back within weeks.

"The Americans are leaving Syria. It's important to keep that in mind," Castaner said. "There are a certain number who are imprisoned because the Americans are there, and they will be freed. They will want to return to France."

The question of what to do with foreigners who joined the Islamic State group has grown increasingly thorny as the U.S. departure looms.

French jihadis made up the largest contingent of European recruits, and in 2015 and 2016 an Islamic State cell of French and Belgian fighters who sneaked in from Turkey attacked Paris and Brussels.

Britain refuses to take back citizens who joined the group and has stripped their citizenship. Other European

countries have remained largely silent about the fate of men and women whom many see as a security threat.

"These are people who have voluntarily joined a terrorist organization ... that has committed attacks in France and continues to threaten us, France's foreign ministry said.

Castaner said all would be jailed immediately in France and face trial. but declined to provide details.

Kurdish authorities in Syria have detained 900 foreign members of the group, and 4,000 family of IS members, according to Ilham Ahmed, a senior Syrian Kurdish official. Russia has taken some of the recruits back and jailed them.

The Syrian Observatory for Human Rights said there are at least 78 French women and children who had recently come out of the last stronghold of IS in eastern Syria. This is in addition to another 65 previously evacuated from other IS held areas and in Kurdish custody. It was not clear if Castaner was also speaking of civilians and families of IS members.

Castaner said a small number had already returned to France, although it's not clear whether they had voluntarily surrendered or were repatriated, or whether he meant fighters or their families.

In April, then-Defense Secretary Jim Mattis said French special forces had joined American troops in Syria.

south highway linking Athens and Thessaloniki at Nikaia, outside the northern city of Larissa, forcing long traffic diversions.

Others are threatening similar action elsewhere in Greece. They are protesting tax hikes and pension mea-

sures imposed during Greece's bailout programs, and what they describe as unfair practices from large buyers

Gay's buzzer beater gives Spurs 126-124 win over Suns

SAN ANTONIO — The San Antonio Spurs mobbed Rudy Gay after his game-winning shot against Phoenix, but that celebration got a cold dose of reality once they hit the locker room.

Gay hit a 21-foot jumper at the buzzer and the Spurs overcame Devin Booker's 38 points to escape with a 126-124 victory Tuesday night, extending the Suns' losing streak to nine games.

"We were really fortunate to win the game," San Antonio coach Gregg Popovich said. "I thought that they outplayed us, outcoached us, outphysicaled us, out-executed us. We had no respect for them or for the game. We didn't play with each other. It was a pathetic performance, and Phoenix got robbed."

The Suns lost their previous four games by an average of 23 points and were without top draft pick Deandre Ayton, but the Spurs needed a clutch shot at the buzzer to win.

"It's a win," Gay said. "I'm not happy about how it happened, but we got a win. That's part of being a good team you've got to find ways to get wins." LaMarcus Aldridge had 29 points

and 14 rebounds for San Antonio, which is 2-0 on a four-game homestand despite playing without injured DeMar DeRozan. Gay finished with 16 points, five rebounds and five assists. The Suns lost their 11th straight in

San Antonio even as Booker matched his season high in points. "Dropping nine straight and losing

three or four to game-winners, you realize that you have to be locked in the whole game," Booker said. "It's not just the final shot."

Phoenix tied this one with 19.6 sec-

onds remaining. Booker stole a pass from Marco Belinelli and fed Josh Jackson for an uncontested dunk to make it 124-all.

With time winding down, Gay was isolated and pulled up off the dribble for a jumper over Kelly Oubre Jr. on the left wing as the clock expired to help San Antonio avoid an upset.

"Salute to Rudy for hitting that," Ou-

The Spurs entered allowing 109.7 points per game, 13th in the NBA, but struggled to contain the Suns. Phoenix had six players score in double figures, including 22 points by Jamal Crawford.

"We're just not as physical as we were when we were really playing well," said San Antonio point guard Derrick White, who had 15 points. "We have moments where we're doing the right things but we haven't been consistent with it."

The Suns were 13 for 29 on 3-pointers and shot 60 percent from the field to turn a 12-point deficit in the third quarter into a near victory.

San Antonio went on a 14-2 run starting midway through the third in taking a 94-82 lead. Phoenix pulled to 96-95 early in the fourth, 106-105 halfway through the period and 119-118 with two minutes remaining.

"We just weathered the storm," Crawford said. "They threw some haymakers at us and we didn't fold. We showed some growth and continue to push forward. We gave ourselves a chance, that's all you can ask for."

The Spurs finished with seven players in double figures, including every starter. Davis Bertans had 18 points and Belinelli scored 17 off the bench.



The trouble comes when an unusual situation develops that really belongs in the safety-play family, and the declarer is unable to relate it to a previous experience. Unaware that

through experience or in textbooks devoted to the play of the cards.

safety measures are necessary, he plunges ahead without taking precau-

tions against a potential danger. As a result, he may sometimes go down in a contract that could have been made. Take this case where South was in

five diamonds. He won the spade lead with the ace and led a diamond. East took the ace and returned a spade. West ruffed, and South had to go down one — but he could have made the contract with the aid of an unusual play.

When declarer first sees dummy,

he should realize that the primary threat to his contract is a spade ruff. Given East's opening spade bid, this is certainly a realistic possibility.

After this danger registers on

South, he should start looking for a way to protect against the ruff. It should also occur to him that ordinary measures will not avert defeat if West really does have only one spade.


Once declarer is thinking along

these lines, it should not take him long to find the solution: Win the spade lead with dummy's king, cash the ace of hearts and discard the ace

From then on, he has smooth sailing. Dummy leads a diamond, taken by East with the ace. Declarer ruffs the spade return, and West cannot overruff. South then draws trumps and concedes the ace of clubs, and the contract is home safe and sound.





Today's Highlight in History:

On Jan. 30, 1948, Indian political and spiritual leader Mohandas K. Gandhi, 78, was shot and killed in New Delhi by Nathuram Godse (neh-too-RAHM' gahd-SAY'), a Hindu extremist. (Godse and a co-conspirator were later executed.)

In 1649, England's King Charles I was executed for high treason.

Adolf Hitler marked the 12th anniversary of his appointment as Germany's chancellor with his last public speech in which he called on Germans to keep resisting until

In 1962, two members of "The Flying Wallendas" high-wire act were killed when their seven-person pyramid collapsed during a performance at the State Fair Coliseum in Detroit.

In 1968, the Tet Offensive began during the Vietnam War as Communist forces launched surprise attacks against South Vietnamese towns and cities; although the Communists were beaten back, the offensive was seen as a major setback for the U.S. and its allies.

In 1969, The Beatles staged an impromptu concert atop Apple headquarters in London; it was the group's last public performance.

In 1972, 13 Roman Catholic civil rights marchers were shot to death by British soldiers in Northern Ireland on what became known as "Bloody Sunday."

In 1973, the rock group KISS performed its first show at a club in Queens, N.Y.

In 1981, an estimated 2 million New Yorkers



turned out for a tickertape parade honoring the American hostages freed from Iran.

In 1993, Los Angeles inaugurated its Metro Red Line, the city's first modern subway.

In 2006, Coretta Scott King, widow of the Rev. Martin Luther King Jr., died in Rosarito Beach, Mexico, at age 78.

Osetkowski, defense lead Texas past No. 11 Kansas 73-63

AUSTIN. Texas Three days after he declared the Texas season at a crossroads, Longhorns senior forward Dylan Osetkowski let his wide body do the talking.

A 73-63 win over No. 11 Kansas, Texas' first against the Jayhawks since 2014, is certainly one step in the right direction.

Osetkowski scored 16 points and Texas used stifling defense Tuesday night in snapping a 10-game losing streak to Kansas. Texas trailed for just nine seconds in the opening minute and batted away every run the Jayhawks made late.

Kerwin Roach scored 15 points and Jase Febres scored 12, knocking down three the second half.

"We've been talking about our identity being defense for a long time now," Osetkowski said. "I think tonight we showed that."

Texas held Kansas' leading scorer Dedric Lawson without a point in the first half, and held the Jayhawks to their fewest points in a half this season. Just three days earlier, the Longhorns gave up 98 in a loss to Georgia in Big 12/SEC Challenge.

Coach Shaka Smart's team limped home after that defeat, the fifth in six games, and held a players-only meeting to sort things out before the team shootaround Tuesday.

"A sense of urgency," Osetkowski said. "We talked about it before the game. We knew what we wanted to do, what we had to do. Coach always talks about being the aggressor. We did that."

Back in the Big 12, Texas (12-9,

4-4) knocked the Jayhawks (16-5, 5-3) out of first place, at least temporarily. Kansas, which has won at least a share of the Big 12 title the last 14 years, has lost three of its last four and this week fell out of the Top 10 for the first time this season.

Freshman Ochai Agbaji scored 24 for Kansas in his first career start. He'd only played in six games and his previous high was 10 points.

Kansas needed a big body on Osetkowski, who was a physical presence the Jayhawks couldn't match early in the second half as he bullied his way to the basket for layups and rebounds or kicked out cross-court passes for 3-pointers. Osetkowski scored six points in a run that pushed the Texas lead to nine early in the second half.

"Osetkowski, he played to his size, especially when we went small,'

Kansas coach Bill Self said.

Kansas cut the lead to 48-45 before Febres made two 3-pointers two minutes apart for the cushion Texas needed. Febres made another with 1:22 left that put Texas up 63-56. Texas made 21 of 23 free throws.

Smart, who is 62-59 in his four seasons at Texas, got his first win over the Jayhawks.

"Feels great, but it's more about we needed to win this game for us, regardless of who the opponent was," Smart said.

BIG PICTURE

Kansas: Kansas looked befuddled early by Texas' defense, which harassed the guards on the perimeter and denied the Jayhawks on just about every chance at getting close to the basket. Kansas scored just 23 points in the first half and the Jayhawks looked like they could get blown out until an 11-1

run late in the period. Kansas never cleaned up sloppy ball-handling that led to 13 turnovers, several of them coming in the second half.

Texas: Freshman forward Jaxson Hayes set the defensive tone with two blocks in the first two minutes and a soaring, two-handed dunk on the other end. Hayes leads the Big 12 in blocks and ranked first nationally among freshmen with 2.65 per game coming in. That sort of defensive effort could carry Texas a long way through the second half of the Big 12 schedule.

ROAD WOES

All five Kansas' losses have been on the road. "I've got to be consis-

tent so we have our best chance to win. When I played average or below average, we lost," AP photo said Lawson, who finafter his scoreless first half. "We've got to find

ways to win on the road. ... Do something different, change shoes or something."

ROACH'S WILD RIDE

Roach had been the goat in a twopoint loss at Kansas two weeks ago when he was out of position as Texas tried but failed to set up a winning shot. He came out firing in the rematch, making three 3-pointers in the opening minutes.

Roach didn't score again until the closing seconds when he was 6 of 6 from the line in the final 41 seconds, and those came after he had thrown the ball away on a wild turnover seconds earlier. He made up for the turnover on Texas' next possession when he chased down a rebound on a missed free throw.

"I was 0-7 against KU. Now I'm 1-7," Roach said. "I'll take it."


