Country Artist Mark Chesnutt, whose hit "Too Cold at Home" reached number three on Billboard's Country chart; and '80s heavy metal group Ratt, whose metal anthem "Round and Round" was named 61st best hard rock song of all time by VH1, have been named headliners for this year's Funtastic Fourth Celebration June 28 and 29. The event takes place at the Howard County Courthouse in downtown Big Spring each

summer.  
 "Rick Trevino, Mark McKinney and Mark Chesnutt have all been confirmed for Friday night," says Christy Brorman, president of Big Spring's Downtown Revitalization Association, the group that organizes Funtastic Fourth each year. "Ratt has been confirmed for Saturday night."

cholesterol, fatty deposits, and calcium. Buildup causes arteries to become narrow, making it difficult for oxygen and blood to flow through the body and to the organs.

Anyone is at risk for developing heart disease. However, people who have high blood pressure, high cholesterol, and smoke cigarettes are at higher risk. According to the CDC, about 47% of Americans have at least one of these risk factors. Additional factors that contribute to the progression of the disease include:

- Diabetes
- Being overweight or obese
- Poor diet
- Physical inactivity
- Excessive alcohol use
- Having a family history of heart disease
- Age, especially in women 55 and older

Dr. Sumathi Venkatesh, Extension Program Specialist with Healthy South Texas, recommends taking preventative measures by becoming aware of risk factors and consulting with a doctor on a regular basis. Developing a treatment plan with a physician can help stabilize blood pressure, blood sugar, and blood cholesterol levels. Other preventative measures include:

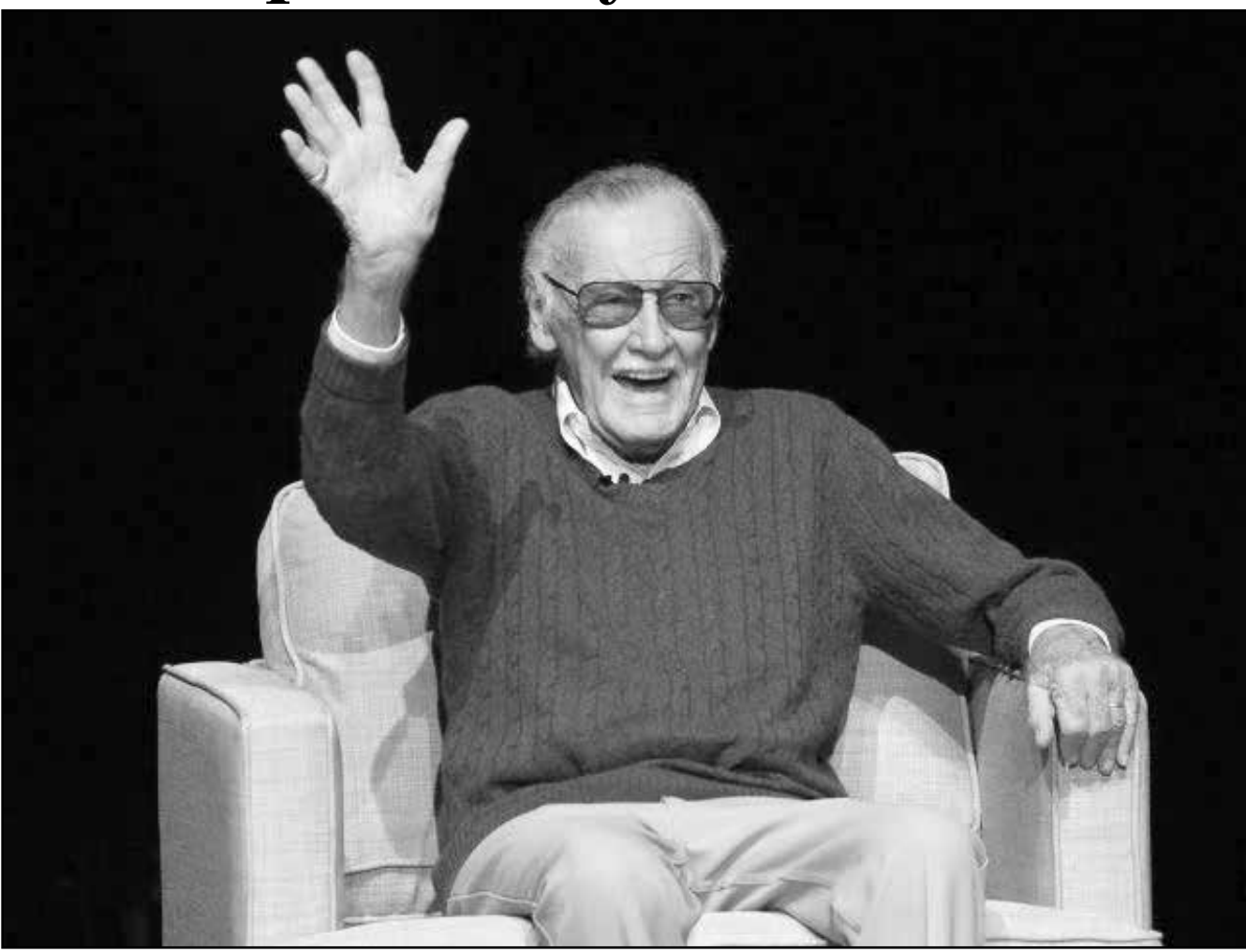
- Eating a healthy diet that includes fruits and vegetables
- Being physically active
- Stopping the use of cigarettes
- Limiting alcohol intake
- Reducing sodium intake

When it comes to pursuing a healthy lifestyle, try incorporating heart healthy foods into your diet such as green, leafy vegetables, avocados, whole grains, and seeds. Add these ingredients into meals like Quinoa Cakes, a Fresh Berry Caprese Salad, or an Avocado Mandarin Salad by using recipes from AgriLife Extension's Dinner Tonight. # Marvel's Stan Lee gets hero worship at Hollywood memorial

LOS ANGELES (AP) — An Army bugler played a mournful taps at a Hollywood memorial for Stan Lee, and military bagpipers sent a solemn "Amazing Grace" into the air.

Standing respectfully around them was another group in its own impeccable uniforms: Lee fans dressed as Black Panther, Wolverine and other members of the X-Men and Avengers.

It might have been a ridiculous scene at the TCL Chinese Theatre Wednesday night had it not been a perfect encapsulation of the life of Lee, a World War II veteran who wanted to become a serious writer and instead grudgingly took a job in comic books, becoming the mastermind behind Marvel Comics and co-creator of many of the best known and most lucrative characters of the last century.

"This was a guy who spent his life dreaming of writing the great American novel, and he didn't realize he was doing it, over and over and over again," said the night's host, filmmaker Kevin Smith, a friend and super-fan of Lee. "The world didn't need another 'In Cold Blood.' It needed Spider-Man."

On a night that had more cheers than tears, hundreds of Marvel fans stood and paid trib-

ute along with Lee's colleagues, co-creators and friends outside the Hollywood Boulevard theater where he had put his hand and footprints in cement in a similar ceremony 18 months earlier. Lee died in December at age 95.

"Sometimes when I'm feeling sad or I'm upset I would think of Stan Lee and this wonderful universe he's created," said Lee fan Isaac Suarez, who was celebrating his 14th birthday. "His soul lives on in every one of us, in every single comic and movie he's put his life into."

Tom DeSanto, who as producer of "X-Men" was among the first to find big-screen success with Lee's characters, said he was astonished by Lee's global reach.

"I've seen kids dressed up as Spider-Man in Beijing, Boston and Barcelona," DeSanto said.

Across the street was a billboard announcing that a movie whose characters started with Lee, "Black Panther," had been nominated for six Academy Awards.

"That's a triumph," Smith said. "It's a cherry on the top of an amazing, productive life."

Smith called Lee "one of the best humans to ever walk the earth," setting the tone for a night when no one would hold back in their superhero-worship. Speakers and panelists would compare Lee to the pope, Jesus, and the shin-

ing light of the sun.

Mark Hamill, a friend of Lee who often worked alongside him doing voices on Marvel animation projects, was among the few to admit Lee had flaws.

"He wasn't always nice," Hamill said in a panel discussion. "He'd give you shots. He could be acerbic."

Chris Miller and Phil Lord, producers of "Spider-Man: Into the Spider-Verse," which is also nominated for an Oscar, talked about meeting Lee when he was very old yet still bursting with energy and ideas.

"There were thousands of them," Lord said. "He was a compulsive creator."

Actor Laurence Fishburne, who appeared in Marvel's "Ant-Man and the Wasp" last year, described the thrill of spending 12 cents to buy a Lee comic book when he was a child in Brooklyn, New York.

"It opened my eyes to the possibility that you could be more than your surroundings say you can be," Fishburne said.

The night also featured frequent digs at comedian Bill Maher, who on his talk show last week took shots at Lee worshippers who still read comic books as adults. A big-screen graphic at one point thanked him for bringing comics fans together.

## Opera singer Daniels, husband arrested on sex assault charge

Police have arrested Daniels, a renowned opera singer and University of Michigan professor, on allegations that he and his husband in 2010 sexually assaulted a singer in Houston.

DALLAS (AP) — A renowned opera singer and University of Michigan professor is in police custody on allegations that he and his husband in 2010 sexually assaulted a singer in Houston.

Countertenor David Daniels and his spouse William A. Scott Walters were arrested Tuesday in Ann Arbor, Michigan, on Texas warrants charging each of them with sexual assault of an adult. A Houston police spokesman declined to comment on the charges Wednesday.

Samuel Schultz told The Associated Press on Wednesday that the couple assaulted him when he was living in Houston as a 23-year-old graduate student at Rice University. Schultz met them at a Houston Grand Opera reception and was invited back to their apartment, where he said he was given a drink that led him to slip in and out of consciousness. He filed a criminal complaint with Houston police in July.

The AP doesn't normally name victims of sexual assault but Schultz offered to publicly identify himself to help others fearful of reporting an assault.

"This is about seeking stalled justice and helping other victims of sexual violence be aware that fear doesn't need to keep them in silence," he said. "I had many reasons to be very fearful of coming forward as a student and in the years after being a graduate student ... but I realized that by letting go of that fear I'm getting my life back."

An attorney for the couple, Houston-based lawyer Matt Hennessy, said Daniels and Walters "are innocent of any wrongdoing."

Schultz "waited eight years to complain about adult, consensual sex to ride the #MeToo movement to unearned celebrity," Hennessy said. "We will fight this."

The San Francisco Opera announced in November that it had removed Daniels from a production later this year of Handel's "Orlando" due to a separate sexual assault allegation made in a lawsuit by a University of Michigan student.

The lawsuit filed in a Michigan federal court alleges Daniels groped the male student and sent and requested sexual photos. The lawsuit also alleges that Daniels served the student alcohol, gave him sleep medication and touched him sexually.

Daniels said in a statement at the time that the accusations were "both false and malicious" and denied any physical relationship with the student.

## DOE secretly shipped plutonium from South Carolina to Nevada

RENO, Nev. (AP) — The U.S. Department of Energy disclosed Wednesday that it has already shipped weapons-grade plutonium from South Carolina to a nuclear security site in Nevada despite the state's protests.

The Justice Department notified a federal judge in Reno that the government trucked in half of the radioactive material that it intends to store at the site 70 miles (113 kilometers) north of Las Vegas. Nevada had filed a request for an injunction to block the move in November.

Department lawyers said in a nine-page filing that the previously classified information about the shipment from South Carolina can be disclosed now because enough time has passed to protect national security. They didn't specify when the one-half metric ton of plutonium was transferred.

Nevada Gov. Steve Sisolak said he's "beyond outraged by this completely unacceptable deception." He said he's working with Nevada's congressional delegation to fight back against the U.S. government's "reckless disregard" for the safety of Nevadans.

Democratic Sen. Jacky Rosen called the move "deceitful and unethical," and Sen. Catherine Cortez Masto, also a Nevada Democrat, said she would demand department officials come to her office on Thursday to explain how they made the "reckless decision" in such "bad faith."

U.S. District Court Judge Miranda Du in Reno is considering the state's request for an injunction to block the Energy Department's plans announced in August to ship a full metric ton of plutonium to Nevada from South Carolina, where a federal

judge previously issued an order that the plutonium be removed from a Savannah River site by January 2020.

Nevada argues the DOE has failed to adequately study the potential dangers of moving the material to an area that is subject to flash floods and earthquakes, and that the state's lands and groundwater may already be contaminated with radioactive materials.

The energy department defended its decision in court on Jan. 17. Its lawyers argued at the time it doesn't have to disclose top-secret details of the shipment plans because of national security.

Du expressed sympathy at times for the state's argument during the evidentiary hearing, but declined to immediately grant the state's request and indicated she wouldn't rule until February.

"I hope the government doesn't ship plutonium pending a ruling by this court," she said at the time.

Sisolak said Wednesday the energy department led the state to believe it was engaged in good-faith negotiations over the plutonium "only to reveal that those negotiations were a sham all along."

"They lied to the state of Nevada, misled a federal court and jeopardized the safety of Nevada's families and environment," he said.

Monica Moazez, spokeswoman for the Nevada's attorney general's office, which is leading the legal fight, said in an email to The Associated Press on Wednesday that the state didn't immediately know what the next step would be in court.

Meanwhile, the states of Nevada and South Carolina are continuing to argue over where the legal challenge should be heard.

Each said in briefs filed in Reno last week that theirs is the proper venue to argue over the fate of the plutonium.

Lawyers for South Carolina say the previous order issued in December 2017 directing that the metric ton of plutonium be removed by the end of this year makes it clear the South Carolina court retains jurisdiction.

"Nevada's interests fail to outweigh South Carolina's interest and substantial public interest in having the matter decided by the court already handling and most familiar with the facts and issues in the case," they said in a filing last week.

A substantial part of the government's efforts to remove the plutonium "have occurred and will occur in South Carolina," John Desmond wrote on behalf of South Carolina Attorney General Alan Wilson.

Nevada's lawyers countered that the disposal site isn't located in South Carolina.

"The environmental impacts of the proposed action here will be almost entirely felt in Nevada," they said.

Experts testifying on behalf of Nevada said the material likely would have to pass directly through Las Vegas on the way to the Nevada Nuclear National Security Site. They fear an accident could permanently harm an area that is home to 2.2 million residents and hosts more than 40 million tourists a year.

The Energy Department wants to temporarily store the material at the Nevada site and the government's Pantex Plant in Texas, two facilities that already handle and process plutonium. The department says it would be sent by 2027 to the Los Alamos National Laboratory in New Mexico or another unnamed facility.

Opening lead — king of clubs. Today's deal was played in a duplicate game, where scoring an extra trick is much more important than in rubber bridge. It might look impossible to make more than 11 tricks at four spades, but at several tables South wound up with 12.

At most tables, declarer won the club lead with the ace as East played the eight. South then led the heart jack toward dummy and put up the king, hoping to steal the trick if West had the ace and ducked. But East won with the ace and returned a club to hold South to 11 tricks.

Many of these declarers most likely did not recognize East's eight of clubs as a probable high-low signal, marking West with six clubs. If this were true, then West couldn't also have the ace of hearts, because he would surely have overcalled with two clubs at his first turn.

So, to this extent, those declarers who tried to steal a trick by leading the jack of hearts to the king bungled the job. Their thinking was obviously misdirected.

The Souths who made the extra trick found a more refined approach. They ducked the club king and won West's club continuation. After ruffing their third club high in dummy, they then played six rounds of trump, producing this position:

South next led the spade four and discarded dummy's king of hearts. East could not discard a heart or a diamond without handing South an extra trick, so these declarers ended up with 12 tricks to share top score on the board.

This Date In History

Today is Thursday, Jan. 31, the 31st day of 2019. There are 334 days left in the year.

Today's Highlight in History:

On Jan. 31, 1971, astronauts Alan Shepard, Edgar Mitchell and Stuart Roosa blasted off aboard Apollo 14 on a mission to the moon.

On this date:

In 1606, Englishman Guy Fawkes, convicted of high treason for his part in the "Gunpowder Plot," was set to be hanged, drawn and quartered, but broke his neck after falling or jumping from the scaffold.

In 1863, during the Civil War, the First South Carolina Volunteers, an all-black Union regiment composed of former slaves, was mustered into federal service at Beaufort, South Carolina.

In 1865, the U.S. House of Representatives joined the Senate in passing the 13th Amendment to the United States Constitution abolishing slavery, sending it to states for ratification.

(The amendment was adopted in December 1865.) Gen. Robert E. Lee was named general-in-chief of the Confederate States Army by President Jefferson Davis.

In 1917, during World War I, Germany served notice that it was beginning a policy of unrestricted submarine warfare.

In 1929, revolutionary Leon Trotsky and his family were expelled from the Soviet Union.

In 1945, Pvt. Eddie Slovik, 24, became the first U.S. soldier since the Civil War to be executed for desertion as he was shot by an American firing squad in France.

In 1950, President Harry S. Truman announced he had ordered development of the hydrogen bomb.

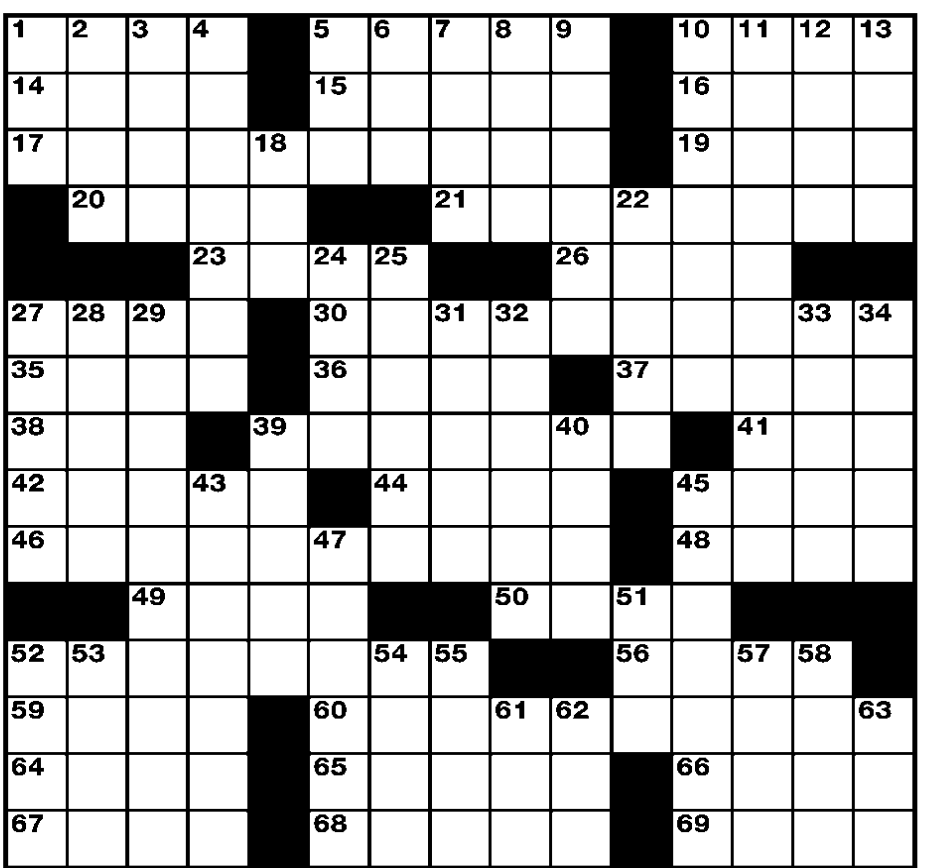

# Dirk, Doncic help Mavs rout Knicks at Madison Square Garden

NEW YORK — Dirk Nowitzki has been coming to Madison Square Garden for about two decades, scoring better there than at any road arena.

If this was the last visit, he ended with a good one.

Nowitzki scored a season-high 14 points, Luka Doncic warmed up after an airball on his first shot in the arena to score 16, and the Dallas Mavericks routed the New York Knicks 114-90 on Wednesday night.

Dennis Smith Jr. had his second career triple-double, and Harrison Barnes led the Mavericks with 19 points, but most of the focus was on the team's star rookie and 21-year veteran, who may be in his final season.

"I always enjoyed playing here," Nowitzki said. "If it was my last time it was definitely one of my most favorite places to play."

The 19-year-old Doncic also grabbed eight rebounds and made two 3-pointers, both in the second half after the game was long secured.

"It was great. For sure we needed that win. We were struggling on the road," Doncic said. "It was great to play here and I'm looking forward to playing a lot of years here."

He shot airballs on two of his first four attempts and wasn't nearly as good as in his previous game, when he scored a season-high 35 points Sunday against Toronto, becoming the first teenager in NBA history with multiple triple-doubles.

Then again, he didn't need to do nearly as much against the team with the NBA's worst record. The Knicks (10-40) lost their 11th in a row, though at least gave home fans something to cheer by giving Enes Kanter some playing time.

They also cheered the 40-year-old

Nowitzki when he walked toward the table to check in late in the first quarter, and stood and cheered when he got into the game. Nowitzki made his first three shots for nine points in seven minutes, then didn't come back on again until the fourth quarter, when he nailed another 3.

He was bummed in Boston, when he couldn't reward the fans with a basket as they desperately cheered for him to knock one in during the final minutes. But after a solid warmup, he felt good about his chances at MSG, where he came in averaging 24.9

points in 17 games, his highest average in a road arena.

"I knew if I get a chance I was going to step into some," Nowitzki said.

Kevin Knox scored 17 points and Trey Burke had 16 for the Knicks, while Kanter had five points in nine minutes.

Fans began chanting "We want Kanter! We want Kanter!" in the third quarter. He waved from the bench and clapped along, then was actually inserted into the game a few minutes later, ending the former starting center's streak of four straight games

where he didn't play.

"He just yelled out my name and I was like 'Yo, really?'" Kanter said, referring to coach David Fizdale. "I even looked around like, is he serious? And then I got up and the fans starting clapping and I thought this is really happening."

He kissed the Knicks logo at center court when he walked onto the floor.

Kanter's first shot was an airball before he got on the board with a dunk.

Mavericks: Smith finished with 13 points, 15 assists and 10 rebounds. ... Wesley Matthews scored 17 points.

Knicks: The Knicks finished 1-12 in January. They were 2-12 in December. ... Tim Hardaway Jr. was 2 for 11 for six points.

COACH DIRK

Nowitzki will be the honorary coach of the World team in the Rising Stars Challenge, adding to his busy All-Star weekend in Charlotte in which he will also take part in the 3-point contest. Asked about playing for Nowitzki, Doncic joked that he was going to try to change teams.

"I told him he's got to play hard or I'm going to sub him out," Nowitzki said. "I'm going to be tough on him. I'm going to teach him a lesson."

KANTER'S CHANCE

Fizdale has made it clear he's focused on playing young big men such as Noah Vonleh and rookie Mitchell Robinson, wasn't happy with them Wednesday so turned back to Kanter.

"I didn't feel the bigs were playing at the level that I want them to play at. I don't want those minutes to feel like entitlement," Fizdale said. "Like I've told Enes, any chance I could get to squeeze you in there within the framework of what we're trying to do with the young guys, I'm going to do it. I want to be upfront and stick with that."

# Cox leads No. 1 Baylor women past Oklahoma State 66-58

STILLWATER, Okla. — Baylor's stay at the top nearly was very short.

Lauren Cox had 16 points and 13 rebounds, and No. 1 Baylor rallied to beat Oklahoma State 66-58 on Wednesday night.

Juicy Landrum scored 15 points while Kalani Brown added 11 points and 12 rebounds for Baylor (18-1, 8-0 Big 12), which moved to No. 1 this week after Notre Dame's loss to North Carolina.

Baylor coach Kim Mulkey expected her team to be tested because of its ranking and Oklahoma State coach Jim Littell's preparation. The Lady Bears outscored the Cowgirls 20-10 in the fourth quarter to pull out the victory.

"I think they understood the target, but guys, whether we were No. 1 or No. 2, you're going to get that kind of performance out of well-coached teams," Mulkey said.

Freshman guard Ja'Mee Asberry scored a season-high 22 points and Vivian Gray and Braxtin Miller each added 12 for Oklahoma State. The Cowgirls (12-7, 3-5) were seeking their first win over a No. 1 team in seven tries.

"I thought our kids really competed hard, hooked it up and really gave us an opportunity to win," Littell said. "When you get that close and you're right there, it's disappointing that you don't finish it out."

Mulkey said she felt the Lady Bears did a good job against Gray and Miller, but Asberry was better than expected. She made 6 of 8 3-pointers.

The Lady Bears countered Asberry's effort by outscoring Oklahoma State 24-7 at the free throw line.

"I guess we fouled a lot and they didn't foul that much," Littell said. "I can't say anything, I can't talk about it, I'm not going to talk about officiating, but we can't foul that much and send people to the free throw line."

Oklahoma State led 14-13 at the end of the first quarter, just the third time this season that Baylor trailed at the end of the first.

The Lady Bears led 29-27 at halftime, despite shooting just 27 percent from the field. Asberry, who averages 6.3 points per game, had 11 at the break.

Asberry scored seven quick points in a 74-second span early in the third quarter to give Oklahoma State a 37-33 lead, and the Cowgirls led 48-46 heading into the fourth.

Cox drained a 3-pointer in the first minute of the fourth quarter to put Baylor up 51-48, and the Lady Bears never trailed again.

"We just kind of hung around," Mulkey said. "They'd make their runs, and then at the end, just executed some things, made our free throws."

BIG PICTURE

Baylor: The Lady Bears didn't play like their normal selves until the second half, but their size and athletic ability eventually won them a road game against a solid team.

"It's hard to win, guys," Mulkey said. "It's hard to win on the road against well-coached teams."

Oklahoma State: The Cowgirls lost their third straight, but they proved they can compete with any team in the Big 12.

"I'm very proud of our team," Littell said.

POLL IMPLICATIONS

Even with the close call, the Lady Bears shouldn't fall from No. 1 unless they lose on Saturday. They hold a head-to-head win over No. 2 UConn.

SHE SAID IT

Mulkey on her team's struggles getting the ball to Brown in the first half: "I felt like we were just standing, watching, thinking all of a sudden the sea was going to part in that lane and Kalani was going to be wide open. You've got to create your own offense sometimes athletically."

## Throw a sensational "Super Sunday" party
