

Julia Grib led things off again on the rubber for the Lady Hawks and pitched four and a third innings while giving up just 2 runs on 4 hits in the win. Defensively Howard College played another great game behind their pitchers and committed no errors in the field.

SAN ANTONIO — The San Antonia Spurs aren't concerned with making statements. They just want to pile up as many victories as they can late in the season.

DeMar DeRozan had 26 points and nine rebounds, LaMarcus Aldridge added 23 points and 13 rebounds and Spurs beat the Golden State Warriors 111-105 on Monday night for their ninth straight win.

"We're just trying to get wins, man, that's all," Spurs forward Rudy Gay said. "We've had wins, we've had big wins, we've had some bad losses, (too). It just feels good to win the games we think we should." San Antonio won its 11th straight

at home and moved into fifth in the Western Conference following the Thunder's loss to Miami. The Spurs also clinched a winning record for the 22nd straight season. Stephen Curry had 25 points after

a slow start and Kevin Durant added 24 for the Warriors, who entered the game having won two straight. Golden State dropped into a tie with Denver for first place in the West with matching 47-22 records.

"That's the hottest team in the league and obviously really wellcoached," Warriors coach Steve Kerr said. "They were executing and I thought they outexecuted us, outcoached us. They deserved to win."

San Antonio's winning streak is second only to Golden State's 11 straight wins earlier this season. Remarkably, the Spurs' longest winning streak since 2016 comes directly after they went 1-7 for their worst Rodeo Road Trip ever.

San Antonio has beaten Golden State, Denver, Milwaukee, Oklahoma City, Portland and Detroit during its streak. All of those clubs are among the top six teams in their conference.

"Guys are playing better," Aldridge said of the turnaround. "We're trying to be better defensively. Communication has been better and it's just winning time. I think everyone senses that."

Spurs extend streak to 9 straight, beat Warriors 111-105

Golden State was without DeMarcus Cousins and Andre Iguodala, who both sat with injuries, but remained within two possessions in the final minute.

The Warriors had to rally in the second half after a sluggish start.

Curry and Klay Thompson opened the game a combined 0 for 11, but the Warriors' defense allowed them to tie the game at 25 when Curry threw in a 61-footer to close the first

Curry finished 9 for 25 from the field and Thompson finished with 14 points on 5-for-18 shooting. Thompson said the "Splash Brothers" struggles were their own rather than anything the Spurs did defensively.

"Just missed shots," Thompson said. "That's all it is. Shots that we normally hit, too. Yeah, they're a smart disciplined team but it's not like we weren't getting to our spots and getting good looks. Just didn't go in."

After trailing by 11 in the third quarter, the Warriors' offense awoke to silence the sold-out crowd with a 16-5 run to forge a 75-all tie. The run included a shakedown, step-back 3-pointer by Curry and a pair of quick passes from Curry to Draymond Green to Shaun Livingston for an emphatic dunk. Curry had eight points in the run.

"Every time we made a run, they countered and they made a run,"

DeRozan scored 10 points in the final quarter, including a pair of pullup jumpers over Thompson, to seal

Gay added 17 points for San Antonio and Derrick White had 12. **TIP-INS** 

Warriors: Cousins sat the game out with a sore right foot and Iguodala missed the game following dental work. ... Andrew Bogut started the game after signing with the team March 6 after playing this season in

Australia. Bogut spent four seasons with Golden State before rejoining the team as a free agent. ... The Warriors have won at least 23 road games in six straight seasons. They lost for the fifth time in 24 games away from home. ... Golden State defeated San Antonio by 39 points in their previous meeting, Feb. 6 at Oracle Arena. It was the largest winning margin over the Spurs in franchise history.

Spurs: Aldridge has 18,854 career points, moving past Glen Rice for 69th all-time in league history. Rice had 18,338 career points over 15 seasons beginning in 1989. ... DeRozan is the first Spurs guard to make 300 free throws in a season since Manu Ginobili in 2011. .. The Spurs won 13

straight in 2016.

WELCOME BACK, MATE Bogut picked up a foul on an illegal screen 9 seconds into the game.

"That was a welcome to the league, for sure," Bogut said. "Just like, we know you set some hard screens so we're just going to blow one early."

Bogut finished with seven points and seven rebounds in 19 minutes as he reunited with Curry, Thompson and Green. His points included an alley-oop dunk from Curry.

"It was fun," Curry said. "It's been what three years (since he last played with Bogut). I came in transition and besides probably (Damian Jones) early in the year, I haven't thrown a lob like that to somebody. It just felt like second nature at that point. He went up and finished it."





Dear Who's: Most obviously -- and most importantly -- you need to ask, and ask often. Few people share your innate sense of responsibility and service. 



Today's Highlight in History: On March 19, 1945, during World War II, 724 people were killed when a Japanese dive bomber attacked the carrier USS Franklin off Japan (the ship was saved). Adolf Hitler ordered the destruction of German facilities that could fall into Allied hands

in his so-called "Nero Decree," which was largely disregarded. On this date: In 1918, Congress passed the first law establishing daylight saving time in the United States, with clocks to be moved forward one hour from the last Sunday

in March to the last Sunday in October. (This law was repealed in August 1919.) In 1920, the Senate rejected, for a second time, the Treaty of Versailles (vehr-SY') by a vote of 49

in favor, 35 against, falling short of the two-thirds majority needed for approval. In 1931, Nevada Gov. Fred B.

Balzar signed a measure legalizing casino gambling. In 1953, the Academy Awards

ceremony was televised for the first time; "The Greatest Show on Earth" was named best picture of 1952.

In 1966, the Texas Western Miners defeated the heavily favored Kentucky Wildcats, 72-65, to win the NCAA Championship played in College Park, Maryland; making the contest especially noteworthy was that Texas Western became the first basketball team to start five black players in a national title game as it faced an all-white Kentucky

In 1976, Buckingham Palace announced the separation of Princess Margaret and her husband, the Earl of Snowdon, after 16 years of marriage. In 1979, the U.S. House of Rep-

resentatives began televising its floor proceedings; the live feed was carried by C-SPAN (Cable-Satellite Public Affairs Network), which was making its debut.

In 1987, televangelist Jim Bakker resigned as chairman of his PTL ministry organization amid a sex and money scandal involving Jessica Hahn, a former church secretary.

In 1993, Supreme Court Justice Byron R. White announced plans to retire. (White's departure paved the way for Ruth Bader Ginsburg to become the

court's second female justice.) In 2003, President George W. Bush ordered the start of war against Iraq. (Because of the time difference, it was early March 20 in Iraq.) In 2005, Police in Citrus Coun-

ty, Florida, found the body of 9-year-old Jessica Lunsford, more than three weeks after she'd disappeared from her bedroom. (Convicted sex offender John Evander Couey was later sentenced to death for kidnapping, raping and burying Jessica alive; he died of natural causes in September 2009.)

In 2013, Pope Francis officially began his ministry as the 266th pope, receiving the ring sympolizing the papacy and a stole exemplifying his role as shepherd of his 1.2-billion strong flock during a Mass at the

Ten years ago: An Austrian jury sentenced Josef Fritzl, 73, to life in a psychiatric ward for locking his daughter in a dungeon for 24 years, fathering her seven children and letting an eighth die in captivity as a newborn. Pope Benedict XVI, visiting Cameroon, told Muslim leaders that true religion rejected violence; the pontiff also held up peaceful coexistence between Christianity and Islam in the country as "a beacon to other African na-

Five years ago: In her first news conference as Federal Reserve chair, Janet Yellen said with the job market still weak, the Fed intended to keep short-term rates near zero for a "considerable" time and would raise them only gradually. # Nowitzki passes Wilt but Pelicans top **Mavs 129-125 in OT**

DALLAS — For the 7-footer who has built a Hall of Fame career shooting from the outside, it was the perfect way to reach his latest milestone.

Dirk Nowitzki swished a 20-foot jumper with 8:35 left in the first quarter Monday night, passing Wilt Chamberlain for sixth place on the NBA's career scoring list — but it wasn't enough for the Dallas Mavericks.

Elfrid Payton had his fifth straight triple-double and Julius Randle scored 30 points to help the New Orleans Pelicans beat the Mavericks 129-125 in overtime Monday night.

Nowitzki moved past Chamberlain (31,419 points) by making his first two shots of the game. The first was a 20-footer off an assist from Jalen Brunson. Then the 40-year-old German took a feed from Luka Doncic and backed down Kenrich Williams before turning and launching from the top of the key.

"I took my time and faced him up like I've done a million times and tried to shoot over him," Nowitzki said. "It was good to get it over with in the first two shots."

Payton had 19 points, 11 assists and 10 rebounds. Dallas rookie Luka Doncic turned in a triple-double of his own with 29 points, 13 boards and 10 assists, including the pass that put Nowitzki higher up in the record

"He deserves everything good that happens to him," Doncic said. "It's amazing the things he has accomplished, but this one is really amaz-

Nowitzki finished with eight points, giving him 31,424 in his 21 seasons trailing only Kareem Abdul-Jabbar, Karl Malone, Kobe Bryant, LeBron James and Michael Jordan.

The two jumpers were a fitting way for Nowitzki to pass Chamberlain, whose listed height of 7-foot-1 is only an inch taller than Nowitzki. But the two achieved their point totals with contrasting styles of play.

Chamberlain once averaged more than 50 points in a season, dominating inside to such a degree that the NBA widened the paint in an effort to neutralize him.

Nowitzki, meanwhile, has made nearly 2,000 3-pointers in his prolific career, establishing the trend of big men with long-range shooting capabilities. He's an 88 percent free throw shooter, 37 points higher than Chamberlain's mark.

"The league wanted a change, and I came in at the right time," Nowitzki said. "They basically forced teams to do a little more movement and more pick-and-roll. All the guys now can shoot and spread the floor. It was just perfect for me and for my skill set."

Nowitzki's skill set has naturally diminished with age, especially this season. He missed the first 26 games after offseason ankle surgery and has averaged only six points per game — 15 below his career average. He started for just the ninth time Monday and played 12 minutes.

"Not many people on the outside know the kinds of sacrifices to be on the floor to accomplish something like this," Dallas coach Rick Carlisle said. "It's just another credit to how he's approached his entire career."

WITNESS TO HISTORY

Randle, a Dallas native who grew up watching Nowitzki and admires his inside-outside game, was in the arena for Nowitzki's previous major milestone as a member of the Lakers when Nowitzki passed the 30,000-point mark.

"I was just happy he didn't hit the shot on me," Randle said. "It's crazy to see he's breaking a record every time I come. It just shows you his accomplishments and his achievements."

HOME SWEET HOME

Also serendipitous was Nowitzki reaching the milestone in Dallas he is the only NBA player to spend 21 seasons with one team. The club launched a new marketing campaign Monday called 41.21.1, commemorating his uniform number and his tenure with the team. It is anticipated that this will be his final season, though Nowitzki has only said publicly he will decide at the end of the year. He reiterated that statement after the game.

FRANTIC FINISH

Randle scored 11 points in the final 3:29 of regulation, helping the Pelicans rally to force overtime. Doncic made the second of two free throws
