# **Golf Course remains hot button** issue at City Council meeting

The Municipal Golf Course at Comanche Trail Park was once again a topic of concern at Tuesday evening's regular meeting of the Big Spring City Council.

The meeting started with a public comment from local businessman and moderator of the popular Facebook group "Big Spring Issues," Scott Emerson.

"I went to (Big Spring Finance Director) Don's (Moore) office and asked to see the financials on the Golf Course, and they're horrendous," Emerson said. "I think that it's always been a losing proposition, but a needed proposition. I'm by no means suggesting that we need to close the Municipal Golf

Course, but I think we need to stop looking at a \$350,000 deficit as normal and acceptable."

Emerson went on to state that so far in the current fiscal year, October through the present, the course's revenue has been \$73,321, while the expenditures have been \$242,520.

"We're already in the negative \$169,000 this year," he said.

Emerson recommended that the planned Parks and Recreation Board be implemented quickly, and that they study the situation at the Golf Course and make a recommendation to the city about how to address the course's losses.

remarks, the council moved on to the Consent Agenda, which typically contains several routine issues which are voted on as a group. One of the items on the Consent Agenda at this meeting was the final reading of an ordinance to amend the pricing structure for annually paid greens fees at the Golf Course. Before this measure, a reduced-cost, limited access annual greens fee for senior citizens allowed seniors to pay a lower annual rate, while being restricted from playing on weekends and holidays. The new measure, which had been approved with some dissent at previous meetings, would allow those paying the reduced fee to play on holidays which occur during the week. Weekends, including weekend holidays, would still be off limits.

District 6 Councilman Jim DePauw asked that the Golf Course item be removed from the Consent Agenda and discussed and voted on separately.

"Mr. Mayor, my motion is to table this item. I agree with Mr. Emerson 100 percent," DePauw said. "I think all of our fees, all of that needs to be looked at by the new Parks Board. Let them do a comprehensive study of all of our parks and all of our fees. None of them have been raised in years. We've had inflation, we've had growing expenses. I noticed that Mr. Emerson pointed out that in three years' time, that's just shy of a million dollars that the Golf Course has lost. So we really need to study this.'

District 3 Councilman Terry McDaniel pointed out that it could well be several months, possibly as late as August, before the Parks and Recreation Board could be formed, study the situation, make its recommendations, and have them voted on by the city.

"In order for this tabled consent item to work, we've got to get the Parks Board together, then bring it before us to approve the Parks Board, then another month goes by and it goes into Consent Items – the Parks Board – and then the Parks Board has to meet to determine all of the different items that are going to be tabled this time if we pass that, and so we're looking at...August?" McDaniel asked.

While DePauw argued he didn't see there was any great need for rushing into approving the new ad-

# South Texas crop duster, 77, killed in plane crash

HARLINGEN, Texas (AP) - A 77-year-old crop duster was killed when his aircraft crashed into a South Texas field.

The Texas Department of Public Safety identified the man as Bernard Rowland II of Lasara, Texas.

The Federal Aviation Administration says he was flying his single-engine Air Tractor 502 about 10:45 a.m. Tuesday when crash happened. The FAA says the aircraft clipped a power line and crashed into a field near the intersection of U.S. 77 and Orphanage Road, almost 6 miles (10 kilometers) northwest of Harlingen. The FAA is still investigating the incident.



#### Texas company that destroyed bump stocks sues US government

FORT WORTH, Texas (AP) — A Texas gun company that destroyed more than 73,000 bump stocks when a federal ban on the rapid-fire devices took effect has sued the U.S. government claiming millions of dollars in losses.

RW Arms of Fort Worth on Monday announced the lawsuit and said the government took its property "without just compensation." Co-founder Mark Maxwell said Tuesday that RW Arms' losses totaled more than \$20 million. Last month's lawsuit seeks fair market value compensation.

RW Arms drew attention March 26, when the ban took effect, by transferring thousands of bump stocks to law enforcement for shredding. Officials initially said about 60,000 items were destroyed.

President Donald Trump's administration supports the ban on bump stocks, which in 2017 were used by a gunman to kill 58 people in Las Vegas.

#### Report: Veteran long showed signs of mental instability

SAN ANTONIO (AP) — An Air Force report indicates a Special Forces veteran's disruptive behavior and mental instability had been evident long before he killed his commander and himself in Texas in April 2016.

Tech. Sgt. Steven Bellino was armed with two hand guns, a knife and 61 rounds of ammunition when he killed Lt. Col. William Schroeder then himself at Joint Base San Antonio-Lackland.

The Air Force Office of Special Investigations report, obtained by the San Antonio Express-News under the Freedom of Information Act, says Bellino admitted in a 1997 psychological examination to destroying property, starting fires, and breaking rules he that found disagreeable.

The report says Bellino didn't leave a suicide note, but that he wrote a "farewell" note in August, saying he didn't want to be part of this world anymore.

Leaders of the company, Force Multiplier Solutions, have also pleaded guilty. They're awaiting sentencing.

# Cop's attorney: 'Perfect storm' led to unarmed woman's death

MINNEAPOLIS (AP) — A Minneapolis police officer who shot and killed an unarmed woman as she approached his squad car after calling 911 to report a possible crime was reacting to a loud noise and feared an ambush, his attorney said Tuesday, calling it "a perfect storm with tragic consequences."

Mohamed Noor, charged with murder and manslaughter in the 2017 death of Justine Ruszczyk Damond, and his partner were rolling down a dark alley in response to Damond's 911 calls about a possible sexual assault when a bicyclist appeared in front of them and they heard "a bang," defense attorney Peter Wold said in his opening statement at Noor's trial.

"It is the next split second that this case is all about," Wold said.

Noor fired a single shot, killing Damond, a 40-yearold dual citizen of the U.S. and Australia whose death rocked both countries and led to changes in

the Minneapolis Police Department. The shooting came just two weeks after an officer in New York was ambushed and killed in a parked vehicle.

Attorneys for Noor, who was fired after being charged in the case and has never talked to investigators about what happened, argue that he used reasonable force to defend himself and his partner from a perceived threat. But prosecutors say there is no evidence he faced a threat that justified deadly force

Prosecutor Patrick Lofton, in his opening statement, questioned a statement from Noor's partner, Matthew Harrity, that he heard a thump right before the shooting. Lofton said Harrity never said anything at the scene about such a noise, instead mentioning it for the first time some days later in an interview with investigators.

Lofton also said investigators found no forensic evidence to show that Damond had touched the squad car before she was shot, an assertion that seemed aimed at the possibility that she had

slapped or hit it upon approaching the officers.

Lofton also wondered why other officers responding to the scene didn't consistently have their cameras switched on. The officers did not turn on their body cameras until after the shooting, and there was no squad car video. Lofton noted that a sergeant taking statements had her camera on when she talked to Harrity, but off when she talked to Noor.

"We'll never hear what Noor said," he said.

Tuesday's opening statements came after six days of jury selection for Noor. Damond was a life coach who had been engaged to be married in just a month's time. Noor, 33, is a Somali American whose arrival on the force just a couple of years earlier had been trumpeted by city leaders working to diversify the police force.

Damond called 911 twice, then called her fiance and hung up when police arrived, Lofton said. One minute and 19 seconds later, Damond was cradling a gunshot wound to her abdomen and saying, "I'm dying," Lofton added.

Minnesota law allows police officers to use deadly force to protect themselves or their partners from death or great bodily harm. Prosecutors charged Noor with second-degree intentional murder, thirddegree murder and second-degree manslaughter.

Earlier Tuesday, Hennepin County District Judge Kathryn Quaintance relented on restrictions that would have prevented the public and media from viewing video evidence introduced in the case. That's expected to include body-camera video that shows efforts to save Damond. Quaintance had cited a desire to protect Damond's privacy, but a coalition of media groups including The Associated Press had challenged the ban.

"The court, like the jury, must follow the law even if I disagree with it," said Quaintance.

Noor's attorneys haven't said whether he will testify. If he does, prosecutors may be able to introduce some evidence that the defense wanted to keep out of the state's case, including that he has refused to talk to investigators. They also could bring up a 2015 psychological test that showed Noor disliked being around people and had difficulty confronting others. Despite that test, a psychiatrist found him fit to be a cadet officer.

The shooting raised questions about Noor's training. The police chief defended Noor's training, but the chief was forced to resign days later. The shooting also led to changes in the department's policy on use of body cameras.

### Mexican citizen, suspect in 5 deaths, found hanged in jail **By JIM SALTER**

ST. LOUIS (AP) - A Mexican citizen accused of killing four people in Kansas and one in Missouri in 2016 died Tuesday after hanging himself from a light fixture in his St. Louis jail cell.

Pablo Serrano-Vitorino was found alone in his cell at 2:02 a.m. He was pronounced dead at a hospital about an hour later, said Koran Addo, spokesman for St. Louis Mayor Lyda had last checked on him.

Serrano-Vitorino, 43, who was in the U.S. illegally, was accused of fatally shooting four men at a home in Kansas City, Kansas, on the night of March 7, 2016. He was arrested a day later and 170 miles away in Montgomery County, Missouri, where he was accused of killing Randy Nordman of New Florence. He was charged with first-degree murder in all five deaths.

He was being held in St. Louis awaiting an October trial in Nordman's death on a change of venue. Missouri prosecutors were seeking the death penalty. He had tried to take his own life before, with a safety razor, shortly after his arrest while jailed in Montgomery County. After a hospitalization he was returned to the jail.

down his Kansas City, Kansas, neighbor, 41-year-old Michael Capps, and three other men at Capps' home – brothers Austin Harter, 29, and Clint Harter, 27, and 36-year-old Jeremy Waters. Before dying, one of the victims managed to call police.

Authorities have not disclosed a possible motive.

Serrano-Vitorino then allegedly fled in his pickup truck into Missouri. Authorities say he killed Nordman, 49, at Nordman's rural home near Interstate 70 about 70 miles (113 kilometers) east of St. Louis. He was captured hiding face-down in a ditch a few miles from Nordman's home, and had a rifle with him, the Missouri State Highway patrol said at the time. A lawsuit filed in Kansas City, Kansas, by the father of one of the victims accused U.S. immigration officials of missing two chances to detain and deport Serrano-Vitorino.

Serrano-Vitorino was deported to Mexico after he was convicted of a felony in 2003 but illegally re-entered the U.S. He was arrested in 2014 and 2015.

After his 2014 arrest in Kansas for battery, Wyandotte County jail officials notified ICE he was in custody. But Serrano-Vitorino was released after the federal agency didn't send an agent to the jail, according to the lawsuit.

Addo declined further comment but St. Louis Public Safety Director Jimmie Edwards told the St. Louis Post-Dispatch that Serrano-Vitorino hanged himself and left a note written in Spanish. Edwards was out of town and didn't know if Serrano-Vitorino was on suicide watch or when jailers

Authorities say the shooting spree began when Serrano-Vitorino gunned

Serrano-Vitorino was fingerprinted in Overland Park, Kansas, Municipal Court in September 2015 after he was cited for traffic infractions. ICE officials asked that he be held in custody but sent the paperwork to a different jail in Johnson County, Kansas, the lawsuit contends. He was once again released from custody.

"That's what I was most excited about and it's turned out to be true," Benson said.


"Some of the neat things that we're going to do, especially talking about growth, we are in the process of implementing BASICS, Brief Alcohol Screening and Intervention for Students; opening a center for students in recovery; expanding suicide prevention education programs; and expanding our bystander intervention programs. Those are the things I'm most excited about developing," he added.

The UTPB website says bystander intervention is "recognizing a potentially harmful situation or interaction and choosing to respond in a way that could positively influence the outcome."

Benson said these initiatives that have been successful in the UT System.

"The expansion of those programs, I think, is going to complement the wellness initiatives that have already taken place on campus," Benson said.

He said he and his team are working toward training the faculty and staff on mental health first aid.

"It's my goal to visit every state park in Texas by the end of 2019. I'm about 20 parks into 95 of them," Benson said.

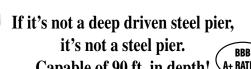

Any person eligible to vote in the board member election that resides in the Permian Basin Zone and meets the seven-year experience requirement may place their name in nomination for election to the Texas Boll Weevil Eradication Foundation Board by written application to the Department at the address provided below. Nomination forms are provided by the Department and must be signed by the nominee and at least ten other eligible voters from within the Permian Basin Zone. The nomination form must be received by the Department at its office located in Austin by April 30, 2019 and must provide the legal residence of the applicant. A nomination form may be obtained by contacting the Department office or any county agent located in the voting area.

The board election will be held by mail balloting. Ballots will be mailed to cotton growers by May 15, 2019. All ballots cast by mail must be postmarked no later than May 30, 2019, in order to be valid. Any cotton grower having planted cotton in the year 2018 within the zone defined above is eligible to vote, and, if he or she resides in the Permian Basin Zone and has at least seven years experience as a cotton grower, can have his or her name placed on the ballot as a candidate in the board member election. A cotton grower is defined as a person who grows cotton intended to be commercial cotton. The term includes an individual who, as owner, landlord, tenant or sharecropper, is entitled to share in the cotton grown and available for marketing from the farm, or share in the proceeds from the sale of the cotton from the farm or from an indemnity or other payment received from or related to the planting, growing, or failure of the cotton.







#### **Today in History**

Today is Wednesday, April 10, the 100th day of 2019. There are 265 days left in the year. Today's Highlight in History: On April 10, 1865, Confederate Gen. Robert E. Lee, a day after surrendering the Army of Northern Virginia at Appomattox Court House, said farewell to his men, praising them for their "unsurpassed courage and fortitude?

Ten years ago: Police in Tracy, California, arrested Sunday school teacher Melissa Huckaby in connection with the death of 8-year-old Sandra Cantu, whose body had been found in a suitcase. (Huckaby eventually pleaded guilty to kidnapping and murdering her daughter's playmate; she was sentenced to life without parole.) 

# Tech has foundation for future after reaching national final

AP Sports Writer MINNEAPOLIS — Brandone Francis plopped down in front of the Texas Tech locker room stalls where Matt Mooney and Tariq Owens were seated, their eyes red and wet as they clasped hands in consolation and solidarity while Virginia was celebrating on the court.

Three of the team's four seniors were still trying to process the fresh agony of losing in overtime of the national championship game with the life-changing and program-lifting season the Red Raiders (31-7) had just finished. In this rawest of moments they expe-

of moments they experienced, the sadness to Virginia in the overtime in the championship of the Final Four NCAA college basketwas too strong to push ball tournament, Monday, April 8, 2019, in Minneapolis.

"It's so hard to come

up short, man," Mooney said in the softest of his voices, staring straight down at the floor after Texas Tech lost 85-77 in Minneapolis.

Mooney, the sharp-shooting guard with the close-shorn haircut who was the star of the win over Michigan State in the semifinals on Saturday, landed in Lubbock with coach Chris Beard for his final year of college.

The two-time transfer, who started at Air Force and then switched to South Dakota, found a place to belong, however briefly, with Beard and his like-minded collection of underdogs and afterthoughts.

Naturally, Mooney was taking the loss as hard as anyone as Monday night crept toward Tuesday morning deep inside U.S. Bank Stadium.

"At the end of the day, we're brothers," he said. "We're family. We're always going to be family."

Beard, the Associated Press Coach of the Year award winner, worked his way through junior colleges, a semipro league, Division III, Division II and a mid-major before finally arriving at a power conference program with the Red Raiders three years ago.

Last season, he took them further than ever, where predecessors Gerald Myers, James Dickey, Bobby Knight, Pat Knight and Tubby Smith never went, to the school's first Elite Eight appearance. Though they went 27-10 and ultimately fell to eventual champion Villanova, the Red Raiders lost five of their top six scorers.

Jarrett Culver, a projected top 10 NBA draft pick, made major strides in his sophomore year. Mooney and Owens made major impacts and immediately meshed with their teammates, never an easy task for graduate transfers. Francis, who started his career at Florida, was a steely spark off the bench. Davide Moretti, a sophomore from Italy, was the team's second-leading scorer. Norense Odiase, the other senior in the rotation, helped hold down the middle.

Whatever the Red Raiders might have been missing on offense, they made up for with the defensive tenacity around which Beard has built this hard-nosed team in the styles of the Knights he once coached under.

By one metric, data expert Ken Pomeroy's points-per-100-possessions ranking, Texas Tech was not only the most efficient defensive team in the nation, but the best since that statistic was invented 17 years ago.


The Red Raiders, along with co-Big 12 champion Kansas State, ended a 14-season run by Kansas atop the conference.

Francis frustratingly declared "nobody remembers second place," but in the case of this Texas Tech team, that's not true, and not just for Red Raiders fans. Any regular follower of the NCAA Tournament will have no trouble recalling this run.

"These guys will go on to be great pros and fathers and husbands," Beard said. "Just never been more proud of a group."

Though Culver said he had not decided yet whether to turn pro, he's a good bet to be lottery bound, so Beard and his staff will have a lot to replace. The foundation has been built, though, and reaching the national title game will never hurt recruiting.

"Having years like this is just great for the program," Odiase said. "We know that this is a team that will be back next year because of



With Culver and Mooney struggling to score for much of Monday night, freshman guard Kyler Edwards filled in capably with 12 points, including a pair of 3-pointers. Moretti will be back, too.

Kansas lost 10 games for only the second time in 19 years, so the Big 12, which has only produced a national champion twice in the past 67 years with titles by the Jayhawks in 2008 and 1988, ought to be as wide open for the Red Raiders as ever.


"We've got new pieces coming in and we've got a little experience," Edwards said. "I feel like we're a good thing heading into next year."

# Nowitzki says goodbye at home, set to visit Spurs in finale

AP Sports Writer DALLAS — Dirk Nowitzki notched season highs in points, shots and minutes before telling Dallas Mavericks fans that his record 21st season with the same franchise would be his last.

Then the 40-year-old said he gave just about all he had in what he knew would be his final home game , which might make the last game of his career at San Antonio on Wednesday night little more than a curtain call. It's a fitting finale in some regards because the Spurs were probably Nowitzki's biggest rivals.

"I'm going to try to play a little bit tomorrow and still enjoy and hoist a few jumpers," said Nowitzki, who had 30 points on 31 shots in 33 minutes in a 120-109 win over Phoe-

have supported me and pushed me over two decades.'

The 14-time All-Star said the Mavericks bought more than 300 tickets in order for employees to attend what everyone now knows will be his final game. And the most accomplished European player in NBA history is merely playing out the string again in a third straight season without the playoffs, the longest drought of Nowitzki's career.


But on Nowitzki's special night, nobody was thinking about the Mavericks never winning another playoff series with the best player in franchise history after he led them to their only championship in 2011.

Not any of the former NBA stars who made the trip. Larry Bird, Charles Barkley, Scottie Pippen, Shawn Kemp and countryman Detlef Schrempf took the court Tuesday night and gave brief speeches in honor of the player who was shown in an old video listing each of them as among those he idolized growing up in Germany.

And certainly not coach Rick Carlisle or owner Mark Cuban, who promised Nowitzki a job for life, a jersey retirement and a statue. Plus, the win over the Suns did allow the Mavericks to avoid a second straight 50-loss season.

"I was so happy for Dirk," Carlisle said. "The only thing he's ever cared about is bringing this fan base success, and helping these fans experience success, and ultimate success. This wasn't a winning season, but it was triumphant in many ways because of the respect and all of attention Dirk got for 21 years being with the same franchise."

Nowitzki said he had broken down emotionally a few times in private since deciding in recent days that it was time to retire, including on the day of his final home game with his wife, Jessica Nowitzki, after putting on the suit he wore to the arena. But the league's 2007 MVP and 2011 NBA Finals MVP also knew how difficult the past two seasons had been physically, including missing the first 26 games of his final campaign after a longer-thanexpected recovery from ankle surgery last April. Nowitzki was experiencing flare-ups in his feet and ankles late this season.

The highest-scoring foreign-born player in NBA history has 31,540 points with a game left. Nowitzki eclipsed 10,000 defensive rebounds late this season — and fans who went wild nearly every time he hit a shot even cheered those moments.

The only 7-footer to win the All-Star 3-point shooting contest was the first player of his size to be a legitimate threat behind the arc. All of the game's biggest stars say that dimension changed the game, and many of them emulated his signature one-legged fadeaway jumper — the shot he used on his final bucket at home late in the fourth quarter.
