In addition to local projects and contributions, the Lions Club helps provide support to a summer camp in Ker-ville.

"Our membership dues go towards supporting a summer camp for youth with disabilities," he said. "This is one of the projects that Lions Clubs are involved in."

One of the main missions of Lions International is to provide eye screenings for kids and eyewear for adults and seniors. An added focus of service, at the centennial celebration, is diabetic supplies.

"We recently helped provide a local resident with obtaining an eye screening and the purchase of eyeglasses, which is what Lions Clubs are known for, but not too long ago, the mission of

providing support for those with diabetes was added," he said. "Now, in addition to eyewear, we can be looking for ways that we can help support our diabetic population."

Texas A&M System Regents Approve Construction Projects

COLLEGE STATION, Texas — The Texas A&M University System Board of Regents approved a long list of construction projects Thursday, continuing a system-wide building boom that has been averaging about \$1 billion a year.

The Board of Regents approved:

Construction for the RELLIS Agriculture & Workforce Education Complex Project at The Texas A&M University System’s RELLIS Campus in Bryan.

The facility will serve as home to construction trades training and Texas A&M’s agricultural education program, which prepares agri-science teachers to enter high school classrooms across the state. By providing hands-on learning opportunities and training, Texas A&M University will be empowering individuals to excel in industries with high demands and big rewards. Construction on this project is scheduled to start in May 2019, with substantial completion scheduled for June 2020. The total project budget is \$15,000,000.

Construction for the Academic and Administration Building - Phase I Project, Texas A&M University-San Antonio.

A&M-San Antonio is a fast growing institution adding approximately 1,000 new students per year. Much of that growth is from the recent initiative of adding the freshman and sophomore years to its undergraduate instruction while continuing to grow its upper division offerings as well as its graduate level programs. Construction on this project is scheduled to start in May 2019, with substantial completion scheduled for June 2020. The total project budget is \$30,000,000

Renovation of the Gibb Gilchrist Building at Texas A&M University, College Station.

The Gilchrist Building is an existing three-story office building currently being utilized by the Texas A&M Transportation Institute (TTI).

The programmed spaces in the renovated Gilchrist building will include offices, conference and meeting rooms, lecture and classroom spaces, teaching and research laboratories and support spaces. Construction on this project is scheduled to start in June 2019 with substantial completion scheduled for December 2019. The total project budget is \$8,189,705.

Construction for the ’72 Wing Chemistry Ground Floor Project at Texas A&M University, College Station.

This project will provide renovated laboratories and associated support facilities for biological chemistry and synthetic organic chemistry research projects, as well as laboratories for analytical and mass spectrometry instrumentation.

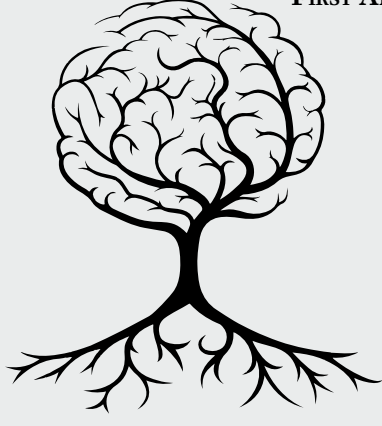

# Running 200,000 miles

When Dave Dial was a six-year-old boy he would ask his father to stop the car so he could get out and run.

“We might have gone to the store and were on our way home when I would tell my dad I wanted to run the rest of the way home.”

Dave has been running ever since.

For the past 11 years, he has run at least 15 miles a day.

His schedule is to take off on a 10 mile run in the morning, after he finishes taking care of chores on his family ranch just outside of Groveton in Houston County. Then he'll run another five miles in the afternoon.

His lifetime running total is 193,000 miles.

His goal is 200,000 miles, which he plans to reach in the spring of 2020.

“I've heard that fewer than 10 people on the planet have ever run more than 200,000 miles. I want to be one of them. I'll be 59 years old next spring. I think I'll be one of the youngest people to hit 200,000.”

He keeps records of his runs in notebooks.

Running is Dave's life.

“I love the feeling of covering distance on my own two feet,” he says. “It's very satisfying.”

He coached track in San Diego while he was raising his son. He also wrote a column about being a dad. That column won two prestigious journalism awards. Dave has lived on both coasts and ran the Boston Marathon when he was 19.

“I placed 42 and ran one of the fastest times for people under 20 years old. My time was two hours, 24 minutes and 18 seconds, which breaks down to 5 minutes and 30 seconds per mile for 26.2 miles. That's moving on.”

When he's working with livestock or driving a tractor he creates Haiku poetry.

“I was a math major at Lamar University in Beaumont, so the Haiku format of 3 lines, with 5,7,5 syllables comes pretty easy. Sometimes when I get one I like I write it down. I might take a photo of a sunset or sunrise and

write a Haiku verse about that.”

Dave has no phone, internet or television. He reads Cowboys & Indians magazine and listens to radio.

He had the coaching job in California when his dad asked him to come help run the ranch.

Skechers provides Dave with running shoes.

Other sports equipment manufacturers give him other items to test.

Skechers likes Dave because he runs on all sorts of surfaces. He's quite a popular sight around the Crockett area.

People wave when they see him and give him the right of way.

“They call me ‘that running guy.’”

His current 11-year streak is his longest without missing a single day of running at least 15 miles.

“I usually take the same route because it's well laid out, and I know how long it is. That way I don't really have to think about running. It has become, sort of, automatic.”

Running to Dave is like breathing for most people. He has run in all types of weather, from 117 degrees to 35 below.

“You don't really have a lot to show for it other than notebooks filled with numbers and a lot of worn out shoes.”



## Telling headlines ...

It was bound to happen, and finally, it did. I overheard the words “artificial intelligence” and “fake news” mentioned in the same sentence.

Maybe we need more “real thing” topics. Coca-Cola sold gazillions of its products with its “real thing” claim years ago.

During our youth, we placed great trust in mass media news, and were wary of products deemed to be “artificial,” far removed from the “real thing.”...

Many playground arguments played out between giggling school girls claiming that their “diamond rings” bought at Woolworth's were indeed diamonds. Some of these tendencies carried over into adulthood. How many guys do you know who roll up their shirt sleeves up a few inches to make sure others see their Rolex watches?

At a speaking engagement years ago, I was seated with three couples; each man was wearing a Rolex. I mentioned that I was probably sitting at the wrong table since I've never owned a Rolex.

I relaxed upon admission by all three men—a pilot, a lawyer and a physician—that their watches were fakes...

A minister friend who carefully avoided trappings of opulence thought he would never be worried about wearing a Rolex. One day, a little old lady of considerable wealth handed him a beautifully wrapped gift when she exited the church.

What to do? It was a Rolex. He didn't want to offend her by giving it back, but he didn't want to wear it either.

His solution? He never wore it

on weekdays, but come Sunday, he'd strap it on, careful to thrust his “Rolex arm” in her direction several times when he was making his strongest points....

HPU distance runner Glenn Petty, later athletic director for Abilene, TX, Public Schools, was running cross-country with his team in Omaha, NE, where it was bitterly cold, and snow was falling. He lost a shoe, but kept running, finishing 21st among more than 100 entries in the national event, and enabling his team to take runner-up honors.

The headline: “Snow Flies, Shoe Flies, He Flies.”...

For decades, periodic guffaws resulted when there were “hiccups” (sometimes downright foul-ups) by mass media. They were mostly unintentional, or were they?

One classic example occurred when radio announcer Harry Vonzel introduced the president: “Ladies and gentlemen, the President of the United States, Mr. Herbert Hoover.” Problem was, he said “Mr. Hoobert Heever.”

Some of the “doozies” occurred in newspaper headlines. Here are a few that continue to warrant chuckles, if not side-splitting laughter. (Sources are not revealed; the innocent are protected even if they're guilty!)...

### Army tries to maintain excellence after record-setting 2018

WEST POINT, N.Y. (AP) — Five years ago Jeff Monken faced a daunting challenge when he was hired at Army: Resurrect a program that had one winning season under six coaches over a 17-year span.

Now he's faced with a task that might be even more difficult. After three straight winning seasons, three consecutive victories against Navy and two outright Commander in Chief's trophies, the Black Knights are trying to maintain their status as the nation's best service academy football team.

Last year's team won a school-record 11 games and finished with its highest final ranking in the AP poll (No. 19) since 1958.

"What we've done in past seasons has nothing to do with what this team will do," Monken said as he prepared for Friday night's Black and Gold game that ends spring ball. "This team will decide what they'd like to accomplish and then decide how hard they want to work towards those goals."

"I hope they've got high hopes and lofty goals. I certainly do if they would ask me. But it's not important what I want. It's what they want."

Spring ball brought in the usual bunch of new faces, and there are some big holes to fill.

"Hopefully, we got some of those guys in place and they'll be able to contribute and help us in the fall,"

Monken said. "If that happens, then we probably accomplished what we hoped to this spring, but it's hard to say how much we've accomplished."

The Black Knights have become accustomed to winning and expect an encore performance.

"I think, and I mean this in all sincerity, that we're going to have a better team this coming year than we did this past year," said linebacker Cole Christiansen, a captain last season as a junior. "The guys that we lost are great players and their places are going to be hard to fill, but the guys coming up are equally athletic and they learn quickly — faster than any young guys I've seen so far."

Army starts next season Aug. 30 against Rice at Michie Stadium.

#### FULLBACK TURNOVER

Army's stable of fullbacks was a big reason the Black Knights topped the nation in conversions on third (112 of 196) and fourth (31 of 36) down as well as time of possession (38 minutes). Gone are Darnell Woolfolk, Andy Davidson and Calen Holt, who combined for 1,474 yards and 16 TDs.

Connor Slomka (324 yards rushing, 4.1 per carry) likely will assume the role of workhorse in place of Woolfolk.

"There's a lot of production there to replace, but we have the components and the guys that can do it," said quarterback Kelvin Hopkins Jr., who averaged 84.7 yards rushing per game.

Also gone is offensive lineman Bryce Holland, a big part of the offense's success.

#### SENIOR LEADER

Hopkins guided an attack that ranked second nationally in rushing last year (312.5 yards per game) and capped his junior season with a record-setting performance in the Armed Forces Bowl, rushing for five touchdowns in a 70-14 victory over Houston. He also took care of the ball — the offense lost just five fumbles and threw three interceptions. The eight turnovers were the second-fewest nationally.

#### SOONER EFFECT

Last year's team was undefeated at home and demonstrated it was special when it nearly beat Oklahoma in late September, losing in overtime to one of the four teams that made it to the College Football Playoff.

"It just is confirmation for our players, what we tell them all the time,"

Monken said. "If we play the way we're capable of playing, the best we have a chance to win every single game."

### Architect, usher helps design new Texas Rangers ballpark

ARLINGTON, Texas (AP) — On opening day at Globe Life Park, Margarita Aguirre showed Texas Rangers fans to their seats like the trained pro she is.

The Dallas Morning News reports this is her seventh season as a Rangers usher and her fourth working Section 209 on the third-base side.

But this isn't just a \$9-an-hour side hustle.

The 29-year-old, first-generation Latina American is also living her dream as a member of the HKS team that's designing Globe Life Field, the Rangers' new \$1.2 billion home.

"Being part of the Rangers (ushering) team, I get a behind-the-scenes view into the employees' day-to-day lives as well as a firsthand look at what fans do and don't like," she says.

What has she learned from her ballpark R&D?

Thanks to Aguirre's input, Globe Life Field will have employee break rooms with lockers on every level so that workers don't have to go to the basement to stash their things and eat their meals.

And fans going for food and beverages in the main concourse will still have sight lines to the game.

Aguirre spends three days a week working at the

job site for the new stadium.

"This being my first big project out of school is

just unbelievable. It's part of my whole pinch-me moment, you know?" she says.

"She's very talented," says Mark Williams, HKS principal and head of its sports division. "She wants to learn and will do whatever it takes. We just keep feeding her more and more responsibility, broadening her role, giving her hands more rein, and she just keeps blowin' and goin'. It's incredible."

Aguirre has known since she was 12 that she wanted to design sports facilities for HKS Inc. in Dallas.

Yes, you read that right.

Aguirre's parents, Irma and Reynaldo, immigrated separately from civil-war-torn El Salvador to California in the 1980s. They met, married and Margarita was born in 1989. The family moved to Irving when Margarita was 4.

Every year, the family visits relatives in El Salvador. When Margarita was 10 and about to enter the fifth grade, her mother's cousin — whom Margarita calls her aunt — introduced her to floor plans, drawings, models and AutoCAD software.

Margarita was smitten.

Two years later, the middle-schooler toured HKS as part of a summertime career program.

She saw stadium seats, architectural drawings and models of stadiums, ballparks and arenas. "It was another oh-my-gosh, a-ha moment. 'This is what an architecture firm does,'" Aguirre recalls. "I thought, 'I want to work here. This is where I want to be.'"

# Cavs no longer chasing NBA title, pursuing coach for future

INDEPENDENCE, Ohio (AP) — The Cavaliers aren't chasing a championship this spring. They're pursuing a coach.

This time, methodically.

No longer NBA title contenders, Cleveland is in the initial stages of an expansive, open-minded search general manager Koby Altman hopes leads to finding a coach to align with his young team, which is coming off a 63-loss season.

"We have to preach patience and we have to continue to grow this thing and we have to find a leader that's obsessed with that process of growing," Altman said Friday while outlining the type of candidates he'll interview. "We're tasked with doing that. We're excited about the next steps. We're done in April for the first time in four years, so we have a lot of time."

At this time a year ago, the Cavs were preparing to make another deep playoff run. They made the Finals for the fourth straight year, but fell short in June against Golden State and then suffered a more devastating blow when LeBron James left a month later. The team endured severe growing pains this past season, which included a coaching change and countless injuries, but Altman believes better days lie ahead.

"The future is bright," he said.

His task is finding the right coach to lead the Cavs into it.

Altman plans to cast a "wide net" in his search for the fifth coach since 2013. He and his staff are paring down a list of potential candidates that will include former head coaches, current assistants — including some on playoff teams — as well as college coaches of both sexes. Head coaching experience is a plus, but not essential and he's not limiting the search to candidates with whom he has a previous connection.

Already, names are beginning to surface with several assistants who have ties to the Cavs.

Denver's Jordi Fernandez, Utah's Alex Jensen, Orlando's Steve Hetzel, Atlanta's Chris Jent, Portland's Nate Tibbetts and Dallas' Jamahl Mosley all spent time working for Cleveland. Altman intimated continuing the Cavs' rebuild with a person already familiar with the organization would be beneficial.

As for a timetable to find a coach, Altman said, as long as it takes.

"We want to make sure we get this right," he said. "We want to make sure we get to know these candidates really, really well and flush this thing out. Make sure it's the right fit for the front office, for our players, for the fan base. We want availability, grinding and all that kind of stuff. We want to make sure that's the right fit and we're the right fit for them, too."

When Altman gets toward the final stages of the process, he said he may consult with Cavs players. Altman said his primary objective is landing a coach dedicated to development.

"It's important that we find a leader that's in it for the long haul, that really wants to be a part of Cleveland, our city and this team and help us grow every day," he said. "I think we have to be obsessed with this process of getting better and not so much results-driven — and that's the person I need to find."

The Cavs finished with the league's second-worst record and are positioned to add a major piece in the draft. Obviously, winning the lottery and getting Duke's Zion Williamson would solve numerous problems. However, choosing first isn't everything, and Altman is confident the Cavs already have enough pieces to attract quality coaching candidates.

"We are going to draft a high-impact player, regardless of where the Ping-Pong balls land and all those things together are a big part of us being an attractive destination," he said. "But I will say this, we're not going to sell our job. The person that is right for this job is going to really, really want to be here. That's going to be the person we hire."

Altman again praised Larry Drew, who took over in October and kept the Cavs competitive until the end. Drew isn't part of the future, but Altman said he left a lasting imprint.

"The great thing that I can be proud of this year is our attitude," Altman said. "We had a great attitude. It wasn't heavy. It wasn't dark, even through all the losses. We had great attitude, great work ethic, and so I think we can build on that."

## After trading Beckham, Giants made sure Shepard stays

EAST RUTHERFORD, N.J. (AP) — The New York Giants have signed wide receiver Sterling Shepard to a four-year contract extension.

The Giants announced the signing Friday just a month after general manager Dave Gettleman stunned many by trading offensive catalyst and fellow receiver Odell Beckham Jr. to the Cleveland Browns.

Details of the deal were not announced, but Shepard is expected to earn \$41 million. The extension will keep him with New York for another five years, counting the final year of his rookie contract.

A second-round draft pick in 2016, Shepard has 190 catches for 2,286 yards and 14 touchdowns in three seasons. He has been durable, missing only five games in 2017.

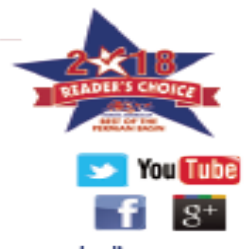

# Stand Up Howard County

One evening, hundreds of balloons and a community joined together, all in hopes of raising awareness for child abuse. The sixth annual Stand Up Howard County child abuse awareness event took place Thursday afternoon.

"The community turned out in support as they always do, and we had more than 20 organizations on site providing information for families and youth," April Arms, event coordinator, said.

A proclamation, read by Mayor Larry McLellan, kicked off the event, followed by a balloon release. The balloons were a small representation of the number of kids affected by child abuse each year.

"Child abuse is a topic we stay away from because we like to think this doesn't exist in our community, but the reality is it does, and the numbers are high compared to other like communities," Arms said.

**Shazam!**  
Back in the 1970s, my pre-teen self was a big fan of the "Shazam! and Isis Power Hour" television show...you know the one: "Chosen from among all others by the Immortal Elders — Solomon, Hercules, Atlas, Zeus, Achilles, Mercury — Billy Batson and his Mentor travel the highways and byways of the land on a never-ending mission: to right wrongs, to develop understanding, and to seek justice for all! In time of dire need, young Billy has been granted the power by the Immortals to summon awesome forces at the utterance of a single word! SHAZAM!" Oh, and Isis was pretty cool too, for a girl. Since that epitome of '70s cheese, we've had a few animated efforts at portraying DC's Captain Marvel — now, I understand, officially remonikered "Shazam" — but a new live-action version is in the theaters starring TV's "Chuck," Zachary Levi.

The movie starts out in 1974 with young Thaddeus Sivana (Ethan Pugiottto) playing with his Magic 8-Ball as he travels by car with his verbally abusive dad (John Glover) and bullying older brother Sid (Landon Doak). Suddenly the ball starts showing some weird symbols, and Thaddeus is transported to a big cave where the wizard Shazam (Djimon Hounsou) tells him he's looking for a champion to battle the forces of the Seven Deadly Sins. Shazam soon determines Thaddeus is too hungry for power (perhaps to fight off his dad and brother) to be the right champion, so he sends him back. Thaddeus inadvertently causes a wreck in which his dad loses the use of his legs.

Flash forward to a few years ago. Young Billy Batson (David Kohlsmith) is at the carnival with his mom (Caroline Palmer) where she wins him a compass instead of the stuffed tiger he wants. As they start to leave, Billy drops the compass and chases after it as it's kicked a few times by people in the crowd. After he retrieves it, mom is nowhere to be found. He's taken to Child Protective Services by the police, and put into the foster system.

Onwards to the present day, where now-14-year-old Billy (Asher Angel) tricks a couple of cops and gains access to their police cruiser's computer, where he looks up the address of a nearby Ms. Batson. He tracks her down, but discovers that she's an African-American woman and not his mom. The police catch up and take him back to his Social Worker, who places him with Rosa and Victor Vasquez (Marta Milans and Cooper Andrews), a couple who already have five other foster kids: Freddy Freeman (Jack Dylan Grazer), Darla Dudley (Faithe Herman), Mary Bromfield (Grace Fulton), Eugene Choi (Ian Chen), and Pedro Pena (Jovan Armand). Billy is put in a room with Freddy, who walks

with crutches. Billy is also a superhero fan, with memorabilia such as an authenticated bullet which has actually bounced off of Superman, and a replica Batman batarang. Unfortunately, at Fawcett High, Freddy's crutches and cocky attitude make him the continual victim of the bullies Brett and Burke Breyer. When Billy defends Freddy by decking the bullies with Freddy's crutch, the brothers chase him, but he escapes onto the subway.

On the subway, Billy experiences an event similar to Sivana's mid-'70s journey to Shazam's cave.

Flash back to a Dr. Lynn Crosby (Lotta Losten), who's interviewing subjects who have had similar Shazam Cave experiences as part of a mass hysteria study. They've all had similar experiences, but this woman has video of weird symbols on her alarm clock. Grown-up Thaddeus — now Dr. Sivana (Mark Strong) — emerges from the shadows, demanding that she show him the video. Using the symbols, he figures out how to travel magically to the cave. While there, he steals the power of the Seven Deadly Sins, and leaves to begin his quest for world domination.

Billy arrives at the cave, and the wizard is about out of options. He needs a champion now, so he demands that Billy grasp his staff and say his name. After the required joke about this obvious creepiness, Billy does so and is transformed into a six-foot tall red spandex and white cape clad Zachary Levi.

I'll stop the narration there. Look for performances from Adam Brody, Meagan Good, Michelle Borth, Ross Butler, and D.J. Cotrona. Giving you the characters they portray would be a spoiler.

This isn't the "Shazam!" I remember from my childhood, or even the one from later comic books and animated movies. While the transformation into super hero form supposedly gives Billy Batson the "Wisdom of Solomon," the character in the movie is played with the knowledge, motivations, and sense of an immature 14-year-old. And Levi plays it for laughs.

That's not the only deviation from traditional Shazam — Dr. Sivana in the comics is a shriveled old 4-foot-tall bald mad scientist. He uses his genius intellect to build devices to battle the super hero. He most certainly doesn't gain superpowers and battle him hand to hand.

Otherwise, it's surprisingly not a bad movie. Billy's discovery of his superpowers (with Freddy's help) is pretty funny.

I'm going to give "Shazam!" (perhaps with a healthy dose of nostalgia) eight stars out of 10. It may not be exactly the Shazam movie I wanted, but maybe it's the Shazam movie I need. Or something.

### Banks push US stocks higher after reporting solid profits

NEW YORK (AP) — U.S. stocks moved broadly higher in morning trading Friday on Wall Street, putting the market on track to erase much of the losses it sustained this week.

Banks led the gains after solid quarterly profit reports from JPMorgan Chase opened the latest round of highly anticipated company earnings. Banks have been benefiting from higher interest rates, which allows them to book fatter profits from making loans.

Energy companies rallied after Chevron said it would pay \$33 billion to buy rival Anadarko Petroleum. The sector has been rising as oil prices moved steadily higher throughout the year.

Disney surged 8.9% to an all-time high after it announced plans to offer its own video streaming service. Disney will be going head-to-head with Netflix, which fell 3.7%.

Fears over a global economic slowdown were put in check by a surge in China's exports in March. That marks a turnaround from a severe contraction in February as the U.S. and China continue negotiating a resolution to their costly trade war. Indexes in Europe and Asia rose broadly.

Investors continue focusing on company earnings reports due over the next few weeks in hopes of gleaning clues about the trajectory of the U.S. economy. Citigroup, UnitedHealth Group and Johnson & Johnson are among the larger companies releasing results next week.

KEEPING SCORE: The S&P 500 index rose 0.4% as of 11:30 a.m. The index erased its losses for the week and is now on track to post its third weekly gain in a row.

The Dow Jones Industrial Average rose 192 points, or 0.7% to 26,332, riding on gains from Disney, Goldman Sachs and JPMorgan Chase. It's still down slightly for the week. The Nasdaq composite rose 0.2%.

ANALYST'S TAKE: The market is coming off a wobbly week as investors worried that the early first-quarter earnings reports would come in even

weaker than the low expectations analysts already have.

Sam Stovall, chief investment strategist at CFRA, said the solid results from major banks Friday were encouraging, but investors need to see more.

"In general, you need to have the financial companies participate in order for a market advance to continue," Stovall said. "Investors will be waiting, listening for other news that would be beneficial not only to banks, but to industrial and technology stocks."

OIL! Anadarko Petroleum surged 33% as Chevron moved in with a \$33 billion buyout that will give it a stronger position in the energy-rich Gulf of Mexico and Permian Basin region in Texas.

Oil prices have surged about 40% so far this year, sending energy company revenues higher and giving them more funds for investment.

Pioneer Natural Resources rose 9.6% and Devon Energy rose 5.8%. Chevron was one of the few decliners in the sector. It shed 5.3%.

MAKING BANK: JPMorgan Chase rose 4.2% after reporting solid profits in the first quarter. They are the first major bank to release financial results.

Wells Fargo initially rose after its results beat analysts' forecasts, but it turned lower in midmorning trading and was down 3.1%.

Both reports show that higher interest rates during the quarter drove increases in revenue. Those higher rates allow banks and financial companies to charge more for loans and credit cards.

Bank of America rose 2.8% and Citigroup rose 2%.

STREAMING MOUSE: Disney surged 9.5% after it released plans to offer a streaming entertainment service.

Disney Plus video is scheduled to roll out on November 12 at \$6.99 per month. The service is well below the \$13 monthly price tag for rival Netflix, whose stock fell 3.3%.

Disney ended a lucrative licensing relationship with Netflix in order to create the streaming service. It faces challenges as it builds a service to compete with the entrenched streaming leaders, which also include HBO Go and Showtime.

# FCC to hold big 5G auction, spend \$20B for rural internet

NEW YORK (AP) — The U.S. communications regulator will hold a massive auction to bolster 5G service, the next generation of mobile networks, and will spend \$20 billion for rural internet.

5G will mean faster wireless speeds and has implications for technologies like self-driving cars and augmented reality. The rollout started last week in the U.S. and South Korea but will take years.

The Federal Communications Commission said Friday that it would hold the largest auction in U.S. history, of up to 3,400 megahertz, to boost wireless companies' networks.

Rolling out 5G has been a source of tension between the U.S. and China. The U.S. government has effectively banned the Chinese telecom equipment maker Huawei in the majority of U.S. networks due to concerns about Chinese government spying and has pressured allies to do the same as they build out 5G. Huawei, the world's largest maker of such equipment, has said this security concern is unfounded.

The FCC also said Friday that it will be "repurposing" funds from existing programs to provide \$20.4 billion, with the goal of connecting up to 4 million rural homes and small businesses to high-speed internet. There are 24 million Americans without access to broadband, and the problem is worst in rural areas.

The agency has spent billions subsidizing rural broadband — \$34.5 billion from 2010 to 2017, according to the Government Accountability Office — with more money coming from other programs. Still, the "digital divide," particularly in rural areas, persists.

FCC Chairman Ajit Pai said Friday that he hopes to start the auction in December and the fund proceeding later this year.

The agency said he will talk about these 5G initiatives at a White House event with President Donald Trump later Friday.

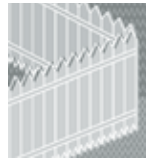

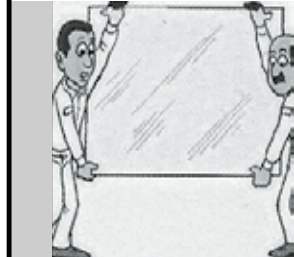

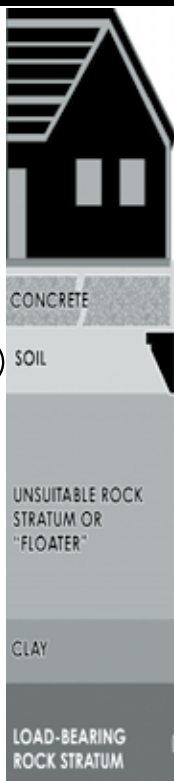

Assume you're East and your partner leads the ten of hearts against three notrump. Declarer covers with the jack, and you realize it would be wrong to play your king because declarer, who certainly has the ace, would thereby acquire an additional entry to dummy's diamonds.

After the jack holds, South plays a club to the ace, leads the jack of diamonds and finesses. Again you duck, since your only hope of defeating the contract lies in preventing

declarer from utilizing dummy's long suit. He thereupon leads another diamond to the queen, but this time you take the trick and shift to the queen of spades.

As a result of your holding up the king of hearts at trick one and the king of diamonds at trick three, South eventually goes down, and you have a right to congratulate yourself on your defense. At the same time, your ebullience is tempered by the realization that you were pretty lucky to defeat the contract, since if declarer had played correctly, nothing could have stopped him from making five notrump!

All he had to do to ensure success was to play the four of hearts from dummy at trick one instead of the jack. After taking the ten with the ace, he leads the jack of diamonds and finesses. When the jack wins, he repeats the finesse.

You take the king and return a spade or a club. South wins and leads a heart to dummy's Q-J, establishing an entry to dummy that enables him to score five diamond tricks as well as two tricks in each of the other three suits.

Thus, if declarer stops to think things over before making his first play at trick one, he's sure to wind up a winner regardless of how good a defender you are.

**Dear Miserable in Mansfield:** There's no chance you won't, if your heart and mind are set on it. Find activities that

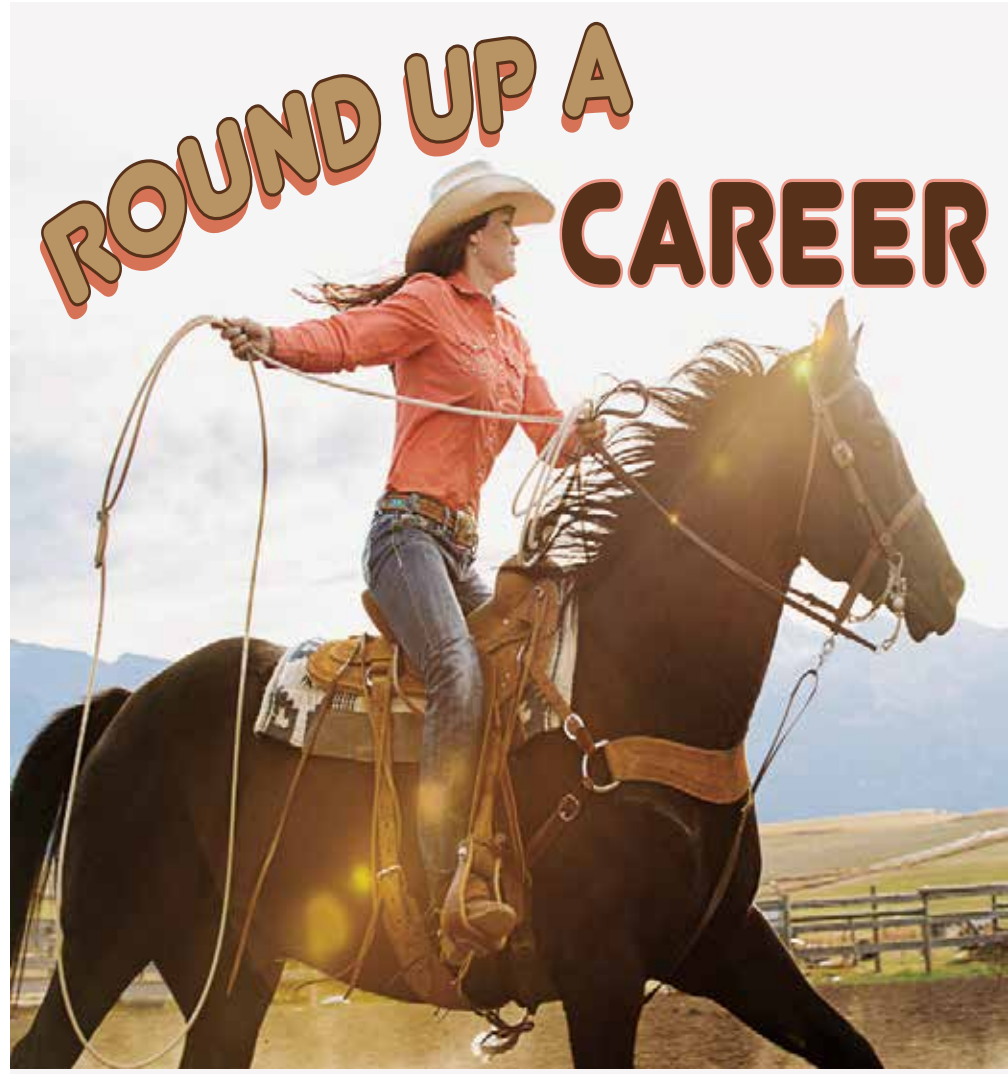
