

Jeanie Knocke is retiring from Wells Fargo

For 47 years, Wells Fargo Bank in Big Spring has been graced by the friendly face of an employee who's sole concern is helping the customers who walk through the bank doors.

Today, Jeanie Knocke, Wells Fargo's longtime receptionist, is retiring.

Knocke, a lifelong Big Spring resident, joined the bank's staff in 1972, and worked in the Proof Department, where she performed a variety of functions related to check processing, deposits, withdrawals and payments, including error checking and reconciliations, adjustments and corrections. In the '90s, she transitioned to a position as a personal banker for 10 years, then took over as receptionist in 2001. While her job title has changed over the years, she has always greeted those coming through the bank doors with a smile.

Several of Knocke's friends spoke about her dedication, generosity, and kindness.

"I just want to cry just talking about her," said Laura McEwen, widow of late Big Spring Mayor Russ McEwen. "She is the sweetest, kindest... She and I love animals. We love animals, but she loves people and she will do anything she can to help people. You can't get them any better than Jeanie.

One suspect in custody after making threats

MIDLAND -- Multiple threats have been called in and reported across the Permian Basin since last weekend's mass shooting event, which took the lives of seven victims and injured more than 25 others. The most recent, on

Thursday afternoon, resulted in a ninth grader at ECISD being charged with threatening to use or exhibit a firearm, according to the Odessa American.

While the girl did not have a weapon and the police officers who responded believe students and staff were not in danger, according to a press release, the student did admit to making the threat.

(Jeanie's husband) Richard's the same way. When Russ passed away, they were right up there at the hospital with me. They are just both really, really good Christian friends."

McEwen spoke about Knocke's caring for others. "Jeanie knows about everything going on. She knows everything. She is the best," she said. "She sends cards to everyone. She is a card person. She sends cards all the time to sick people, she's constantly sending cards...My mom was sick and actually passed away a couple of years ago, and she sent her cards all the time. We've got a good friend who's battling some bad illness right now, and she's sending her cards all the time. You couldn't honestly find a better sweetest person than Jeanie. Everybody loves Jeanie."

Jeanie's husband Richard works at Big Spring's Southwest Tool, which is owned by her brother, Jimmy Johnson. The couple live in Big Spring with their dog Coal, and have a son, daughter-in-law and two grandkids in the Dallas area. Jeanie also has a sister in Ruidoso and her mom lives in Big Spring.

"I'm just so excited she's finally retiring. I think we will see more out of Jeanie," McEwen said. "She's always been giving because she has at the bank, but she's going to get into volunteering or she's just going to stay busy. I'm thrilled because she's going to realize just how much fun she's going to have after she worked so hard. She worked hard at the bank. She had some long hours and she was always there. She's got a lot of fun years to come, so I'm just excited for her."

Another friend who spoke about Jeanie is Howard College's basketball coach, Earl Diddle.

"I came to town 16 years ago as the women's basketball coach, and I had previously been with Wells Fargo, so I walked in and Jeanie greeted me as she does everyone," he said. "I just think that Jeanie Knocke is the greatest arm of public relations that Wells Fargo has. I noticed that she would help me with anything I wanted. I wasn't a very good banker, so she really helped me, and I noticed she helped everyone else and did anything that was within her power to help people and to guide them in the right direction."

Coach Diddle said that Knocke helps "...to ease the pain of banking, and what it's becoming today,

that customer service is really kind of out the window," he said. "They want you all to become online bankers, and for some of us...that really doesn't interest me. But she was just wonderful and hospitable and really very kind, and I think she's just a pillar of the community."

Diddle said he often walks by Knocke's house on his way home from work.

"I know her husband and I know her dog Coal. I stop and pet Coal every once in a while," he said. "She always asks me about our team, and she's very concerned about Howard. She loves Big Spring, and she loves Howard College. It makes you feel better, really, about yourself and what you're doing because of her interest." Coach Diddle had good wishes for Jeanie's retire-

"I just think the world of her. She'll never be re-

placed," he said. "Obviously I'd like to wish her well with what she's got ahead of her. She's got a lot of energy and she's wonderful with people. I hope that she can inspire and have an affect on other people the way she's affected me. I'm sure she will. I hope she finds a peace in her retirement and finds something to do, because she brings a lot of positive energy to the people she touches, and that's a rare quality." Big Spring's Donna Wright also offered some

kind words about her friend, Jeanie Knocke. "I cannot begin to say enough good things about

Jeanie. She is a one of kind! I have known her for years and she is a true friend, fun loving, the most caring of others and her community of anyone I have ever known," Wright said. "She always greets you with that big smile and that infectious laugh. Everyone comes to Jeanie when they need something and it never matters how big or small the need is, she will always do what she can to help to get what they need."

Patricia Vess is a friend of, and former co-worker at Wells Fargo, with Jeanie. "Jeanie is the most generous person I know. She

loves people and will do anything for anybody. She volunteers wherever needed in her community and for her church," Vess said. "On a funny note, she used to come to work with rollers in her hair and everyone would say 'Do you know you still have your rollers in?' and she would just laugh and say 'Yes, I know.' When we worked in proof there was no telling where you would find an eyelash. You just pick it up and give it to Jeanie and say 'I found

your eyelashes.' She also has a ton of jewelry. She has matching jewelry for everything she wears. Love that woman and she is so special. Wells Fargo does not know what they are losing."

Lisa Hobbs of Big Spring spoke about Jeanie's customer service ethic and caring attitude for her customers and friends.

"If you look up the words 'Customer Service' in a dictionary, you will see Jeanie's picture," Hobbs said. "She never forgets a name, a birthday or anniversary of anyone she knows. Her thoughts were and still are, 'I am here for the customers.' For years, during the third week of December, she turned the bank lobby into Santa's Workshop, wrapping gifts her family had purchased throughout the year for children in need."

If you need anything, Jeanie's the person to go to for information, Hobbs said.

"She is like a living, breathing Chamber of Commerce," she said. "You need a house to buy or rent, she knows someone who has one. Need a doctor? She will find you one. Child care, vet, anything you can think of, she either knows someone or knows who to call. Jeanie would give you her last

dime if she thought you were going to go hungry or needed a roof over your head. It will be sad to go into the bank and not see her smiling face behind the front desk, but I know she will be happy to have time to spend with her family."

Reflections: How To Remain Positive in a Negative World

Since this column reflects on current events and life experience, I am constantly searching



the news for information. It is a daunting task. The headlines alone are depressing, let alone the blowby-blow accounts of murder, theft, graft, rape, sexual abuse, prejudice, hatred, scams, suicide, mass shootings, political corruption and \boldsymbol{B}_{ILL} that drags every ray of light into its

a looming recession. Sometimes the news seems like a black hole $_{\mbox{\scriptsize Tinsley}}$ dark abyss. I spent some time this morning reading about the victims in last weekend's senseless shooting in Midland-Odessa, Texas.

It is difficult not to become a pessimist from this constant onslaught, but we must not give in. We must resist the darkness and cling to the light. We must not surrender to the pessimism that surrounds us.

A new study released August 26 by the Boston University School of Medicine concludes that people who are more optimistic live 11 to 15 percent longer and are 50 to 70 percent more likely to reach age 85. But how do we remain optimistic in a world filled with pessimism?

It seems to me that we do so by looking for the moments that renew our faith in each other. Like the tender moment when Naomi Osaka embraced 15-year-old Coco Gauf after soundly defeating her in the round of 16 at the U.S. Open and persuading her to share the post-game inter-

We can remain optimistic by focusing on obscure moments like the first day of second grade reported by WIVB News in Wichita, Kansas. Eight-year-old Christian, who is African American, saw eight-year-old Conner, who is white, standing alone crying while they waited for the school to open. Quietly, Christian reached out and took Conner's hand. Conner stopped crying and the two of them walked into their classroom together, hand-in-hand. Conner is autistic.

We are surrounded by little acts of kindness, some demonstrated on the grand stage like Osaka and Gauf, others in obscure corners like Christian and Conner, and we are sustained by a faith that overcomes darkness and despair. Love overcomes hate. Forgiveness wipes away resentment and guilt. Resurrection conquers death. Our God, who is the Father of Lights, is the source of all good things.

The Bible is the most realistic and most optimistic book ever written. It clearly exposes man's sin and consistently demonstrates God's righteous redemption. It embraces the Cross with all of its pain and despair and proclaims the resurrection in all of its glory.

The Bible always offsets our struggle with discouragement and despair with the hope of faith and the unchangeable goodness of God. Three times the Scripture asks, "Why are you in despair O my soul? And why have you become disturbed in me? Hope in God, for I shall again praise Him for the help of His presence" (Psalm 42:5, 11; 43:5).

The Apostle Paul wrote, "We were burdened excessively, beyond our strength, so that we despaired even of life; indeed we had the sentence of death within ourselves so that we would not trust in ourselves, but in God who raises the dead" (2 Cor. 1:8-9). Jesus said, "I have told you these things so that

in me you may have peace. In the world you will have trouble. But take heart! I have overcome the world" (John 16:33).

Explanatory Statements for the November 5, 2019 Constitutional **Amendment Election**

Proposition Number 1 (HJR 72)

HJR 72 proposes a constitutional amendment permitting an elected municipal judge to serve as a municipal judge in more than one municipality at the same time. Unlike an appointed municipal judge, an elected municipal judge may not concurrently hold another municipal judge office. This amendment would allow an elected municipal judge to serve as a municipal judge in more than one municipality at the same time, in the same manner as appointed municipal judges.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment permitting a person to hold more than one office as a municipal judge at the same

Proposition Number 2 (SJR 79)

SJR 79 proposes a constitutional amendment authorizing the Texas Water Development Board to issue additional general obligation bonds, in an amount that does not exceed \$200 million, for the economically distressed areas program. These bonds can only be used to provide financing for the development of water supply and sewer service projects in those economically distressed areas as defined by law.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of additional general obligation bonds by the Texas Water Development Board in an amount not to exceed \$200 million to provide financial assistance for the development of certain projects in economically distressed areas."

Proposition Number 3

(HJR 34) HJR 34 proposes a constitutional amendment allowing the legislature to temporarily exempt from ad valorem taxation a portion of certain property located in an area covered by a disaster declaration of the governor. The proposed amendment would allow the legislature to prescribe the method of determining the amount of the tax exemption and the duration of the exemption and also would allow the legislature to create any additional eligibility requirements for the tax exemption.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for a temporary exemption from ad valorem taxation of a portion of the appraised value of certain property damaged by a disaster."

Proposition Number 4 (HJR 38)

HJR 38 proposes a constitutional amendment prohibiting the state from imposing or collecting an individual income tax, including an individual's share of partnership and unincorporated association income. There is no current constitutional bar on imposing or collecting an individual income tax.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment prohibiting the imposition of an individual income tax, including a tax on an individual's share of partnership and unincorporated association income."

Proposition Number 5 (SJR 24)

SJR 24 proposes a constitutional amendment that would automatically appropriate the net revenue received from the portion of the state's tax revenue received on sales of sporting goods to the Texas Parks and Wildlife Department (TPWD) and the Texas Historical Commission (THC). The legislature would maintain the authority to determine the specific uses of the funds and their allocation between TPWD and THC.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment dedicating the revenue received from the existing state sales and use taxes that are imposed on sporting goods to the Texas Parks and Wildlife Department and the **Texas Historical Commission** to protect Texas' natural areas, water quality, and history by acquiring, managing, and improving state and local parks and historic sites while not increasing the rate of the state sales and use taxes."

Proposition Number 6 (HJR 12)

HJR 12 proposes a constitutional amendment authorizing the legislature to increase the maximum bond amount for the Cancer Prevention and Research Institute of Texas (CPRIT) from

\$3 billion to \$6 billion to be issued by the Texas Public Finance Authority. CPRIT was created in 2007 to promote and fund cancer research in Texas. CPRIT uses bond proceeds to award grants for cancer research and prevention.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to increase by \$3 billion the maximum bond amount authorized for the Cancer Prevention and Research Institute of Texas."

Proposition Number 7 (HJR 151)

HJR 151 proposes a constitutional amendment allowing increased distributions from \$300 million per year to \$600 million per year to the available school fund and also allowing the State Board of Education, the General Land Office, and other entities that manage revenue from land or other properties held in the permanent school fund to distribute certain revenue to the available school fund.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment allowing increased distributions to the available school fund."

Proposition Number 8 (HJR 4)

HJR 4 proposes a constitutional amendment creating the flood infrastructure fund as a special fund in the state treasury, using money appropriated from the economic stabilization fund. The flood infrastructure fund would provide additional resources to implement plans to mitigate flood damage. The proposed amendment would authorize the Texas Water Development Board to use money in the flood infrastructure fund for drainage, flood mitigation, or flood control projects. The proposed amendment also would authorize the creation of separate accounts in the flood infrastructure fund as necessary to administer the

fund or authorized projects. The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the creation of the flood infrastructure fund to assist in the financing of drainage, flood mitigation, and flood control projects."

Proposition Number 9 (HJR 95)

HJR 95 proposes a constitutional amendment authorizing the legislature to create a property tax exemption for precious metal held in a precious metal depository located in this state.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to exempt from ad valorem taxation precious metal held in a precious metal depository located in this state."

Proposition Number 10 (SJR 32)

SJR 32 proposes a constitutional amendment authorizing the legislature to allow a state agency or political subdivision to transfer a law enforcement animal to the animal's handler or another qualified caretaker in certain circumstances. Currently, the Texas Constitution prevents the transfer of certain public property, such as law enforcement animals, to a private person or organization at no cost. This amendment authorizes the legislature to allow the transfer of a law enforcement animal to the animal's handler or another qualified caretaker at no cost, upon the animal's retirement or at another time if the transfer is determined to be in the animal's best interest.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to allow the transfer of a law enforcement animal to a qualified caretaker in certain circumstances."




But the greatest thing about the confession of my sin is knowing that I can tell God, and He doesn't think any less of me. He already knew what kind of Christian I would be even before He saved me.



Saints' long-awaited shot at redemption starts vs. Texans

NEW ORLEANS — Perhaps no team wants to move on from last season more than the New Orleans Saints.

They've spent nearly eight months preparing to play a meaningful game for the first time since their emotionally crushing loss in an NFC title game tainted by officiating gaffes so obvious that the NFL felt compelled to change the rules in an effort to avoid a recurrence of major missed calls at crucial moments.

And while the stakes in Week 1 will be lower than last January, New Orleans wants to squelch any notion of a hangover effect against Houston on Monday night.

"It's got to strengthen you and motivate you," quarterback Drew Brees said this week. "Anytime you have some sort of negativity or some sort of adversity, it's: Are you going to allow it to affect you negatively or are you going to allow it to affect you positively? I think we take the approach that we're going to let it affect us positively. The togetherness on this team, the strength of this team, the way guys are there to lift each other up and support each other, it's pretty

Emotions are bound to be running high in the Superdome when fans, some of them so aggrieved by how last season ended they filed lawsuits against the NFL, welcome the

Saints back for a new season.

And Texans coach Bill O'Brien finds it hard to imagine the Saints opening a new season in a tailspin because of how last season ended. After all, New Orleans only got better in 2018 after its previous campaign ended on an unlikely, 61-yard Vikings touchdown as time ran out on a divisional-round playoff game in Minnesota. The Texans, meanwhile, had their own share of playoff disappointment last January, falling at home to Indianapolis after they'd won the AFC South.

The Saints, O'Brien said, "have been at a championship level for a long time.

"It's going to be a great game. You've got two teams that are starting off the season with high hopes and two teams that have a lot of great players," O'Brien continued. "I'm sure that the Saints are looking forward to having a good 2019, just like the Houston Texans are. I think we've all moved on."

Prescott focuses on goals for Cowboys amid contract chatter By SCHUYLER DIXON drafted Prescott in the fourth round,

FRISCO, Texas — Dak Prescott smiled without saying a word when a reporter wondered aloud why the star quarterback of the Dallas Cowboys didn't hold out for a new contract, a strategy that just led to a \$90 million extension for backfield mate Ezekiel Elliott.

The 2016 NFL Offensive Rookie of the Year is going into the final season of his rookie deal — a year ahead of Elliott — while trailing only New England's Tom Brady in victories since entering the league and coming off his first playoff win.

Yet Prescott has never shown even a slight interest in staying away to try to get a contract that will be

worth more than twice as much as Elliott's annually, assuming the two-time Pro Bowler and the Cowboys that common

ground. As with Elliott, the deal figures to get done. In meantime, Prescott wants push the Cowboys past

There's one year left for that breakthrough since Dallas won the last of a proud franchise's five Super Bowl titles during the 1995 season. Prescott's pursuit starts Sunday with the opener at home against the New York Giants.

"I mean, obviously I want to see it done," Prescott said of a contract that will be the richest in franchise history when it happens. "At this point, my focus is all on the Giants, the Giants defense, what this team needs to do to win the game and then next week we'll go to the next opponent.

"I don't want to blur my mind or distract myself any bit with thinking about those talks or thinking about what's going on when I've got enough on my plate to handle."

That doesn't mean the deal can't get done during the season. It just means Prescott probably won't be as involved in the talks as he was for another 10 years.

"Amidst all the contract stuff, the guy comes to work ready," said Witten, who watched his best friend in Romo lose his job when Prescott led the Cowboys to a franchise-record 11 straight wins and the top seed in the NFC before a divisional loss to Green Bay in 2016.

"He's ready every single day. Ask

any guy in the locker room, they'll through a wall for me at this point in my career to have a young teammate come in at that position and to see him take each step."

Prescott and Elliott formed a rare pair in leading an of-

fense from the first snap of their first season together. They missed Witten last year, particularly inside the 20-yard line. Receiver Amari Cooper was a huge boost in a midseason

Now the Cowboys have added one of Aaron Rodgers' favorite targets in Green Bay, Randall Cobb, as the slot receiver with Cole Beasley's departure to Buffalo in free agency. Michael Gallup, who was solid as a rookie, appears poised for a big improvement in his second year.

Center Travis Frederick returns after missing last season with a nerve disorder, re-solidifying an offensive line that has been among the best in the league but slipped last year. Prescott was sacked 56 times, second-most in the NFL.

Three years after starting against the Giants when many figured the Cowboys were on their way to another lost season without an injured Romo, Prescott is trying to meet lofty expectations instead of surpass modest ones.





This Date In History

Today in History Today is Friday, Sept. 6, the 249th day of 2019. There are 116 days left in the year. Today's Highlight in His-

On Sept. 6, 2006, President George W. Bush acknowledged for the first time that the CIA was running secret prisons overseas and said tough interrogation had forced terrorist leaders to reveal plots to attack the United States and its allies. On this date: In 1901, President William

McKinley was shot and mortally wounded by anarchist Leon Czolgosz (CHAWL'gawsh) at the Pan-American Exposition in Buffalo, New York. (McKinley died eight days later; Czolgosz was executed on Oct. 29.) In 1909, American explorer Robert Peary sent a telegram from Indian Harbor, Labra-

dor, announcing that he had

reached the North Pole five months earlier. In 1943, 79 people were killed when a New Yorkbound Pennsylvania Railroad train derailed and crashed in Philadelphia. In 1949, Howard Unruh, a resident of Camden, N.J., shot and killed 13 of his neighbors. (Found to have paranoid schizophrenia, Unruh was confined for the rest of his life; he died in a Trenton nursing home in 2009 at age 88.)

In 1972, the Summer Olympics resumed in Munich, West Germany, a day after the deadly hostage crisis that claimed the lives of eleven Israelis and five Arab abduc-

In 1985, all 31 people aboard a Midwest Express Airlines DC-9 were killed when the Atlanta-bound jetliner crashed just after takeoff from Milwaukee's Mitchell Field.

In 1995, Baltimore Orioles shortstop Cal Ripken broke Lou Gehrig's record by playing his two-thousand-131st consecutive game. In 1997, a public funeral

was held for Princess Diana at Westminster Abbey in London, six days after her death in a car crash in Paris. In Calcutta, India, weeping masses gathered to pay homage to Mother Teresa, who had died the day before at age 87.

In 2002, meeting outside

Washington, D.C. for only the second time since 1800, Congress convened in New York to pay homage to the victims and heroes of September 11. In 2003, Justine Henin-Hardenne (EH'-nihn ahr-DEHN') won the all-Belgian women's singles final at the

woman Kim Clijsters (KLY'sturz), 7-5, 6-1. In 2004, in Iraq, seven members of the First Marine Division from Camp Pendleton, California, and three U.S.-trained Iraqi soldiers were killed by a car bomb near Fallujah.

U.S. Open, beating country-

In 2017, Hurricane Irma, the most powerful hurricane ever recorded in the Atlantic, pounded Puerto Rico with heavy rain and powerful winds; authorities said more than 900,000 people were without power. (Hurricane Maria, which would destroy the island's power grid, arrived two weeks later.) A California parole panel recommended parole for Leslie Van Houten, who at 19 was the youngest of Charles Manson's murderous followers in 1969. (California Gov. Jerry Brown later blocked her release.) Ten years ago: The White House announced the resignation of President Barack Obama's environmental adviser Van Jones, who'd become embroiled in a controversy over past inflammatory statements;

against him.

Jones cited what he called a

"vicious smear campaign"

Five years ago: President Barack Obama, in an interview taped for NBC's "Meet the Press," said the surge of immigrant children entering the U.S. illegally had changed the politics surrounding the issue of immigration and led him to put off a pledge to use executive action that could have

shielded millions of people from deportation. One year ago: One after another, President Donald Trump's top lieutenants stepped forward to deny being the author of a New York Times opinion piece that purportedly came from a member of an administration "resistance" move-

Brewer entrenched as Baylor QB; UTSA's Harris just started

WACO, Texas — Charlie Brewer is finally entrenched as Baylor's quarterback, now in his third season starting games. Frank Harris, also a touted dual-threat recruit as a Texas high school senior three years ago, is just getting started at UTSA.

Brewer is set for his 18th start in 19 games with the Bears, and his 23rd game overall, when they host UTSA on Saturday. Harris will start and play in only his second game for the Roadrunners.

"We had very, very high expectations from the moment we got here for Frank Harris, and it took a while to get here," said Roadrunners coach Frank Wilson, who after taking the job in January 2016 almost immediately began recruiting Harris, then a high school junior less than 30 miles from the UTSA campus.

Harris was verbally committed to the Roadrunners before a torn ACL in his left knee midway through his senior season. He redshirted at UTSA in 2017, then sustained an ACL injury in his other knee before the 2018 season.

More than 1,000 days after playing his last game, Harris made his UTSA debut last Saturday in a 35-7 season-opening win over Incarnate Word. He set a school record for a debut by completing his first 13 passes, and finished 28 of 36 for 206 yards with three touchdowns. His 123 yards rushing broke the school record for a quarterback.

"I wouldn't say that we were surprised because we've had good defenses over the years, and whether it was in a spring or a fall camp, he's flashed that against our very talented defenses," Wilson said. "So to see him do it against someone else was confirmation of something that we thought it would

As a returning starter for the Bears last season. Brewer early on shared snaps with a graduate transfer. He threw for 3,019 yards, finishing last vear and going into his junior season as their clear No. 1 quarterback. In a 56-17 season-opening win over Stephen F.

Austin, Brewer was 21-of-31 passing for 199 yards and three touchdowns in just more than a half. Coach Matt Rhule said Brewer checked the Bears into the right plays on each of those TD passes. "I think his ability now to really play like a pro,

see what's happening and get us in the right play versus those pressures, to me, is the big difference," Rhule said.

LONE POWER WIN

UTSA, a program only in its ninth season, is 1-12 against Power Five conference teams. That lone win was 17-10 at Baylor two years ago. The Bears won 37-20 last year in the Alamodome.

WAYS TO IMPROVE

While Baylor had a lopsided victory in its opener,

Rhule pointed out that the defense gave up four big plays and Bears quarterbacks got hit too often even without getting sacked.

"I always tell our team, you didn't play well, you didn't play bad, you played how you played," Rhule said. "I do believe our biggest improvement though is always Week 1 to Week 2."

BLOCK THAT KICK

After blocking seven kicks last season, their most since 1989, the Bears blocked a punt and a field goal attempt in their opener against Stephen F. Austin. No other team nationally blocked two kicks last

"It really comes down to players. If you ever notice our field goal block team, when they rush, they never look to see if the ball was made or not," Rhule said. "It doesn't matter if it went through or not. All that matters is our effort. Anytime you start to have success in something, it starts to take hold and take root."

EXTRA POINTS

Sincere McCormick ran 12 times for 74 yards last week against Incarnate Word, when he became the first true freshman to start at tailback for UTSA since the program's very first game on Sept. 3, 2011. ... Baylor WR Denzel Mims has a catch in each of his last 25 games played, and is 49 yards receiving from 2,000 in his career. ... UTSA had 11 different

players catch passes in its opener; Baylor had 10.

Brantley homers in 13th, Astros rally past Mariners 11-9

HOUSTON — When the Houston Astros fell behind by seven runs in the second inning Thursday night, it would have been easy for them to starting looking ahead to their next

But for this team, with its eyes on a World Series championship, that was never even a thought.

"I think that's what makes a team special, a never-give-up attitude and we're always in every game, and we did that tonight," outfielder Michael

Brantley hit a two-run homer in the bottom of the 13th inning to give Houston an 11-9 comeback victory over the Seattle Mariners.

The win improved the Astros to 91-50, the best record in franchise history after 141 games, and 13-1 against the Mariners this year.

Houston rookie Kyle Tucker hit his first major league homer in the sixth and tied the score 9-all in the 12th with an RBI single. Josh Reddick also went deep and Jose Altuve had a tworun triple for the AL West leaders, who were down 7-0 in the second. "We just hung in there, we kept chip-

ping away, we got some big swings and we look up and we tied the game," manager AJ Hinch said. "We kept the game alive and ultimately the big swing at the end with Mike. A lot happened in that game and obviously it started out terribly for us but finished in dramatic fashion."

Kyle Seager homered twice, including a tie breaking shot in the 12th, and rookie Aaron Nola had two home runs and five RBIs for Seattle.

"A lot of good things, but unfortunately we couldn't shut the door," manager Scott Servais said. Matt Wisler (3-4) walked Jake

Marisnick leading off the 13th before Brantley launched a drive to rightcenter. Josh James (5-0) struck out five in

two innings for the win. Seager connected off James with

one out in the 12th to put the Mariners up 9-8.

"That's a championship team," Sea-

ger said. "That's why they are where they are and that's what they've done. They have a very good lineup and they grind. We were able to get a lead, but they keep battling, they chip and chip and chip, and there's not much of a letdown top to bottom there." Yuli Gurriel walked with one out

in the bottom of the 12th and was replaced by speedy pinch-runner Myles Straw. He advanced to second on a groundout before scoring on Tucker's single to tie it again.

James then struck out the side in the 13th.

The Mariners opened a 7-0 lead thanks largely to the worst start of the season by Wade Miley.

"They came in with a good game plan and they executed it and put us behind the 8-ball pretty early," Miley said. "They just had me today." But the Astros chipped away by

scoring one in the second, two in the third and two in the sixth. They trailed 8-5 in the eighth before Altuve hit a two-run triple off Sam Tuivailala. Brantley's sacrifice fly scored Altuve to tie it.

Dan Altavilla struck out the side in the ninth to send it to the 10th.

Neither team got a hit in the 10th or 11th before Seager's home run.

Nola hit a two-run double and Seager homered in a five-run first for Seattle. Miley gave up five hits and five runs without getting an out in the shortest start of his career.

Nola's first home run of the night came in the second to put Seattle up 7-0, and he added a solo shot in the seventh to make it 8-5.

Seattle starter Marco Gonzales yielded seven hits and five runs four earned — in 5 1/3 innings.

Tucker, the fifth overall pick in the 2015 draft, hit his first career homer to cut the lead to three in the sixth. There was one out in the inning when Reddick chased Gonzales with a homer to right field to make it 7-5.

The Astros trimmed the deficit to 7-1 in the second when Yordan Alvarez scored on a wild pitch by Gonzales. The pitcher dashed from the mound to cover home plate and the throw was just short, allowing Alvarez to slide in safely.

"We have a lot of guys out there," J.J. Watt said. "Obviously it's tough to lose a player like that, but we have a lot of guys out there than can step up can make plays."

The Texans also acquired left tackle Laremy Tunsil and former Saints receiver Kenny Stills in a trade with Miami last weekend.

THIN INTERIOR

The Saints open the season without two of their top interior defensive linemen, Sheldon Rankins and David Onyemata. Rankins, who had eight sacks last season, is back at practice after recovering from an Achilles tear last January, but does not appear ready to play yet. Onyemata, who had $4\frac{1}{2}$ sacks last season and helped the Saints rank second in the NFL against the run, is suspended one game because of a misdemeanor citation for marijuana possession. That leaves the Saints relying primarily on a three-man rotation of veteran free agent Malcom Brown, who was with New England last season, along with second-year pro Taylor

Stallworth and rookie Shy Tuttle.

BREES FAN CLUB

Count Houston quarterback Deshaun Watson among the admirers of the 40-year-old, record-setting Brees, who is entering his 19th season.

"That's crazy," Watson said. "I've only been alive for 23 years, so it's amazing to see what he's done. And actually this summer I was looking at his stats and seeing the amount of years he's had 5,000 yards, 5,000 yards, 5,000 yards, 4,000 yards and just constantly doing it."

Watson, who is entering his third year, said any young quarterback should look up to Brees. And as he was reviewing Brees' biographical information, he was stunned to learn of one award the 12-time Pro Bowler has never won.

"He's never had an MVP, which is very mindblowing," Watson said.

Brees is the NFL career leader in yards passing (74,437) and completions (6,586). He needs 20 TD passes to surpass Peyton Manning's record of 539.

This season, he'll have a new receiving target in tight end Jared Cook, coming off a career-best season in Oakland.

The Saints' Ryan Ramczyk, a rising star at right tackle, is likely to see a lot of watt, whose 16 sacks led the AFC last season.

Brees is counting on Ramczyk to hold up, but empathizes with his task.

"There's a few guys in the league that you sit there and say, 'All right, that's a tough matchup, 1-on-1, for anybody. I don't care who you are," Brees said of Watt. "He's just an extremely talented player because of his size, his speed, his strength, his explosiveness, his awareness, his smarts, his energy, his motor. He is really like a one-of-a-kind player."

SLOW STARTS The Saints have lost their past five season openers, but managed to make the playoffs the past two seasons. Houston, meanwhile, overcame an 0-3

start in 2018. Not that both teams wouldn't rather start fast.

"There is always a sense of urgency," Brees said. "You are not going to sit here and say, like, 'Are you preparing that much harder for Week 2 if you lose

"Whether you won or lost, it's, 'We got to get better," Brees continued. "It's a race to get better, especially early in the season."
