ensure the safety of the staff and those utilizing the YMCA. Since the onset of the pandemic, following the guidance handed down by the Governor, the YMCA has been focusing heavily on an increased and heightened cleaning process.

Birdwell. The T&P Home was located close to the tracks on what is presently Auto Zone. It was built for the railroad employees by T&P however, they welcomed traveler's business as well. Can did not waste time or take the chance that potential customers would go to the T&P Hotel or perhaps the Cole. He would greet the incoming trains and try to persuade the customer to stay at the T&P Home. This was not an easy task considering the Birdwell Hotel was the first place that greeted the deboarding passengers. Cam offered a rate of \$1 per night as compared to the \$2 per night at the Birdwell Hotel.

In 1918, Can admitted to exaggerating his age "downward in numbers" and enlisted in World War I along with his sons. Can said, "A man does not reach his prime until the age of 68. By that time, he has learned what friends to trust and what friends to shun; what ideals to uphold and what flimsy traditions to shatter."

Can's wife Eva died in 1935, he lived another five years, dying in the house that he had built and loved at the age of 93.

The house was later sold to the Walter Grice family. Walter served Howard County as J.P for over 40 years. The house on 2nd street was a wedding venue for hundreds of brides and grooms during the 40's all the way thru the 80's.

A house that held more happy memories than sad, a house that withstood storms, high winds, flooding, wars, a depression, booming economy to a sluggish economy. The house was built during Teddy Roosevelt's administration and lasted through 20 Presidents of the United States.

Weather

last day for the waterslides will be the weekend of August 8.

"We are ready to welcome the youth back to the YMCA for the summer in several capacities. We have the waterslides open and we are about to kick off our summer sports camp and swim lessons," Jones said.

According to Jones, while the YMCA will be closed the Fourth of July weekend, upon reopening the Sports Camp – a three week camp – will open with 15 slots. During the sports camp, attendees will be able to learn the fundamentals of all sports, from basketball, volleyball, softball, baseball and football.

"We are continuing to do our part to social distance which is why we are keeping registration small and we are breaking the groups up into five kids with two counselors," he said.

As we begin to offer our summer activities Jones said he encourages the community to come out and enjoy all that the YMCA has to offer, but use caution. If you are showing symptoms or running a fever Jones is asking patrons to stay home until symptoms have cleared before returning to the YMCA facilities.

Swim lessons for youth between 5 and 12 years of age, with beginner to advance levels able to be registered for. "Each session will be a week long and will serve as an opportunty to im-

prove and enhance their skills," he said. "We are looking forward to seeing our members and we continue to encourage the community to do their part to slow the spread and stay safe." For those wanting to utilize the waterslides, the entrance and exit will be

located on the outside of the YMCA in order to help control traffic in that area. Membership to the YMCA includes the usage of the waterslides and for nonmembers the charge is \$5 per day.

Department of Public Safety (DPS) executed arrest warrants for two suspects: Darius Deshawn Berkley, 22, of Austin, Texas, who was arrested for rioting on the Texas State Capitol grounds; and Gerald Govan Brown, 18, of Pflugerville, Texas, who was arrested in connection with the vandalism of the Texas State Capitol and the assault of a Texas State

DPS Special Agents obtained an arrest warrant for rioting on Berkley, following an incident that

tol. DPS Special Agents discovered Berkley was incarcerated in the Travis County Jail on unrelated charges. The aforementioned warrant was served on Berkley at the Travis County Jail.

Brown was also arrested on Saturday, June 27, in connection with incidents that occurred during the protests at the Texas State Capitol on May 30. Multiple arrest warrants were obtained for Brown, including felony criminal mischief-destruction of public monument, as well as misdemeanor crimiofficer, resisting arrest, interference with public duties and participating in a riot.

Both arrests come as the result of ongoing investigations by DPS Special Agents who reviewed hundreds of hours of videos from various media platforms, surveillance camera footage, law enforcement databases and open source information over the last several weeks, and the investigation

# Confederate flag losing prominence 155 years after Civil War

BIRMINGHAM, Ala. (AP) — Long a symbol of pride to some and hatred to others, the Confederate battle flag is losing its place of official prominence 155 years after rebellious Southern states lost a war to perpetuate slav-

Mississippi's Republican-controlled Legislature voted Sunday to remove the Civil War emblem from the state flag, a move that was both years in the making and notable for its swiftness amid a national debate over racial inequality following the police killing of George Floyd in Minnesota. Mississippi's was the last state flag to include the design.

NASCAR, born in the South and still popular in the region, banned the rebel banner from races earlier this month, and some Southern localities have removed memorials and statues dedicated to the Confederate cause. A similar round of Confederate flag and memorial removals was prompted five years ago by the slaving of nine Black people at a church in Charleston, South Carolina. A white supremacist was convicted of the shooting.

Make no mistake: The Confederate flag isn't anywhere close to being gone from the South. Just drive along highways where Sons of Confederate Veterans members have erected gigantic battle flags or stop by Dixie General Store, where Bob Castello makes a living selling hundreds of

rebel-themed shirts, hats, car accessories and more in an east Alabama county named for a Confederate officer, Gen. Patrick Cleburne.

"Business is very good right now," Castello said Monday.

But even Castello is surprised by how demonstrations over police brutality became a wave that seems to be washing over generations of adoration for the Confederate battle flag by some. He wonders what might hap-

"This could go on and on," he said. "There's just no limit to where they could go with it."

The Confederacy was founded in Montgomery in 1861 with a Constitution that prohibited laws "denying or impairing the right of property in negro slaves." The South lost, slavery ended, and Confederate sympathizers almost ever since have argued the war wasn't just about slavery, instead advocating the "lost cause" version centered around state's rights, Southern nobility and honor.

To some, the Confederate battle flag - with its red background, blue X and white stars — is a down-home symbol of Southern heritage and pride. The band Alabama, one of the top-selling country music groups ever, included the banner on five album covers in the 1980s and '90s while at the height of its popularity.

Patty Howard, who was visiting

a huge carving of Confederate Civil War generals at Georgia's Stone Mountain Park with her husband, Toby, on Monday, said they aren't offended by the flag, but they also don't fly it at their home in Hendersonville, North Carolina.

"I don't see it as related to slavery," said Howard, 71. "To us, it just represents being from the South."

But the flag has a dark side. It has been waved for decades by the Ku Klux Klan, neo-Nazis and other white supremacists who oppose equal rights. The banner's use by such groups, combined with a widening sense that it is time to retire the symbol of a defeated nation once and for all, has led to change.

"The argument over the 1894 flag has become as divisive as the flag itself and it's time to end it," Mississippi Gov. Tate Reeves said of the state's current flag, which was adopted by lawmakers at a time when white supremacists were actively squelching political power that African Americans had gained after the Civil War.

Georgia — which added the battle emblem to its state flag in 1956 in response to U.S. Supreme Court decisions to desegregate public schools adopted a flag without a rebel banner

Alabama flew the battle flag atop its state Capitol until 1993, when it was

removed following protests by Black legislators. Additional Confederate flags were removed from around a massive Confederate memorial just outside the building in 2015, when South Carolina also removed its battle flag from the state Capitol grounds after the shooting.

It has taken longer in Mississippi. Not long after the Charleston shooting, House Speaker Philip Gunn became the state's first prominent Republican to say the Confederate symbol on the state flag was morally offensive and must be changed. People posted signs with the slogan, "Keep the Flag. Change the speaker," but Gunn was easily reelected twice.

During the past month, Gunn and Mississippi's first-year lieutenant governor, Republican Delbert Hosemann, persuaded a diverse, bipartisan coalition of legislators that changing the flag was inevitable and they should be part of it.

Hosemann is the great-grandson of a Confederate soldier, Lt. Rhett Miles, who was captured at Vicksburg and requested a pardon after the war ended in 1865.

"After he had fought a war for four years, he admitted his transgressions and asked for full citizenship," Hosemann said during the debate. "If he were here today, he'd be proud of us.'

# Astronaut says losing mirror on spacewalk was 'real bummer'

CAPE CANAVERAL, Fla. (AP) — The commander of the International Space Station said Monday that losing a mirror during last week's otherwise successful spacewalk was "a real bummer."


NASA astronaut Chris Cassidy said he has no idea how the small mirror on his left sleeve came off. The band for the mirror is on pretty tight, he noted, and it may have caught on a metal tether attachment as he exited the airlock "I just happened to glance down and I saw this reflecting thing disappearing

into the darkness, and that was the last I saw of it," Cassidy said in an interview with The Associated Press. "That was a real bummer for me."

Joe Bright purchases local land for new location of J.B. Sports Academy

Joe Bright has played basketball mostly his entire life. After years of playing the sport and advancing all the way to the NCAA Division I level, he has brought all of the skills and lessons he has learned from the game to his new occupation: Trainer at his own Basketball Academy.

Bright has been training the youth around Big Spring for the last couple of years inside any gym that he could. Now, there will be a new home for the Joe Bright Basketball Academy within a mile of the school.

Following months of working with a realtor to find the perfect spot for his growing business, the Big Spring basketball guru has decided to build the first permanent home for his athletic training facility at 1317 E. Sixth Street.

"As soon as I saw it, I just thought to myself, 'Man, this is it," Bright said. With that new location comes a new company name and the Basketball Academy will soon become J.B. Sports Academy.

"With J.B. Sports Academy is just like any academy where you would send your child," Bright said. "Yes, they're going there to work on their craft but at the same time it's going to be dealing with life lessons. I have a business plan in place where we'll be doing things other than just training. We want to be a place where they have an opportunity to get out of school and come here and do their homework. I'm working with some great organizations where we will have some critical thinking skills challenges on Wednesday's and on the weekends we try to do different programs."

The first two students to be trained by Bright were current Big Spring basketball players Kaegen Mitchell and Kyler Seymore. Both of those players still train with Bright and have recruited some of their teammates to do the same as well. Bright serves as an assistant coach on the Steers' varsity team and is always there to give advice whether it is in-game or during practice.

The old Howard Hawk has taught players such as Mitchell and Seymore a lot about the game and continues to challenge them and not let them grow complacent with their game.

"He's a great coach," Seymore said. "One of the things I love about him is that he holds you accountable and he doesn't take anything for granted. He wants you to be there at every practice, he wants you to work you butt off and if you're not giving it your all, then he'll set you straight. He makes it feel like a team. No one is favored and he makes all five guys out on the court really feel like a team."

Bright also knows the nuances of the game and has experience playing every position on the court from his time on the hardwood. This allows him to detail and construct his workouts to fit the particular player that he is training. Those personalized workouts are unique and not something that you would get from every trainer.

Mitchell has recently made the position switch to point guard and that is where he will be starting when the Big Spring basketball season tips-off later this year. Bright knew about the switch and has now been helping Mitchell adapt to his new position running the floor.

"I changed my position so me and him have been working on reading the court better and getting my coordination down," Mitchell said. "He always motivates us and gets us where we need to be."

Since the beginning of the coronavirus pandemic and the subsequent shutdown of mostly every small business, Bright had been forced to stop training his students. This was tough not only on the players, but on Bright as well because of the change in schedule to someone who seems to be very routineoriented and focused on doing the job to the best of his ability.

Bright has been back in the gym training his students since June 18 after being forced to take a hiatus. He has been training and teaching smaller class sizes but says his business has picked up even more after the virus hit.

The new location will welcome in even more new students and will surely catch the attention of any local parents that are thinking about signing their child up for sports. Even though Bright does train high school players, most of his time training is spent on the younger kids who are just getting into the

After playing for Howard College and now being a teacher and coach at Big Spring, Bright's preferred location for his business was inside of Big Spring's city limits.

"That was like my No. 1 thing," Bright said. "I definitely wanted it in Big

Spring. If I couldn't have it in Big Spring, that was fine but at the same time that was basically my No. 1 goal." While the headquarters will be in Big Spring, young athletes from Coahoma

and Forsan routinely travel into Steer Country to be trained by the great Joe

Bright has been a hardworking and determined member of this community for years now and he is asking for some help with raising funds so that he can complete his building as soon as possible.

"I was just hoping that I can get some fundraisers or some donations and possibly even some grants so that I can have some help building the facility," Bright said.

# Six Texas Fisheries Named Top 100 Lakes Of Decade

BIRMINGHAM. Ala. Since 2012. Bassmaster Magazine has released annual rankings of the country's best bass fisheries. While tournament data could not be gathered because of the COVID-19 pandemic, crunching numbers gathered over the past eight years revealed a surprising Best Bass Lake of the Decade — California's Clear Lake.

While Toledo Bend at No. 6 was Texas's highest placing lake, overall the state had six fisheries on the Top 100 list — Toledo Bend, Sam Rayburn, Falcon, Fork, Ray Roberts and Caddo — creating a three-way tie for second place with California and Florida.

"Typically, creating the rankings takes more than two months as we dig through current tournament data as well as state fishery information on stocking efforts, catch rates and angler access," explained Bassmaster Magazine Editor-in-Chief James Hall. "Instead, we used all of this research and rankings from the past eight years to create an incredible — and somewhat surprising — ranking of bucket-list destinations for anglers.'

While long-considered a West Coast powerhouse, Clear Lake has never topped the Best Bass Lakes list until this year. However, in the past decade, California's largest natural lake has also never ranked below 10th in the country and has been the top-ranked Western fishery for the past three years. Anglers can expect to consistently catch big bass in a fishery where an average bass weighs in at over 5 pounds. In fact, a bass over 16 pounds was landed at Clear Lake last year. Combine that production with a pristine setting in California's wine country, and you have the definition of a bucket-

list fishing destination. Alabama's Lake Guntersville, home of the 2020 Academy Sports + Outdoors Bassmaster Classic presented by Huk, took the No. 2 spot, matching its 2019 rank. Like Clear Lake, the Big G has never been named the Best Bass Lake in the nation, but it is rarely out of contention. Guntersville is known for its breathtaking scenery and easy access, but big fish swim there as well. Most big-bass prizes

are awarded to fish topping the 8-pound mark, with 10-plus-pounders taking center stage on occasion.

True giants call our third-place fishery, Lake Erie, home. While most of the tournament data comes out of Buffalo, N.Y., anglers can expect smallies in the 6-pound range anywhere along the shoreline, which includes New York, Ohio, Pennsylvania and Michigan. Michigan's Lake St. Clair, where you can catch the smallmouth of a lifetime surrounded by Instagram-worthy scenery, is in the fourth spot.

Rounding out the remainder of the Top 10 lakes are California's Sacramento/San Joaquin Delta at fifth; Toledo Bend, on the Louisiana/Texas border, at sixth; Sam Rayburn Reservoir at seventh: Falcon Lake at eighth; Idaho's Lake Coeur d'Alene at ninth; and Florida's Lake Okeechobee at tenth.

The rankings identify the Top 25 lakes in the nation based on head-to-head comparisons, as well as the top lakes in four geographical regions — Central, Western, Southeastern and Northeastern.

"We divide the nation into four regions and rank the lakes in each region to give anglers perspective on the fisheries they can most likely reach," Hall explained.

As for bragging rights on which state has the most fisheries in the all-decade rankings, that title goes to Michigan with seven lakes.

In many hands, declarer is faced with a choice of several possible lines of play. In such cases, he should select the approach that offers the greatest chance of success, even if that chance is not a very good one.

Take this case where West found the most effective lead against six hearts, a trump. Without this lead, South could have gotten home safely by cashing the ace of diamonds and leading the queen through West.

However, the opening trump lead completely altered the situation. Now the ruffing finesse in diamonds would

do declarer no good: After West covered the queen with the king and dummy ruffed with its last trump, South would still be left with a diamond loser as well as a spade loser. Declarer therefore considered his

remaining options. One possibility was to win the opening trick in dummy and lead a diamond to the queen. If the finesse succeeded, he could next cash the ace of diamonds and ruff a diamond in dummy, hoping that the king would fall on either the second or third round.

The only viable alternative to this was to try to establish dummy's clubs by cashing the A-K, playing the ace of diamonds, ruffing a diamond and ruffing a club. If the opposing clubs broke 3-3, South would later discard a spade and a diamond on dummy's good clubs to make the slam, losing only a diamond to the king.

Controlted with these two options, declarer had to rely on percentages. He knew that a 3-3 club division would occur only 36 times in 100 — certainly not the best of odds. But he also knew that his chance of winning a diamond finesse and then dropping the king doubleton or tripleton with eight diamonds missing was even worse — roughly, a bit more than 10%.

So South elected to play for the 3-3 club break, and, with a welcome assist from Lady Luck, the slam came rolling home.



On July 1, 1863, the pivotal, three-day Civil War Battle of Gettysburg, resulting in a Union victory, began in Pennsylvania. On this date:

In 1867, Canada became a selfgoverning dominion of Great Britain as the British North America Act took effect

In 1912, aviator Harriet Quimby, 37, was killed along with her passenger, William Willard, when they were thrown out of Quimby's monoplane at the Third Annual Boston Aviation

In 1944, delegates from 44 countries began meeting at Bretton Woods, New Hampshire, where they agreed to establish the International Monetary Fund and the World Bank.

In 1946, the United States exploded a 20-kiloton atomic bomb near Bikini Atoll in the In 1961, Diana, the princess of

Wales, was born in Sandringham, England. (She died in a 1997 car crash in Paris at age

In 1963, the U.S. Post Office inaugurated its five-digit ZIP codes.

In 1966, the Medicare federal insurance program went into

effect.

In 1991, President George H.W. Bush nominated federal appeals court judge Clarence Thomas to the Supreme Court, beginning an ultimately successful confirmation process marked by allegations of sexual harassment. In 1997, Hong Kong reverted to Chinese rule after 156 years as a British colony. Actor Robert Mitchum died in Santa Barbara, California, at age 79.

In 2002, the world's first permanent war crimes tribunal, the International Criminal Court, came into existence. A Russian passenger jet collided with a cargo plane over southern Germany, killing all 69 people, including 45 schoolchildren, on the Russian plane and the cargo jet pilots.

In 2004, actor Marlon Brando died in Los Angeles at age 80. In 2009, Academy Award-winning actor Karl Malden, 97, died

in Brentwood, California. Ten years ago: California lawmakers approved a \$20 million settlement with the family of Jaycee Dugard, who was kidnapped as a girl and held captive in a secret backyard for 18 years by a paroled sex offender. At least two suicide bombers attacked a popular Muslim shrine in Pakistan's second largest city, Lahore, killing some three dozen people.

Five years ago: After more than a half-century of hostility, the United States and Cuba declared they would reopen embassies in each other's capitals, marking a historic full restoration of diplomatic relations between the Cold War foes. Episcopalians voted overwhelmingly at their General Convention in Salt Lake City to allow religious weddings for same-sex couples. San Francisco resident Kate Steinle, 32, was fatally shot in the back while walking along the city's popular waterfront. (Juan Francisco Lopez-Sanchez, a Mexican national who was in the U.S. illegally, acknowledged holding the gun that killed Steinle but said it fired accidentally after he found it. He was found not guilty of killing Steinle; a state appeals court threw out his conviction on a gun charge.)

One year ago: Fifteen-year-old Coco Gauff, the youngest player to qualify at Wimbeldon in the professional era, defeated 39-year-old Venus Williams in the first round, 6-4, 6-4. Los Angeles Angels pitcher Tyler Skaggs, 27, was found dead in his room at the Texas hotel where the team was staying; the medical examiner found that Skaggs had a toxic mix of alcohol and the painkillers fentanyl and oxycodone in his body. Hundreds of protesters swarmed into Hong Kong's legislature, defacing portraits of lawmakers and spray-painting pro-democracy slogans in the chamber before vacating it as riot police cleared surrounding streets with tear gas; the threehour occupation came on the 22nd anniversary of the former British colony's return to China. # Baseball's minor leagues cancel 2020 seasons

NEW YORK (AP) — Baseball's minor leagues canceled their seasons Tuesday because of the coronavirus pandemic, and the head of their governing body said more than half of the 160 teams were in danger of failing without government assistance or private equity injections.

The National Association of Professional Baseball Leagues, the minor league governing body founded in September 1901, made the long-expected announcement. The minors had never missed a season.

"We are a fans-in-the-stands business. We don't have national TV revenues," National Association president Pat O'Conner said during a digital news conference. "There was a conversation at one point: Well, can we play without fans? And that was one of the shortest conversations in the last six months. It just doesn't make any sense."

O'Conner estimated 85-90% of revenue was related to ticket money, concessions, parking and ballpark advertising. The minors drew 41.5 million fans last year for 176 teams in 15 leagues, averaging 4,044 fans per game.

MLB teams are planning for a 60-game regular season and most of their rev-

"I had a conversation with the commissioner, and we weren't unable to find a path that allowed us to play games," O'Conner said. "It wasn't an acrimonious

decision on our part." O'Conner said many minor league teams had received money through the

federal Paycheck Protection Program Flexibility Act.

"That was a Band-Aid on a hemorrhaging industry," he said. "Many of our clubs have gone through one, two, maybe three rounds of furloughs. In our office here, we've had varying levels of pay cuts between senior management, staff, and we've furloughed some individuals, as well, and are just about to

enter in a second round of furloughs."

He hopes for passage of H.R. 7023, which would provide \$1 billion in 15-year federal loans from the Federal Reserve to businesses that had 2019 revenue of \$35 million or less and "have contractual obligations for making lease, rent, or bond payments for publicly owned sports facilities, museums, and com-

In addition, the Professional Baseball Agreement between the majors and minors expires Sept.. 30, and MLB has proposed reducing the minimum affiliates from 160 to 120.

"There's no question that what the pandemic has done is made us somewhat weaker economically," O'Conner said. "I don't think it's challenged our resolve. I don't think it's impacted our desire to stick together and get a good deal.'

There have not been substantive talks for about six weeks.

"There are very many teams that are not liquid, not solvent, not able to proceed under normal circumstances, and these are anything but normal circumstances given the PBA and the uncertainty of the future for some of these ball clubs," O'Conner said. "So I think the coronavirus has really cut into many clubs' ability to make it. And I think that we're looking at without some government intervention, without doing something to take on equity partners, you might be looking at half of the 160 who are going to have serious problems."

MLB already has told clubs to retain expanded 60-player pools, of which 30 players can be active during the first two weeks of the season starting in late July.

Conner said the financial impact of the pathogen might extend until 2023.

"As serious as the threat from Major League Baseball was," O'Conner said "this threat from the coronavirus, it transcends any list that anybody wants to make with respect to the possibility of teams not being around in the future."

# Teams not able to disclose who goes on IL due to virus

day that a team will not specifically announce a COVID-19 injured list placement for a player who is removed from the club after testing positive, just an IL trip. MLB's operations manual says a

positive test, exhibiting symptoms that require isolation for additional assessment or exposure to someone who has had the virus are cause for placement on the new COVID-19 IL.

"It would be a speculating circumstance," Yankees general manager Brian Cashman told media during a conference call.

Baseball's collective bargaining agreement states that for any medical condition not related to employment "a club may disclose only the fact that a medical condition is preventing the player from rendering services to the club and the anticipated length of the player's absence from the club."

Cashman noted the situation continues to evolve as MLB and the players' union continue discussions. Testing of players and staff will begin Wednesday as they report to their teams to resume workouts. They will be tested once every two days.

Last week, Charlie Blackmon of the Colorado Rockies became the first MLB player known to have tested positive. According to reports, the All-Star outfielder was one of three Colorado players to have a positive

Numerous other teams have said they have players who have tested positive for the virus without identifying any of them. The Philadelphia Phillies announced seven, while the Detroit Tigers said one player who was living in Florida but not working out at the team's spring training facilities in Lakeland also tested positive.

Seattle Mariners general manager Jerry Dipoto said a few players have tested positive but declined to specify how many. Several Toronto Blue Jays players and staff members also have tested positive.

# Ertz, Short say soul-searching led to vulnerability on field

Chicago Red Stars teammates Julie Ertz and Casey Short say hard conversations over the past several weeks led to their vulnerability in the moment they shared an emotional embrace while they knelt during the national anthem as the NWSL opened its season.

Short sobbed as she was held by Ertz before Chicago's match against the Washington Spirit on Saturday night, the second game of the National Women's Soccer League tournament in Utah.

"Currently, every time the national anthem is played, our country continues to become more and more divided on what the visual symbol of unity looks like," Short and Ertz said in a joint statement they released Tuesday. "Through our continuous conversations we wanted to make sure that whatever we decided to do, it would not be an empty gesture. It would be a gesture that portrayed that we have heard those who needed to be heard, validated

"That moment during the anthem was difficult, very difficult. We are still searching but we are humbled by the outpouring of support."

Short was not made available for comment after the match, so the context of the moment wasn't known. Teammate Rachel Hill, who stood during the anthem and put a hand on Short's shoulder, also was not made available for comment following

"The two of us have always set out to be our honest and true selves, but have struggled to find the "right" thing to do in order to show our truth. We understand people are entitled to their opinions. Often these opinions are presented through the individual's lens and do not accurately portray how the two of us truly feel," Short and Ertz said.

Hill posted a statement to Instagram on Tuesday night, saying the decision did not come easily.

"Before the game, I was completely torn on what to do. I spoke with friends, family and teammates — of all races, religions and backgrounds — with

the hope of guidance," Hill wrote. "I chose to stand is a league that was built on diversity and courage because of what the flag inherently means to my and those principles will continue to drive us formilitary family members and me, but I 100 percent support my peers. Symbolically, I tried to show this with the placement of my hand on Casey's shoulder and bowing my head. I struggled, but felt that these actions showed my truth, and in the end I wanted to remain true to myself."

Players for the Portland Thorns and the North Carolina Courage collectively knelt during the national anthem Saturday as they opened the Challenge Cup tournament. A few players, including Hill, chose to stand as the anthem was played before the late game between the Red Stars and Spirit.

While it is customary that only starters are on the field during the anthem, the entire squads for the four teams that played Tuesday took the field before their games. Most, but not all, knelt.

Players and coaches have also worn Black Lives Matter T-shirts in warmups before games, and players have also knelt during a moment of silence before kickoffs. The NWSL players association released a state-

ment in support of all players, no matter their deci-"The Players Association supports both making

a clear statement that Black Lives Matter and each player making a personal decision around whether to stand or kneel during the national anthem," the union said. "We ask that our supporters and media respect each player's right to handle these moments in the way that they choose and know that our players are united against racism and in support of one another."

After some players were criticized, the league announced Monday that it would allow players to remain in the locker room during the anthem.

"The NWSL stands behind every player, official and staff member. Kneel on the field. Stand with your hand over your heart. Honor your feelings in the privacy of the locker room or at midfield," NWSL Commissioner Lisa Baird said in a statement announcing the policy change. "The NWSL

The NWSL is the first professional team sports league in the United States to return amid the coronavirus pandemic. The teams had gathered for training camps in March when the league was shut

The tournament opener between the Thorns and the Courage was broadcast nationally on CBS and the network announced Tuesday that the game averaged 572,000 viewers, a record for the NWSL.
