Community Covid-19 testing sites open; vaccinces dispersed to frontline workers

Scenic Mountain Medical Center reported the following update pertaining to testing completed to date. There have been 2,666 tests for Covid-19, with five pending. Of those tests there have been 707 returned positive for an overall positivity rate of 26.5%.

From Dec. 1 through Jan. 5, SMMC and SMMG has conducted 730 Covid-19 tests with five pending and 197 posi-

tives returned for a positivity rate of 27%. There are currently 17 Covid-19 patients in Scenic Mountain Medical Center with three in ICU and two vents.





Protestors rush Capitol Hill as House and Senate prepare to vote

Members of the House and Senate were convening to hear debate before the Electoral College went to a vote to accept and certify the Presidential Election results Wednesday afternoon. While hearing debate, around 1:20 p.m.(CST) protestors breached the building sending the House and Senate into recess and placing the building on lock down. Video footage from Capitol Hill

showed protestors climbing up the walls to try and gain access to the building while flooding steps outside. Protestors were also shown climbing through windows to gain access into official office. Photos were released of protestors inside the Capital offices, inside the dome, and even attempting to gain access onto the House floor. Upon hearing of the breach, Capital Hill security began moving lawmakers to a secure location. All members of the Senate were able to be moved before protestors gained access. According to video footage there were some House members still locked on the House floor while protestors were outside the cham-

A few hours after the protesgained access, National Guard troops were requested by the Mayor of Washington DC; a 6 p.m. curfew was also put in place to help de-escalate the situation.

President Elect Joe Biden took the podium to address the nation around 3 p.m. Thursday as the overtaking of the Capitol took

" (This is) An assault on people's representatives, on Capitol Hill, police sworn to protect them public servants who work at the heart of our Republic, on the rule of law. This is one of the few times we've seen it... let me be very clear the scenes of chaos do not reflect the true American do not represent who we are," President Elect Joe Biden said during his address to the people. "We are seeing a small number of extremist; this is disorder, chaos ... it must end. I call on this mob to pull back and let the work of democracy go forward."

He continued, "The words of a president matter no matter how good or bad the president is at their best they can inspire, and at their worst they can incite."

President Elect Joe Biden called for President Trump to call for an end to this scene on national tele-

The protestors began to enter the Capital building around 1 p.m. as House and Senate members were debating before taking to the Electoral College vote on Presidential Vote totals.

The scene is still unfolding. There have been reports of tear gas, gun shots and other forceful actions taken inside the Capitol building. At the beginning of the chaos, House and Senate members along with members of the press who were inside the building, were moved to secure loca-

Protestors are still being shown surrounding the building as of

Shortly after President Elect Biden's address, President Trump Tweeted out a video encouraging those who are taking part in the protests at the Capital to go home. The video was short and Tweeted out by the White House.

With the additional National Guard support and heavy law enforcement and first responder presence around the area, the Capitol was able to be cleared and secured as time ticked down to the 6 p.m. curfew enacted earlier in the day. Amidst the chaos, it was reported that one female succumbed to injuries from a gunshot wound she sustained inside the Capitol.

The U.S. Senate reconvened at 7 p.m. CST to continue debate and proceed to the electoral college vote count.

Prior to the attack on Capitol Hill on Wednesday, the Georgia votes were also tallied with a final vote count being issued.

According to the Associated Press, the 2020 Georgia runoff election has named winners for the two open seats: Jon Ossoff claimed victory over David Perdue with a 50.3% total and 2,229,482. Ossoff's victory placed another Democractic seat on the Senate. Raphael Warnock, also Democrat, claimed victory with 50.7% of the vote over Kelly Loeffler. Warnock ended with 2,245,870 votes.

With the announcement of the Election totals, Democratic control of the Senate was gained.

Vaccines have arrived in Howard County and have started to be distributed to frontline healthcare workers. While the vaccine is not yet available to the community, but are expected to be made available soon in accordance with Texas Phase 1B

Reaction from leaders pours in after mob breaks into Capitol

AP-US--Congress-Electoral College

A mob of violent protesters made its way into the U.S. Capitol on Wednesday, forcing police to evacuate lawmakers and delaying the constitutional process to affirm Joe Biden's victory in the November election. Some of the reaction from around the United States and the world:

British Prime Minister Boris Johnson: "Disgraceful scenes in U.S. Congress. The United States stands for democracy around the world and it is now vital that there should be a peaceful and orderly transfer of power."

Canadian Foreign Minister François-Philippe Champagne: "Canada is deeply shocked by the situation in Washington, D.C. The peaceful transition of power is fundamental to democracy — it must continue and it will. We are following developments closely and our thoughts are with the American people."

Vice President-elect Joe Biden: "To storm the Capitol, to smash windows, to occupy offices, and to threaten the safety of duly elected officials is not protest. It is insurrection. The world is watching and like so many other Americans, I am shocked and saddened that our nation, so long a beacon of light, hope and democracy, has come to such a dark moment."

National security adviser Robert O'Brien: "Violence has absolutely no place in our democracy. I applaud the men and women of law enforcement and the National Guard, who are working to restore order and protect our institutions. Our country is better than what we saw today at our Capitol."

Sen. Ben Sasse, Republican from Nebraska: "Today, the United States Capitol — the world's greatest symbol of self-government — was ransacked while the leader of the free world cowered behind his keyboard — tweeting against his Vice President for fulfilling the duties of his oath to the Constitution. Lies have consequences. This violence was the inevitable and ugly outcome of the President's addiction to constantly stoking division."

Former President George W. Bush: "Laura and I are watching the scenes of mayhem unfolding at the seat of our Nation's government in disbelief and dismay. It is a sickening and heartbreaking sight.

This is how election results are disputed in a banana republic – not our democratic republic. I am appalled by the reckless behavior of some political leaders since the election and by the lack of respect shown today for our institutions, our traditions, and our law enforcement. The violent assault on the Capitol – and disruption of a Constitutionallymandated meeting of Congress – was undertaken by people whose passions have been inflamed by falsehoods and false hopes."

National Association of Manufacturers President and CEO Jay Timmons: "The outgoing president incited violence in an attempt to retain power, and any elected leader defending him is violating their oath to the Constitution and rejecting democracy in favor of anarchy. Anyone indulging conspiracy theories to raise campaign dollars is complicit. Vice President Pence, who was evacuated from the Capitol, should seriously consider working with the Cabinet to invoke the 25th Amendment to preserve democracy."

Democratic Gov. Andrew Cuomo of New York: "This is the final chapter of an incompetent, cruel, and divisive administration that has trampled on the Constitution and the rule of law at every turn, and we won't let President Trump, the members of Congress who enable him, or the lawless mob that stormed our nation's Capitol steal our democracy. The election results are clear and the will of the American people will be carried out."

Thomas Donohue, CEO of the U.S. Chamber of Commerce: "The attacks against our nation's Capitol Building and our democracy must end now. The Congress of the United States must gather again this evening to conclude their Constitutional responsibility to accept the report of the Electoral College."

AFL-CIO President Richard Trumka: "We are witnessing one of the greatest assaults on our democracy since the Civil War. Today's attempted coup has been years in the making as Donald Trump consistently spews venom, conspiracies, hate and lies to his supporters. They are carrying out his wishes, and far too many Republican lawmakers have enabled and even encouraged this violent threat to our republic."

NATO Secretary General Jens Stoltenberg "Shocking scenes in Washington, D.C. The outcome of this democratic election must be respect-

Rep. Liz Cheney, Republican from Wyoming: "We just had a violent mob assault the Capitol in an attempt to prevent those from carrying out our Constitutional duty. There is no question that the President formed the mob, the President incited the mob, the President addressed the mob. He lit the flame."

Former President Barack Obama: "History will rightly remember today's violence at the Capitol, incited by a sitting president who has continued to baselessly lie about the outcome of a lawful election, as a moment of great dishonor and shame for our nation. But we'd be kidding ourselves if we treated it as a total surprise. For two months now, a political party and its accompanying media ecosystem has too often been unwilling to tell their followers the truth — that this was not a particularly close election and that President-Elect Biden will be inaugurated on January 20. Their fantasy narrative has spiraled further and further from reality, and it builds upon years of sown resentments. Now we're seeing the consequences, whipped up into a violent crescendo."

Former President Bill Clinton: "Today we faced an unprecedented assault on our Capitol, our Constitution, and our country. The assault was fueled by more than four years of poison politics spread ing deliberate misinformation, sowing distrust in our system, and pitting Americans against one another. The match was lit by Donald Trump and his most ardent enablers, including many in Congress, to overturn the results of an election he lost. The election was free, the count was fair, the result is final. We must complete the peaceful transfer of power our Constitution mandates."

President Donald Trump: "These are the things and events that happen when a sacred landslide election victory is so unceremoniously & viciously stripped away from great patriots who have been badly & unfairly treated for so long. Go home with love & in peace.

Remember this day forever!"

Southeast Texas congressman tests positive for COVID-19

The Southeast Texas congressman and ranking Republican Ways and Means Committee member revealed his test results in a tweet late Tuesday, followed by a prepared statement Wednesday. The disclosure came as a record number of Texas COVID-19 deaths were reported Wednesday.

Brady had been practicing all guidelines laid out by the Centers for Disease Control and Prevention and the House physician, including social distancing and mask-wearing, according to the statement. Brady had been tested when he began experiencing COVID-19 symptoms and began

Pfizer COVID-19 vaccine on Dec. 18 and was to have received his second dose later this week, according to the statement. It was not immediately known where Brady was recovering or whether he was quarantined.

According to the Food and Drug Administration, "the effectiveness of the vaccine after a single dose is inconclusive. He has full confidence in the safety and effectiveness of the vaccine and is incredibly proud of the historic success of Operation Warp Speed," according to the statement.

The Conroe Republican had been the House Ways and Means Committee chairman until Democrats won a House majority in 2018.

A record 326 COVID-19 deaths were reported Wednesday, shattering the previous record of 278 deaths reported on July 23, according to statistics compiled by the Texas Department of State Health Services. That brought the Texas death toll for the eightmonth-old outbreak to 28,545.

The state reported 19,535 new confirmed coronavirus cases and 4,026 probable cases on Wednesday, bringing to almost 1.9 million the number of confirmed and probable cases in Texas. Of those, 320,540 cases were active on Wednesday, a record 13,628 were hospitalized, the 10th consecutive record day.

Austin-area officials announced Wednesday that they were discussing

plans to turn the Austin Convention Center into a field hospital as hospitals continue to fill close to their capacities because of the soaring number of COVID-19 cases.

Dr. Mark Escott, the interim Austin-Travis County health director, said local hospitals' intensive-care units were projected to be filled to capacity by Jan. 15. However, the convention center could be pressed into service as a field hospital sooner as a surge of cases from the Christmas and New Year's holidays was expected to intensify, he said.

The convention center was pressed into service as a hospital previously during the July COVID-19 surge for up to 1,500 coronavirus patients.

In an unprecedented step, Twitter suspended the account of President Donald Trump from tweeting for 12 hours Wednesday following the storming of the U.S. Capitol by his supporters.

Twitter said that future violations by Trump could result in a permanent suspension. The company required the removal of three of Trump's tweets, including a short video in which he urged those supporters to "go home" while also repeating falsehoods about the integrity of the presidential election. Trump's account deleted those posts; had they remained, Twitter had threatened to extend his suspension.

Earlier in the day, Twitter, Facebook and YouTube all removed the video, but only Twitter placed additional limits on the president.

While some cheered Twitter's actions, experts noted that the companies' actions follow years of hemming and hawing on Trump and his supporters spreading dangerous misinformation and encouraging violence that have contributed to Wednesday's violence.

Jennifer Grygiel, a Syracuse University communications professor and an expert on social media, said Wednesday's events in Washington, D.C. are a direct result of Trump's use of social media to spread propaganda and disinformation, and that the platforms should bear some responsibility for their

"This is what happens," said Grygiel, who uses they/them pronouns. "We didn't just see a breach at the Capitol. Social media platforms have been

attempt in the United States."

Grygiel said the platform's decision to remove the video — and Twitter's sus-

pension — are too little, too late. "They're creeping along towards firmer action," they said, calling Trump "Exhibit A" for the need for greater regulation of social media. "Social media is complicit in this because he has repeatedly used social media to incite violence. It's a culmination of years of propaganda and abuse of media by the president of the United States.'



Full Howard basketball preview for upcoming season set to begin this month

The Howard Hawks have been known as one of the most competitive and prestigious junior college basketball teams in the country for years. They reached the pinnacle in 2010 when they put together a recordsetting season and won the National Championship under then Head Coach Mark Adams, who now serves as an assistant coach at Division I national powerhouse Texas Tech.

Current NBA player Jae Crowder once suited up for the red and black under Adams and the long list of Division I commits from Howard has continued under current Head Coach Scott Raines. Eric Reed Jr., from last year's team, is now suiting up, playing solid minutes, and putting up solid scoring numbers for Southeast Missouri State. In fact, almost every player from last year's 22-9 squad committed to and moved on to play at a four-year university this past

That means that now the Howard Hawks will have almost a completely different team than the one that hit the hardwood last winter. They will be versatile this season with good size and shooting ability.

Both Raines and assistant coach Junsie Cotten have been working hard this offseason to put a strong team together so that they can compete in the extremely strong and daunting Region V.

With all of that being said, let us take a look at who will be playing for the Hawks this season and what they bring to the court:

AKENE AGEE - Brampton, Ontario

Agee is an athletic 6-foot-4 guard who played his college ball last year at Cloud County Community College in Concordia, Kansas. He started just one game but played in 27 while averaging 4.7 points per game and 2.0 rebounds per game. He scored a season-high 21 points against Cowley and totaled four games of double-digit points scored for the T-Birds. Agee will be a sophomore this season and will be battling with a strong group of guards for solid playing time in the rotation.

JACOBY BISHOP - New Waverly, TX

Bishop will be a true freshman fresh off of an 18 point-per-game season while at Coldspring-Oakhurst High School. He is a 6-foot-0 combo guard that distributes the ball well and has a knack for finding the open man. He averaged 7.0 assists per game while playing for the Trojans and that strong facilitating ability should help the Hawks at some points over the next season. Just like Agee, Bishop will have his work cut out for him at earning minutes with a crowded backcourt.

GREG DURAND - Sheffield, **England**

Durand is a 20-year-old wing from Great Britain with great size (6-foot-5) and scoring ability. He played in 11 games last year for Charnwood College in England and averaged 14.1 points per game. Durand had both a high field goal percentage (47.0) and three-point percentage (34.3) while also producing as a force on the boards by grabbing 6.7 rebounds per game. He will also be playing alongside his Charnwood teammate Blaize Sagna in Big Spring and both Raines Mackson will surely be battling to fill and Cotten are excited about Durand's potential.

LAMAR EVERD - Winnipeg, CN

Everd played last year at Paris Junior College in East Texas and will be making the move west to Big Spring to join the Hawks. He averaged 11.9 points, 4.9 rebounds, and 3.9 assists per game last year for the Dragons and scored a season-high 34 points against Kilgore late in the season. Everd appeared to get stronger as the season went along last year and he will look to continue that momentum into the his sophomore year at How-

DARRELL GREEN - Baltimore,

Green is one of two returning Hawks from the 2020 team and he will look to use that as a springboard towards the starting lineup. Green played very well at points last year in a crowded guard room and played his best ball at the end of the season. In fact, Green's two highest-scoring games of his freshman season came in the last four games of the season for Howard. Overall, Green averaged 5.0 points per game with a high field goal percentage (47.9) and staggering three-point percentage (44.3) while coming off the bench.

MARKO JOKSIMOVIC - Berane,

Joksimovic will make the move to Howard College after playing in 2019-20 for KK Beko Beograd in Serbia. He has played in the International Basketball Federation (FIBA) and will bring good size to the Howard lineup.

GERMAN KASANZI OBAMA – Alcala de Henares, Spain

Kasanzi Obama played for Navarro College last year and appeared in 25 games while averaging 10.2 points per game. He totaled 15 games with double-digit points scored and seemed to find the basket often every time that he hit the hardwood. He scored a season-high 23 points against Tyler last

year but had plenty of games where he led his team in scoring. He is a guard with good size (6foot-4) that is more likely to score than he is to distribute the ball around (0.9 assists per game last year).

ZACHERY MACKSON - Atlanta, GA

Mackson is another transfer that will be fighting for playing time this season. He put together a verymstrong season last year while playing for Bishop State in Mobile, Alabama. Mackson averaged 13.9 points per game and shot an extremely high percentage from the floor (66.7). He scored a seasonhigh of 37 points and totaled four games with over 20 points. He was a

consistent starter

for the Wildcats and

a starting role again this year.

NOAH MASON – Humble, TX

Mason is a big-bodied forward out of Atascocita High School in Humble, Texas. Mason will provide muchneeded size for the Hawks. Size on the interior was an issue for Howard last year and Raines is hoping that the addition of Mason will help alleviate that issue.

MO MUSA – Amarillo, TX

Musa is the second of two returning Howard players from last year's team. He most often served as a situational defensive player that was quick to force a turnover. His season-high in points scored was nine (twice) and Musa has been working hard this offseason to earn more time on the court.

BLAIZE SAGNA – London

Sagna is an athletic guard that was considered the top prospect coming out of England. He has played the last two seasons for Charnwood and averaged 22.8 points per game last season. He also averaged 7.8 rebounds per game and 3.0 assists per game. The year before, his numbers were not quite as strong, which is a strong indication that Sagna is still improving and has not reached his full potential. The 6- foot-1 guard will most likely be one of the starting guards for the Hawks during the upcoming season and Raines will rely on him to run the offense.

SAMI SANAD - Cervignano, Italy

Sanad played alongside Agee last season at Cloud County Community College. The 6-foot-7 forward averaged 4.9 points and 3.0 rebounds per game in 29 games played. He will be one of the forces for Howard on the low block during this next season and could play good minutes if he proves himself as a consistent strong frontcourt player.

RODNEY SMITH - Atlanta, GA

Smith played last season at Pensacola State and averaged 7.8 points per game. He was forced to play out of position and he believes that the versatile Howard system will help him produce. "It was a learning year," Smith said. "It was my first time ever playing off the ball and not being the main man. I had to learn how to get my shots off the ball and how to be the second option. I knew that I was going to have to do that at the next level anyways, so I'm happy that it happened early." Smith will now step into a competitive environment with a group of very strong guards that will all be vying for playing time.

BONAVENTURE UDOH -Amarillo, TX

Udoh spend last year at Wayland Baptist and will be making the switch to Howard in January. He was the leader for Amarillo Palo Duro back in 2019 and adds another versatile and dynamic member to the 2021 Hawks' roster.

D'MARI WILTZ – New Orleans

Wiltz is an athletic point guard with a competitive streak and the ability to both score and facilitate the ball for his teammates. He will be joining Howard straight out of high school where he starred at St. Augustine High School. His team finished the last two seasons as the Louisiana state Runner-Up and Wiltz was a driving force behind the team's success. Now, he will join the Hawks as a true freshman with all of the tools to be a great player. "We had a really good read on him and he fits exactly what we're looking for," Raines said. "He's a really talented attack-the-basket type of player who can play with the ball in his hands and we really liked his competitiveness and toughness."

The Howard coaches have spent countless hours recruiting these players and assembling a roster full of ballers from around the world. Next, we will see how all of those players mesh together quickly and then we shall find out just how impressive the 2021 Howard Hawks are.



However, this is not because I play better than the others — as a matter of fact, they all bid and play their cards better than I do.

Where I have a big edge is when it comes to psychology. For instance, the other night I won a 3,300-point rubber — the very first one we

played. My partner and I didn't have the cards to win by such an amount, and to be perfectly frank about it, we should actually have lost the rubber.

It was the psychology, though, that did it, and this hand is what got us started. We got to five spades, and West led his singleton club.

I won with the king, noting that with neither opponent able to give the other a club ruff, the contract was now assured. I then led a spade and finessed. West took the king and made a good play by leading a low heart away from his ace in the hope that East could win and return a club.

East got pretty mad when he saw the heart lead because he wanted a club return also. When he played the ten of hearts, I let him win the trick by discarding a diamond.

This was the key play of the hand, and if you don't understand why, you are missing the whole point. East laid down the ace of diamonds, which I ruffed, and I then claimed the balance, making five.

You never heard such a ruckus as now took place. East and West accused each other of all kinds of stupidity for failing to return a club. Neither of them had noticed my seven-card club suit.

Today in History

Today is Thursday, Jan. 7, the seventh day of 2021. There are 358 days left in the year.

Today's Highlight in History:

On Jan. 7, 1789, America held its first presidential election as voters chose electors who, a month later, selected George Washington to be the nation's first chief executive.

On this date:

In 1927, commercial transatlantic telephone service was inaugurated between New York and London.

In 1942, Japanese forces began besieging American and Filipino troops in Bataan during World War II. (The fall of Bataan three months later was followed by the notorious Death March.)

In 1953, President Truman announced in his State of the Union message to Congress that the United States had developed a hydrogen bomb.

In 1959, the United States recognized the new government of Cuba, six days after Fidel Castro led the overthrow of Fulgencio Batista.

In 1972, Lewis F. Powell, Jr. and William H. Rehnquist were sworn in as the 99th and 100th members of the U.S. Supreme Court.

In 1979, Vietnamese forces captured the Cambodian capital of Phnom Penh, overthrowing the Khmer Rouge govern-

In 1989, Emperor Hirohito of Japan died in Tokyo at age 87; he was succeeded by his son, Crown Prince Akihito.

In 1999, for the second time in history, an impeached American president went on trial before the Senate. President Bill Clinton faced charges of perjury and obstruction of justice; he was acquit-

In 2004, President George W. Bush proposed legal status, at least temporarily, for millions of immigrants improperly working in the U.S.

In 2006, U.S. Rep. Tom DeLay, R-Texas, facing corruption charges, stepped down as House majority leader. (DeLay was found guilty in Nov. 2010 of illegally funneling corporate money to Texas candidates; his conviction was eventually overturned.)

In 2015, masked gunmen stormed the Paris offices of Charlie Hebdo, a French newspaper that had caricatured the Prophet Mohammad, methodically killing 12 people, including the editor, before escaping in a car. (Two suspects were killed two days later.)

In 2019, Amazon eclipsed Microsoft as the most valuable publicly-traded company in the U.S. For the first time in more than 25 years, Supreme Court Justice Ruth Bader Ginsburg was absent from oral arguments as she recuperated from cancer surgery.

Ten years ago: A package addressed to Homeland Security Secretary Janet Napolitano ignited at a Washington postal facility, a day after fiery packages sent to Maryland's governor and state transportation secretary burned the fingers of workers who opened them.

Five years ago: President Barack Obama tore into the National Rifle Association during a televised town hall meeting in Fairfax, Virginia, as he dismissed what he called a "conspiracy" alleging that the federal government - and Obama in particular — wanted to seize all firearms as a precursor to imposing martial law.

One year ago: A magnitude 6.4 earthquake, the strongest to hit Puerto Rico in more than 100 years, killed one person, injured nine others and knocked out power across the U.S. territory. A stampede at the funeral of Gen. Qassem Soleimani in his Iranian hometown of Kerman killed 56 people and injured more than 200. Jury selection began in New York for the rape and sexual assault trial of Hollywood

NFL prospects everywhere in Alabama-Ohio State title game

Former LSU linebacker Patrick Queen is a good example of how a huge performance in a national championship game can help a player boost his Queen was a rising prospect throughout last

season and capped it by being the defensive MVP of the College Football Playoff championship victory against Clemson. About three and half months later, Queen was selected in the first round by the Baltimore Ravens at No. 28 overall. No. 1 Alabama and No. 3 Ohio State head into the

national title game Monday night with a slew of future NFL players. The matchups will not only determine who wins a championship, but could also influence where some of their stars are drafted

"You do want to look into a player's ability to play in the clutch and in the big moments because obviously when you're putting together a football team, an NFL roster, your goal is to be playing in the playoffs," said Jim Nagy, Senior Bowl executive director and a former NFL scout. "So you want to look at the consequential games. The games that

Alabama center Landon Dickerson, who is out with a knee injury, and guard Deonte Brown have already accepted invitations to the Senior Bowl on Jan. 30, Nagy said. Heisman Trophy-winning receiver DeVonta Smith, star running back Najee Harris and tackle Alex Leatherwood have also

For Ohio State, center Josh Myers, running back Trey Sermon, linebackers Tuf Borland and Barron Browning, and defensive end Jonathon Cooper plan to take part in the Senior Bowl, Nagy said. Invitations have also been extended to defensive tackle Haskell Garrett and linebacker Pete Werner.

There are perhaps 20 players who could potential-

ly be drafted in April after playing for the Crimson Tide and Buckeyes.

QUARTERBACKS

Ohio State's Justin Fields was amazing against Clemson, throwing six touchdown passes and showing off accuracy and arm strength all over the field. He also displayed poise and toughness, playing most of the game after taking a nasty hit to his side.

That came after an inconsistent and truncated season that has called into question Fields' status as the best available QB behind Trevor Lawrence.

"There's a lot of buzz around the league about (BYU's) Zach Wilson being the No. 2 pick in the draft behind Lawrence," said Dane Brugler, a draft analyst for The Athletic. "Fields, with what he did it changed that a little bit. He's making teams kind of go back and reconsider.'

The Alabama defense has had some bumpy moments, but it is still the most talented group Ohio State has faced, starting with SEC defensive player of the year Patrick Surtain III. The junior will prob ably be the first cornerback drafted if he declares.

Plus, Fields will be tested by Alabama schemati-

"Give (Tide coach) Nick Saban 10 days to figure you out and to find your weaknesses, that's terrifying," said Matt Miller of NFL Draft Scout.

Alabama quarterback Mac Jones is among the second tier of quarterbacks in the upcoming draft that includes Florida's Kyle Trask and maybe SMU's Shane Buechele.

Jones has been superb, but he doesn't have athletic traits comparable to Fields and Lawrence. Jones is surrounded by top-end talent, and offensive coordinator Steve Sarkisian has done a good job of scheming receivers open and creating mismatches.

"He's a very, very difficult evaluation because

how do you separate him from just an elite situation," Brugler said of Jones.

Especially on the heels of former Alabama star Tua Tagovailoa's rookie NFL season, which was solid but far from spectacular.

WADE'S WORLD

Ohio State cornerback Shaun Wade made the All America team, but that was a generous evaluation based on reputation and last year's play when he was a nickelback and slot corner.

His move to the outside this season has been spot

ty at best and indicative of Ohio State's cornerback play in general. Now, he gets to face Smith, a sure first-rounder, and the gemstone of Alabama's pro lific passing game. "If I'm Alabama and Steve Sarkisian, I'm getting

DeVonta Smith on (Wade's) side of the field as much as humanly possible because no one has been able to stop him," Miller said.

Brugler said Wade's future might still lie at safe

"At the same time, if he goes out there and per forms at a high level against Smith, then all of a sudden that's a different conversation," Brugler said. "But based on what we've seen from Shaur Wade this year, it just doesn't seem like a realistic possibility."
