# New app coming soon, approved by **City Council in Tuesday meeting**

Large item pick-up, Golf Course, firefighter update also on agenda

The Big Spring City Council met on Tuesday. at 5:30 p.m. at the City Council Chambers, located at 307 E. 4th St.

Leading the meeting was the discussion on zone changes from light commercial (LC) to single family residence (SF-3) on 0.42 acres combined, being lots 3-5, Addition, located approximately 70' N.E of the intersection of N.W. 11th St. and N. Bell St. There were 23 notifications sent out, and only two objected. The ones that didn't

"Prior to 1972 the zoning there was already SF-3 which allows for manufactured homes," Roxanne Johnston, City Planner, said. The zone change was approved by the Council with a 5-2 vote.

Also topping Tuesday nights' meeting was an ordi-

nance amending Chapter 6 of the Big Spring Code of Ordinances entitled "Cemetery, Parks, and Recreation," article 7 "Comanche Trail Golf Course" by amending fees and use guidelines.

# **HOPE** Foundation deadline approaching

Creativity is sparked and if supported in the right conditions can grow into endless opportunity and adventure. Through the HOPE grants, Big Spring ISD teachers are receiving support to make those creative ideas thrive with their students.

The deadline for teachers in the Big Spring Independent School District to apply for Innovative Teaching Grants from the HOPE Foundation is fast approaching. The deadline to apply is March 1.

"Classroom teachers have lots of great ideas for activities in their classrooms. The problem is that many of those ideas need funds in order to make them happen. That money may not in the district budget, so the ideas go by the wayside," Linda Conway, with the HOPE Foundation, said.

HOPE stands for "Help Our Pupils Excel." The HOPE Foundation, originally established in November 2014, is a 501 (c)(3) nonprofit corporation that will award grants to BSISD teachers to enable them to implement innovative and creative instructional activities in their classrooms that might not be possible without this funding.

In order to help make these ideas possible, the HOPE Foundation takes applications from October 1 to March 1. The applications are reviewed by demic year.

"The foundation's goal is to give our community

a way to directly help our teachers broaden the learning opportunities that make students 'work ready, college ready,





# Buttigieg, Sanders campaigns request Iowa caucus recanvass for recent votes

WASHINGTON — Bernie Sanders' and Pete Buttigieg's presidential campaigns filed requests Monday for a partial recanvass of the results of Iowa's Democratic caucuses.

The Sanders campaign cited "mathematical errors and inconsistencies" in more than two dozen locations that it says would change the results if amended. And the Buttigieg campaign requested the party check the results in 66 precincts.

Iowa Democratic Party Chairman Troy Price said Monday that the party is reviewing the requests and will respond with next steps within the next 48 hours.

On Sunday, the state party released updated caucus results that gave the former South Bend, Indiana, mayor a lead over Sanders of two state delegate equivalents out of 2,152 counted, or 0.09 percentage points.

Iowa awards 41 national delegates in its caucuses. As it stands, Buttigieg has 13 and Sanders has 12. Trailing behind are Elizabeth Warren with eight, Joe Biden with six and Amy Klobuchar with one.

The 41st and final delegate from Iowa will go to the overall winner. While the state party said Sunday that it belongs to Buttigieg, the caucus won't formally come to an end until the campaigns' requested recanvass — and any potential recount to follow — is complete. The Sanders campaign has outlined 25 precincts and three satellite caucuses where it believes correcting faulty math could swing the delegate allocation in Sanders' favor and deliver him, not Buttigieg, that final delegate. Buttigieg's campaign, in response to Sanders' move, submitted a recanvass request for dozens more precincts that they say would net them an even bigger advantage and keep the remaining delegate in Buttigieg's hands.

The Associated Press reviewed updated results of the Iowa caucuses provided Sunday evening and decided that it remains unable to declare a winner based on the available information. The results, the AP says, may not be fully accurate and are still subject to potential revision.

The caucuses were roiled by significant issues in collecting and reporting data from individual precincts on caucus night. There were also errors in the complicated mathematical equations used to calculate the results in individual caucus sites that became evident as the party began to release caucus data throughout the week.

A recanvass is not a recount, but a check of the vote count against paper records created by caucus leaders to ensure the counts were reported accurately. Iowa Democratic Party volunteers have already undertaken this process with most of the precincts, and the party has told Iowa Democratic activists it will not correct any faulty math recorded by volunteers in each precinct because changing the paper documentation would amount to criminally tampering with a legal document.

Price reiterated this policy during a news conference in Des Moines on Monday and said the only opportunity to correct the math would be a recount.

A candidate can only request a recount of a precinct that has already gone through a recanvass, and candidates must pay for both.

The worksheets used by volunteers leading each caucus to calculate the results are "the official record of what went on in the room, and we did not believe that we should be altering what is the official record of what happened," he said.

"The course for correcting that is what is starting here today, starting with the canvass process and then, if requested, a recount after that," Price added.

A recount would require the party to check the results reported by volunteers in each individual caucus against cards used by each caucusgoer to record his or her picks.

In a statement, Sanders senior adviser Jeff Weaver said the campaign does not expect the recanvass to change the results of the caucuses, and he suggested the campaign may ask for a full recount in the future.

"Once the recanvass and a subsequent recount are completed in these precincts, we feel confident we will be awarded the extra national delegate our volunteers and grassroots donors earned," he said.

# Samsung unveils its new foldable phone, the Galaxy Z Flip

SAN FRANCISCO (AP) — Samsung on Tuesday unveiled a new foldable phone, the Galaxy Z Flip, its second attempt to sell consumers on phones with bendable screens and clamshell designs.

The new phone can unfold from a small square upward into a traditional smartphone form, and will go on sale Feb. 14 starting at \$1,380. The company announced the phone at a product event in San Francisco.

Samsung's first foldable phone, the Galaxy Fold, finally went on sale last September after delays and reports of screens breaking. The Fold, which carries a price tag of nearly \$2,000, folds at a vertical crease rather than horizontally as a flip-phone design would. Motorola has also taken the flip-phone approach with its new \$1,500 Razr phone.

The foldable phones represent manufacturers' attempt to energize a market where sales have slowed. Many consumers are holding onto old phones longer, in part because new phone features offer increasingly marginal benefits. But these foldable models come with higher price tags and are likely to appeal for now mostly to tech enthusiasts and others at the forefront of technology. "While there's a lot of excitement around this new category, it is still early days and they will evolve significantly." said Paolo Pescatore, an analyst at PP Foresight. "While these innovative new designs are nice to have, they're not musthave, sought-after features among users." The Z Flip can stay open at different angles for use watching videos or taking photos. When the phone is closed, it will take selfies and display notifications in a small window on the cover. Unfolded, its screen measures 6.7 inches diagonally.

to keep out dust and improve hinge function, likely to address shortcomings of the Galaxy Fold.

For everyone else, Samsung offers its S series. In a nod to the start of the 2020s, the South Korean company showed off the Galaxy S20, S20 Plus and S20 Ultra, skipping directly to the S20 from its previous S10 series.

The S20 phones are designed to take high-quality pictures in dark settings, Samsung product manager Mark Holloway said. The phones can take both video and photos at the same time, using artificial intelligence to zero in on the best moments to capture the still images.

Samsung's renewed focus on the camera follows other smartphone makers. Apple last fall announced the iPhone 11, which offers an additional lens for wider-angle shots and combined multiple shots with software to improve low-light images. Google's Pixel phones also offer a similar lowlight feature.

Samsung's S phones already offer the wider angle and some features for low-lighting. But the company says the new phones will focus on highresolution photos and the ability to zoom in 30 to 100 times, depending on the model. The S20 phones go on sale in the U.S. on March 6, and will range in price from \$1,000 to \$1,400. All S20 models will be compatible with next-generation cellular networks, known as 5G, although it's still an early technology that consumers typically won't need yet. The Z Flip will not work with 5G networks. As people packed into San Francisco's Palace of Fine Arts for Samsung's launch event, they passed a team taking remote temperatures in the security line, likely a precaution to check for the coronavirus. Samsung also offered hand sanitizer stations and face masks inside the event lobby.



# **Charity founded by disgraced cyclist** announces a reinvented relaunch plan

AUSTIN, Texas (AP) — The cancer charity whose yellow wristbands became a global brand under founder Lance Armstrong is seeking to reinvent itself, years after donations and revenues crashed along with the disgraced cyclist's career.

Armstrong was nowhere to be seen earlier this month during Livestrong's "relaunch" ceremony in Austin. The charity announced plans to end its one-on-one cancer support services, where a patient could call for help dealing with insurance, counseling and medical trials. Instead, it will pivot to spending \$5-6 million annually to support entrepreneurs developing products to improve treatment and patient care.

Livestrong will maintain its partnership with the Livestrong Cancer Institutes at the University of Texas Dell Medical School, which focuses on cancer research, patient care and treatment.

"We're more than a wristband," Livestrong President and CEO Greg Lee told a crowd of about 200 gathered for the event. A few minutes earlier. Gloria Gaynor's 1970s hit single "I Will Survive" pumped out of the speakers.

Livestrong's trademark yellow wristbands were once worn by celebrities and politicians the world over. Donations and commercial ties to athletic apparel company Nike brought in tens of millions annually.

But those days are gone. The wristbands are rarely seen anymore, and Nike ended its Livestrong clothing line years ago.

The legacy and reputation of Armstrong, a cancer survivor who won the Tour de France seven times, crumbled abruptly following revelations he used performance-enhancing drugs. Livestrong has chugged along as a much smaller, leaner organization.

The relaunch came with an artistic redesign. Gone is the yellow-and-black "Livestrong" logo that mimicked the wristband, which is still available for purchase online. The logo has been replaced by a blue background with three rings orange, blue and yellow.

"We're nimble," Lee said. "We're not like an ocean liner. We're more like a jet ski that can turn on a dime."

Lee insists the move is about better serving can-

cer patients, not just reversing declining financial trends.

Livestrong was a pioneer in providing one-onone help to guide people through difficult and sometimes traumatic cancer diagnosis and treatment. The model has been successfully copied by many. The company therefore needs to find new, unique ways to help patients, Lee said.

A money drain also needs attention.

Armstrong founded Lance Armstrong Foundation in 1997 after he was diagnosed with testicular cancer that had spread to his lungs and brain. His remarkable recovery and success on the world's biggest stage for cyclists fueled a boom that transformed the once small charity into a global force.

At its peak, Livestrong took in \$41 million in donations in 2009 when Armstrong came out of retirement to finish third in the Tour de France. The downturn came when Armstrong's career and reputation were undone first by a 2012 investigation in performance-enhancing drug use and his 2013 confession in a televised interview with **Oprah Winfrey**.

The charity desperately tried to distance itself from the scandal. Armstrong was pushed out of his role as chairman of the board of directors he remains listed as a board emeritus member but is otherwise not involved — and the foundation's name was formally changed to Livestrong.

According to 2018 financial records, the most recent available, donations and revenue had dipped under \$2.5 million. Assets listed at \$100 million a decade ago have been whittled to \$46 million. That includes a \$37 million endowment, which has about \$15 million tied to specific spending restrictions.

The 2018 report doesn't reflect the \$17 million sale in 2019 of Livestrong's former headquarters in downtown Austin.

With that money in the bank, analysts at charity watchdog groups Charity Navigator and Charity Watch still give Livestrong good marks for being financially healthy overall and transparent in how it spends. And donations at least have leveled off from their initial plummet.

But Livestrong still spent three times what it takes in on it national partnership with the YMCA, the local one with the University of Texas, and operating expenses. Lee's salary is about \$350,000 a year.

"They are going to have to increase revenue or decrease spending. It will be a question of how they maintain that revenue," said, Kevin Doyle analyst with Charity Navigator.

Lee said Livestrong will shift from it's main fundraising model from one that depends on contributions at large to one that more aggressively seeks corporate and venture-capital partnerships to support its grants and gifts.

Grants could support a wide range of tools for helping cancer patients, such as transportation services or smart phone applications that help patients organize treatment records or connect with multiple physicians, Lee said

Livestrong still has a formidable brand that will likely attract interest from grant applicants and investors, said Daniel Borochoff, founder of Charity Watch.

"They are still a high-profile group," Borochoff said. "People will be motivated to have the Livestrong name backing them."

A decade ago, Armstrong's towering presence alone could draw money as he dominated the world's most famous bike race or flew around the world to meet with celebrities and political leaders at global cancer forums. Back in 2007, it was Armstrong's late-hour lobbying that pushed Texas lawmakers to pass a \$3 billion cancer research fund.

But his divorce from Livestrong was bitter Armstrong's name and image were completely scrubbed from the re-launch celebration.

There were no photographs of Armstrong used in a video compilation of cancer patients and celebratory moments. His presence was missing from a display charting the foundation's first two decades, which included a large bowl filled with yellow Livestrong bracelets.

One speaker mentioned the foundation had been through good times and bad. Only the event host's passing reference to a "famous founder" seemed to acknowledge his impact in starting it all.

A Livestrong spokeswoman said the charity offered to brief Armstrong ahead of the unveiling party, but he declined. Armstrong declined comment when contacted by The Associated Press.

"We have done everything we can to talk to tell people that (Livestrong) is not about one person," Lee said. "We have a changing focus, a new mission and a new visual identity."

# repeal a California travel ban

HOUSTON (AP) — The Texas attorney general has asked the U.S. Supreme Court to overturn a California law prohibiting state employees from using taxpayer-funded business trips to expos or conferences in Texas.

Attorney General Ken Paxton asked the high court to reverse the ban on Monday, the Houston Chronicle reported. The Supreme Court has exclusive jurisdiction over civil disputes between states.

California adopted the ban following a 2017 Texas law that allows foster care and adoption agencies to deny services for religious beliefs. Supporters say the law does not discriminate because it requires the agencies to make referrals to other organizations. But opponents argue the law gives child-placement offices legal authority to discriminate against the LGBT community and others. Paxton called California's ban "economic warfare" and an attempt "to punish Texans for respecting the right of conscience for foster care and adoption providers." "The law California opposes does not prevent anyone from contributing to child welfare," Paxton said. "Boycotting states based on nothing more than political disagreement breaks down the ability of states to serve as laboratories of democracy while still working together as one nation the very thing our Constitution intended to prevent." In a statement issued Tuesday, California Attorney General Xavier Becerra said his state has "chosen not to use taxpayer money to support laws discriminating against the LGBTQ community." The ban by California affects 11 states, including Alabama, Iowa, Kansas, Kentucky and South Carolina. "Discriminatory laws in any part of our country send all of us several steps back," Becerra said in 2017. "That's why when California said we would not tolerate discrimination against LGBTQ members of our community, we meant it."

# Texas asks Supreme Court to Plane flying from Mineral Wells to Granbury crashes, killing pilot

HOOD COUNTY - A single-engine plane flying from Mineral Wells to Granbury crashed over the weekend, killing the pilot and lone occupant of the craft, according to authorities.

The Texas Highway Patrol said wreckage of the Beechcraft BE33 plane was found Sunday about 3 miles from Granbury Airport near FM Road 4 and County Road 2580.

The victim's name has not been released

Authorities believe the wreck occurred sometime Saturday. The pilot reportedly submitted a flight plan from Mineral Wells to Granbury.

The cause of the crash is under investigation by the FAA and National Transportation and Safety Board.

# **3 people found shot to death** inside a Tarrant County home


AZLE, Texas (AP) — Authorities were investigating Tuesday after three people were found dead in a Tarrant County home.

Two men and a woman were found with gunshot wounds Monday after noon at a home in Azle, about 45 miles (70 kilometers) west of Dallas, the Tarrant County Sheriff's Office said.

David McClelland, the chief of staff for the sheriff's office, told the Star Telegram that a family member had called authorities because no one had heard from those living in the house since Sunday night.

McClelland said each person was shot one time.

He said the deaths are still under investigation, but that police don't believe there's a threat to the community.

# **Ex-Army medic sentenced to 35 years for** his wife's murder in 2014

HONOLULU (AP) — A former Army medic stationed in Hawaii was sentenced Monday to 35 years in prison for the 2014 stabbing of his wife in a case involving porn, sex charges and a love triangle.

Michael Walker, 40, pleaded guilty to second-degree murder in September, about a week before his trial was scheduled to begin. He said he arranged for the woman with whom he was having an affair to kill his wife, Catherine Walker, while he was working in the emergency room at Tripler Army Medical Center in Honolulu.

Ailsa Jackson, who committed the killing, was sentenced to 30 years in prison Monday.

In 2015, Jackson pleaded guilty to murder, describing how she stabbed Catherine Walker and then waited a half-hour to make sure she was dead.

Jackson, 29, avoided a mandatory life sentence by helping prosecutors win an indictment against Walker, including providing information about their coded messages to each other, Assistant U.S. Attorney Tom Brady said Monday.

"Our goal from the very beginning was to hold everyone responsible for Catherine's death accountable," Brady said.

Catherine Walker's father, Douglas Plotz, said his family supports a lower sentence. "We wholeheartedly forgive her," he said. "I want Ms. Jackson to know that."

Catherine Walker also forgave Jackson, Brady said. "On the night she was stabbed to death, Jackson asked her if she forgave her," Brady said. "As she was being stabbed, Catherine, replied, yes."

Under a deal with prosecutors, Michael Walker faced 24 to 30 years in prison. But U.S. District Judge Susan Oki Mollway said she sentenced Walker to a longer term because he orchestrated the killing. Mollway, who agreed to sentence Jackson to a range of 30 to 33 years, said she wanted to make sure Walker's sentence was longer than Jackson's.

"Ms. Jackson wielded the knife that killed your wife," Mollway said. "And that was a terrible, terrible deed. But it does appear to me that you were in control. That she did what she did because you wanted her to. And you knew she had mental health problems."

After meeting through an online dating site in September 2014, Michael Walker told Jackson he was married and that his "deepest desire" was to have his wife gone, but he couldn't divorce her, prosecutors have said.

Walker told Jackson he couldn't simply divorce his wife because of financial concerns and stood to receive \$400,000 in life insurance, Brady said.

They plotted the killing in emails, in person and in text messages where they called each other "daddycakes" and "babygirl," according to Walker's plea agreement.

On Nov. 14, 2014, they met in a military reservation's gym parking lot, where Jackson said she would kill Catherine Walker that night, Brady said.

He described how the two came up with a text messaging code to let Jackson know whether she should enter the home through a window or use a key near the back door. If Michael Walker texted, "good," that would mean use the window and "bad' would mean the key.

Walker texted "bad," Brady said, and at about midnight Jackson walked to the Walkers' house at Aliamanu Military Reservation and found the key, Brady said.

Jackson said in court previously she "went inside and grabbed a knife and went upstairs and stabbed her."

Walker apologized to his wife's family Monday. "I love Cathy very much and I would do anything if it could bring her back," he said.

In 2016, a military court found Walker guilty of child pornography charges that surfaced during the murder investigation.

In 2017, Walker was convicted of sexually abusing a child, physically assaulting a child, and wrongfully communicating a threat. He was reduced in rank from sergeant to private, sentenced to 10 years confinement, and received a dishonorable discharge, the Army said.

# Mississippi inmate death toll rises amid emergency extension

JACKSON, Miss. (AP) — Another Mississippi inmate died Monday, the same day the governor extended an emergency order allowing the state to quickly spend money to try to resolve problems in a prison system beset by violence and poor living conditions.

The two developments were announced separately, and there was no indication that Gov. Tate Reeves' extension of the emergency order was in response to the latest death.

The U.S. Justice Department is investigating Mississippi prisons after a string of inmate deaths. The death Monday brings the total to at least 16 since late December.

Many jobs for Mississippi prison guards are unfilled. Health inspections have found recurring problems, including clogged toilets and moldy showers.

Most of the inmate deaths have occurred at the Mississippi State Penitentiary at Parchman and many of them during violent clashes.

Sunflower County Coroner Heather Burton said an autopsy will be done on James Allen Brown, 54, who died Monday. He was serving life for murder, plus 25 years for residential burglary, in Scott County. He was sentenced June 11, 1993. Burton said no foul play is suspected in Brown's death, according to a news release from the Mississippi Department of Corrections. The Justice Department announced Wednesday that its civil rights division is investigating whether Mississippi corrections officials are adequately protecting prisoners from physical harm and whether there are adequate health care and suicide prevention services.

The investigation will focus on con ditions at the Parchman, the South Mississippi Correctional Institution. the Central Mississippi Correctional Facility and the Wilkinson County Correctional Facility, the Justice Department said.

The Wilkinson facility holds state prisoners, and the state pays a private company, Management & Training Corporation, to operate it.

An outburst of violence in late December and early January occurred when Phil Bryant was ending his second term as governor and fellow Republican Reeves was ending a second term as lieutenant governor. Bryant signed an emergency declaration for prisons Jan. 6, and Reeves was inaugurated as governor Jan. 14.

Reeves said in his State of the State address in late January that he has ordered the Department of Corrections to take steps to shut down Parchman's Unit 29, where many of the problems have occurred.

About 1,400 inmates were housed

## Michigan State hires Colorado coach Mel Tucker

EAST LANSING, Mich. (AP) — Mel Tucker has agreed to lead Michigan State's football program, according to two people familiar with the decision.

The people spoke Wednesday morning to The Associated Press on condition of anonymity because the hiring had not been announced. One person said the school's governing board scheduled a meeting later in the day to approve the hire.

Tucker succeeds Mark Dantonio, the school's alltime winningest coach,

who retired less than two weeks ago.

Colorado hired Tucker in December 2018, and gave him a shot to run a program after he was Georgia defensive coordinator. He was given a five-year, \$14.75 million contract to lead the Buffaloes and they were 5-7 last season.

Tucker has ties to Michigan State because he was a graduate assistant at the school under Nick Saban in the late 1990s.

"I've known Mel for well over 20 years and he is one of the brightest coaches in our profession," Saban has said. "They are getting a guy with a great personality, who knows college football, works hard each and every day, and does it with a tremendous amount of enthusiasm and positive energy."

After being an NFL defensive coordinator in Cleveland, Jacksonville and Chicago, Tucker became an assistant again under Saban at Alabama in 2015. He spent only one season with the Crimson Tide, helping them win a national title, before the Bulldogs hired him away. He also was the interim head coach for Jacksonville over the final five games in 2011 after Jack Del Rio was fired.



Today is Wednesday, Feb. 12, the 43rd day of 2020. There are 323 days left in the year. Today's Highlight in History: On Feb. 12, 1809, Abraham Lincoln, the 16th president of the United States, was born in a log cabin in Hardin (now LaRue) County, Kentucky.

On this date: In 1795, the University of North Carolina became the

beat American teammate Danny Kass to win the Olympic gold medal. In 2008, General Motors reported losing \$38.7 billion in 2007, a record annual loss in automotive history, and offered buyouts to 74,000 hourly workers. Uno became the first beagle named Westminster's best in show.

Ten years ago: On the day the Winter Olympics opened in Vancouver, British Columbia, Nodar Kumaritashvili (noh-DAHR' KOO'mah-ree-tahsh-VEE'-lee), a 21-year-old luger from the republic of Georgia, was killed in a high-speed crash during a practice run. inree University of Alabama-Huntsville professors were gunned down during a faculty meeting; police charged neurobiologist Amy Bishop with capital murder. (Bishop later pleaded guilty and was sentenced to life in prison without the possibility of parole.) Five years ago: European leaders agreed on a truce to halt fighting in eastern Ukraine between government forces and Russianbacked separatist rebels. One year ago: Mexico's most notorious drug lord, Joaquin "El Chapo" Guzman, was convicted in New York of running an industrial-scale smuggling operation; a jury whose members' identities were kept secret as a security measure had deliberated for six days. (Guzman is serving a life sentence at the federal supermax prison facility in Florence, Colorado.) Lyndon LaRouche Jr., the political extremist who ran for president in every election from 1976 to 2004, including one campaign waged from federal prison, died at the age of 96. Retired astronaut Mark Kelly announced that he would run in 2020 to finish the Senate term of the late John McCain; Kelly had become a prominent gun-control advocate after the shooting that injured his wife, U.S. Rep. Gabrielle Giffords. Hundreds gathered at a church in suburban Detroit for the funeral of for-

mer Democratic Rep. John Dingell, the longest-serving member of Congress in U.S. history.

In 1914, groundbreaking took place for the Lincoln Memorial in Washington, D.C. (A year later on this date, the cornerstone was laid.)

In 1924, George Gershwin's "Rhapsody in Blue" premiered in New York.

In 1959, the redesigned Lincoln penny — with an image of the Lincoln Memorial replacing two ears of wheat on the reverse side — went into circulation.

In 1973, Operation Homecoming began as the first release of American prisoners of war from the Vietnam conflict took place.

In 1980, the FBI announced that about \$5,800 of the \$200,000 ransom paid to hijacker "D.B. Cooper" before he parachuted from a Northwest Orient jetliner in 1971 had been found by an 8-yearold boy on a riverbank of the Columbia River in Washington state.

In 1993, in a crime that shocked and outraged Britons, two 10-year-old boys lured 2-year-old James Bulger from his mother at a shopping mall near Liverpool, England, and beat him to death.

In 1999, the Senate voted to acquit President Bill Clinton of perjury and obstruction of justice.

In 2000, Charles M. Schulz, creator of the "Peanuts" comic strip, died in Santa Rosa, Calif. at age 77.

In 2003, the U.N. nuclear agency declared North Korea in violation of international treaties, sending the dispute to the Security Council.

In 2006, figure skater Michelle Kwan effectively retired from competition as she withdrew from the Turin Olympics due to injury (she was replaced on the U.S. team by Emily Hughes). Snowboarder Shaun White

HOUSTON (AP) - After James Harden and Russell Westbrook combined for 78 points Tuesday night, Harden was asked just how dangerous this combination can be when it gets rolling.

"It's pretty scary," Harden said.

Harden scored 42 points, Westbrook had 36 and Houston snapped Boston's seven-game win streak with a 116-105 victory over the Celtics in a game that showcased the Rockets' dynamic small-ball lineup.

Harden had eight rebounds and seven assists and Westbrook finished with 10 rebounds and five assists as the Rockets used a starting lineup without a true center after trading Clint Capela last week.

"It's helping both of them," coach Mike D'Antoni said. "It should. It opens up the floor for them. Both of them are great drivers and great finishers ... and it should trickle down to everybody else, too."

Houston broke it open with a 15-2 run that made it 116-98 with about two minutes left. Harden scored six points during the decisive stretch, and Danuel House had five.

Boston had two turnovers and missed numerous shots to allow the Rockets to turn the close game into one where D'Antoni cleared the bench for the last minute with the game well in hand.

"Harden was great ... and Westbrook was great," Boston coach Brad Stevens said. "Those guys are two of the best in the world and they showed it again tonight."

The Rockets enjoyed a big advantage at the line, going 37 for 42 compared to 20 for 25 for the Celtics. Harden made 17 of 18 foul shots.

Gordon Hayward had 20 points in Boston's first loss since Jan. 26. Jaylen Brown scored 19, and Jayson Tatum had 15 on 5-for-15 shooting.

Westbrook, who is in his first season in Houston after a trade from Okla-

homa City, is excited for the possibilities for this lineup once they have more experience with it.

"We can be pretty successful," he said. "We've just got to find ways to continue to be effective, efficient and make the right plays."

Harden, who scored 19 points in the third quarter to help Houston take control, picked up his fifth foul with about eight minutes left. But he was able to stay in the game and avoid fouling out.

Robert Covington had 12 points and seven rebounds in his fourth game since he was acquired as part of the four-team trade that sent Capela to the Hawks.

The Rockets were up by seven with about eight minutes left when Harden picked up three fouls in about 30 seconds. The Celtics then closed to 96-94 on Brown's 3-pointer and a dunk by Tatum with 5:40 to go.

But Houston made five straight free throws to push the lead to 101-94 before making the big run to put the game away.






