Roadwork, bids top business at Commissioners' Court meeting

Howard County Road Engineer Brian Klinksiek presented several items at Monday's Commissioner's Court meeting, including three bids on road work, naming of a road for 9-1-1 identification purposes, and Texas Department of Transportation plans for work on two farm-to-market roads in the county.

The roadwork contracts, designated as RFB 2020014, 2020015 and 2020016, were each awarded to the lowest bidder, per Klinksiek's recommendations. The 2020014 bid concerns work on

County Road 32, and was awarded to Black Jack Energy Services LLC of Big Spring. RFB 2020015 is for work on County Road 23 and 2020016 is for work on County Road 43; the latter two contracts were awarded to Cox Paving Co. of Blanco County.

Although the commissioners had printed copies of the bid amounts, those figures were not mentioned in the meeting.

"I'm perfectly fine with our low bidders. They are all qualified," Klinksiek told the commissioners. "These numbers did, fortunately, come in under my estimates. I'd like y'all to accept those, and allow me to move forward with the contracts with these contractors for the county's projects." Commissioners approved the name "Foltz Lane" for an unnamed roadway off of Terry Lane.

"I said 'Precinct 2' and I may be wrong, it may be Precinct 4. There's a couple of spots where I get confused," Klinksiek said. "Terry Lane comes off of the South Frontage Road and proceeds back kind of south-easterly and then turns easterly. The back portion of it there is an area that was withheld for public use when the area was subdivided. The road was not accepted by the county and it has no name."

Klinksiek explained that, although the

Howard College Board of Trustees approves tuition hike for fall, first since 2015

Howard College students will see a small increase in their tuition cost, starting in Fall 2021.

"We determined not to do it... not to bring it back for your consideration this spring. We decided to wait. We have not increased tuition since 2015. There have been some variations in fees, but as far as tuition, we have not," Howard College President Dr. Cheryl Sparks told the Howard County Junior College District board of trustees at its regular meeting Monday afternoon. "Also, when we look at tuition, we look at how we compare to colleges in the West Texas area. Our peer colleges, small colleges, and we try to get a good idea of how we relate. A lot of small colleges charge a lot more, but we have tried to stay -

in the West Texas area – around the state average."

Sparks said that, after much research and discussion, the college's administration had decided to seek a \$5 per credit hour tuition increase for students from within Howard College's district and a \$10 per credit hour increase for students hailing from farther away.

The increase should increase the tuition of an in-district student from \$90 to \$95 per credit hour, an increase of \$75 for a 15hour course load. Students from Texas but outside the Howard County Junior College District will see their tuition increase from \$138 to \$148 per credit hour, or by \$150 for a 15-hour load; while out-of-state students will see their tuition jump from \$187 to \$197 per credit hour, also a \$150 hike for a

TxDOT calls for safer driving as work zone traffic deaths rise during pandemic

AUSTIN – Even with less traffic during the pandemic, Texas work zone fatalities increased 9% in 2020 compared to 2019. That's why TxDOT is calling on drivers to make safety their number one priority at all times and especially when passing through active construction and maintenance work zones on the roadway.

TxDOT's "Be Safe. Drive Smart." campaign is marking National Work Zone Awareness Week, April 26–30, with safety tips to reduce work zone fatalities. Last year, there were more than 22,000 traffic crashes in Texas work zones with 186 people killed, including four road workers.

"We know driving through work zones can be said TxDOT Executive Director challenging," James Bass.

"There can be extra congestion, slow-moving heavy equipment, temporary barriers, and vehicles that make sudden stops. We can't stress enough how important it is to give driving your full attention and slow down—for your own safety and that of the people who work alongside the road."

15-hour load.

Tuition at the South West College for the Deaf is set by the state, so the increases by the District won't apply to SWCD students.

Howard College is planning a live, in-person graduation event this spring at the Dorothy Garrett Coliseum, Sparks reported during her update on the status of the college's response to COVID-19. The coliseum will be partitioned so that about 25 percent of its regular capacity will be allowed to attend the graduation ceremony, and the event will be livestreamed so that those not able to attend can watch online, she added.

"Students are going to be allowed four tickets each," she said. "Then, what will happen, unused tickets will be redistributed as requested.'

Sparks said several COVID-related requirements will be placed on those attending the ceremony, including wearing of face masks, COVID screenings prior to entry, and social distancing. Sparks urged those displaying disease symptoms to stay home. In addition, the ceremony will feature fewer people on stage than in previous years and a heightened security presence during

Drivers and their passengers account for the majority of those who have died in work zone crashes. In 2020, 147 motorists and vehicle passengers were killed in Texas work zones, along with 35 pedestrians and bicyclists and four road workers.

The Texas Mutual Insurance Company, which helps employers prevent workplace incidents and their consequences, is partnering with TxDOT to promote safe driving. The "Be Safe. Drive Smart.' campaign outlines five key steps drivers can take to safely navigate a work zone:

1. Slow down. Follow the posted speed limit and drive to conditions. Unsafe speed is one of the main causes of crashes in work zones.

2. Pay attention. Avoid distractions, keep your mind on the road and put your phone away.

3. Watch out for road crews. The only protective gear they wear is a vest, a hardhat and safety boots. Remember, they want to get home safe, too.

4. Don't tailgate. Give yourself room to stop in a hurry if you need to. Rear-end collisions are the most common kind of work zone crashes.

5. Allow extra time. Road construction can slow things down. Count on it, and plan for it.

Traffic fines double in work zones when work ers are present and can cost up to \$2,000. Failure to heed the Move Over/Slow Down law can also result in a \$2,000 fine. State law requires drivers to move over a lane or reduce their speed to 20 mph below the posted speed limit when approaching a TxDOT vehicle, emergency vehicle, law enforcement, tow truck or utility vehicle stopped with flashing lights activated on the roadside.

"Be Safe. Drive Smart." is a key component of #EndTheStreakTX, a broader social media and word-of-mouth effort that encourages drivers to make safer choices while behind the wheel such as wearing a seat belt, driving the speed limit, never texting and driving and never driving under the influence of alcohol or other drugs. Nov. 7, 2000 was the last deathless day on Texas roadways. #EndTheStreakTX asks all Texans to commit to driving safely to help end the streak of daily deaths.

the event.

Sparks reported that several college donors have recently requested to transfer their donated funds from the college itself to Howard College's various foundations.

"They've given money to the college as opposed to the Foundation – or one of our foundations – and they have expressed an interest in moving their funds from the college to the Foundation because we can have a more aggressive investing policy in our Foundation than through the college," she said.

The Howard College board unanimously approved a resolution supporting such transfers.

The board approved the purchase of 125 laptop computers for \$195,000 using district funds and funds received through the Coronavirus Aid, Relief and Economic Stability (CARES) Act. The board also approved a lease agreement for computer printers for the college.

The board opened the floor for nominations to the Howard County Appraisal District board of directors, but no one put forth a nomination.

The board approved the nomination of Diane Gierke, chairperson of the Child Development program at Howard College San Angelo, as a Professor Emeritus.

road will not fall under the county's responsibility for maintenance, it needs a name for identification through the 9-1-1 system so that services can be directed to it in case of an emergency.

Klinksiek said landowners in the area requested the name Foltz Lane, and he did not know the origin of the name.

The county engineer reported that TXDoT informed him they would be working on FM 1785 and FM 846 in the near future.

"This is a notification to us from TXDoT that this is what they intend to do," Klinksiek said. "They are going to ask the judge to sign on the title sheet so that they know we were informed. I don't want this to be confused with this being agreement with

the work or them asking about the work. This is their system and this is what they intend to do, and they just want us to know that this is what they intend to do."

Klinksiek said the road project will involve substantial detours.

"1785 runs more or less east and west and starts in Borden County and continues across to US 87. Seven miles south of there, FM 846 runs from 669 out to the end of the county line," he said. "Their intention, on 1785, you will be allowed to go one way on that road. The easiest way I can explain it is, you can go west on 1785. You're going to have to drop down to 846 to go back east. I believe there is a seven-mile difference between those two roads, so you will be traveling 14 miles out of your way to go east and west on those two roads."

The TXDoT work will begin this fall, he said. Commissioners also approved the purchase of a truckload of road repair emulsion and additional equipment for the Road Department, including a tire machine, a vehicle computer, a vehicle lift and four laptop computers, at Klinksiek's request.

In other business, the commissioners nominated Dwain Fox to fill an unfinished term on the How ard County Appraisal District board.

The commissioners also approved several items of routine business, including personnel consid-

erations and County Treasurer Sharon Adams' Quarterly Report; and invoices, purchase requests, budget amendments and County Auditor Jackie Olson's Monthly Financial Report.



Texas health commissioner says J&J vaccines should resume

AUSTIN, Texas (AP) — Coronavirus vaccine providers in Texas should resume using the Johnson & Johnson vaccine, Texas health commissioner Dr. John Hellerstedt said Saturday.

"The Johnson & Johnson vaccine is an important tool in our fight against COVID-19, and the scientific review over the last 11 days has affirmed its safety and effectiveness," said Dr. John Hellerstedt.

Texas joined several other states Saturday in ordering or recommending a resumption after after U.S. health officials said Friday that they were lifting an 11-day pause on vaccinations using the J&J vaccine.

During the pause, scientific advisers decided the vaccine's benefits outweigh a rare risk of blood clot.

The state health department on Saturday reported more than 2,200 newly confirmed or probable virus cases and 49 additional deaths.

There have been more than 2.8 million confirmed or probable virus cases in Texas and 48,946 deaths since the pandemic began. The state health department reports more than 2.7 million people have recovered.

Tesla CEO Elon Musk adding SNL hosting job to his to-do list

NEW YORK (AP) — Technology mogul Elon Musk has a lined up a new gig in addition to his jobs as CEO of electric car maker Tesla and spaceship maker SpaceX. He is going to host the iconic TV show "Saturday Night Live."

Musk's scheduled May 8 appearance builds upon his recent run of success. Tesla's stock is worth nearly six times more than it was before the pandemic started, leaving Musk with an estimated fortune of \$177 billion, according to Forbes magazine. And SpaceX just a launched a mission that sent astronauts to the International Space Station.

Saturday Night Live doesn't make a habit of having business executives host its show, but Musk is far from a stuffy corporate type. He regularly jokes around on Twitter, where he has nearly 52 million followers and has gotten into legal trouble for making disparaging remarks about critics and hinting that he might lead a buyout of Tesla that resulted him getting fined \$20 million by stock market regulators

Miley Cyrus will be the musical guest on the night Musk hosts.

Dallas-area man suspected of killing mother, sister

ALLEN, Texas (AP) - A Dallas-area man has been arrested while awaiting an airline flight out of state and charged with capital murder in the deaths of his mother and sister, police said Sunday.

Isil Borat, 51, and daughter Burcu Hezar, 17, were found knifed to death in their Allen, Texas, home on Saturday morning by police answering a reported "disturbance with weapons."

Borat's husband identified stepson Barak Hezar, 20, as the suspect, said Sgt. Jon Felty, Allen police spokesman. Police were able to trace Burak at Dallas-Fort Worth International Airport. Hezar was arrested while awaiting a flight to San Francisco, where his biological father lived, Felty said. The motive for the homicides was unclear, he said. Hezar was booked into the Collin County on a capital murder charge on \$2 million bond. Jail records list no attorney for him.

killed and his two passengers were hospitalized with non-life-threatening injuries after a light aircraft crashed at a coastal Texas airfield, officials said Sunday.

The crash happened about 1:15 p.m. Saturday at Mustang Beach Airport in Port Aransas, about 20 miles east of Corpus Christi, according to a Texas Department of Public Safety statement.

Carrol V. Jorgenson, 76, of Corpus Christi, was the pilot and was killed in the crash, the DPS said. His two passengers, a 40-year-old man and an eightyear-old child, were ejected from the aircraft by the impact and were in serious but stable condition at Corpus Christi hospitals.

No identities were immediately released, and no cause for the crash has been determined. The Federal Aviation Administration and the National Transportation Safety Board were investigating.

Texas per capita new COVID-19 cases still in bottom quarter

AUSTIN, Texas (AP) — Texas is seeing 165 new COVID-19 cases per 100,000 population over the past two weeks, keeping the state in 40th place among the states and territories in the U.S., according to Johns Hopkins University researchers.

Over the past two weeks, Texas has averaged almost 3,400 new cases per day. Johns Hopkins data show the state also has had 174 COVID-19 deaths per 100,000 population over the past two weeks, ranking 24th in the nation.

The state health department reported 1,344 new COVID-19 cases and 20 related deaths Sunday. However, than 2,200 newly confirmed or probable virus cases and 49 additional deaths.

However, state health officials have said some jurisdictions don't report COVID-19 cases or deaths on Sundays, while some don't report over the weekend at all.

Supreme Court rejects Texas suit over California travel ban

WASHINGTON (AP) — The Supreme Court on Monday refused to consider Texas' challenge to California's ban on state-funded business trips to Texas and other states deemed to discriminate against LGBTQ people.

California adopted the ban following a 2017 Texas law that allows foster care and adoption agencies to deny services for religious beliefs.

Justices Samuel Alito and Clarence Thomas said they would have allowed the lawsuit to go forward at the high court.

Texas Attorney General Ken Paxton sought to file the suit at the Supreme Court, which hears disputes between states. He has called the California law an effort "to punish Texans for respecting the right of conscience for foster care and adoption providers."

In 2017, then-California Attorney General Xavier Becerra said, "Discriminatory laws in any part of our country send all of us several steps back. That's why when California said we would not tolerate discrimination against LGBTQ members of our community, we meant it."

Becerra now heads the U.S. Health and Human Services Department.

The Dallas Opera model takes a different approach than Metropolitan Opera on Demand, an online subscription streaming service of video and audio of past performances, and the Vienna State Opera, which launched a daily stream of an opera or ballet performance.

"We wanted to try something new and we wanted to be able to host it in a way that allows us to take the content that we already had and then allow different categories for future content programing, as well," Derrer said.

Bail denied for man accused in Chicago rapper's 2020 killing

CHICAGO (AP) — A man charged in a Chicago rapper's fatal shooting has been denied bail following his recent extradition from Texas to Cook County in the 2020 killing.

Demitri Jackson, 20, was recently arrested in Fort Worth, Texas, on a murder warrant related to the June 2020 shooting death of Kentray Young, 26, in Chicago's Chatham neighborhood.

A Cook County judge denied Jackson bail on Sunday and ordered the former Chicago man back to court this Friday.

Jackson's private attorney, Thomas Hallock, had argued against denying his client bail, explaining that Jackson was cooperative with authorities and left Chicago only after his grandmother's death from cancer last fall, the Chicago Tribune reported.

But Judge David R. Navarro granted the prosecution's no bail request, adding that Jackson faced natural life in prison if convicted of killing Young, who performed as Tray Savage and had been signed to the Glory Boyz Entertainment record label.

Hello Football fans, it's that time of the year! It's draft week; the NFL will hold its annual draft starting with the first round this Thursday night. The second and third rounds will be Friday night, followed by the final four rounds Saturday. We will focus on what the Dallas Cowboys may do in this draft.

Dallas will pick tenth overall in the first round and have ten picks in the draft. The Cowboys are coming off a disappointing year. They finished 6-10 and had one of the worst defenses in the entire NFL. Couple that with a week five season-ending gruesome broken ankle injury to starting QB Dak Prescot, it was too much for this team to overcome under first-year head coach Mike McCarthy.

Before we get into what the team should or should not do this Thursday night with that tenth pick, let's look at what moves the Cowboys made this offseason. Of course, the most significant move was the signing of franchise quarterback Dak Prescot to a four-year deal worth 160 million. He will earn a record 126 million guaranteed. The agreement has a no-trade clause. Prescot will make 75 million in his first year of the contract. Dak was having a career year until his injury. He led the league in passing yards with 1,856 in only five games. The Cowboy's offense was the top passing team in the league until the superstar QB was injured. Prescot is said to be fully recovered after the significant injury; he has had two surgeries to correct the broken ankle. Andy Dalton moved on to the Chicago Bears, where he has been told he will get a shot at being the starting QB. Dalton did a decent job filling in for the injured Prescot. As I stated earlier, the biggest weakness of this team was the horrific defense. After the woeful season, the Cowboys decided to part ways with Defensive coordinator Mike Nolan.

In will step former Atlanta Falcon head coach Dan Quinn. Quinn was the Falcons head coach for six years. He came to prominence when he was the Defensive Coordinator for the Seattle Seahawks from 2013-2014. He will bring a change of philosophy for the defense this upcoming season. Along with Quinn, the Boys had a few more changes as last year's starting safety Xavier Woods left in free agency. Safety was a needed position in the offseason, and the Cowboys did sign a few names to bring in to compete for spots. Both being former players for Dan Quinn. Keanu Neal was a former first-round pick for the Atlanta Falcons. He comes over to Dallas as a multi-position player. He has played safety in his career, but the consensus is the Cowboys will try him at Linebacker. Damontae Kazee is another former falcon that will come in to compete for the starting safety role. Brent Urban is another name that the Cowboys signed to bolster a lackluster pass rush.

Now that we have looked a what the Boys have done in the off-season let's look at this year's draft and what the Cowboys may do to better this team. Anytime You have a top ten pick, you know you're getting a quality player. OK, so let's break down a few different scenarios that could playout for the Cowboys in the first round Thursday night. Dallas needs help in the defense, and the cornerback position is a glaring one. Second-round draft pick from last year Travon Diggs showed some promise last year, but we still need someone to play alongside him. According to the experts, the best cornerback in the draft is Patrick Surtain II. The player from the University of Alabama is the son of former NFL player Patrick Surtain. He is a Junior that has started all his three years at the college powerhouse. He also played alongside Travon Diggs. If he is indeed there at the tenth pick, I would think Dallas will draft the young cornerback. According to the scouts, he is the most "pro," ready to step in and play from day one. Watching the tape on him. He has all of the skills you want in an NFL cornerback. He has a great back pedal, does not tend to sit on the top of a route, and has great instincts at the position. The most athletic cornerback in the draft, in my humble opinion, is the South Carolina Gamecock Jaycee Horn. Horn is yet another son of a former football player Joe Horn who played wide receiver for the New Orleans Saints. The 6 foot 205 pound CB is a very talented athlete. While he lacks the natural talent that Surtain has, he makes up for it in athleticism. It will make for an exciting decision for the Cowboys if both are still on the board. I tend to lean toward Surtain at pick ten. If Surtain is gone, then I think you trade down a few spots to maybe 13-15 and take Horn. OK, so another position the Boys need help at is the offensive line.

After a year riddled with injuries, The Cowboys have said that Tyron Smith and Laell Collins are healthy. Having said that, Tyron Smith is entering his tenth year in the league and has battled injuries for the last few years. The two top offensive linemen in the draft are Oregon's Penei Sewell and Northwestern's Rashan Slater. While I do not expect either one to be available at pick ten, it would be in consideration if one of them were. Now we come to the Kyle Pitts situation. Pitts is a tight end from the University of Florida. A few analysts consider the young TE to be a once-ina-lifetime talent at the position. It has been reported that Cowboys owner Jerry Jones is "infatuated" with the player. I do not see any way that Pitts will be there at the tenth pick, meaning the Cowboys would have to move inside the top four or five to have a shot at the exceptional athlete. For me, it's a stretch for the Boys to move up that far to grab Pitts. While Pitts may indeed be a generational talent, the cost of moving up that far is just too much, in my opinion. With the defense needed and so much help, I expect this to be a defensive-focused draft. Meaning I hope the Cowboys draft a lot of Defensive players.

It will be an exciting night for the Cowboys come Thursday. They have a lot of defensive tools that I hope they can fill over the three-day draft.







In 1791, the inventor of the telegraph, Samuel Morse, was Charlestown, born in Massachusetts.

In 1810, Ludwig van Beethoven wrote one of his most famous piano compositions, the Bagatelle in A-minor.

In 1822, the 18th president of the United States, Ulysses S. Grant, was born in Point Pleasant, Ohio.

In 1865, the steamer Sultana, carrying freed Union prisoners of war, exploded on the Mississippi River near Memphis, Tennessee; death toll estimates vary from 1,500 to 2,000.

In 1941, German forces occupied Athens during World War II.

In 1973, acting FBI Director L. Patrick Gray resigned after it was revealed that he'd destroyed files removed from the safe of Watergate conspirator E. Howard Hunt.

In 1982, the trial of John W. Hinckley Jr., who shot four people, including President Ronald Reagan, began in Washington. (The trial ended with Hinckley's acquittal by reason of insanity.)

In 1994, former President Richard M. Nixon was remembered at an outdoor funeral service attended by all five of his successors at the Nixon presidential library in Yorba Linda, California.

In 2009, a 23-month-old Mexico City toddler died at Texas Children's Hospital in Houston, becoming the first swine-flu death on U.S. soil.

In 2010, former Panamanian

Ten years ago: Powerful tornadoes raked the South and Midwest; according to the Oceanic National and Atmospheric Administration, more than 120 twisters resulted in 316 deaths. An Afghan officer, Col. Ohtani wins for Angels in 2-way start like none since Ruth

ARLINGTON, Texas— That was quite a twoway Sho in a big league start like none since Babe Ruth a century ago.

Shohei Ohtani struck out nine after a shaky first inning on the mound, and also scored three runs and drove in two as the Los Angeles Angels beat the Texas Rangers 9-4 on Monday night.

"A pretty complete game of baseball," Angels manager Joe Maddon said. "If you weren't entertained by watching him tonight, you can't be entertained watching the game of baseball."

A day after hitting his seventh homer to tie for the MLB lead, Ohtani (1-0) became the first home run leader to be the starting pitcher for a game since Ruth for the New York Yankees against Detroit on June 13, 1921. It was the second time this season Ohtani pitched and batted second.

After giving up four runs while throwing 28 pitches in the first inning — when he walked two, hit another batter and threw a wild pitch — Ohtani got the Angels even at 4-4 in the top of the second when he had a two-run double and then scored on a single by Mike Trout, who had four hits in his return to the lineup.

"I was able to drive in those two runs, that was huge for me, and we were able to tie the game up in the second inning," Ohtani said through his translator. "So it felt like a fresh start, I treated it like a brand new ballgame."

The Japanese right-hander retired 14 of the last 15 batters he faced in five innings, with all of his strikeouts in that span. It was his first big league win since 2018, before Tommy John surgery that kept him off the mound for all of 2019 and most of last season.

"I'm very happy for the team victory," Ohtani said. "Personally that first inning was terrible, so I can't be overly satisfied."

Ohtani drew a one-out walk and scored on Jared Walsh's single in the Angels first. He bunted against the shift for a single in the sixth and scored on Walsh's double, and was done.

"He's impressive. Clearly, he's vulnerable in the first inning, and he's shown that twice against us," Rangers manager Chris Woodward said. "But, you know, to watch him settle down ... just amazing. Then he's doing some things with the bat. You just don't see kind of what he can do."

Justin Upton and Albert Pujols put the Angels ahead to stay with back-to-back homers to start the third off Texas starter Jordan Lyles (1-2), who allowed seven runs and 10 hits in 2 2-3 innings. José Iglesias later went deep off Hyeon-Jong Yang, the lefty from South Korea making his big league debut.

Trout also had an RBI double while raising his average to .426. He had missed three games because of a bruised left elbow after getting hit by a pitch in the series opener at Houston on Thursday.

Texas led on Nate Lowe's sixth homer, a threerun shot that gave him an MLB best-matching 21 RBIs. David Dahl's sacrifice fly made it 4-1.

In his previous start on the mound, last Tuesday at home against the Rangers when he didn't bat, Ohtani became the first starting pitcher since at least 1901 with four scoreless innings with at least six walks and seven strikeouts. He allowed only one hit in the Angels' 6-2 victory.

That was his first time on the mound since April 4 after dealing with a blister issue on the middle finger of his throwing hand. In that first start, Ohtani both smashed a 451-foot homer and pitched two-hit ball into the fifth inning against the Chicago White Sox.

Ohtani settled in needed only 47 pitches to get through the his final four innings, and was done after Maddon said he started to develop another blister. Ohtani said afterward it wasn't a big deal.

"His offensive performance tonight while he was pitching was a big contributor to our win," Maddon said.

SHORT HOPS

Upton's go-ahead shot leading off the third was his 313th career homer in his 15 MLB seasons. The 41-year-old Pujols, in his 21st season, followed with his 667th career homer — he is fifth on the MLB list, 30 from passing Alex Rodriguez for No. 4 all-time. ... Yang allowed two runs over 4 1/3 innings in his big league debut, the longest for a Rangers reliever since 1989.



The 33-year-old Yang played 14 years with the Kia Tigers in the Korean Baseball Organization, where he was the MVP in 2017 and the league ERA champion twice. ... Rangers RF Joey Gallo extended his season-opening onbase streak to 22 games with a walk.


TRAINER'S ROOM

Angels: 3B Anthony Rendon was back in the lineup after missing 11 games with a left groin strain. He was activated from the injured list before the game. To make room on the roster, the Angels optioned infielder Luis Rengifo.

Rangers: To make room on the 40-man roster for Yang, the Rangers transferred first baseman/outfielder Ronald Guzmán (torn meniscus right knee) from the 10-day to 60-day injured list. Guzmán was placed on the injured list April 13, and is scheduled to have seasonending surgery Wednesday.

Rangers RHP Mike Foltynewicz (0-3, 5.32 ERA) and LHP José Quintana (0-1, 9.00) are the starting matchup again, like last Wednesday in a series finale at Los Angeles that the Rangers won 7-4. Foltynewicz has given up an MLB-high eight homers, including solo shots to Ohtani, Trout and Upton last week.
