The community was invited to a reception at the Hangar 25 Air Museum to continue the recognition and remembrance of those who served.



'Leave the building': Texas walkout escalates voting battles

AUSTIN — Midnight was coming fast. Any moment now, the Texas House of Representatives would sign off on one of the most restrictive new voting laws in America.

It was 10:35 p.m. Suddenly, every Democrat still on the floor got a text message.

"Members, take your key and leave the chamber discreetly. Do not go to the gallery. Leave the building."

The walkout was a go, and minutes later, Senate Bill 7 was dead. Left without enough House members to conduct business under the rules before a midnight deadline Sunday, Texas Republicans were forced to abandon for now an elections overhaul they had crammed with previously unseen restrictions during closed-door negotiations, including one prohibiting Sunday morning early voting — a time widely used by Black churchgoers in "souls to the polls" campaigns.

It was a dramatic, last-ditch revolt: One by one, Democrats headed for the exits and disappeared down corridors. The voting machines on their abandoned desks were locked. In the unlikely event of a "call of the House" — an extreme remedy to secure a quorum, mobilizing state troopers to forcibly bring absent members back — Democrats chose a hideout that was unmistakable in meaning: Mt. Zion Baptist Church, a Black house of worship more than 2 miles (3.22 kilometers) away.

The rebellion gave Democrats and voting rights allies nationwide a morale-raising moment after months of racking up losses in GOP-controlled statehouses, where Republicans have rushed to enact a wave of strict voting laws in response to former President Donald Trump's false claims that the 2020 election was stolen from him.

But the walkout in Texas is likely only a fleeting victory: Republican Gov. Greg Abbott, who had declared new voting laws a priority in Texas, barely waited for every Democrat to flee the House floor before declaring that he would order a special session to finish the job. And he's already begun punishing lawmakers, saying Monday that he would veto the part of the state budget that funds legislators' salaries.

"No pay for those who abandon their responsibilities," Abbott tweeted.

He has not said when he will drag lawmakers back to work.

"I understand why they were doing it," said Republican state Rep. Briscoe Cain, who carried the bill in the House. "But we all took an oath to Texans that we would be here to do our jobs."

Coming in at 67 pages long, the Texas bill would have reduced polling hours, empowered poll watchers and scaled back ways to vote. It included a ban on drive-thru voting centers and 24-hour polling places, both of which were used last year around Houston, reflecting how Republicans went after Texas' largest Democratic stronghold.

Many were ideas that Democrats had spent months fighting, but they protested that others were snuck in at the last minute. That included not just new early voting limits for Sunday but also a provision that could make it easier to overturn an election. Under the bill, a judge could void a candidate's victory if the number of fraudulent votes cast could change the outcome, regardless of whether it was proved that the fraud actually had affected the result.

It's the sort of provision that could allow a favorable judge to side with a candidate who makes broad claims of fraud with little specific evidence — as Trump did with virtually no success. Democrats and voting groups were particularly alarmed about it because the GOP has continued to embrace Trump even after he tried to overturn the 2020 election on phony claims of extensive fraud.

Hours before the vote was set to take place Sunday, Democrats packed into a back room with Republican House Speaker Dade Phelan.

"We weren't getting satisfactory answers about why the bill had gotten so much worse," Democratic state Rep. Gina Hinojosa said. "Most of us walked away from that meeting understanding that this was our only option."

But even before then, Hinojosa said, momentum toward a walkout was building. She said a meeting of Black and Hispanic lawmakers in the House made clear there was "an anger, a sadness, an intolerance" about letting the bill pass. Another option was running out the clock but that carried more risk: Hinojosa said Democrats received word that any effort to filibuster the bill would lead to Republicans cutting off debate and holding a vote.

It was the first time in nearly 20 years that Democrats had staged a quorum break in Texas.

The meltdown of the Texas bill was a rare victory for Democrats in a year that has seen 14 states enact new laws tightening voting restrictions, according to the Brennan Center for Justice, a voting rights group. These laws have typically been muscled through by Republican-controlled state legislatures and signed swiftly by GOP governors. The Democrats' potential remedy to the wave of restrictions — a sweeping national voting bill — is bogged down in Congress.

"We've been getting example after example in Republican state legislatures, and this is the culmination in terms of its raw racism and cutting back of the ability for brown and Black voters to vote," said Fred Wertheimer, founder of the voting rights group Democracy 21. "The way they're fighting in Texas tells a story of just how bad this legislation is and how Democrats are prepared to do everything they can conceive of to stop this legislation from happening."

Democrats and voting rights groups also hope that Texas gives a shot in the arm to the bill in Congress, known as the For the People Act or HR1. The measure has been stalled in the Senate because some Democrats are not willing to end the filibuster. Senate Majority Leader Chuck Schumer has scheduled debate on the bill to begin in late June in hopes of breaking the impasse, and activists hope the boldness of Texas Democrats in using quorum rules to block legislation will push their Washington, D.C., counterparts to eliminate such rules in the U.S. Senate.

At the least, Democrats hope the walkout bought them some time. When they left the church, it was after midnight.

"We may have won the war tonight but the battle is not over," Democratic state Rep. Nicole Collier said.

Houston seethes over being frozen out of federal flood funds

HOUSTON — Residents of the East Aldine neighborhood of Houston are tired of their homes flooding during hurricanes and of worrying every time it rains because their streets and waterways don't drain well.

Like the rest of the Houston area, East Aldine was hammered in 2017 by Hurricane Harvey, which caused an estimated \$125 billion in damage throughout the state but nowhere more than in the nation's fourthlargest city and surrounding Harris County. East Aldine residents had to flee their homes through chest-high water, many carrying their children on their shoulders as they sought higher ground. The working class, predominantly Latino neighborhood that straddles Houston and unincorporated parts of the county was flooded again two years later during Tropical Storm Imelda.

'Whether you flooded or not, whether you had to evacuate or not, you are traumatized by the fact that rain is coming and you don't know what's going to happen and you don't know how it's going to impact your family," Shirley Ronquillo, a community activist who grew up in East Aldine, said Thursday. That's why she and many other Houston residents were outraged when a state agency recently announced that Houston wouldn't get a cent of the initial \$1 billion in federal funding that was promised to Texas following Harvey to help pay for flood mitigation projects, including drainage improvements and the widening

of bayous. The Harris County government was also iced out, though four smaller cities in the county were awarded a total of \$90 million.

The awarding of the U.S. Department of Housing and Urban Development funding led to a rare show of solidarity by local Democratic and Republican officials, who condemned how the Texas General Land Office, or GLO, picked its winners and losers. Ronquillo called it a "slap in the face" to communities of color who have historically been denied assistance.

Some officials and residents accused the GLO of playing politics, given that Houston and Harris County are Democratic strongholds in a state controlled by the GOP and have been at odds with the state's Republican leaders since Harvey over issues related to recovery funding.

The land office said the competition for the initial distribution of funding was fair and not political, and that it used scoring criteria based on HUD guidance. But a HUD spokesman. Michael Burns, said the federal agency didn't require the criteria used by Texas and that it believes "all areas of the state, including Houston and Harris County, should receive the resources they need to recover from Hurricane Harvey." Faced with the criticism, Land Commissioner George P. Bush – a Republican grandson of former President George H.W. Bush — said he would ask HUD to approve \$750 million for Harris County, though none of it would be given directly to Houston and it's unknown if HUD would approve that outlay.

Bush suggested that "red tape requirements and complex regulations" under President Joe Biden's administration were responsible for Houston and Harris County not being awarded any of the funds. During a news conference Thursday, some Democratic members of Houston's congressional delegation accused Bush of politicizing the awards process by criticizing the Biden administration even though delays in establishing rules to use the funding and the creation of criteria for awarding it happened during the Trump administration.

The lack of flood mitigation funding has left many Houstonians seething.

During a meeting of the Harris County Commissioners Court last week, Pastor Rick Martinez, with Bethel Community Church in the East Aldine area, said residents were "being used as political pawns" and he asked GLO officials to visit his community after the next storm.

Standing along Halls Bayou, a few blocks from her home, she said the lack of funding would likely endanger the families who live along the waterway, which has experienced major flooding 14 times since 1989. Many of these families can't afford flood insurance and have little savings because they're focused on day-to-day survival, said Ronquillo, who co-founded the community group Houston Department of Transformation.

In the Allen Field subdivision north of East Aldine, houses and mobile homes are raised 6 to 8 feet (1.8 to 2.4 meters) off the ground because of perpetual flooding. But many residents, including Dolores Mendoza, are being forced to move because of a mandatory flood buyout program.

Six generations of Mendoza's family have lived in the subdivision and she would rather stay, but the flooding is getting a lot worse. Her home is near Greens Bayou, and the open drainage ditches that line her street are often clogged by debris and do little to remove water when it floods. Heavy rainfall last week made the roads leading to her home impassable. Mendoza, a 34-year-old accountant, said the GLO's funding decision was frustrating but not surprising because "people don't really understand what it really is like out here." "With the lack of support from the state, the fear is that once again, we're not going to get the funding that we need and therefore we will continue to flood," Ronquillo said.

The lack of flood mitigation funding is also aggravating a \$1.4 billion shortfall Harris County faces in fully funding flood control projects that Houston-area voters approved in 2018 in response to Harvey.

Tucker, Houston Astros down former bench coach Cora, Boston Red Sox 11-2

HOUSTON-Back in Houston as Boston's manager, Alex Cora and the Red Sox were handed their most lopsided loss of the season by his former team.

Kyle Tucker had a seasonbest three hits and tied a career high with four RBIs as the Astros beat their exbench coach and his Red Sox 11-2 on Monday.

This was the first time Cora, now managing the Red Sox again, had faced the Astros since being suspended last year for his role in Houston's illegal sign-stealing scheme in 2017.

Cora helped Houston win the 2017 World Series as bench coach, then managed Boston to the 2018 championship. He was let go by the Red Sox following Major League Baseball's investigation into the Astros, then suspended by MLB through the 2020 postseason before getting rehired in Boston last Novem-

ber.

"I got suspended," Cora said, reflecting on the scandal before the game. "That's something that will always be on my resume and I think at the end, we all made a mistake. We all messed up, and we all are paying the price."

Cora remains close with Houston players Carlos Correa and Jose Altuve and said before the game that Astros hitting coach Alex Cintrón was his "best friend." Cora and Cintrón talked and joked around before the game.

"Cora, that's my boy," Correa said. "That's my brother for life. His time here, I will always appreciate it because I learned so much from him when he was here."

Cora was asked about Houston's approach at the plate on Monday.

"They did a good job of just making contact," he said. "It's not about hitting hard all the time. You make contact and good things happen and today they did that."

Jose Urquidy (4-2) did his a lot of runs and win the part in ending Boston's threegame winning streak. He yielded three hits and one run, striking out nine over six innings in his return from the injured list.

Urquidy, who had been out since May 12 with shoulder inflammation, won his career-best fourth straight decision.

"He had good tempo," Astros manager Dusty Baker said. "Everything was in sync. He told us he was going to be ready and he ... threw as good of a game as he had all year."

The recent struggles for Eduardo Rodriguez (5-4) continued when he allowed a season-high six runs and seven hits in 4 1/3 innings to extend his losing streak to a careerlong four games. He struck out four and walked two after pitching just four innings his last time out.

Altuve hit a two-run homer and Alex Bregman drove in two runs for Houston.

"It's always good to score

game," Altuve said. "This is why we're here. I think we're playing good but we need to play even better. I like where we're at."

The Astros got things going by hitting three consecutive singles with no outs in the second before taking a 1-0 lead on a sacrifice fly by Taylor Jones. Myles Straw then grounded into a double play that scored another run.

Martín Maldonado singled to start Houston's third before Altuve homered into the seats in left field to extend the lead to 4-0. That homer was the 140th of Altuve's career, moving him past Bob Watson and into sole possession of eighth place on the franchise list.

Altuve singled with one out in the fifth and Rodriguez walked Bregman with two outs. Colten Brewer relieved and walked Correa to load the bases, and Tucker grounded a two-run single to make it 6-0. Bregman's two-run single

highlighted a five-run sixth.

Alex Verdugo hit an RBI double in the Boston sixth. Hunter Renfroe homered in the eighth.

Stars carry Clippers at Mavs again, 106-81 rout evens series

DALLAS - A little cat-and-mouse game between the coaches over the size of the lineups didn't amount to much, as entertaining as it was early for another boisterous crowd in Dallas.

The big dogs of the Los Angeles Clippers were the difference on the road again, and their team is back in control of the first-round series.

Kawhi Leonard had 29 points and 10 rebounds, Paul George scored 20 points and the Clippers manhandled the Mavericks, winning 106-81 in Game 4 on Sunday night to keep the road team perfect in a Western Conference series now tied 2-2.

Reggie Jackson added 15 points, and the fourthseeded Clippers are headed home for Game 5 on Wednesday night much more sure of themselves than when they left LA in a two-game hole.

"We're where we were supposed to be," said Nicolas Batum, who was at the center of the lineup swap as a smallish 6-foot-9 starter over 7-footer Ivica Zubac. "We're supposed to be at 2-2, technically. So we're going to go home and home court." Luka Doncic started slowly after being listed as questionable because of a cervical strain, the diagnosis for the Dallas sensation after he said following Game 3 that he felt pain in his neck and down his left arm. Playing with medical strips on his left shoulder, and wearing a large pad in that area when he wasn't playing, Doncic scored 19 points after averaging 38 in the first three games.

couldn't turn left, couldn't look to his left, couldn't turn his neck to the left. That's difficult for a guy that relies on peripheral vision and basically has played his whole life with his head on a swivel. His neck issue certainly contributed to a 9-for-24 night and him having some real unusual struggles.

The Mavericks came home filled with hope of ending a 10-year run without a playoff series victory since the franchise won its first championship, knowing the number of fans was about to more than triple with loosened COVID-19 restrictions.

Instead, a pair of crowds exceeding 17,000 didn't get much after a huge jolt of energy in Game 3 carried the Mavericks to a 19-point lead in the first quarter before Leonard and George took over.

The LA superstars didn't give fans much of a chance to get into Game 4, beyond the early gamesmanship between the coaches.

After a smaller lineup turned Game 3 in LA's favor, Lue chose that approach from the beginning in going with Batum.

"His mindset is great," Lue said. "I thought he did great job on Luka getting up the floor, trying to deny him the basketball, pressure him a bit. Nico starting allowed us to do more defensively, switch more." Marcus Morris didn't even jump against Kristaps Porzingis on the opening tip, and the 7-3 Latvian scored the first two Dallas baskets on post-up jumpers. Porzingis finished with 18 points. With Zubac still sitting midway through the first quarter, Carlisle replaced Porzingis with the 7-4 Boban Marjanovich, a fan favorite who hadn't even played in the series before that. The big Serbian got a huge ovation and the crowd went even crazier when he had the next two Dallas baskets. Zubac's first appearance came shortly thereafter. Neither of those answers lasted long, and the Mavericks never found solutions for Leonard and George. Leonard, who is averaging 33 points in the series, got to the rim when he wanted to and was efficient from 3-point range, making two of three. He was

11 of 15 overall, and made 24 of 32 shots in the two games in Dallas.

"The pace and the speed he's playing with is what we need," Lue said. "It's unbelievable.'

George did his damage in the first half of both games in Dallas, the first helping LA recover from the hot Dallas start. This time, he had 18 points before the break to help the Clippers to a 61-35 lead. The margin surpassed 20 for the first time on an 8-0 run to start the second half.

"They've got two great players that are just putting their head down and basically trying to go through us," Carlisle said.

After entering the game shooting 51% from 3-point range in the series, the Mavericks were just 5 of 30 (17%). Dallas shot 35% overall.

TIP-INS

Clippers: Despite not starting, Zubac still managed to foul out with 8:15 remaining in the game. He had five points and eight rebounds in 18 minutes, which was seven more than he played when Lue went small in Game 3. ... Batum scored 10 points.

Mavericks: Tim Hardaway Jr. and Dorian Finney Smith were two key secondary scorers for Dallas in the two wins in LA. They were a combined 4 of 17 from the field. ... Marjanovich scored 12 points.

Grimacing at times and grabbing his neck at others, the 22-year-old star was 9 of 24 with series lows in rebounds and assists with six apiece.

"I don't think that matters right now," Doncic said. "Injuries are a part of basketball. I was 100%. But I played terrible. Just got to move on to the next one.'

Coach Rick Carlisle disagreed, and said the best hope for Dallas was two full days between games for Doncic to get rest and treatment.

ROAD WARRIORS

It's the seventh time in the past 50 postseasons that the road team won the first four games of a series. The most recent was Chicago-Boston in 2017, when the Bulls won the first two before losing the last four of the first-round series (including Game 5 at the Celtics).

The Mavericks did with Houston in 2005, losing twice at home before winning two at the Rockets on the way to a seven-game series victory in the first round.

FREE THROW PUZZLE

Doncic has a puzzling problem at the free throw line, a place he has a knack for finding with his unique abilities to pass and create at the rim. He missed all five freebies, putting him at 13 of 32 for the series.

Brown leads TCU past Oklahoma St. 10-7 in Big 12 title game

OKLAHOMA CITY — Porter Brown had two hits and drove in five runs to help TCU defeat Oklahoma State 10-7 in the Big 12 championship game on Sunday night.

Brown, a redshirt freshman outfielder, was selected the Most Outstanding Player of the tournament.

"I just got hot at the right time," he said.

Phillip Sikes had three hits and scored three runs, and Luke Bovers had two hits and scored twice for the second-seeded Horned Frogs (40-17), who also were selected Sunday as one of the 16 NCAA Tournament regional hosts.

TCU, which tied for the Big 12 regular-season title, previously won the tournament in 2014 and 2016.

Cade Cabbiness had two hits and three RBIs for fourth-seeded Oklahoma State (35-17-1).

Oklahoma State scored five unearned runs with two outs in the top of the third inning to take a 5-2 lead. The highlight was a three-run homer by Cabbiness — the Cowboys' only hit in the inning. TCU committed two errors to help Oklahoma State.

TCU's freshman Garrett Wright entered in the third to try to stop Oklahoma State's momentum. He hit a batter, walked two and gave up the homer to Cabbiness before getting out of the inning.

TCU scored two in the bottom of the third and one in the fourth before taking control in the fifth. Brown doubled and knocked in three runs to highlight a five-run inning that gave the Horned Frogs a 10-5 lead.

Wright settled down and pitched scoreless innings in the fourth, fifth and sixth to earn the win.

"So, obviously, Garrett Wright struggled a little bit," Brown said. "He got back in the dugout and we just told him to keep his head up and keep on giving us innings and pitches and to trust in our hitters to have good quality at-bats to bring us back into the game."

Oklahoma State scored one run in both the seventh and eighth innings. The Cowboys got a runner to second in the ninth, but did not score.

It was Oklahoma State's third trip to the title game in the past four tournaments. The Cowboys previously won the Big 12 Tournament in 2004, 2017 and 2019

The Cowboys expect to be awarded a regional berth Monday and hope to get to Omaha for the College World Series.

"We wanted a ring," Oklahoma State coach Josh Holliday said. "We fought hard to get in position for one. We came up short, so we'll shift our focus to a different type of ring.'



In 2003, leaders of the world's seven wealthiest nations and Russia pledged billions of dollars to fight AIDS and hunger on the opening day of their summit in Evian, France.

In 2009, Air France Flight 447, an Airbus A330 carrying 228 people from Rio de Janeiro to Paris, crashed into the Atlantic Ocean with the loss of everyone on board.

In 2015, Vanity Fair released its cover photo featuring the former Bruce

politics over Medicare; the White House said Obama had in fact led on the issue, and accused Republicans of trying to destroy the popular health care program for seniors. Space shuttle Endeavour and its six astronauts returned to Earth, closing out the next-to-last mission in NASA's 30-year program.

President Donald Trump, after declaring himself "the president of law and order" and threatening to deploy the U.S. military in a Rose Garden speech, then walked across the empty park to be photographed holding a Bible in front of St. John's Church, which had been damaged a night earlier in a protest fire. A curfew failed to prevent another night of destruction in New York

Jason Kokrak gets 2nd win quicker, overcoming Jordan Spieth at Colonial

FORT WORTH, Texas — Jason Kokrak played in 233 PGA Tour events before getting his first victory. The big hitter didn't have to wait nearly as long to win again, though this one may have been harder because he had to overcome a local favorite at Colonial.

Kokrak shot an even-par 70 in a final-group showdown Sunday with resurgent Jordan Spieth, winning the Charles Schwab Challenge at 14-under 266. He was two strokes better than Spieth, who hit his approach from the rough at No. 18 over the green and into the water.

"You stay in the moment and it's a golf course. You're playing the golf course, you're playing yourself. You're not really playing Jordan,' Kokrak said. "But for where we got to in comparison to some of the other players, I knew it was going to be a boxing match and see who was going to come out on top."

There were five bogeys and five birdies for Kokrak, who twice needed two shots to get out of bunkers. There were also back-to-back bogeys at Nos. 15 and 16 before a key par-saving 7-foot putt after his approach missed the 17th green.

But when he struck his round-end-

the cup and finally broke into a smile when celebrating with caddie David Robinson.

A huge crowd followed the only contending group all day, most of them waiting to erupt for Dallas-native Spieth, who began the round with a one-stroke lead before a bogey-filled 73. Kokrak said he heard some negative comments and knew he "definitely was not the favorite," but did have a high school buddy and a cousin's friend supporting him on the course.

"Naturally, you're going to pull for the hometown kid. I appreciate it. I appreciate the gamesmanship," Kokrak said. "Jordan was amazing all day. He's a true champion and he's won multiple times and is an incredible player. I'm glad to be standing victorious above a guy that's so good."

Kokrak, playing in his 16th tournament since winning the CJ Cup at Shadow Creek in October, joined Bryson DeChambeau and Stewart Cink as the only players with two wins on the PGA Tour this season.

Spieth, the 2016 winner at Colonial, was a runner-up there for the third time after leading each of the first three rounds.

"I didn't play well at all, quite simply," Spieth said. "I could have shot even par today and won the golf tournament, but from the very get-go, just

ing 4-footer, he followed the ball to a really bad start, and then tried to fight my way through it. I was just really off with my golf swing. I really lost it this weekend. You just have to be in control around Colonial."

It was still his eighth top-10 finish in his last 11 starts this year, one more top 10 than he had the previous two seasons combined.

Along with the \$1.35 million winner's check and plaid jacket, Kokrak got a customized restored 1946 Schwab Power Wagon, a truck with 40-inch tires and a model date matching the first year of Colonial, the longest-running PGA event at the same venue.

"I'm a big guy with a big truck with a big jacket and a big paycheck. So I guess everything's bigger in Texas, right," he said.

Charley Hoffman had a closing 65 to finish in a four-way tie for third at 10 under. He also had a tournamentbest 62 on Friday, but that was sandwiched by a pair of over-par rounds (71 on Thursday and 72 on Saturday). Patton Kizzire (67), Sebastian Munoz (68) and Ian Poulter (68) were also at 10-under 270. Troy Merritt was alone in seventh at 7 under.

Sergio Garcia was in third place at 10 under to start the final round, but the 41-year-old Spaniard, who got the first of his 11 PGA Tour wins 20 years ago at Colonial, bogeyed the opening par 5, then had had a three-putt for double bogey at No. 3. He shot a 76 and tied for 20th at 276.

Kokrak took the lead for good with birdies at the longest and shortest holes. He made a 13-foot putt at the 629-yard 11th, then a 17-footer off the fringe at the 170-yard 13th after a tee shot the came close to going into the water fronting the par 3.

Spieth only had two birdies, the last with an approach to less than 2 feet on No. 9 that matched them at 14 under going to the back nine.

After going into a greenside bunker at the 551-yard opening hole, Kokrak didn't get the ball out of there on the first try and the bogey quickly put him two strokes behind.

But Spieth, who had only two bogeys in the first 55 holes, then bogeyed three holes in a row — and had two more on the back nine. He went in the right rough and then over the green on both Nos. 2 and 3, then hit into a bunker fronting the difficult 241-yard, par-3 fourth. He blasted to six feet, but his par attempt curled around the edge of the cup.

Kokrak led for the first time after a 23-foot birdie putt at the fifth, but his other bunker trouble came at No. 7, where he bogeyed while Spieth made par after a wayward tee shot hit a tree and ricocheted into the fairway.

Arkansas top seed in NCAA Tournament after dominant SEC run

OMAHA. Neb.- Arkansas was rewarded Monday for its dominant run through the Southeastern Conference, landing the No. 1 national seed in the NCAA baseball tournament.

The Razorbacks (46-10) won all 10 of their SEC series and wrapped up their first conference tournament championship on Sunday. After losing three straight games in March, the Hogs never lost consecutive games.

This is the third tournament in a row that Arkansas has been a top-eight national seed.

"It's still really special just to sit there and see your name called," coach Dave Van Horn said after his team gathered to watch the selection show. "Such a good season up to this point."

The 64-team tournament opens Friday in 16 regionals. Winners advance to eight best-of-three super regionals. Those winners move on to the College World Series in Omaha.

The top eight national seeds are assured of hosting super regionals if they win their regionals.

The national seeds following Arkansas: Texas (42-15), Tennessee (45-16), Vanderbilt (40-15), Arizona (40-15), TCU (40-17), Mississippi State (40-15) and Texas Tech.

would play in Game 1, they kind of were ready to move on.'

Vanderbilt, making its SEC-best 15th straight tournament appearance, will be going for its third national championship since 2014 after winning the title two years ago. There was no tournament in 2020 because of the COVID-19 pandemic.

Seeds nine through 16 are Stanford (33-14), Notre Dame (30-11), Old Dominion (42-14), Mississippi (41-19), East Carolina (41-15), Oregon (37-14), Florida (38-20) and Louisiana Tech (40-18).

The SEC led all conferences with nine teams in the field, followed by the ACC (8), Pac-12 (6), Big 12 and Conference USA (4) and Big Ten (3).

The last four teams selected were Alabama, Michigan, North Carolina and UC Santa Barbara. The first four out were Baylor, Pittsburgh, Georgia and Ball State.

Baylor would be first in line to replace any team that can't play its regional because of failure to clear COVID-19 testing protocols.

Stetson athletic director Jeff Altier, the Division I Baseball Committee chairman, said varying scheduling strategies because of the pandemic made the task of selecting at-large teams extremely difficult.

Altier said the opinions of regional advisory com-

cause several conferences didn't play outside their leagues.

"It was an incredibly difficult year," Altier said "Nobody experienced COVID before. We look at the RPI as a tremendous metric for us to help us evaluate, and in a year where you cannot play everybody across the conferences as typically you would do, it makes it difficult to choose."

Other notes about the tournament:

Old Dominion (42-14) is the top seed in the regional hosted by South Carolina. The Gamecocks are No. 2. Old Dominion did not submit a bid to host.

- Florida State (30-22) has the longest active streak of tournament appearances at 43.

-- Presbyterian faces its old coach in Vanderbilt's Tim Corbin. The school gave Corbin his first head coaching job (1988-93).

Texas has its highest national seed since it was No. 2 in 2010, and the program will be making its NCAA-best 60th appearance in the tournament.

Tennessee, at No. 3, is hosting a regional for the first time since 2005, the year the Volunteers last advanced to the CWS. There was a more relaxed vibe around the team on Monday compared with in 2019, when the Vols barely made the tournament with a losing SEC record.
