Amarillo riders gallop through Floyd County

G.A. Gossett of Amarillo has been riding the Caprock trails between Amarillo and Floydada, with local kids, for over 15 years. They ride horses, camp out on the side of the road and visit with the local churches along the way.

The 'trail riders' travel from Amarillo through the Caprock canyons to Turkey, Quitaque, Matador and Floydada. Then they head back north to Lockney, Rock Creek, Tulia, Dimmitt and back to Amarillo each summer. They also ride on several weekends during the rest of the year.

"We make about 15 miles, or more, per day. We left Amarillo on June 1st and we hope to arrive back home on August 1st," said Gossett.

The trail riders, Gossett and 7 young people from Amarillo (4 boys and 3 girls), arrived at the Floydada Sale Barn, located on the northeast side of Floydada, Wednesday, June 28th, right at high noon under the near 100 degree sun. They hobbled their horses and headed for the Sale Barn's cafe. They were hot, tired, thirsty and hungry.

There was a total of 10 horses coming into Floydada. The kids were leading two horses with empty saddles. Gossett said, "Two riders were picked up a couple of days ago."

The horses and supplies are all furnished by Gossett and his brother, Virgil, of Silverton. Virgil's son, Marcus, also helps along the route. There are three vehicles with horse trailers and camping equipment that follow along to help or go ahead of them preparing for their next stop. One of those vehicles had problems and it had to be returned to Amarillo shortly before they got to Floydada, according to Gossett.

"All of these kids have had a hard time at home. We are here to try to help them and keep them occupied during their summer

months. The kids can stay with us as long as they want, or leave whenever they want, but most make the entire trip," said Gossett.

According to Gossett, "If the kids make straight 'A's', and no 'B's', in school and ride with me for over a year, then I will give them their own horse." It has been estimated that Gossett has given away over \$20,000 worth of horses to kids over the years on these rides.

The kids are taught right from wrong. "We have prayer before starting each day and we attend church services along the way when we can," said Gossett.

Gossett's son-in-law, John Garrido, was a big part of these trips a couple of years ago. "We went to Louisiana to get some more horses and on the way back we had a terrible accident. An 18 wheel truck hit us from behind on Interstate 20. John and all the horses were killed and I was hurt real bad. I almost gave it all up, but the people at church prayed for me and encouraged me to carry on," said Gossett.

Following their noon meal at the Sale Barn, Gossett and the kids came to downtown Floydada and toured the Floyd County Historical Museum. Executive Director Bettye Jackson and crew gave the kids a grand tour for over two hours.

During that time Gossett hitched a ride back to pick up one of his vehicles left about five miles east of town. They had spent the previous night with Travis and Jon Jones on the Matador Highway. "We sure appreciated their hospitality and for putting up our horses," said Gossett.

Following their museum stay, the kids mounted their horses that had been hobbled in front of the museum. They headed for Dairy Queen to get Blizzards for everyone.



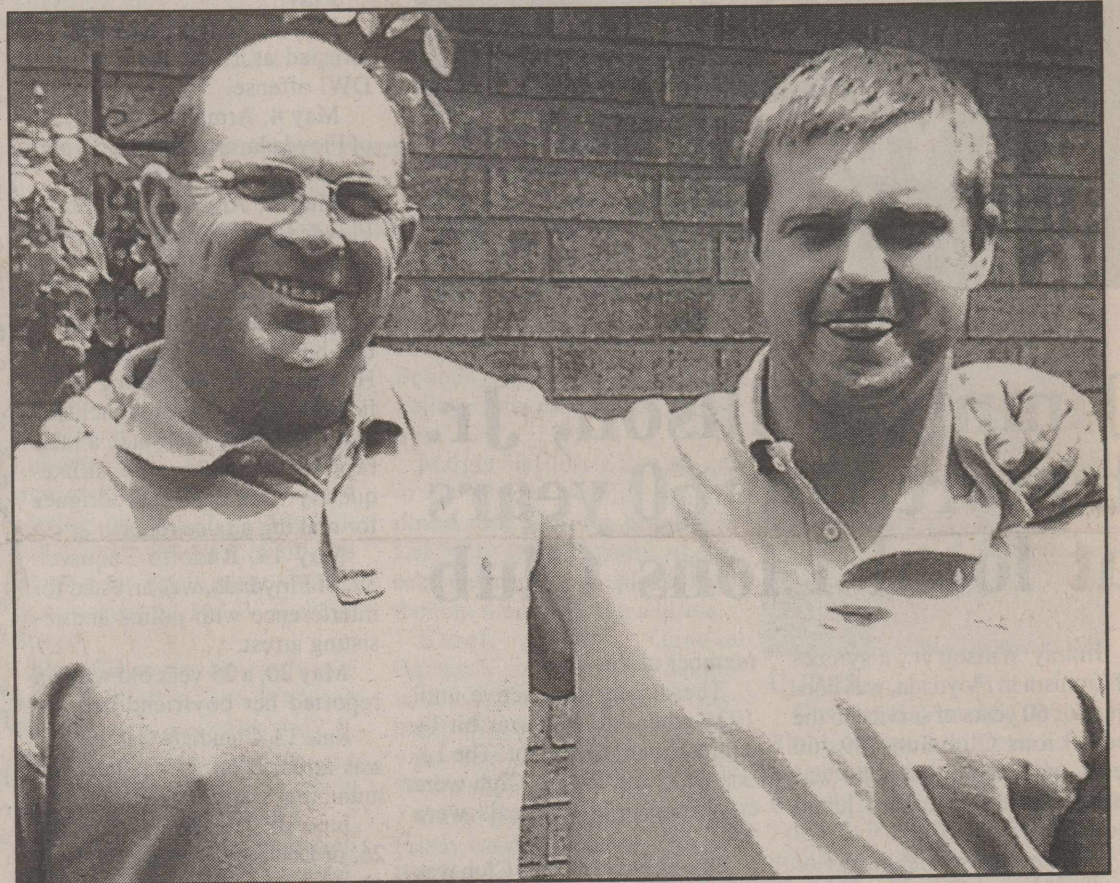
YOUNG TRAIL RIDERS FROM AMARILLO SPEND A NIGHT IN FLOYDADA

The group attended the Wednesday night service of the Bible Baptist Church, located just two blocks south of the Dairy Queen. Their horses were hobbled again at the dry lake just west of the church. The tall green grass there provided a welcome meal for the hungry horses, while the kids were fed cold watermelons following the church service.

Spirit of Sharing (S.O.S.) of Floydada provided two motel rooms at Floydada Inn, where again their horses were hobbled for the night in the field east of the motel.

The next morning the trail riders ate breakfast at Leonard's Cafe in Floydada and then they rode north to Lockney's Dairy Queen for their noon meal. From there they rode to a farm northeast of Lockney where they put their 10 horses up for a few days break around July 4th. Guy Carthel donated a round bale of hay for the horses.

The 'trail riders' went back to Amarillo in their vehicles and they plan to return on July 5th to finish the last half of their summer trail ride.

Brent Sanders donates kidney

Brent and Sarah Sanders of Floydada 'seems to be' just another good neighborly family in the community. But because of their sacrifice a week ago sets them apart from the other families in town.

Brent (51) became an organ donor last week by donating one of his kidneys to his nephew, Will Sanders (28) of Lubbock, in order to keep him alive. That makes Brent special. Brent's immediate family knows he is special. Will Sanders knows he is 'very special.' Will's parents know it and now the entire community knows.

Sarah and Brent were married 29 years ago in 1977. Brent began working at Lighthouse Electric and Sarah began her teaching career with FISD that same year. They have two daughters, Katy and Abby. Katy just graduated from Texas Tech University and is getting married soon, while Abby is attending Sam Houston State University.

It all started about two years ago when Will began to have high blood pressure. While doctors were treating his high blood pressure both kidneys were attacked and began to fail. Will was diagnosed as having IGA Nephropathy, known as Bergers Disease. This disease causes the immune system to attack the kidneys for some unknown reason.

Will was put on dialysis and on the transplant list, along with another 70,000 patients in the U.S.A. waiting for a kidney. This wait could possibly take years to find a donor match.

The entire family tried to come to his rescue by having their blood tested, along with other tests, to see if they were a match for donation. Will's mom and dad, Joe Bob and Diane Sanders of Dimmitt, were tested, along with his sister and two younger brothers.

The doctors told them 4 out of 6 criteria needed for a donor match would be 'real good.' Will's dad, Joe Bob, was rated 4 out of 6, while one of Will's younger brothers, Matthew, was rated 3 out of 6, which was only 'good.'

The surgery to transplant one of Joe Bob's kidneys to Will's body was set for April 2, 2006. Only hours before the surgery a benign cyst was discovered by x-ray by Donor Surgeon, Dr. Beck, on one of Joe Bob's kidneys. The surgery preparations were stopped immediately.

Younger brother, Matthew (21), with a 3 out of 6 criteria ratio, was now being considered as a kidney donor.

Brent stepped up to the plate and was tested. The tests also showed him to be a 3 out of 6 ratio. Brent volunteered to give one of his kidneys to Will, instead of his younger brother, Matthew.

"I believe because of my age at 51, compared to Matthew's age at 21 years, it would be better for me to give up one of my kidneys instead of Matthew. You never know. He may need both of his (kidneys) later in life, more than me at my age," said Brent.

The decision was made by Brent and Sarah. The transplant

surgery was rescheduled for June 27th at Covenant Hospital in Lubbock.

On that day Dr. G. Baird Helfrich, Transplant Surgeon and Dr. Janet Cruz, Nephrologist, removed Brent's left kidney (the one doctors say has the best blood flow) and placed it in Will's body replacing the work load of his two failed kidneys.

Brent left the hospital on June 30th and Will left the hospital on July 2nd.

According to Brent, "Will's blood poison count of 17, with his two bad kidneys, immediately went down to a number three within hours following the surgery. That is real good for Will."

"There will be the possibility of Will getting an infection, or even his body trying to reject the transplant, for the next three months. He will need to be on anti-rejection medication, as well as up to 40 other medication pills per day for the rest of his life," said Brent.

Will told Brent, "That is just an inconvenience compared to dialysis and possibly a much shorter life expectancy."

Brent and Sarah told the Hesperian-Beacon, "We would like to thank this community for all the prayers and well wishes we have received. It is a blessing to live in this community."

Brent humbly concluded, "It is a real blessing just to see my nephew receive his life back and have a chance of living a normal life now."

County Commissioners hear farm report from Ragland

The Floyd County Commissioners met Monday, July 10, and heard a farm report from County Extension Agent J.D. Ragland. Also, the board passed a regional emergency response plan and appointed election judges and alternates for the upcoming elections.

County Agent Ragland addressed the commissioners concerning the need for rainfall in the county. "We need some good rainfall. Some of our county's (irrigated) cotton is looking real good, but some of our dryland cotton had to be plowed up for lack of moisture. We are seeing cotton this year in all stages. Some was replanted and some is in a good growing condition, but it needs water."

"The heat units are up high, which is good. Heat units play a big roll in cotton development. The higher the heat units the faster the cotton grows and develops," said Ragland.

According to Ragland, there are about 190,000 acres of cotton this year in Floyd County and "about 40 percent of those acres are dryland."

Concerning other crops in the county, Ragland said, "Our 20,000 corn acres are looking pretty good, but it is under heat stress, also. The producers are watering their corn nonstop."

Ragland stated that wheat seed is in short supply here and throughout the whole country because of grazing and the drought. "Wheat yields have been around 25-30 bushels per acre. Early planting of wheat

again this year should start around mid August, if seed is available."

There are about 1200 to 1500 acres of pumpkins in the county this year and around 40,000 acres of sorghum, according to Ragland. "Again the producers are watering their pumpkins non-stop. The weeds are taking over for lack of not being able to use chemical controls."

In other matters, the court passed a South Plains Regional (Emergency) Response Plan sent out by S.P.A.G. and to be used in the county for any and all emergencies. "We must have this in place. We have no choice," said County Judge William Hardin.

Colston; Pct. 23, Judge A.C. Pratt; Alternate Petra Gonzalez; Pct. 24, Judge Ralph Jackson; Alternate Vance Mitchell; Early Voting Ballot Board: Judge Larry Ogden; Alternate Judge Jon LaBaume.

Floyd County Extension Agent Melissa Long also gave a brief report to the commission-

ers concerning her activities. Some of the events Long reported on were: July 13-14, teaching a Food Protection Management course in Plainview; 4-H State Round-up: Kami Keaton, \$12,000 scholarship winner, 3rd place in Fashion Show and won the Construction Wool Award; plans to take ten 4-Her's to District Record Book judging; taking two 4-Her's to participate in the State Horse Show; taking two 4-Her's to Prime Time State Camp at Brownwood and plans to take three 4-Her's to the State Congress in Austin.

Long reported on the 8 week program of Walk Across Texas for physical fitness. "We had 8 teams with 64 participants. They walked a total of 5,863 miles and Judge Hardin's team walked the most with 1,643 miles. The Judge walked 321 miles himself," said Long.

A \$55 bid by Aurelio Jimenez of Lockney to buy a Pct. 2 chain hoist was approved by the commissioners.

\$32,000 from the Bridge and Road Fund was transferred by the court to the four precincts at \$8,000 in each precinct to be used for their general expenses.

The commissioners approved to continue collecting a \$10 Road and Bridge fee and a Child Safety Fund fee for each vehicle registered in the county.

Three farm contracts were approved by the court. They were all in Pct. 3: one was 2 miles east of SH207 on CR110, to bury improvements for cultivation, by Jay Lackey; one was 1 mile north

Dr. Stennett of Lockney honored by Texas legislature

Earlier this year, Dr. Kevin Stennett of Lockney was chosen to be the Texas State Legislature Doctor of the Day for Monday, April 17. 2006 marks the 35th year the Academy of Family Physicians has sponsored this program. He was presented a certificate of citation which stated, "Extending our most sincere congratulations, we proudly present this certificate to Kevin Stennett, M.D., Doctor of the Day, Texas House of Representatives, 79th Legislature, April 17, 2006."

Two pictures of Dr. Stennett were taken and mailed to him later. One was with Speaker of the House, Tom Craddick and Representative Pete Laney. Dr.

Stennett said, "It was interesting, standing there between the present Speaker of the House and the past Speaker of the House." The other was with State Senator Kel Seliger and State Senator Robert F. Deuell, M.D.

Dr. Stennett worked in a primary care clinic located in the Capitol extension and treated anyone sick or injured on the Capitol grounds. He was introduced on the House floor, by Representative Pete Laney, and his name is now part of the official legislative record. Family physicians have volunteered their time and services since 1971 for every regular and special session of the Texas Legislature.

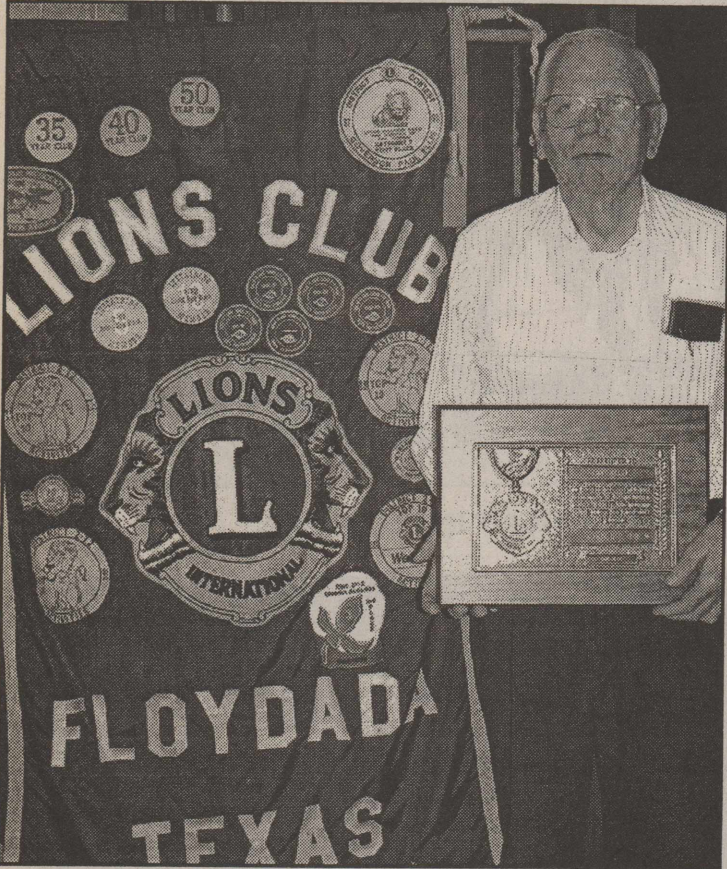
Laney had approached Dr. Stennett almost two years ago. However, spare time is very limited for a doctor working in a rural area and he declined.

"When I learned Representative Laney was not going to run for office again, out of respect for him, I called and asked to be contacted the next time the legislature was in session and I would make time to come to Austin," Stennett said.

Dr. Stennett works at Mangold Memorial Hospital in Lockney. He and his wife Michealle have two children, Keenan (age 13) and Kelsie (age 11). He is the son of Jimmy and Theresa Stennett, also of Lockney.

Jimmy Willson, Jr. honored for 60 years at local Lions Club

Jimmy Willson Jr., a symbol of Lionism in Floydada, was honored for 60 years of service to the local Lions Club June 29--60 years and one day after he was part of starting the Lions Club in Floydada.

Willson gave a brief history of the local Lions Club after being presented with a plaque at the Thursday noon luncheon in the Massie.

He reminded the Lions that the local club had turned 60 years old on June 28, 2006, and that the Club had survived some hard times since its inception.

The first Lions Club that served the area was chartered from a group of men who had been meeting as a luncheon club for three years. The group was chartered November 26, 1928 and met in Plainview. Willson's father, J.M. Willson Sr. was a

member of this club.

These men were active until 1931 when the area was hit by depression and drought. The Lions Club and Rotary Club were combined and the meals were 25¢.

The Floydada Lions Club was recharged in 1936 when times began to improve. This group was active until 1942 when so many young men were drafted for WWII. The Club was again merged with the Rotary Club.

In 1946, under the leadership of Ed Johnson, O.M. Watson Sr. and J.M. Willson Sr. and J.W. Willson Jr., the Floydada Lions Club was reorganized.

At the present time the Club has 33 members. Of the group who reorganized in 1946 Kenneth Bain and Jimmy Willson (J.M. Willson Jr.) are still active members of the club.

Palo Duro Basin Oil and Gas Update

Floyd County: Many inquiries have been received asking about the current status of the Apollo Energy Operating Company, L.P. W.D. Miller Lease Well #1. The Miller #1 continues to be pumped, producing oil. Apollo Energy operating has reported 1387 barrels of oil production (January thru May, 2006).

Floyd County: On Saturday July 1, 2006 the Bankers Petroleum (US) Inc. Stansell Lease Well #1 was plugged back and temporarily abandoned. The Stansell #1 had been drilled to a total depth of 9336 feet. 13 3/8 inch surface casing was set to 772 feet. 9 5/8 inch intermediate casing was set to 4407 feet. Two cement plugs were set in the wellbore. A 65 sack cement plug was set in open hole from 7500 to 7400 feet. An 80 sack cement plug was set across the show of the 9 5/8 inch casing from 4460 to 4390 feet. The SimDrill rig is

remaining on the Stansell #1 location while repairs are made to the rig.

Floyd County: The Bankers Petroleum (US) Inc. Misener lease well #1 was fraced on Friday July 7, 2006.

Floyd County: The BASA Resources, Inc. Foster lease well #1 was performing downhole mechanical work this week. The second stage of the frac job will be conducted following this work.

Motley County: On July 6, 2006 Tyner Resources Ltd. issued a news release on their recent completion work on the Tyner Texas Operating Company R.G. Stephens lease well #1. Tyner reported they isolated the lower Penn Bend Shale perforations and conducted a flow test, resulting in a rate of 250 mcf per day of gas and 20 barrels per day of oil. Tyner also reported the lower sand interval would flow 200 mcf per day of gas.

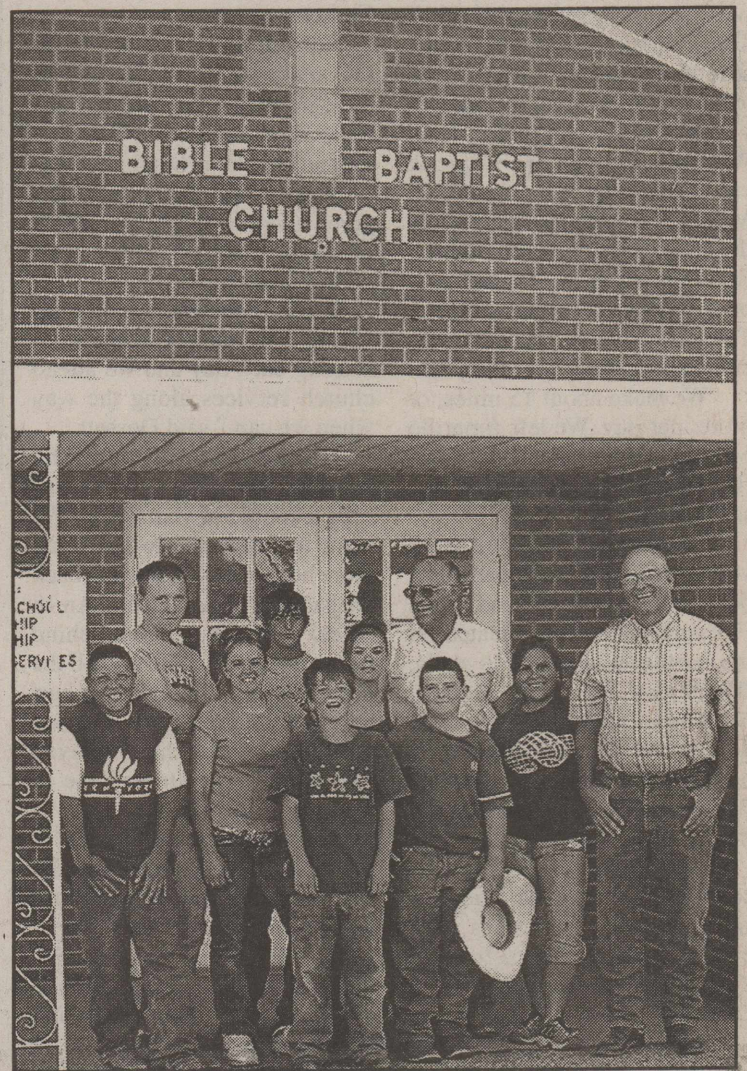

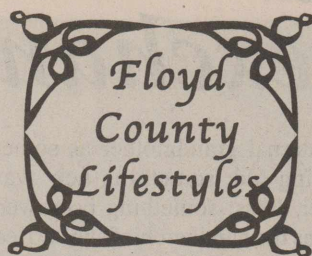
The reception was held in the couple's backyard.

The bride is the daughter of John and Lee Moss of Floydada.

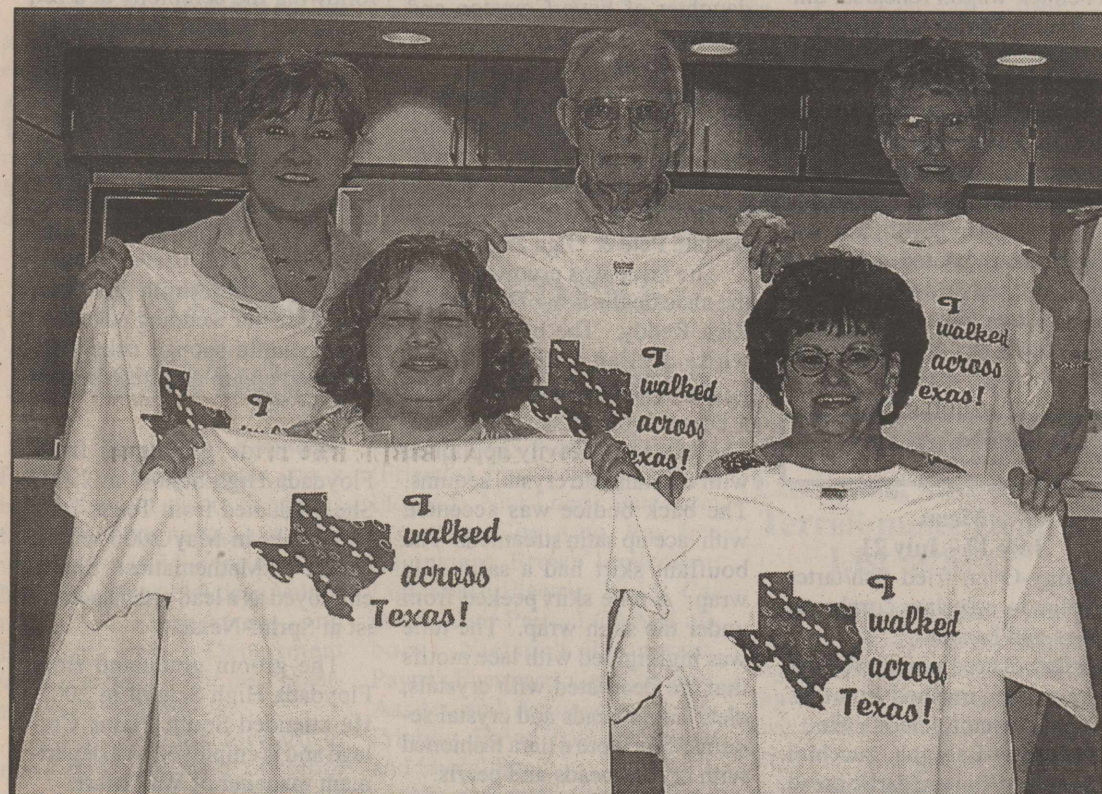
The groom is the son of the late Ed and Edna Butler of Lubbock.

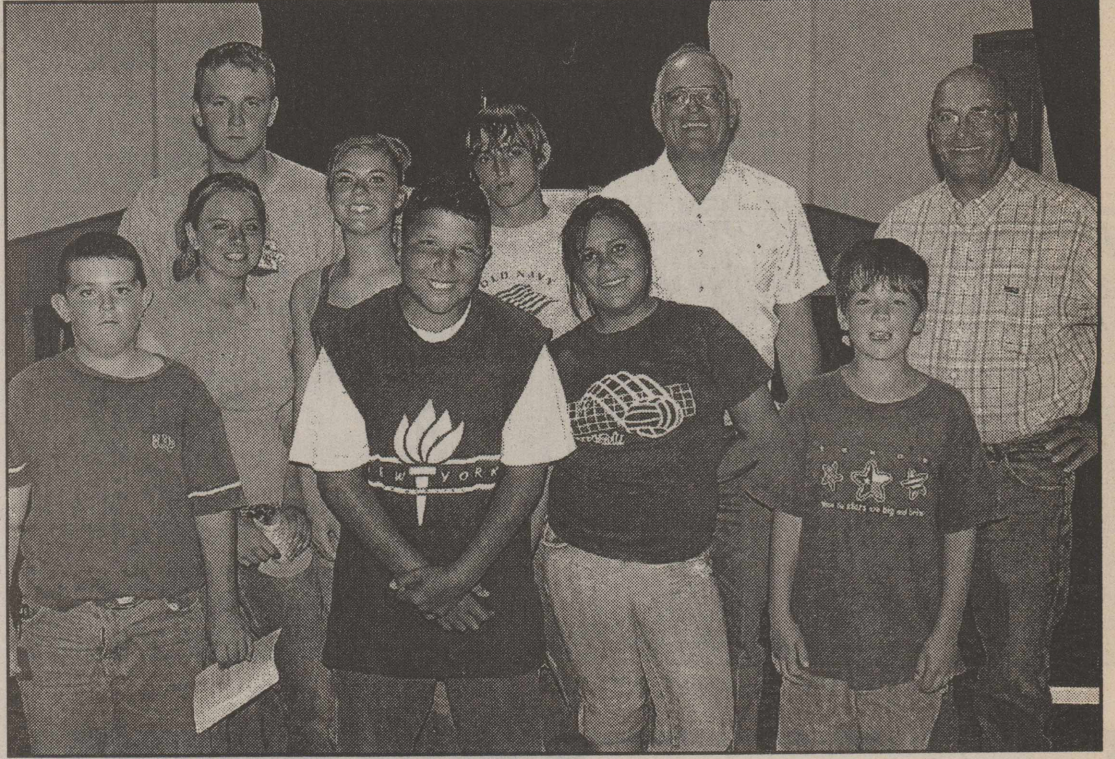

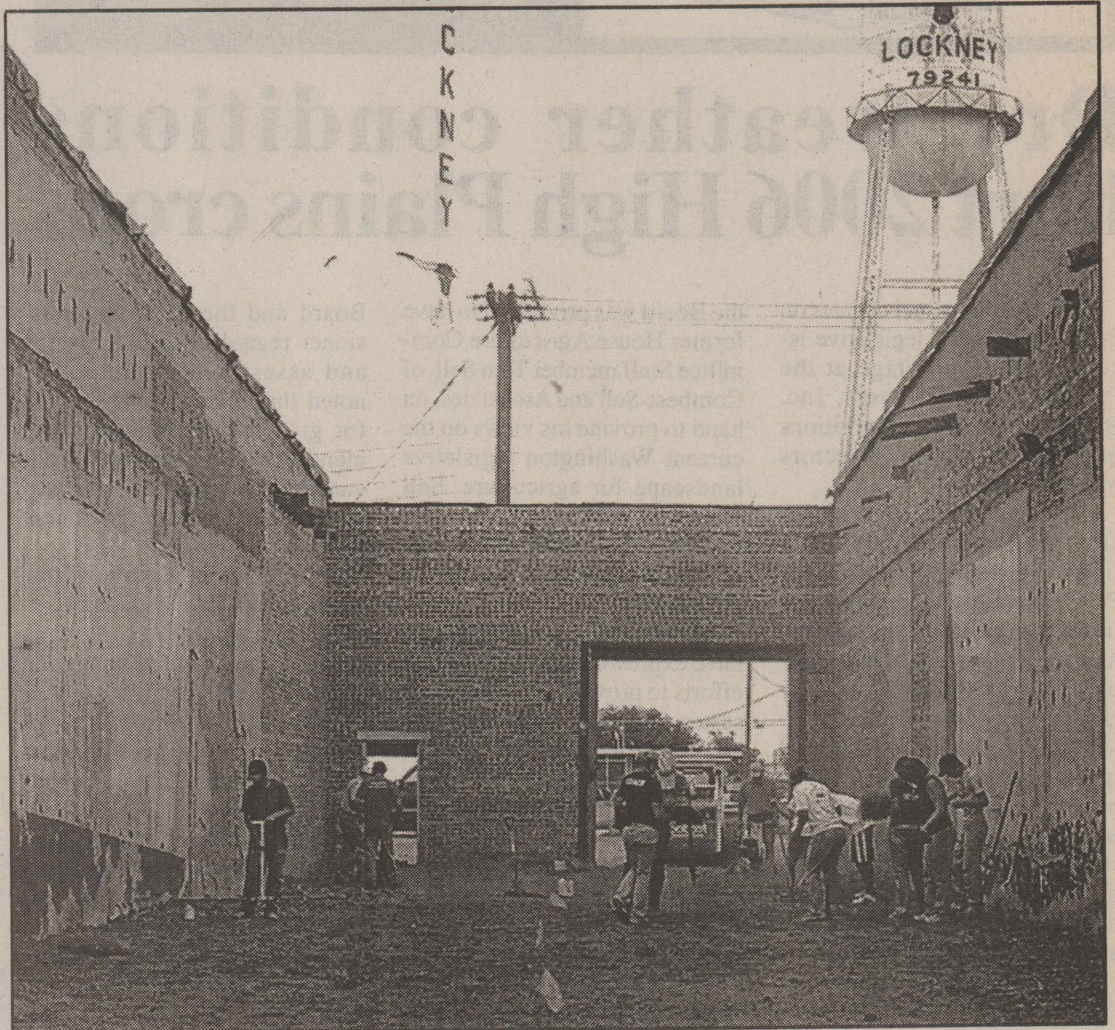

Dry weather conditions hurt 2006 High Plains crops

Dry conditions and updates on State and Federal legislative issues took center stage at the Plains Cotton Growers, Inc. Board during the organizations quarterly Board of Directors meeting July 5.

With the 2006 High Plains crop off to a rough start due to lingering drought conditions, PCG Board members were particularly interested in hearing how the crop was faring in other parts of the organization's 41-county service territory.

While the Board heard several reports of irrigated cotton in various locations that continue to rate in the good to excellent categories, the biggest story continues to be the dwindling prospects for dryland acres throughout the area.

Based on the reports heard at the meeting, PCG's current projection that the High Plains could eventually see up to one million acres of dryland cotton abandoned during the course of the 2006 growing season appears to be reasonably accurate and possibly even be somewhat conservative.

As it becomes increasingly probable that failed cotton could exceed the one million acre mark, two items of discussion, the growing need for disaster assistance and the failed acreage policies in current High Plains boll weevil eradication zones, received considerable attention during the discussion.

In regard to disaster assistance

the Board was privileged to have former House Agriculture Committee Staff member Tom Sell, of Combest-Sell and Associates, on hand to provide his views on the current Washington legislative landscape for agriculture. Sell covered a wide variety of topics including the growing awareness of the drought situation that is developing.

He noted that several Senators have expressed a desire to renew efforts to provide agricultural disaster assistance. He added that as the extent of current problems become clearer the chances for a disaster program including 2006 crops increases.

Sell added that a variety of factors will ultimately impact how the disaster assistance effort develops and encouraged PCG to remain in communication with their representatives in the House and Senate to ensure the area's interests are included.

In regard to failed acres and current boll weevil program failed acreage policies, Texas Boll Weevil Eradication Foundation executive director Lindy Patton, reported that the failed acreage and assessment policies in individual zones are based on the program situation that exists in that particular zone.

Patton explained that as each zone pays down debt accumulated during the early years of the eradication program the zone grower advisory committees gain additional flexibility to recommend changes to the TBWF

Board and the TDA Commissioner regarding failed acreage and assessment policies. He noted that the approval process for grower committee recommendations is started well in advance of the growing season and allows little room for adjustment later on.

Patton advised growers that operate in zones with failed acreage programs that provide a credit for acres failed before the Farm Service Agency's Acreage Certification Date to make sure that they get their acres certified as failed before the July 15 deadline. He noted that there is no requirement within the crop insurance program preventing a grower from certifying the acreage as failed at the FSA office before an insurance representative evaluates and releases the acres.

He also advised that when acres are failed that the producer communicate with local eradication program office personnel to ensure that they are aware of the crops status and the status of any field operations necessary to keep the acreage free of hostable cotton for the remainder of the growing season.

In other business, the Board was given an update on State legislative issues by State Representative Delwin Jones of Lubbock, adopted a 1006-2007 Operating Budget and discussed upcoming PCG participation in a number of industry sponsored activities.

Dry weather dents South Plains cotton

LUBBOCK - After back-to-back record cotton crops in 2004 and 2005, South Plains cotton farmers are watching the sky and keeping their fingers crossed. Rain is a badly needed, yet scarce, commodity for dryland and irrigated producers right now.

The 22-county area surrounding Lubbock, often called the "world's largest cotton patch," has received only spotty rainfall since planting began in mid-May.

After almost 60 days of hot, dry weather, dryland farmers are faced with "zeroing-out" some or all of their acreage. Producers with irrigation, and higher energy/fuel bills, wonder when Mother Nature will lend a hand with some crop-quenching, area-wide rainfall.

"We began assessing and releasing non-emerged dryland acres with a May 31 crop insurance final planting date on June 17," said Dr. Randy Boman, Texas Cooperative Extension agronomist based at Lubbock. "Producers in counties with a June 10 crop insurance planting date were eligible for adjustments as of June 27."

"We may be destined to fail perhaps around 1 million acres in Andrews, Bailey, Cochran, Dawson, Gaines, Glasscock, Hockley, Howard, Lynn, Martin, Midland, Terry and Yoakum counties this year. To put that in perspective, these counties produced more than 1.64 million bales from 1.39 million harvested

acres last year." Many dryland fields from Lubbock and Crosby counties northward are either in poor condition or haven't emerged at all, Boman added.

Scattered showers accompanied by high winds brought some moisture to portions of the South Plains the week of June 21, but it was not enough to help most fields, Boman said.

According to the National Weather Service, Lubbock received less than one inch of rainfall in June, two inches below average. Lubbock has received 5.64 inches of precipitation for the year to date, more than 3 inches shy of its average of 8.96.

Since July 1, rainfall across the South Plains has ranged from trace amounts up to 1.67 inches in some locations. National Weather Service climactic data is online at: <http://www.srh.noaa.gov>

Producers with spotty stands of cotton can either take their chances with what's out there, or join those with no stand at all and plow it up and plant another crop if timely rainfall occurs.

Fortunately, there are two Extension publications available to help producers take stock of their situation.

"Making Replant Decisions, Effect of Stand Loss and Skips on Cotton Yields" and "2006 Alternative Crop Options After Failed Cotton and Late-Season Crop Planting for the Texas South

Plains" are available at the Lubbock center, from area Extension offices and online at: <http://lubbock.tamu.edu>.

"Farmers should evaluate the plant density in damaged fields before deciding to zero-out those acres," Boman said. "If you've got a stand of at least 1.5 healthy plants per foot of row, you should consider sticking with the crop. Given better growing conditions, it could still make acceptable yields."

"If you decide to zero it out, be sure and double-check your replanting options so you will remain in compliance with farm program regulations."

Farmers with failed cotton acres may still have time to plant a catch crop such as corn, grain sorghum, sunflowers, soybeans, guar, sesame, peas or beans, said Dr. Calvin Trostle, Extension agronomist based at Lubbock.

Trostle's alternative crop and late-season planting guide discusses herbicide concerns, crop maturity requirements, recommended last planting dates, pest problems, marketing options, and realistic yield expectations for these crops. It also contains information on forage sorghums, sorghum-sudan and hybrid pearl millet forage crops.

Producers can also obtain "2006 Texas South Plains Catch Crop Budgets" online in the What's New column of the Lubbock Center Web site.





Burial was held in the Dreamland Cemetery in Turkey under the direction of Kornerstone Funeral Directors of Tulia.

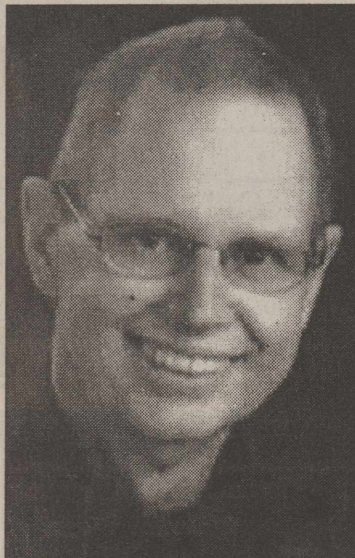
Mr. Gafford died Saturday, July 1, 2006 in Lockney.

ALLAN R. HENNEMAN
Capt. Allan R. Henneman (USAF retired), 57, of Lubbock, Texas, died July 3, 2006 at his residence after a courageous battle against cancer.

Capt. Henneman was born to the late Lt. Col. Carl D. Henneman (USAF retired) and Arline Lucker Henneman August 21, 1948 in Munich, Germany.

A military dependent, Allan lived in Germany, Guam, Ohio, New Mexico and Japan. He graduated from Fairborn High School (Ohio) in 1967 and enlisted in the US Air Force in 1968 during which time served as a Fire Protection Specialist with duty in Florida, Alaska, Thailand, Germany and Washington.

He married Ann Battey of Floydada May 15, 1976, and they spent the first three years of their marriage living in Rhein-Main AFB, Frankfurt, Germany and traveling throughout Europe. Capt. Henneman separated from the Air Force in 1981. He and Ann attended West Texas State University School of Nursing where they earned their Bachelor of Science in Nursing degrees in 1984. Allan worked in the private sector as a registered nurse until being recalled to active duty with the USAF in 1990.
