# Wind turbines coming soon

Construction about to begin on RES Whirlwind Energy Center

Very soon 26, 2.3 MW wind turbines will dot the landscape at the RES' Wind Farm 20 miles east of Floydada. The local wind farm will be known as the RES Whirlwind Energy Center.

The turbines will be on land leased from Winfield Davenport and other landowners surrounding Davenport--approximately 10,000 acres.

RES, (Renewable Energy Systems Americas) purchased the turbines from Siemens Power

The 26 Siemens wind turbine generators will produce 59.8 MW of electricity, or enough to power approximately 28,000 Texas homes.

Allen Jensen, the local project manager, says construction crews will be here through December 2007

According to Jensen the project should be underway by March, 2007

Approximately 10 miles of new roads will be built to the site and the area will also be cleared for trailers to house construction crews. Existing roads will also be upgraded to handle the large equipment coming to the area.

Project Director Chris Hills said the lines will be tied into the existing Matador substation.

"Most of the turbines are built in Denmark and shipped to Houston," said Hills. "They will" then be trucked in here.'

power will be sold to "Austin Energy under a recently executed long-term arrangement (Power Purchase Agreement) that will commence upon completion of construction and commission-

RES-Americas also intends to own a significant portion of the project and be the project opera-

"RES Americas is excited about our continued relationship with Siemens which provides some of the highest quality wind generation equipment in the world," said Craig Mataczynski, President of RES Americas. "By securing these turbines RES is moving full speed ahead with the Whirlwind Energy Center."

"Siemens has a long productive track record of working with RES," said Michael Revak, director of wind power, Americas at Siemens. "Our relationship

with RES in Texas dates back to 2001 when RES built the King Mountain Wind Ranch in Upton County, using 278MW of Siemens (then Bonus) turbines. RES Americas has completed projects including 342MW of Siemens turbines and is currently constructing projects with an additional 451MW of Siemens turbines, including the Whirlwind Energy Center, at sites in Texas and elsewhere in the U.S.

Modules still in field

A couple of gins in Floyd County are still ginning, or waiting to gin, their last few bales of 2006 cotton. Another week to ten days will probably wrap up the 2006 cotton harvest. (The 2006 cotton bale count will be published in the Hesperian-Beacon

Floydada Coop Gin and Blanco Gin are both trying to finish up their 2006 cotton harvest. Floydada Coop Manager Todd Cypert told the Hesperian-Beacon, "We still lack about 5,000 bales being through. The rain last weekend kept us from bringing as soon as all the numbers are in about 536 modules left in the

fields, but we are bringing them in this week.

"We have about 60 modules on the gin lot now and the gin is running. This will be our second largest ginning season when we finish this year," said Cypert. According to the gin office, they may gin close to 50,000 bales of cotton this year.

Blanco Gin Manager Jody James said, "We still have some cotton in the field that needs to be harvested before we can finish ginning this year."

Other gins in the county have already reported average, above average and some below average bale counts this year. The ones Continued On Page 3

# Mangold is "Super Doctor"

County have known for a long time how lucky they were to have not only a good quantity of doctors serving this area, but also good quality doctors.

Now, Texas Monthly Magazine has recognized it too, with a special section in the December 2006 issue highlighting "Texas Super Doctors". Included in the listing is Lockney's own, Dr. Gary Mangold.

"Super Doctors" are selected through polling by Key Professional Media. The research team asks more than 45,000 Texas doctors to nominate one or more doctors, other than themselves, from specified medical specialties based on one question: "If you needed medical care, which doctor would you choose?"

The nominees are grouped into 29 medical practice areas. Those nominees with the highest point totals from each practice area are invited to serve on the blue ribbon panel. Each blue ribbon panelist reviews and scores a list of nominees for their primary practice area.

Dr. Gary Mangold, of Lockney, made the list in the specialty area of General/Family Practice.

Mangold has also recently been featured in "Pulse", a publication of Texas Tech University Health Sciences Center.

A graduate of Texas Tech University Health Sciences Center School of Medicine, Mangold told "Pulse" that he had dreamed of becoming a doctor since he was 6 years old.

He completed his residency at Residents in and around Floyd John Peter Smith Hospital in Fort Worth and then returned to his hometown of Lockney in 1979 to practice with his father, W.J. Mangold, M.D.

Lockney's hospital, was named after W.J. Mangold.


Dr. Mangold had already worked in Lockney for almost 40 years, when Dr. Gary (as he is called by his patients) arrived to help him out.

Dr. Gary says he is now seeing his fourth generation of patients. He told "Pulse" that he and his wife, Brenda, had planned on spending only a short time in Lockney before settling in the Hill Country in Central Texas. Instead they made Lockney their

Until 1987, the father and son team were the only physicians at the Lockney hospital, which also serves residents from the surrounding farming communities of Silverton, Turkey, and Peters-

And the stability of those two doctors in this small town was often credited with attracting more doctors. Dr. W. J. Mangold passed away in 1992 and Dr. Gary continued the family tradition in Lockney.

While most rural towns are struggling to find one doctor, Lockney is now blessed with 4 family practitioners: Dr. Mangold, Dr. Kevin Stennet, Dr. Sharie Moore and Dr. Kevin bad. Stewart; and a physician assis-

Keeble started his hike on October 7, 2006 in Cape Girardeau, Missouri and says he will eventually end up in Canada.

"I tried just getting on the highways and walking, but I soon found out that wasn't for me," said Keeble. "I then decided to hike all the trails across the United States. I have friends that get me from one trail to another."

Keeble says some of his favorite places he has seen so far is Ozark, Arkansas during the changing of the leaves and Caprock Canyons. "It was such a surprise to me to be walking along on the upper trail and then come up on the Canyon.'

"The rain and snow seem to be following me," said Keeble. "The worst weather I've experienced has been in Tulsa. I was there when the freeze hit.


"I've been humbled by the number of people who stop and ask if I need help, or they want to make sure I'm alright. I'm

# **Commissioners Court advertising** to fill vacancy of retiring Sheriff

The Floyd County Commissioners met Monday, January 8, 2007, and discussed the recent discovery of missing computer records from the County Judge's office computers, tax incentives, and the upcoming retirement of the Sheriff.

Commissioners approved a motion to advertise for the position of Floyd County Sheriff to be open on February 1, 2007 after Sheriff Royce Gilmore told the court his last day before retirement is January 31, 2007.

In response to County Judge Penny Golightly reading the agenda item concerning missing records from office computers, Commissioner Lennie Gilroy commented, "These are important records and we can't find them. Maybe we are just not familiar with these computers, but we need someone to help us find them."

Former County Court Coordinator Margaret Ponce was present and was recording the meeting with a video camera and tape recorder. During Public Comment, Ponce explained that there is a backup disc with those records and they can be retrieved, and that she would be willing to

Ponce concluded, "I'm not aware of any records missing from the computers."

No action was taken on the

The court heard a presentation by Dora Ross, Executive Director of the Floydada Economic Development Corporation, and Phil Cotham, President of the Lockney Economic Development, concerning establishing a committee for business development incentives in Floyd County.

Ross told the court, "We need incentives to attract businesses and for expansion of (existing) businesses. Each business would be evaluated on an individual basis by our elected officials on our boards. We need something in place to dangle ahead of time."

Cotham added, "Many areas have gotten dairies and wind farms with tax breaks. A good tax break to start will eventually bring in more taxes later. By the time we try to process any tax break by the taxing entities, many businesses have gone somewhere else."

Ross gave an example of dairies moving into the Muleshoe School District which have added over 200 students in their

school district. This includes the dairy business and the milk processing plants and other businesses that come with them.

Commissioner Gilroy said, 'We are open for incentives on an individual basis.'

Commissioner Quattlebaum added, "Our motive is to increase our tax base. We are for new businesses coming to Floyd County and we will work with you."

Commissioner Jon Jones asked, "What incentives are surrounding counties giving?"

Ross responded, "Some counties offer all weather roads, such as asphalt. For example, Muleshoe E.D.C. offered cash, while the county commissioners gave tax abatements. Other incentives can be roads, electricity, sewer, etc. Remember, the land is already on the tax rolls and that stays on the rolls.."

"Tax abatement can be for 100 percent, 75 percent, 50 percent and 25 percent. We need the jobs. Floyd County has the highest unemployment in the area. Our purpose is to create jobs. We need this committee to recommend some tax abatement rates for qualified businesses," concluded


The court will meet in Special Session later to appoint a commissioner to this committee.

The commissioners appointed 7 residents to the County Historical Commission during January of odd-numbered years. They were: Nancy Marble, Hulon Carthel, Olive Hinton, Dee Copeland, Connie Bertrand, Carolyn Hardy and Donelle

Floyd County Treasurer Elva Martinez presented the commissioners the December, 2006 Financial Report. The Report showed a Beginning Balance of \$978,318.60, with Receipts of \$207,476.88. Transfers In and Out were at \$256,369.50, with Disbursed at \$248,244.18, leaving an Ending Balance of \$937.551.30.

The court transferred \$16,000 from the Road and Bridge Fund into the four precincts at \$4,000

Floyd County Extension Agents J.D. Ragland and Melissa Long gave reports to the commissioners. Visiting and observing with them was the new County Agent, Seth Manney, from Briscoe County. He will be training in Floyd County until January 31st.







# Shingles and Chickenpox caused by the same virus - early diagnosis offers best treatment

The same virus that causes chickenpox causes shingles, a disease that affects nerves and causes pain and blisters in adults. After recovering from chickenpox, the virus does not leave your body, rather it continues to live in some nerve cells according to Andy Crocker, Extension Program Specialist with Texas Cooperative Extension. For reasons that are not totally understood, the virus can become active instead of remaining inactive and cause shingles. Most adults live with the virus in their body and never get shingles. But about one in five people who have had chickenpox will get shingles later in life - usually after the age of 50.

When the activated virus travels along the path of a nerve to the surface of the skin, a rash will appear. It usually show up as a band on one side of the face or body. Right now there is no way

of knowing who will get the disease. However, the risk of getting shingles increases as you age due to increased difficulty fighting off infections with age.

While symptoms may vary, most people report some or all of the following: burning, tingling or numbness of the skin; feeling sick, such as chills, fever, upset stomach or headache; fluid-filled blisters; skin that is sensitive to touch; mild itching to strong pain

The rash usually happens on one side of the body. A few days after the tingling or burning feeling on the skin, a red rash will come out on your body, face or neck. In a few days, the rash will turn into fluid-filled blisters. The blisters dry up and crust over within several days. Most cases of shingles last from 3 to 5

It is important to see your health provider no later than 3 days after the rash starts. He or she needs to see the rash to confirm what you have and make a treatment plan. Although there is no cure for shingles, early treatment with drugs that fight the virus may help. Medications are also available which may help lessen the pain. When started within 72 hours of getting the rash, anti-viral medications may help shorten the length of the infection and lower the risk of other

After the rash goes away some people may be left with long lasting pain called post-herpetic neuralgia or PHN. The pain is felt in the same area where the rash had been. Those who have had PHN or stabbing. Their skin is so sensitive they cannot bear to wear even soft, light clothing. The older you are when you get shingles, the greater your chance

might have developed PHN there are medicines that may

In 2006, the Food and Drug Administration approved a shingles vaccine, Zostavax, for use in people 60 and older who have had chickenpox. Researchers found that giving older adults the vaccine reduced the expected number of shingles cases by half and, in people who still got the disease despite immunization. greatly reduced the severity and complications of shingles. The shingles vaccine is only a preventive therapy and is not a treatment for those who already have say the pain is sharp, throbbing shingles. While the vaccine is currently approved only for those 60 and older, you may still wish to discuss this option with your health provider.

In a small number of cases, swelling of the brain may occur. It is very important to see your health provider as soon as possible - especially if you have blister on your

Shingles is not contagious. You cannot catch shingles from someone who has it; but, you can catch chickenpox from someone with shingles. If you have never had chickenpox, try to stay away from anyone who has shingles.


If you have shingles, here are some things that may make you feel better: make sure you get enough rest, avoid stress as much as you can and eat well balanced meals; dip a washcloth in cool water and apply it to your blisters to ease the pain and help dry the blisters; do things that take your mind off your pain: watch

TV, read books, talk with friends or work on a hobby; try to relax. Stress can make the pain worse. Listen to music that helps you

High Plains cotton producers adversely impacted by drought in 2006 still have time to seek relief through the trait and seed drought assistance programs offered by Monsanto and various seed companies serving the West Texas market.

Many producers made a conscious decision to try technology-enhanced cottonseed on dryland acreage in 2006 based on the trait and seed drought relief programs offered by Monsanto and later matched by other cottonseed vendors.

The programs opened the door for dryland producers to plant technology enhanced seed by providing the added security of knewing that their technology fees and all or part of their planting seed expense would be refunded if their crop yielded less than 150 pounds per acre due to drought.

With the filing deadline for many of these programs right around the corner, it is critical that any grower that has not already filed a drought relief claim with their seed and/or technology supplier submit their paperwork before the deadlines that were established for participation by the various companies offering drought relief programs. The deadline for filing drought relief claims with Monsanto is January 15.

Any producer who believes they have cotton that will not yield 150 pounds which will not be ginned before January 15, and do not have a Federal Crop Insurance appraisal to document an estimated yield for the affected acres, should contact their local

seed retailer and/or their local seed company representative

prior to January 15.

It is important that growers act before the deadline to submit a claim under any of these programs. Producers should contact their local seed retailer and/or local seed company as soon as possible to ensure that claims are entered before the deadline and remain eligible to be processed:

Claims submitted or received after the announced deadline, cannot be accepted according to federal regulations governing these types of programs.

The Monsanto Trait Relief program applies to any variety that contains Monsanto technology traits. The Monsanto Seed Drought Relief Program applies to Stoneville and NexGen brand cottonseed varieties.

Like the Monsanto programs, the Seed Drought relief programs offered by All-Tex Seed, Americot, Beltwide Cotton Genetics, Croplan Genetics, Delta & Pine Land, Dyna-Gro and FiberMax/AFD Cotton Seed utilize a 150-pound per land acrethreshold to trigger rebates to eligible growers.

All of these programs, except for the D&PL drought relief program was December 29, 2006, while the All-Tex submission deadline was January 2, 2007.

Growers who planted D&PL or All-Tex seed, whether or not they filed a claim with the seed company, still have until January 15 to file a claim with Monsanto for refund of their paid 2006 technology fees on drought affected acres.




