

Craig and Jordan honored for 50 years of safe flying

Jordan were both recently awarded the Wright Brothers Master Pilot Awards for their 50 or more consecutive years of safe flying.

Not only do Craig and Jordan have thousands of hours of flying time separately they have also logged many miles and many hours together.

Beginning in 1967 the two doctors flew 35 consecutive missions to Central America to provide dental and medical needs to the needy. In 1976 the two also flew a disaster relief mission to Guatemala.

As of January, 2007, Craig had logged nearly 5,300 accident free hours and continues to fly today. He currently holds a commercial pilot license with single and multi-engine ratings.

Floydada sets tax rate

Floydada Council members met September 25 to adopt their 2007/2008 budget and set the 2007 Tax Rates

The Council voted unanimously to levy a tax rate of \$.40 for each \$100 valuation of property. The total valuation of taxable property in Floydada was determined to be \$59,590,970.

The Council also voted to levy a tax rate of \$.06 on each \$100

valuation for debt retirement for meters, plus the cost of a new sewer improvement debt.

"This was approved in 2005," said City Manager Gary Brown, "but has not been collected until this year. It helps pay for the sewer improvements.'

After a report from Brown of some city electric customers illegally bypassing meters, the council voted unanimously to charge a fee of \$100 to reconnect anyone caught tampering with

meter.

Brown told the council the city was having some problems with people trying to slow down their meters or trying to bypass their meters. "We file on them in J.P. Court and also charge them with the cost of replacing the meter.

The meters that have been messed with either have to be removed or the electric lines dis-

LISD and architects make plans for new field house

LISD Trustees met with architects in a special meeting, September 25, to discuss costs and plans for the new field house. "The architects numbers are

more than what the insurance company wants to settle for," said Superintendent Cotham. "We are still in the negotiating phase of this process. We don't know what the numbers are going to be yet."

After the special meeting the board convened in a regular meeting to conduct business. The Trustee approved a joint

election agreement between LISD and Floyd County to hold the Roll Back Election for the school district and the Constitutional Amendments election at the same time on November 6.

By state law roll back elections must be held in conjunction with another state election.

The trustees also approved the donation of the special education bus to EPEC SSA (the new Special Education Cooperative). "This bus was received from the Caprock Cooperative as part of our dissolution agreement," said Cotham. "It will be donated to EPEC to be used as a buy-in to the Coop's fund balance.'

The trustees voted down the purchase of a truck for the band. We are being very careful about spending right now," said Cotham. "We are just on a what do we need basis. We are being verv frugal.'

Trustees approved the Highly Qualified Report which is part of \$3,048,690.65.

This will enable the school to the "No Child Left Behind" mandates. Cotham said, "100% of our teachers have to be highly qualified (certified), or show progress in getting certification. The district is responsible for making that happen and LISD is rated 'highly qualified'."

The board approved a bid on property at 310 S.E. 2nd for \$300 from Andres DeLeon, and a bid for \$850 for a 1990 International Bus from County Line Auto Sales in Plainview.

The trustees also reviewed and approved the Financial Integrity Rating System of Texas (FIRST) report. The district had received a "Superior Achievement" rating. In the financial report for the month of September the district showed a balance of \$3,571,901.32, which includes CD investments of







On the opening kickoff Blake Greer went untouched for a 70yard touchdown. Although "Pickles" Alvarado missed the extra point, the Whirlwinds were well on their way to a blowout victory. Using the legs of Aarrhon Flores and the arm of Payte Beedy, Floydada scored forty-one first half points and held a commanding 41-14 lead at halftime

Tahoka's Michael Gonzales scored on a forty-two yard touchdown run on the Bulldog's first possession. After Gonzales' score however, Floydada scored on five consecutive offensive possessions. The scores included: Flores sixty-yard run, Flores four-yard run, Colby Turner 2-yard run, Beedy 63yard pass to Alvarado, and Beedy 7-yard pass to Alvarado. Tahoka's lone bright spot of the second quarter was an 80-yard kickoff return for a touchdown by Britt Wuenshce.

Floydada's offensive onslaught in the second quarter in-

cluded a twenty-nine point effort. opener on Friday, October 12. Flores, who did not play the second half, rushed for 136 yards on only nine carries. He finished with two touchdowns and has now amassed 662 yards on the ground this year. Beedy's first half highlights included throwing for 123 yards and two touchdowns, both to Alvarado. Alvarado is averaging 37 yards a catch on the season with five touchdowns.

Floydada was able to get many of their younger players in during the second half. Fred Williams and Chad Davis did a good job at running back, and Colton Covington scored a oneyard touchdown (Floydada's only of the second half). The second half passed quickly as both teams kept the ball on the ground. Tahoka added a late touchdown in the fourth quarter making the score 47-21, which would be the final.

The Winds will not be playing this week. They host the Childress Bobcats in the district


The 7th graders had an interception returned for a touchdown, a kickoff return for a touchdown, and a punt return for a touchdown.







Lockney's "First Bale" proceeds to be donated to Boys Ranches

D & J Gin in Lockney called the Hesperian Beacon Newspaper Saturday, September 29, for a "First Bale" picture. However on Monday as the picture was being taken, more information came in that changed the results of the "First Bale Race."

It turned out McCoy Gin had ginned the first bale on Friday. The race could have been a tie

or a very close first and second if D & J Gin had not been shut down Friday because of a direct lightning strike.

David Foster related how the gin had taken a direct lightning strike Thursday evening, September 27 around 5:00 or 6:00 p.m., knocking out equipment, making ginning impossible. "Three PLC's were lost in the gin, one in the office and the office TV. Also knocked out in the gin was a 40 HP motor, controller to the strapping machine on the press and a burner control," said Foster. "The lightning damage prevented us from ginning Johnny's cotton sooner."

Johnny Belt grew the FM Flex 9058 cotton on his dryland "John G. Belt Town Place." The bale weighed 477 pounds. The cotton was stripped Friday, September 28 and ginned 4:20 p.m. Saturday, September 29 at D & J Gin. It had been treated with FirstPick, Ginstar and Prep. Chemicals were applied by Wilbur-Ellis Company.

Belt had already told Foster he wanted the money from his first bale to go to Cal Farley's Boys Ranch. When he found out the new "First Bale" results, he said he still wanted to donate the money to the Ranch.

Belt told Foster, "I want the money from this first bale to go to Cal Farley's Boys Ranch and the money from the second bale (418 pounds) to go to Texas Boys Ranch in Lubbock." Foster added, "The gin will donate the ginning charges to the Boys Classing Office in Lubbock: Ranches.

When word got out the money was to be donated to the Boys Ranches, other generous people wanted to help the cause.




